(57) **CLAIM**

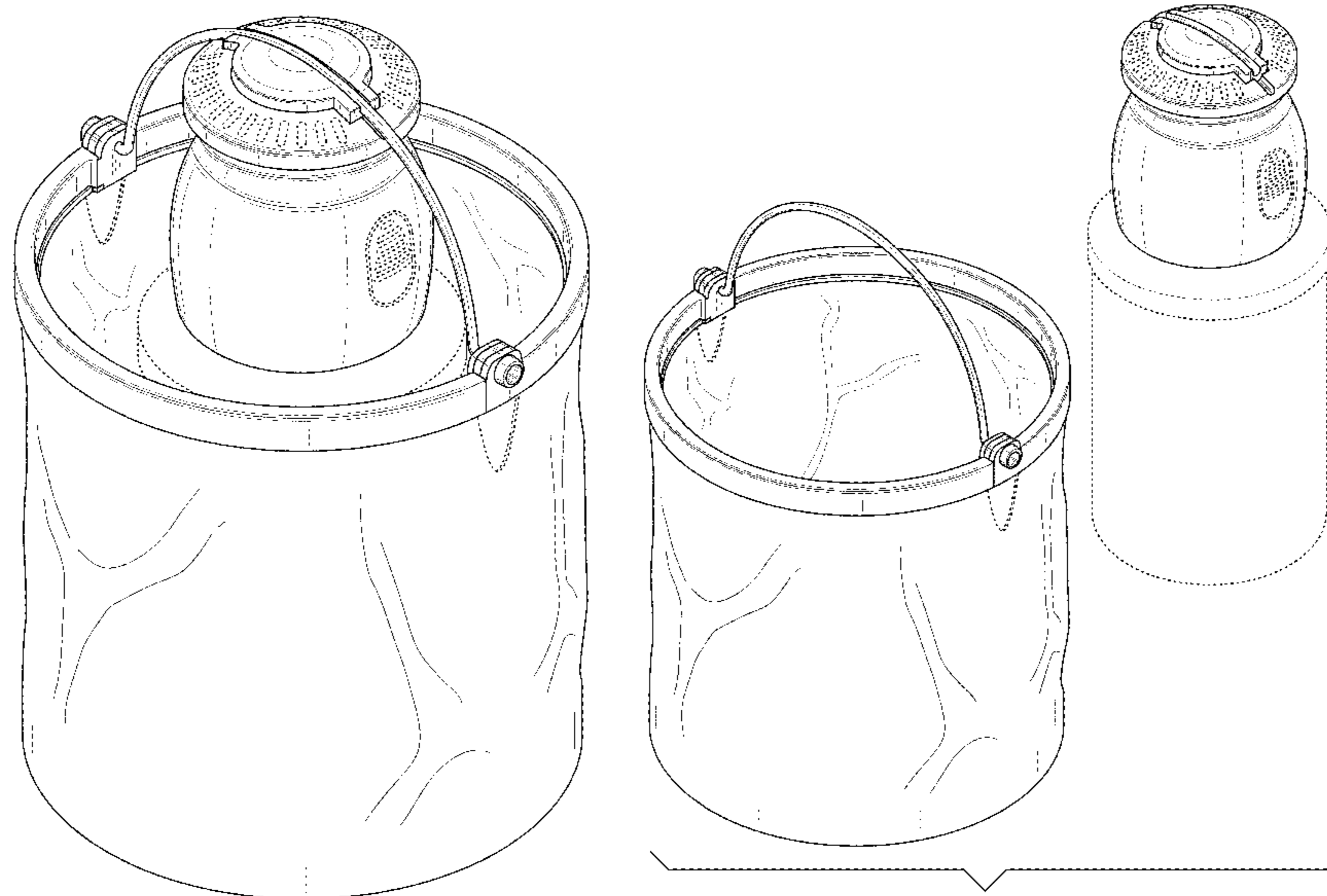
The ornamental design for an ice cream maker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view as seen from the top, front and right side of an ice cream maker showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is another perspective view thereof, in exploded condition.

The broken line in the figure drawings represents unclaimed environment only and forms no part of the claimed design. The Y-shape line shown in the drawings represent a soft surface on the claimed article.

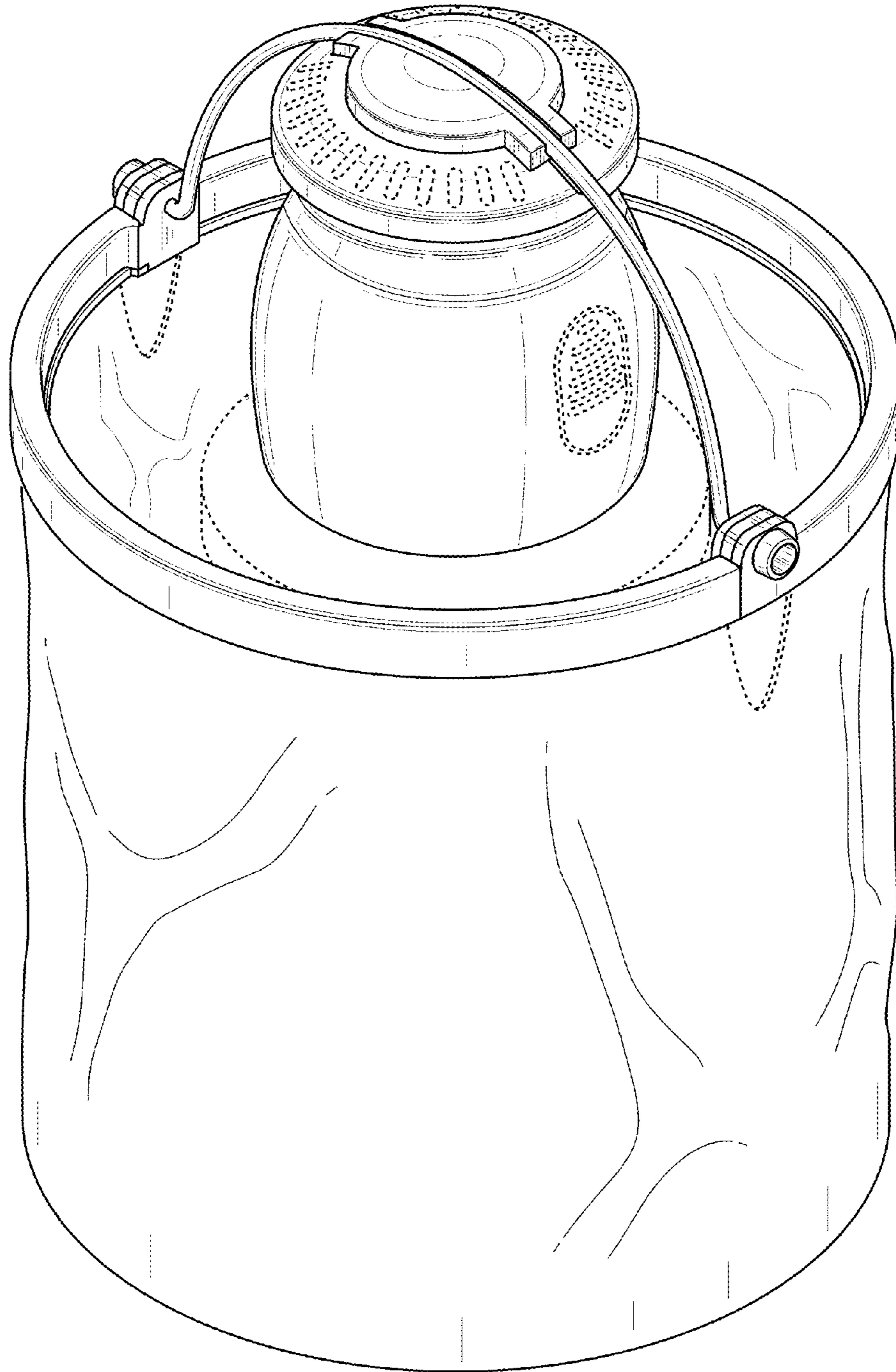

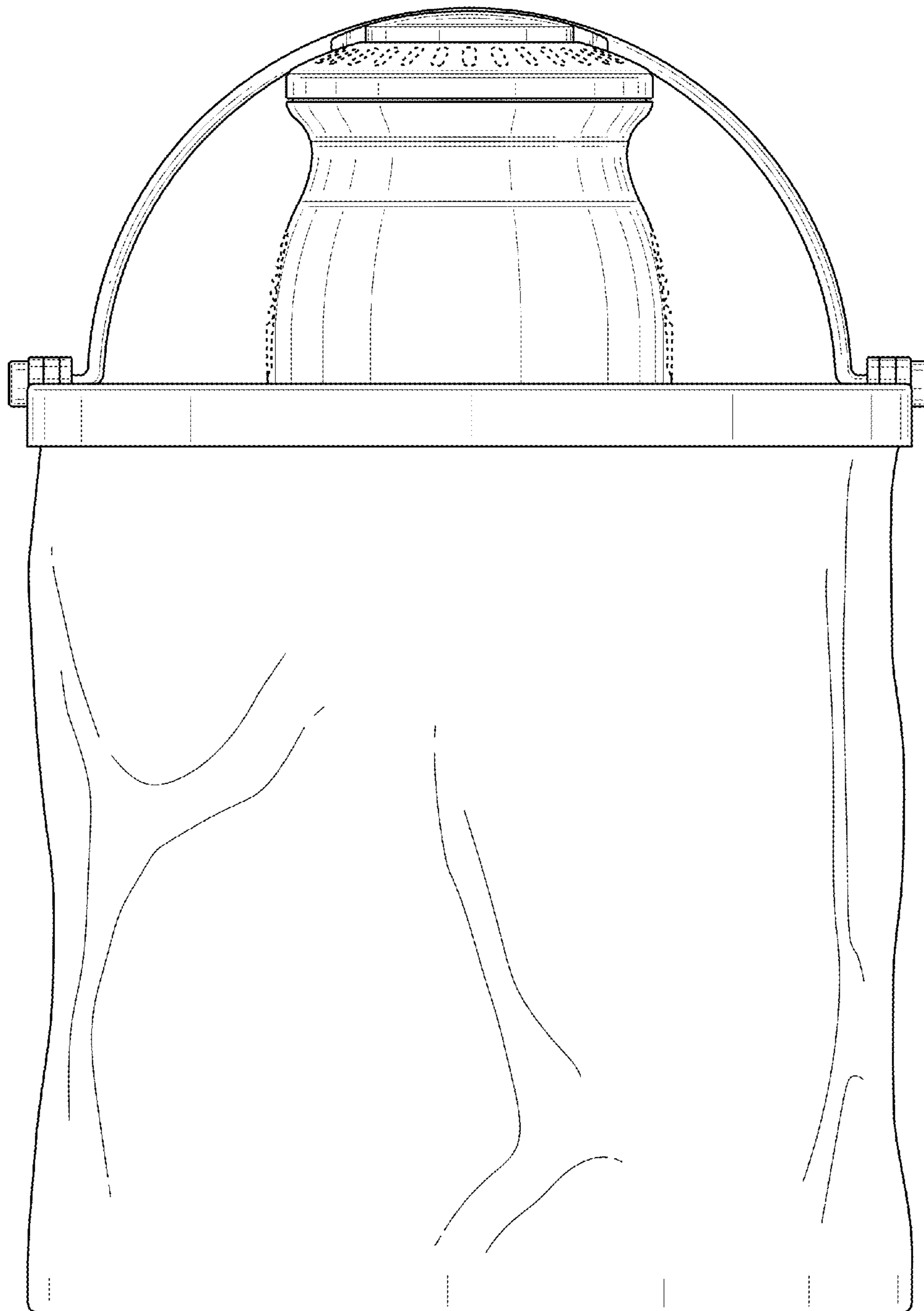

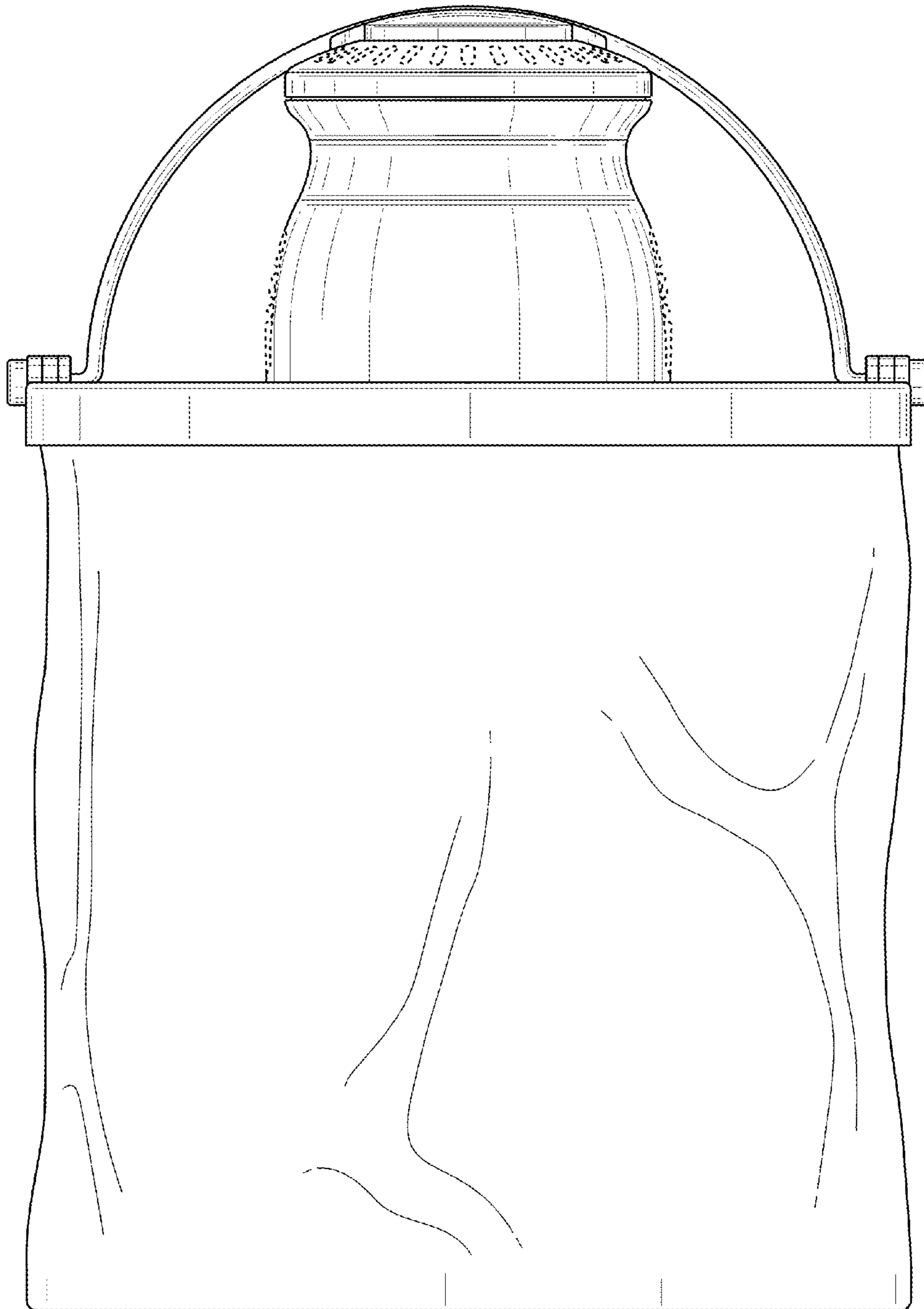

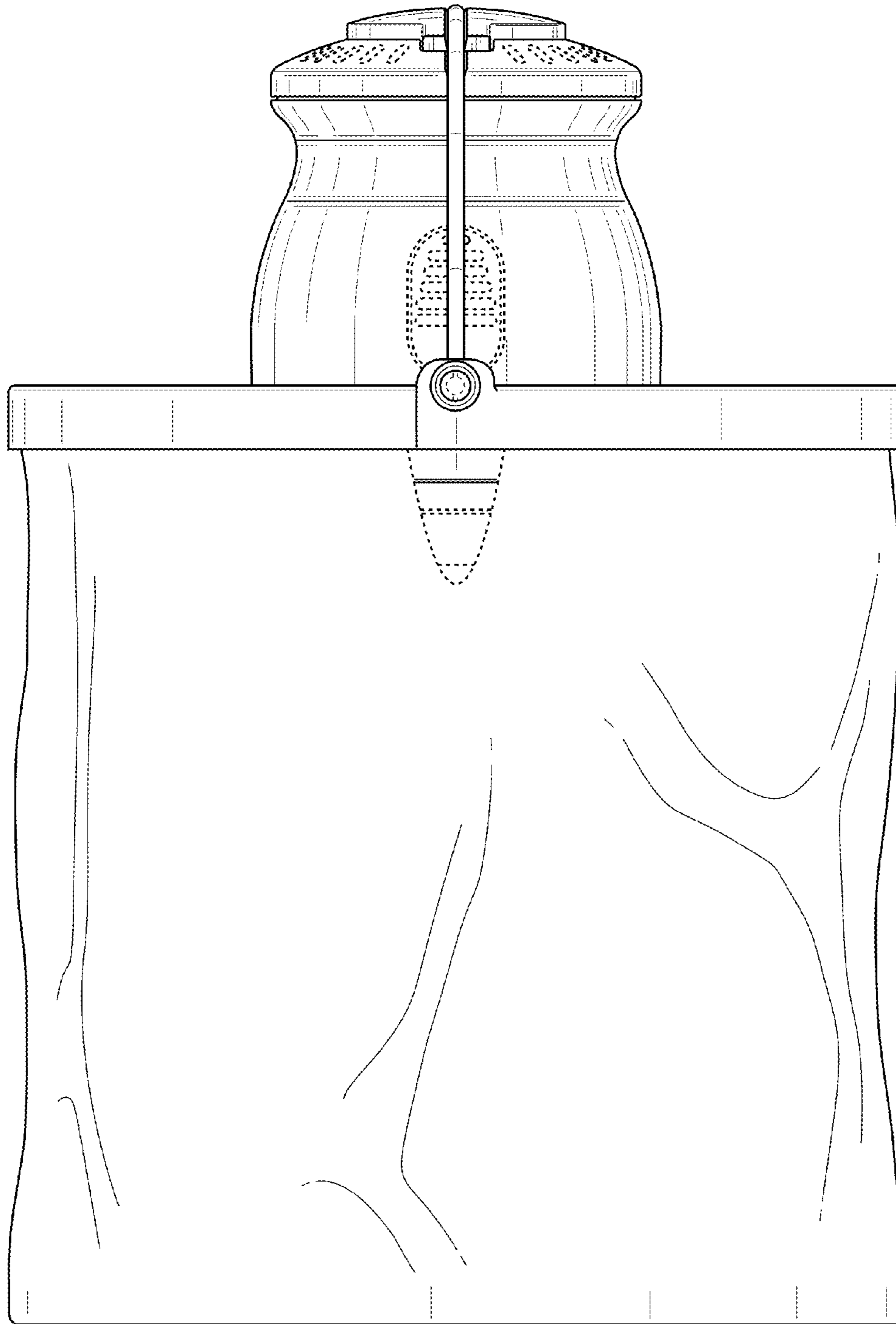

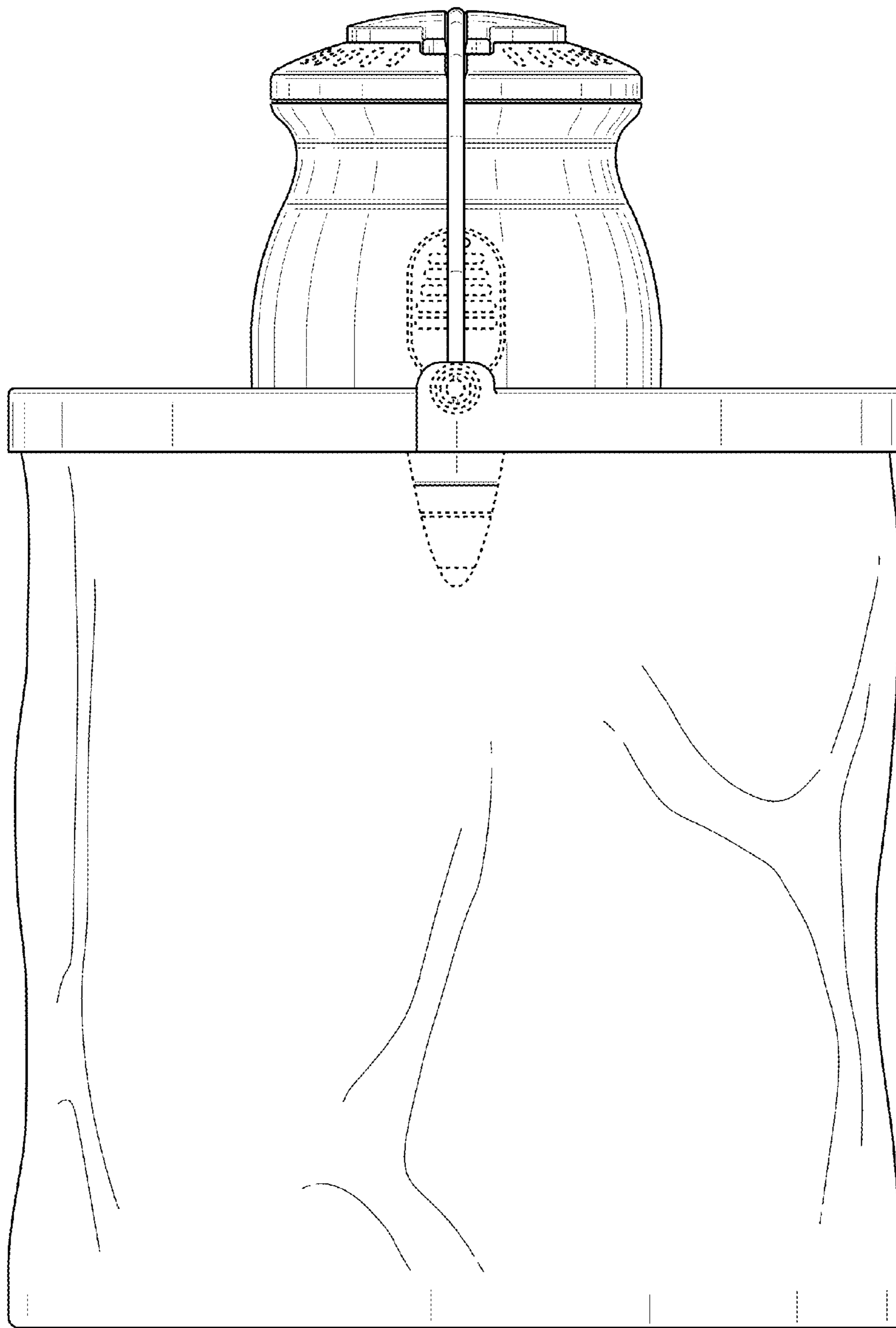

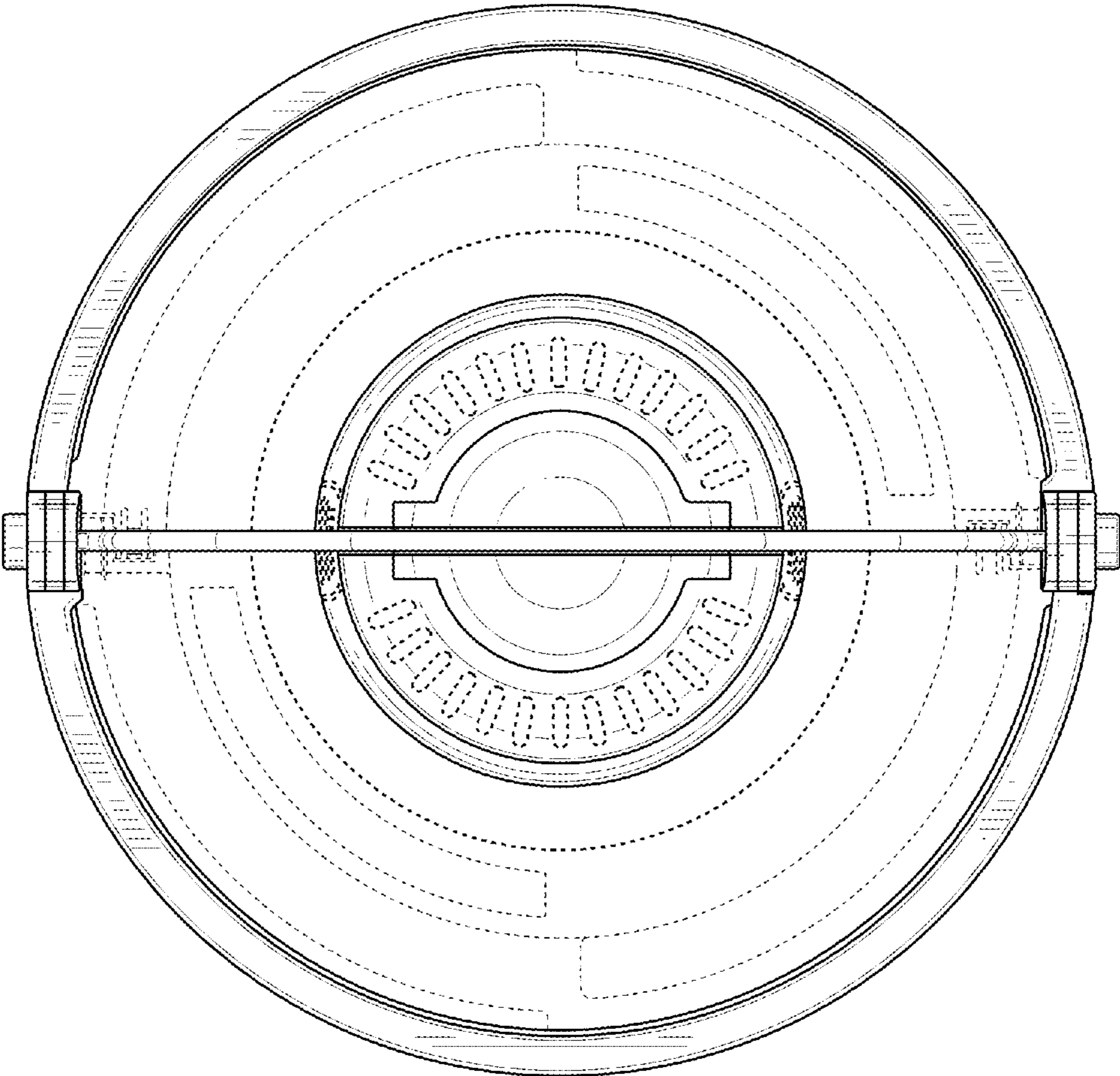

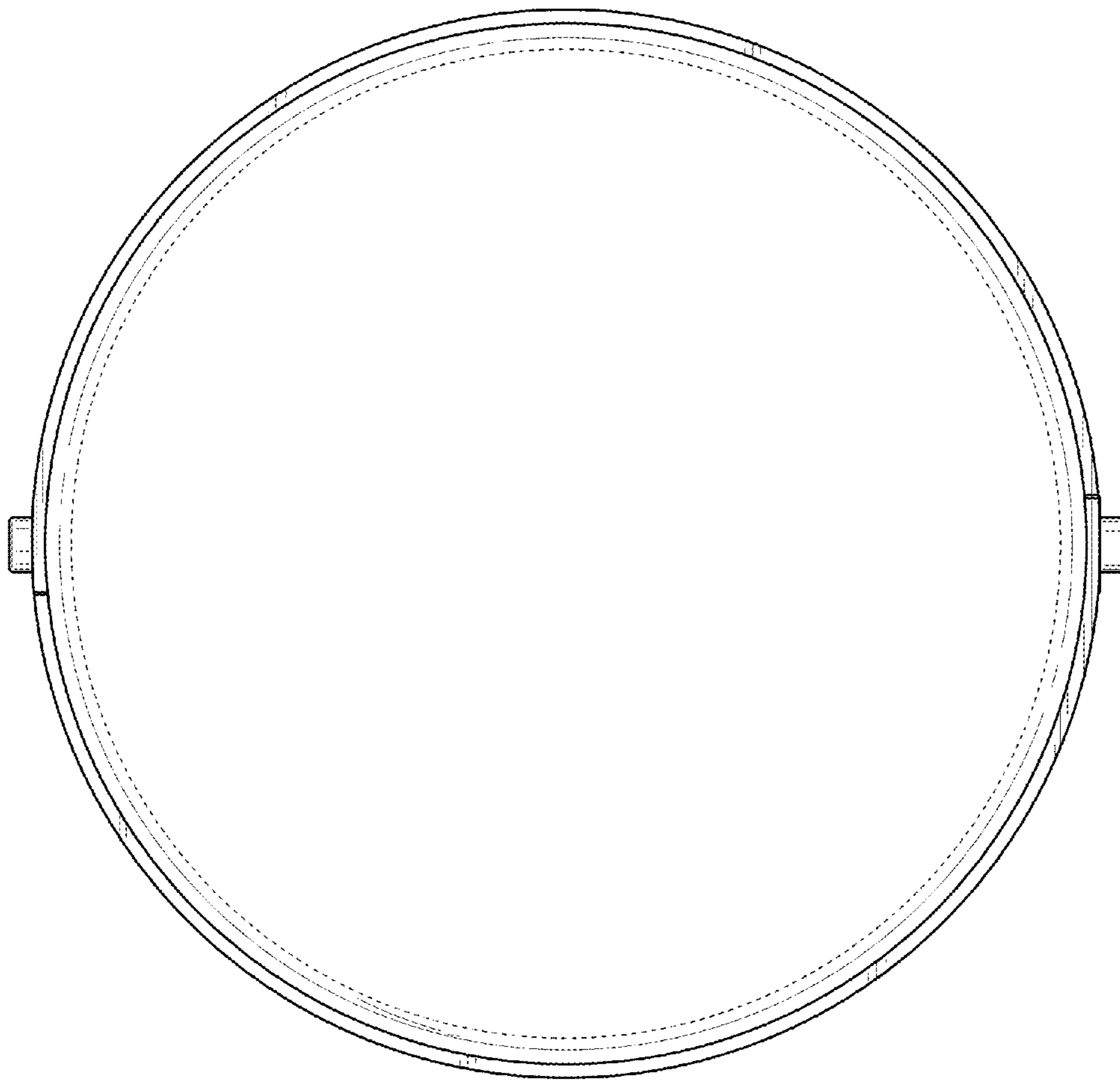
