(57) **CLAIM**

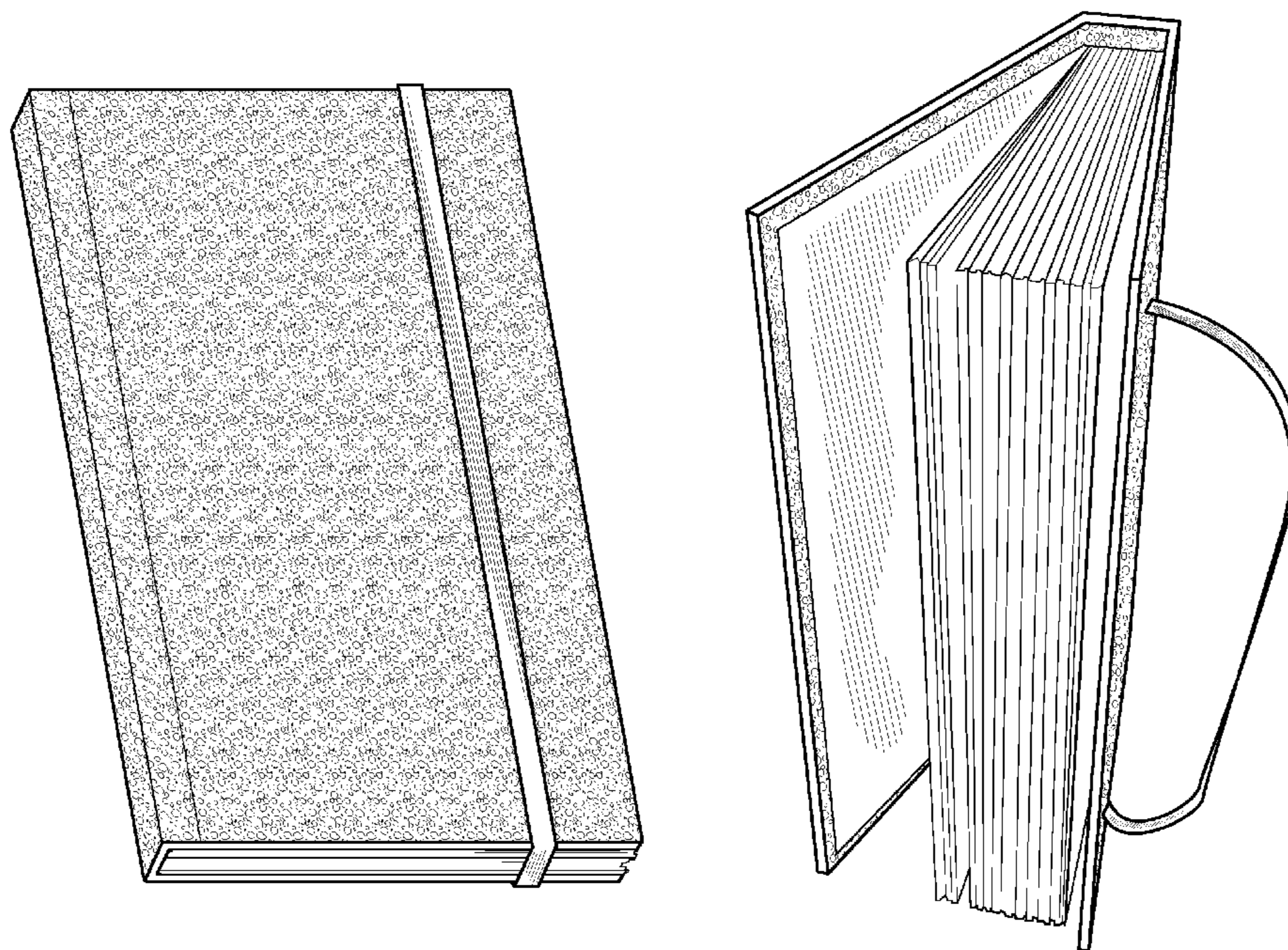
I claim the ornamental design for a football journal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a journal with a football journal, showing my new design in a closed position; FIG. 2 is a front elevational view of FIG. 1; FIG. 3 is a left-side elevational view of FIG. 1; FIG. 4 is a right-side elevational view of FIG. 1; FIG. 5 is a rear elevational view of FIG. 1; FIG. 6 is a top plan view of FIG. 1; FIG. 7 is a bottom plan view of FIG. 1; FIG. 8 is a perspective view thereof, illustrated in a partially open position; and, FIG. 9 is an enlarged view thereof, taken along line 9 of FIG. 5.

The dash-dot-dash lines in FIG. 5 annotate the area from which the enlarged view of FIG. 9 is from and form no part of the claimed design.

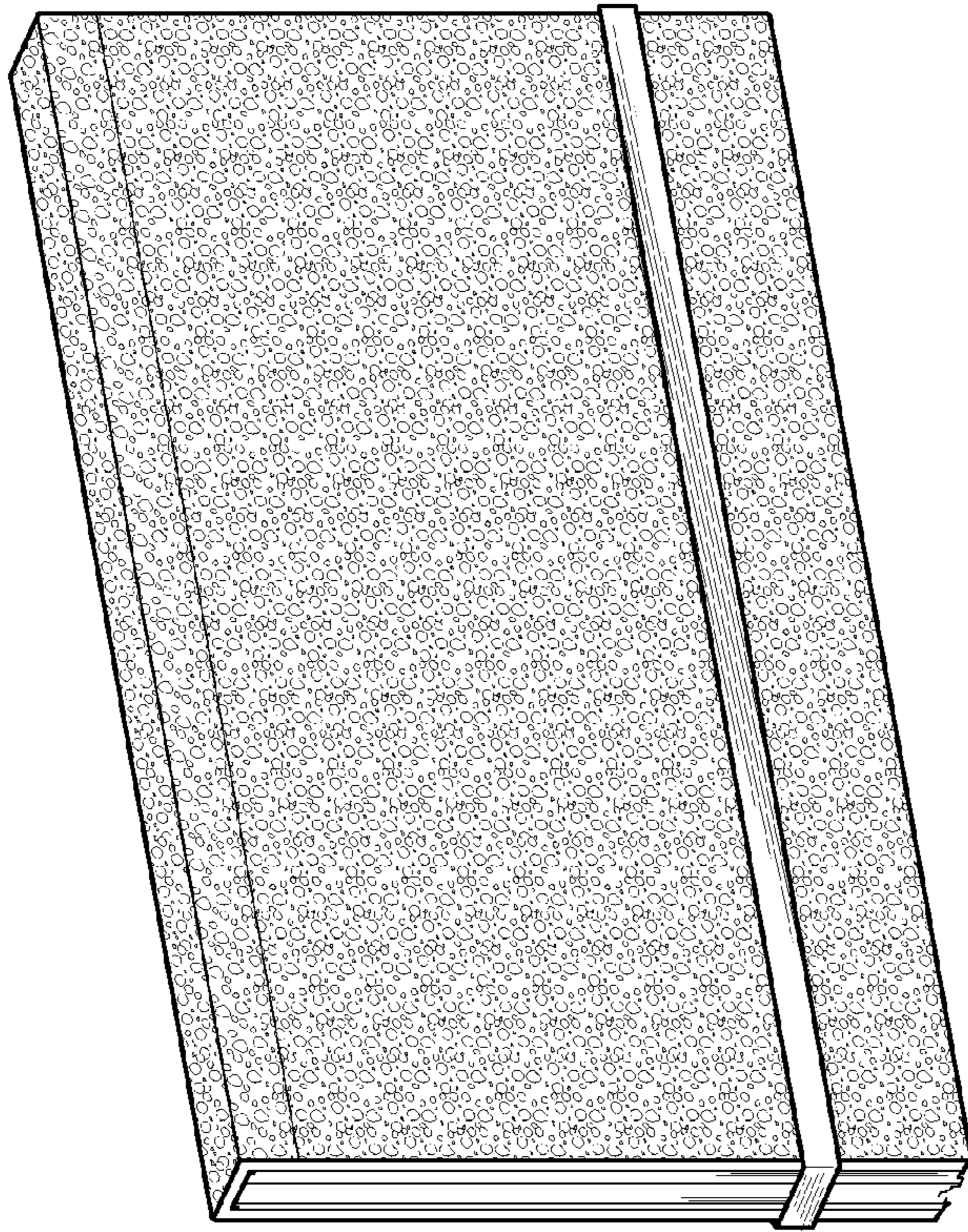

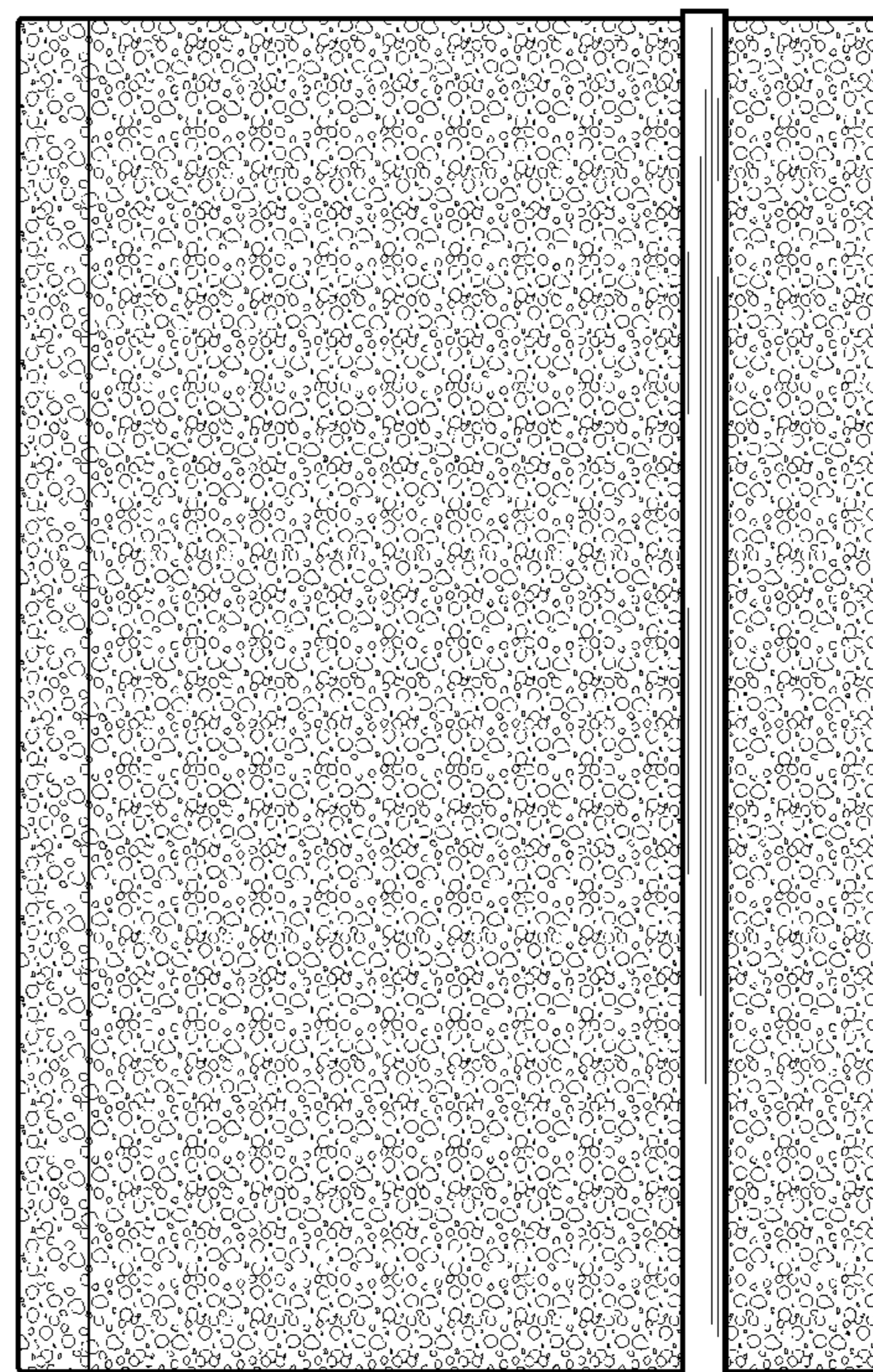

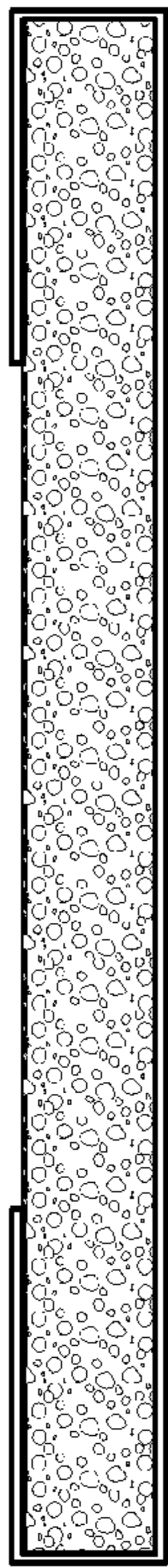

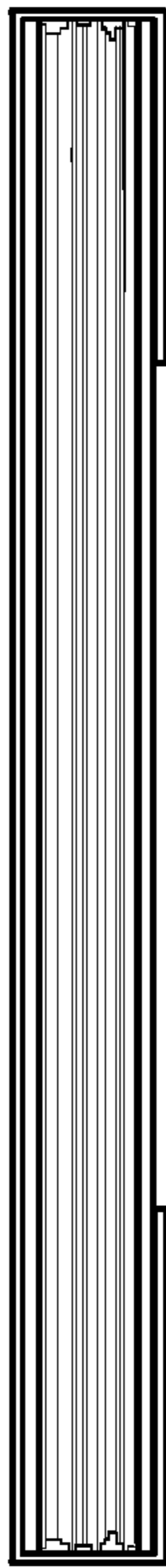

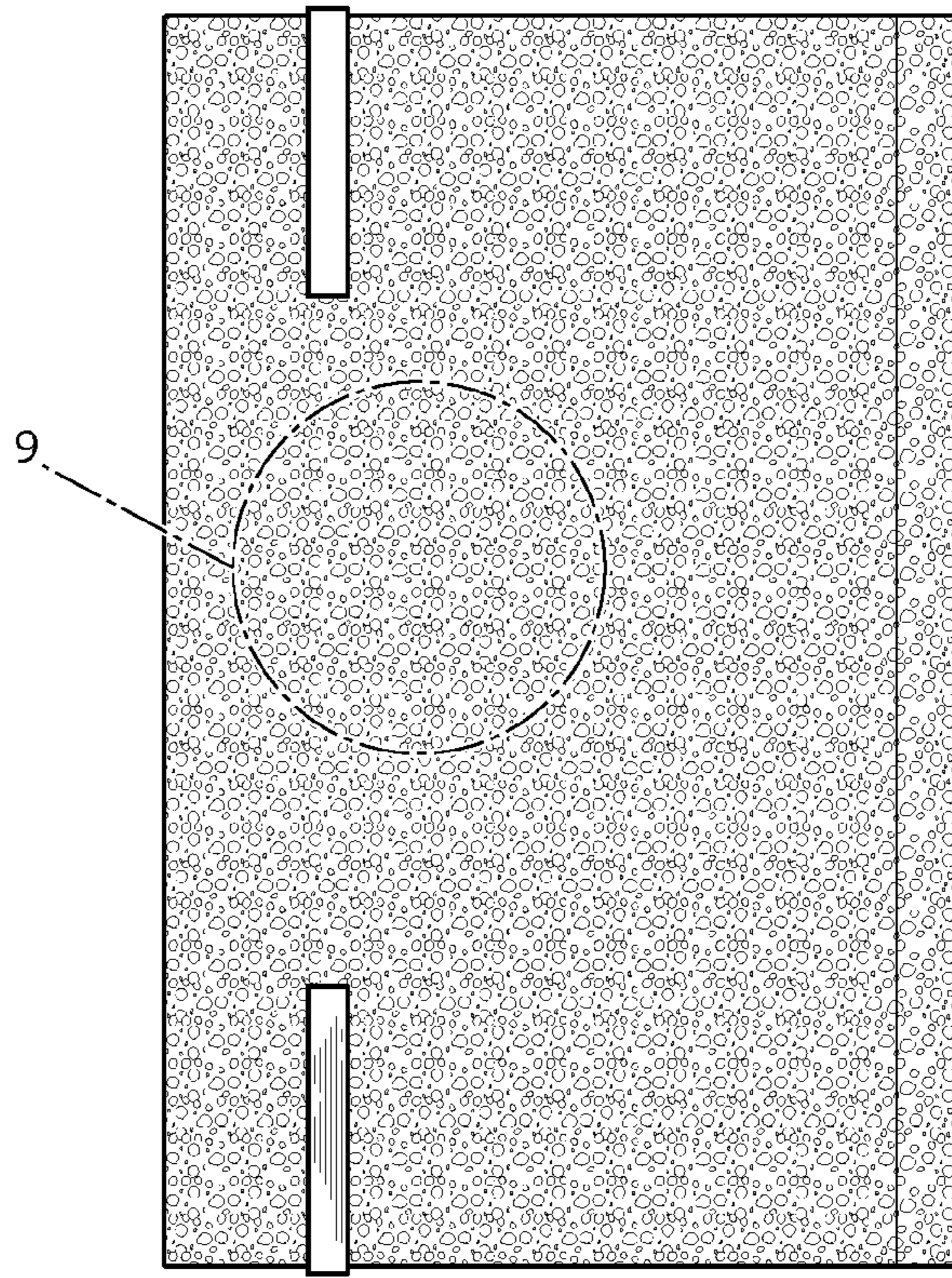

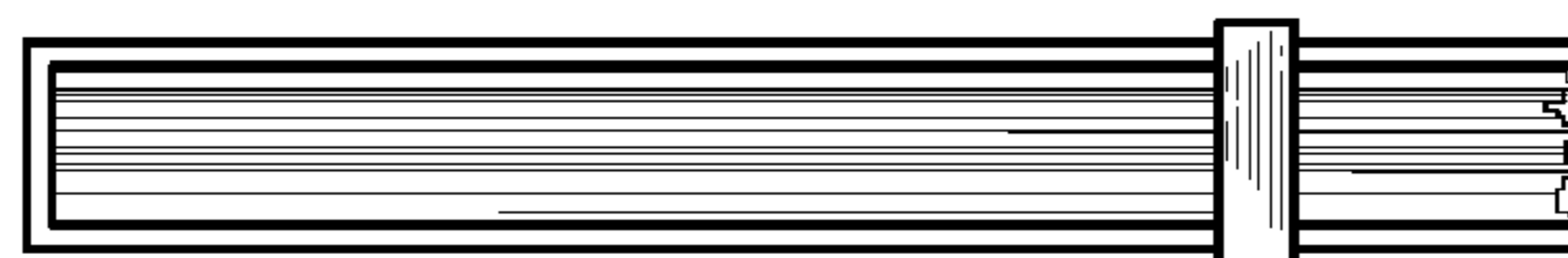

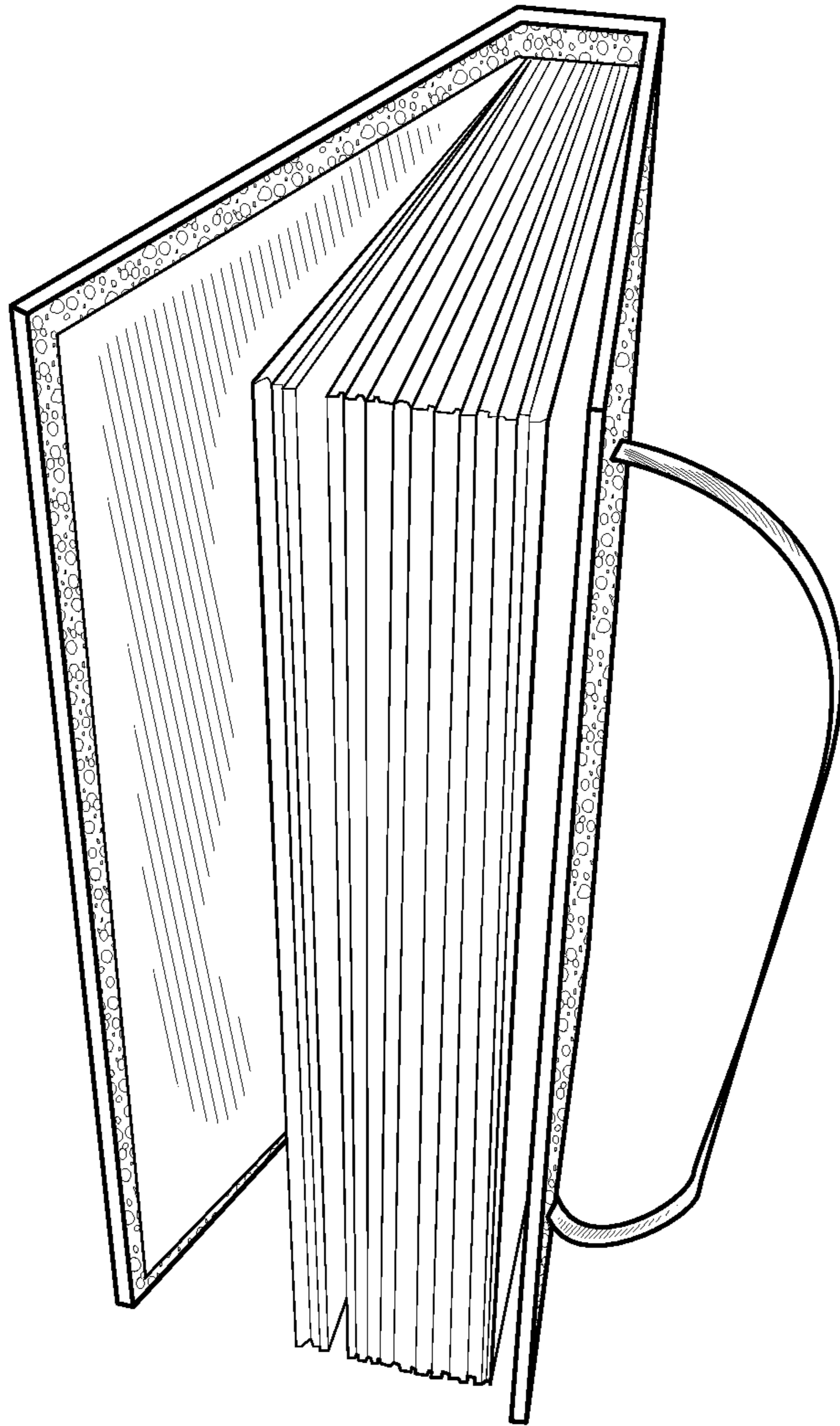

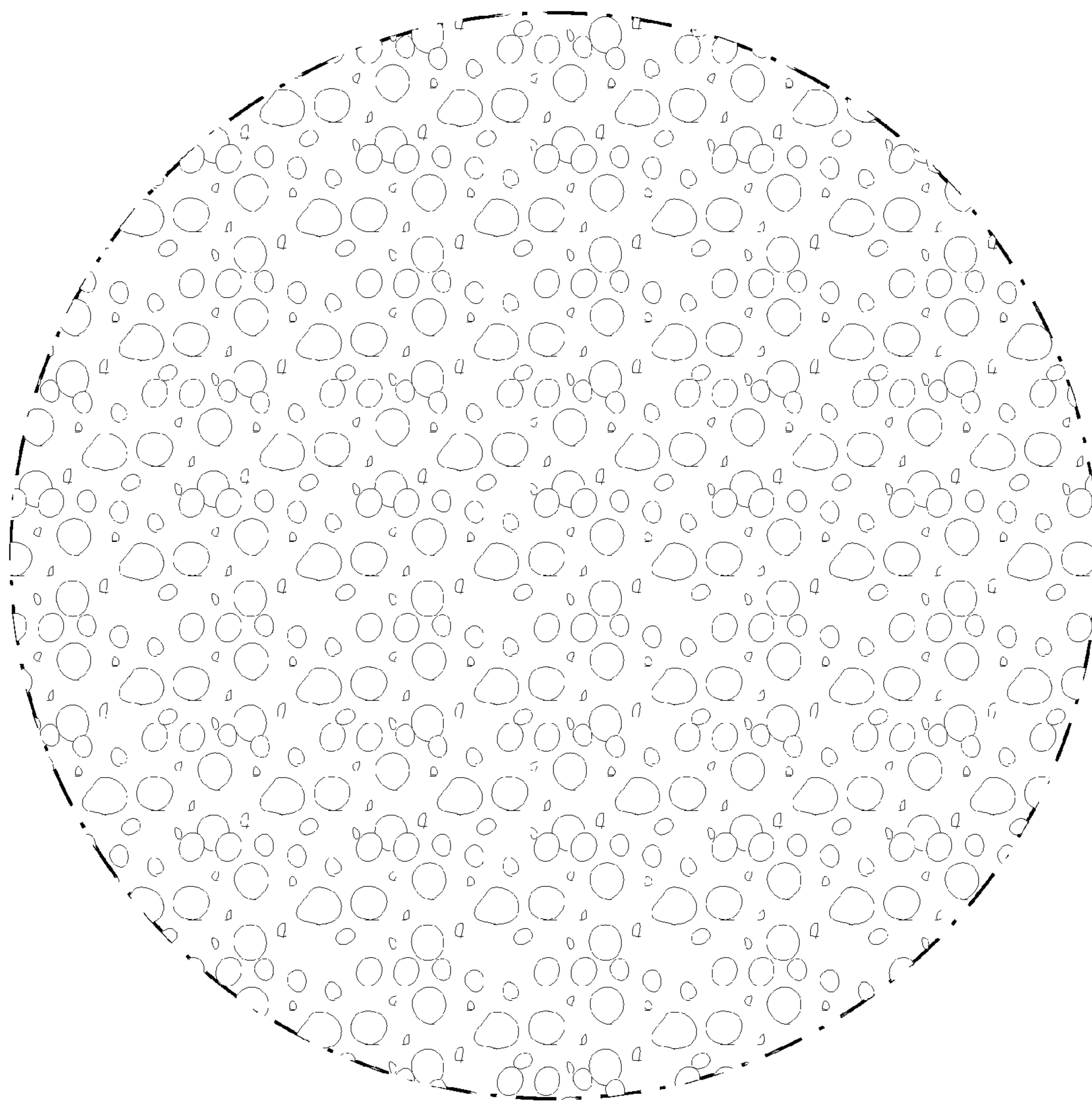
