The ornamental design for a set of toy blocks, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a set of toy blocks showing my design in an assembled configuration;

 FIG. 8 is a front perspective view of a first block of the design, the remaining blocks omitted for clarity of illustration;
 FIG. 9 is a front elevational view of FIG. 8, the rear elevational view, the top plan view, the bottom plan view, the left side elevational view, and the right side elevational view all being a mirror image thereof;

 FIG. 18 is a front perspective view of a fourth block of the design, the remaining blocks omitted for clarity of illustration;

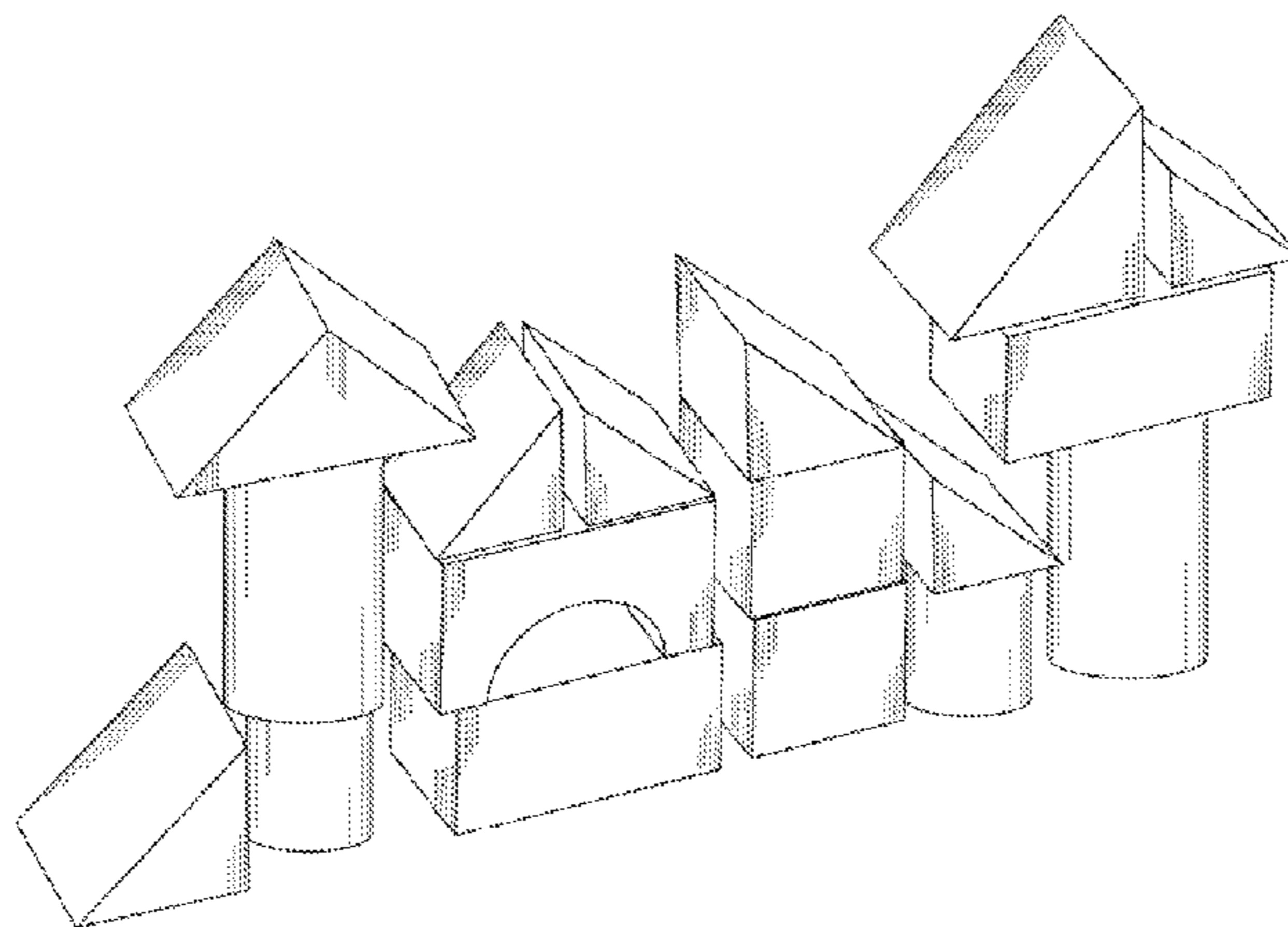


FIG. 19 is a front elevational view of FIG. 18 with the rear elevational view being a mirror thereof;

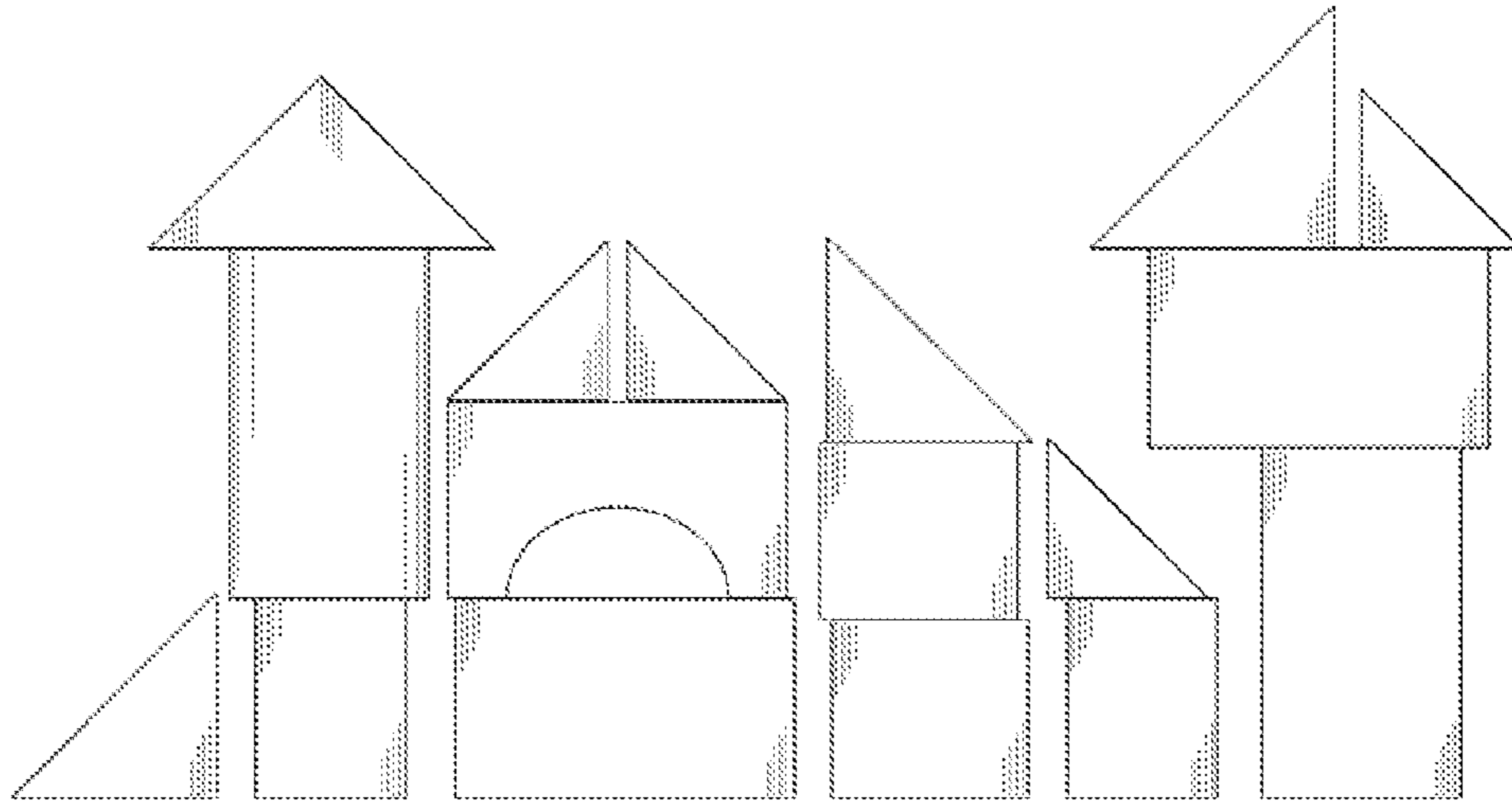

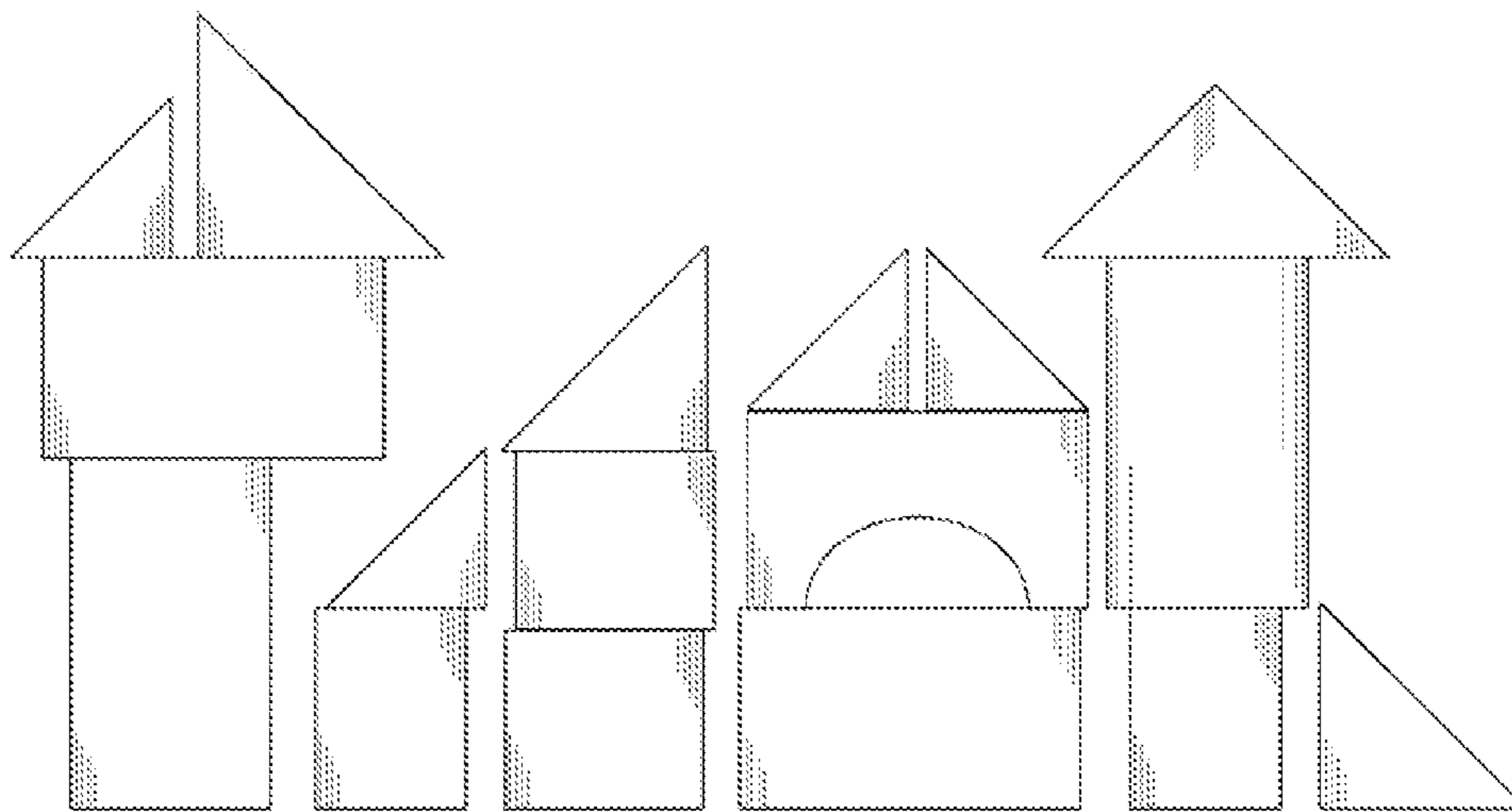

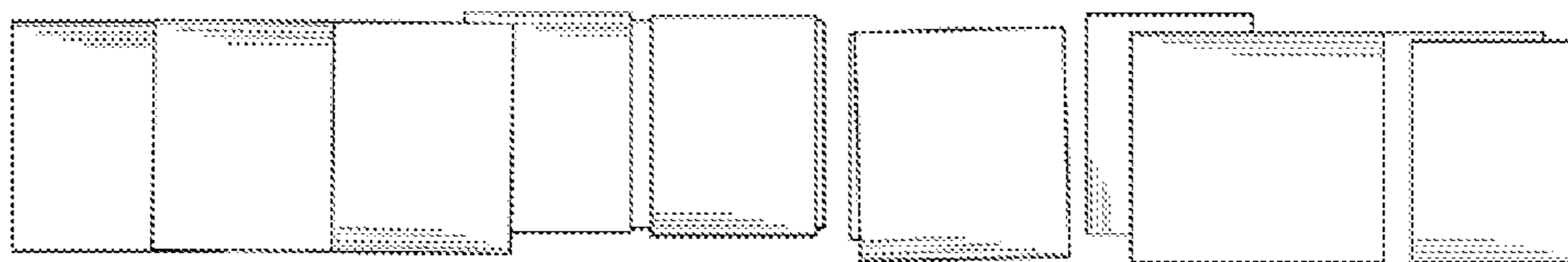

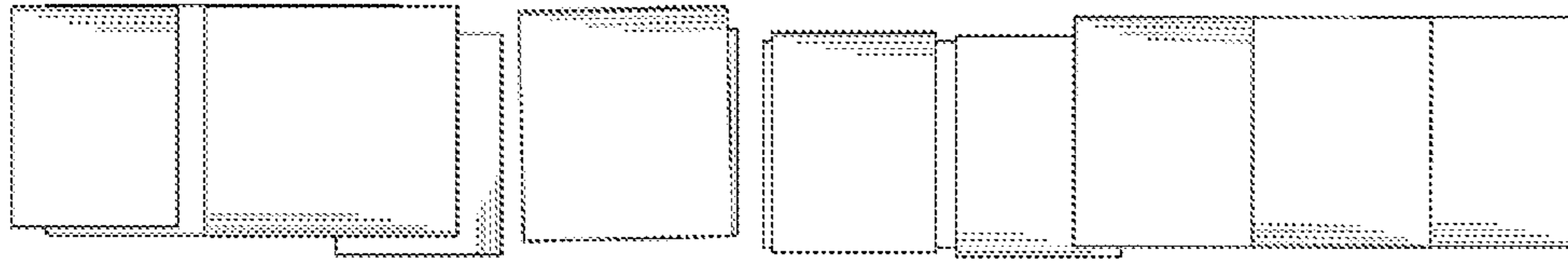

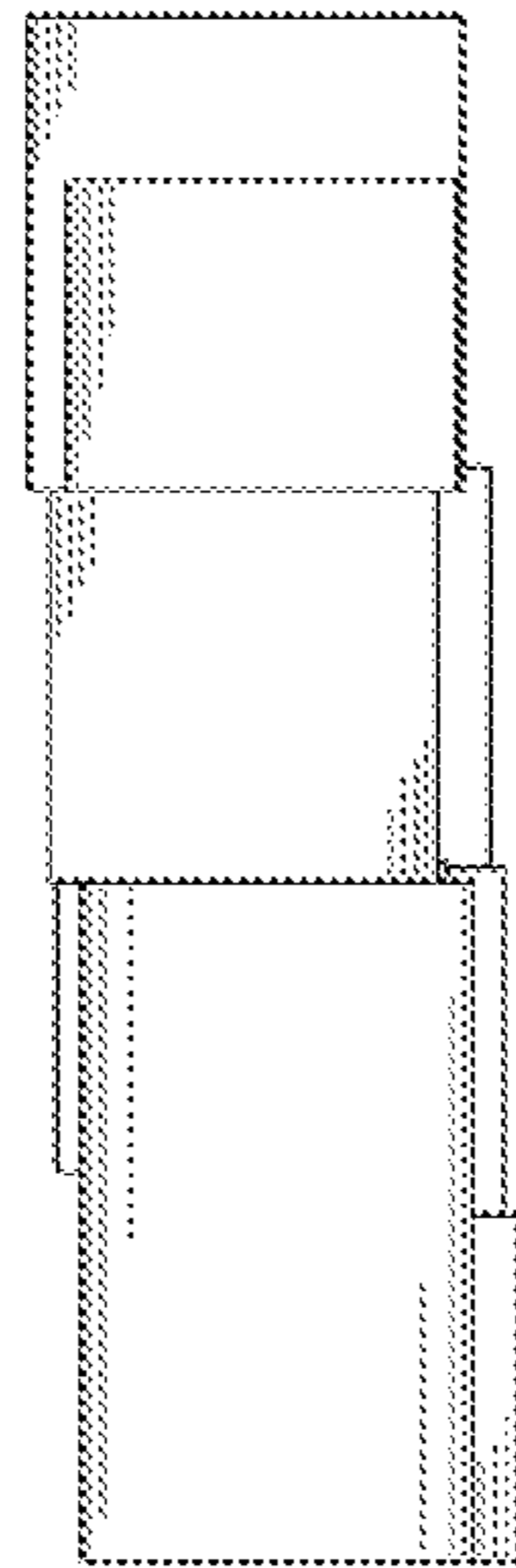

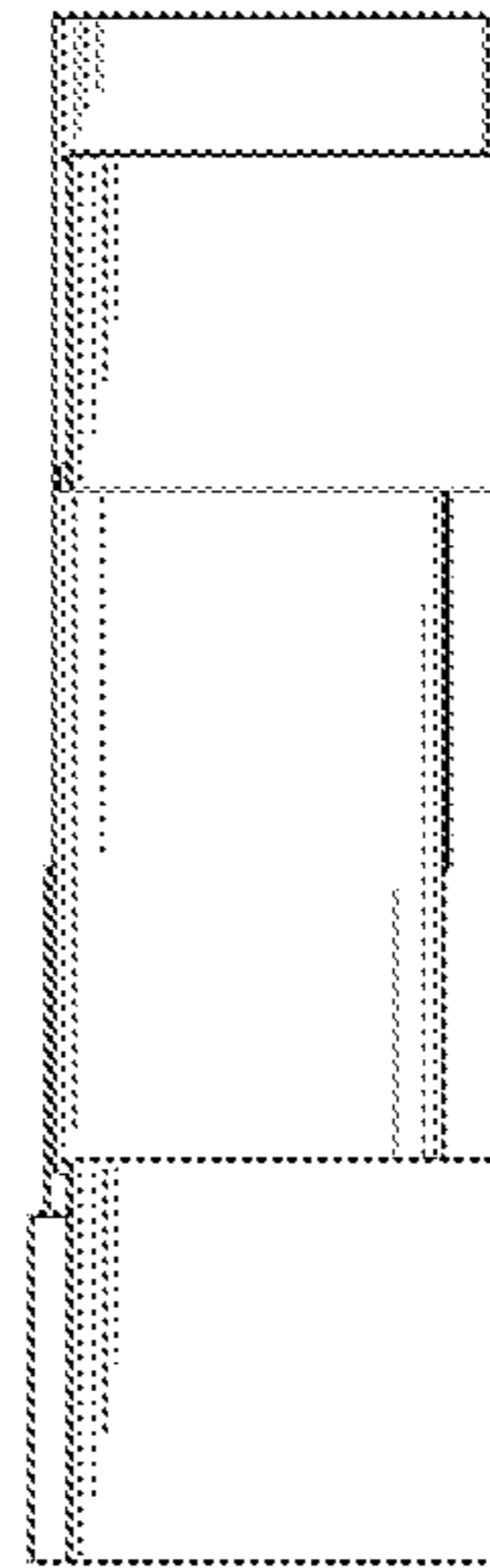

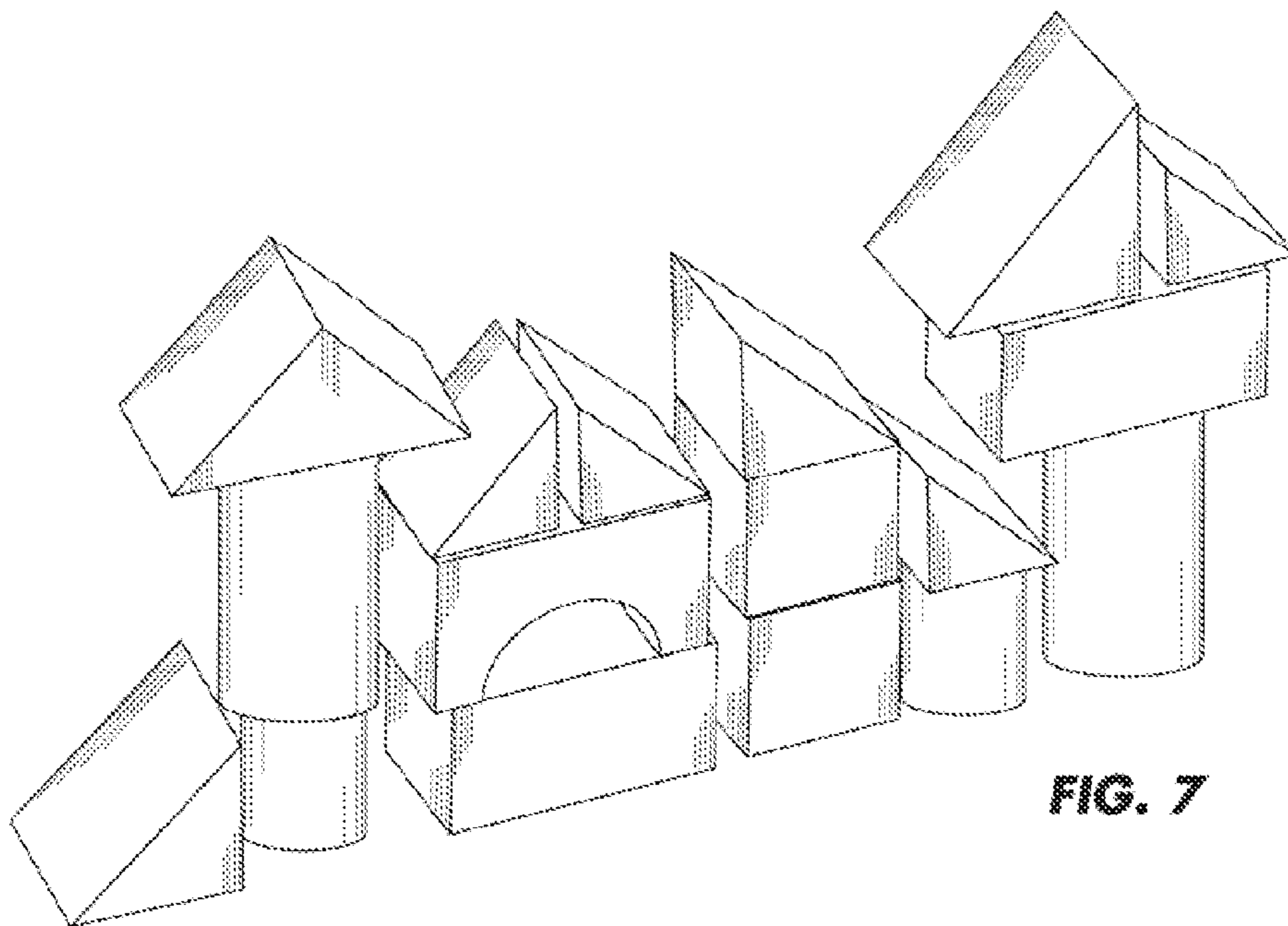

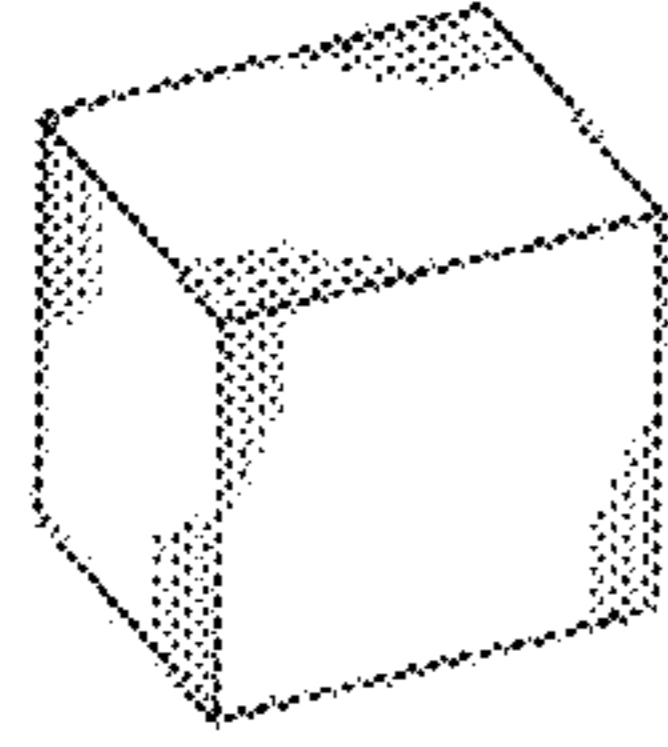

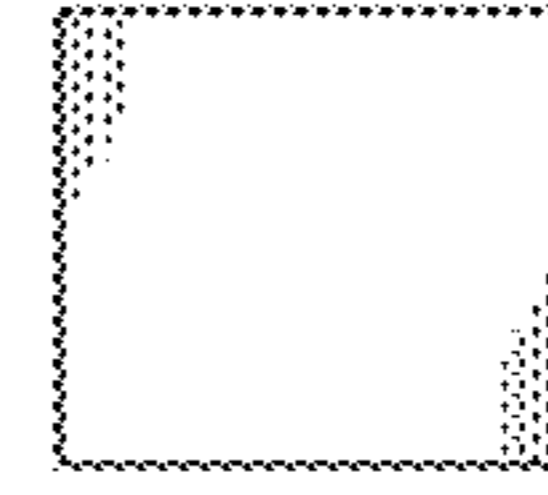

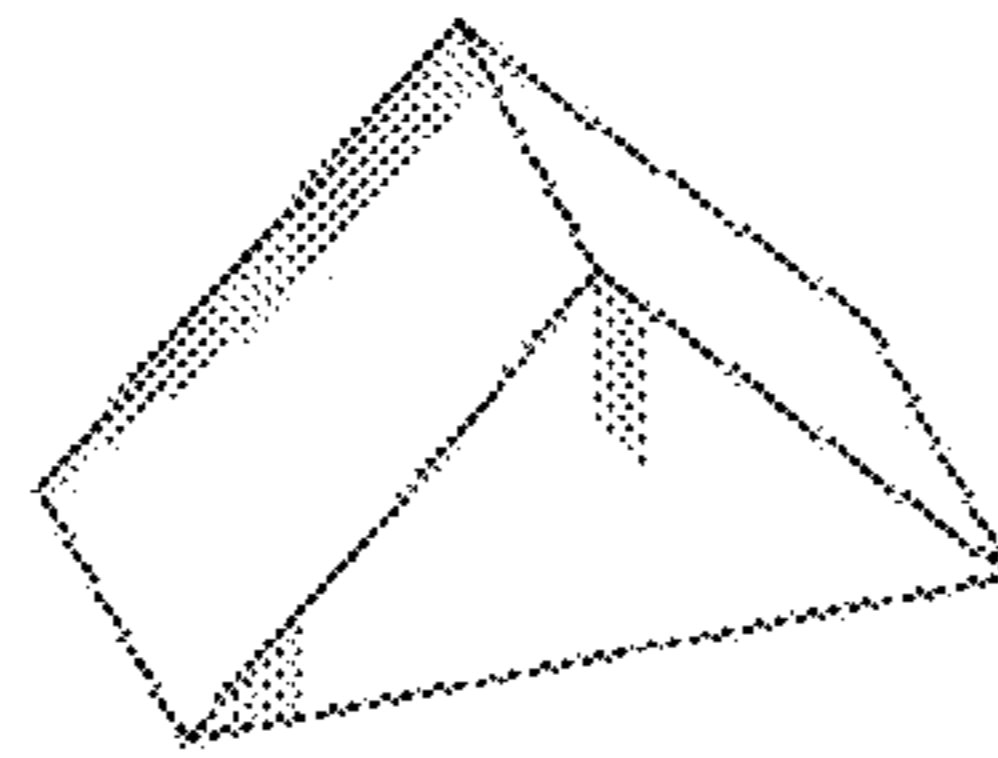

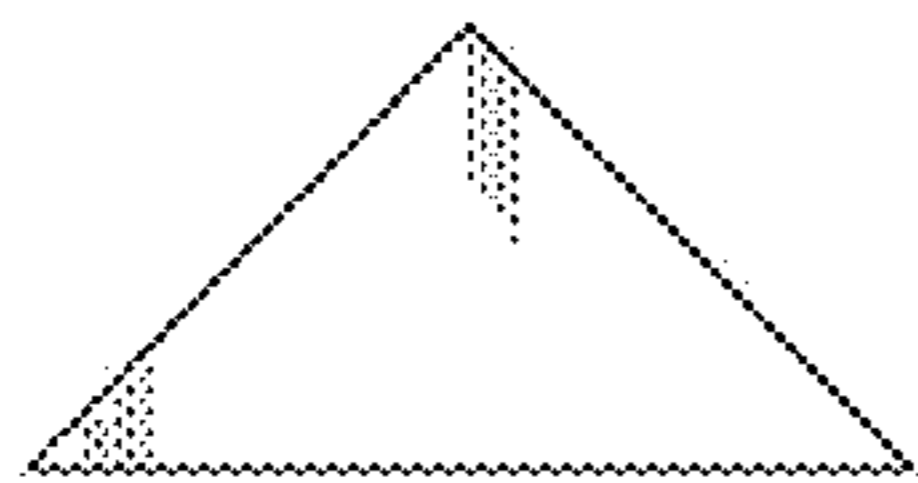

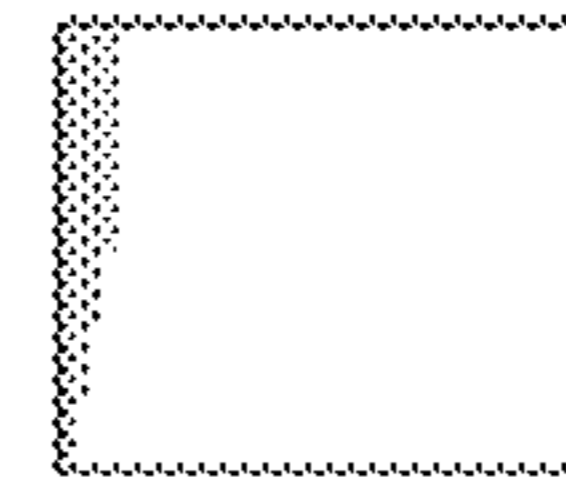

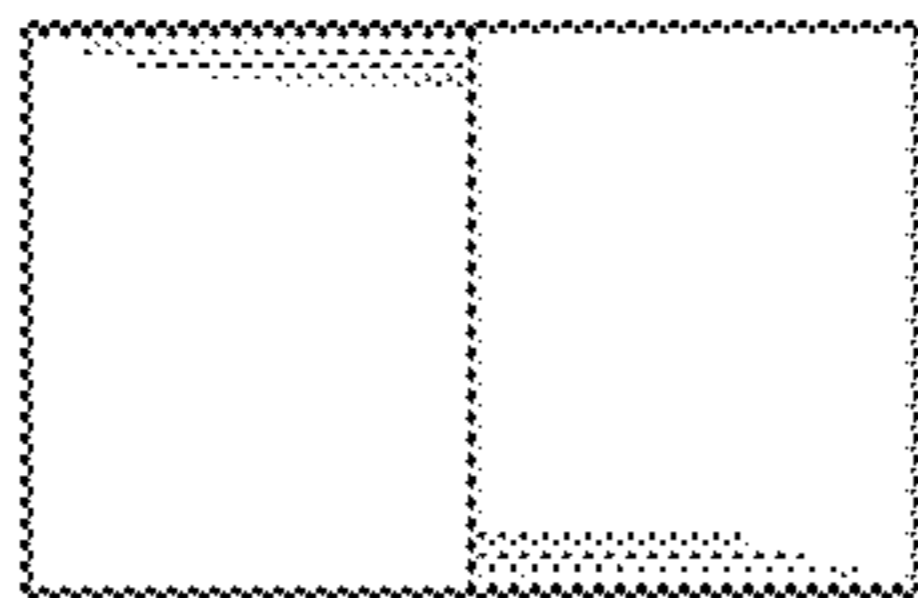

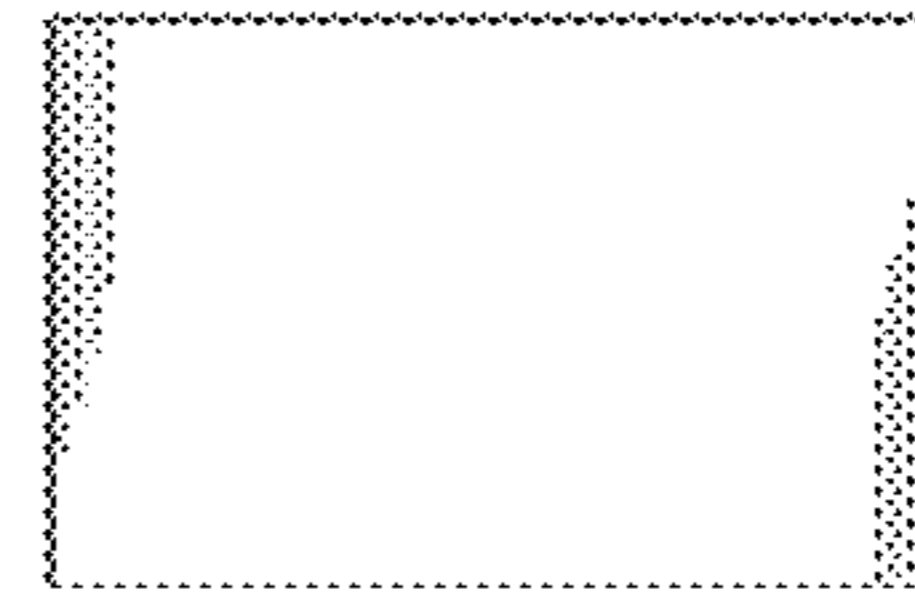

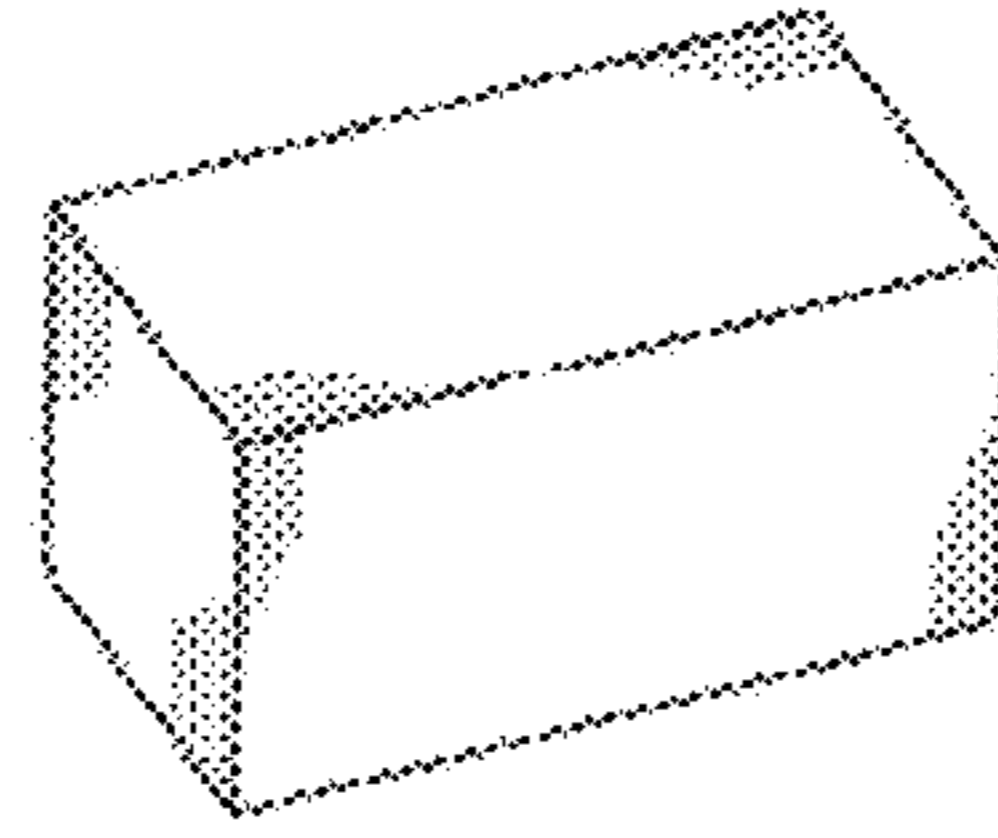

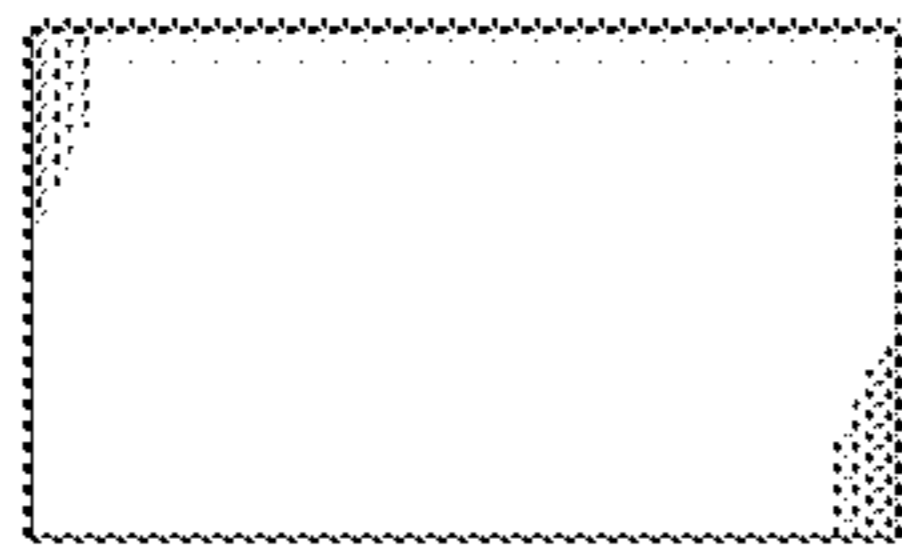

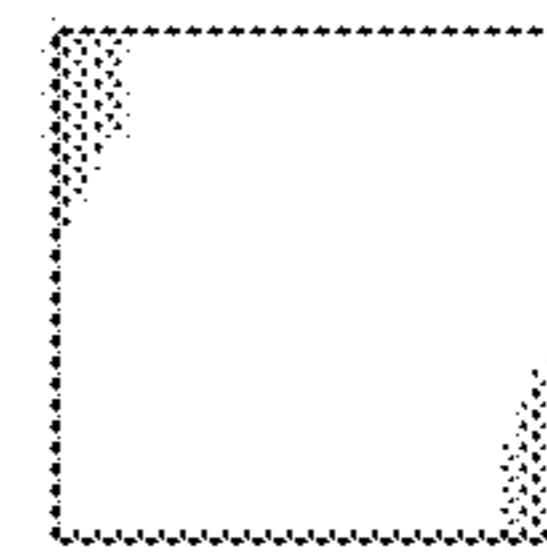

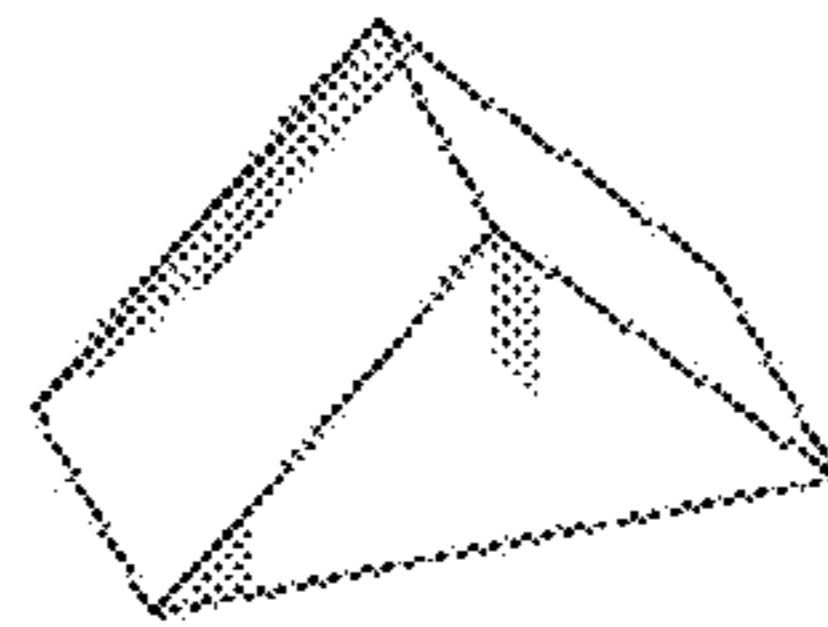

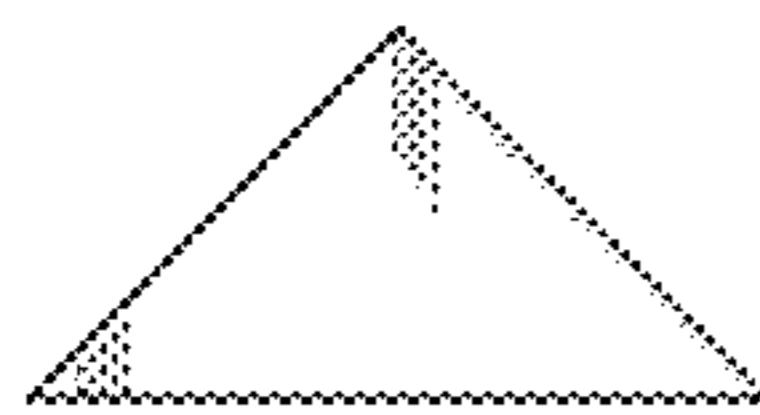

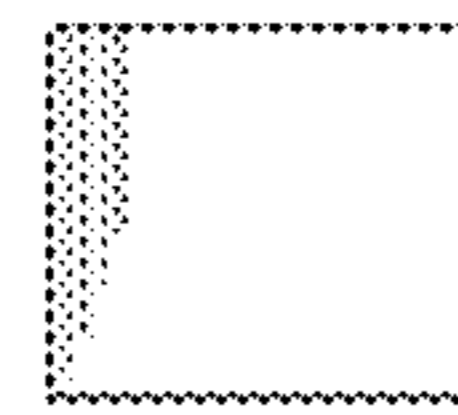

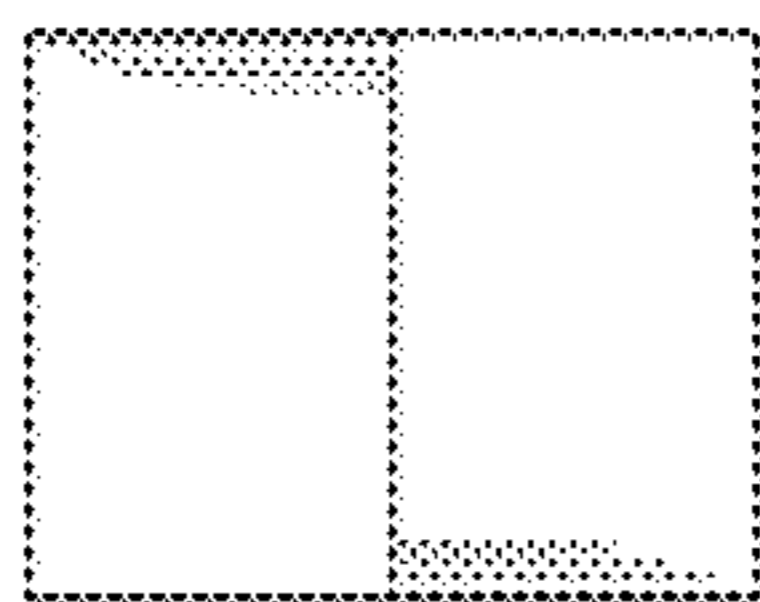

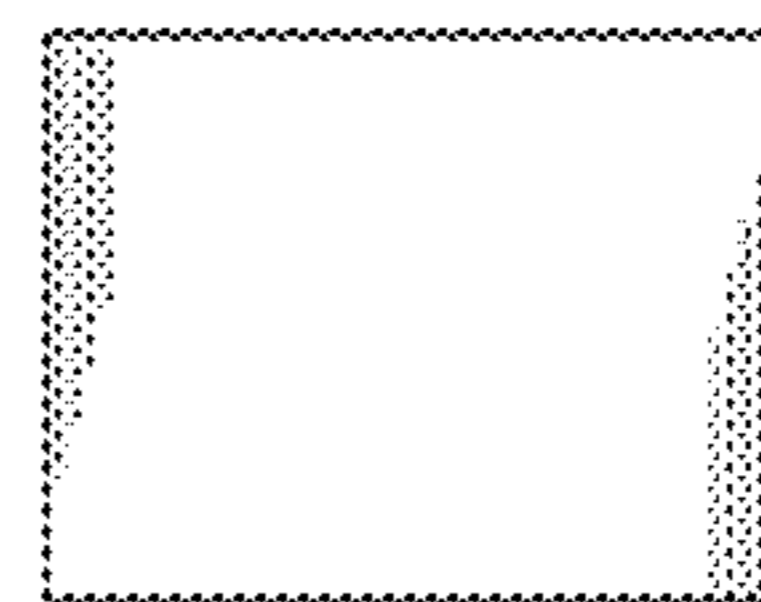

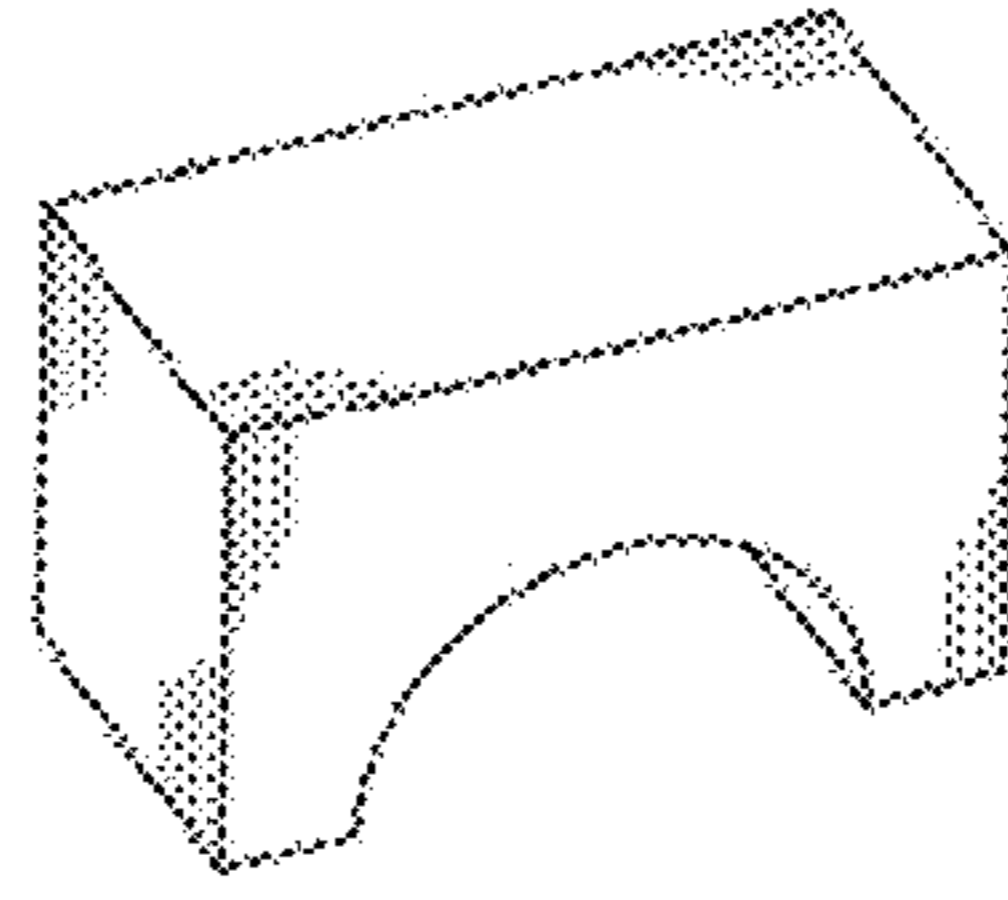

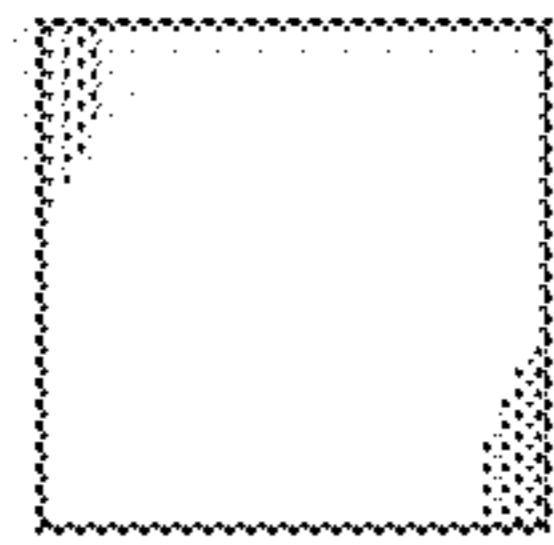

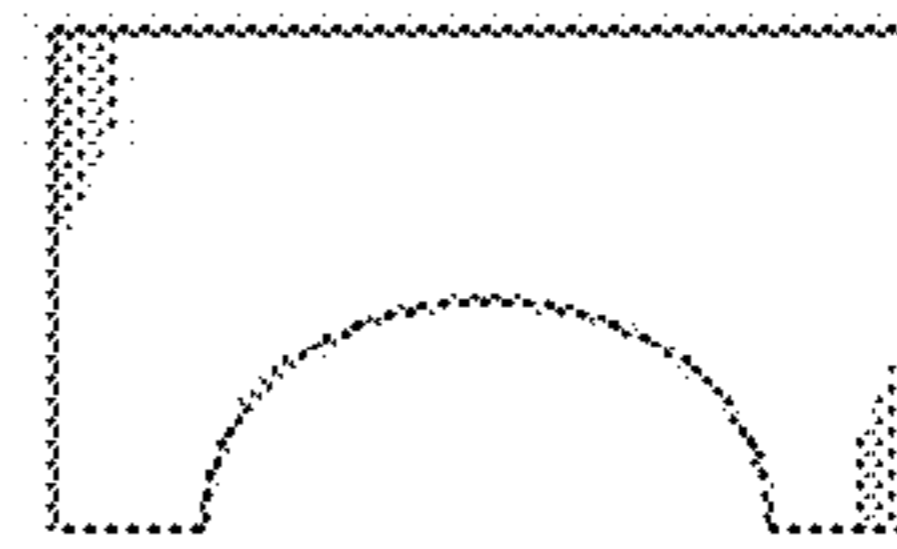

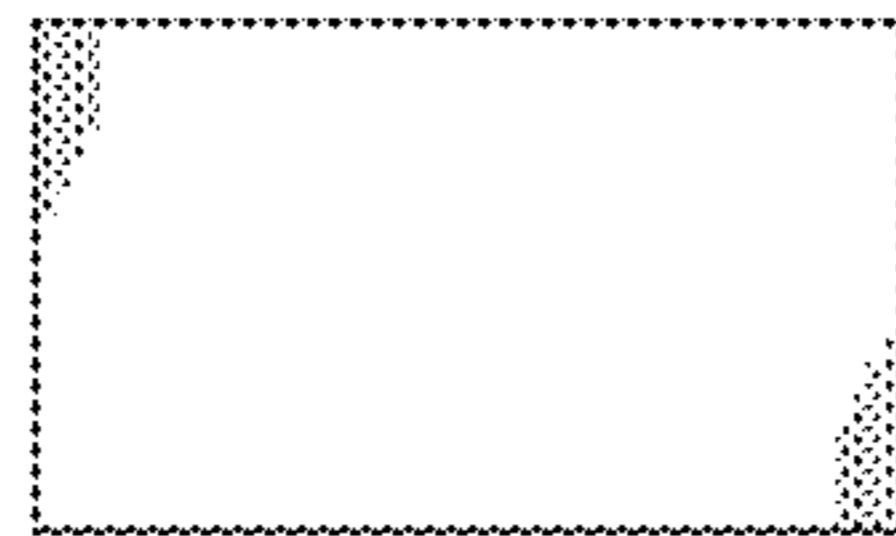

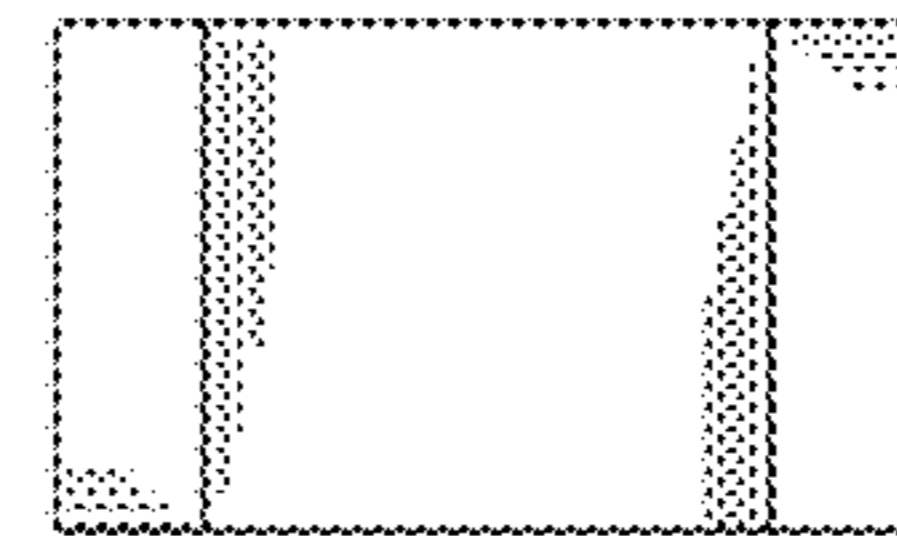

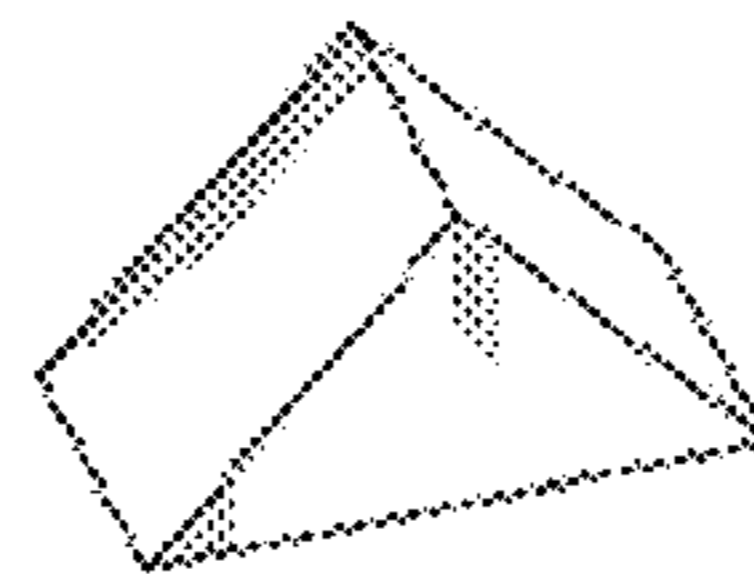

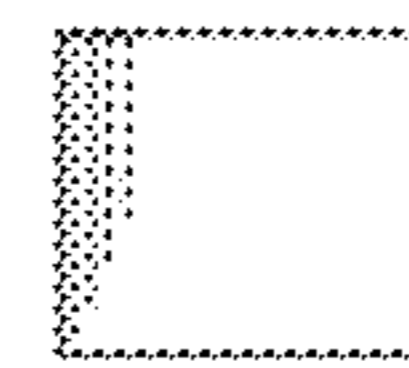

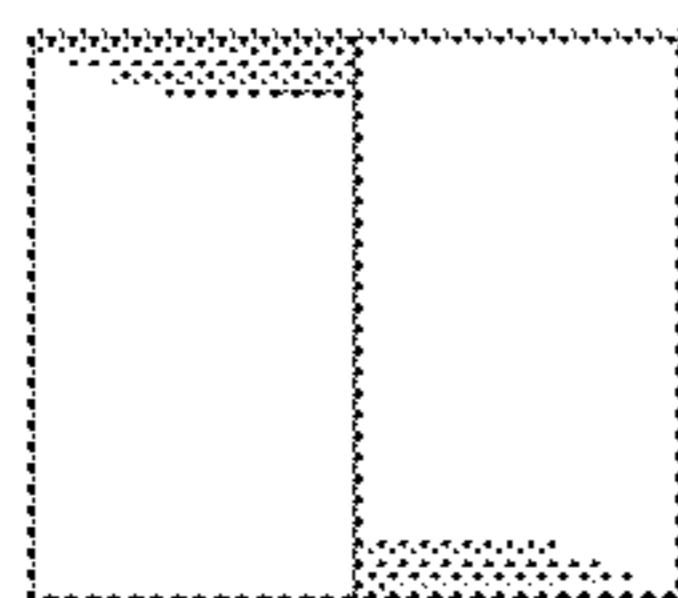

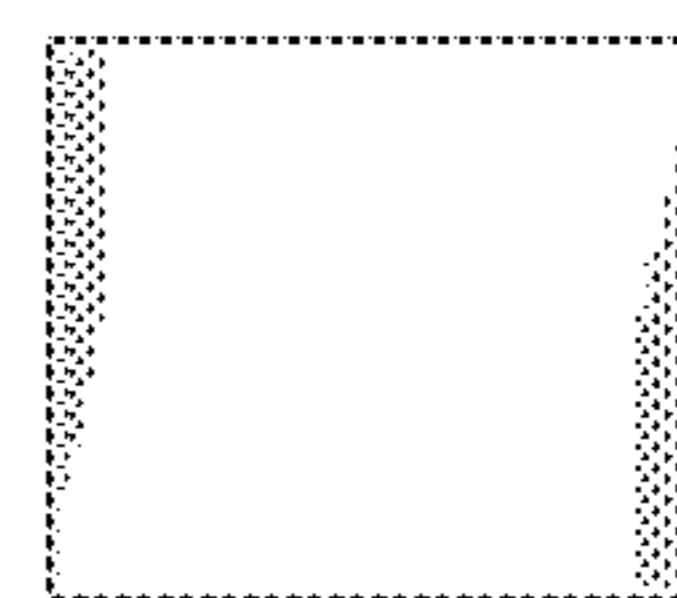

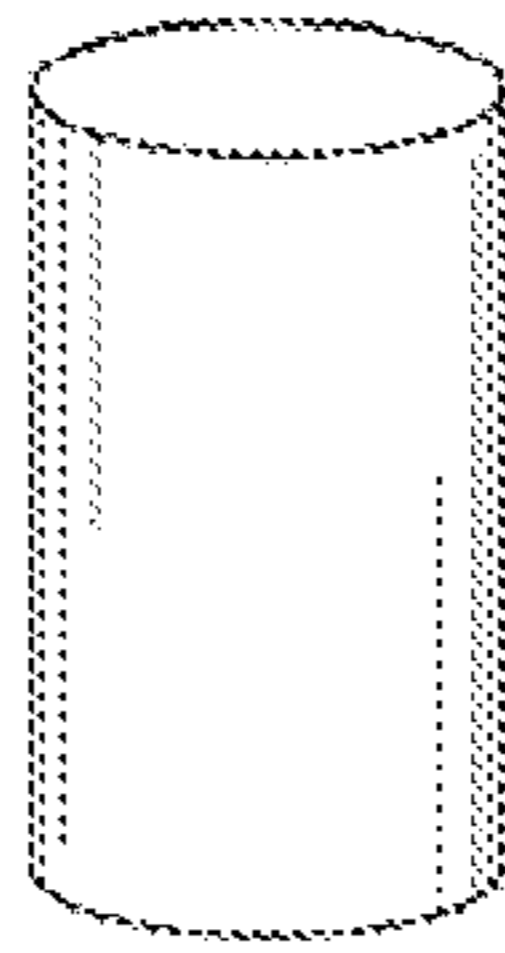

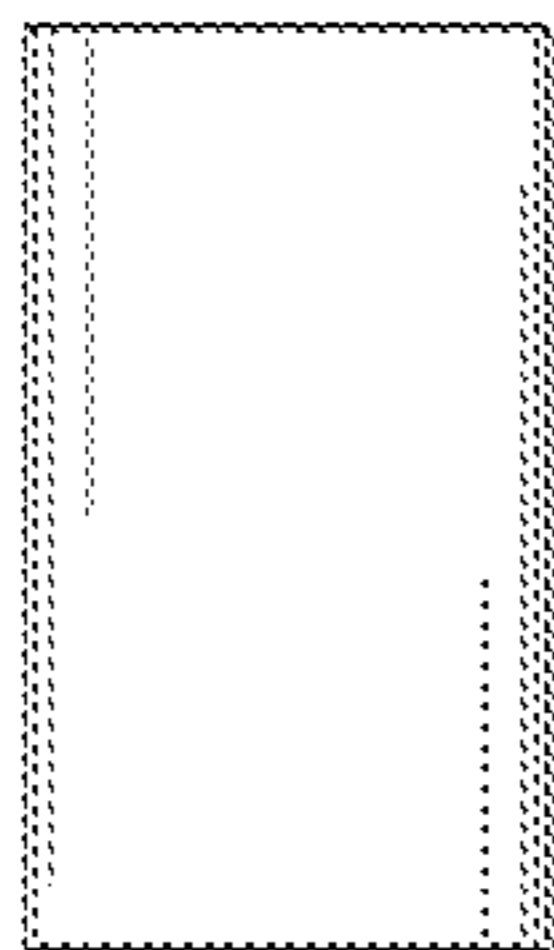

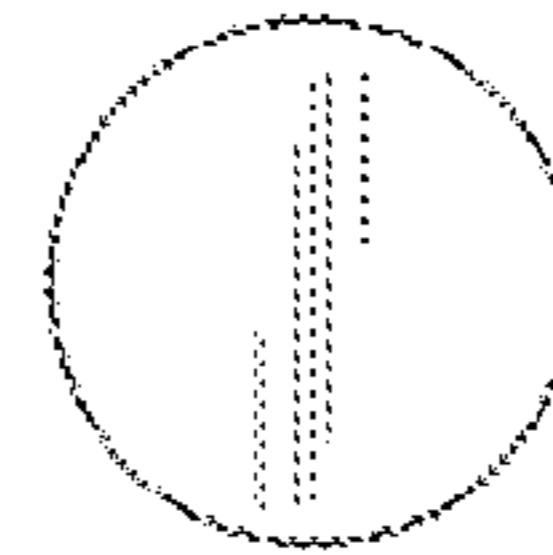

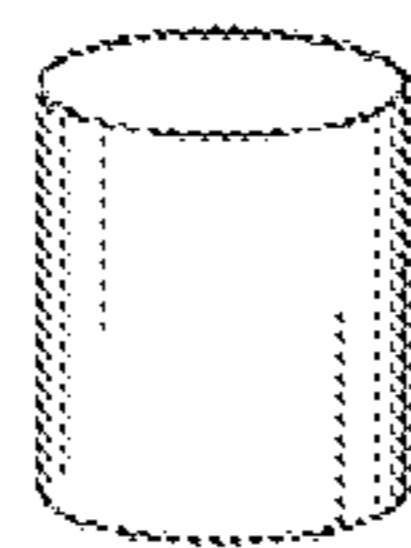

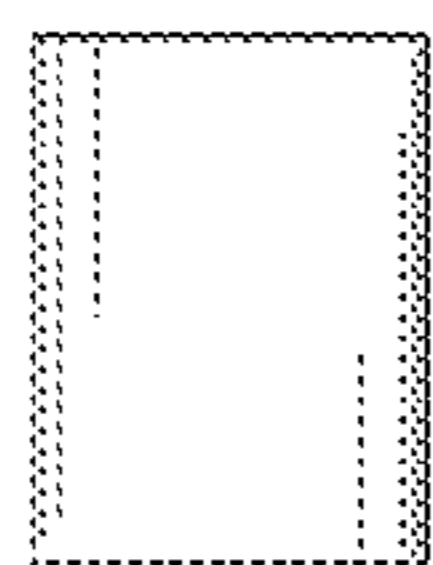

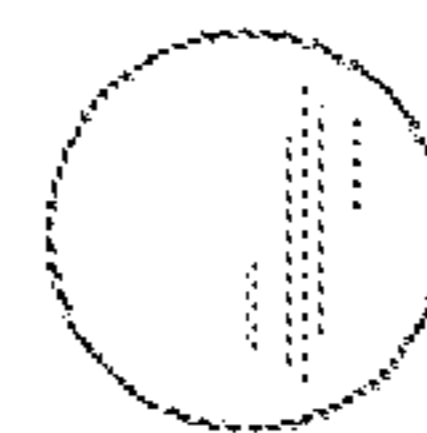
