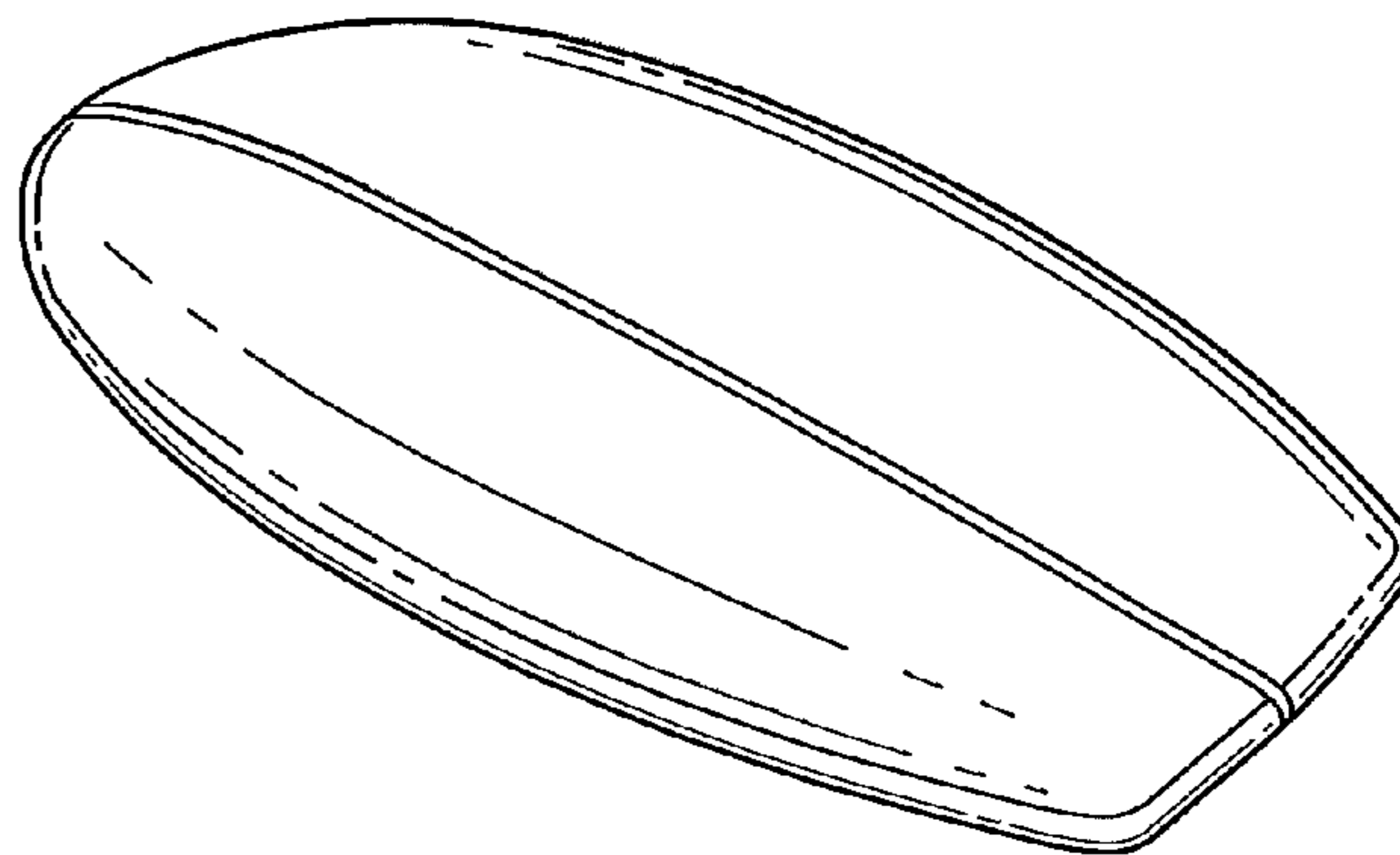
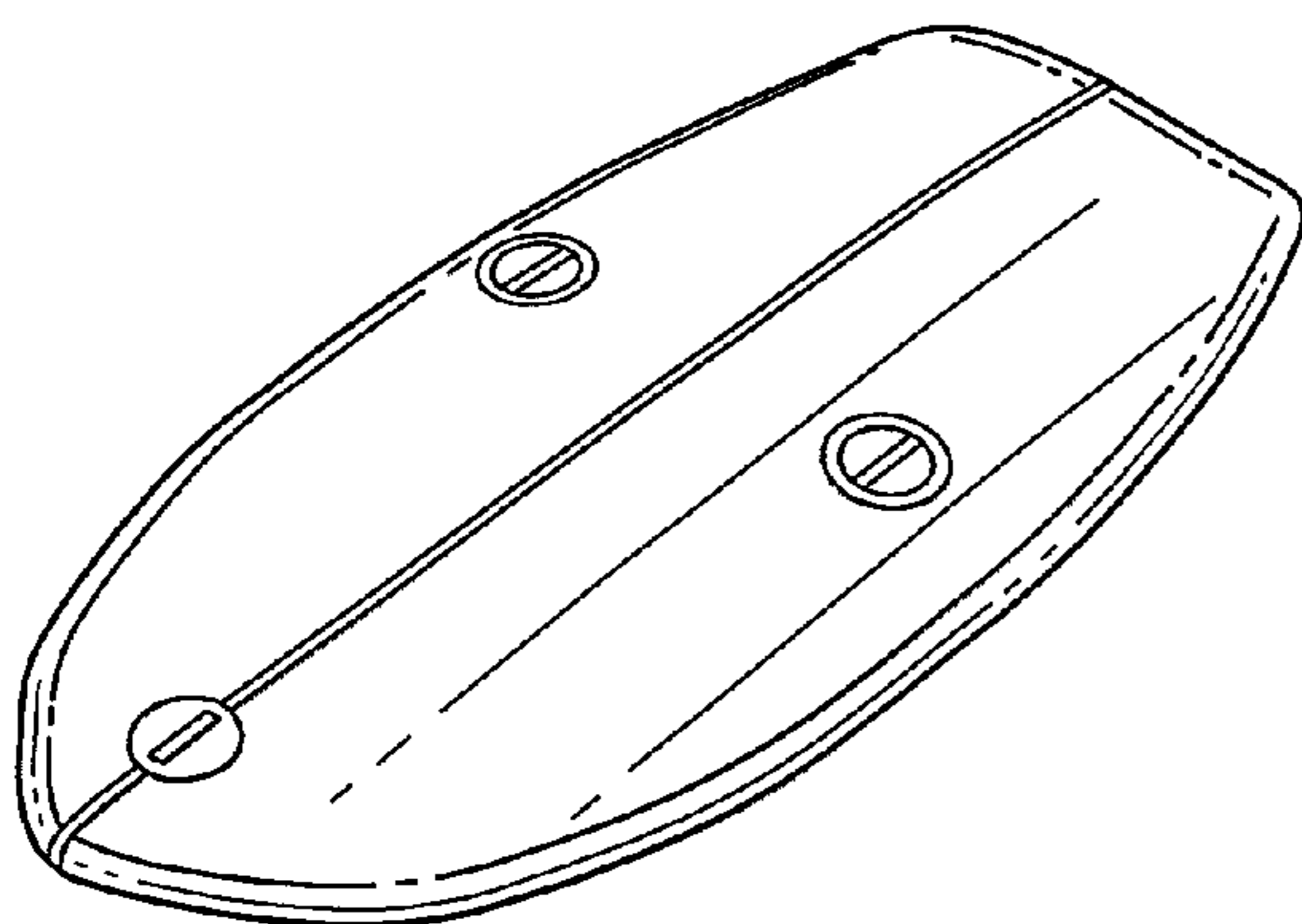
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the top of a handboard showing our ornamental design;
FIG. 2 is a front elevation view of the handboard of FIG. 1;

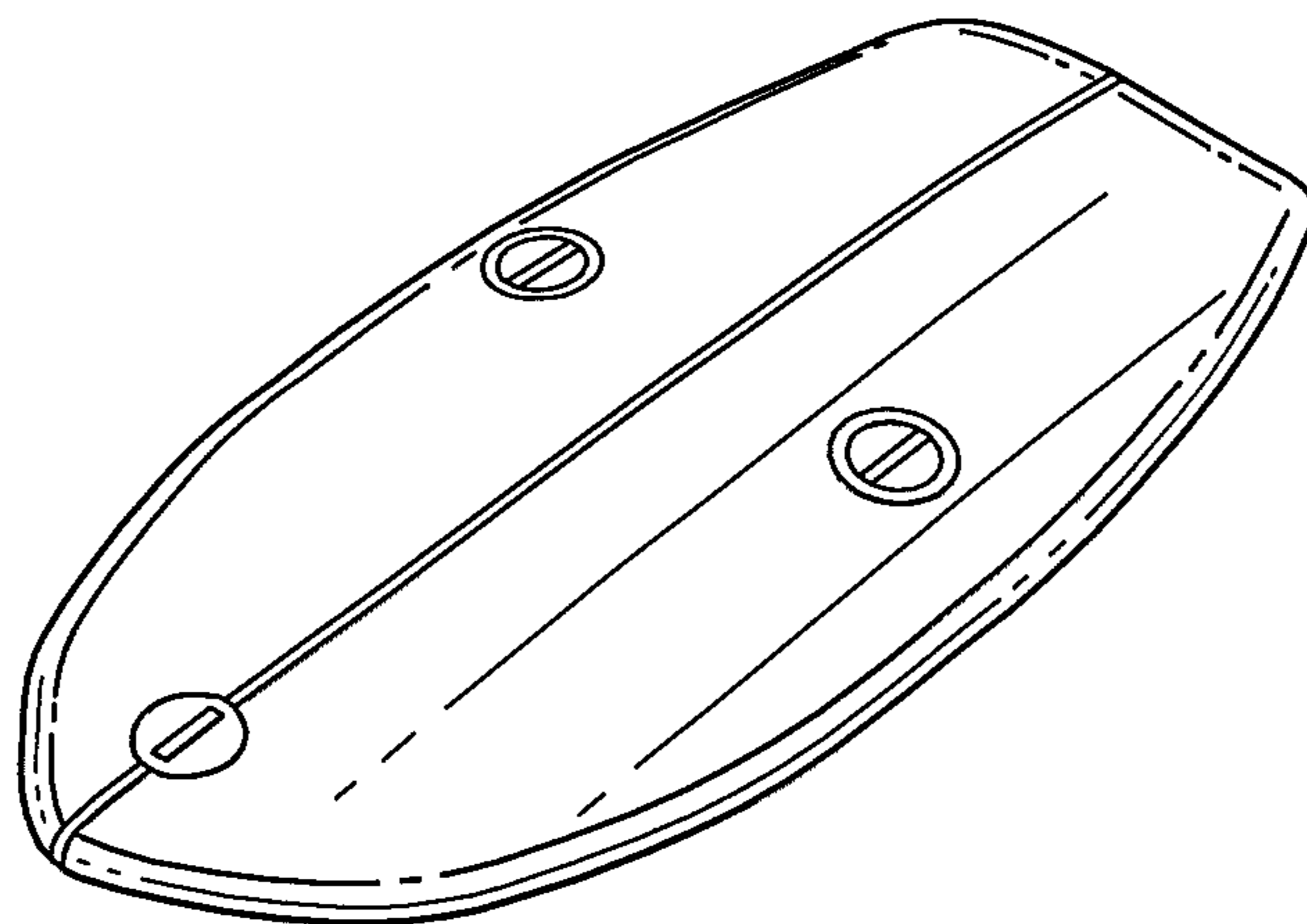

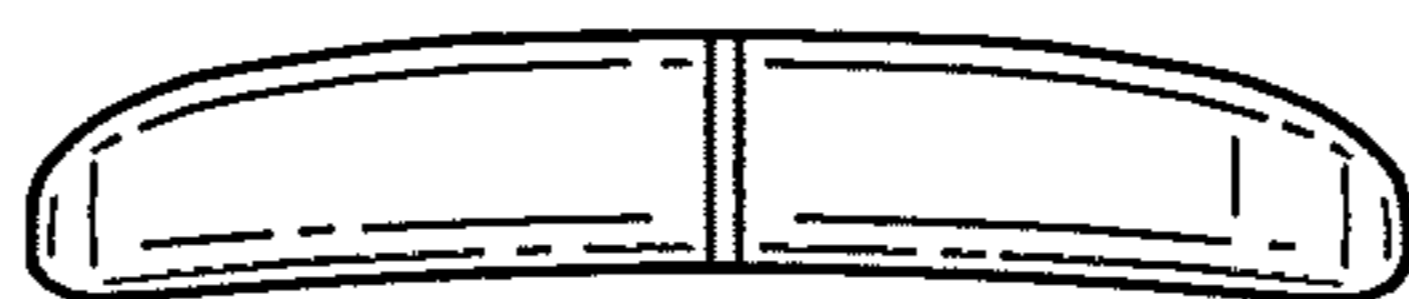

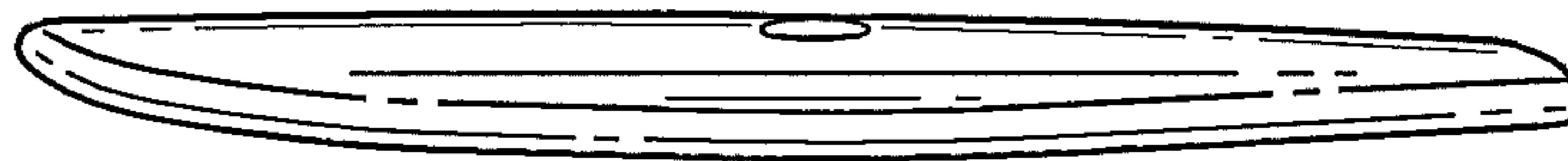

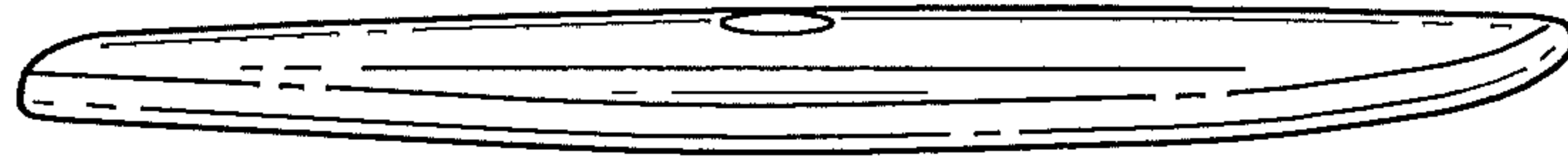

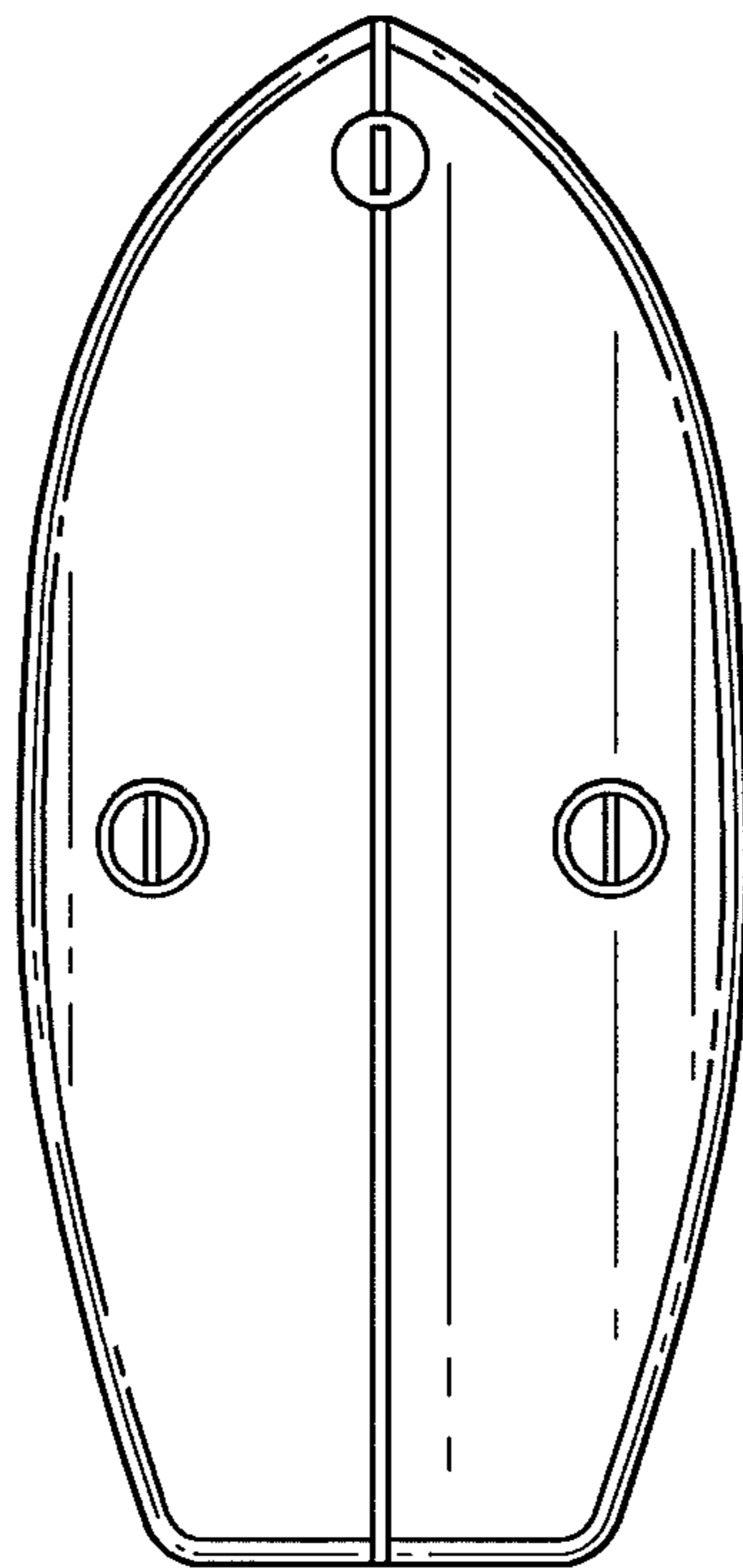

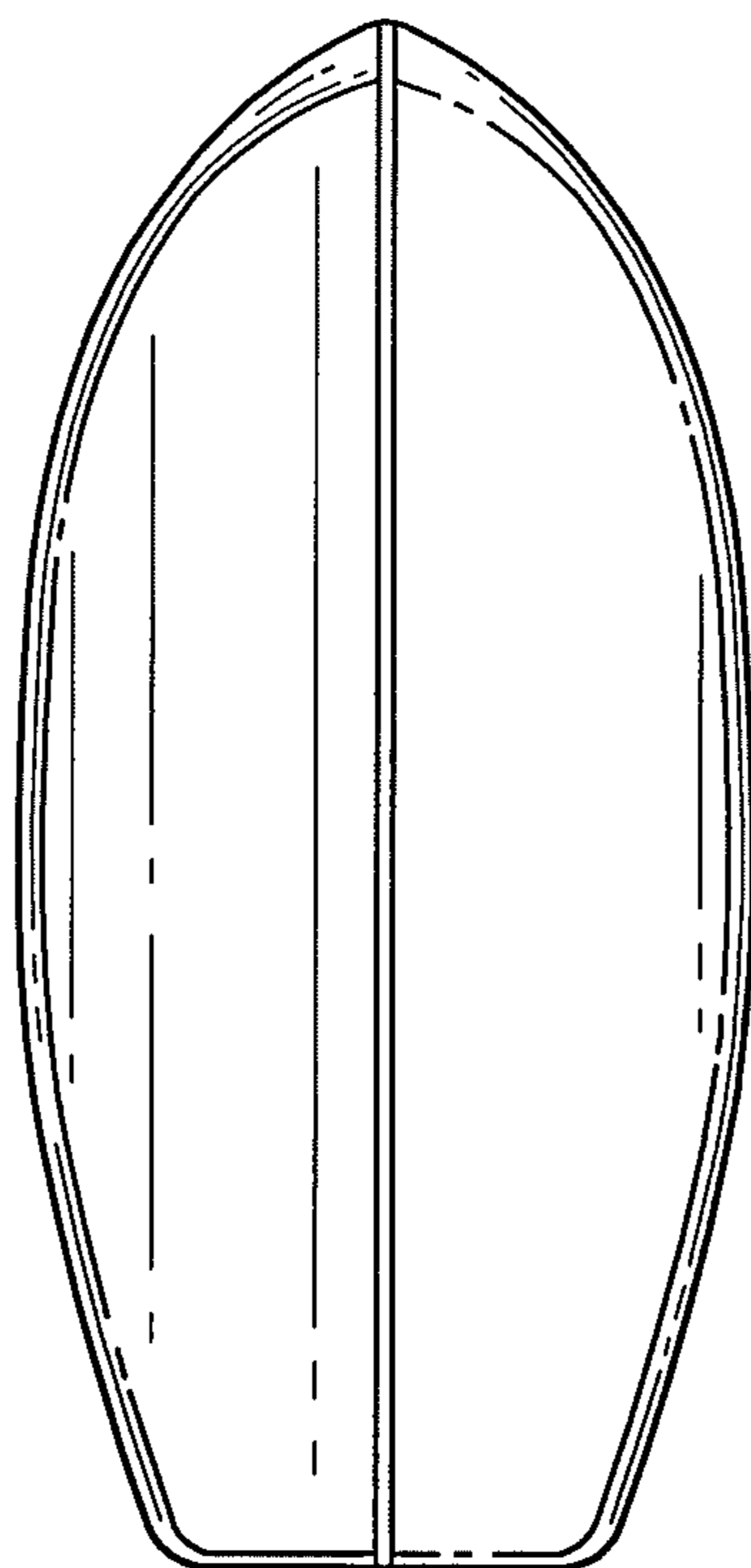

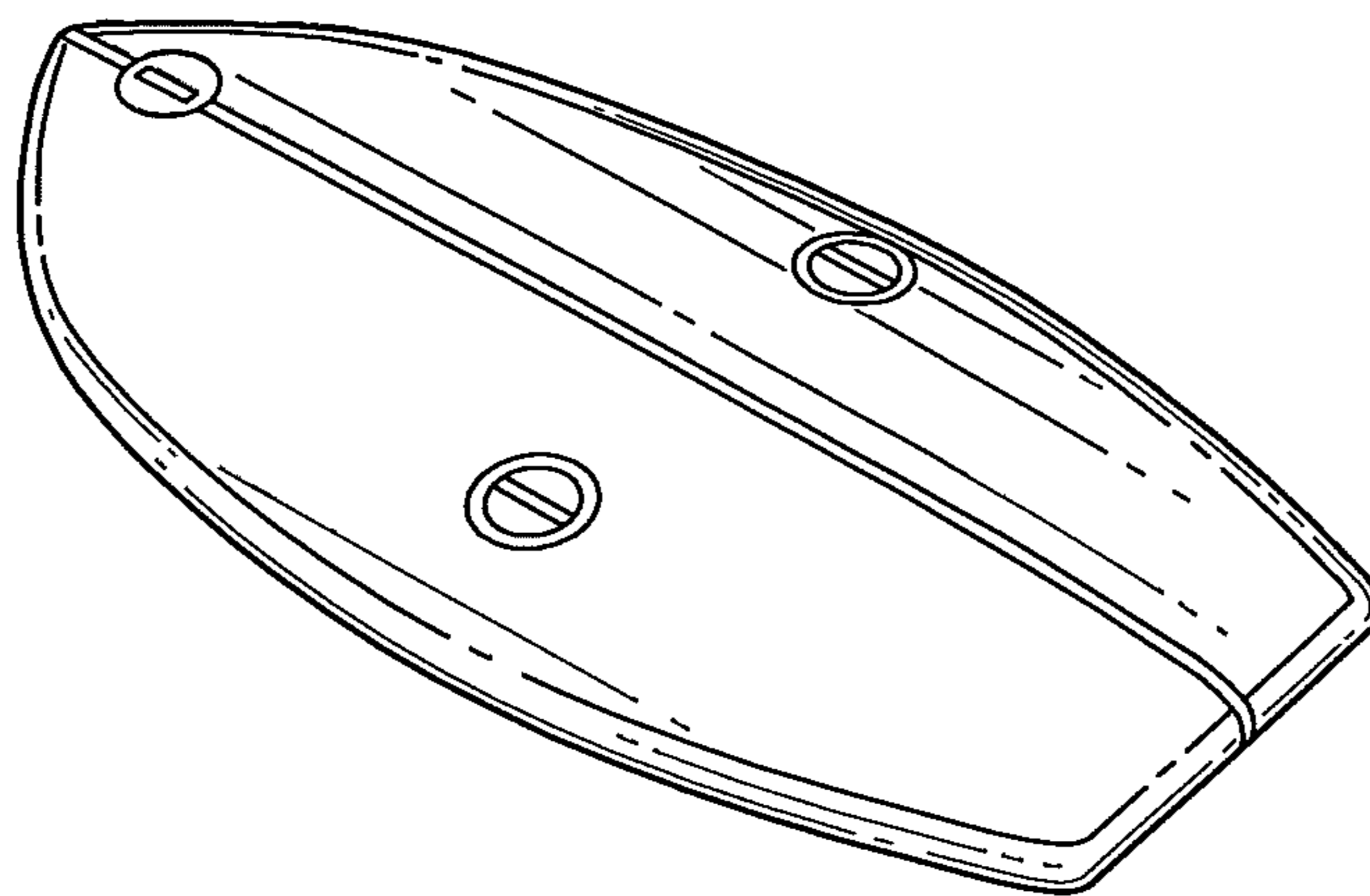

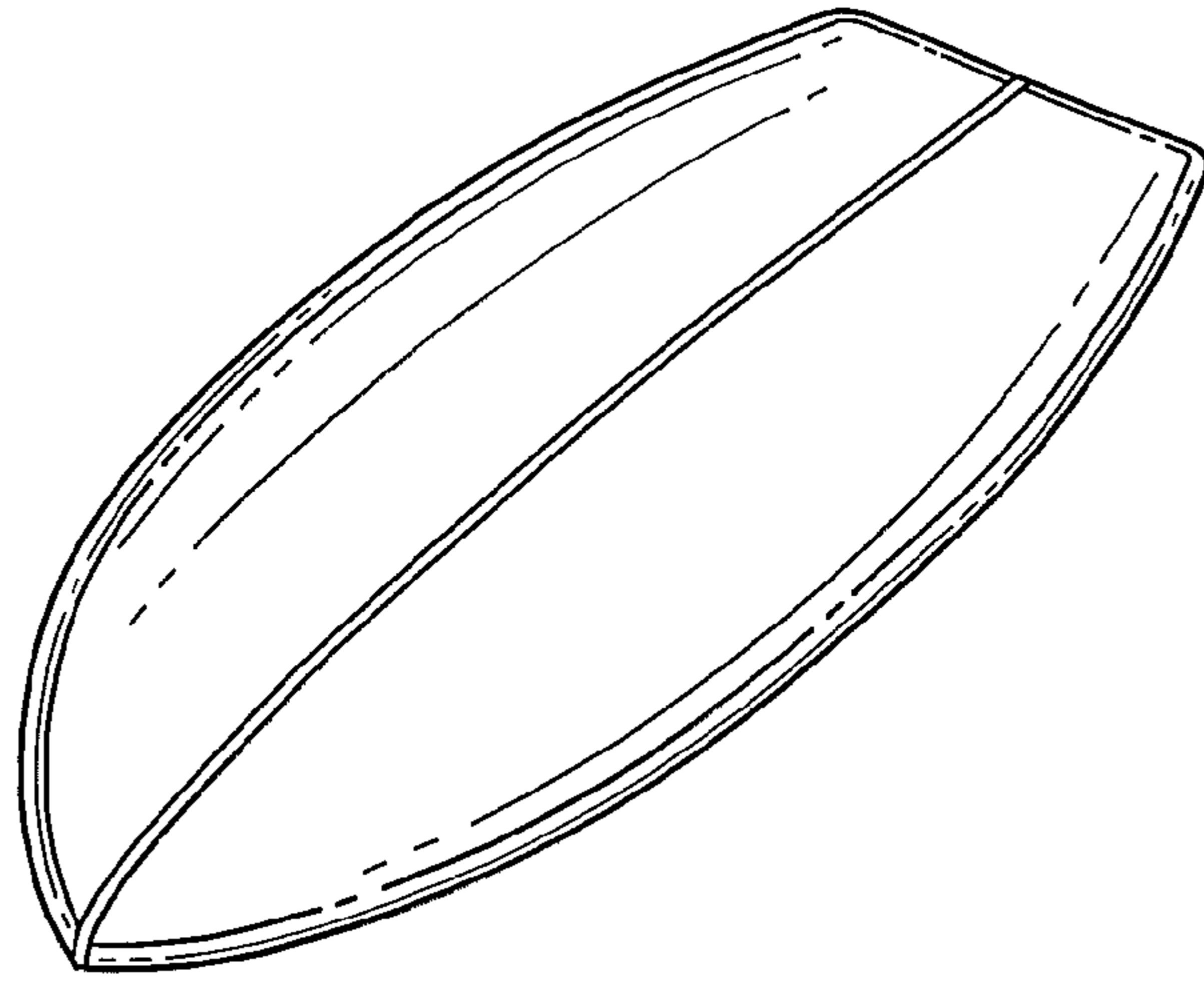

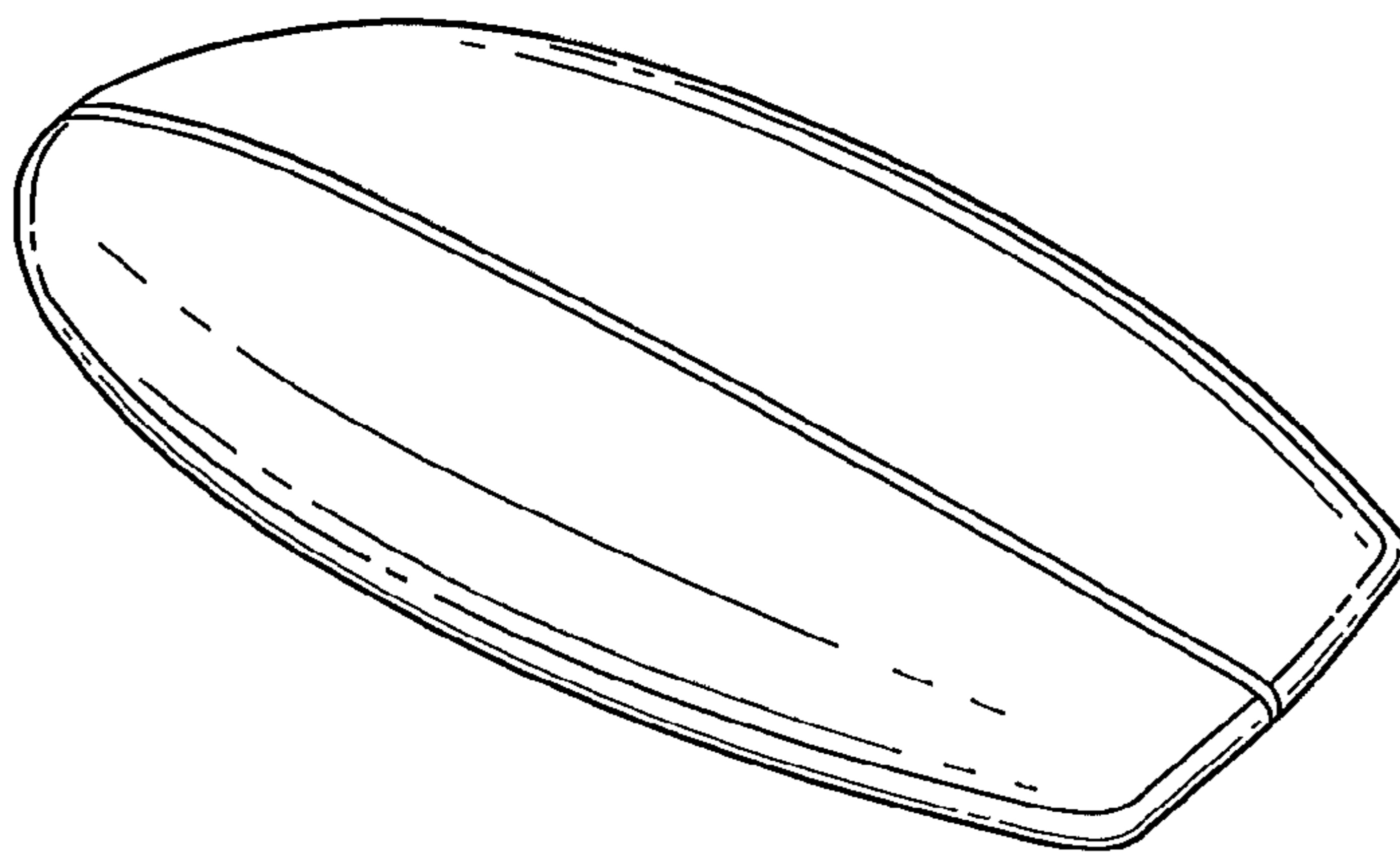
