DESCRIPTION
FIG. 1 is a perspective view of a sheet for face pack showing my new design;
FIG. 2 is a front view thereof, a rear view being symmetrical to the front view thereof.

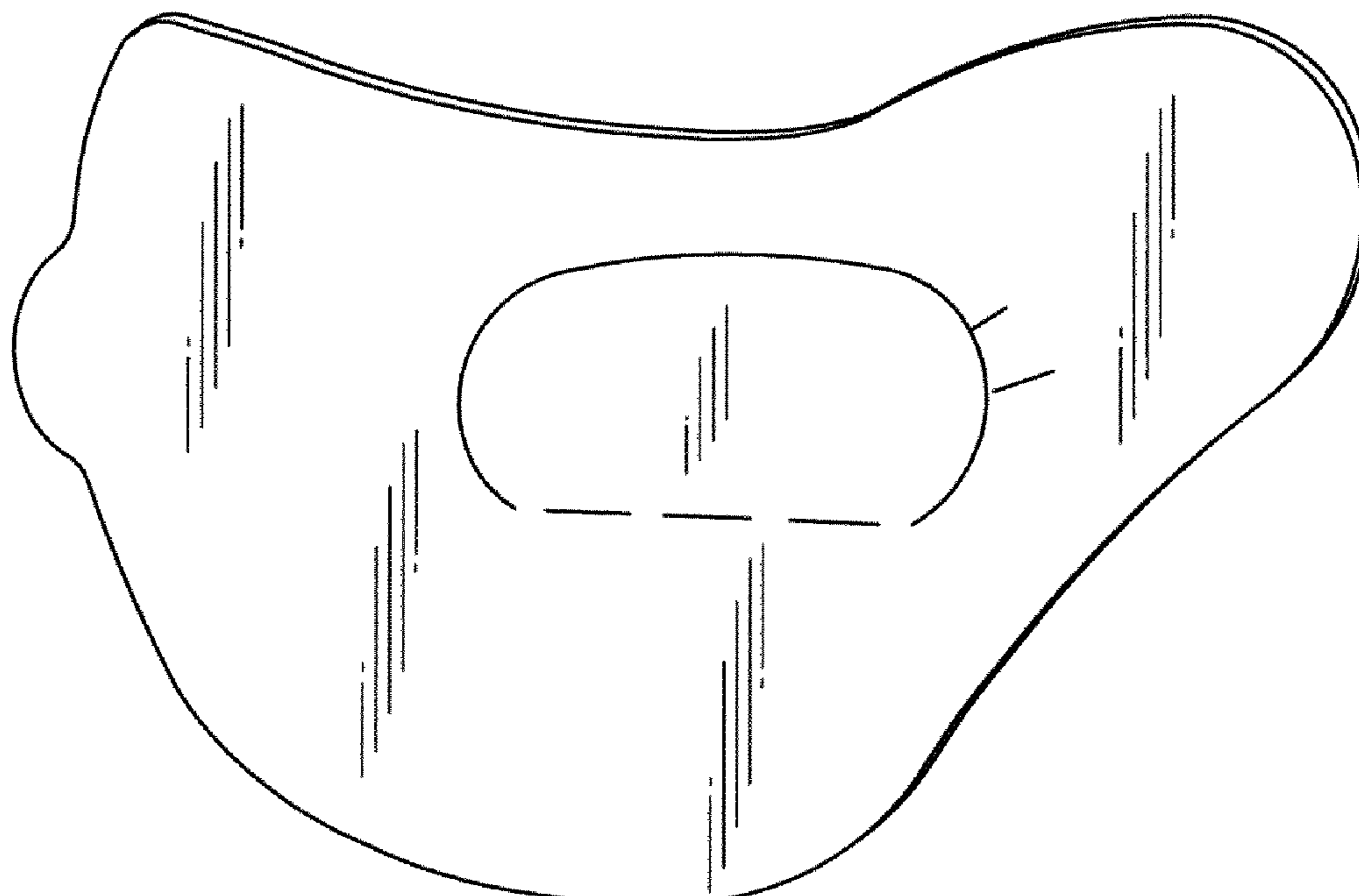

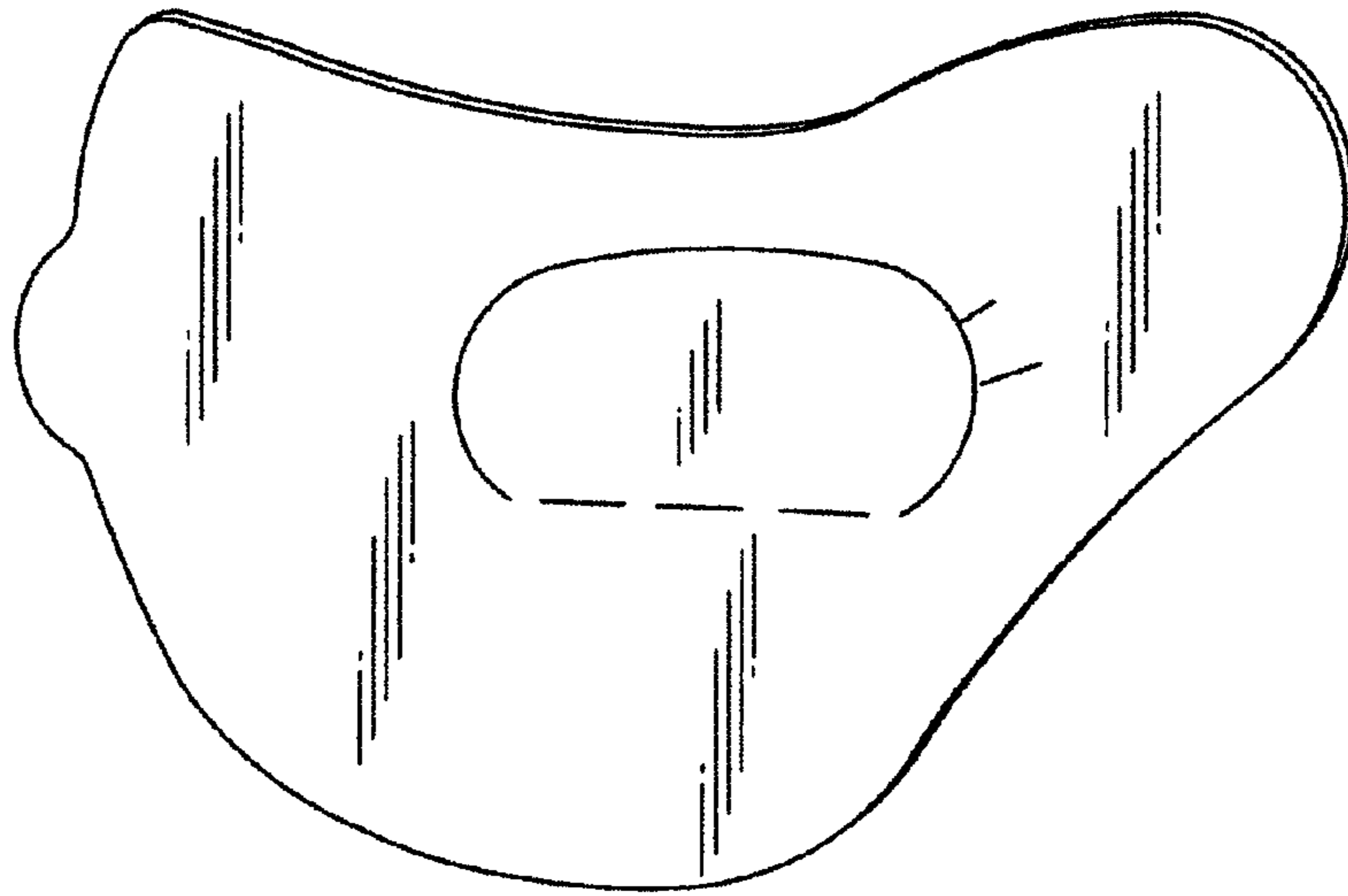

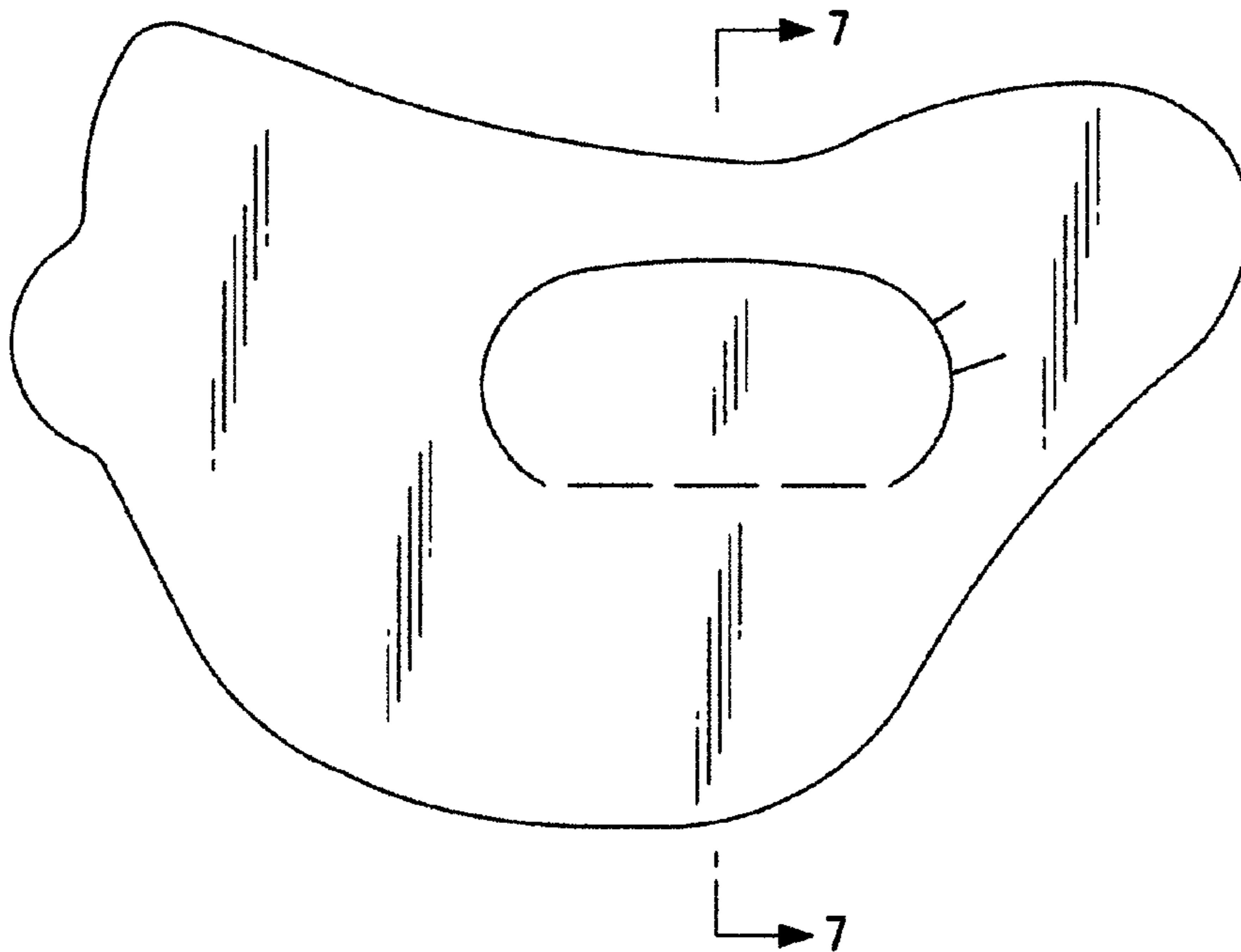

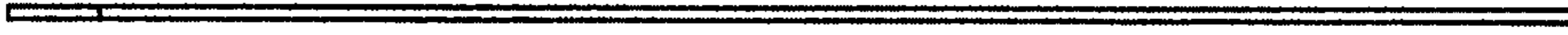
