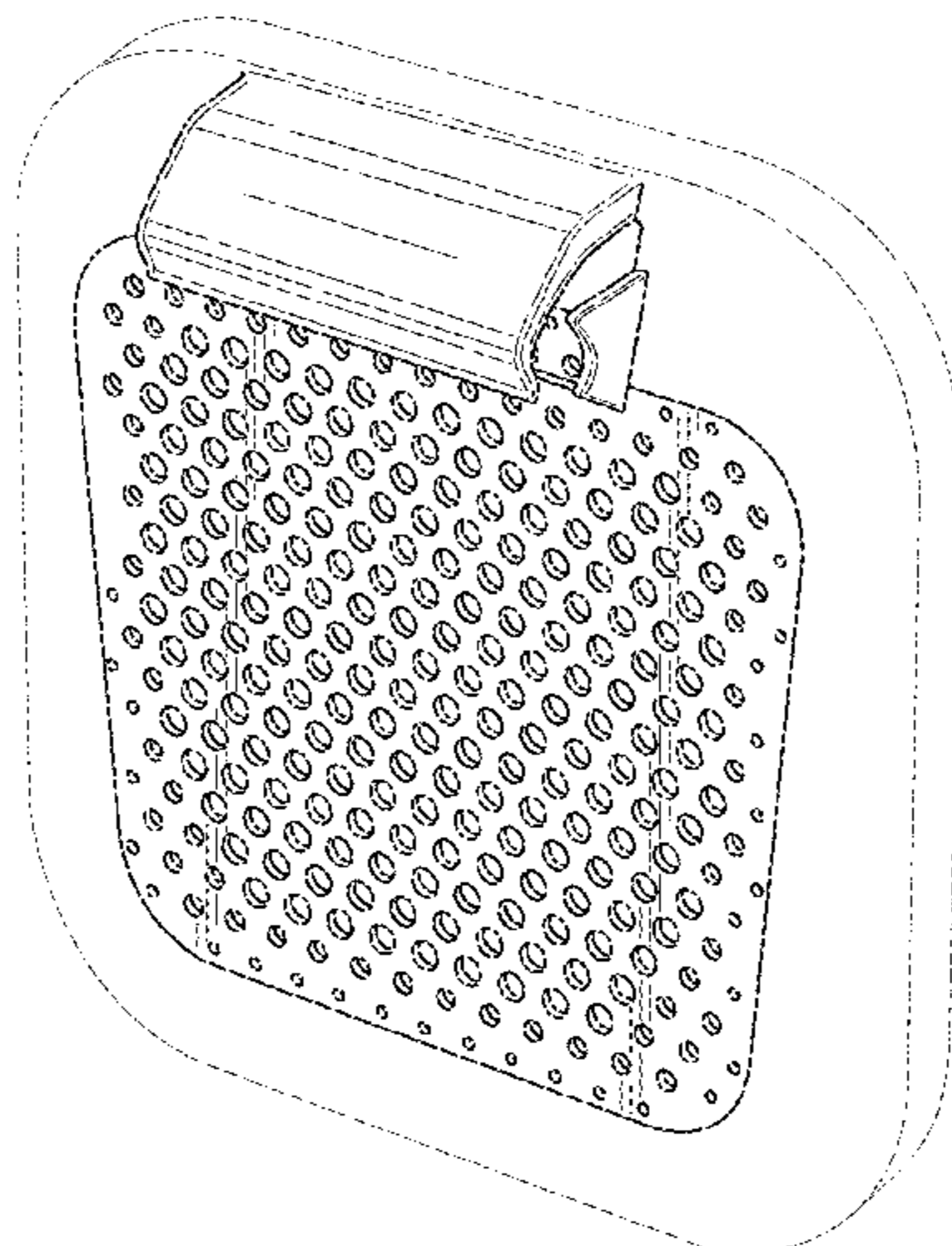
(57) **CLAIM**

The ornamental design for a device for delivering a washing agent, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a device for delivering a washing agent of the present invention;
 FIG. 2 is a front view of the device for delivering a washing agent of FIG. 1;
 FIG. 3 is a rear view of the device for delivering a washing agent of FIG. 1;
 FIG. 4 is a side view of the device for delivering a washing agent of FIG. 1;
 FIG. 5 is the other side view of the device for delivering a washing agent of FIG. 1;
 FIG. 6 is a top view of the device for delivering a washing agent of FIG. 1; and,
 FIG. 7 is a bottom view of the device for delivering a washing agent of FIG. 1.

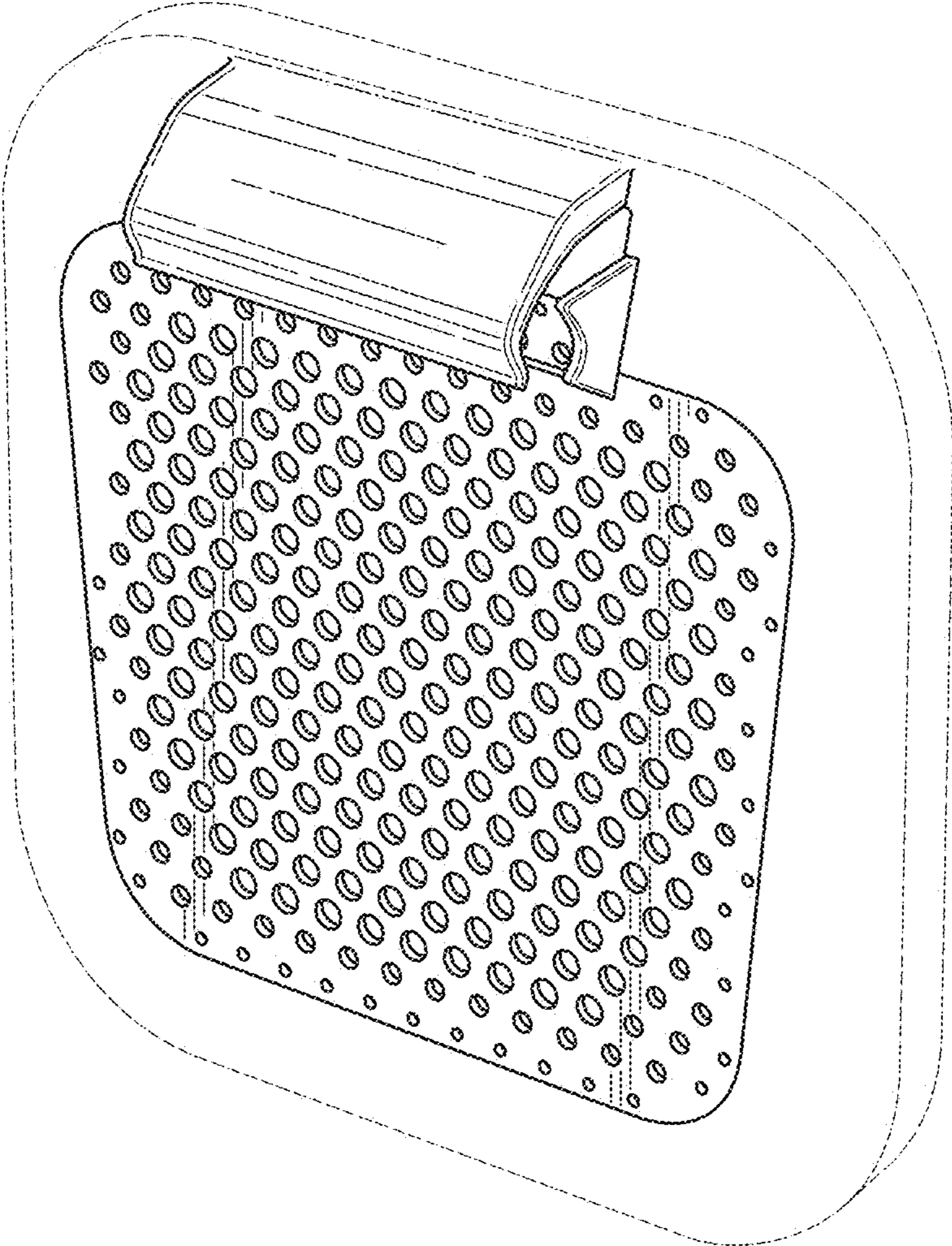

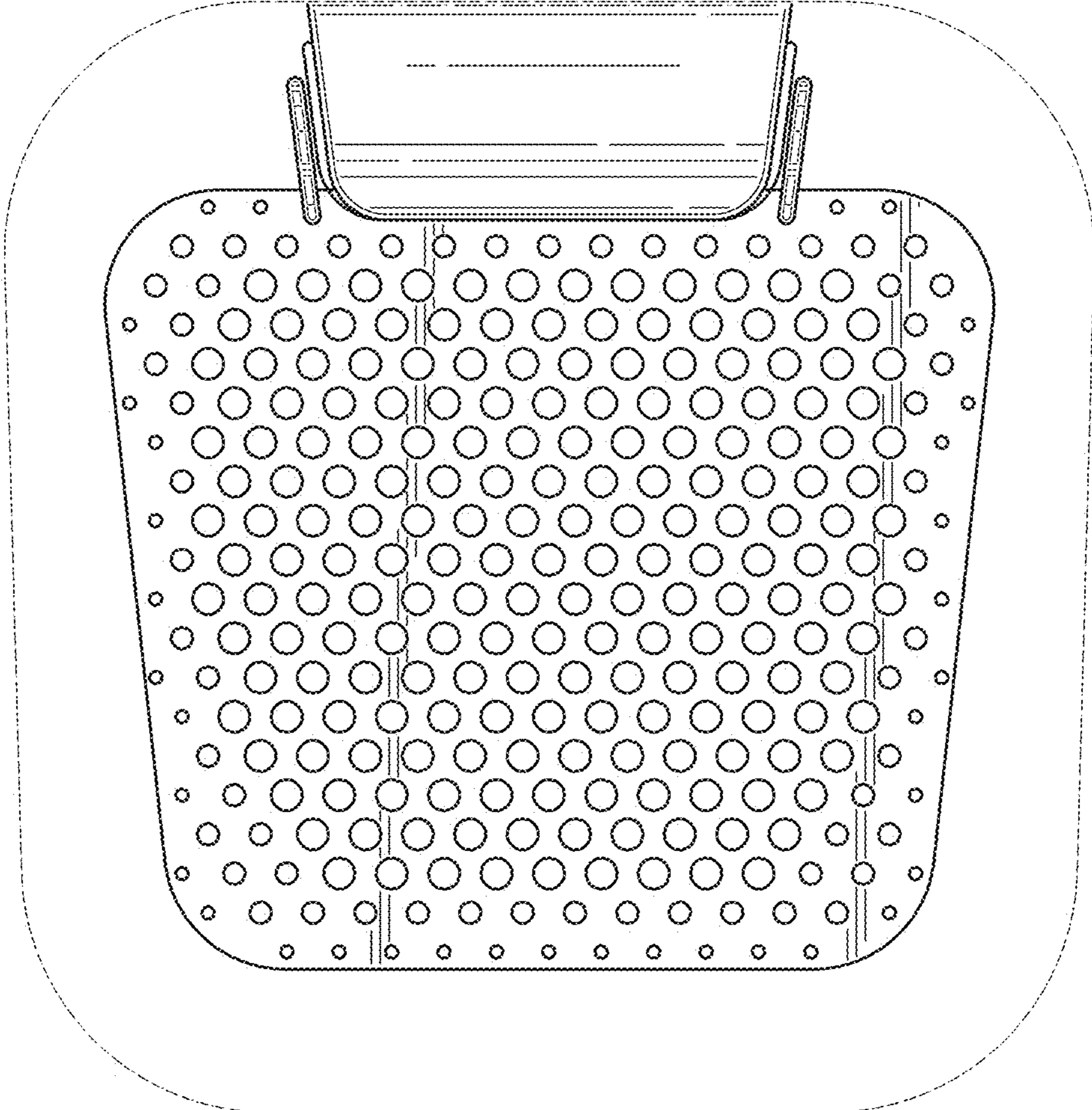

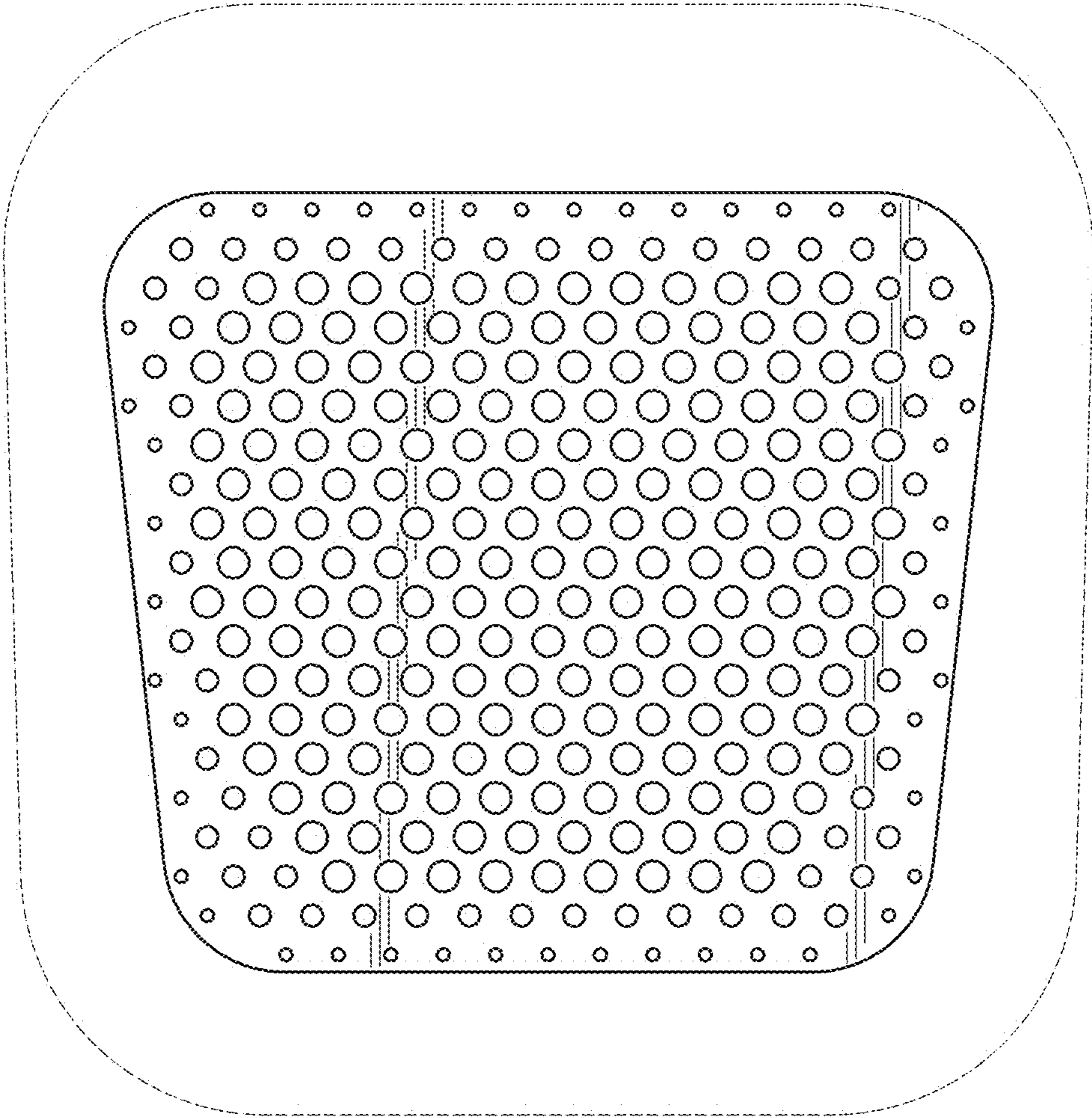

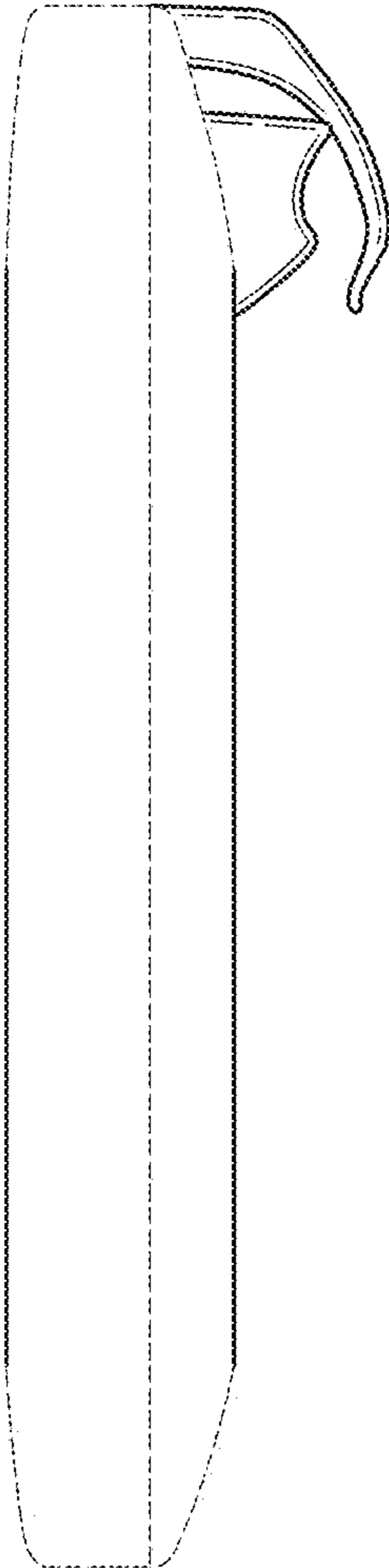

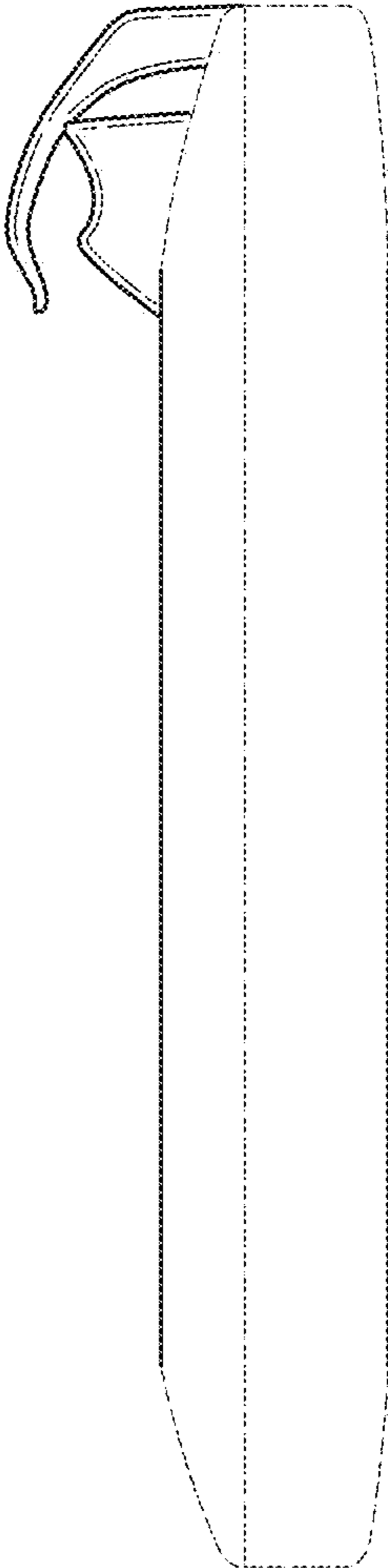

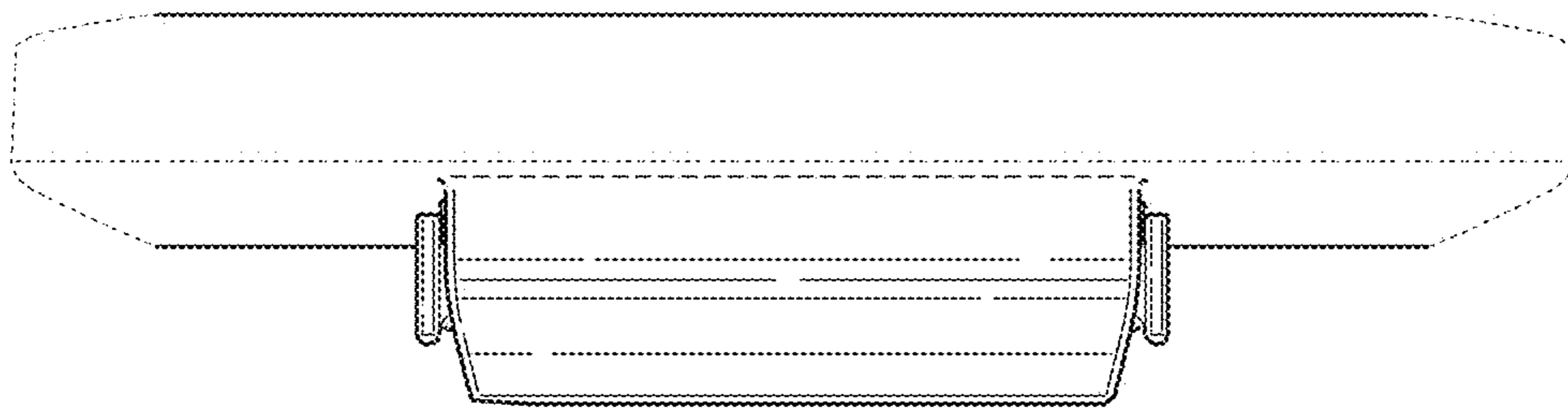

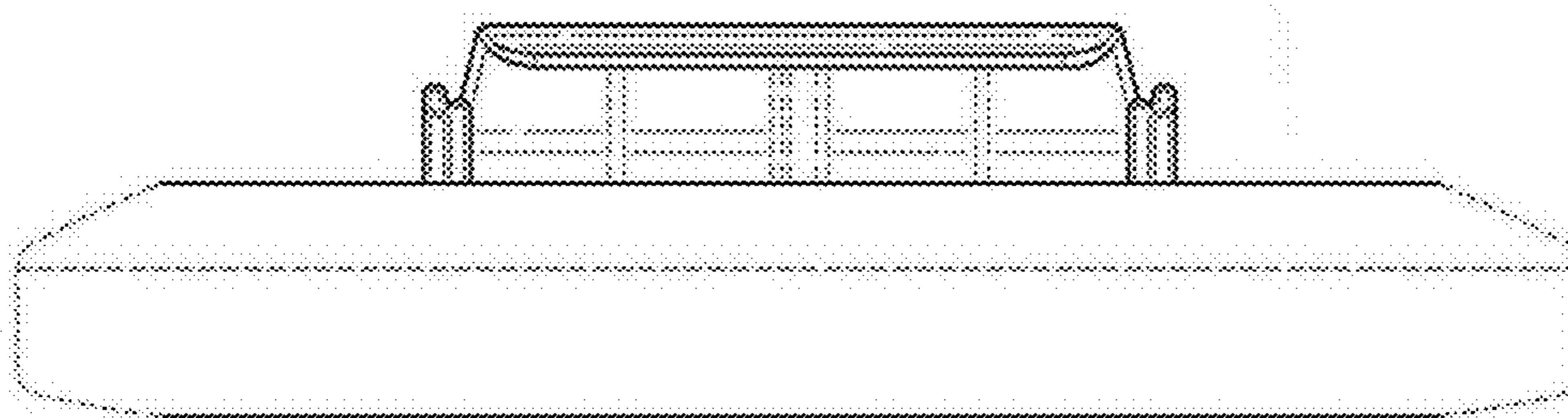
