The broken lines shown in the figures are included for the purpose of illustrating other portions of the rolling cart and form no part of the claimed design.

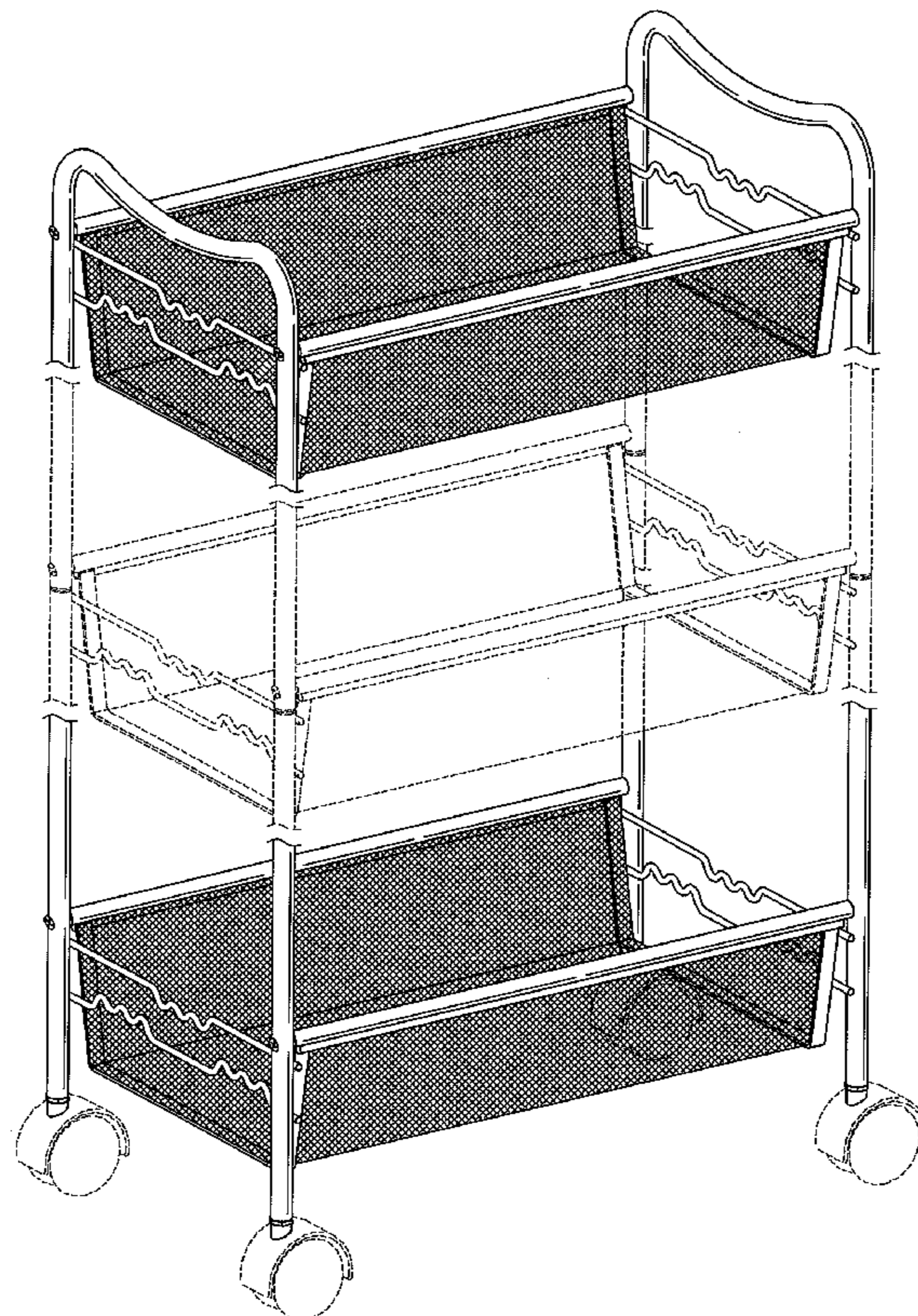

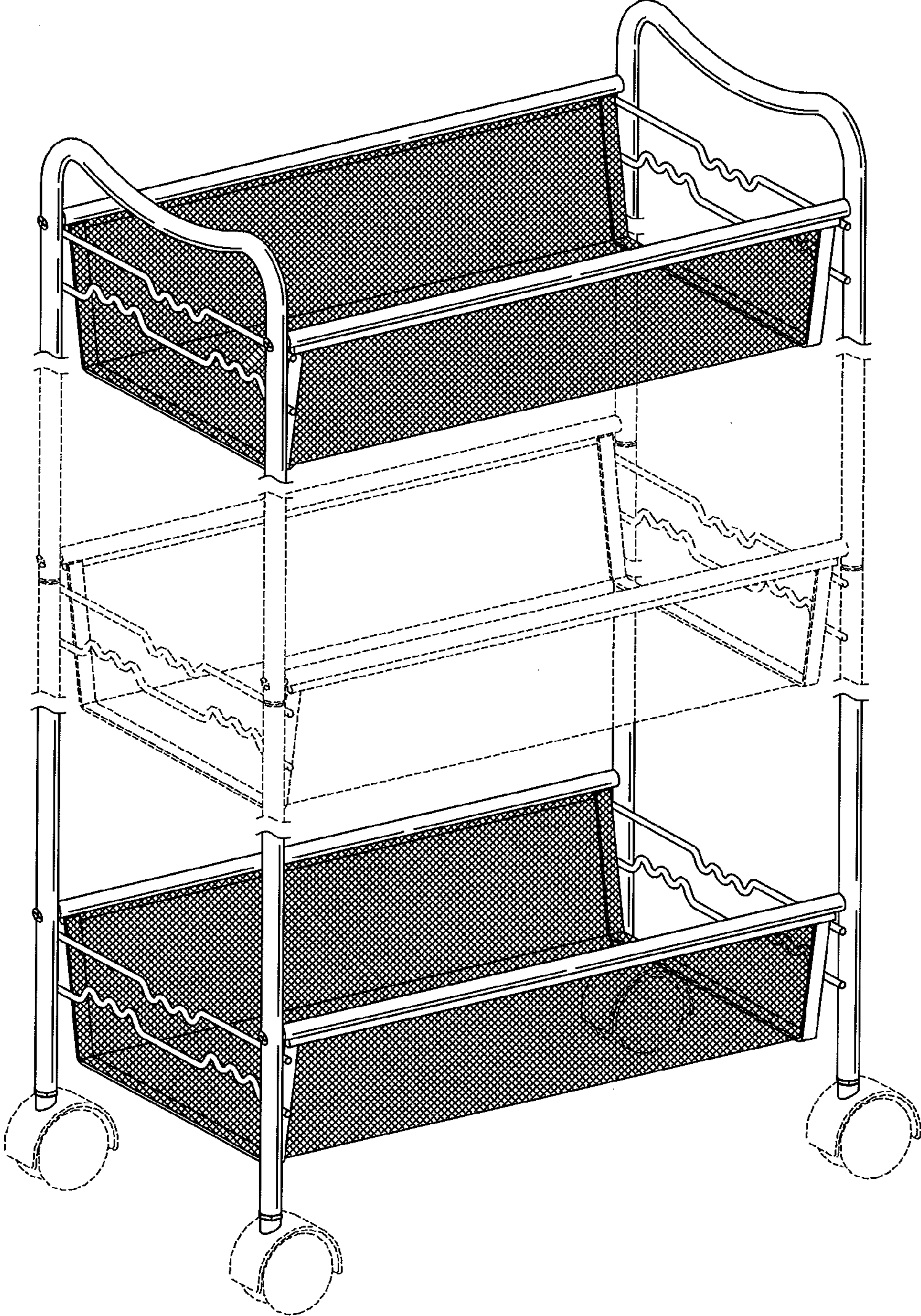

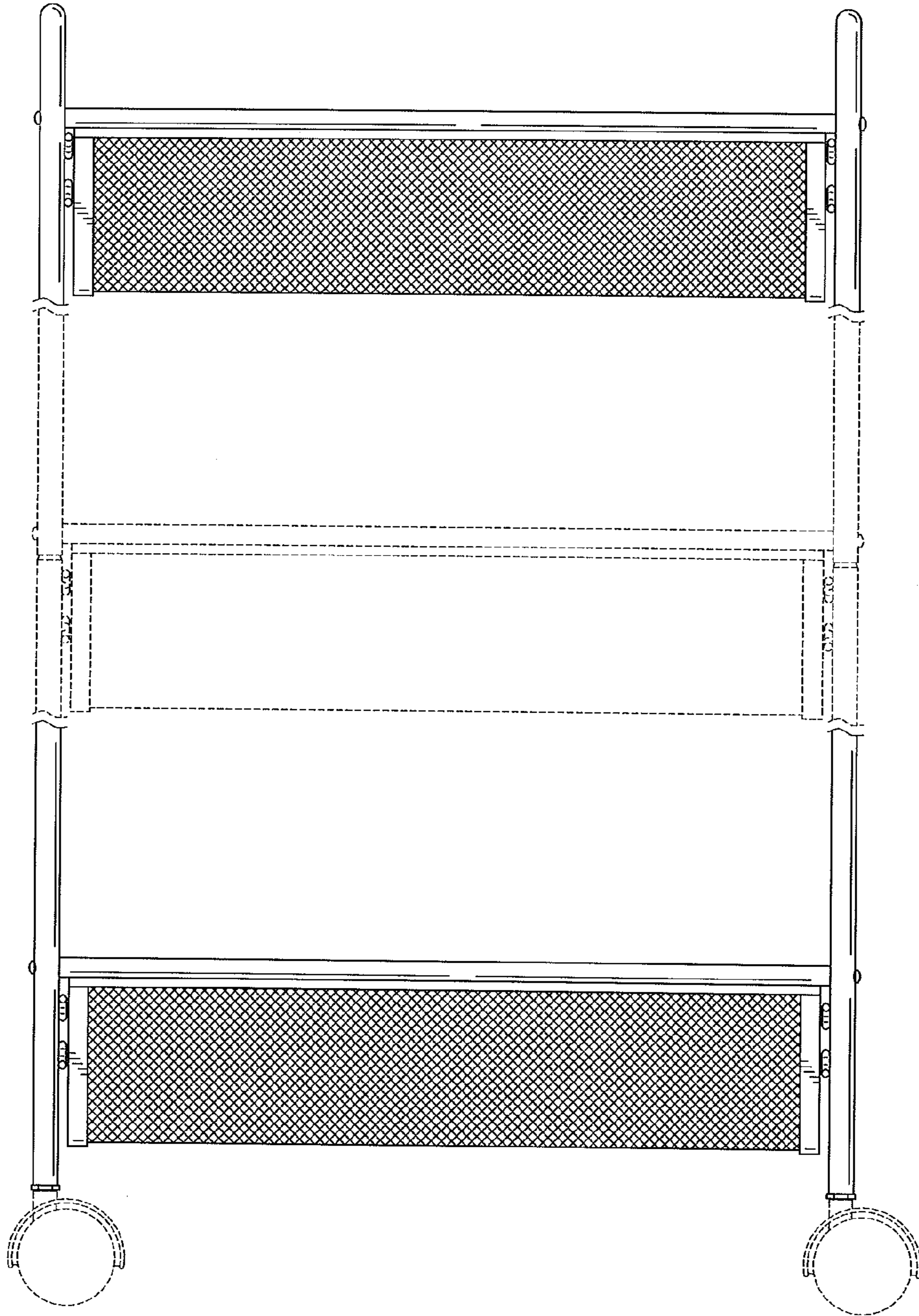

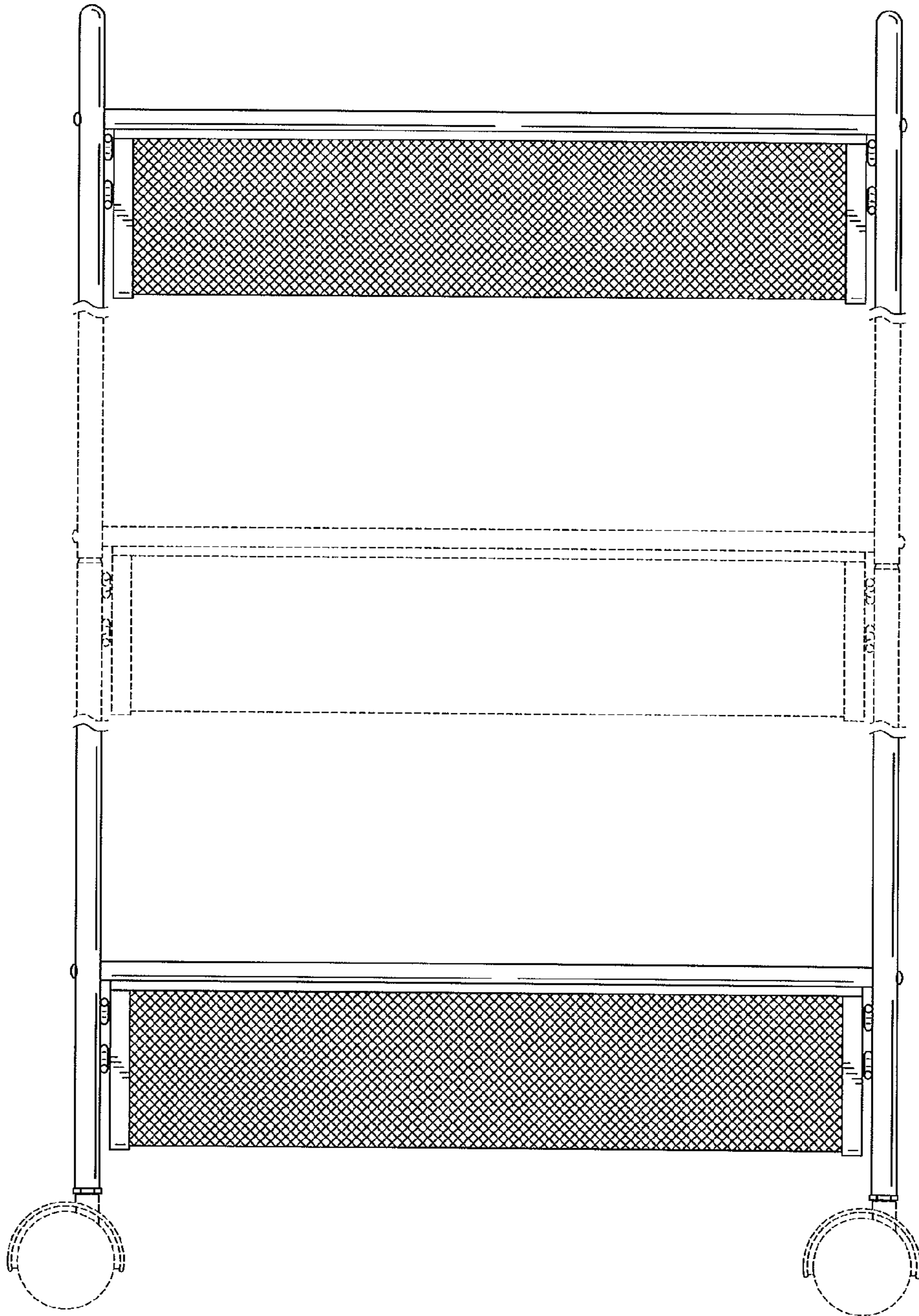

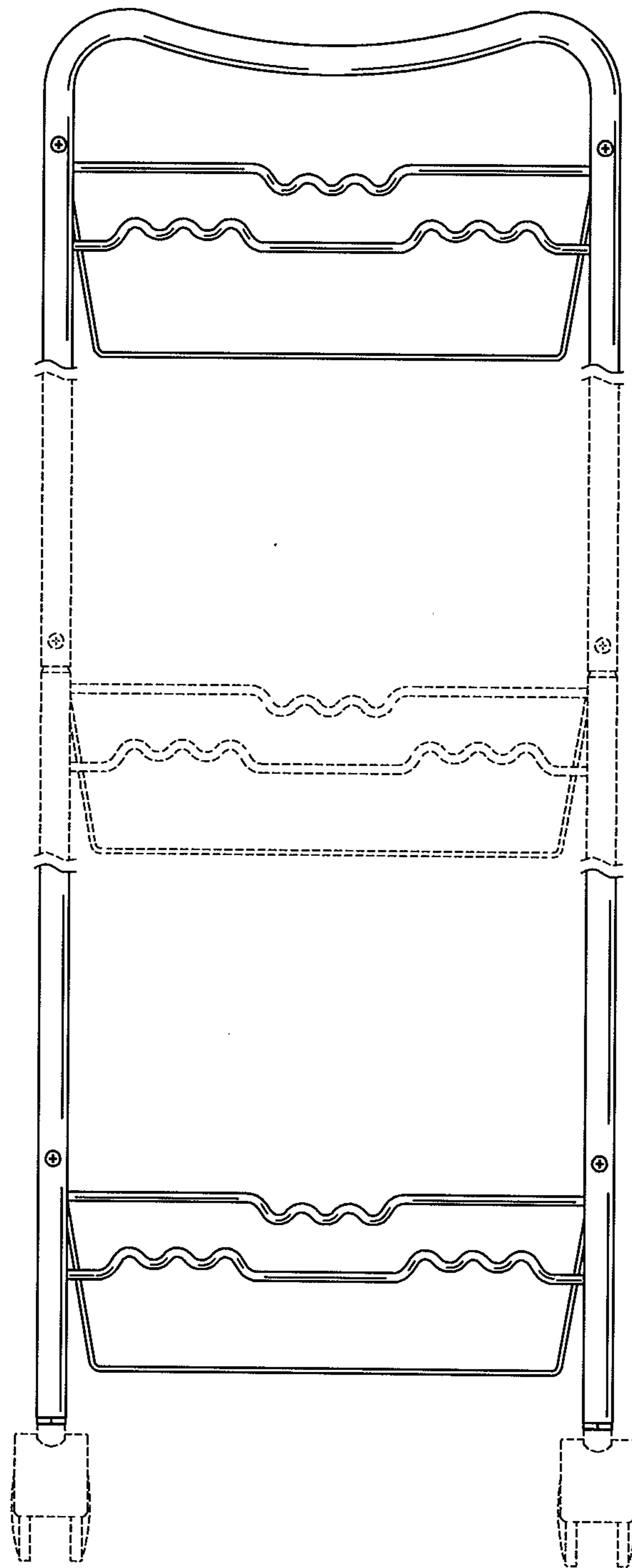

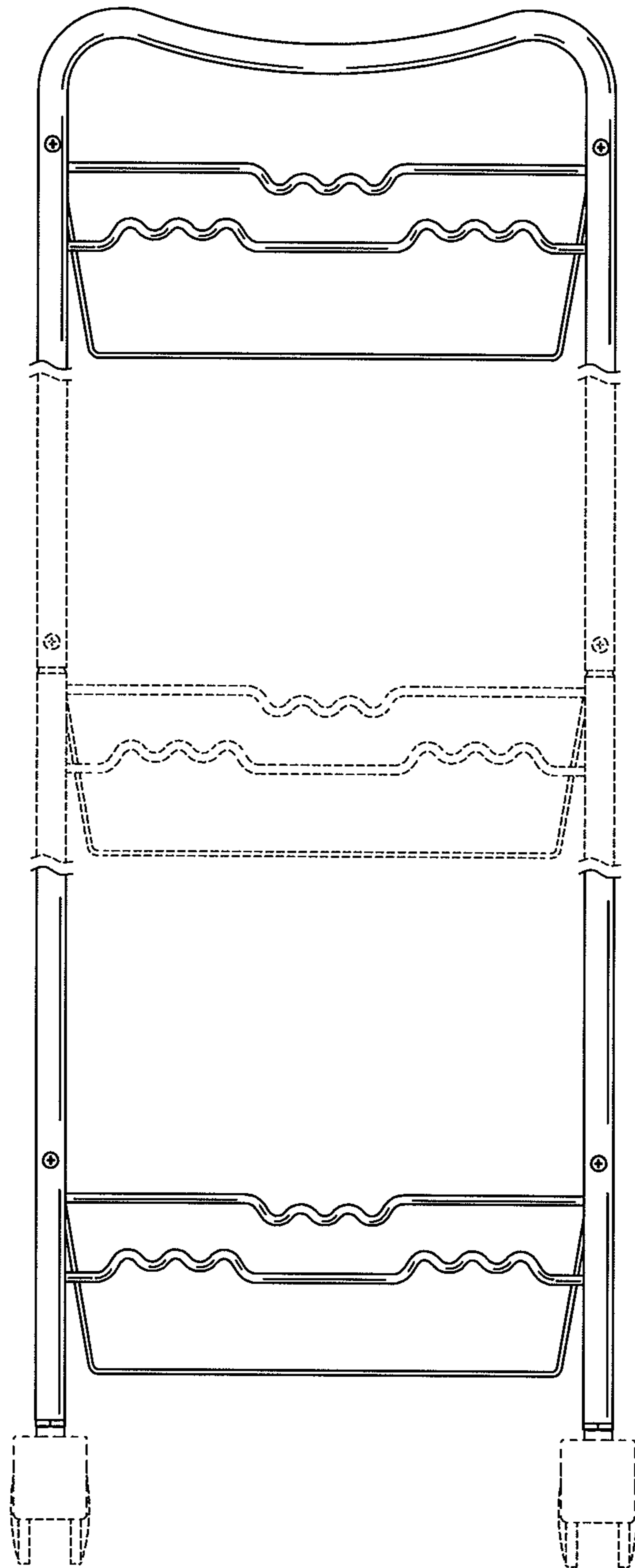

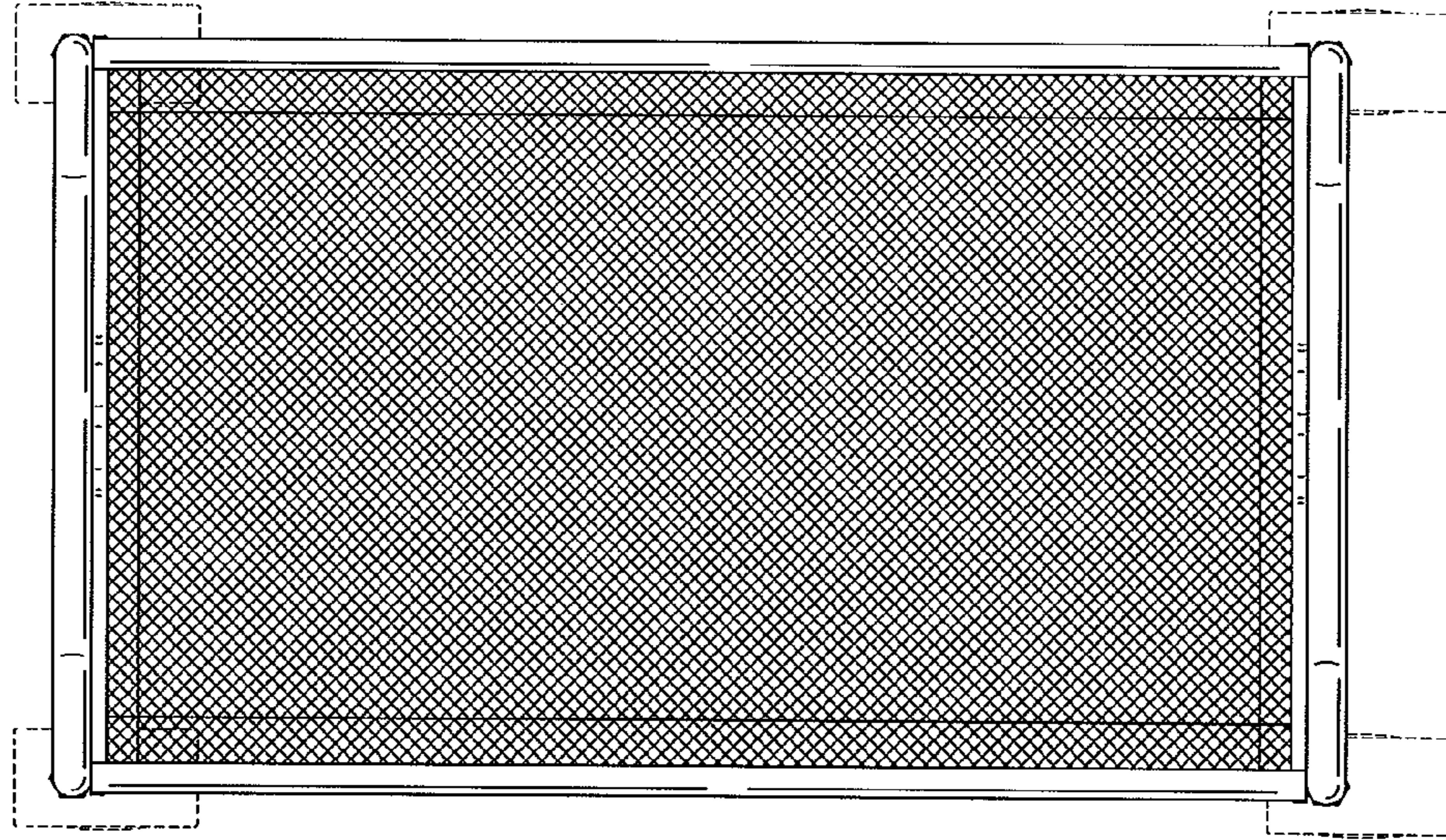

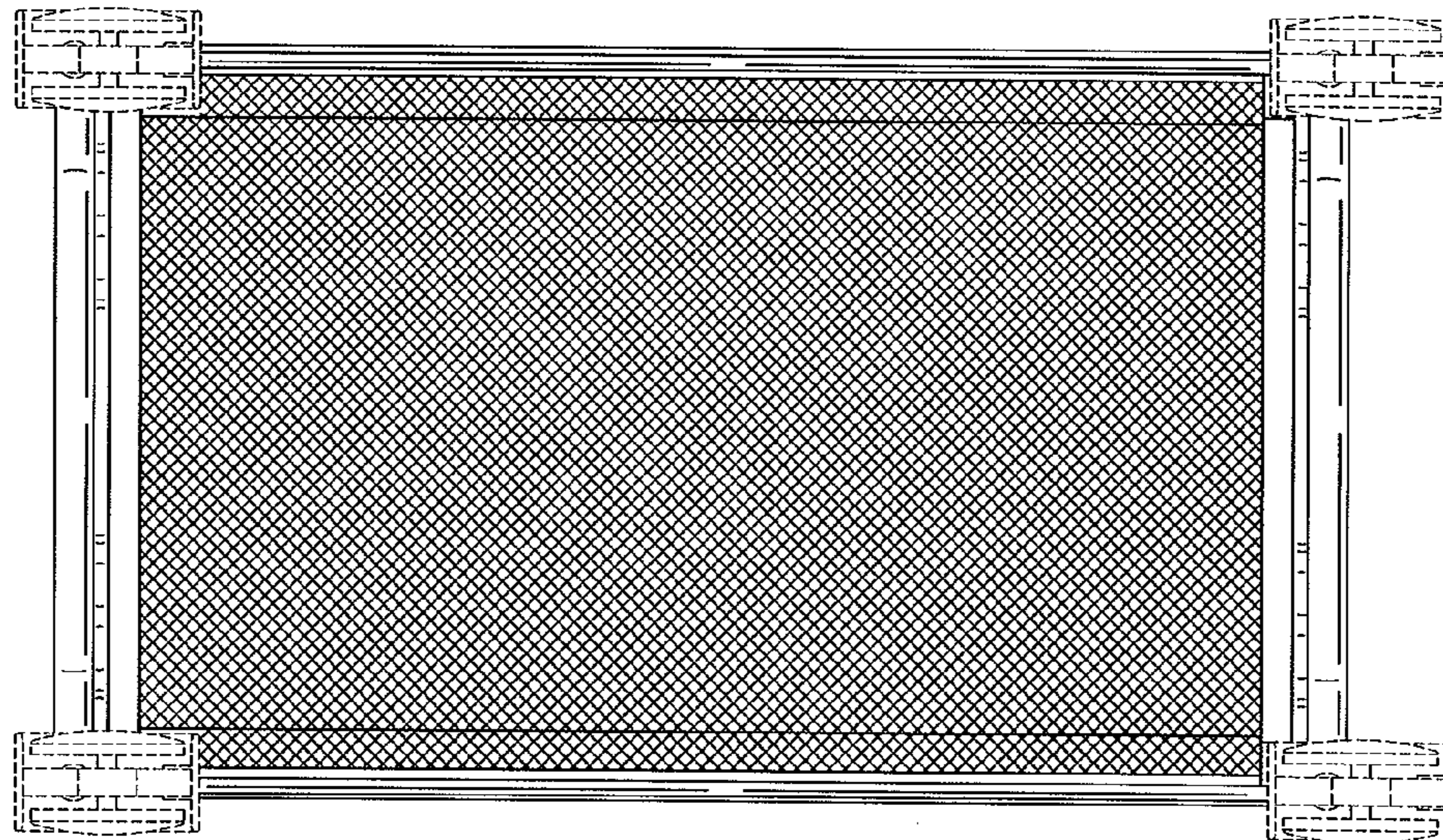
