The ornamental design for a trouser leg bottom, as shown and described.

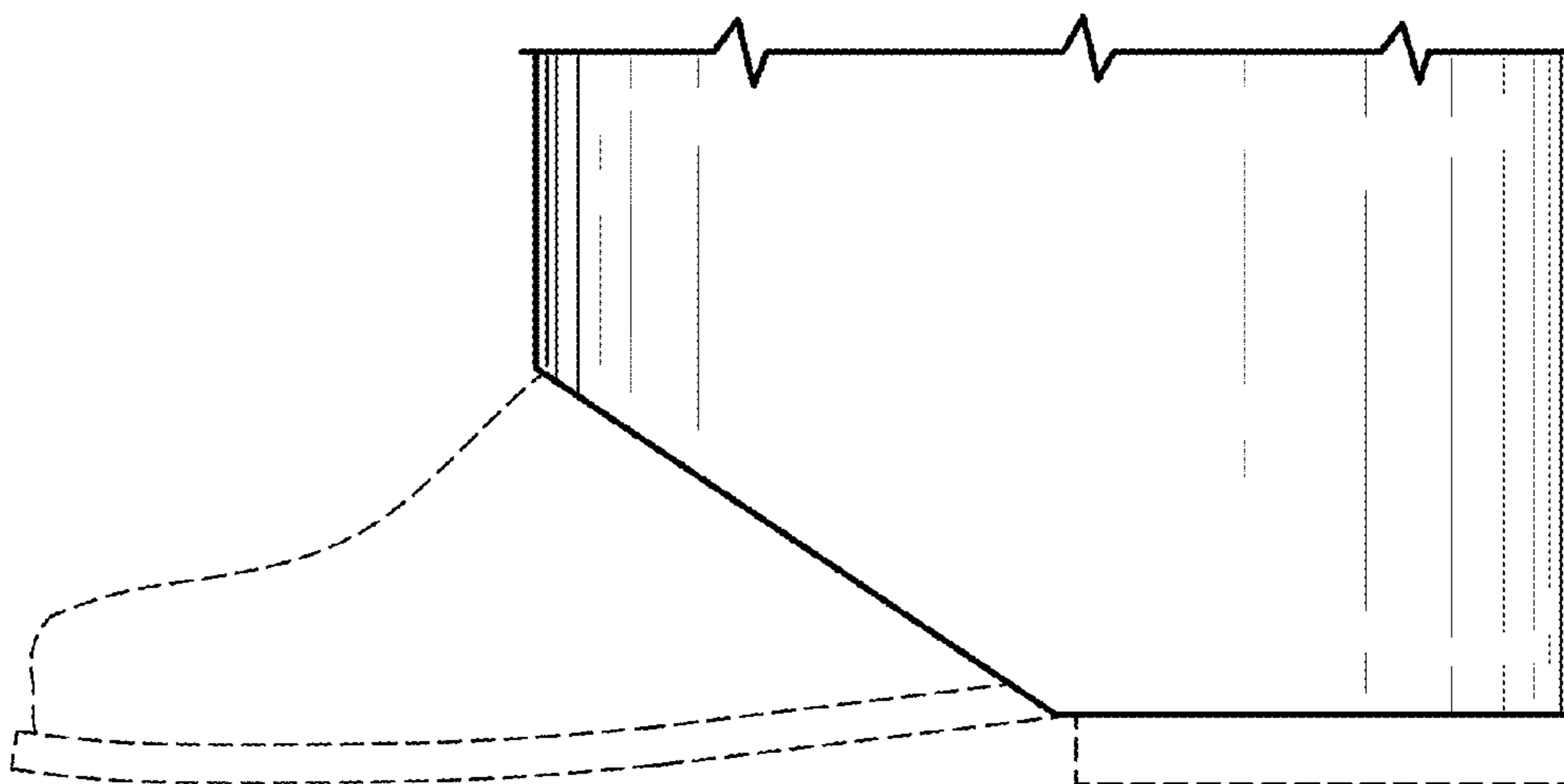
**DESCRIPTION**

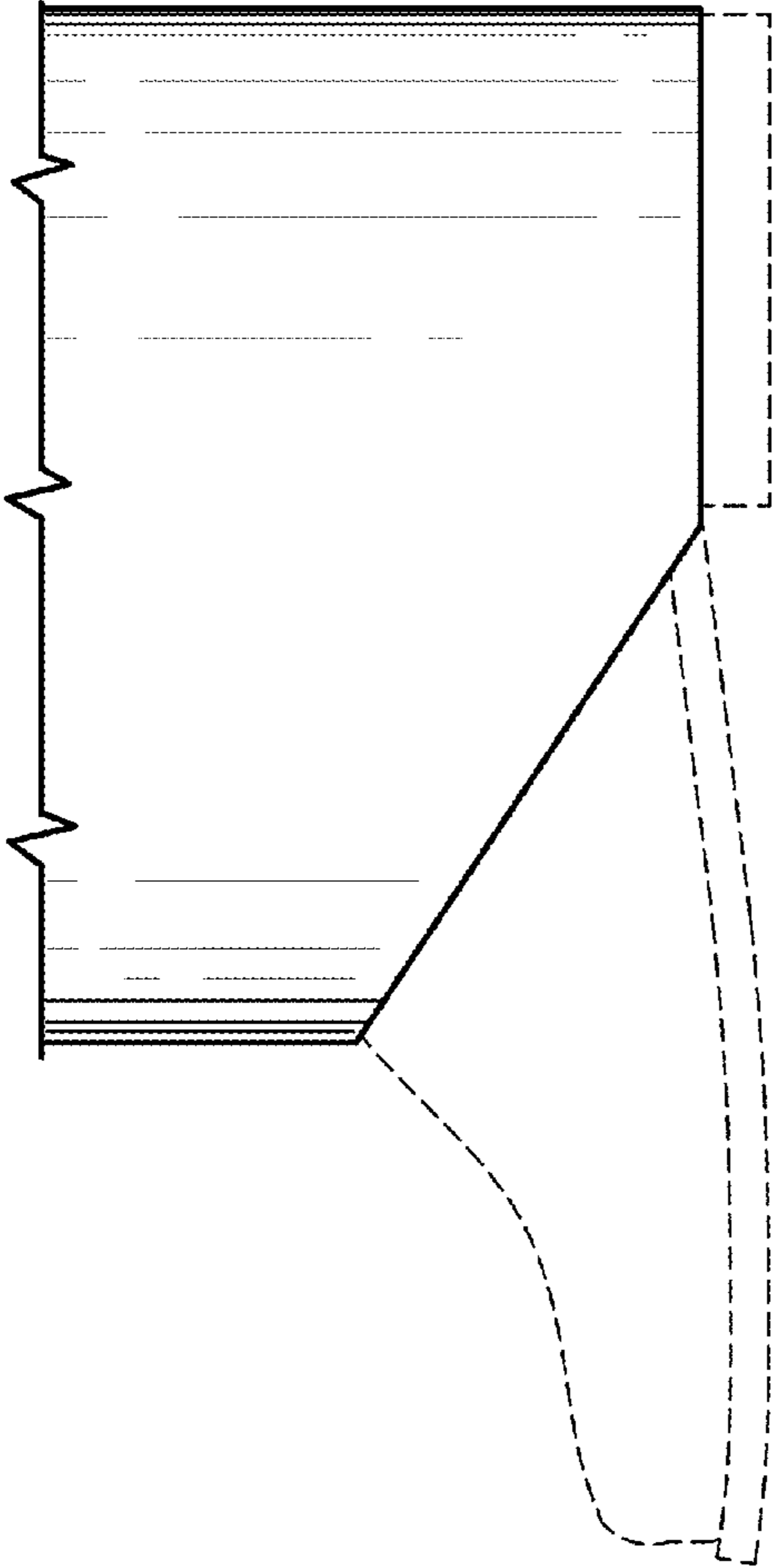

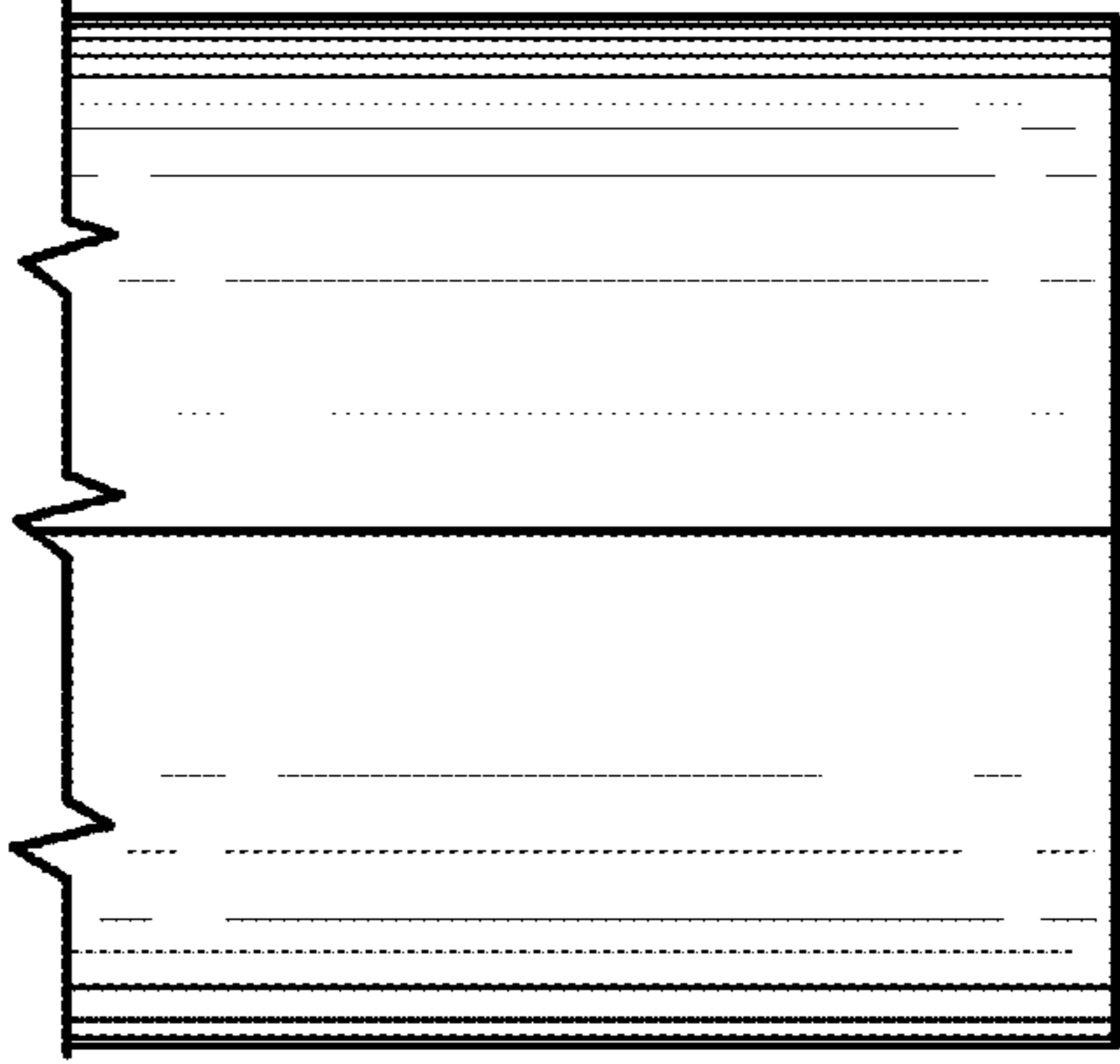

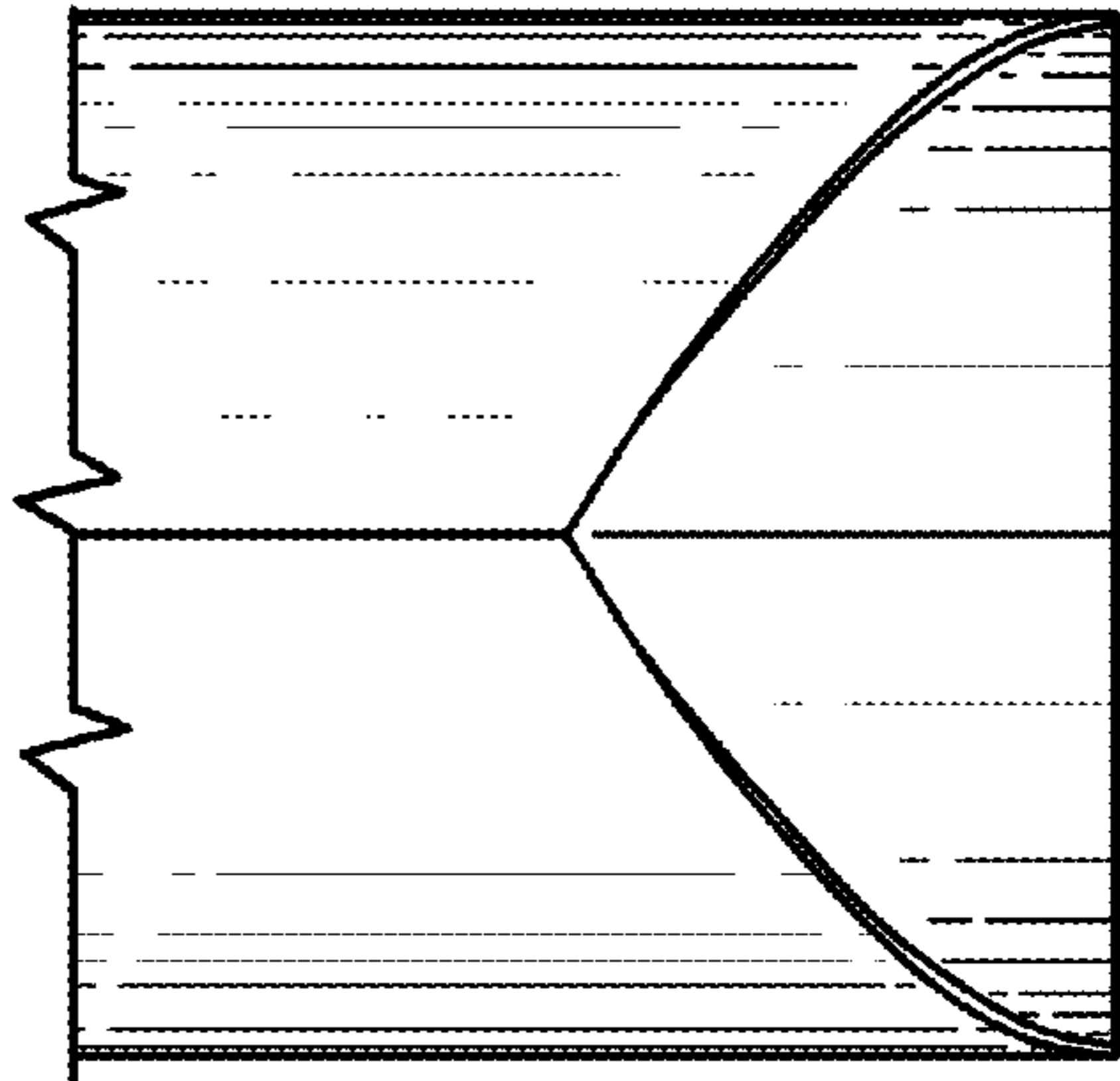

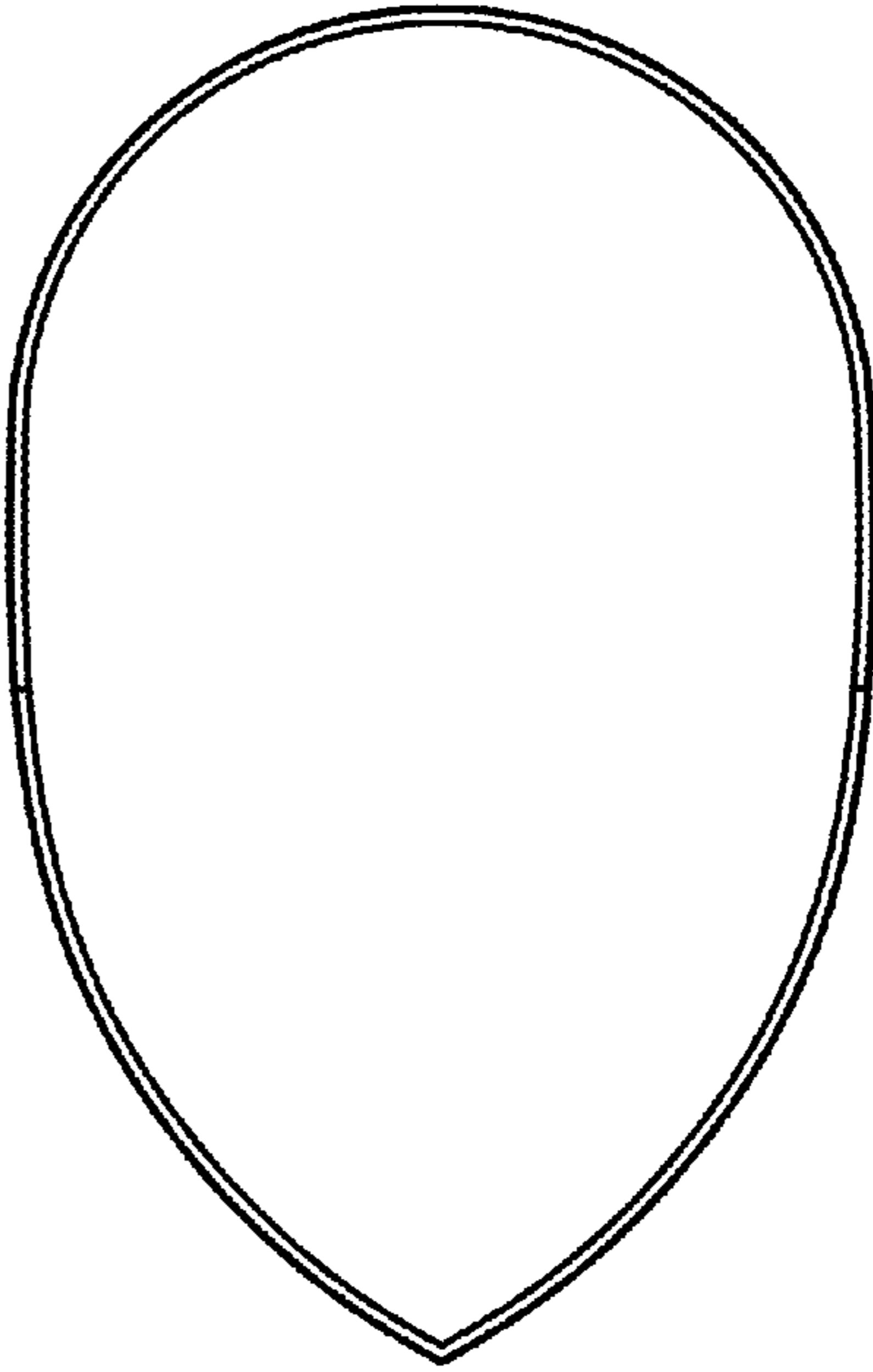
