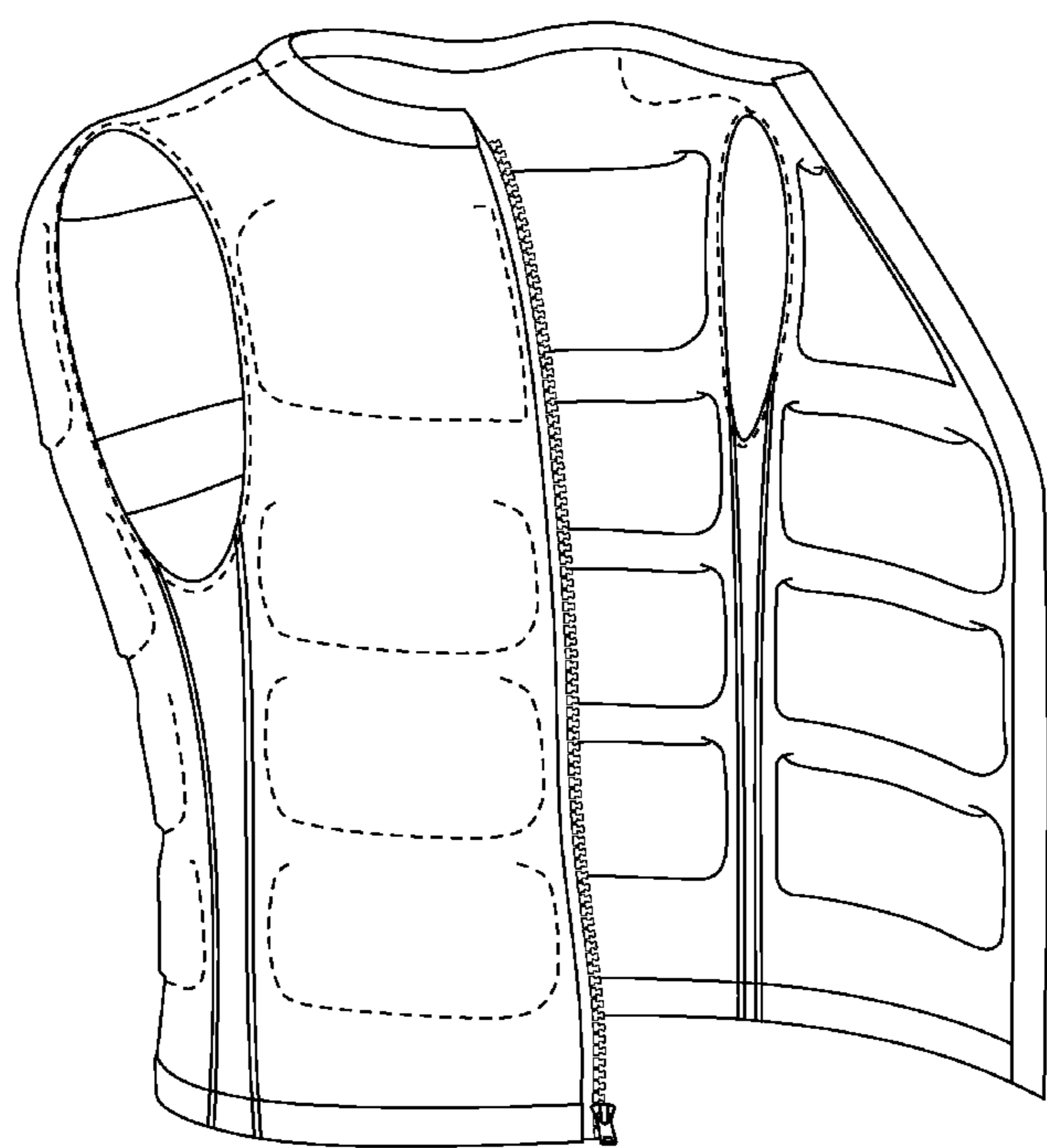
(57) **CLAIM**
The ornamental design for a weighted exercise vest, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a weighted exercise vest; FIG. 2 is a front view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a front elevation open to an inside view thereof; and, FIG. 6 is a front perspective partially open to an inside view thereof.
The broken lines shown in the drawings represent portions of the weighted exercise vest which form no part of the claimed design.

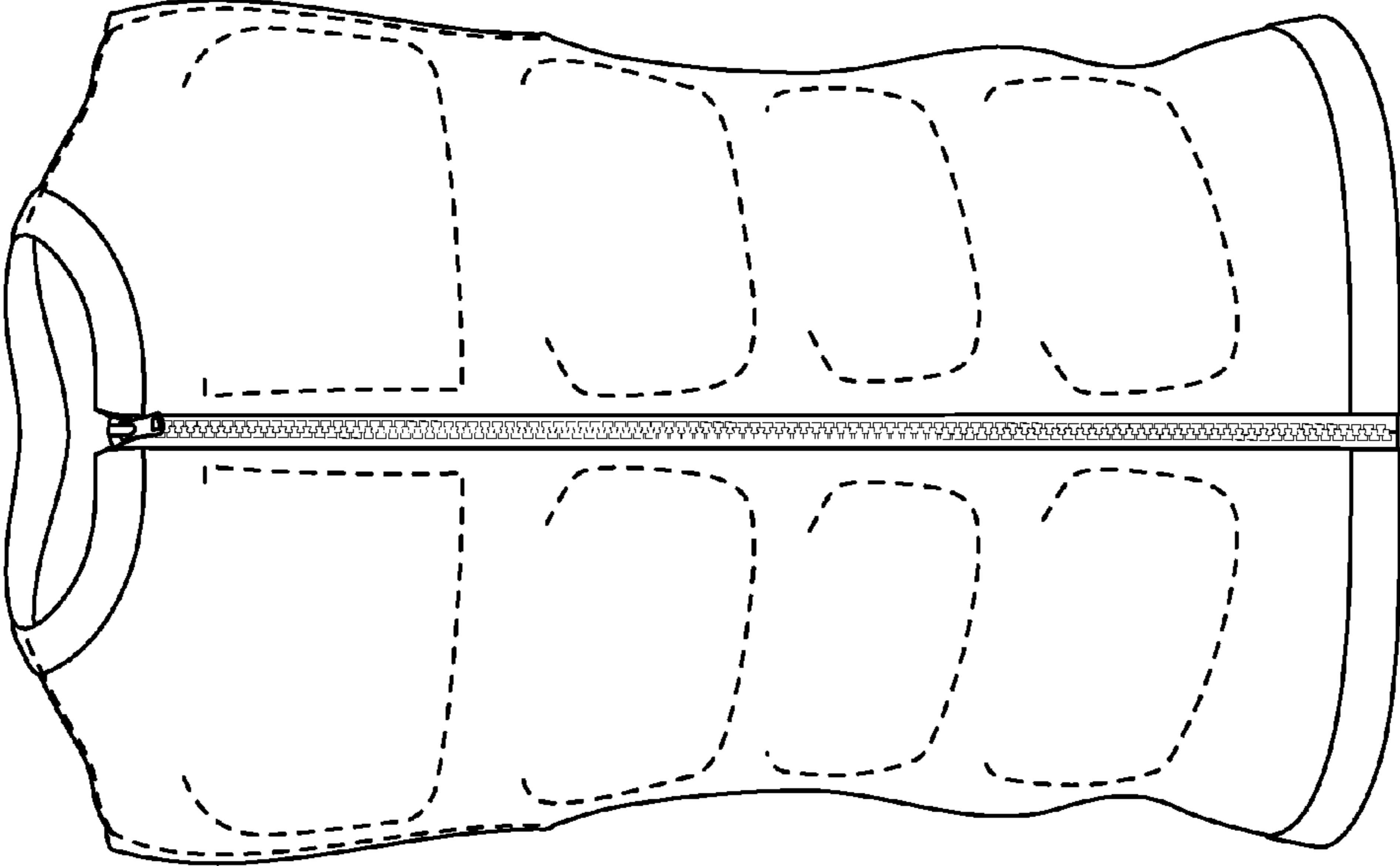

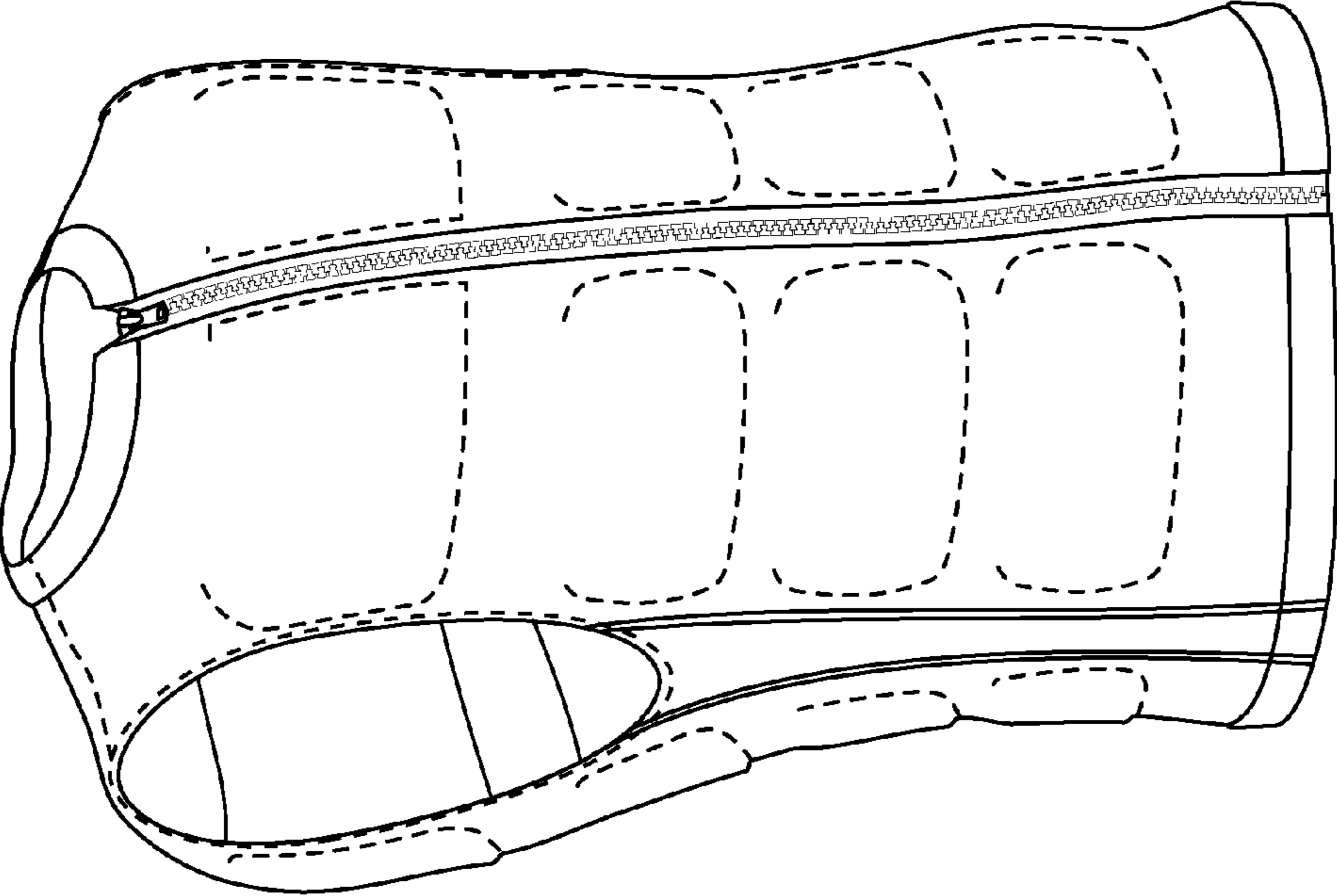

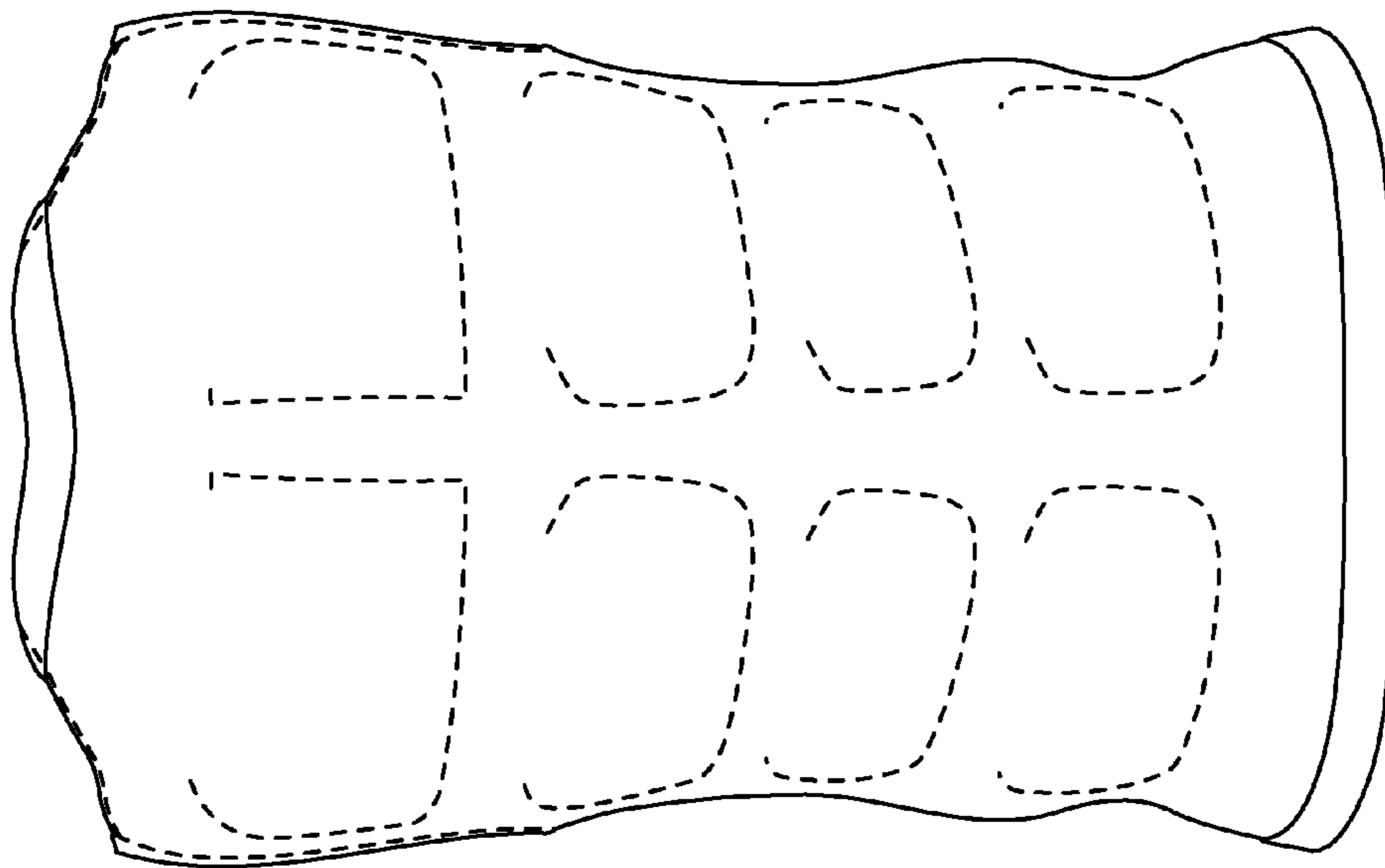

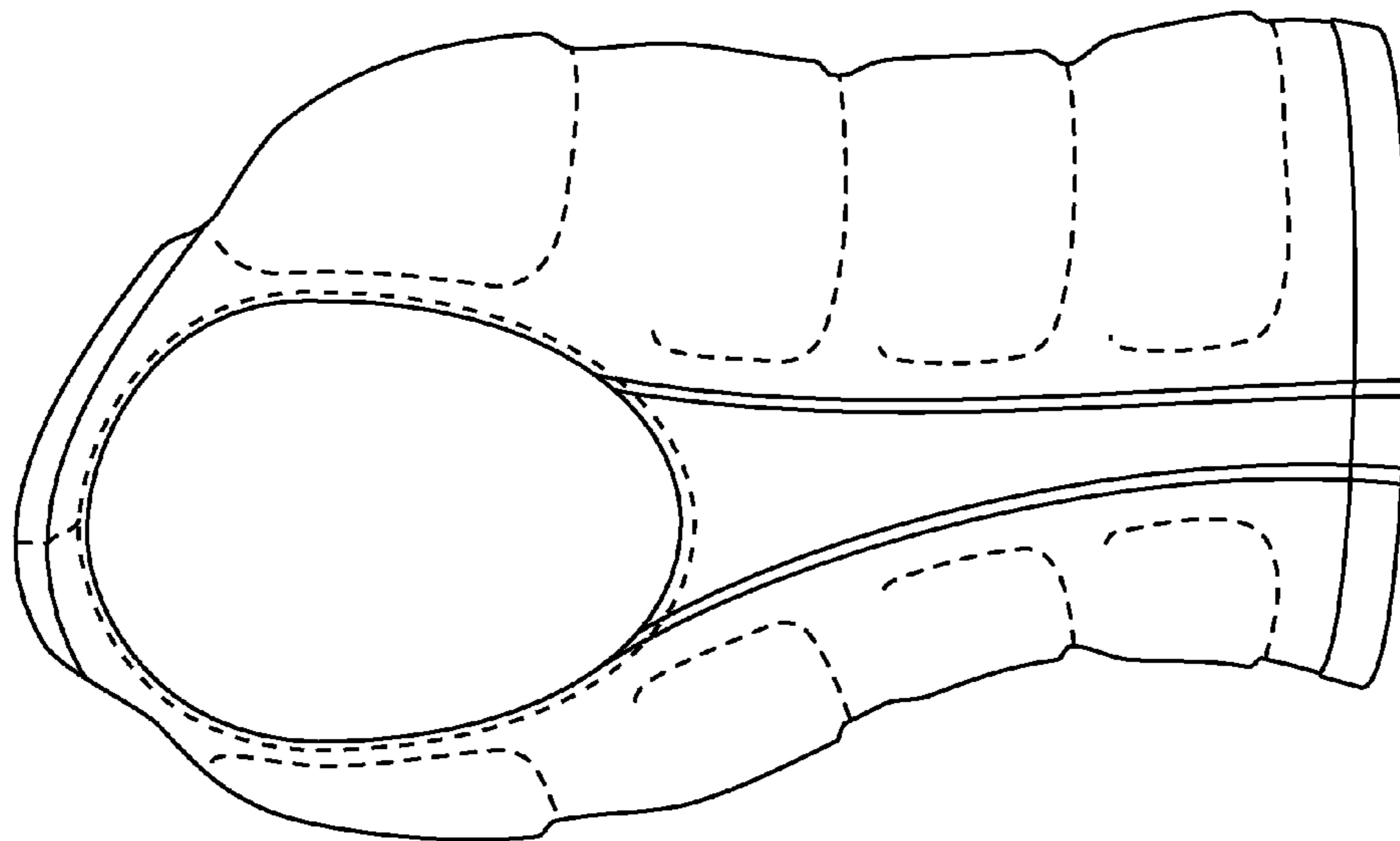

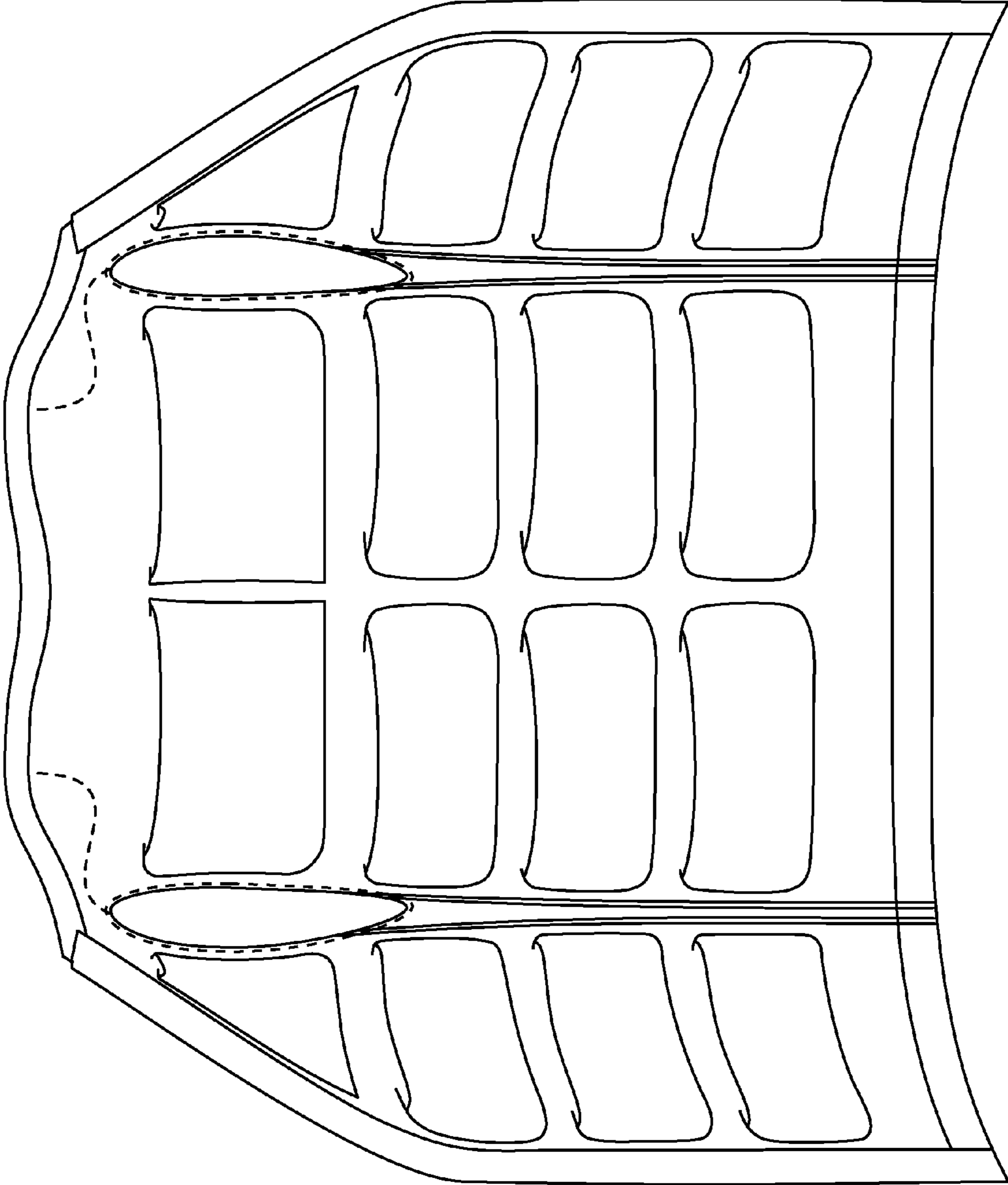

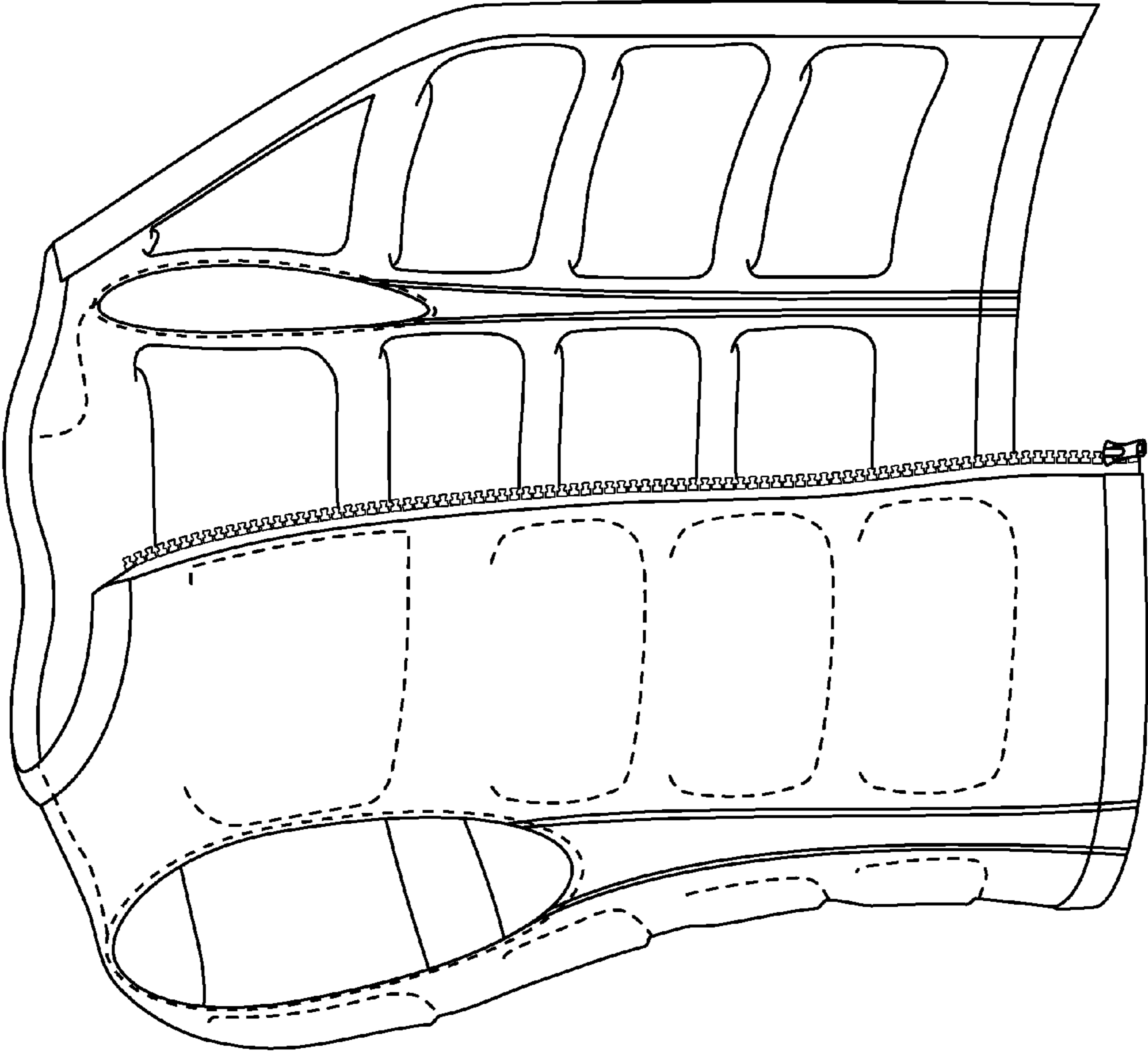
