(57) **CLAIM**

I claim the ornamental design for a beanie with means for illumination, as shown and described.

DESCRIPTION

FIG. 16 is a top plan view thereof;

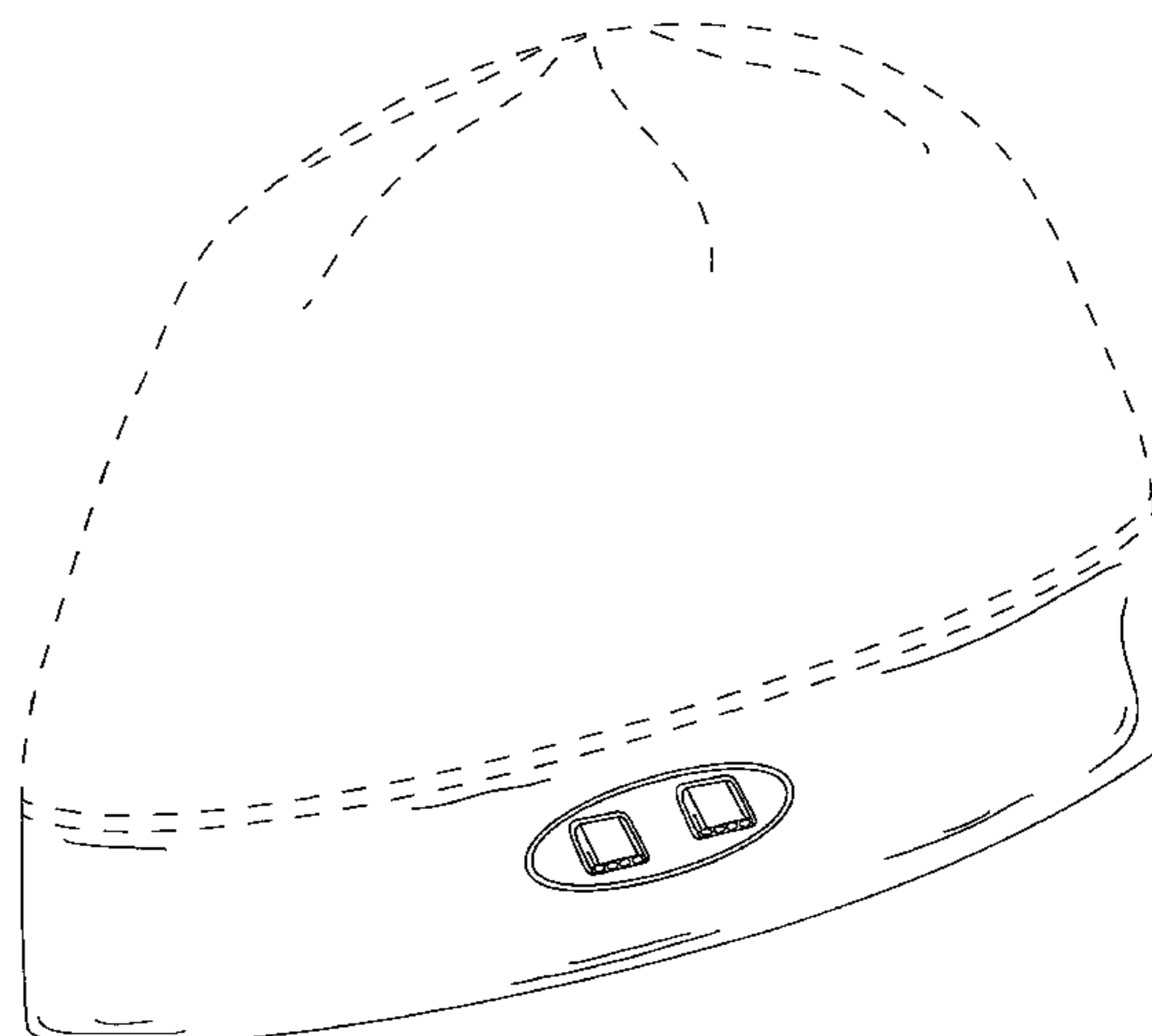
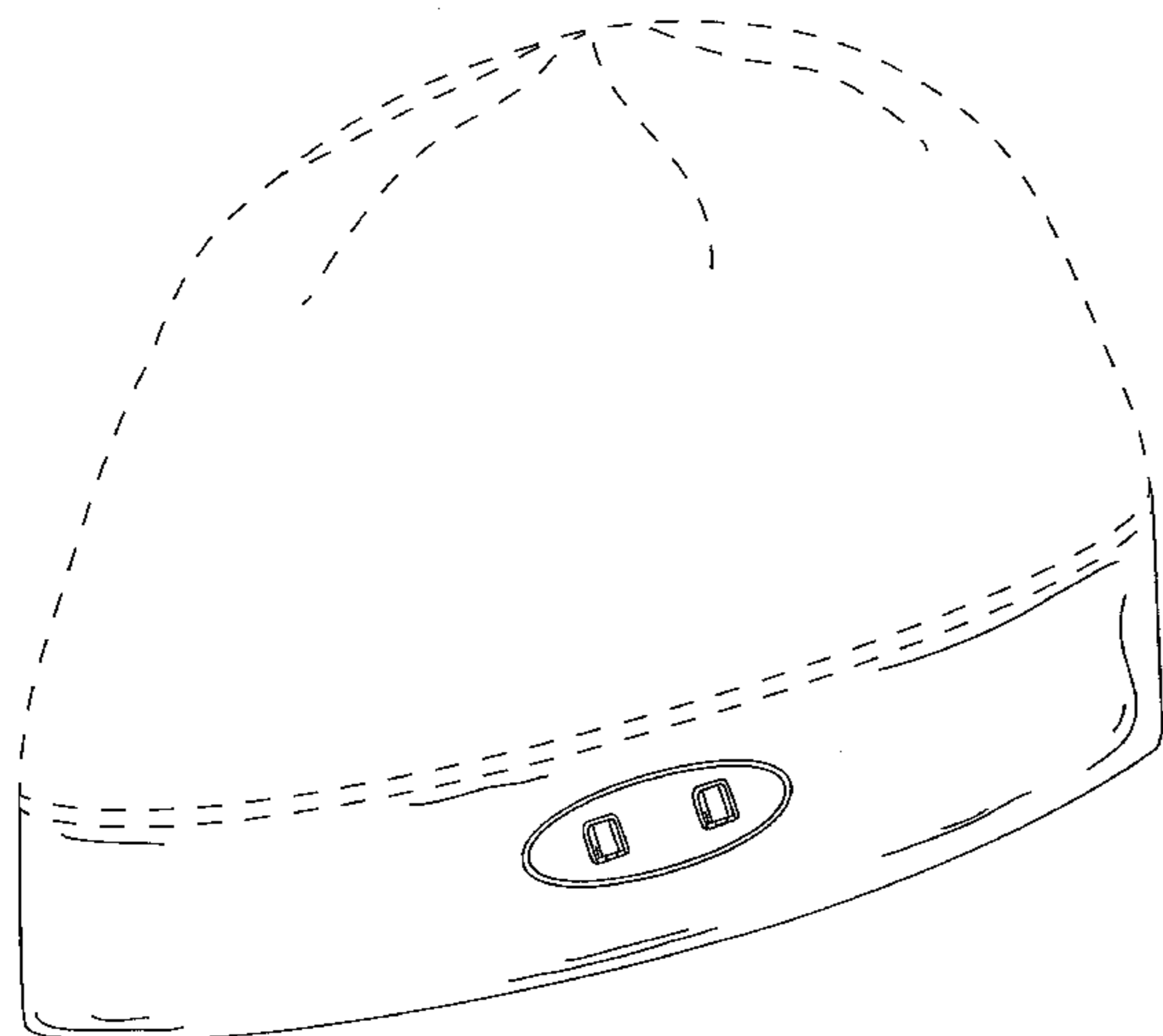
FIG. 17 is a rear elevational view of each of the first through fourth embodiments of the beanie with means for illumination;

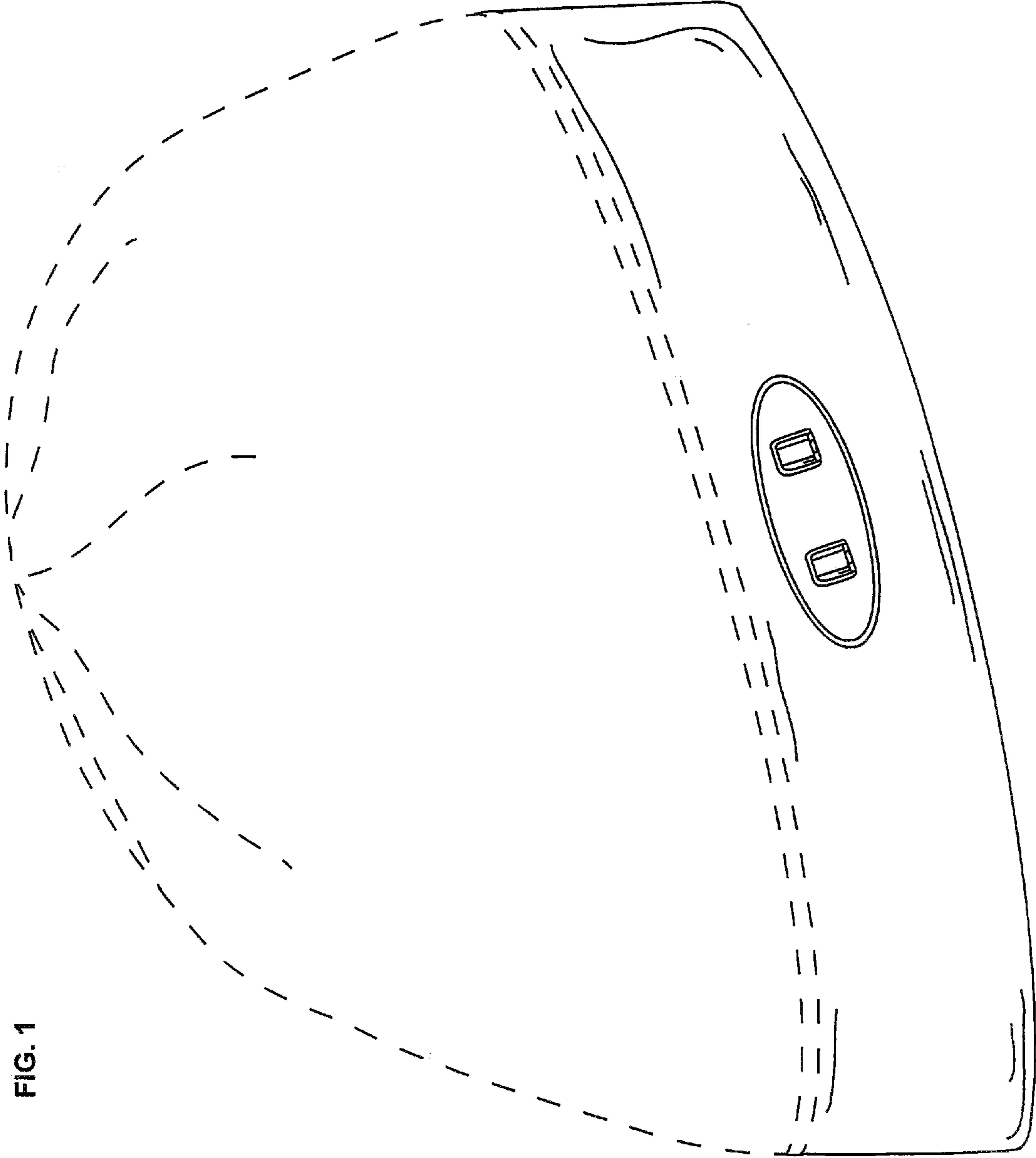

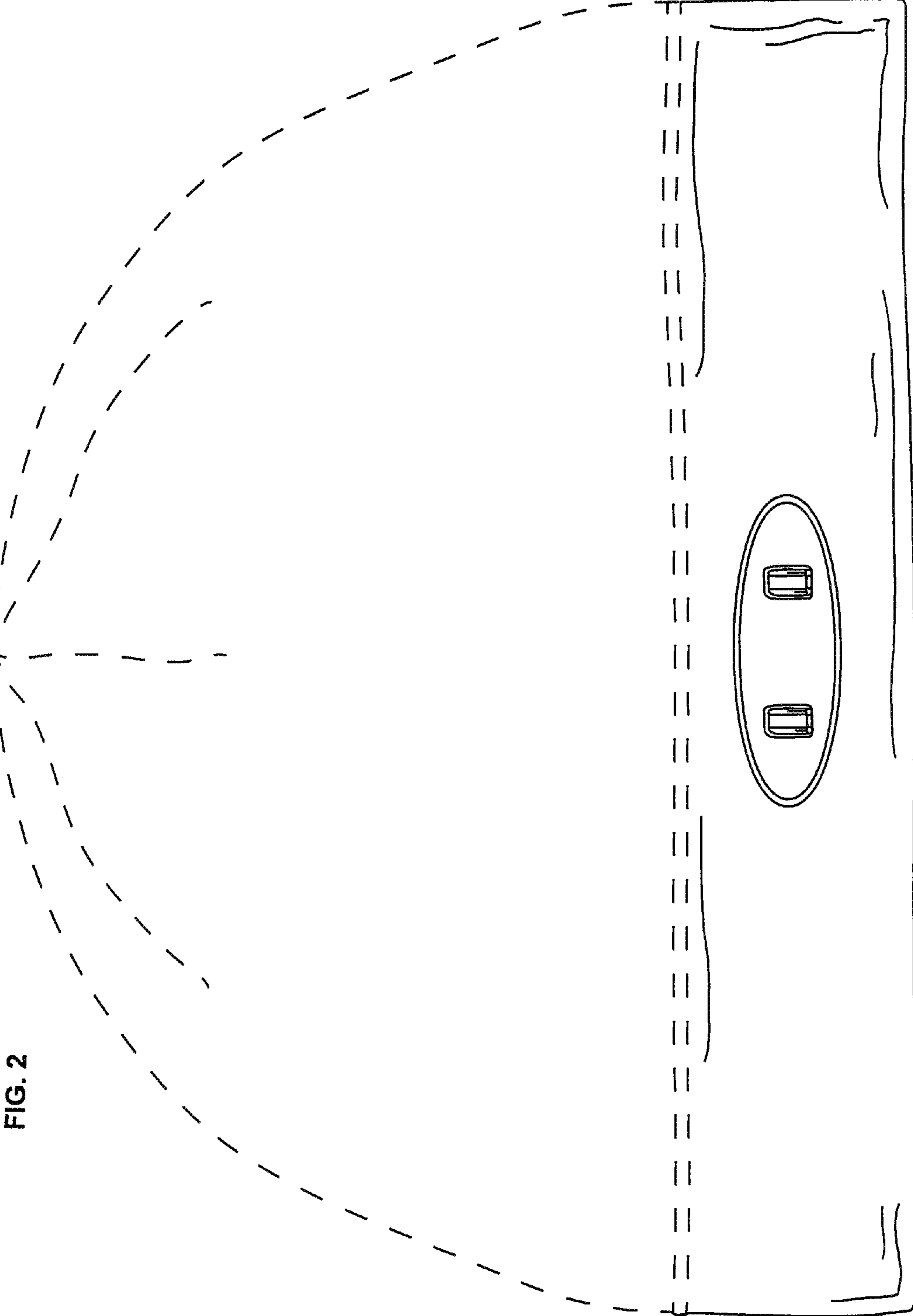

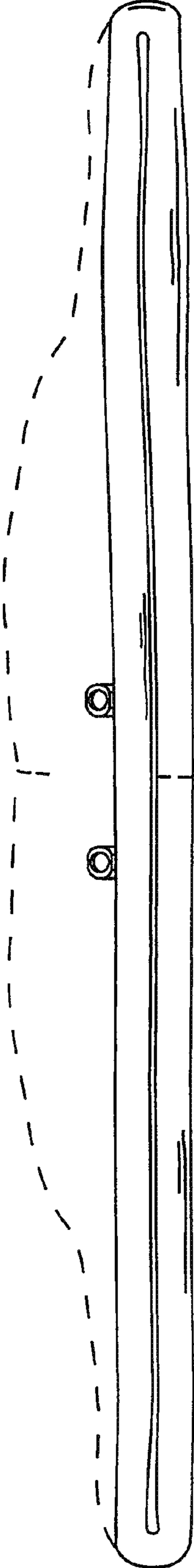

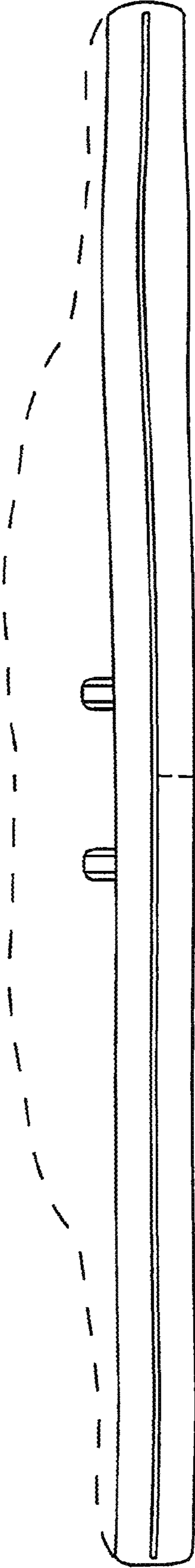

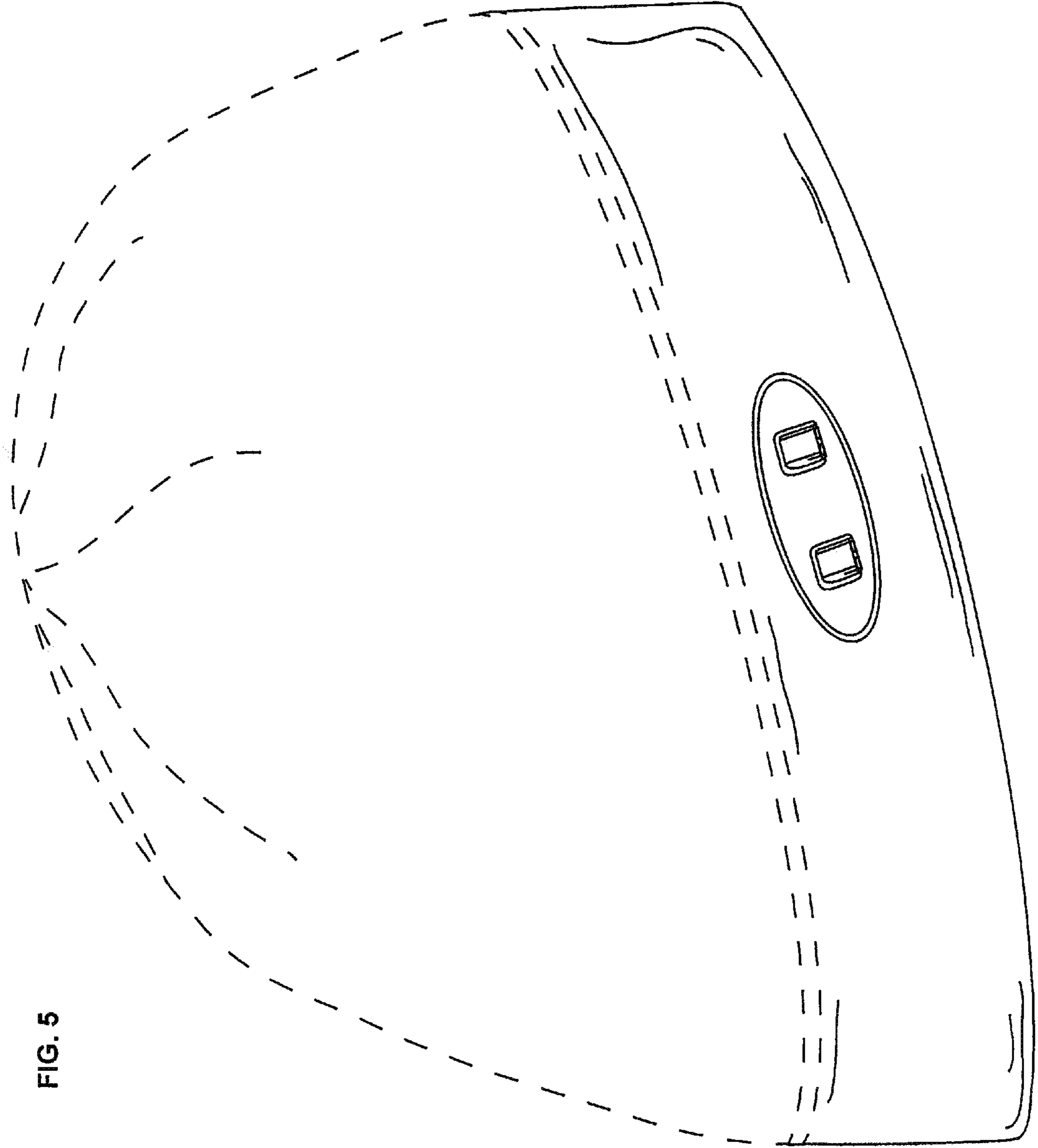

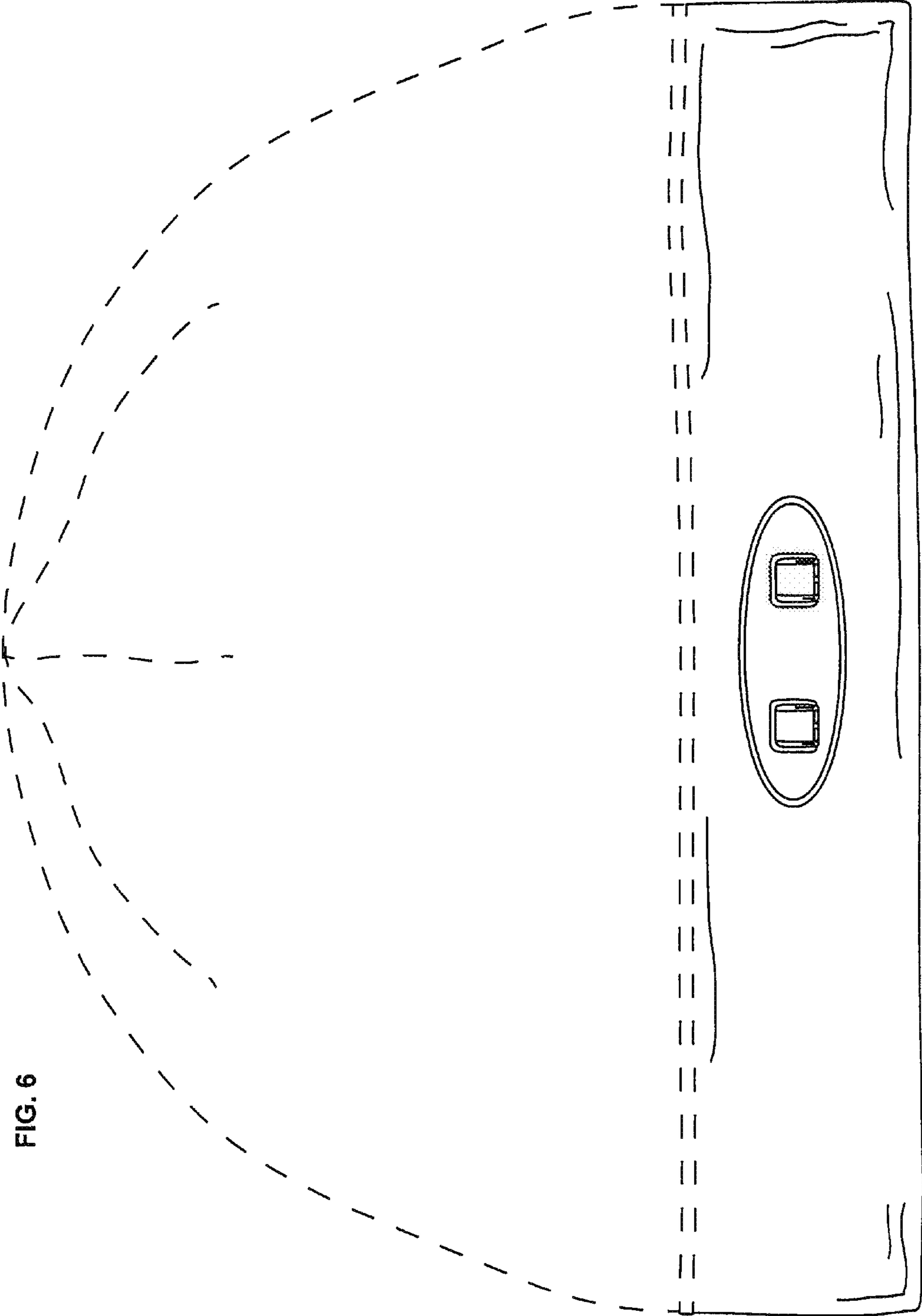

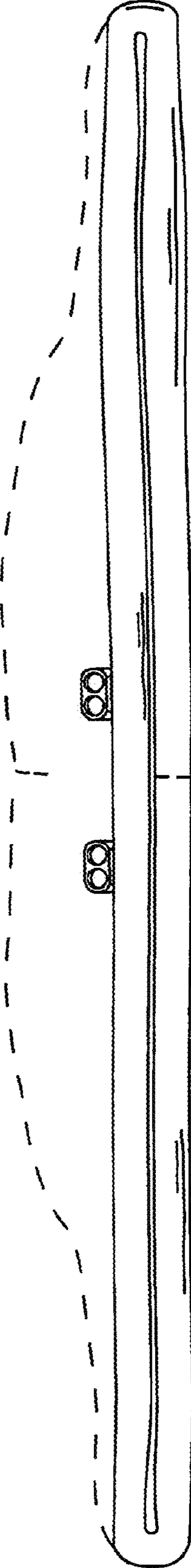

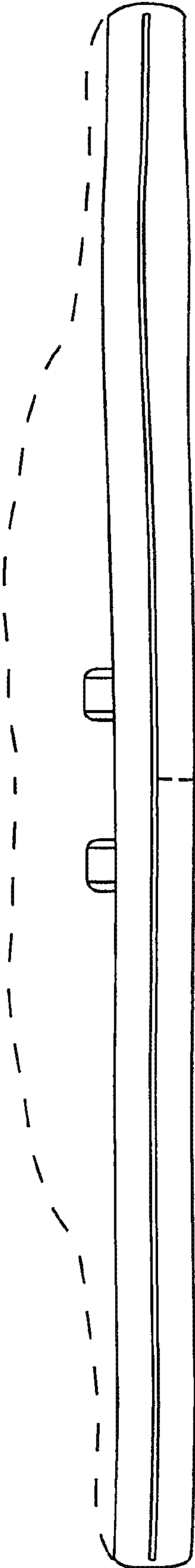

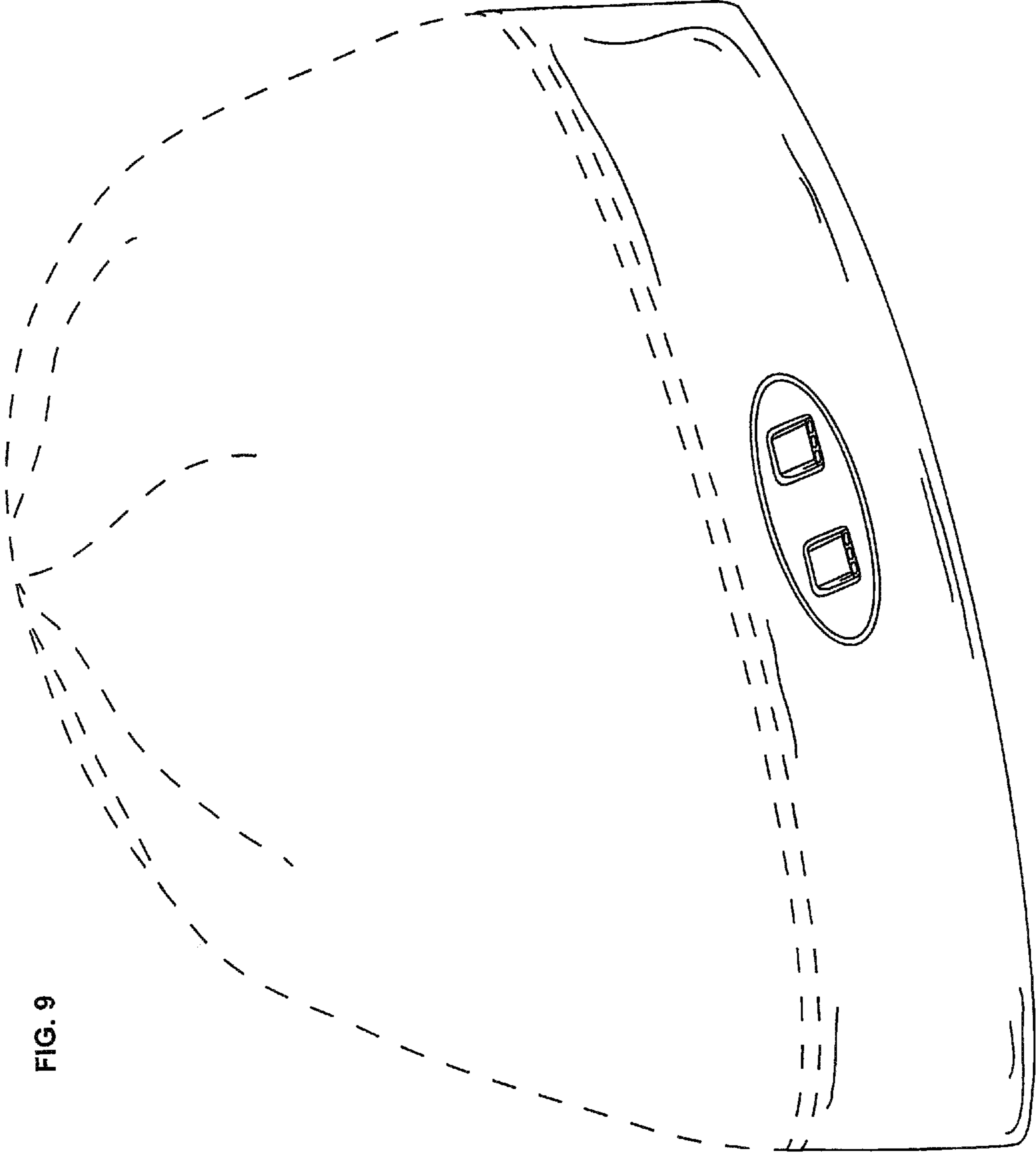

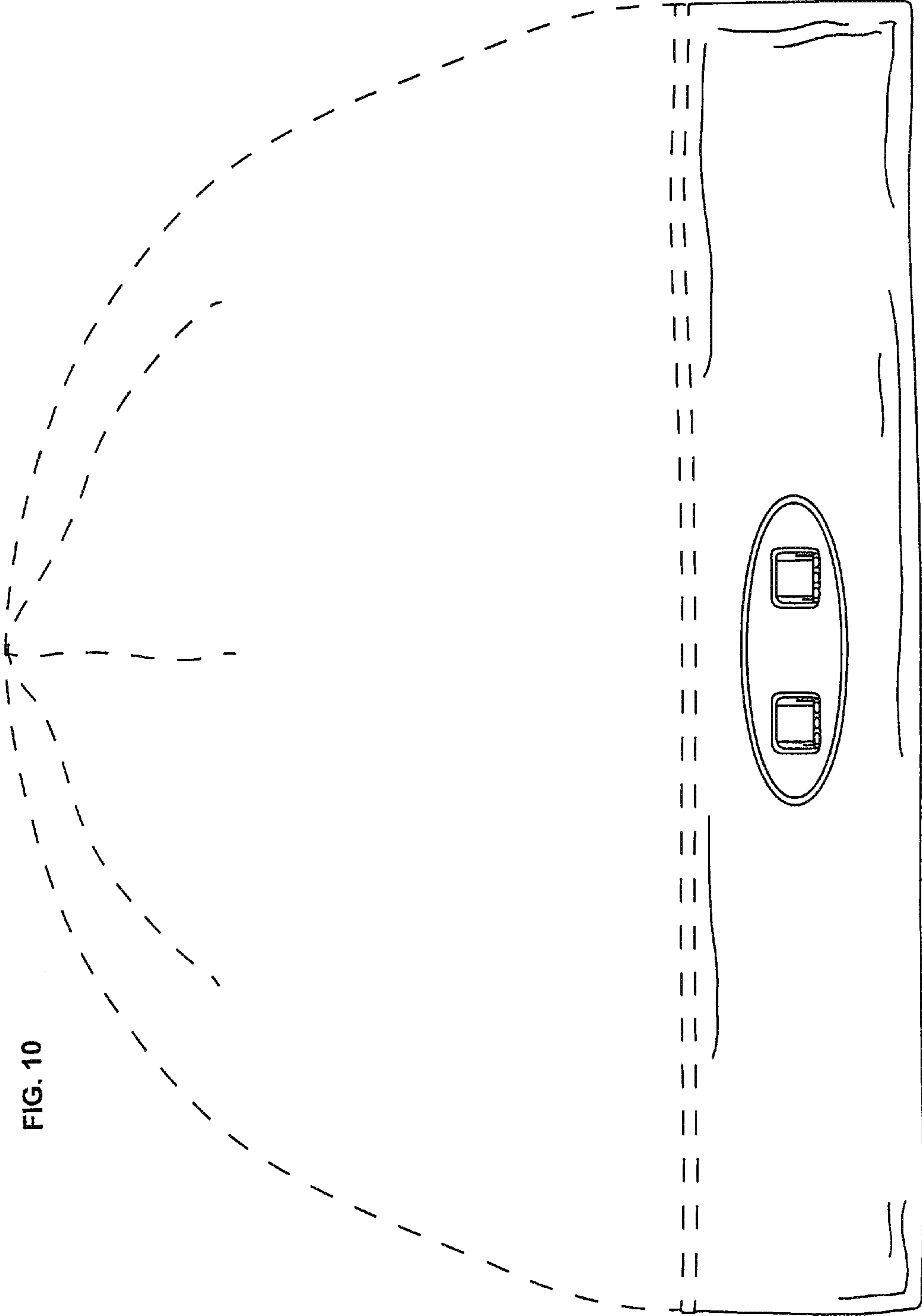

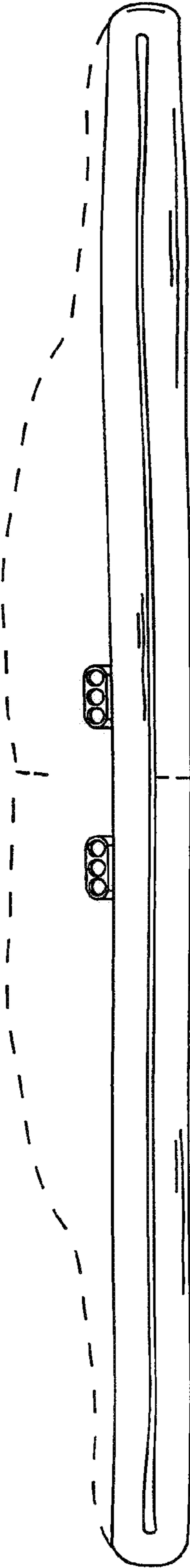

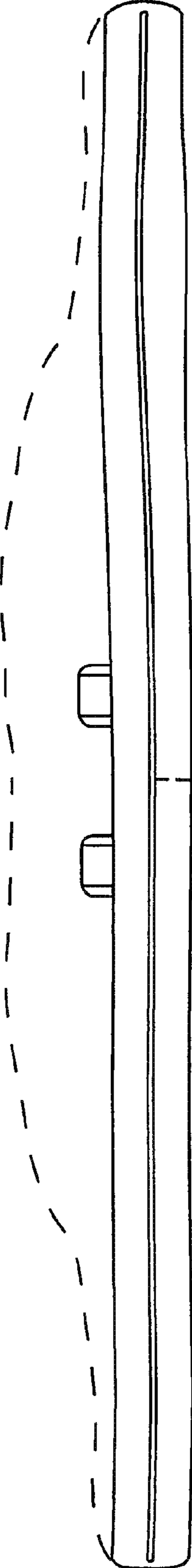

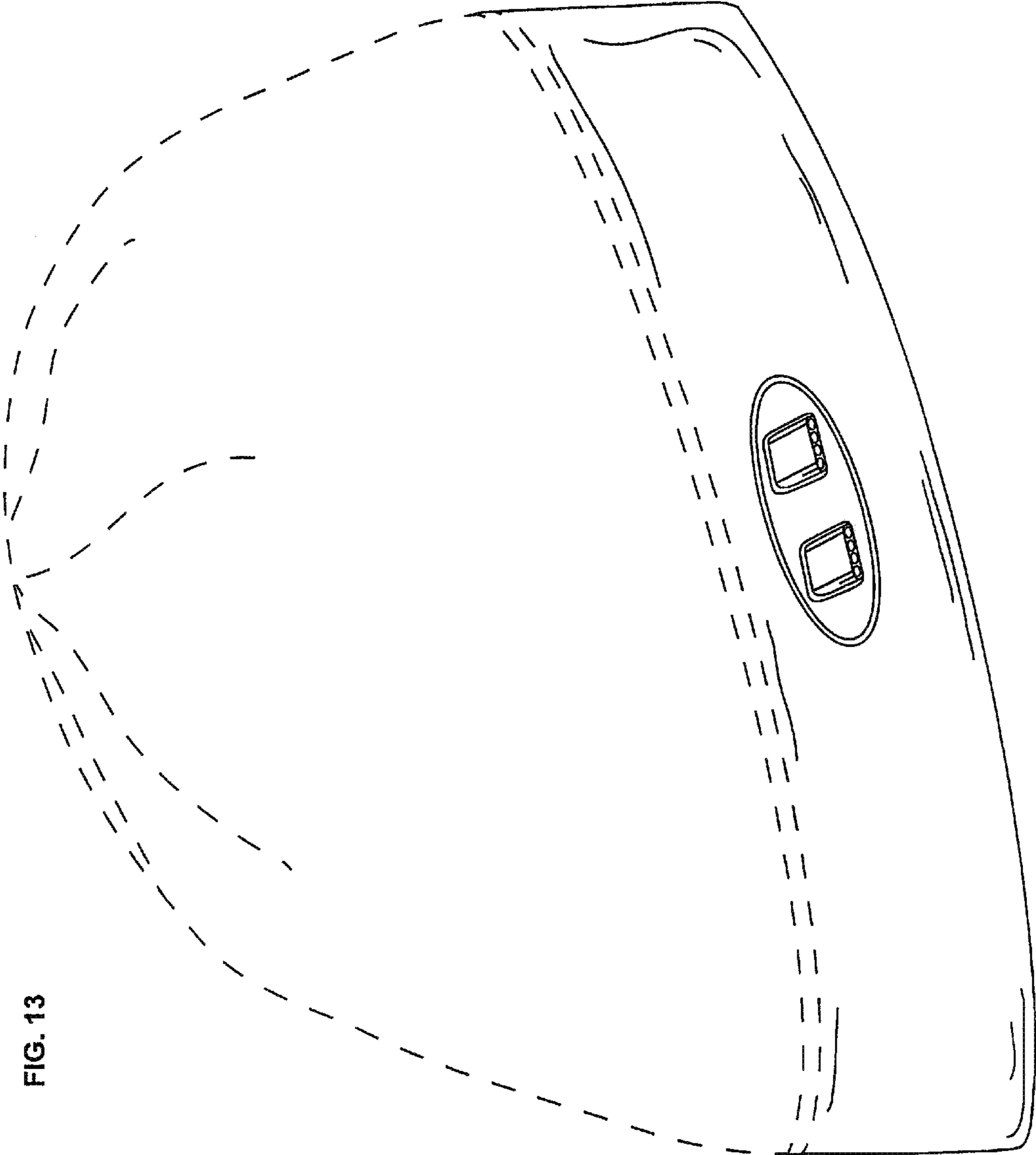

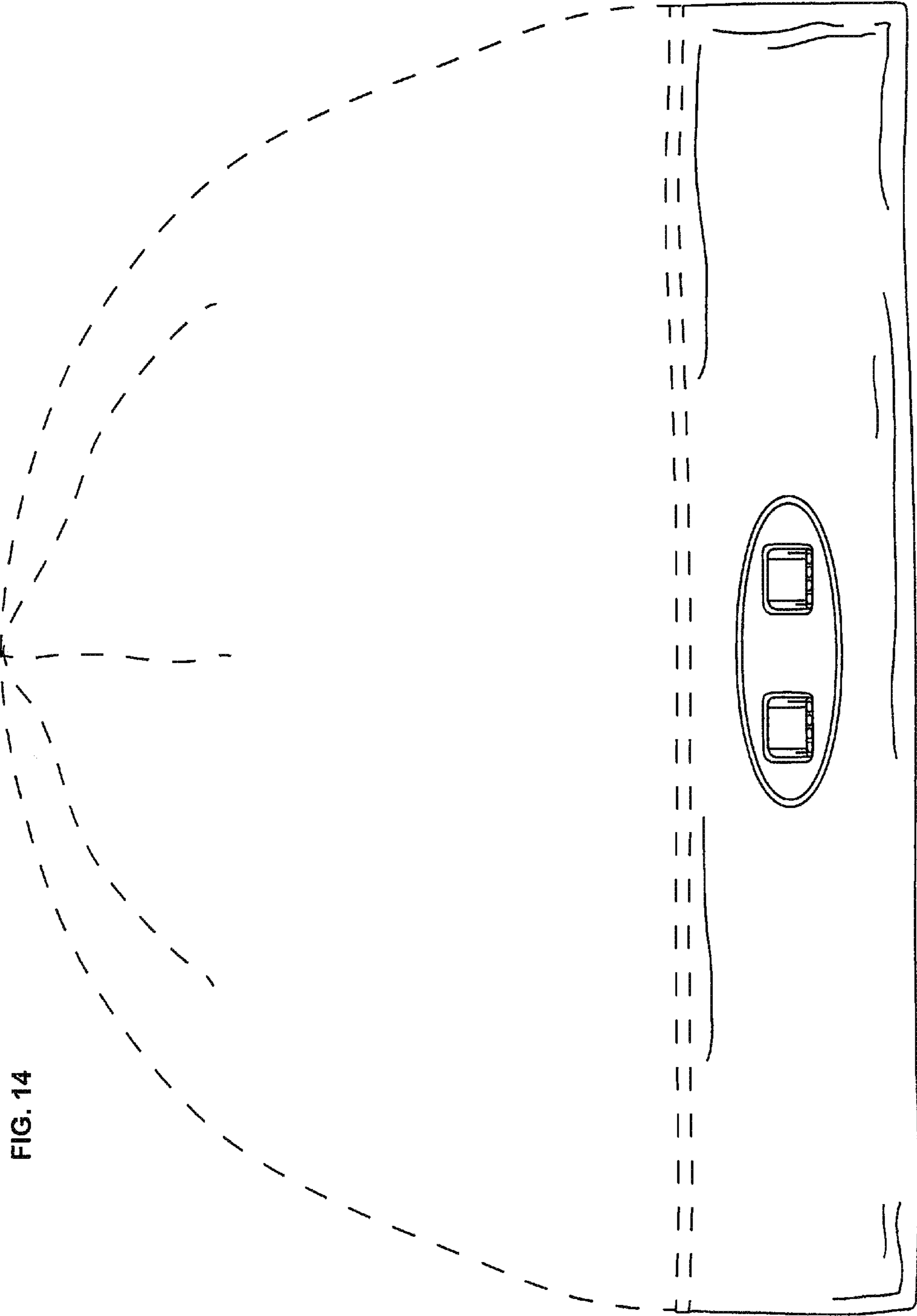

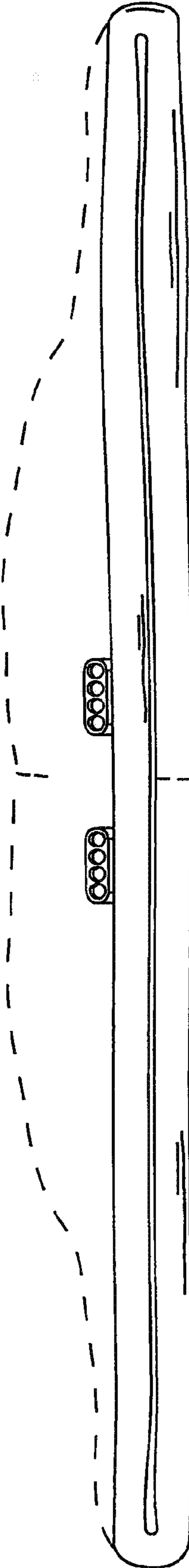

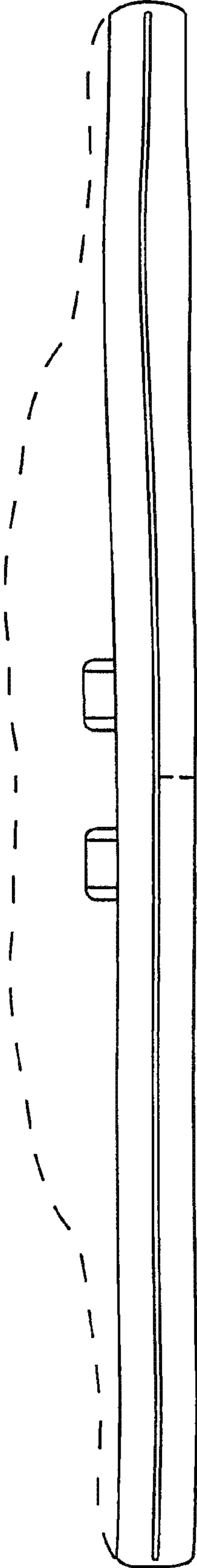

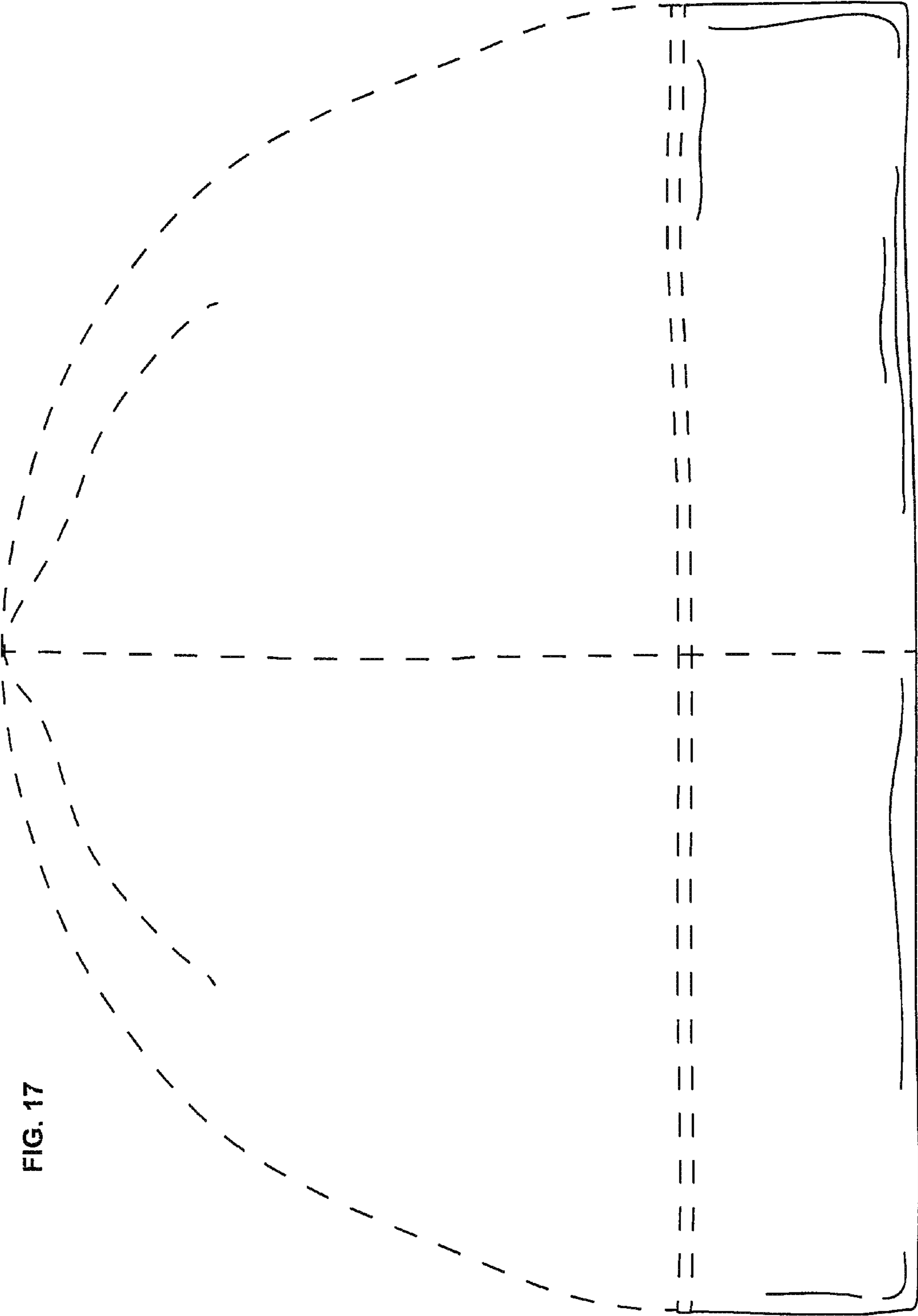

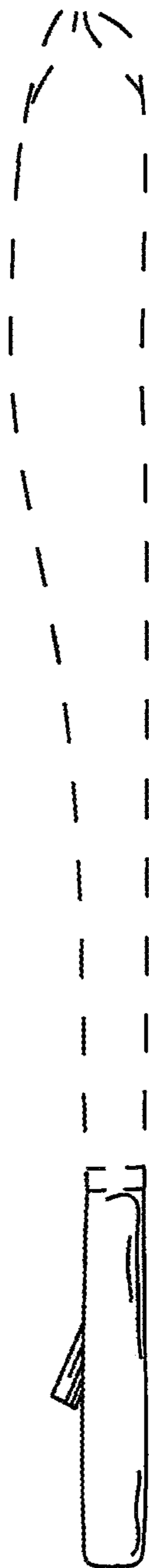
