(57) **CLAIM**

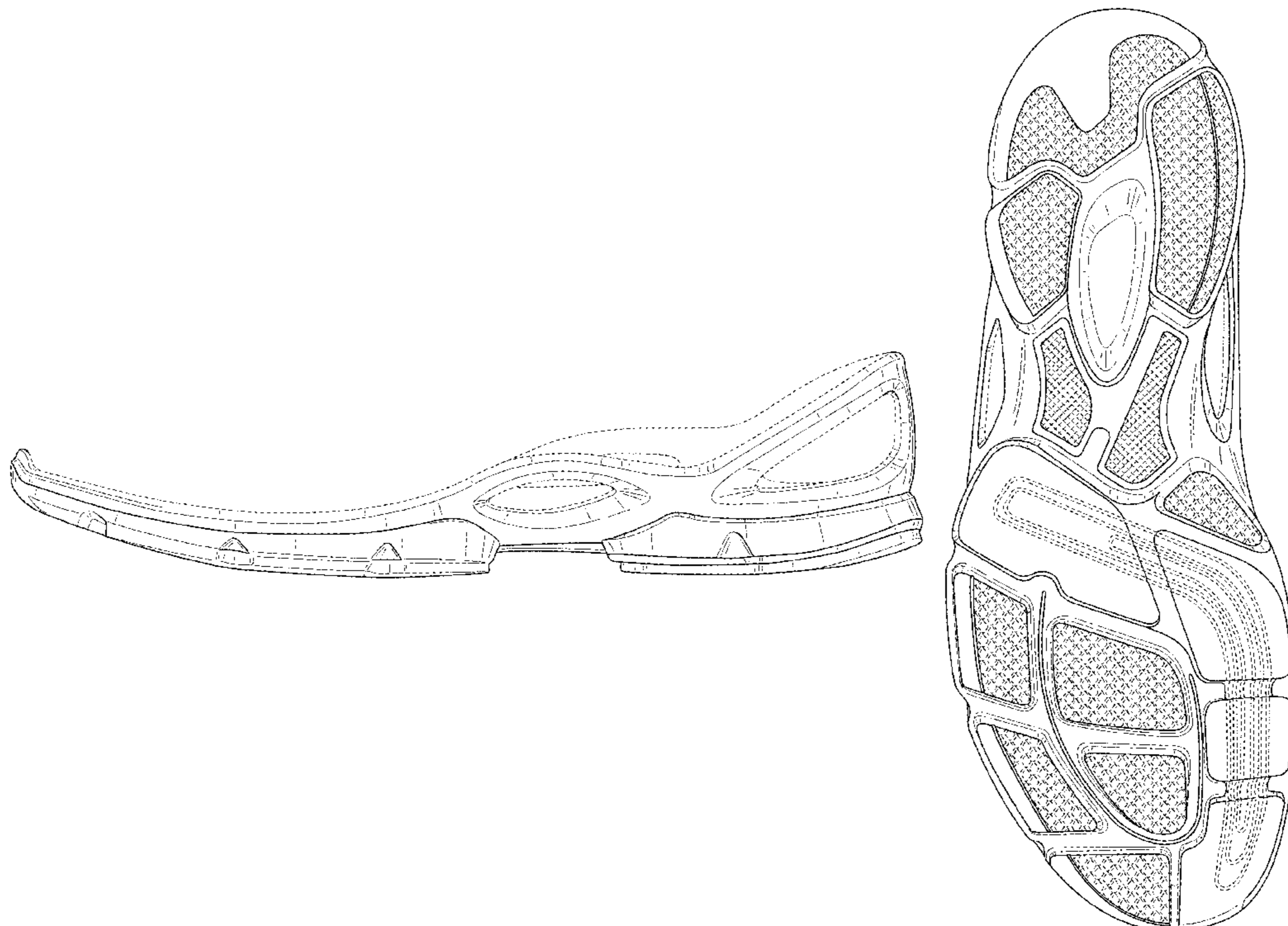
The ornamental design for a sole, substantially as shown and described.

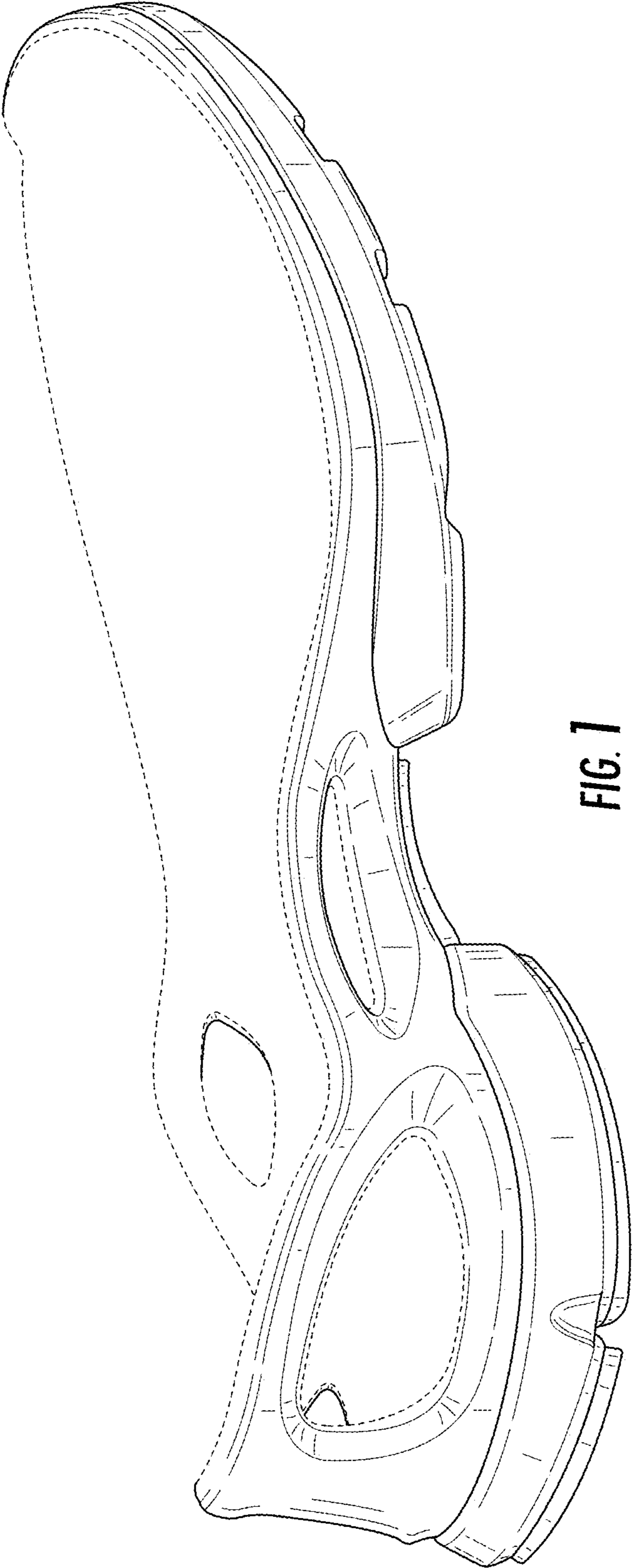
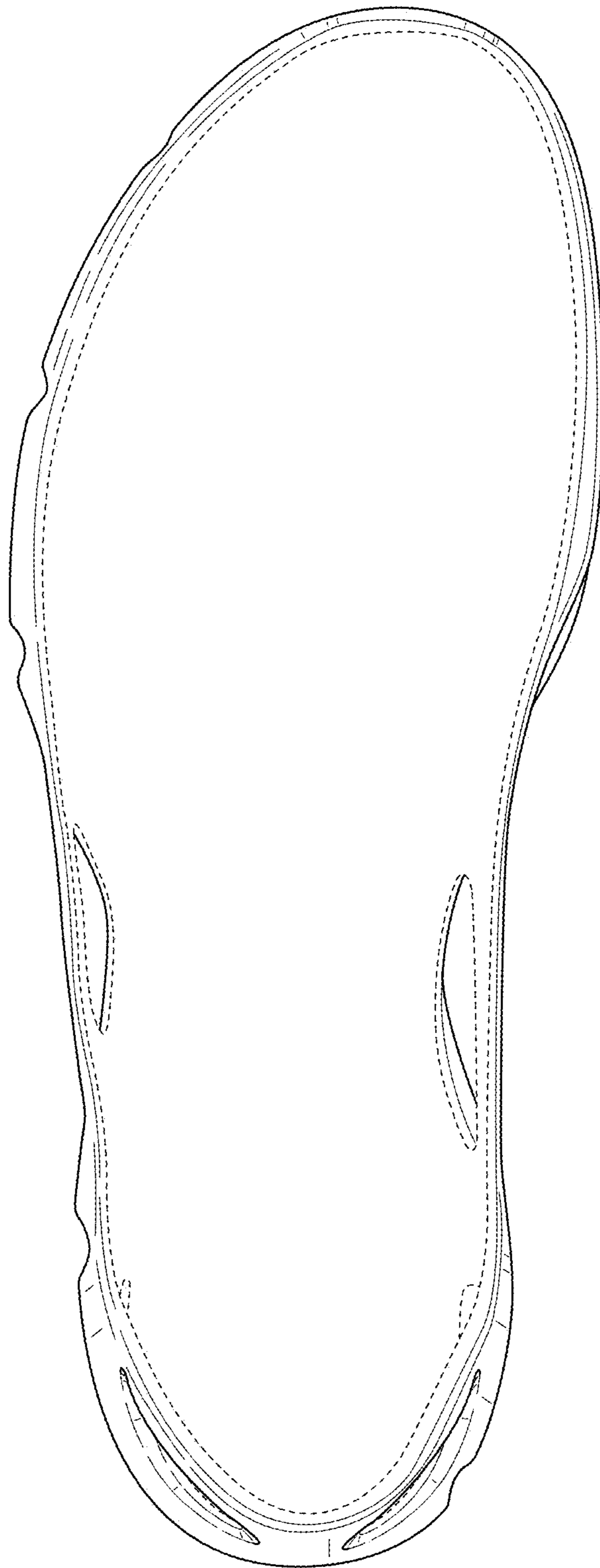

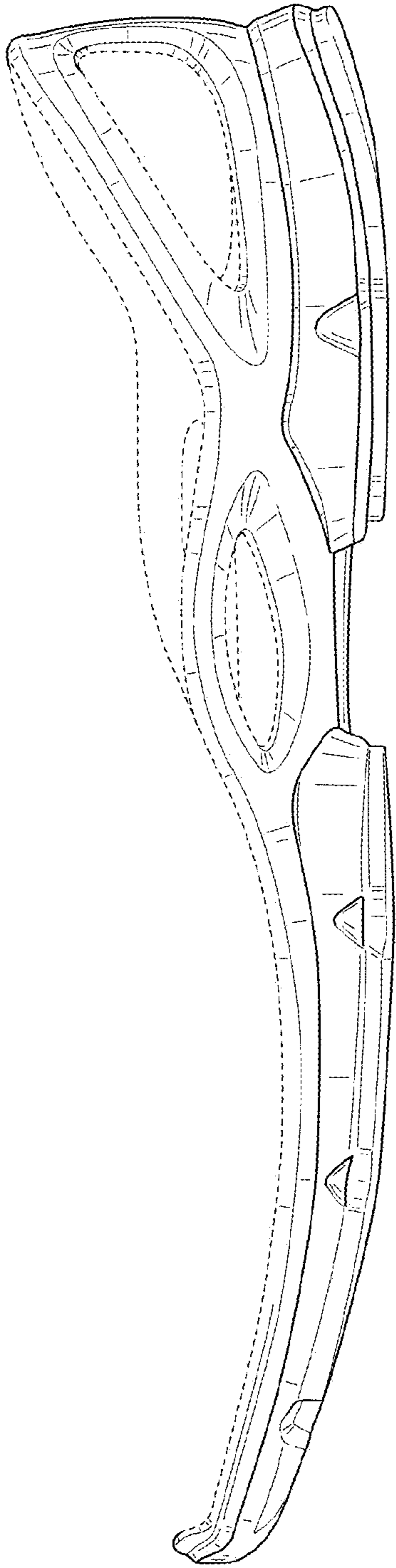

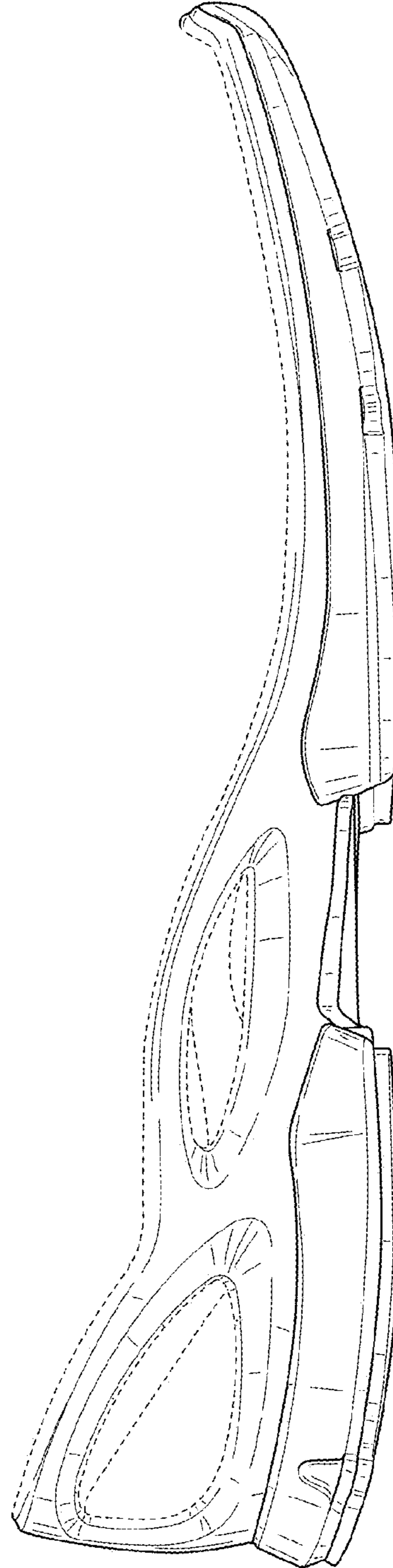

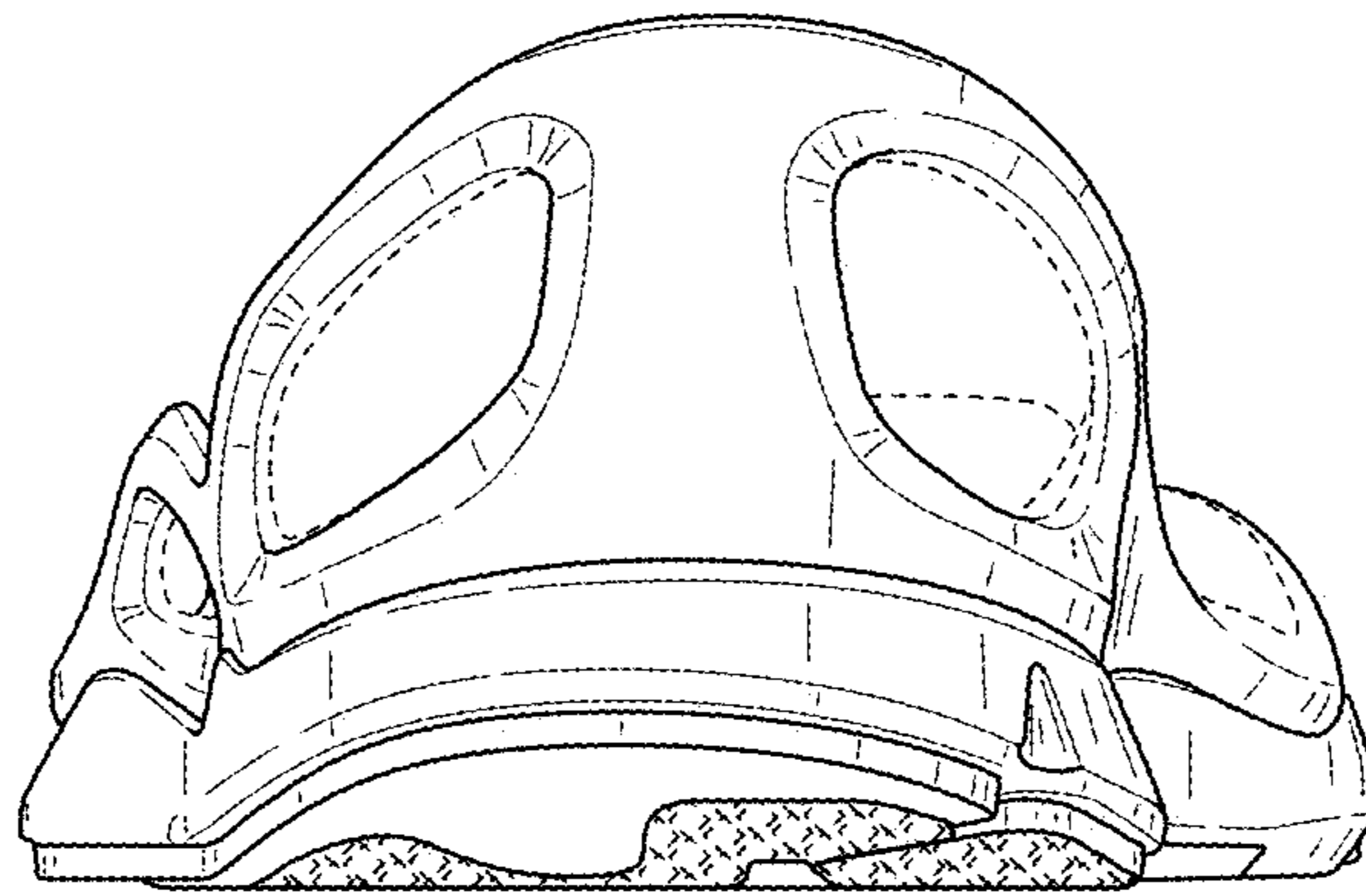

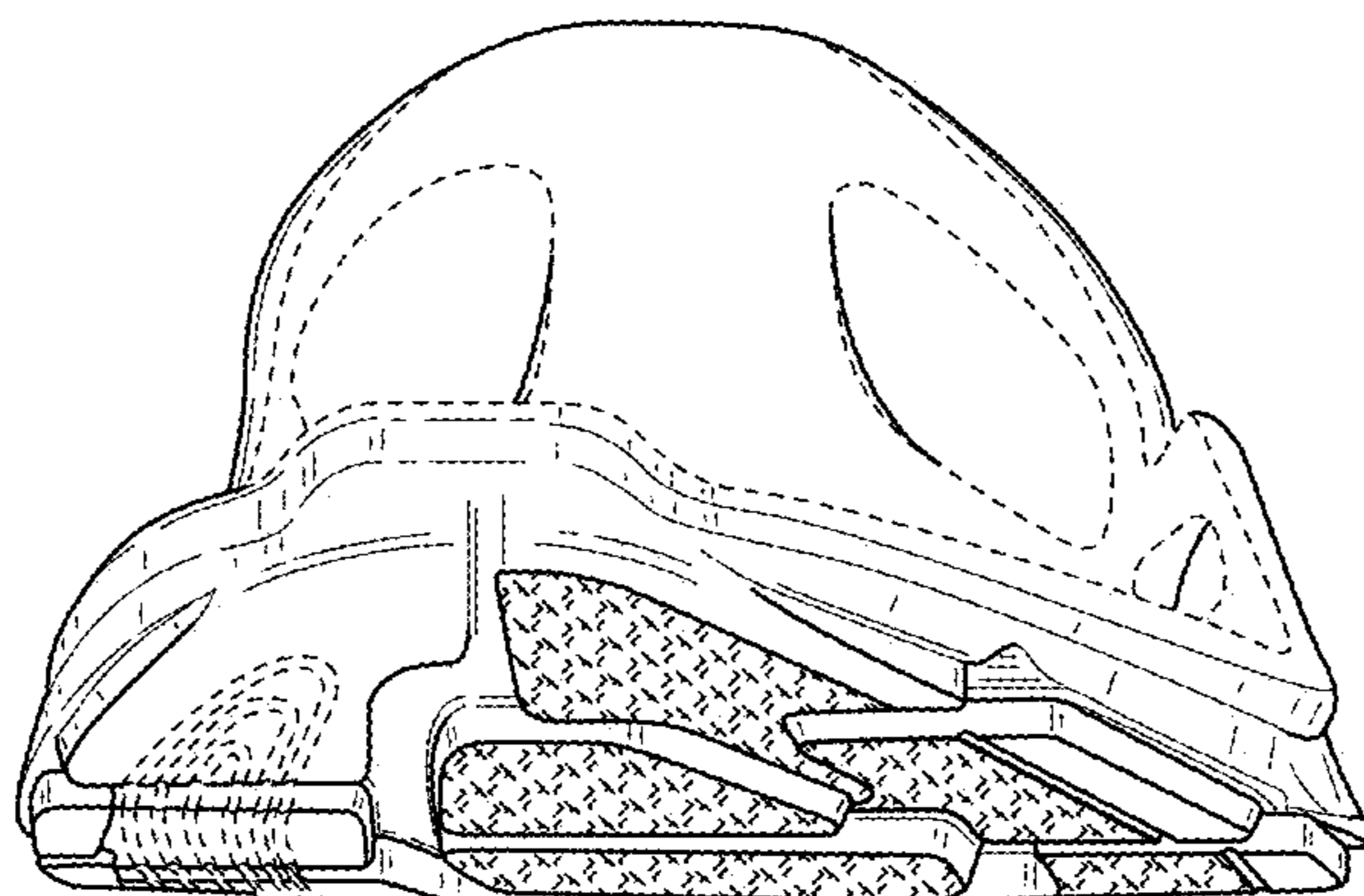

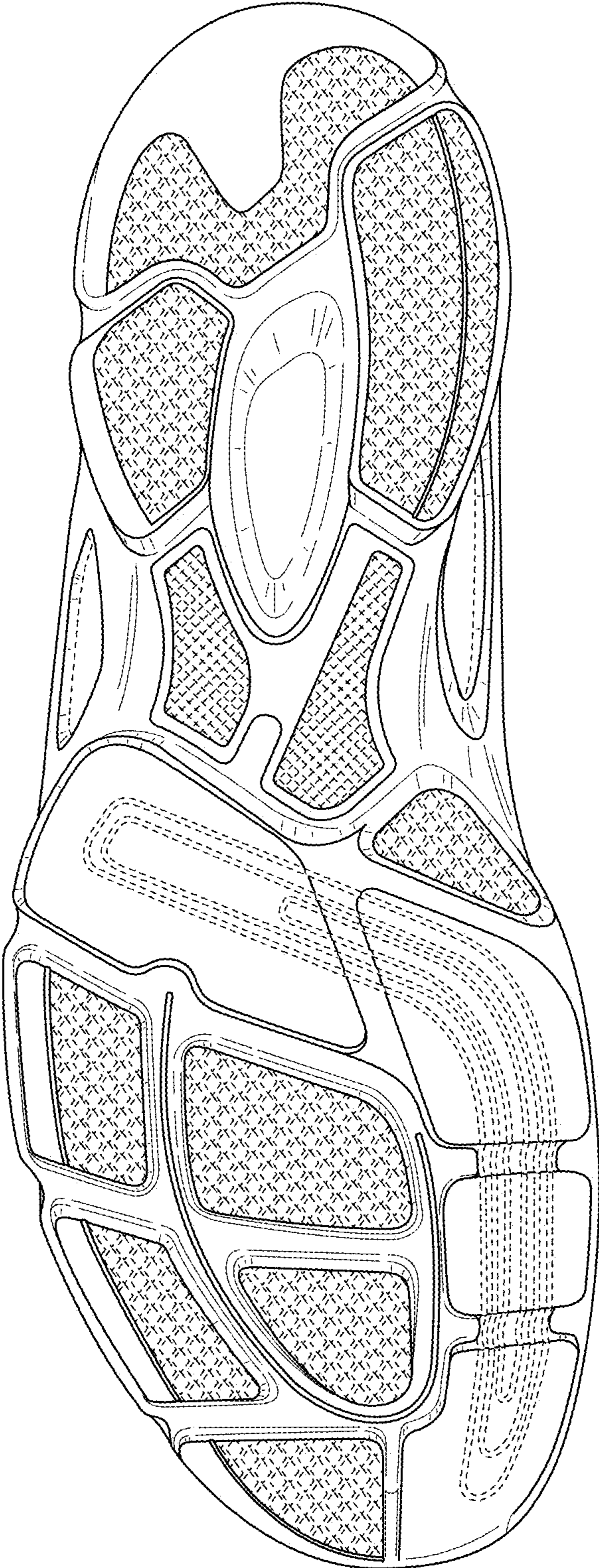
