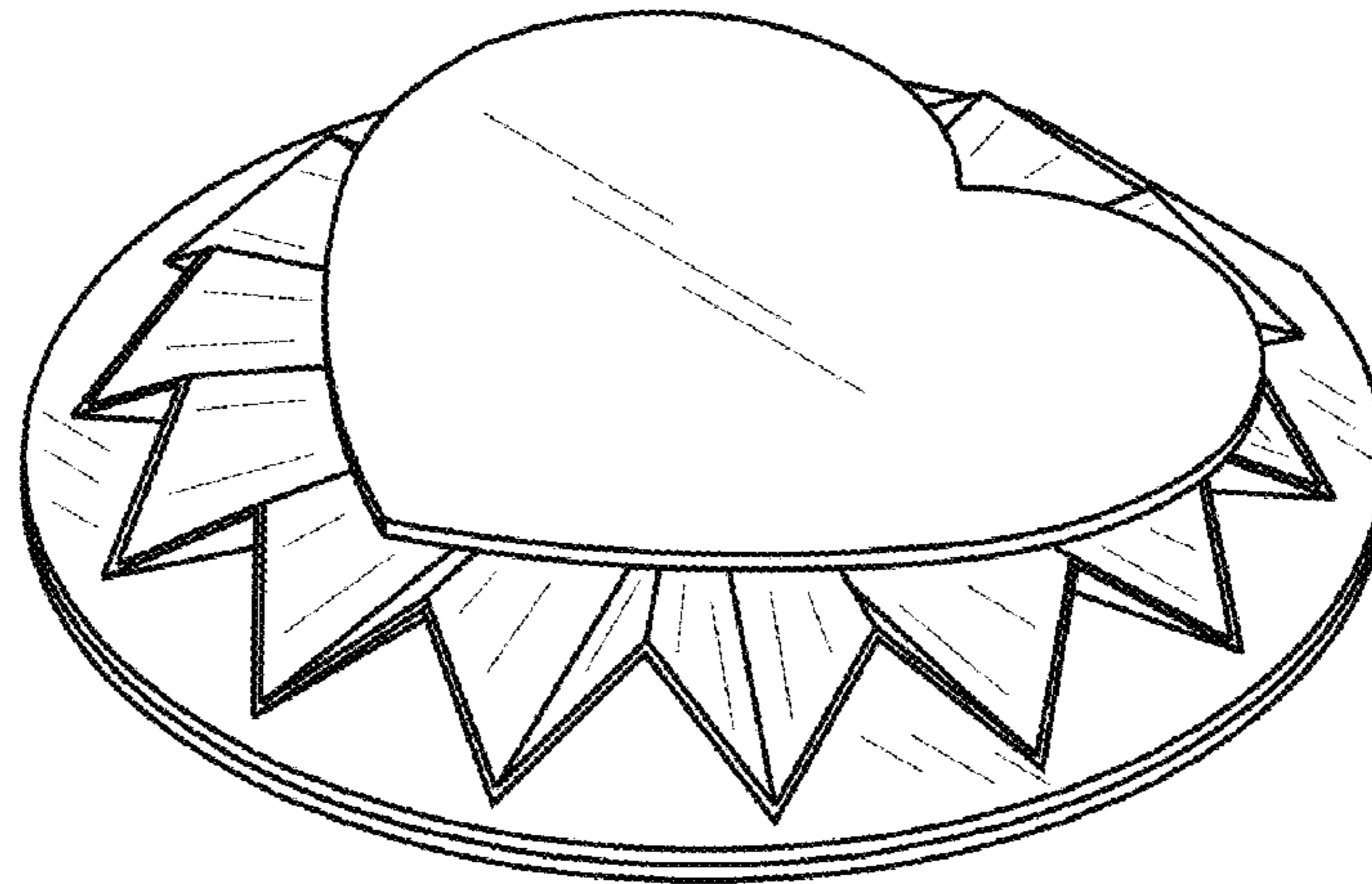
(57) **CLAIM**

The ornamental design for a rosette box top holder for stored value cards, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a rosette box top holder for stored value cards in a closed configuration;
FIG. 2 is a front elevation view of the rosette box top holder for stored value cards in a closed configuration;
FIG. 3 is a rear elevation view of the rosette box top holder for stored value cards in a closed configuration;
FIG. 4 is a first side view of the rosette box top holder for stored value cards in a closed configuration;
FIG. 5 is a second side view of the rosette box top holder for stored value cards in a closed configuration;
FIG. 6 is a bottom view of the rosette box top holder for stored value cards in a closed configuration;
FIG. 7 is a top view of the rosette box top holder for stored value cards in a closed configuration; and,
FIG. 8 is a front perspective view of a rosette box top holder for stored value cards in an open configuration.
The broken dashed (---) lines showing in FIG. 8 is included for the purpose of illustrating portions of the rosette box top holder for stored value cards that form no part of the claimed design.

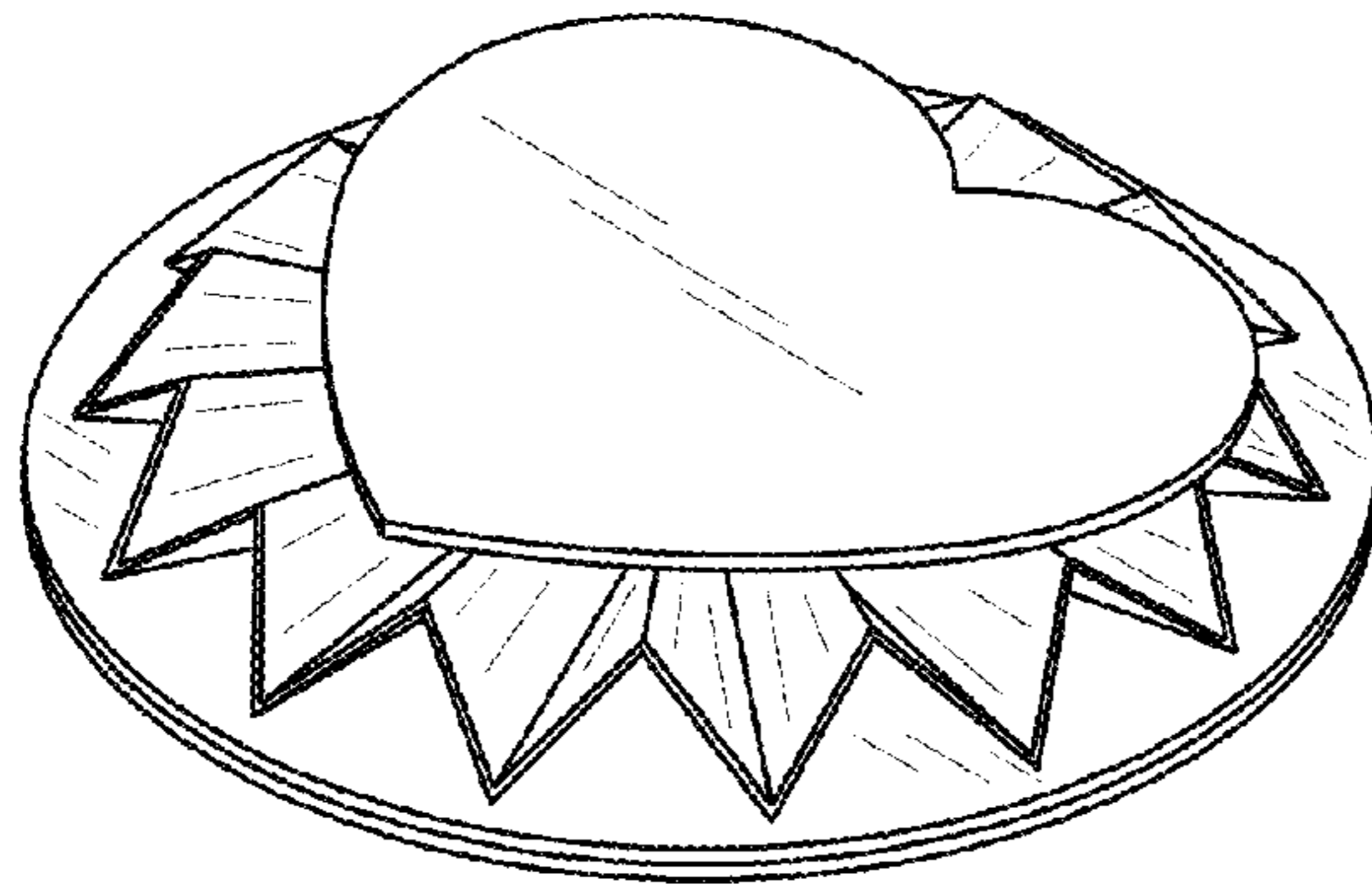

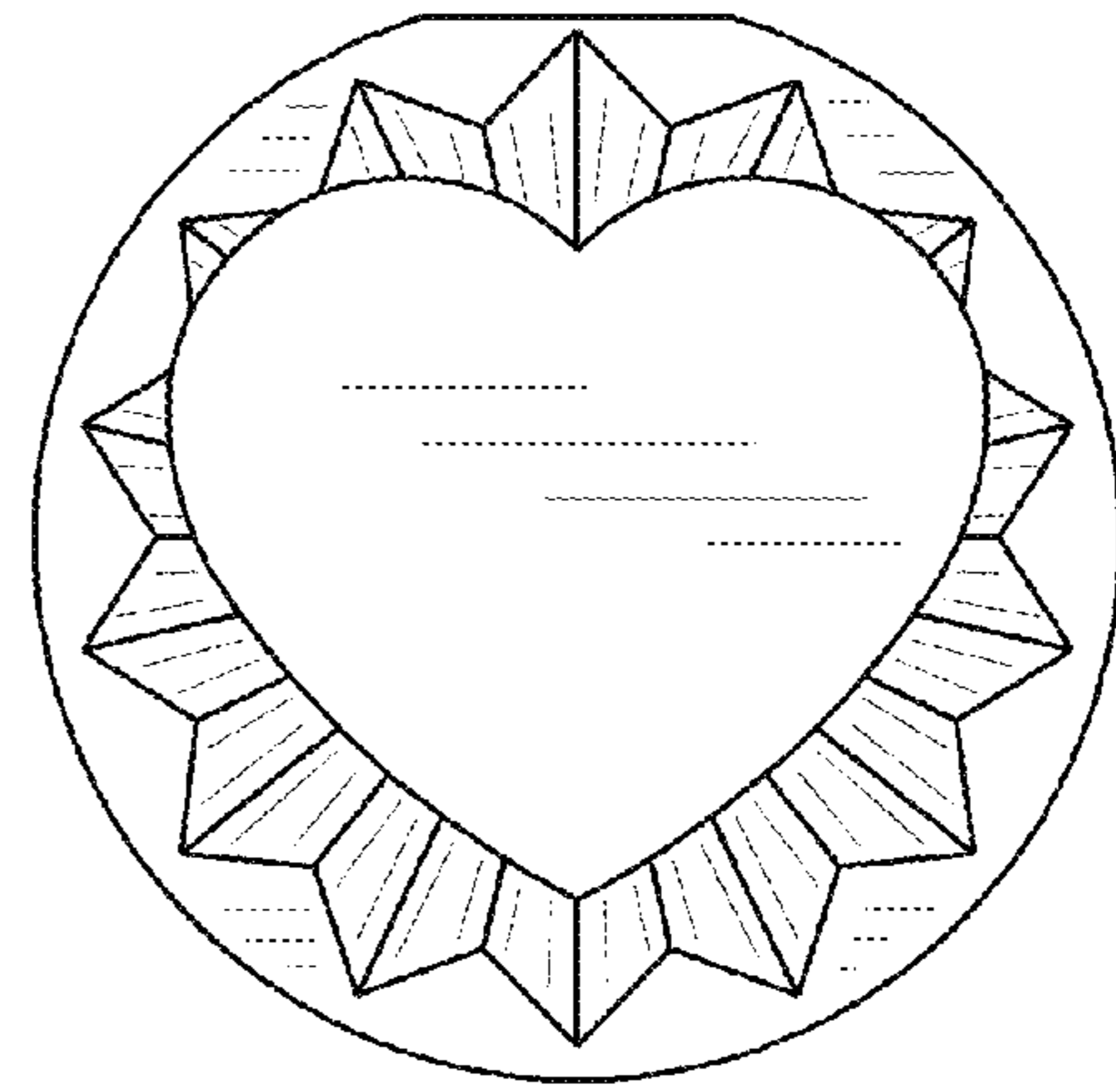

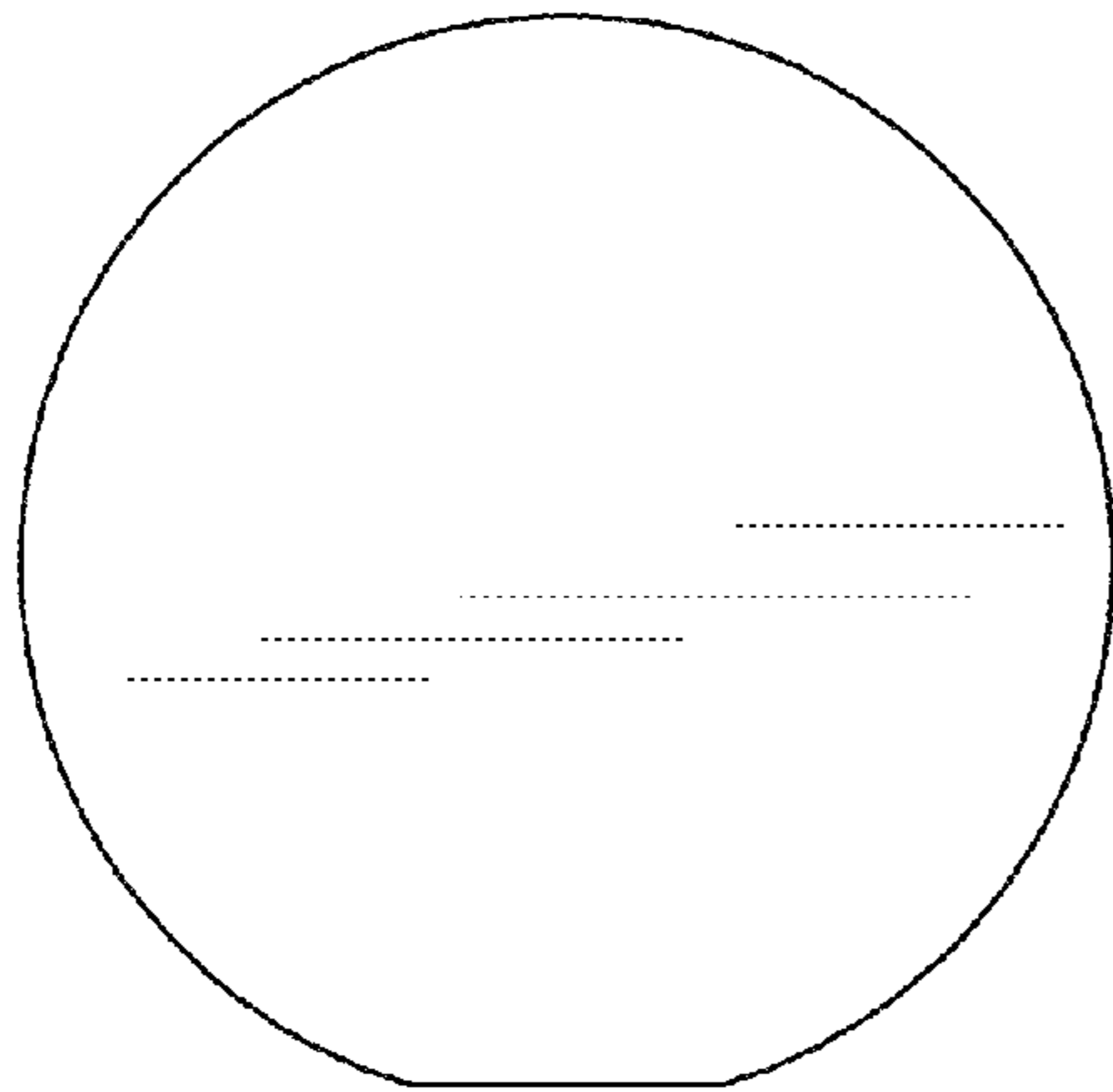

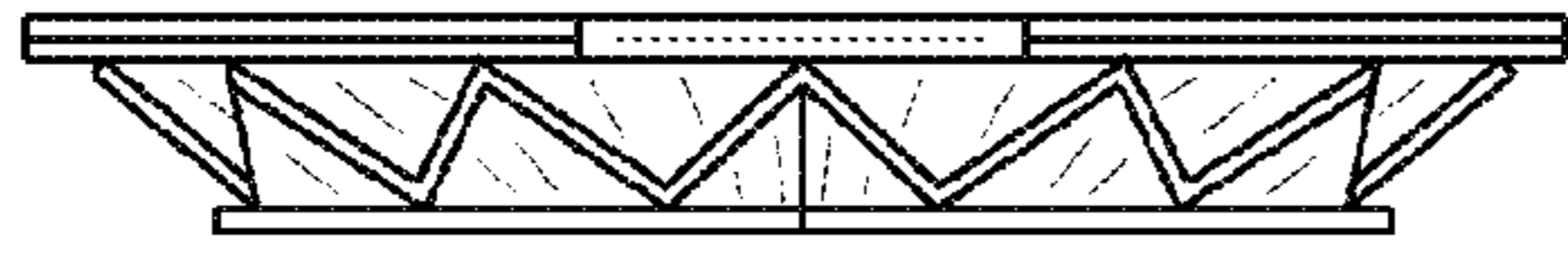

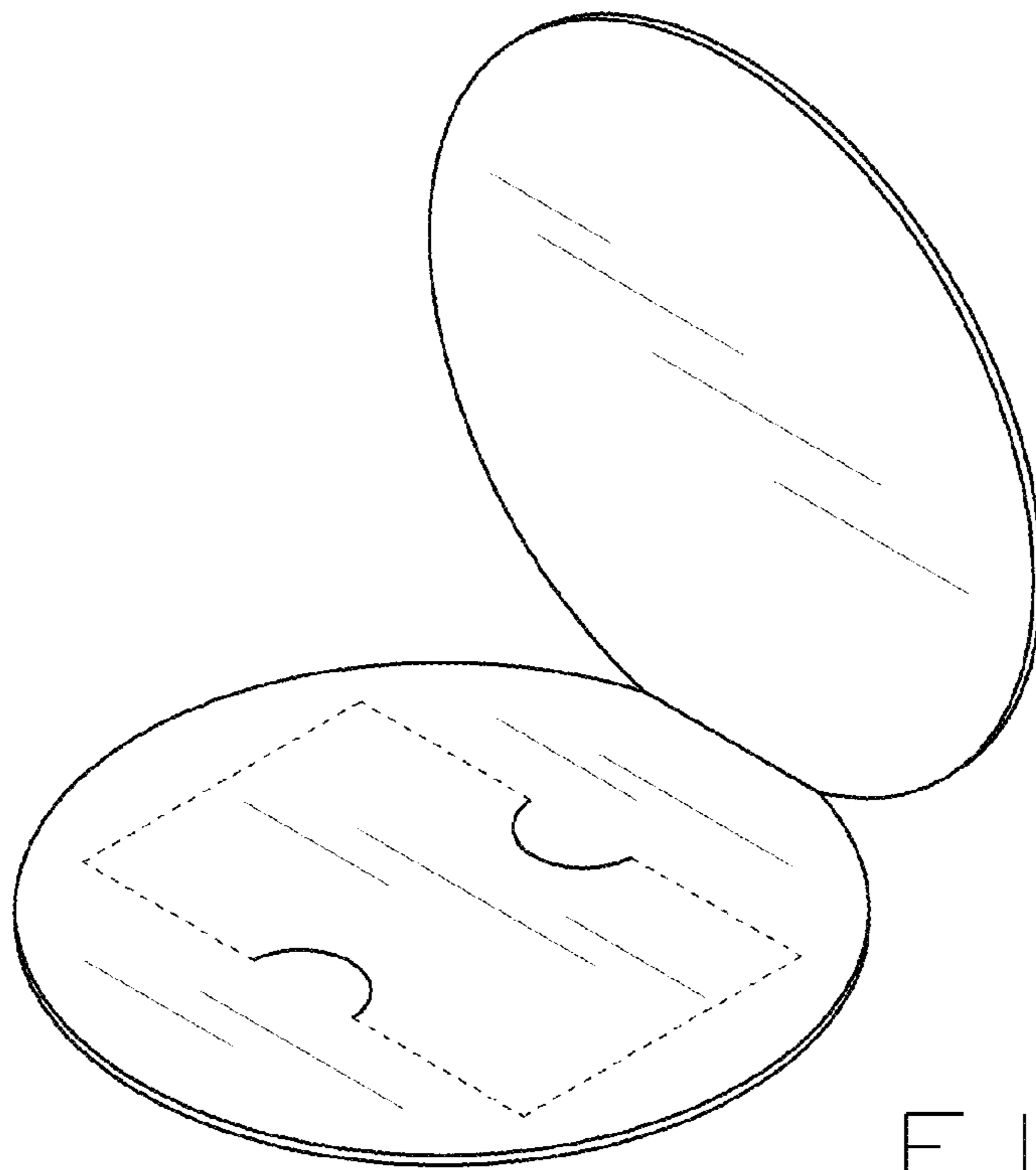
