(57) **CLAIM**

The ornamental design for a transparent bag having a resealable zipper and a flap having an opaque privacy shield insertable through a slit, as shown and described.

DESCRIPTION

FIG. 1 illustrates an isometric view of a transparent bag having a resealable zipper and a flap having an opaque privacy shield insertable through a slit, according to one embodiment of the present disclosure;

FIG. 2 is a front view of the transparent bag having a resealable zipper and a flap having an opaque privacy shield insertable through a slit, according to one embodiment of the present disclosure;

FIG. 3 is a rear view of the transparent bag having a resealable zipper and a flap having an opaque privacy shield insertable through a slit, according to one embodiment of the present disclosure;

FIG. 4 is a right side view of the transparent bag having a resealable zipper and a flap having an opaque privacy shield insertable through a slit, according to one embodiment of the present disclosure;

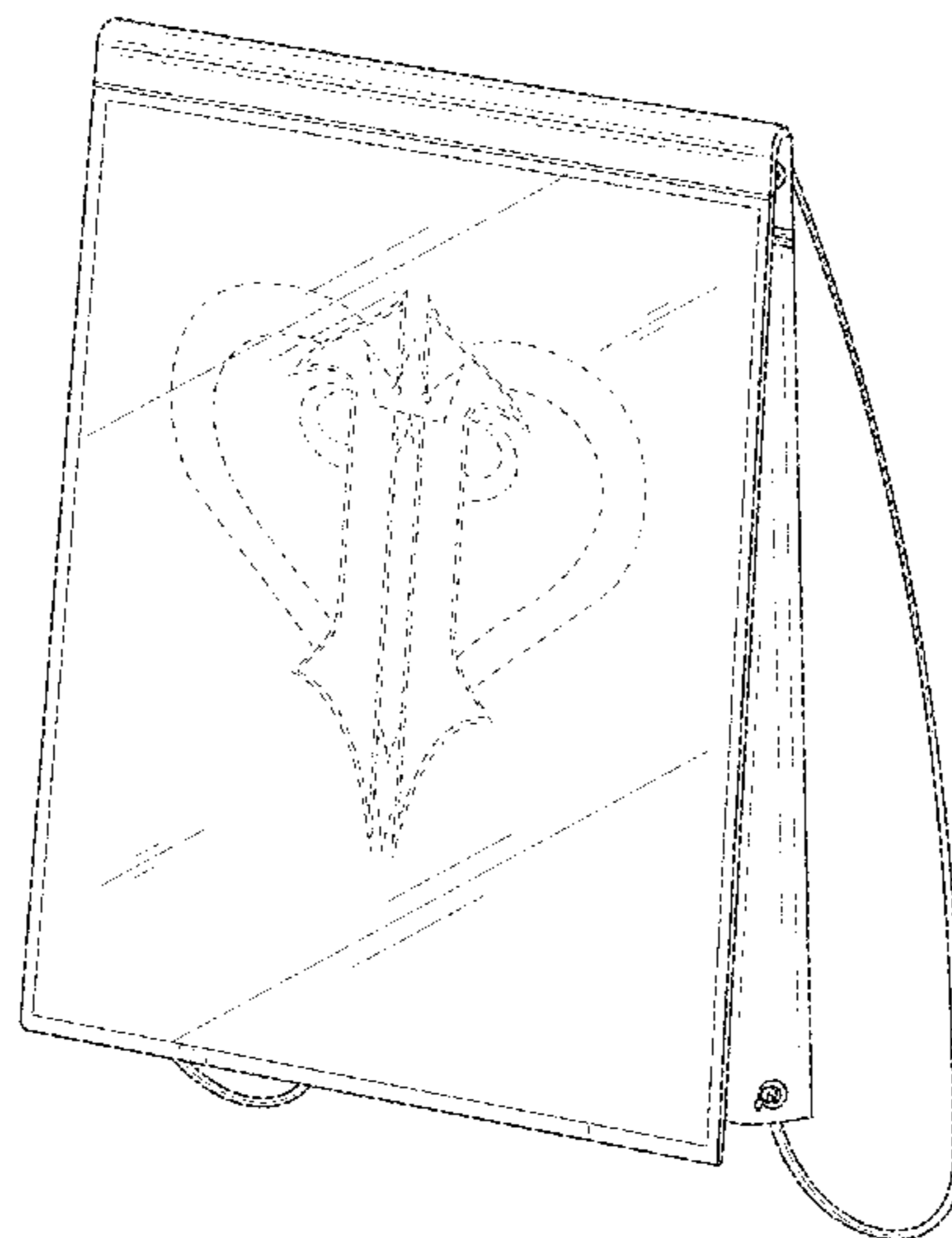

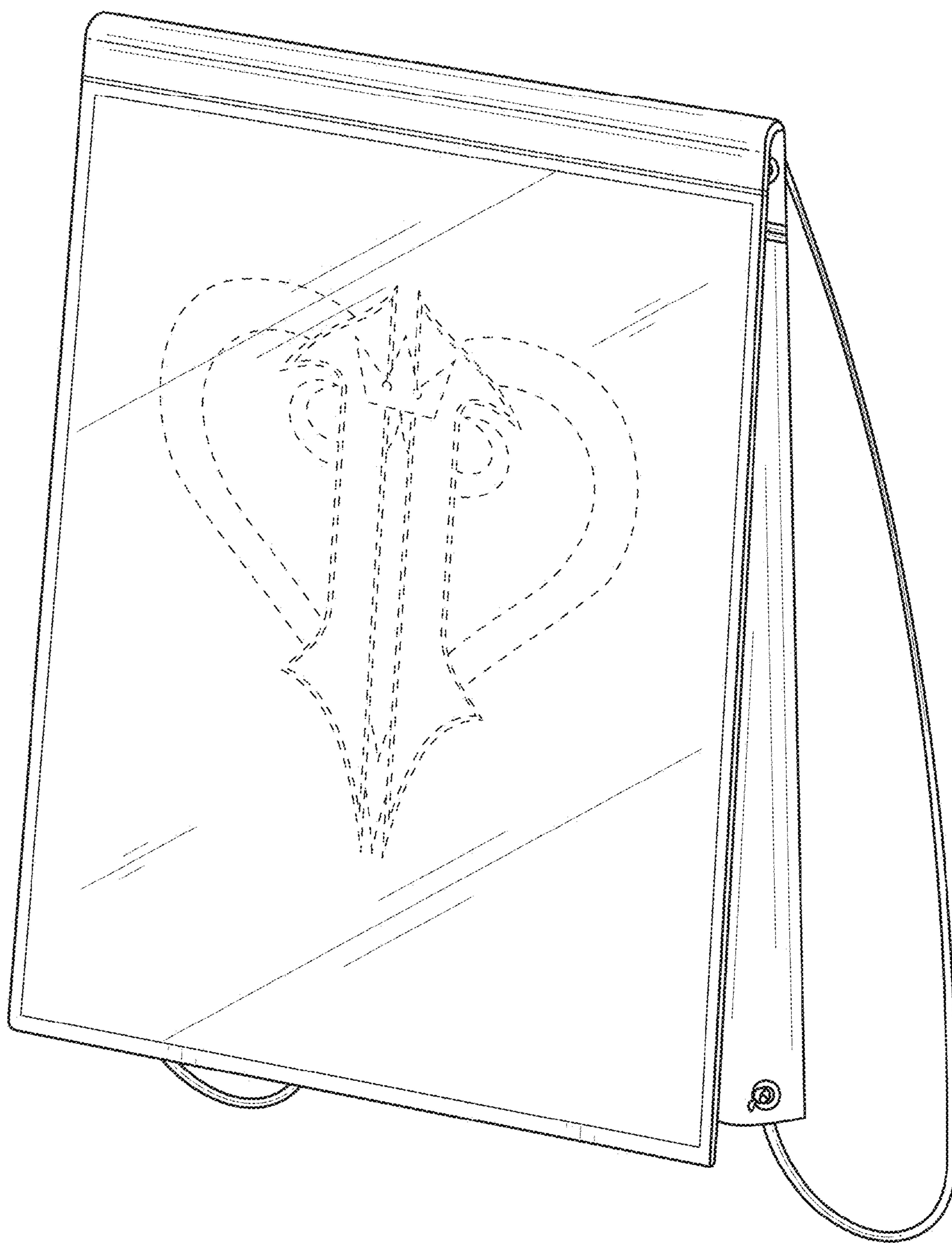

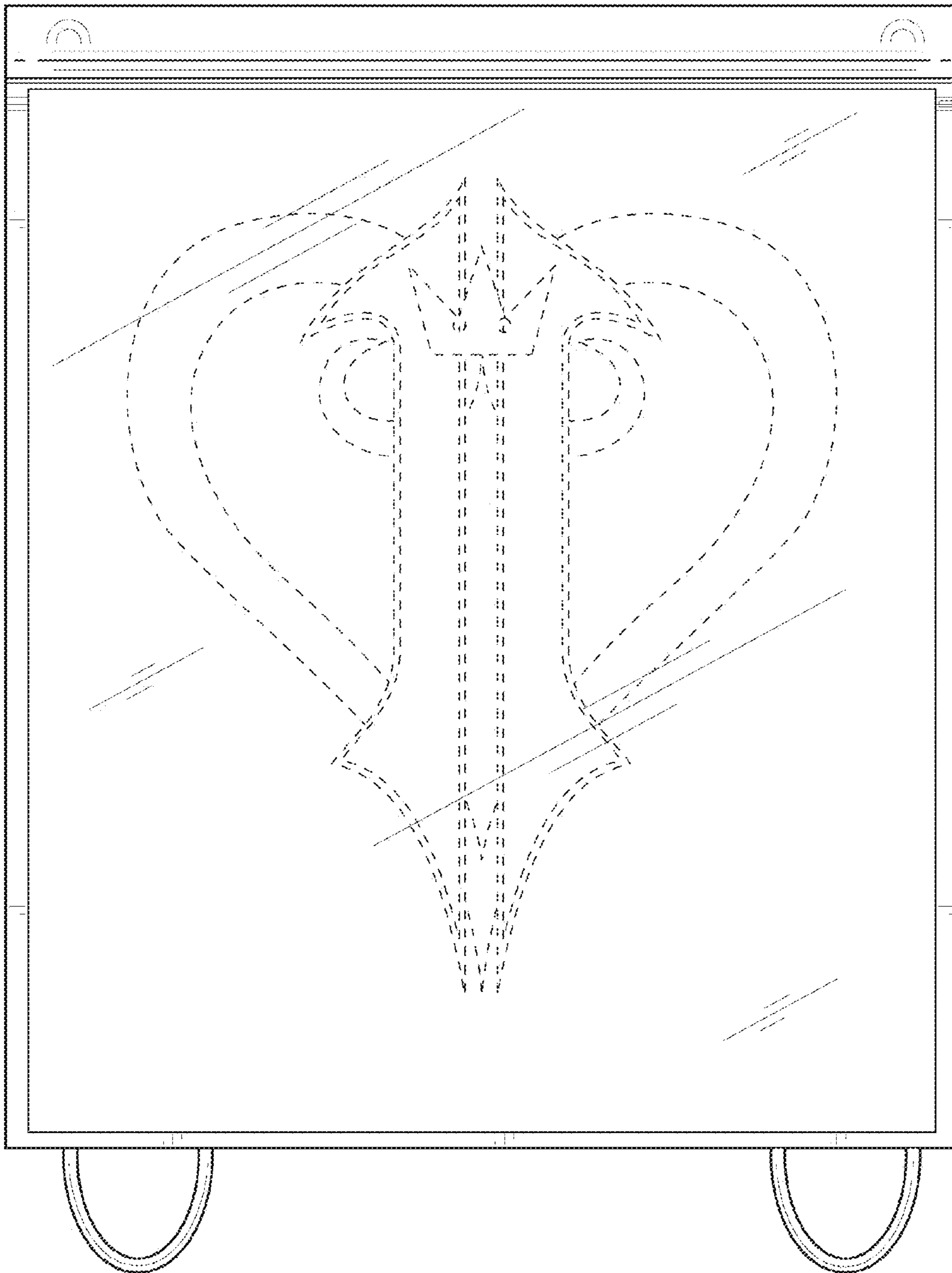

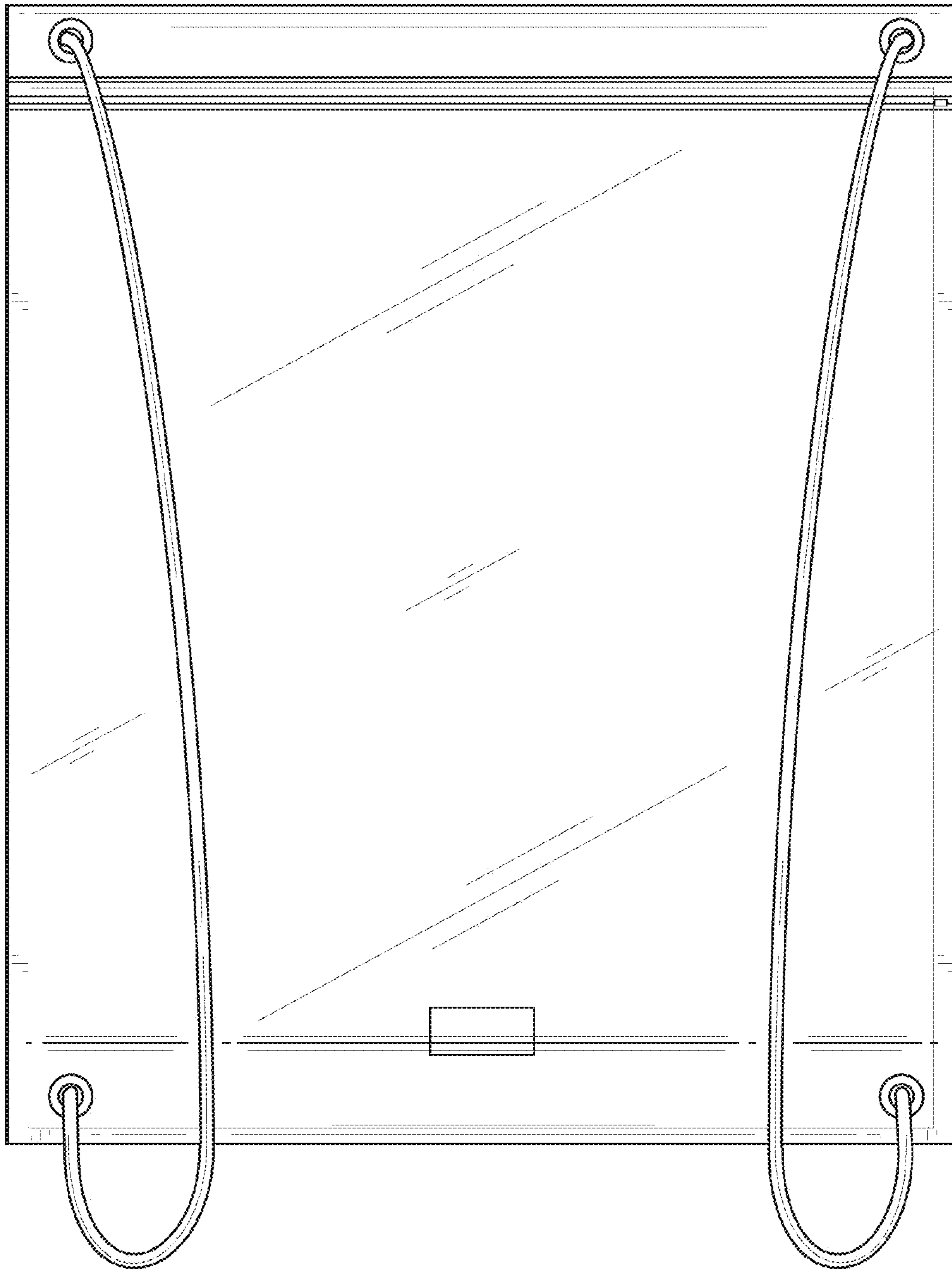

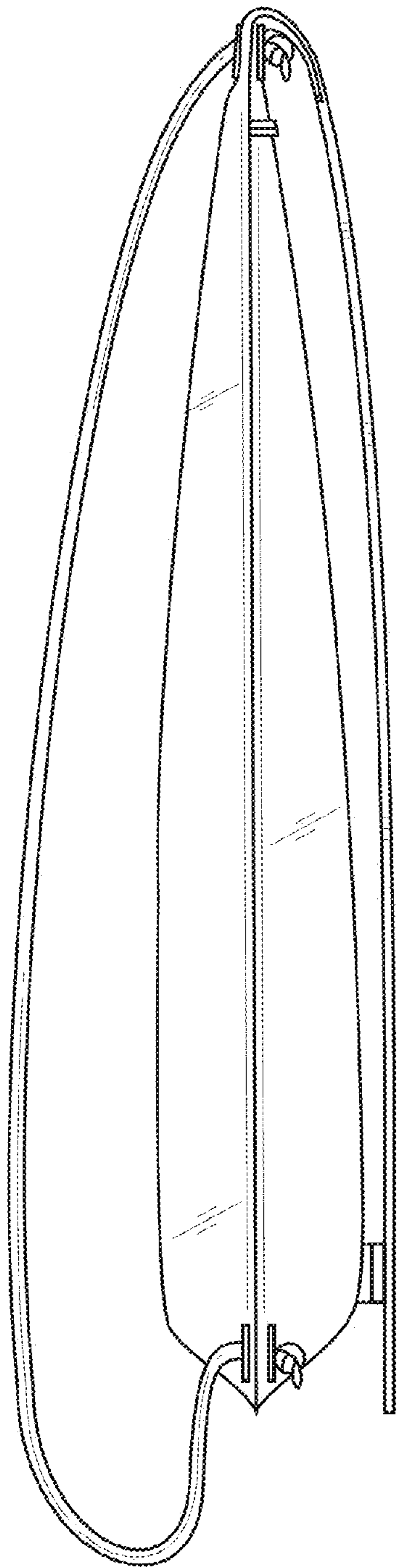

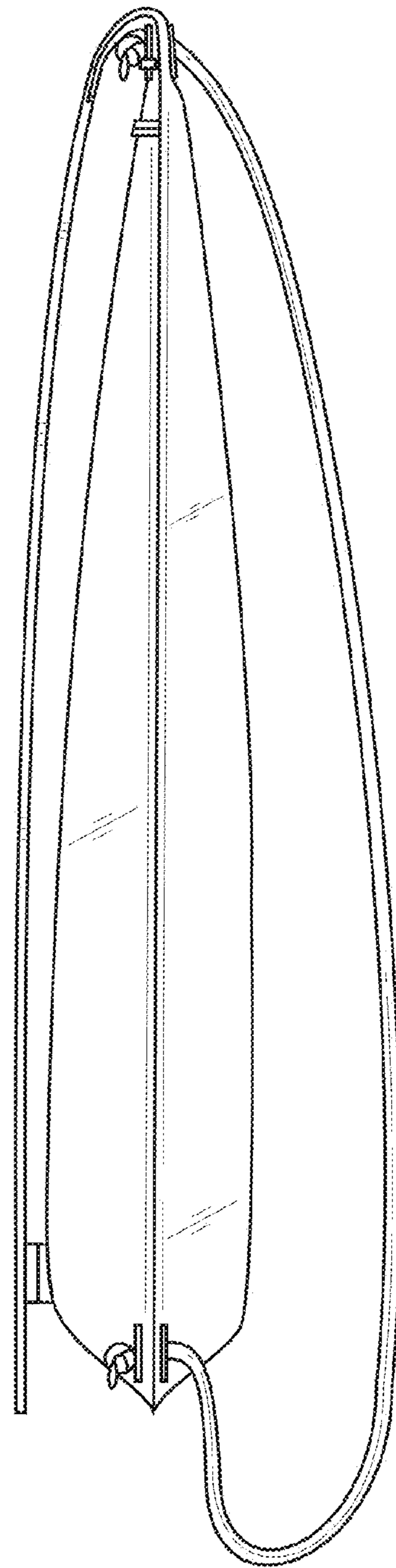

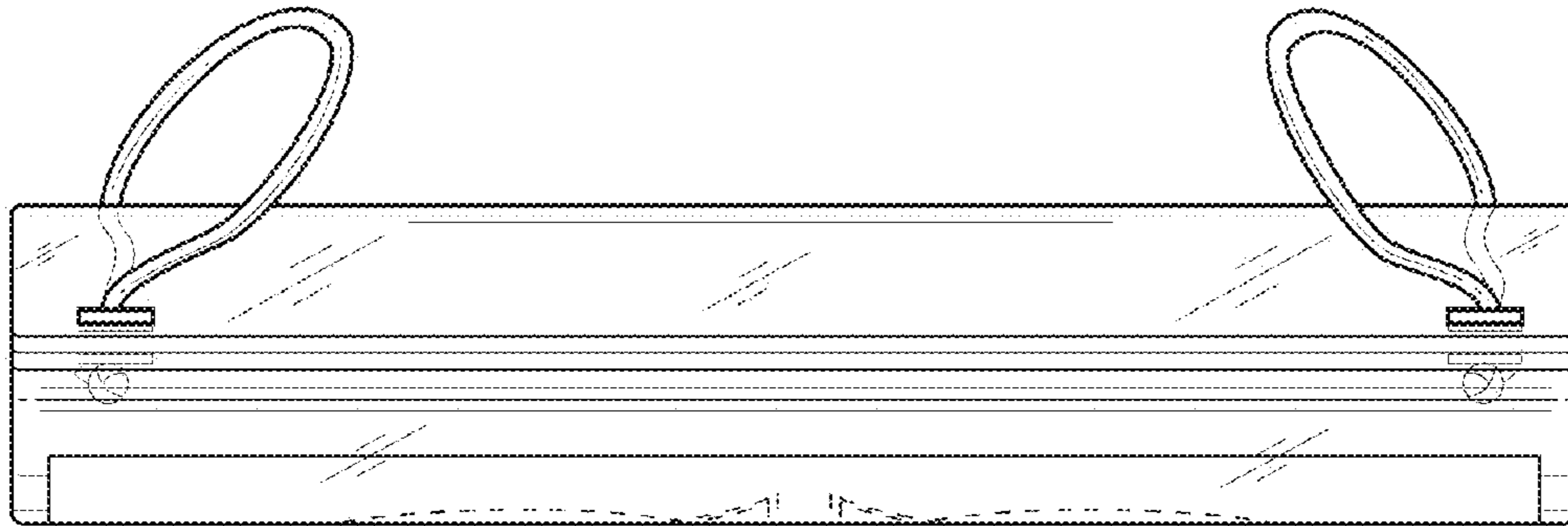

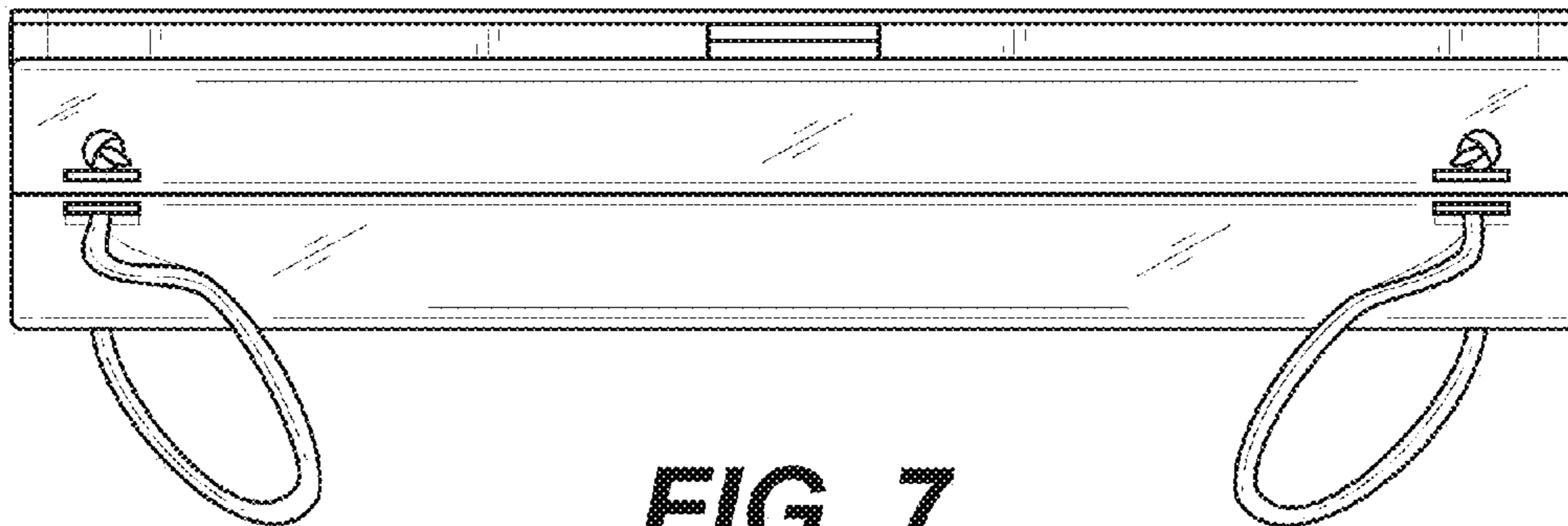
