DESCRIPTION

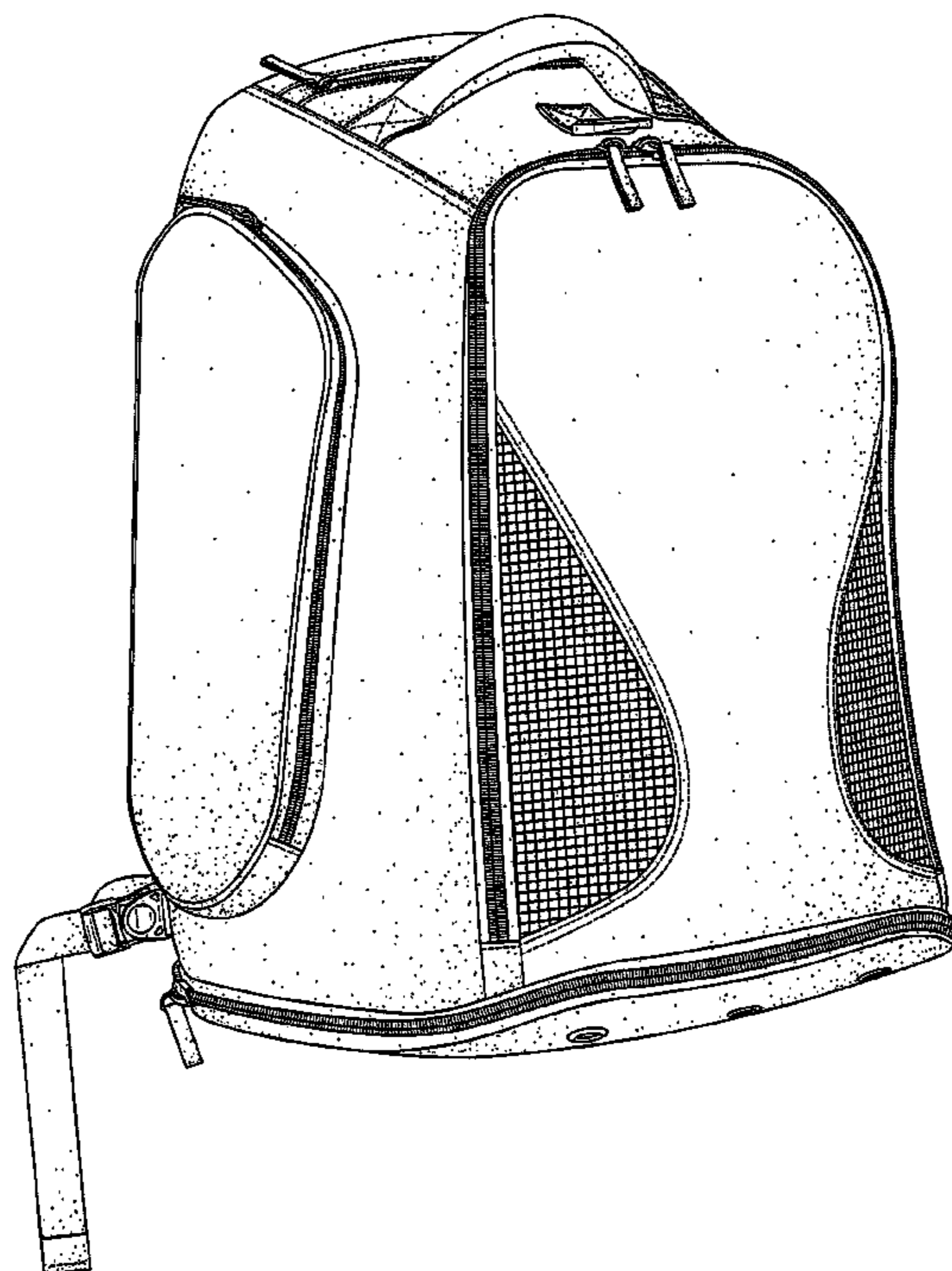
FIG. 1 is a front perspective view of the bag of the present invention showing my new design;

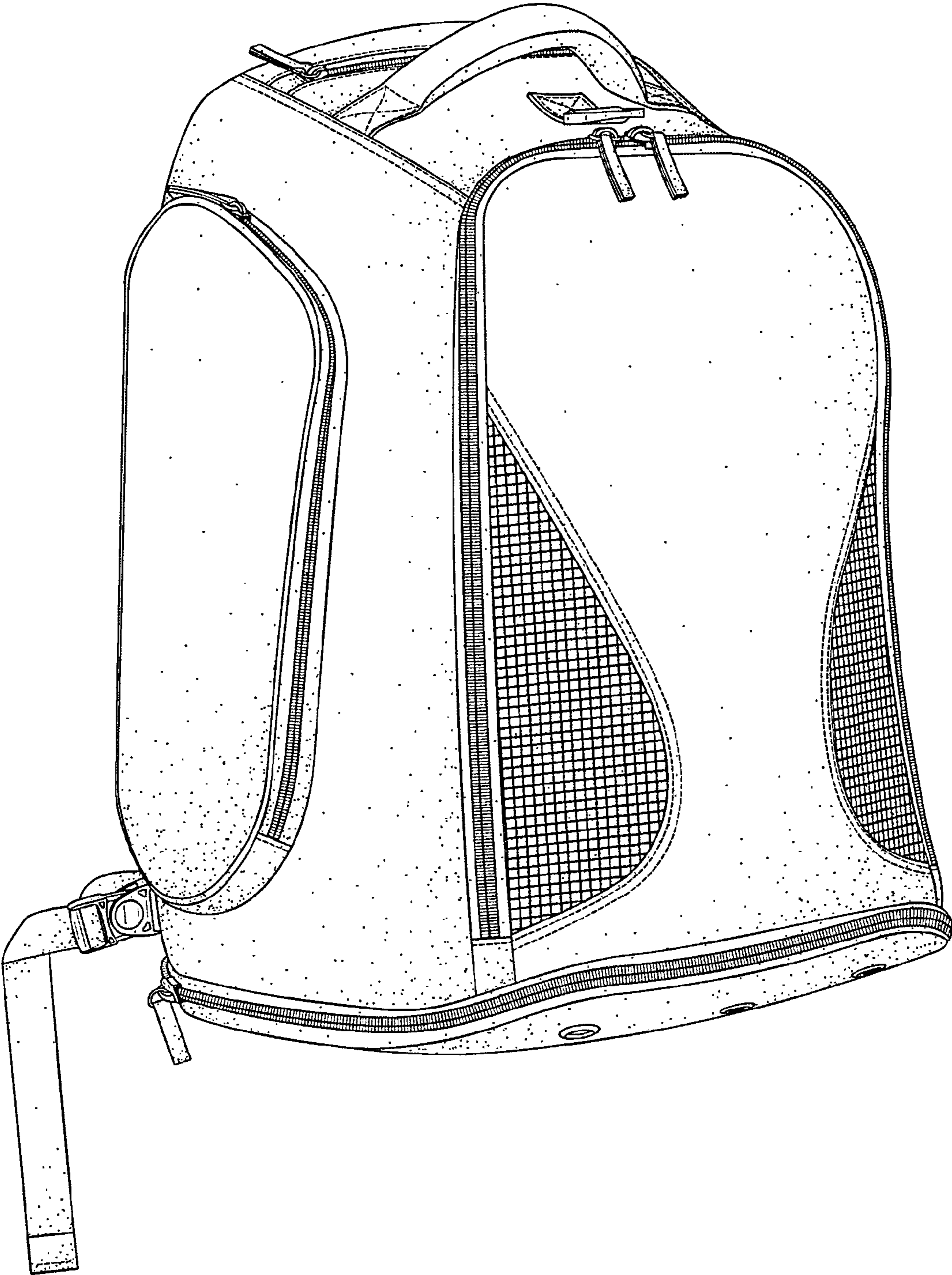

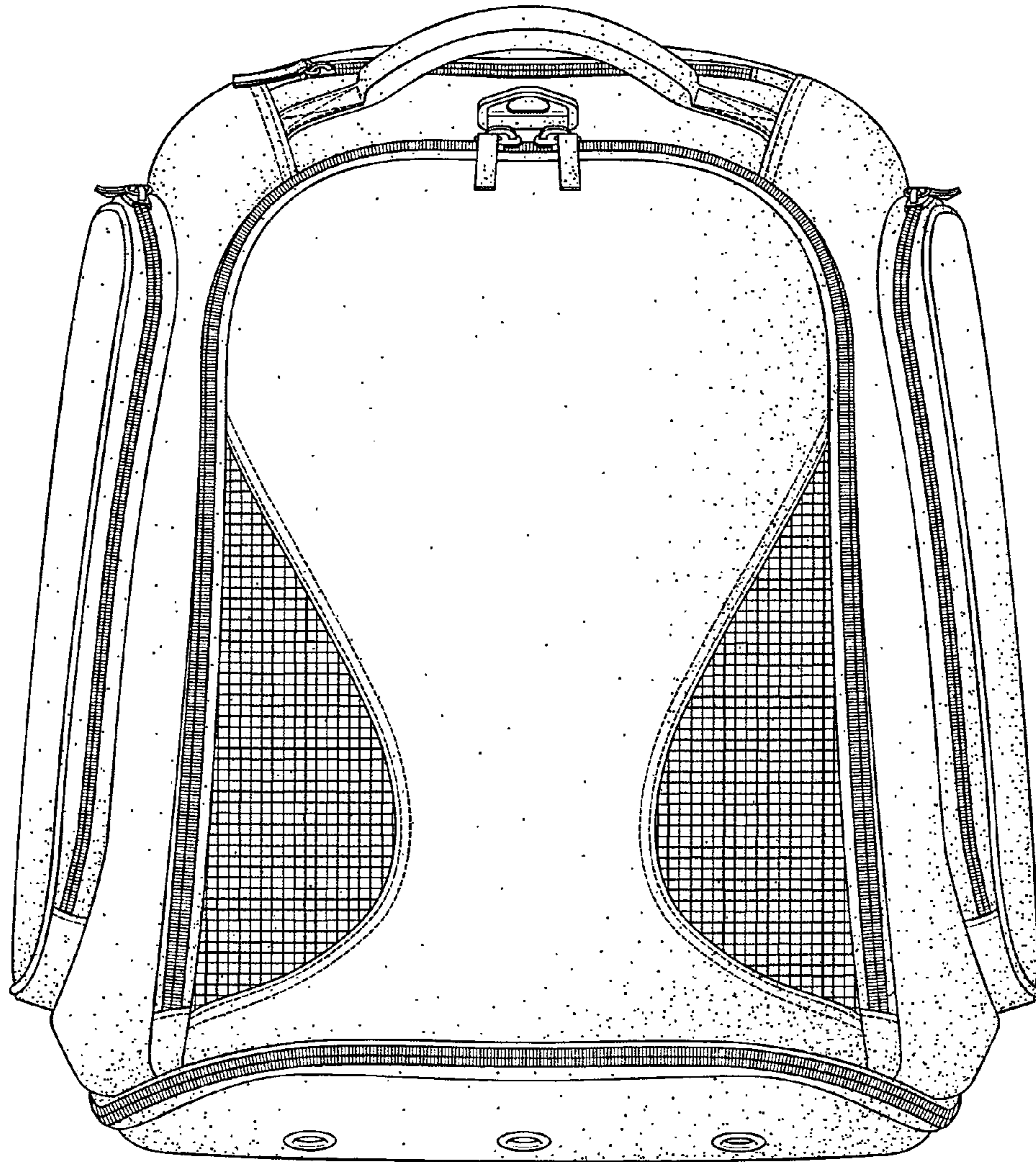

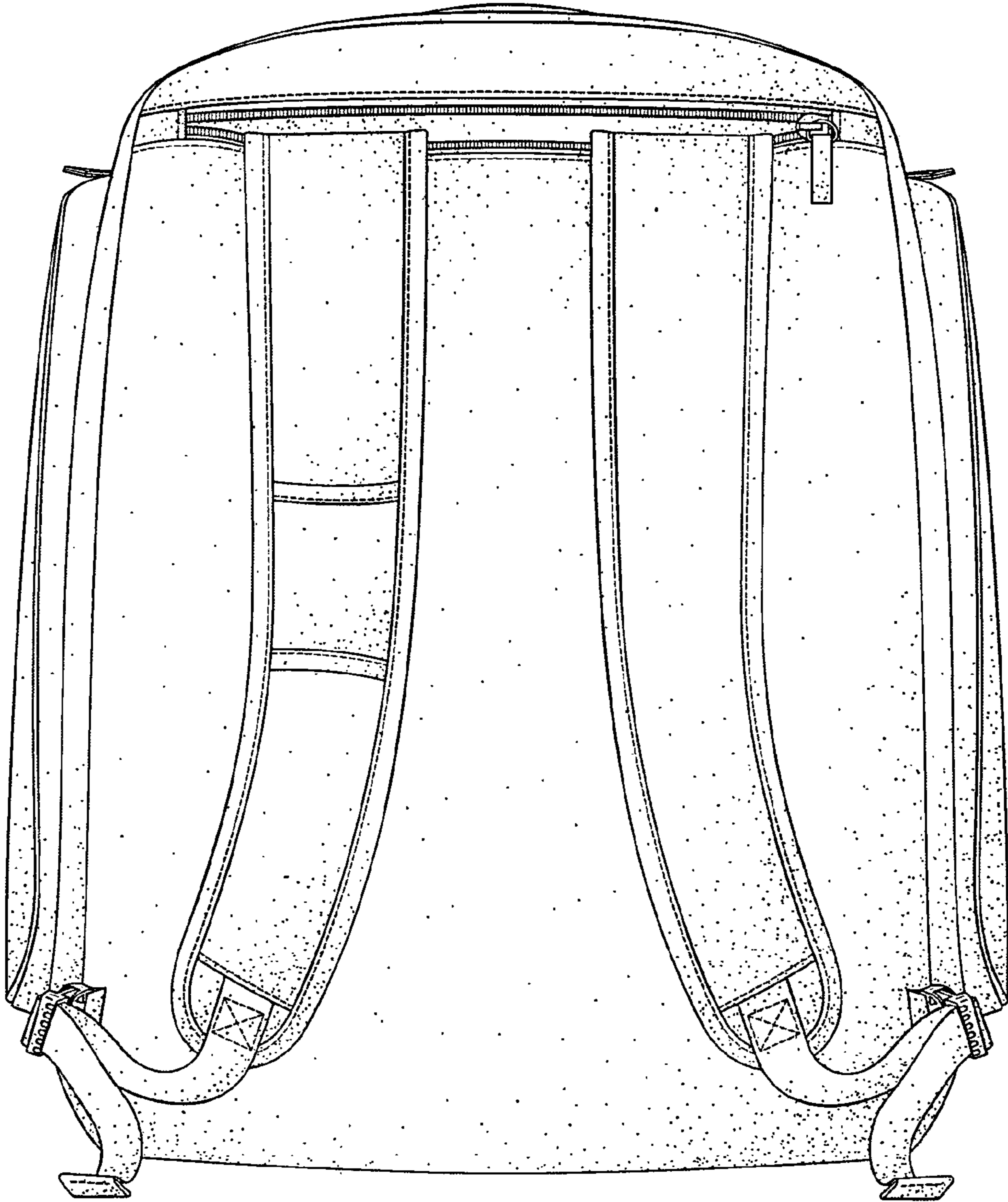

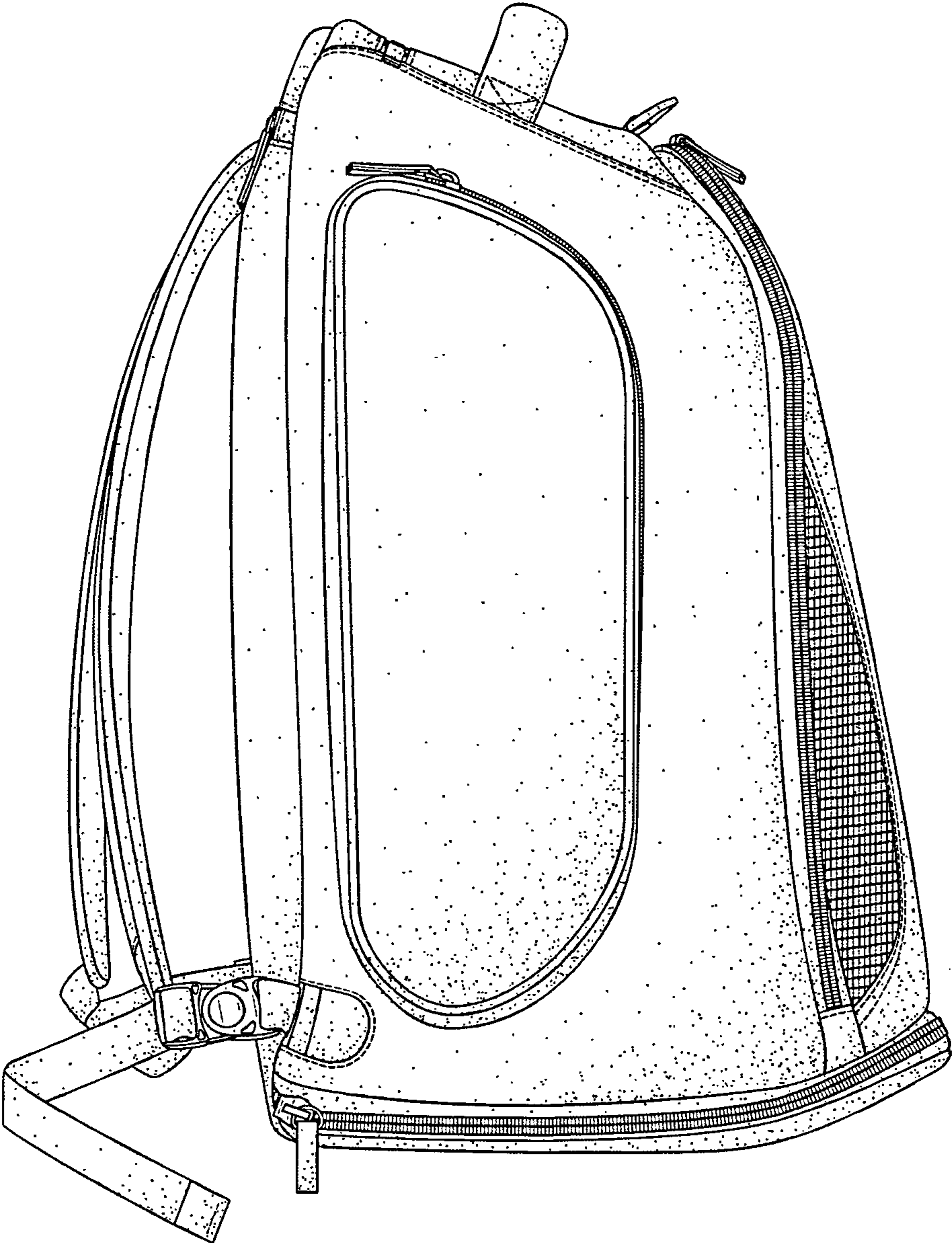

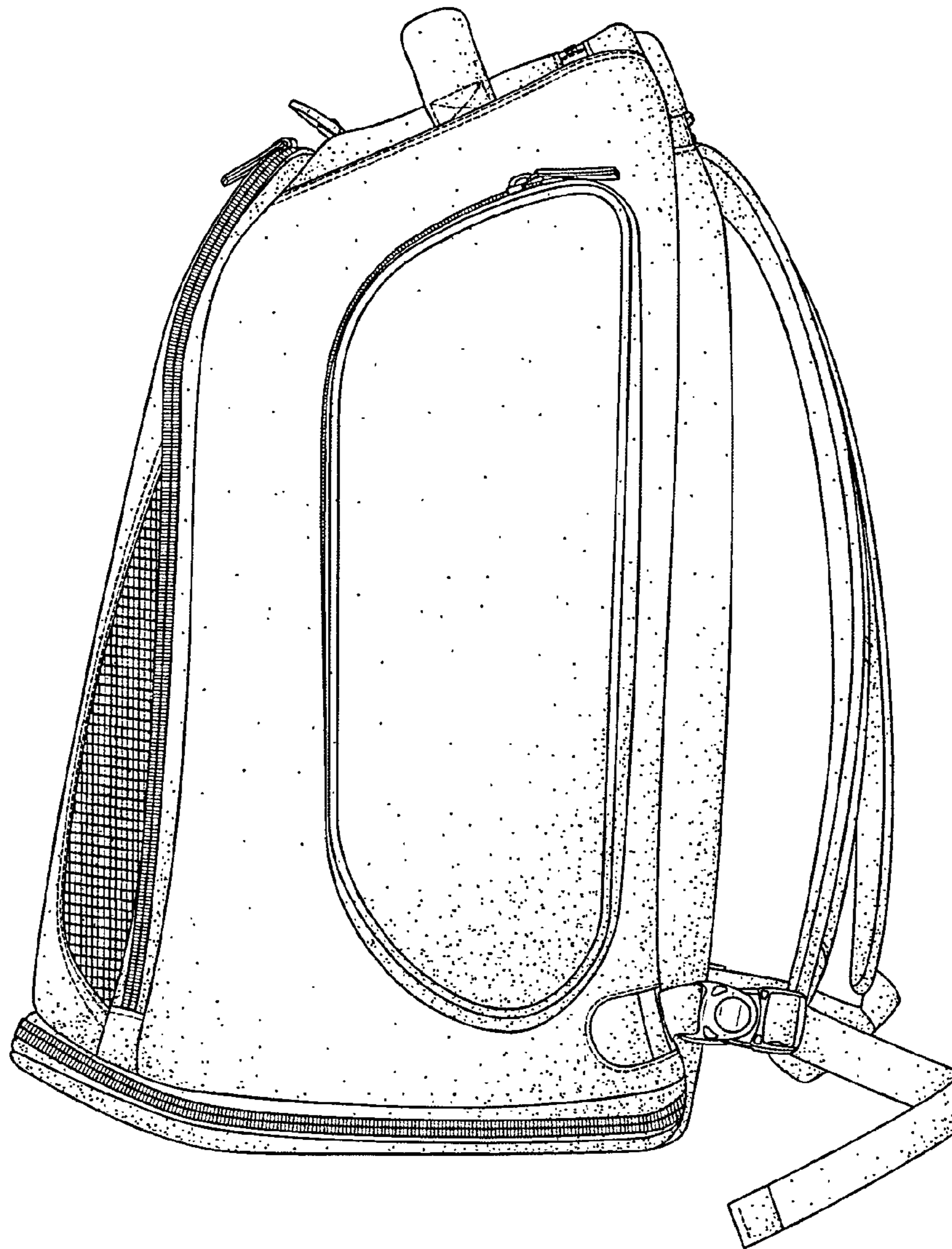

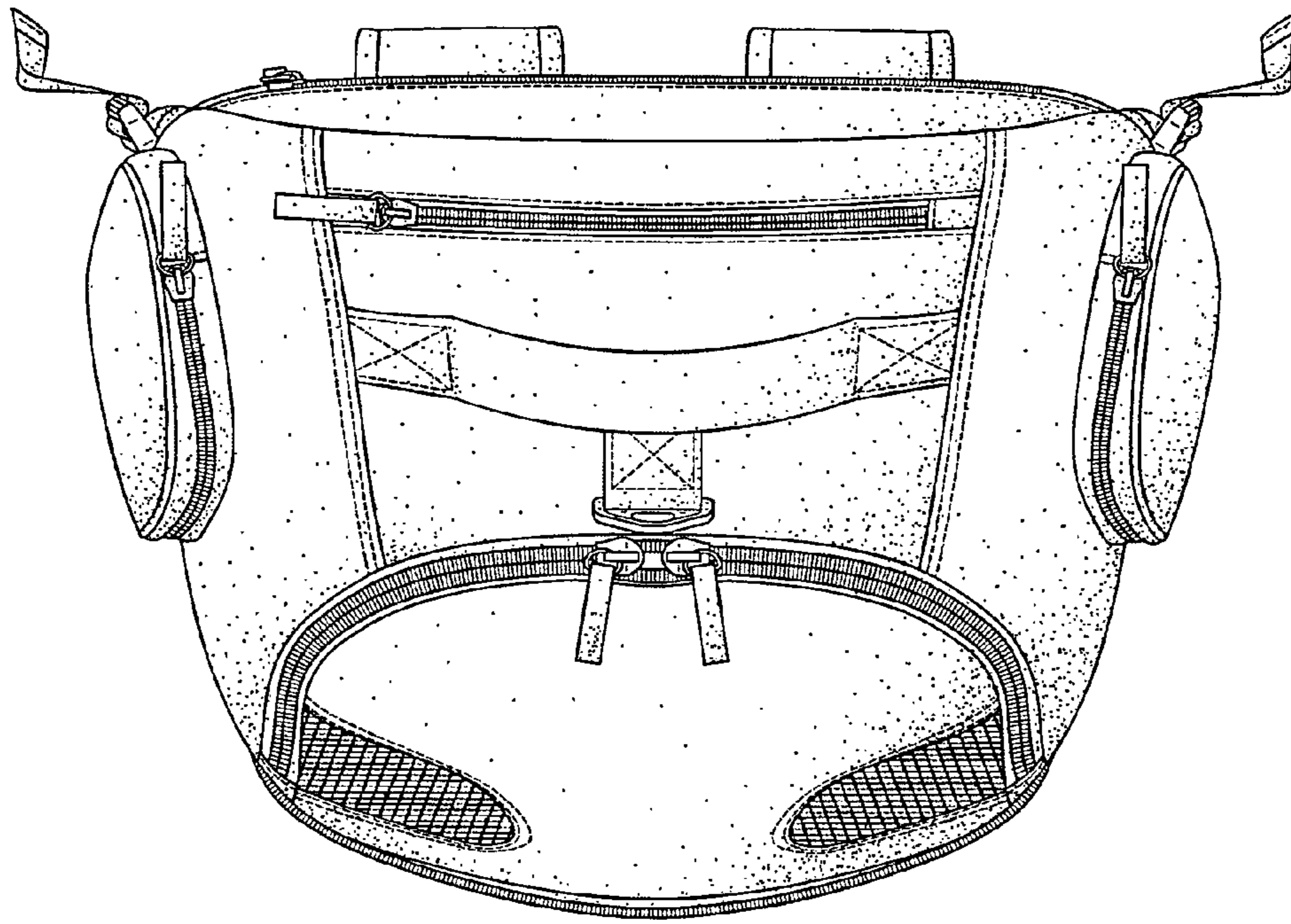

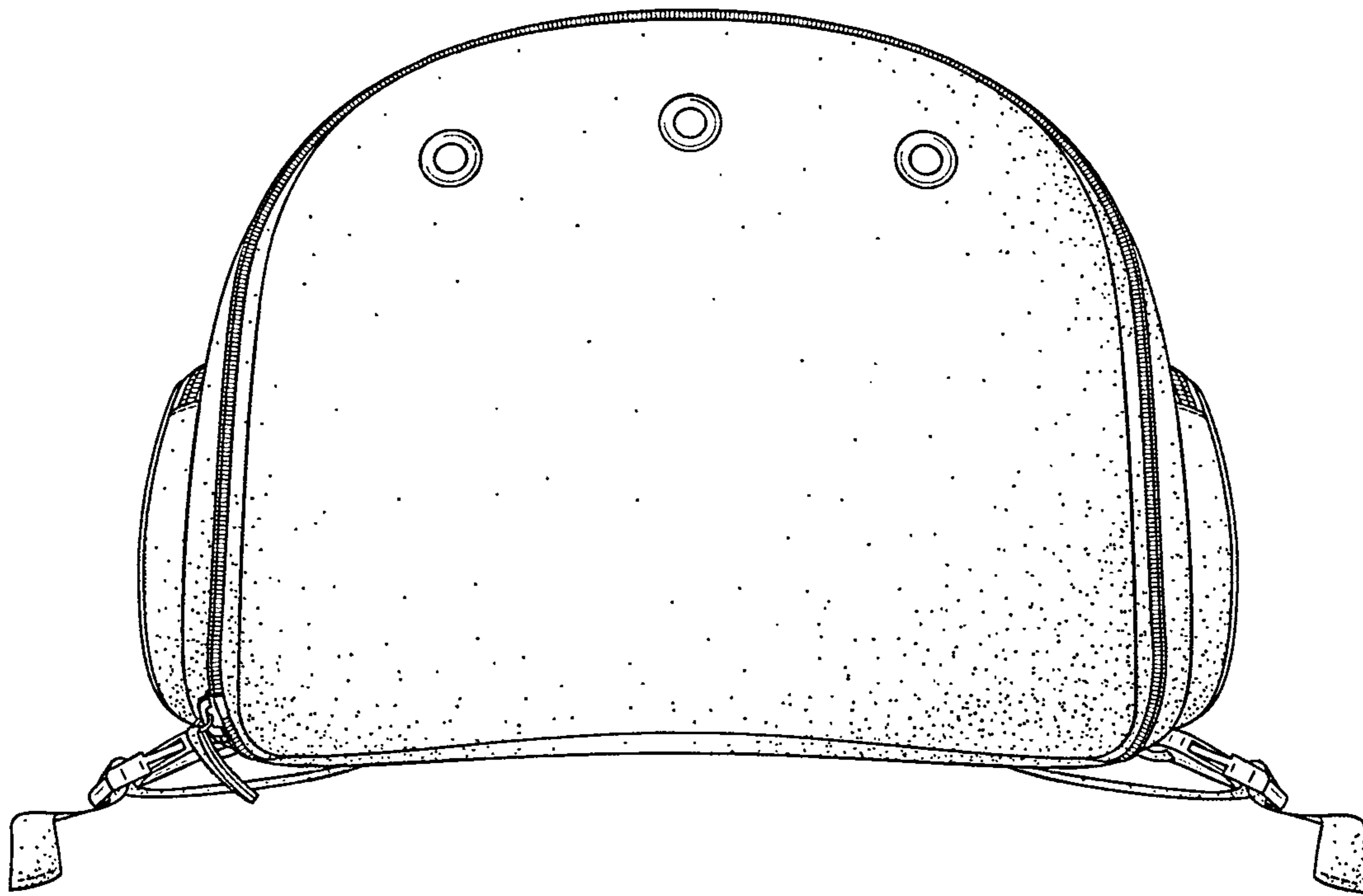

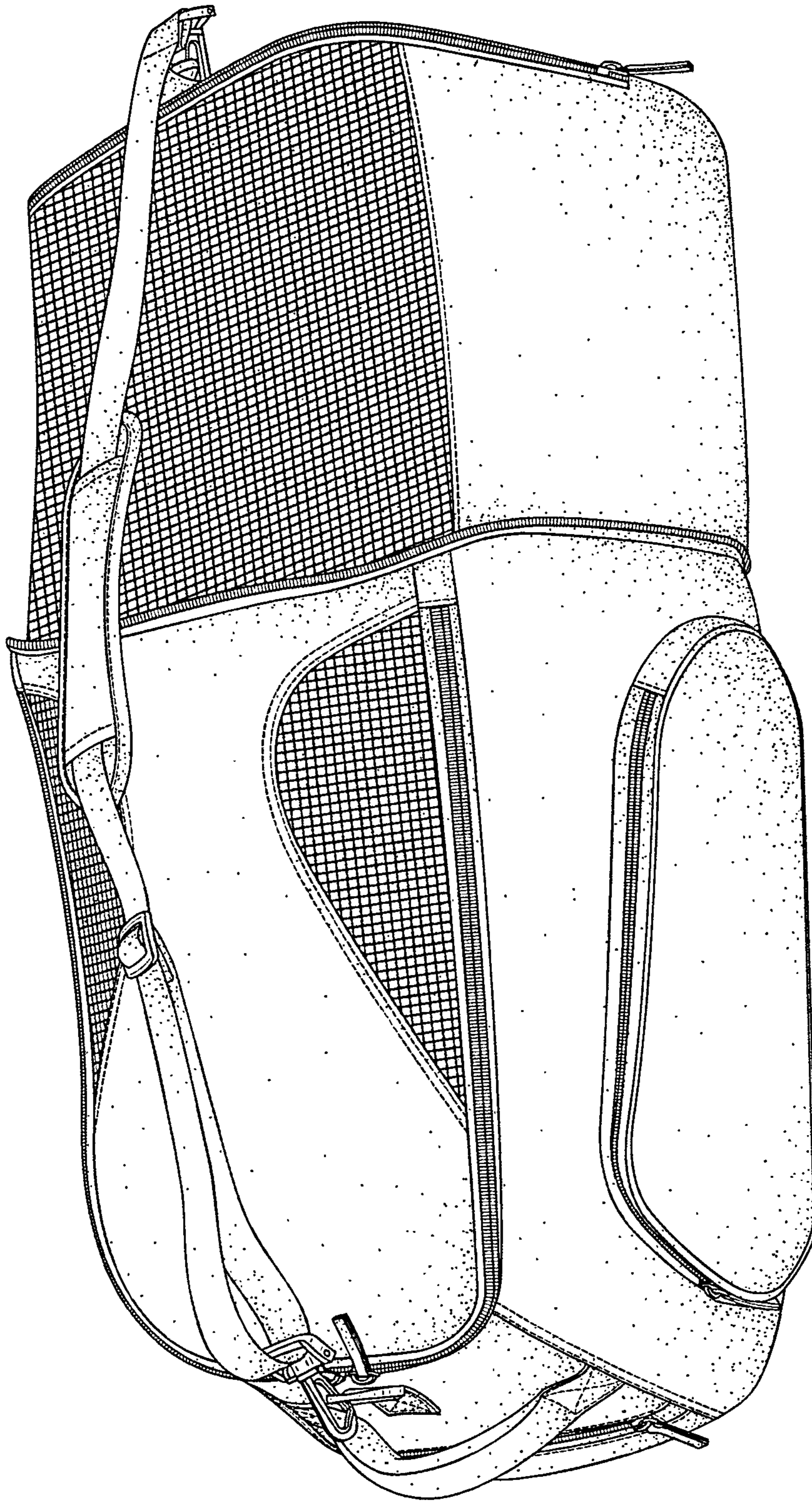

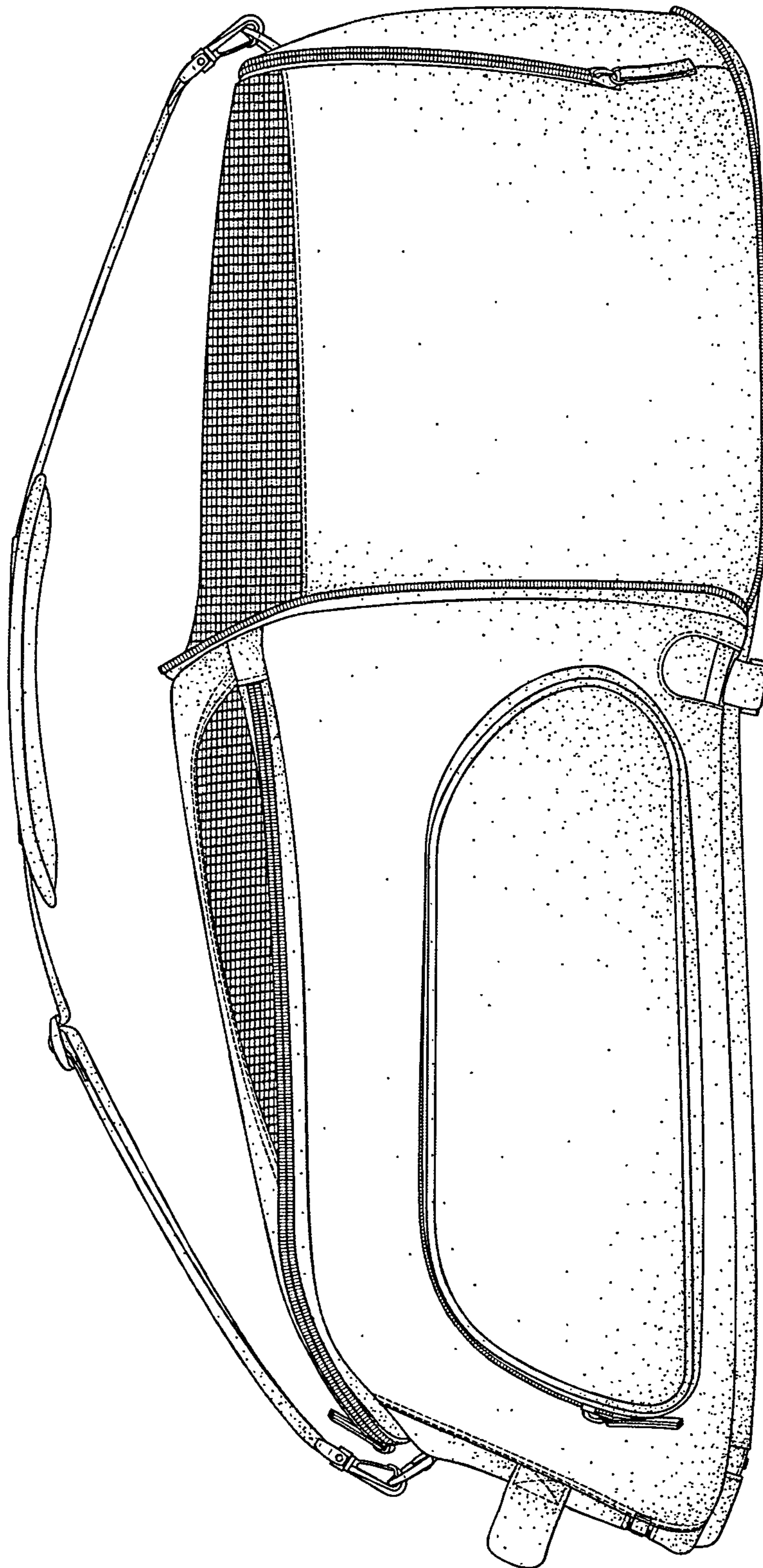

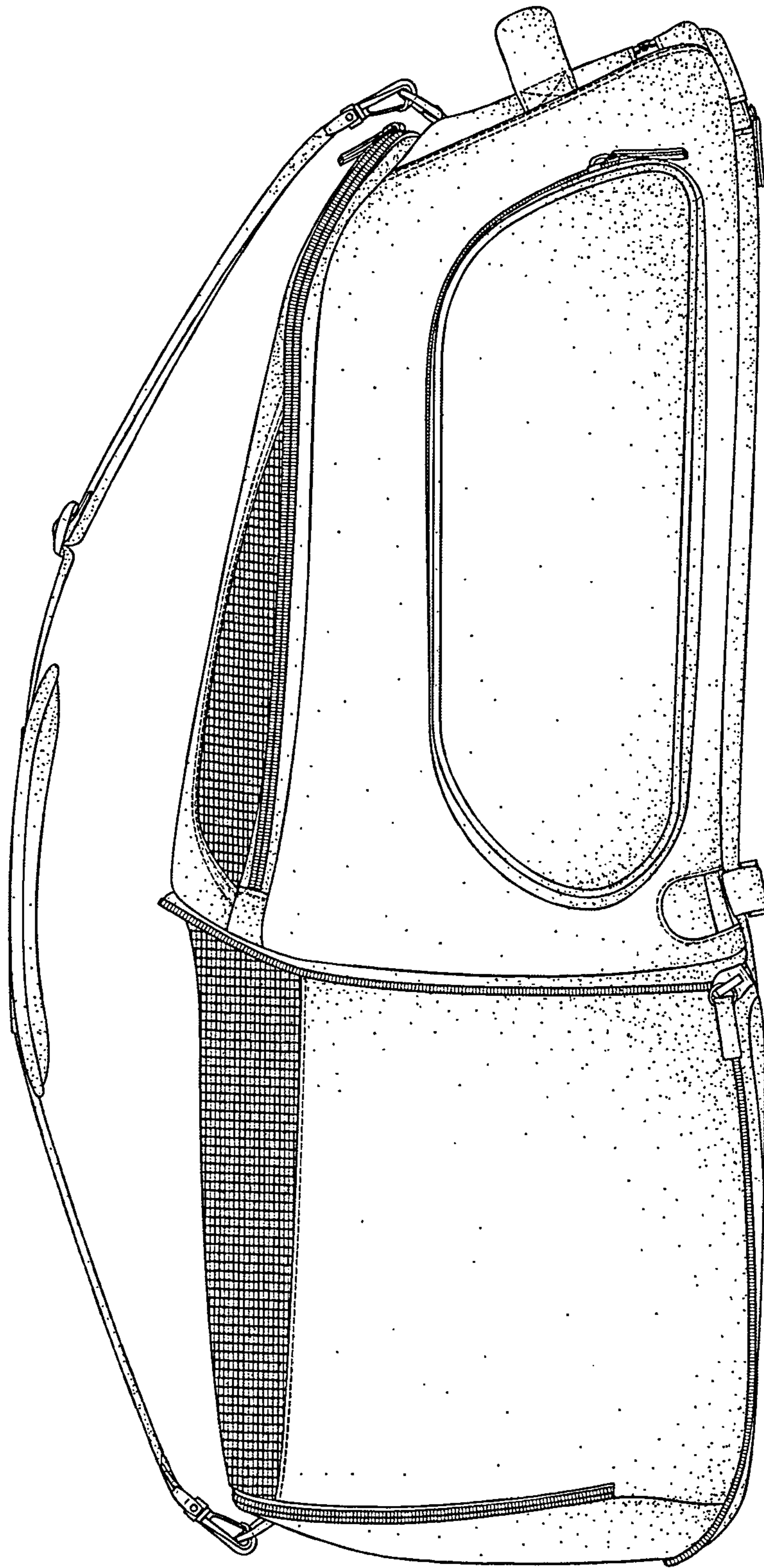

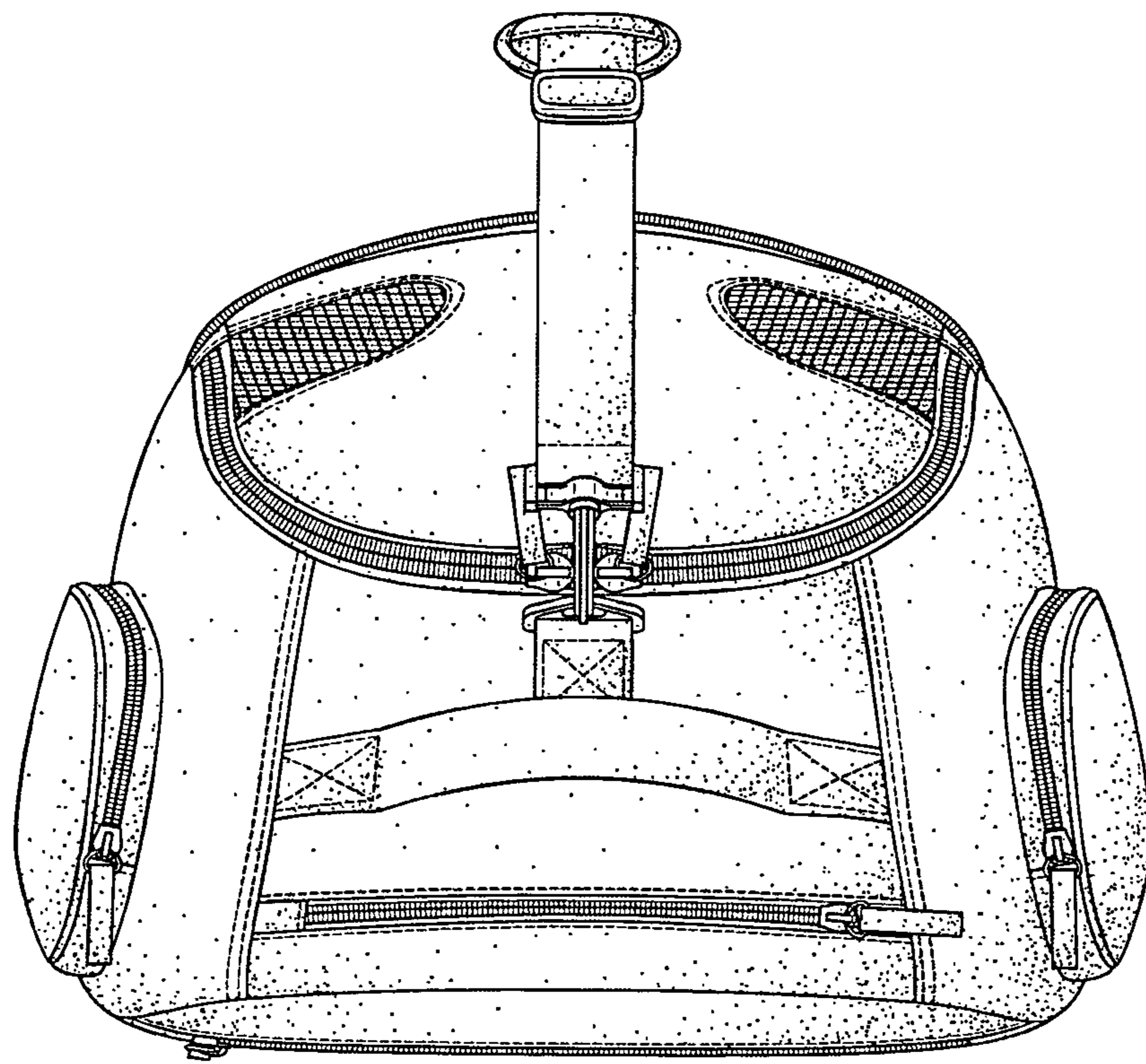

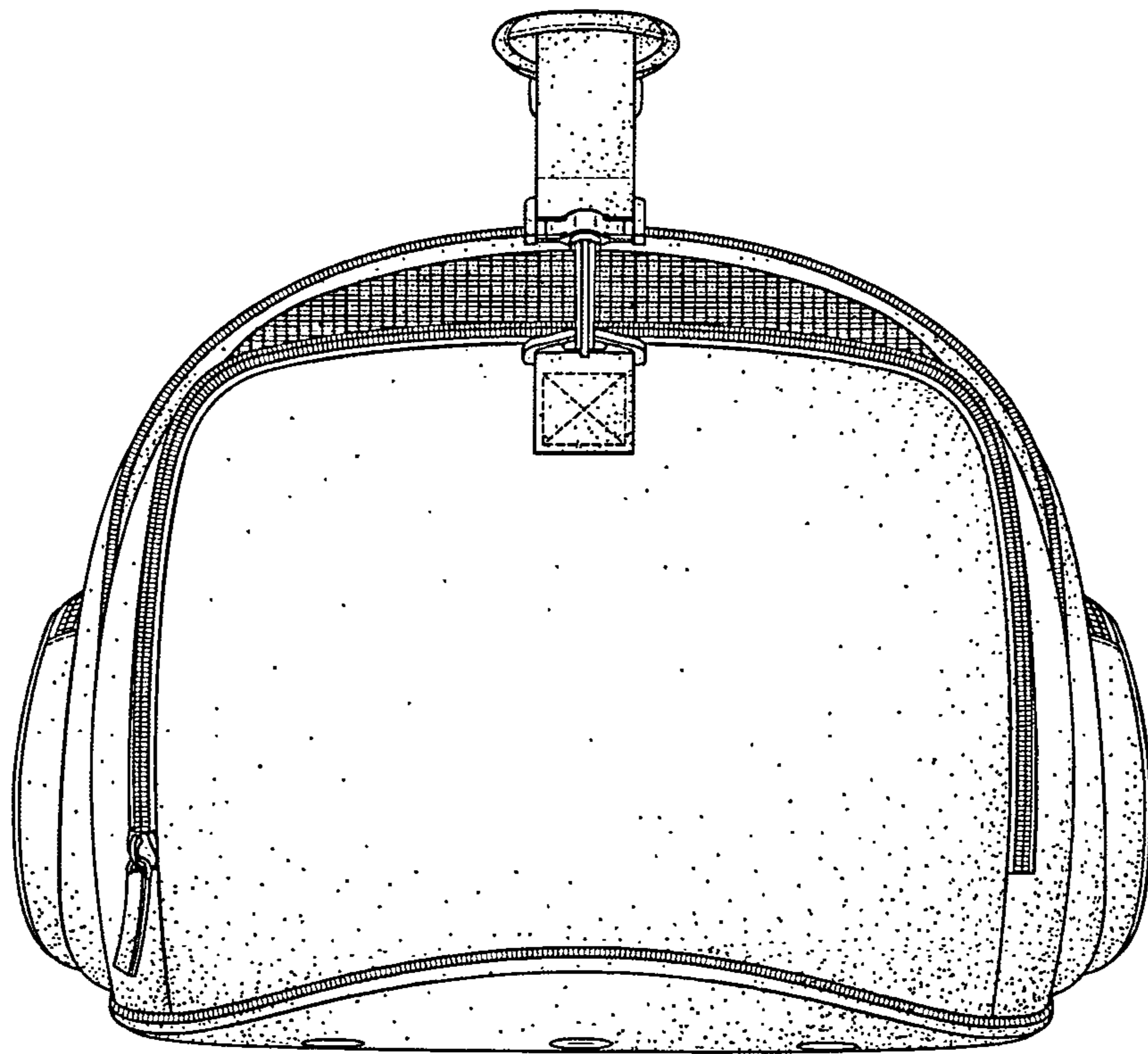

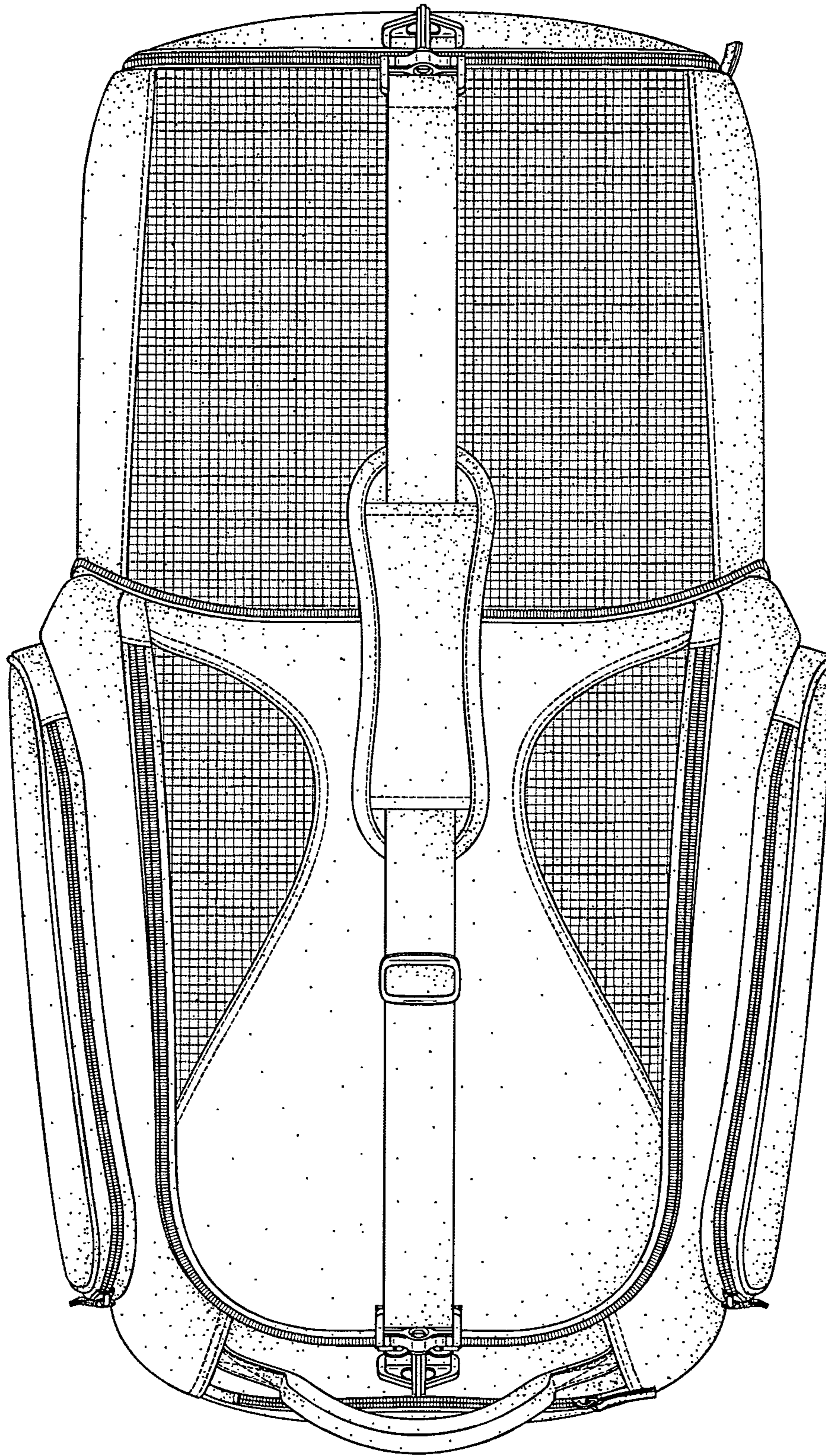

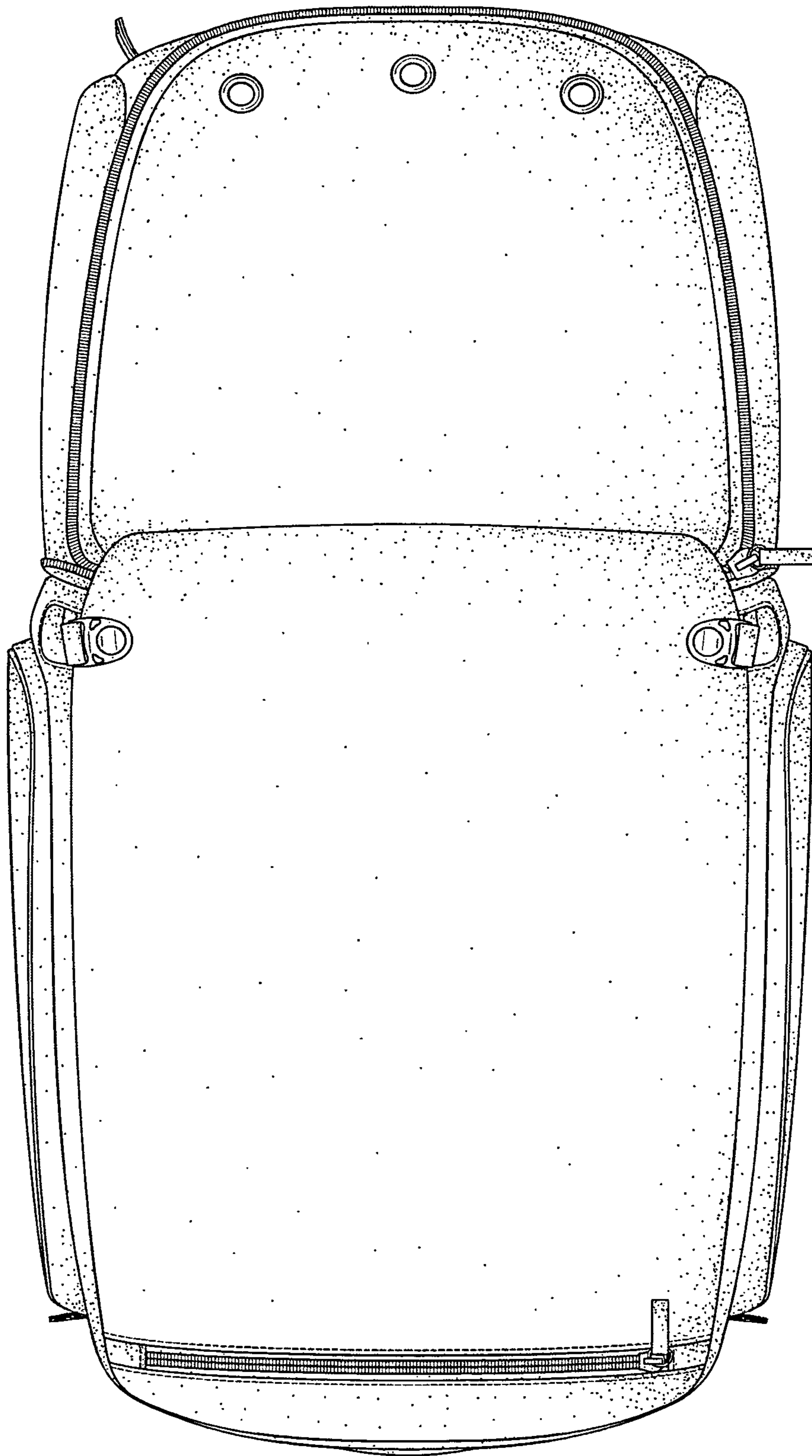
