(57) **CLAIM**

I claim the ornamental design for a hanger accessory, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a hanger accessory according to the present invention; and,

FIG. 2 is a partial enlarged view thereof according to the broken square indicated by "2" in FIG. 1.

The dotted lines shown on the hanger accessory represent stitching and form part of the claimed design.

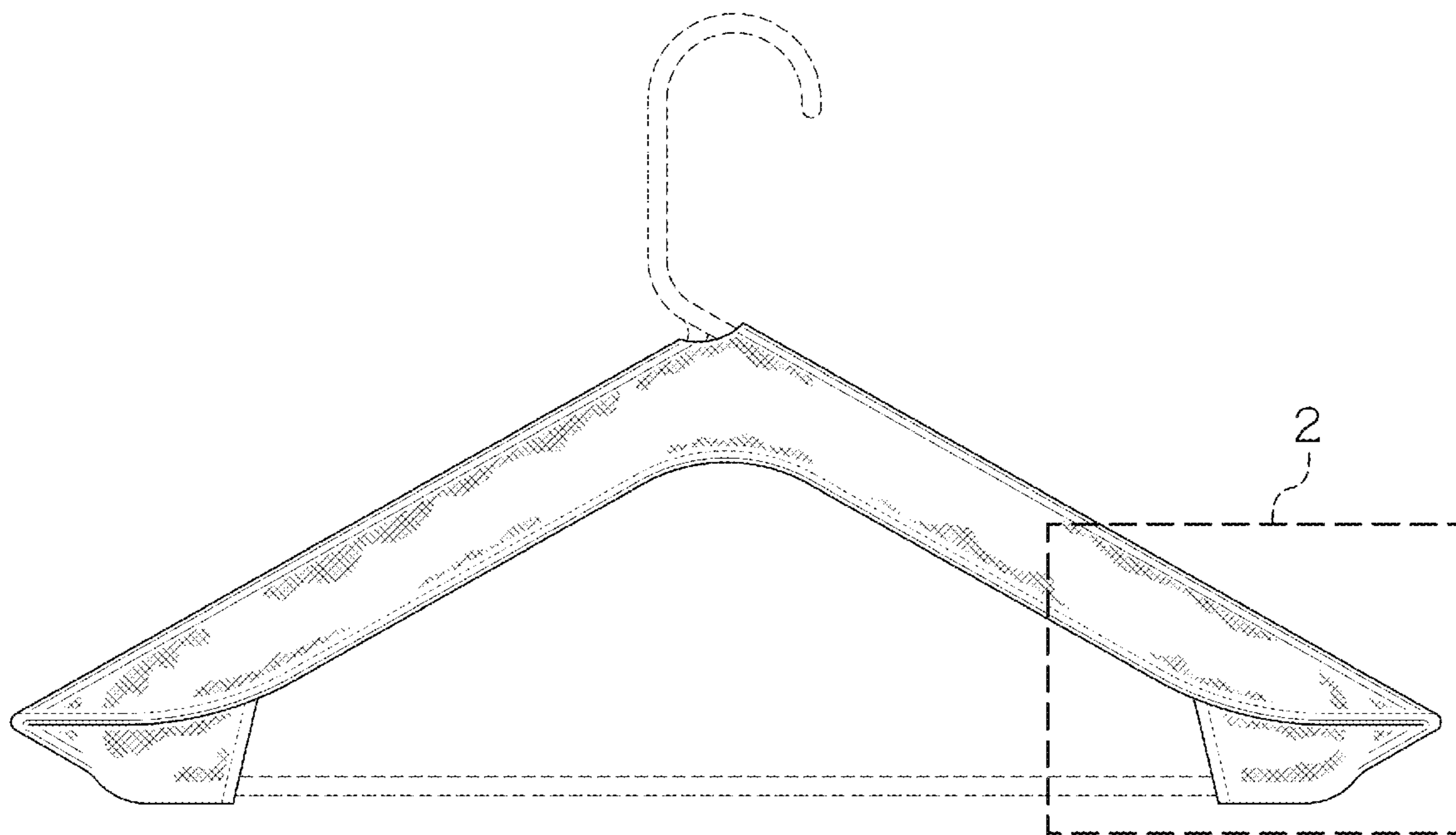
The broken lines shown represent unclaimed subject matter and form no part of the claimed design.

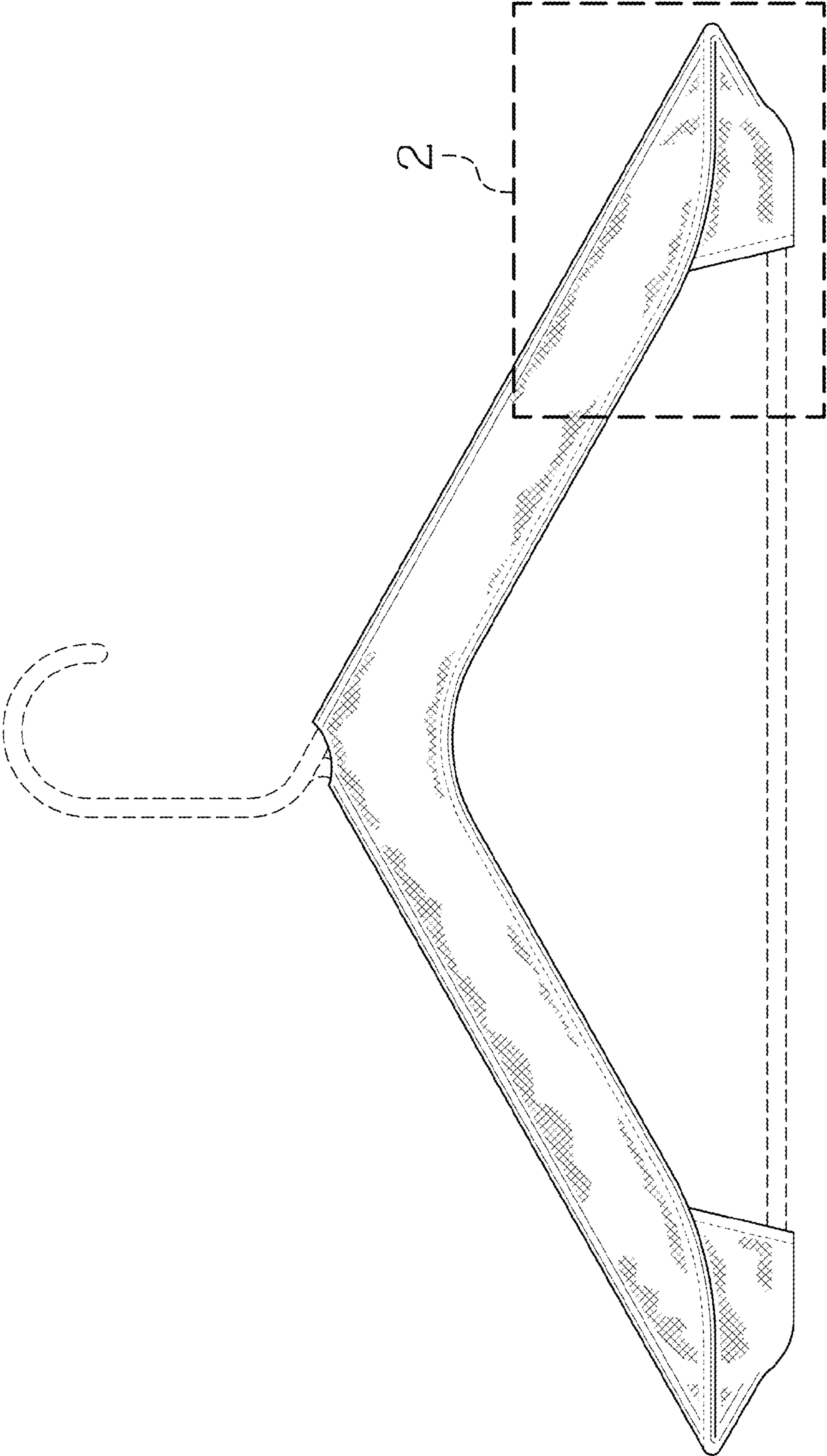

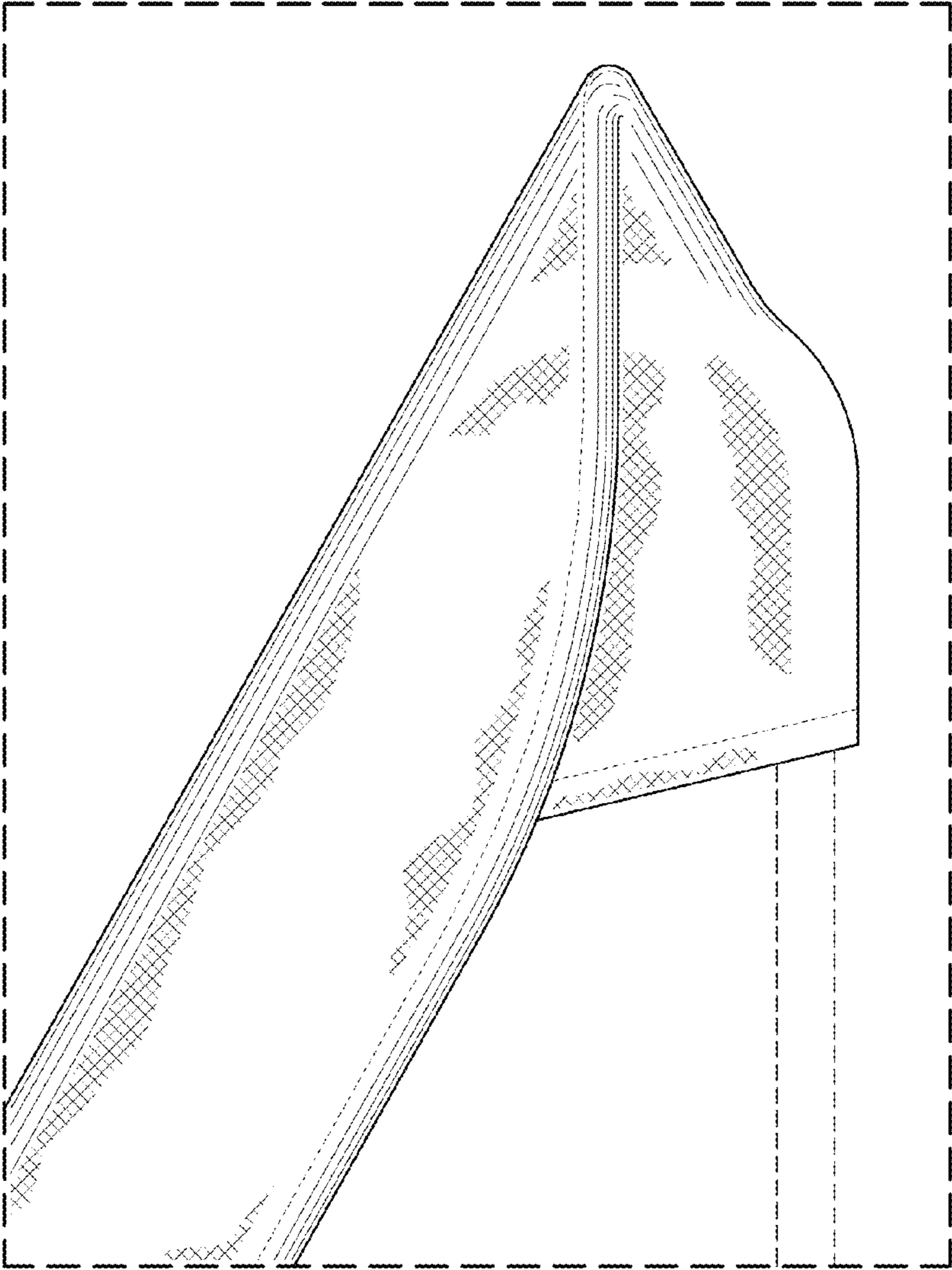
