DESCRIPTION

FIG. 7 is a left-side elevation view thereof.

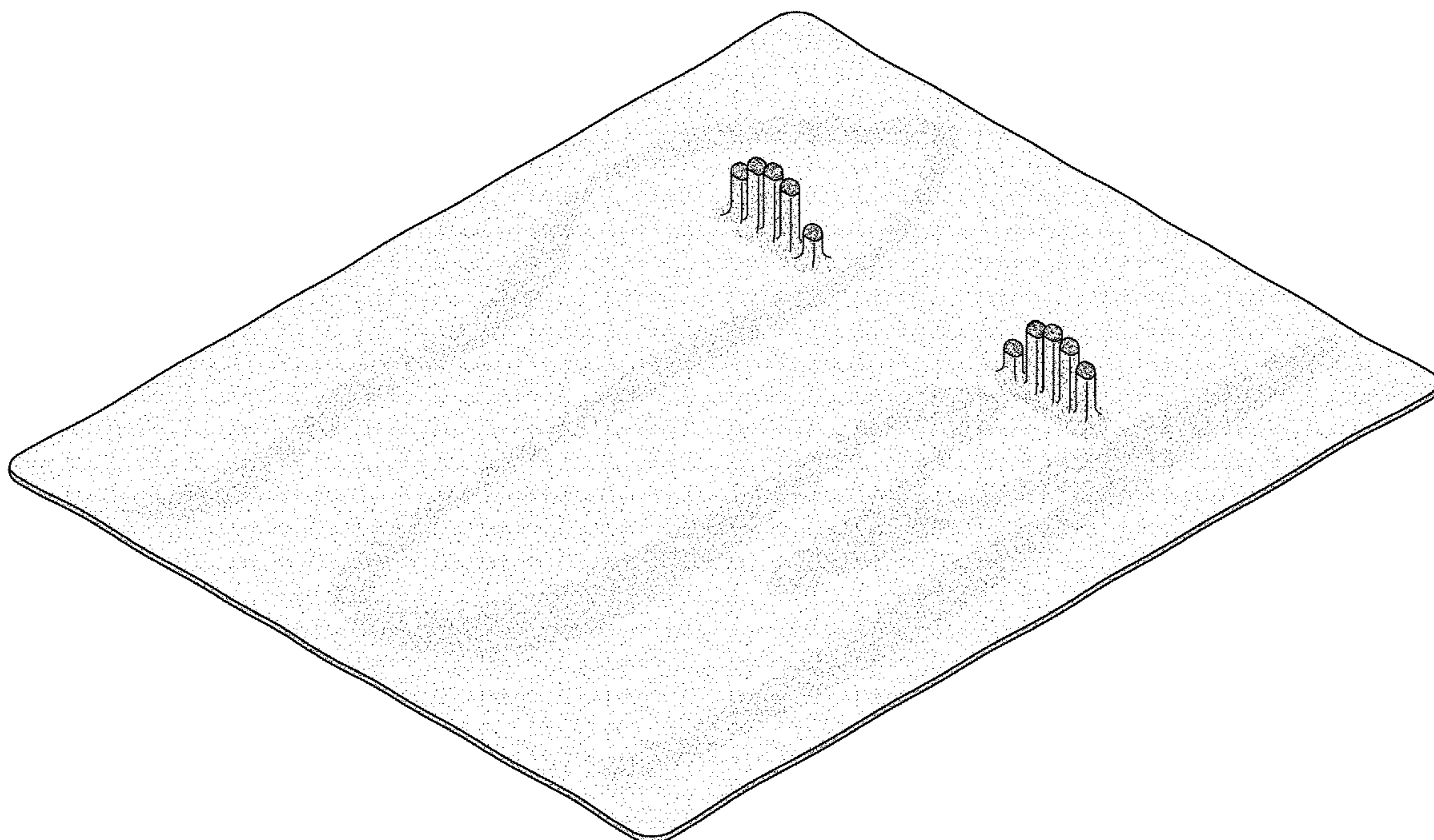
The broken lines depict portions of the blanket with fingers that form no part of the claimed design.

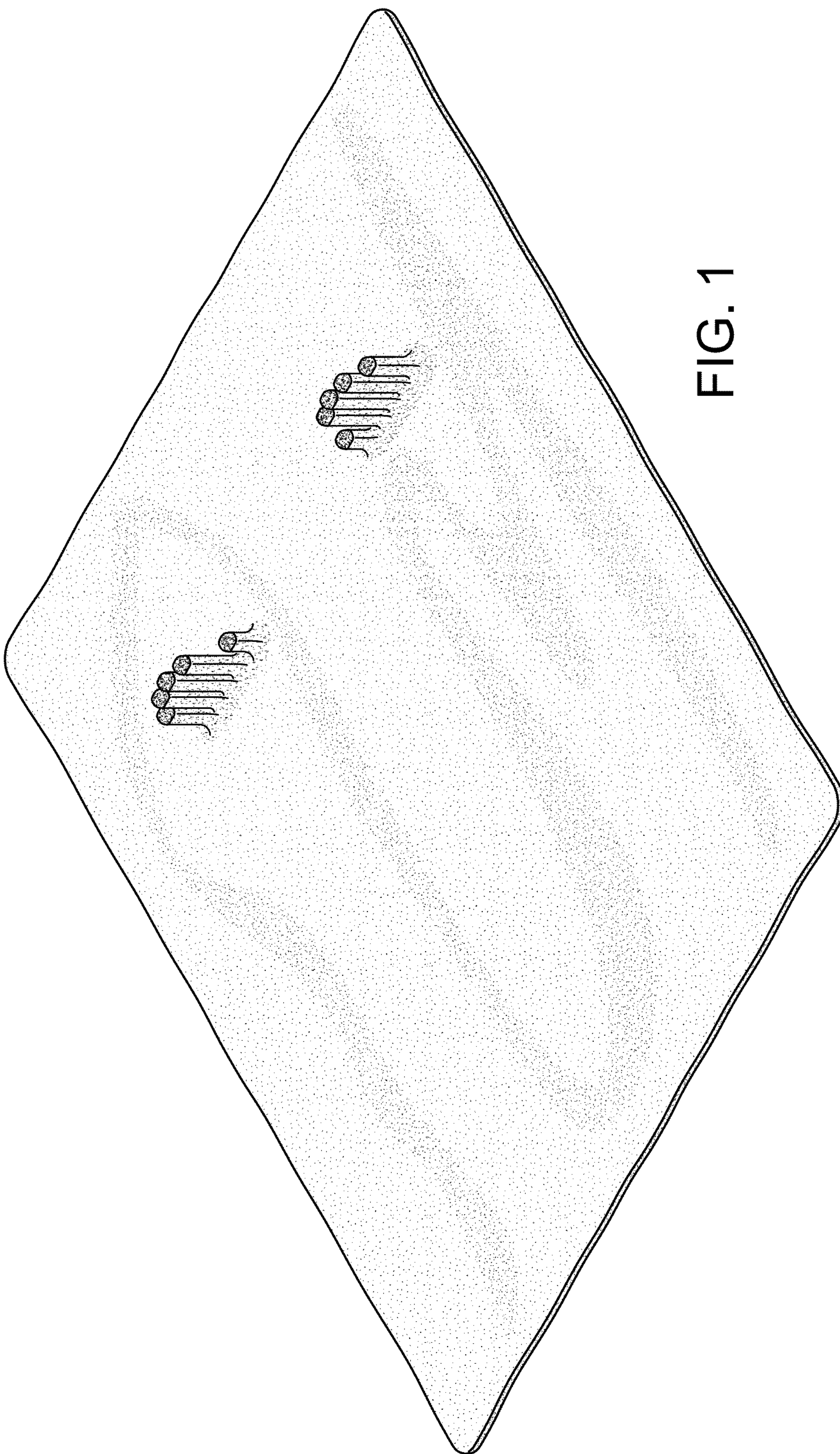

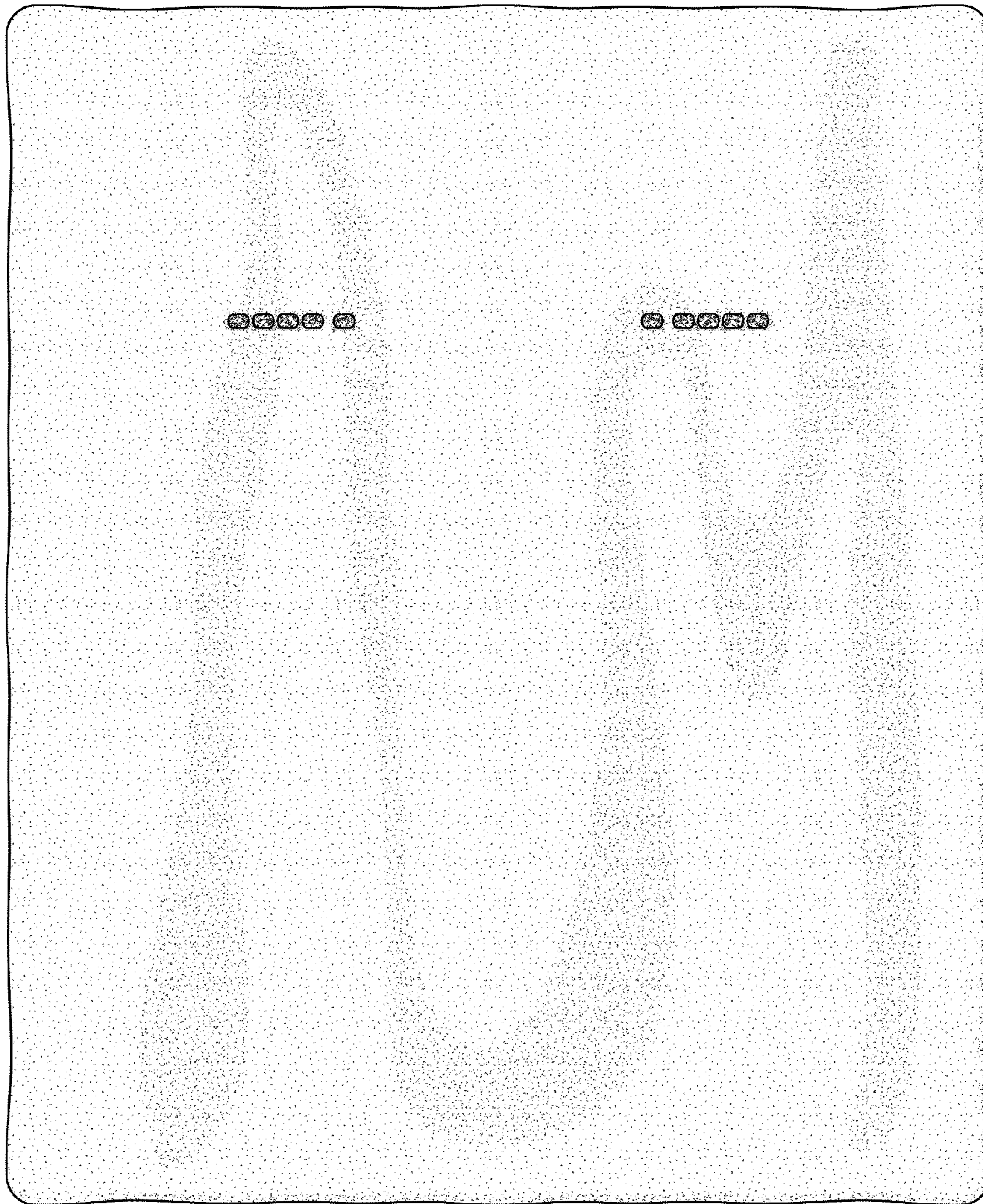

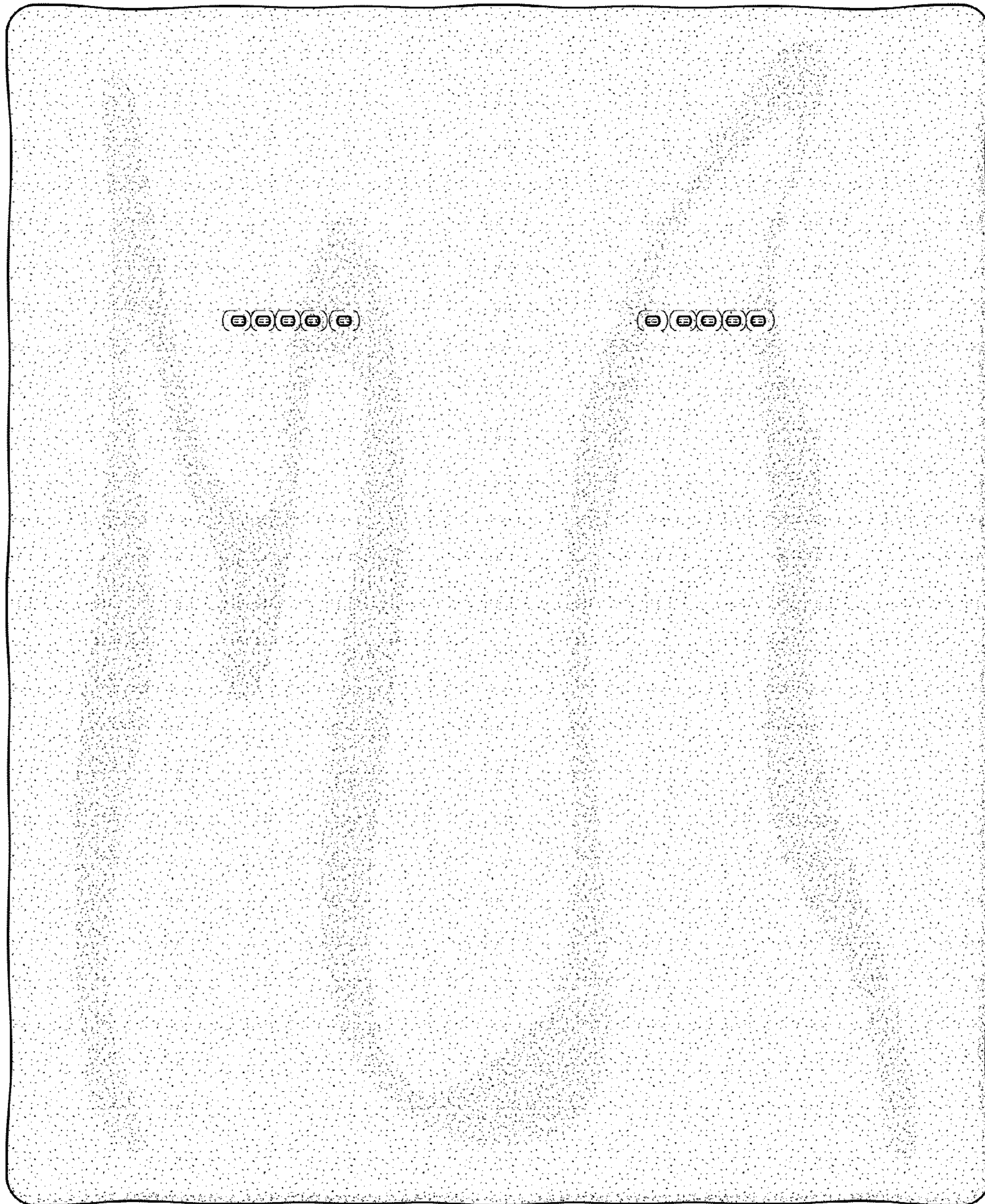

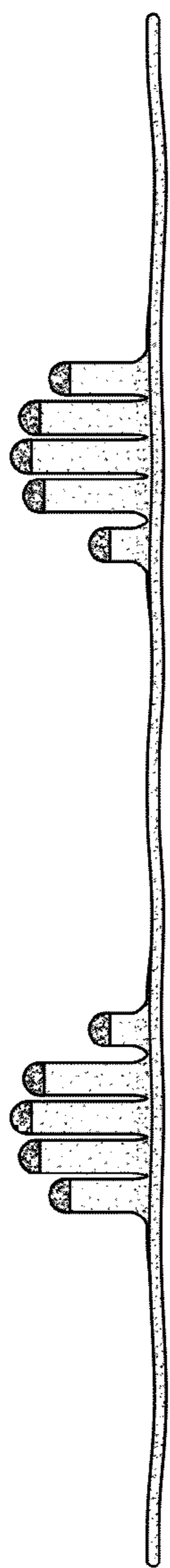

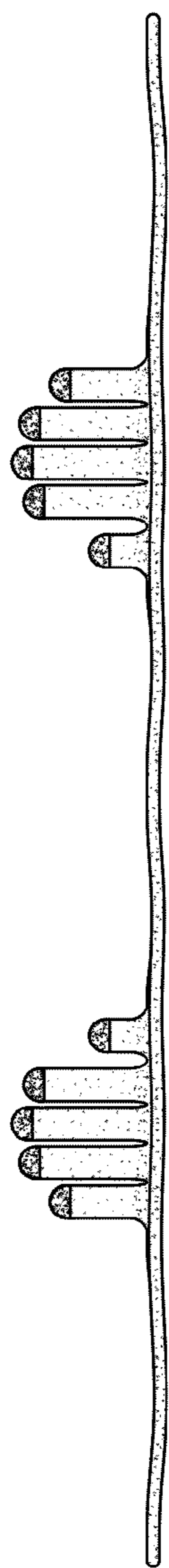

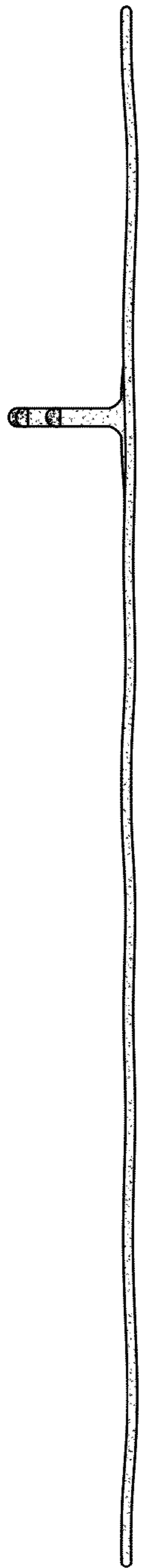

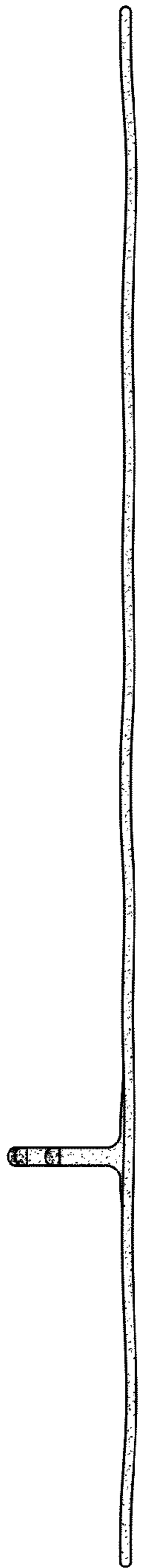
