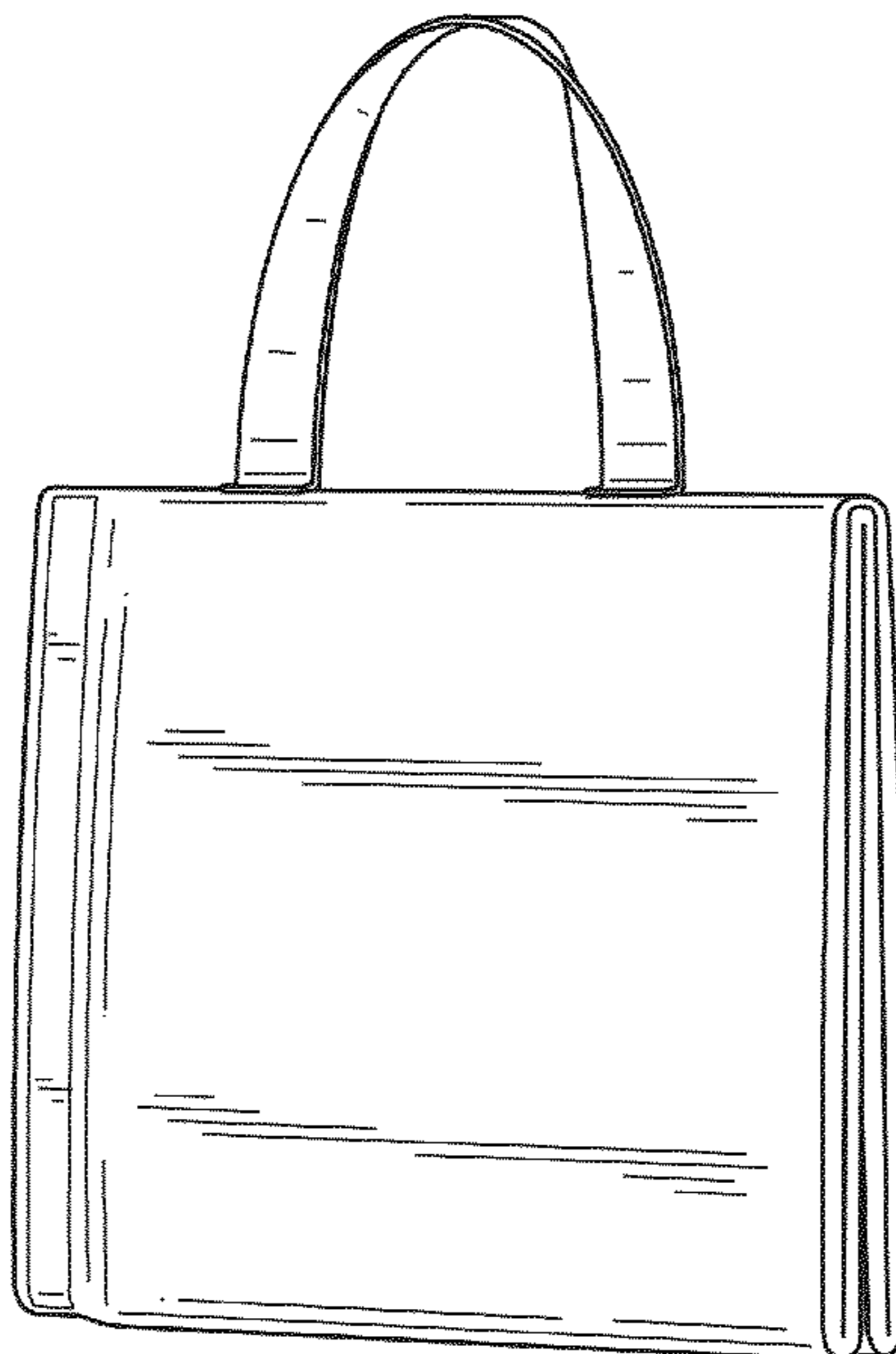
FIG. 1 is a perspective front view of a portable car seat cooling device;

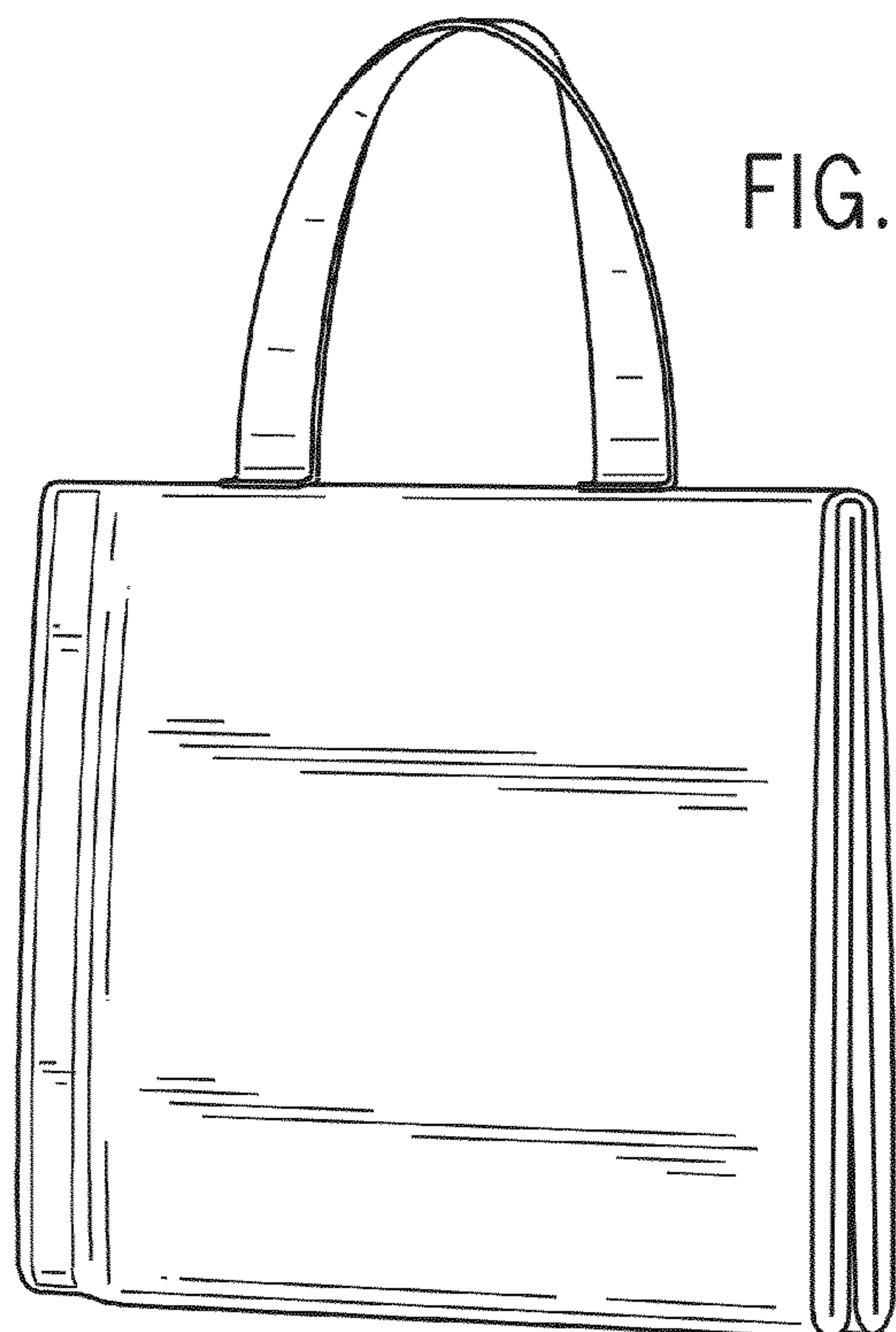

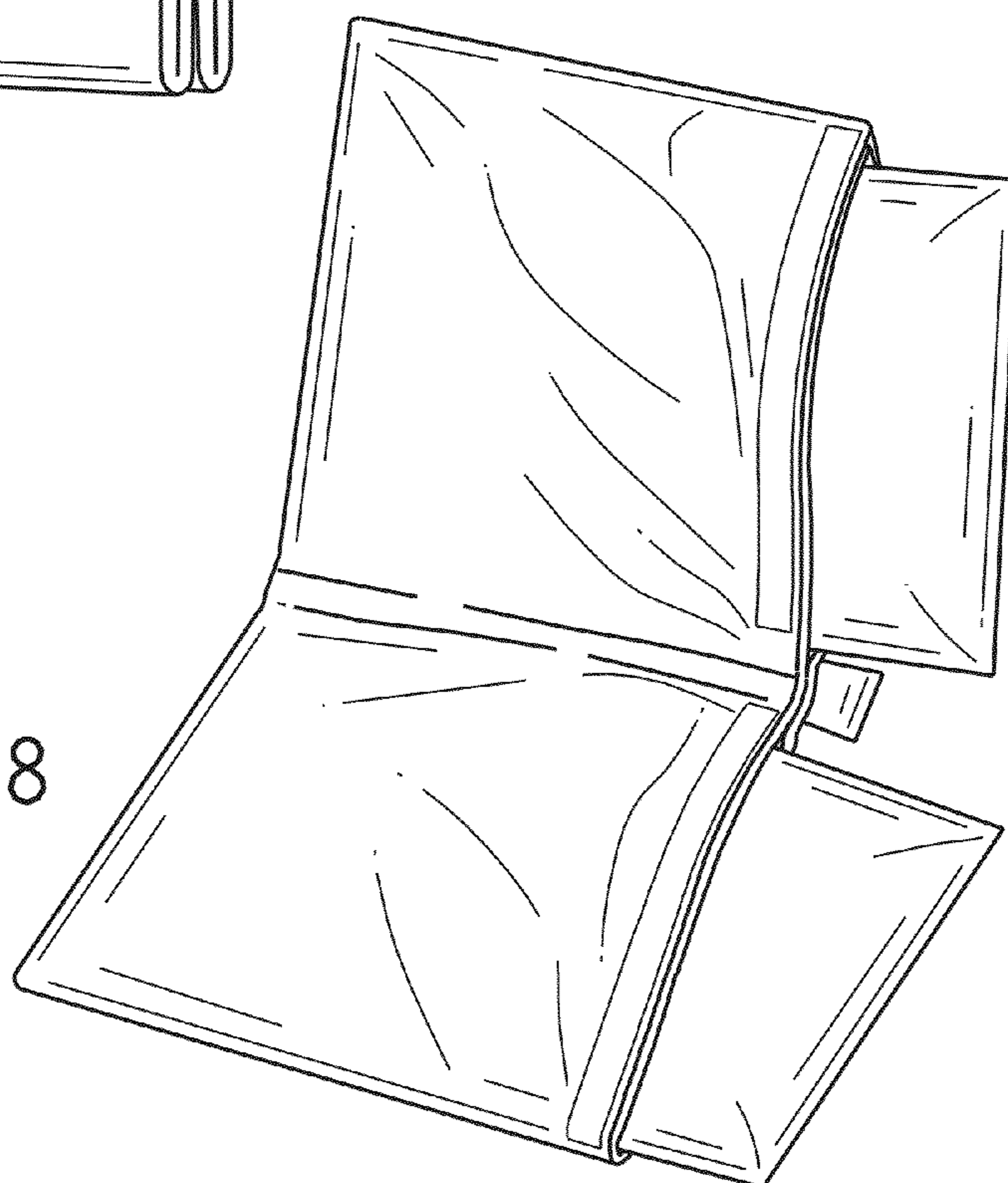

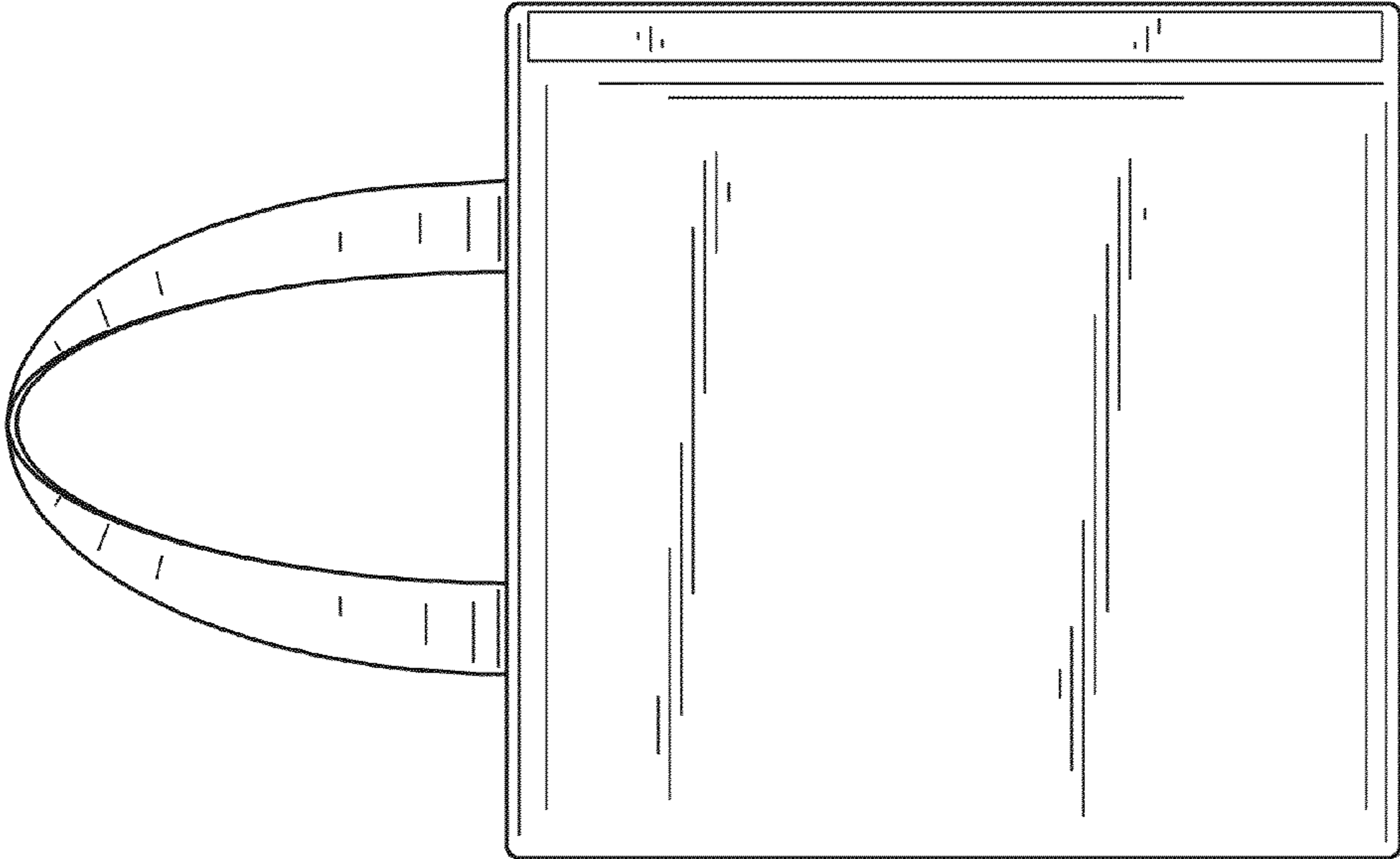

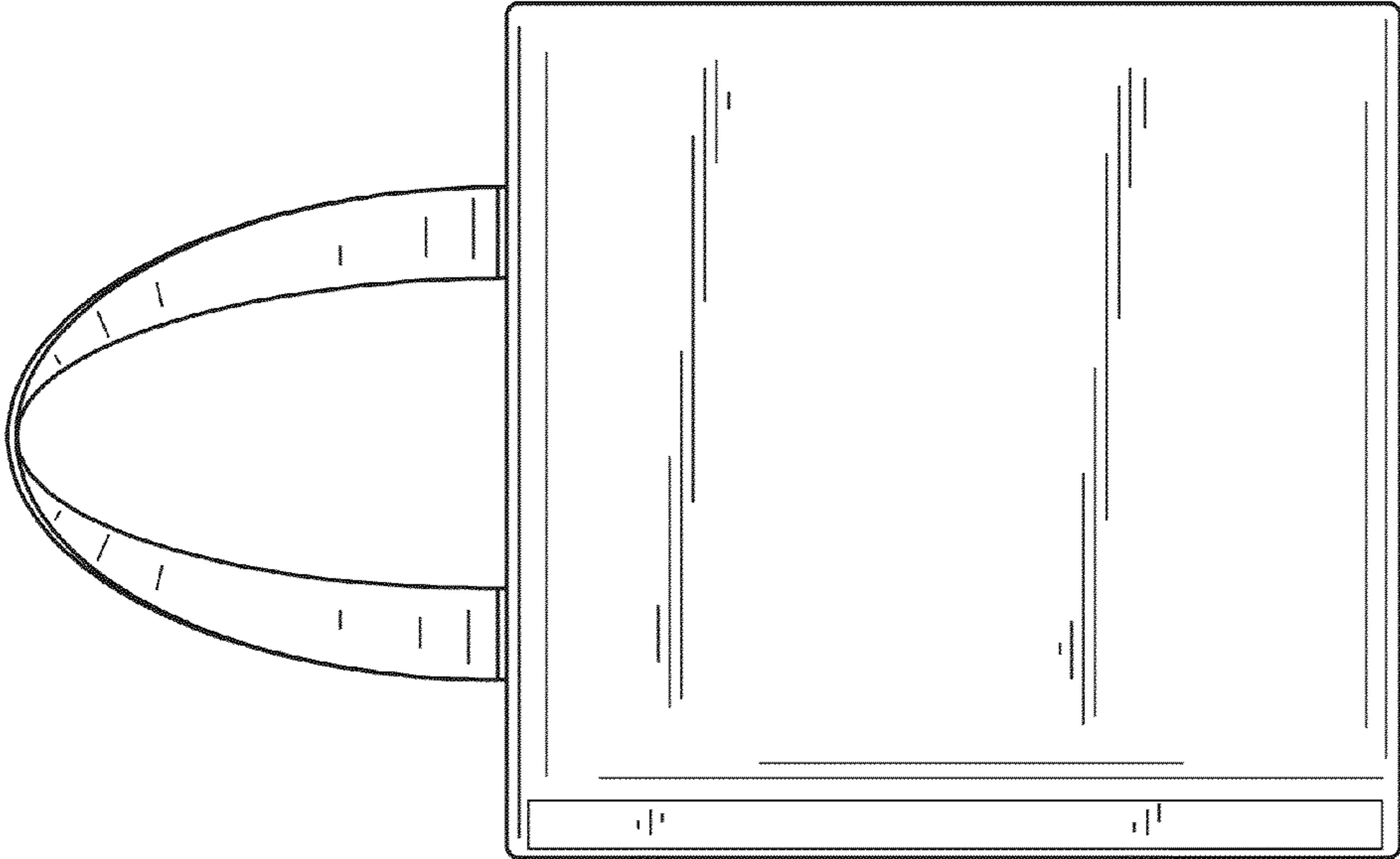

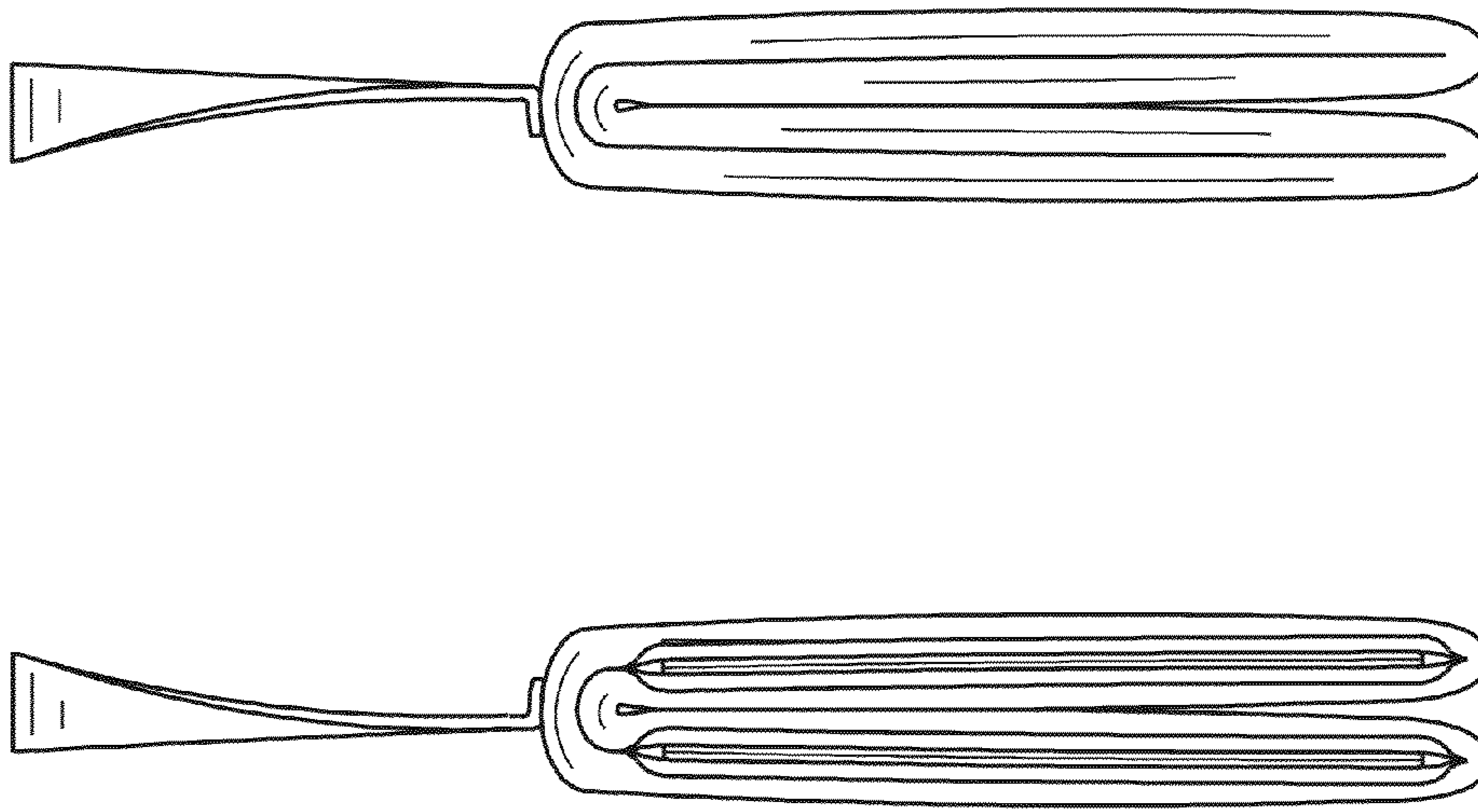

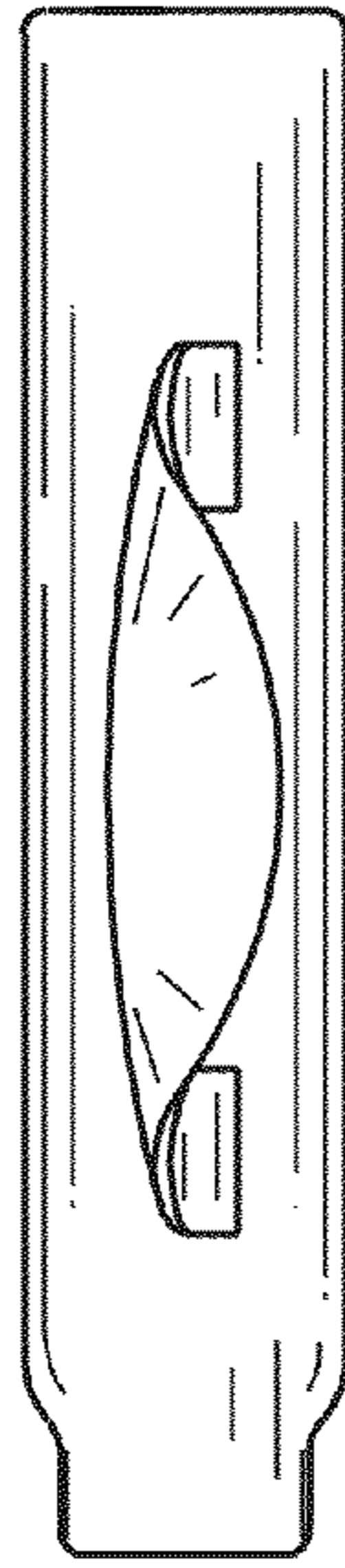

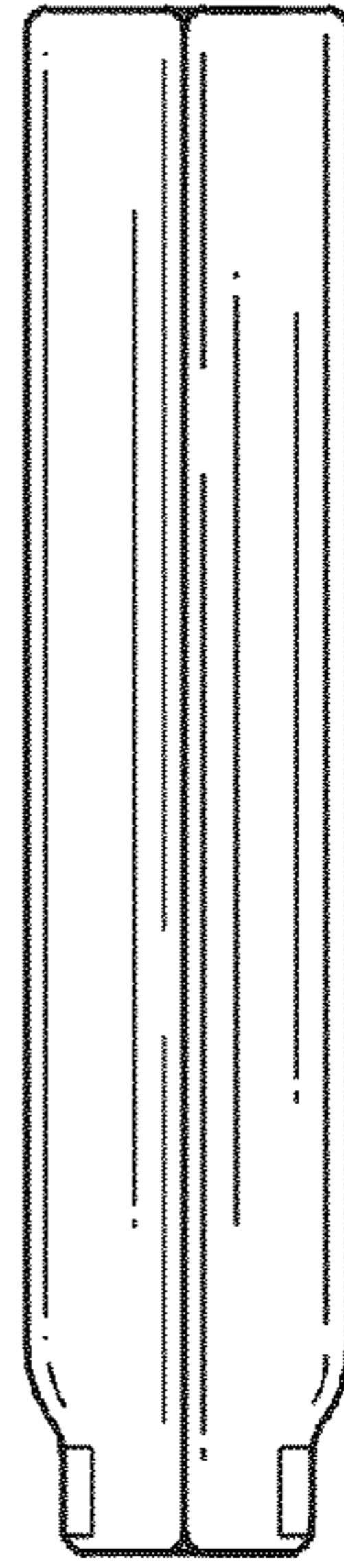
