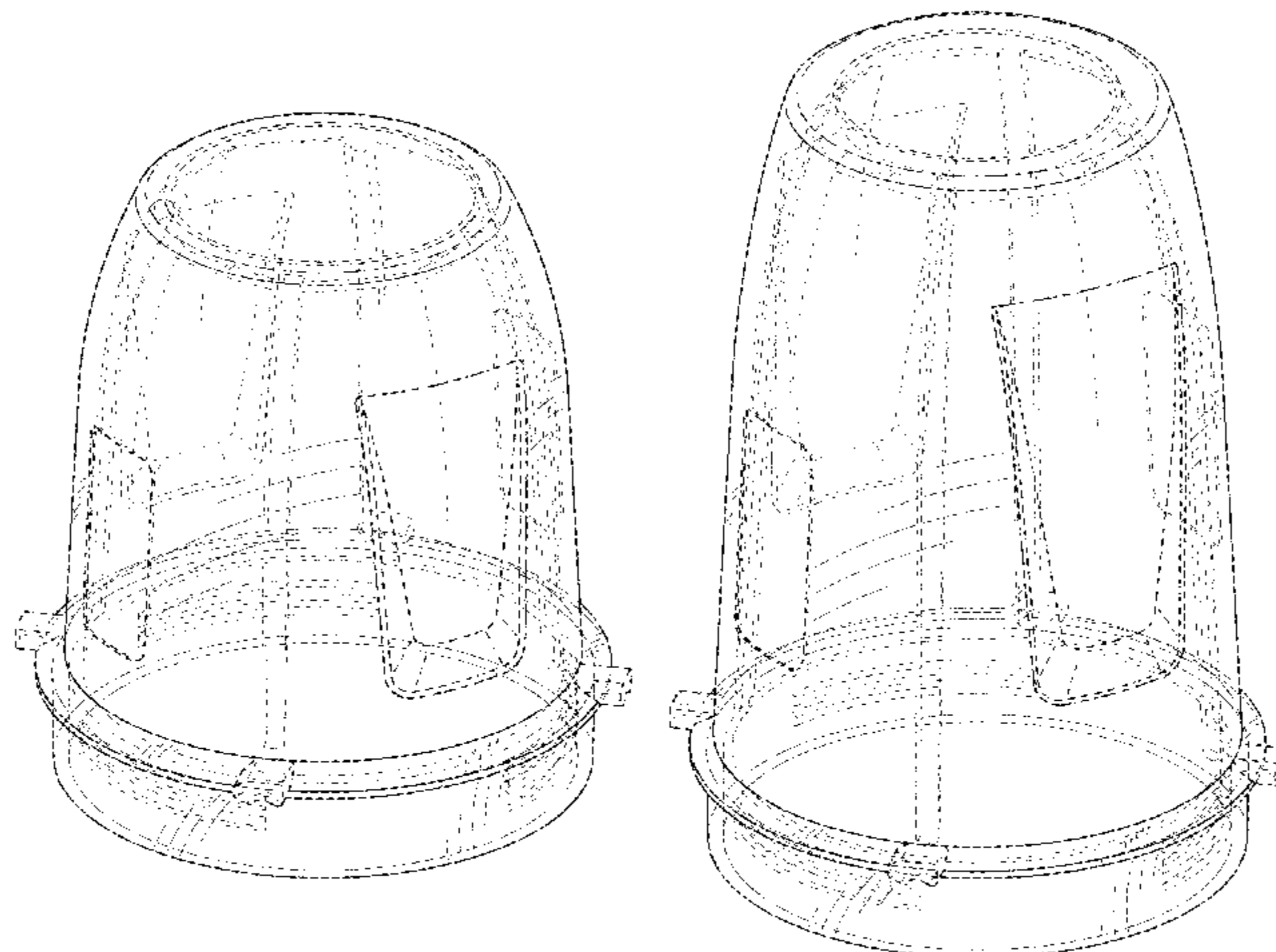
(57) **CLAIM**

The ornamental design for a blender container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a first embodiment of a blender container showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top, front, left side perspective view of a second embodiment thereof; FIG. 9 is a front elevational view of FIG. 8; FIG. 10 is a rear elevational view of FIG. 8; FIG. 11 is a left side elevational view of FIG. 8; FIG. 12 is a right side elevational view of FIG. 8; FIG. 13 is a top plan view of FIG. 8; FIG. 14 is a bottom plan view of FIG. 8; FIG. 15 is a top, front, left side perspective view of a third embodiment thereof; FIG. 16 is a front elevational view of FIG. 15; FIG. 17 is a rear elevational view of FIG. 15; FIG. 18 is a left side elevational view of FIG. 15; FIG. 19 is a right side elevational view of FIG. 15; FIG. 20 is a top plan view of FIG. 15; FIG. 21 is a bottom plan view of FIGS. 15; FIG. 22 is a top, front, left side perspective view of a fourth embodiment thereof; FIG. 23 is a front elevational view of FIG. 22; FIG. 24 is a rear elevational view of FIG. 22; FIG. 25 is a left side elevational view of FIG. 22; FIG. 26 is a right side elevational view of FIG. 22; FIG. 27 is a top plan view of FIG. 22; and, FIG. 28 is a bottom plan view of FIG. 22. The broken lines of FIGS. 1-28 illustrate portions of the blender container that form no part of the claimed design. The dash-dot-dash broken lines shown in FIGS. 1-6, 8-13, 15-20, and 22-27 define boundaries of the claimed design.

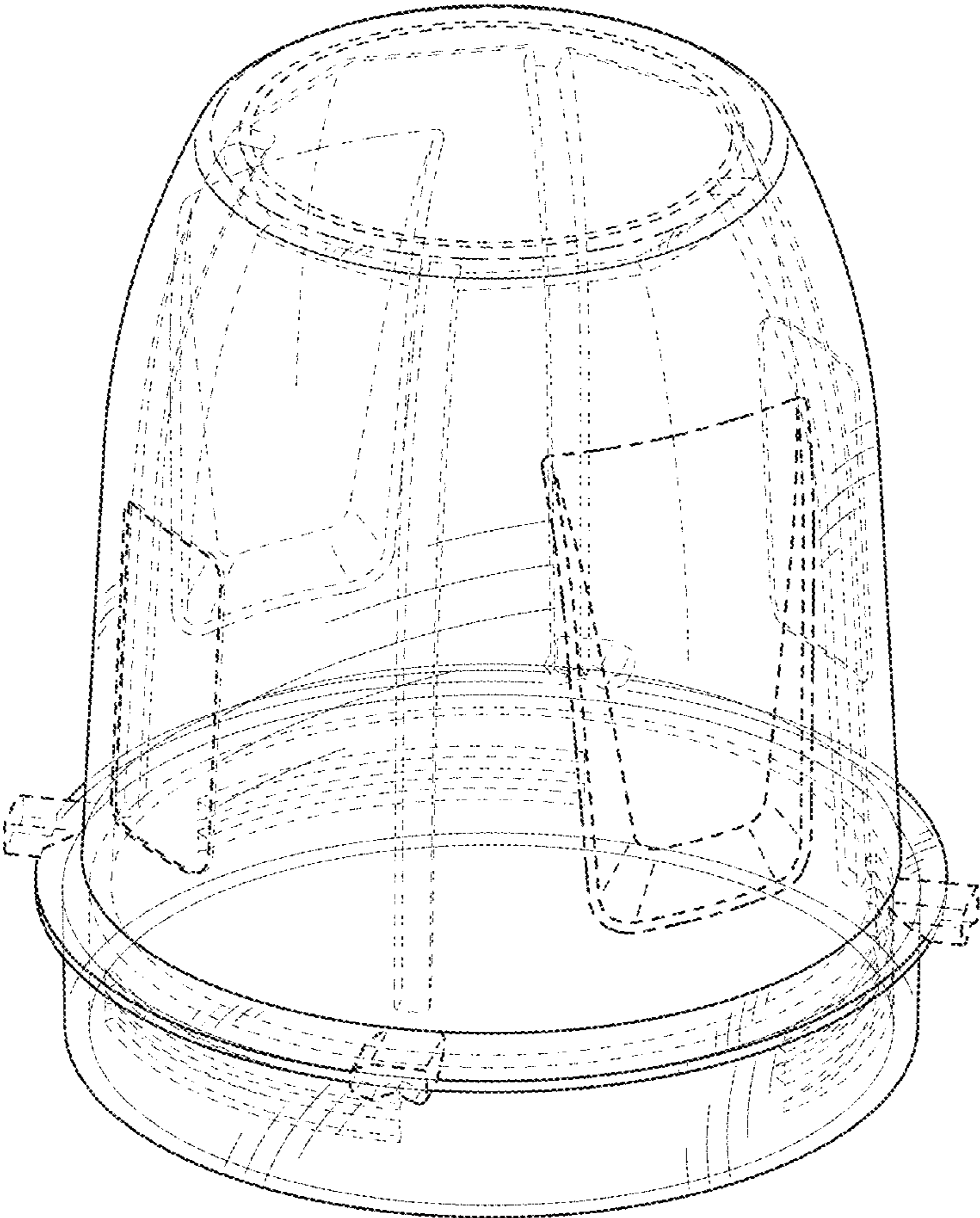

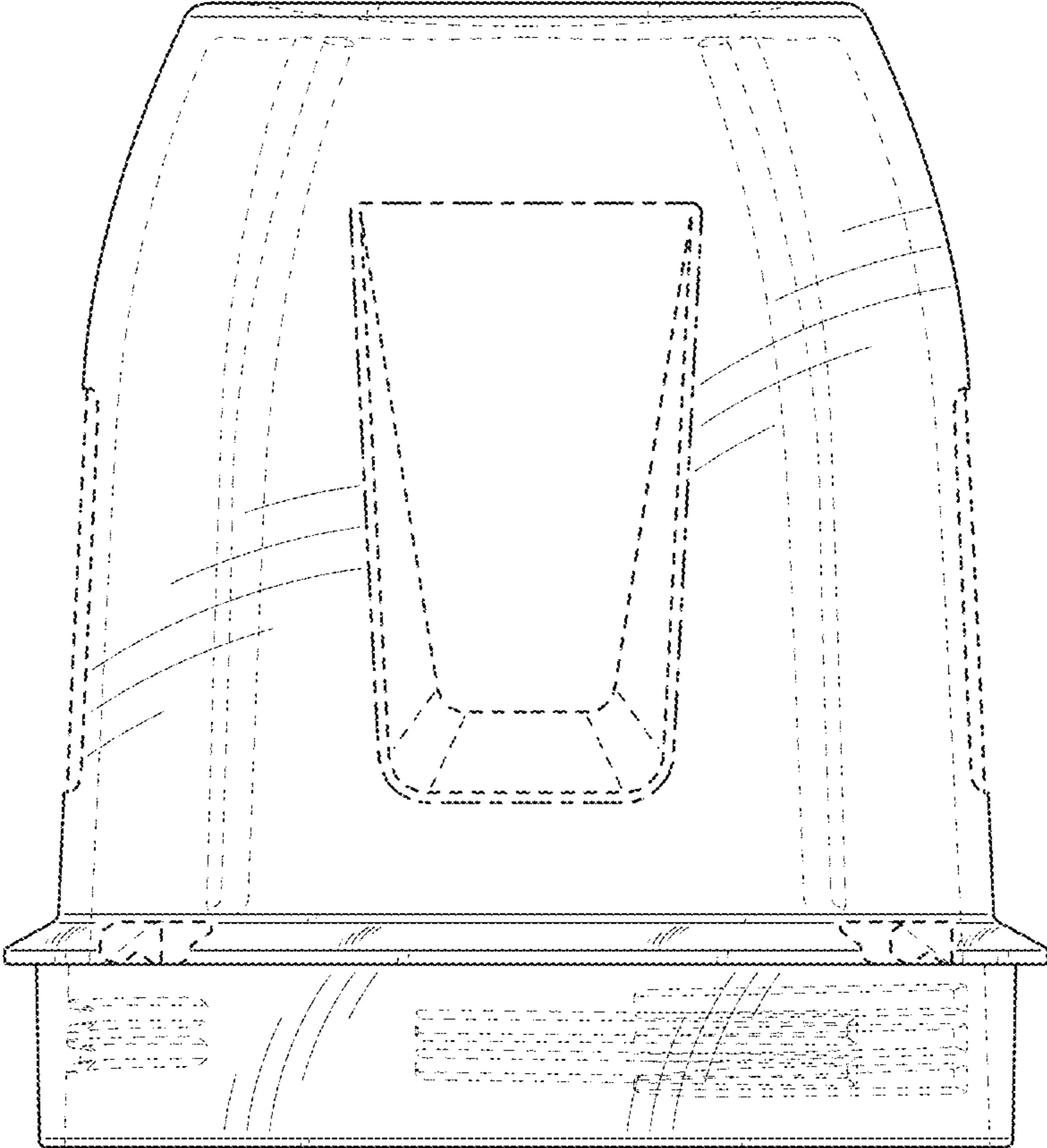

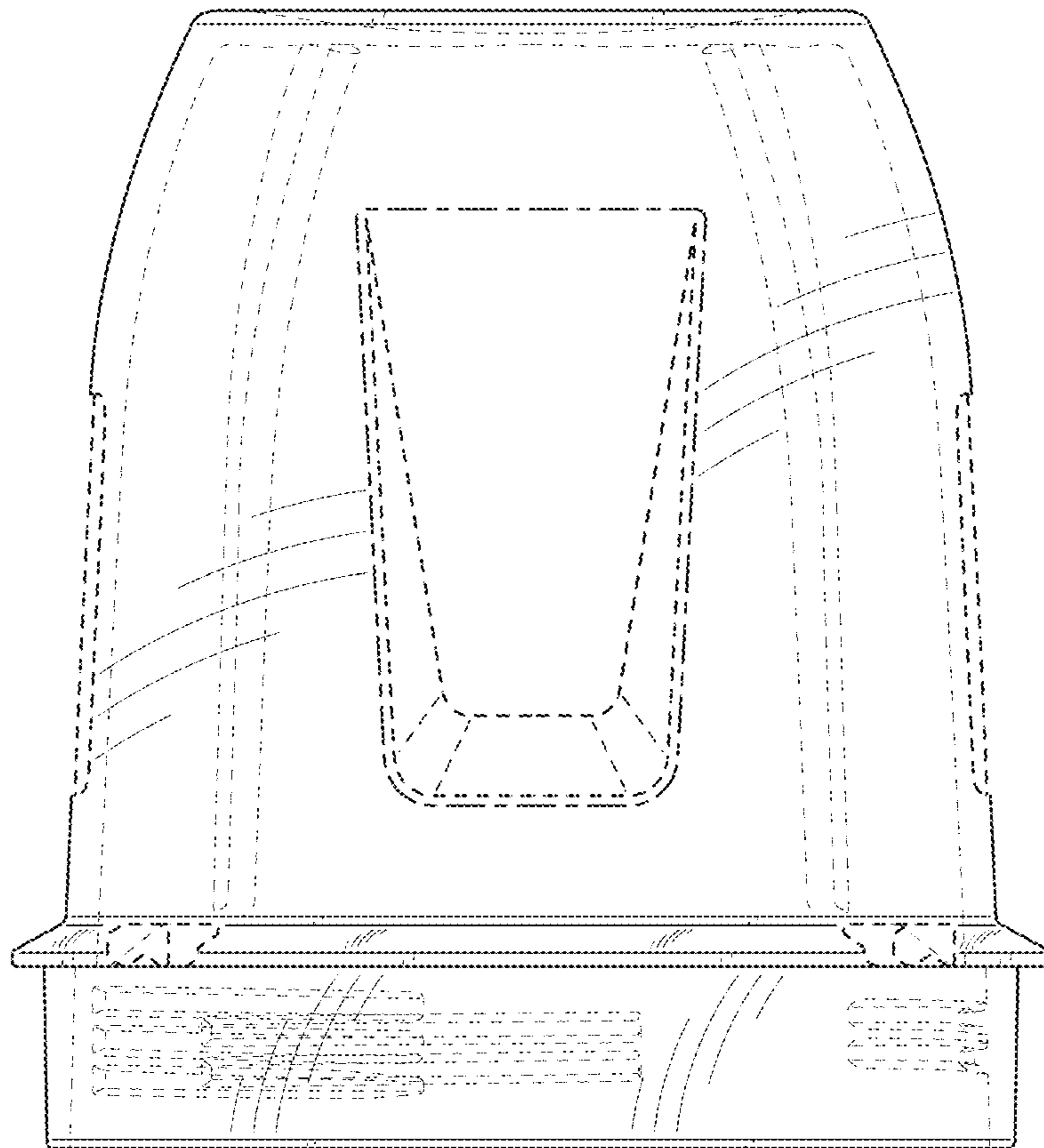

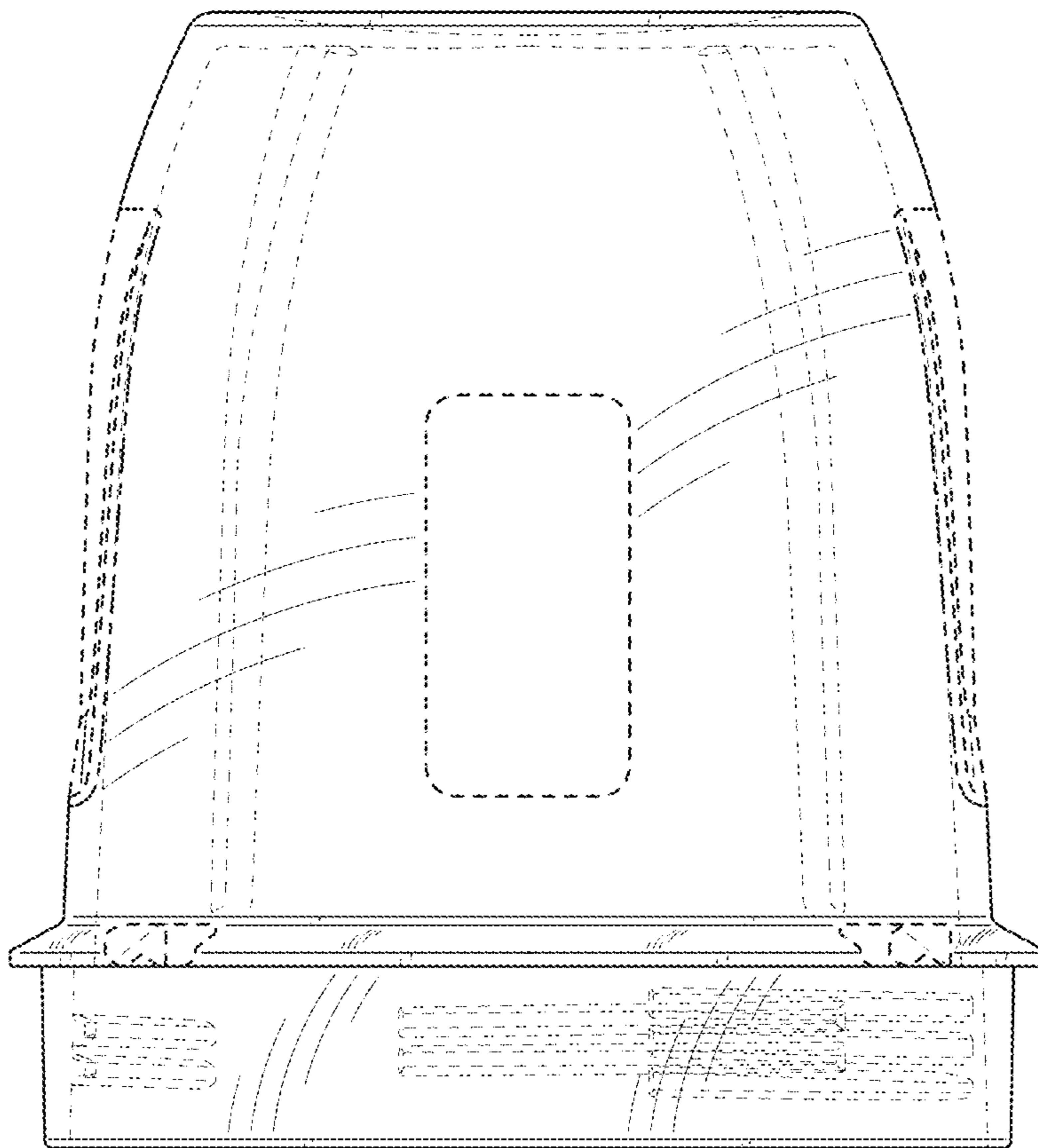

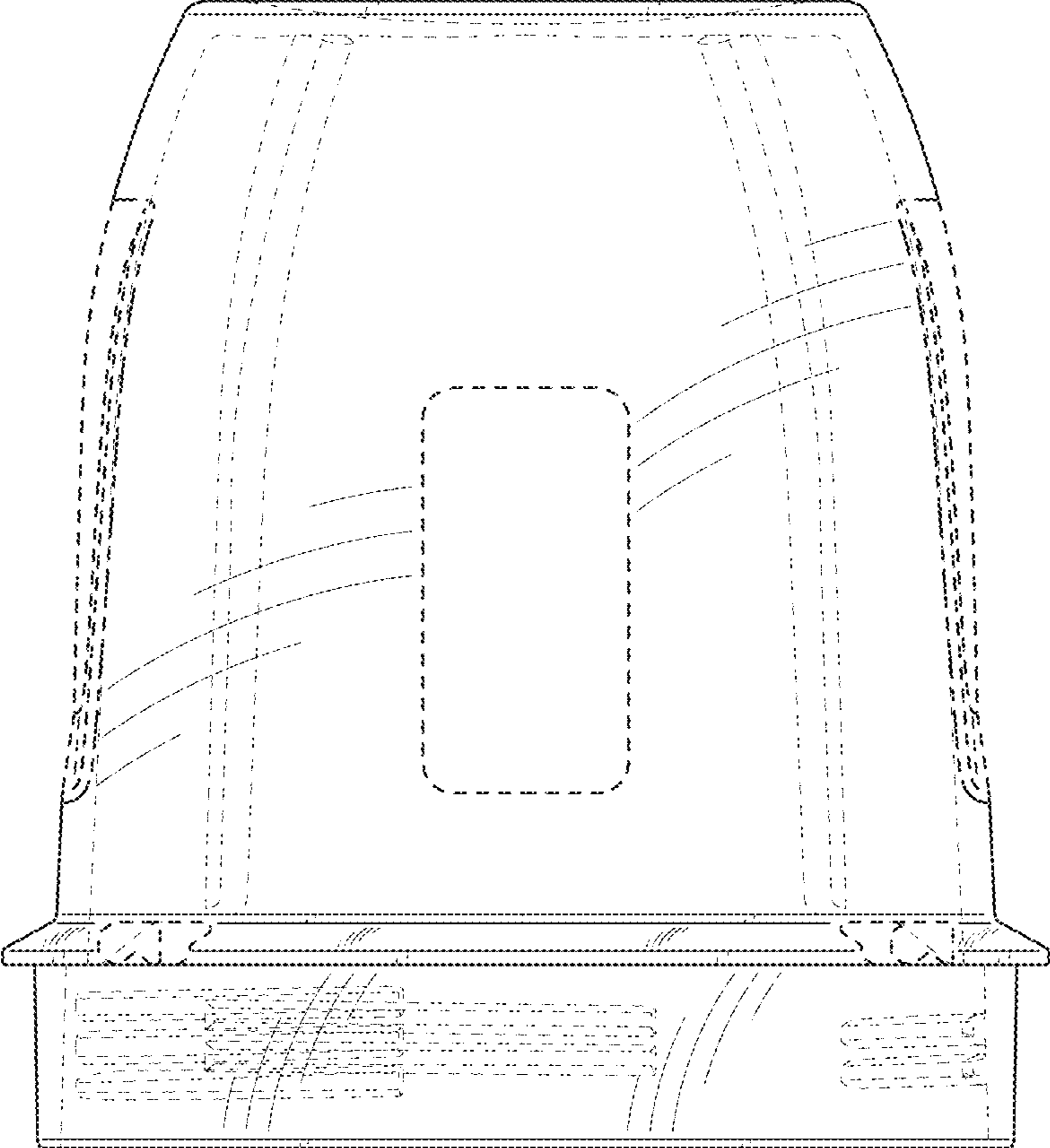

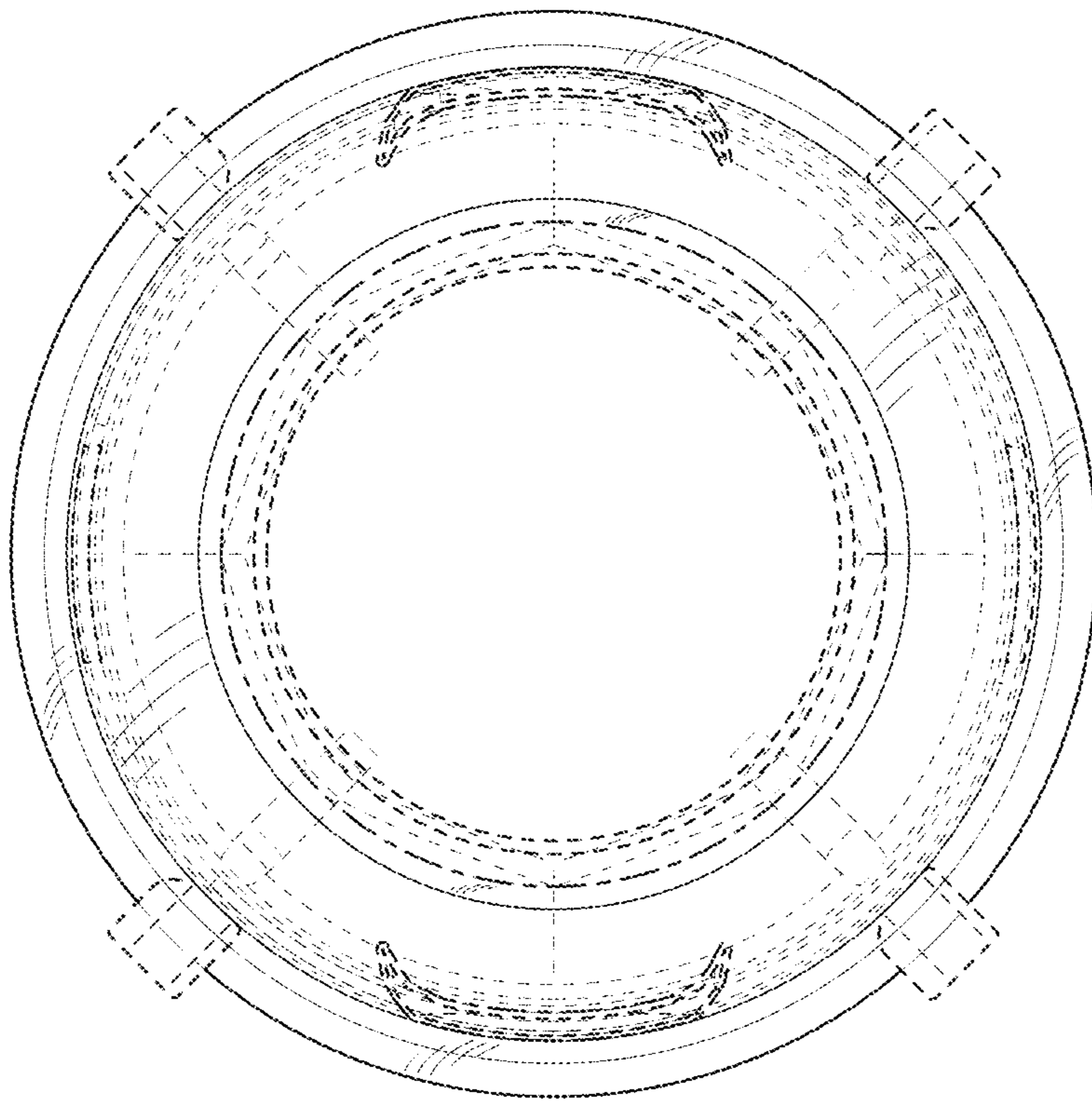

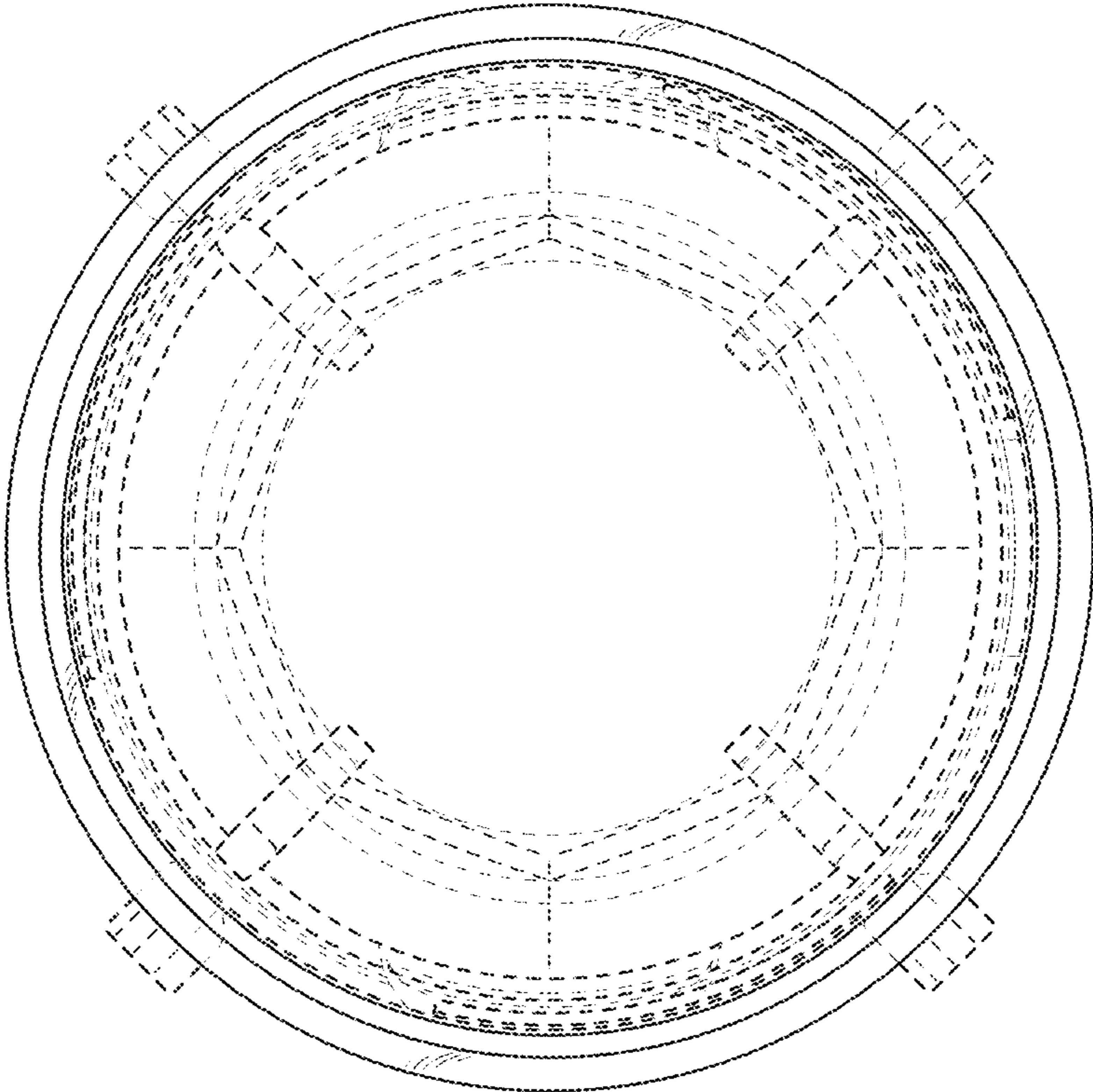

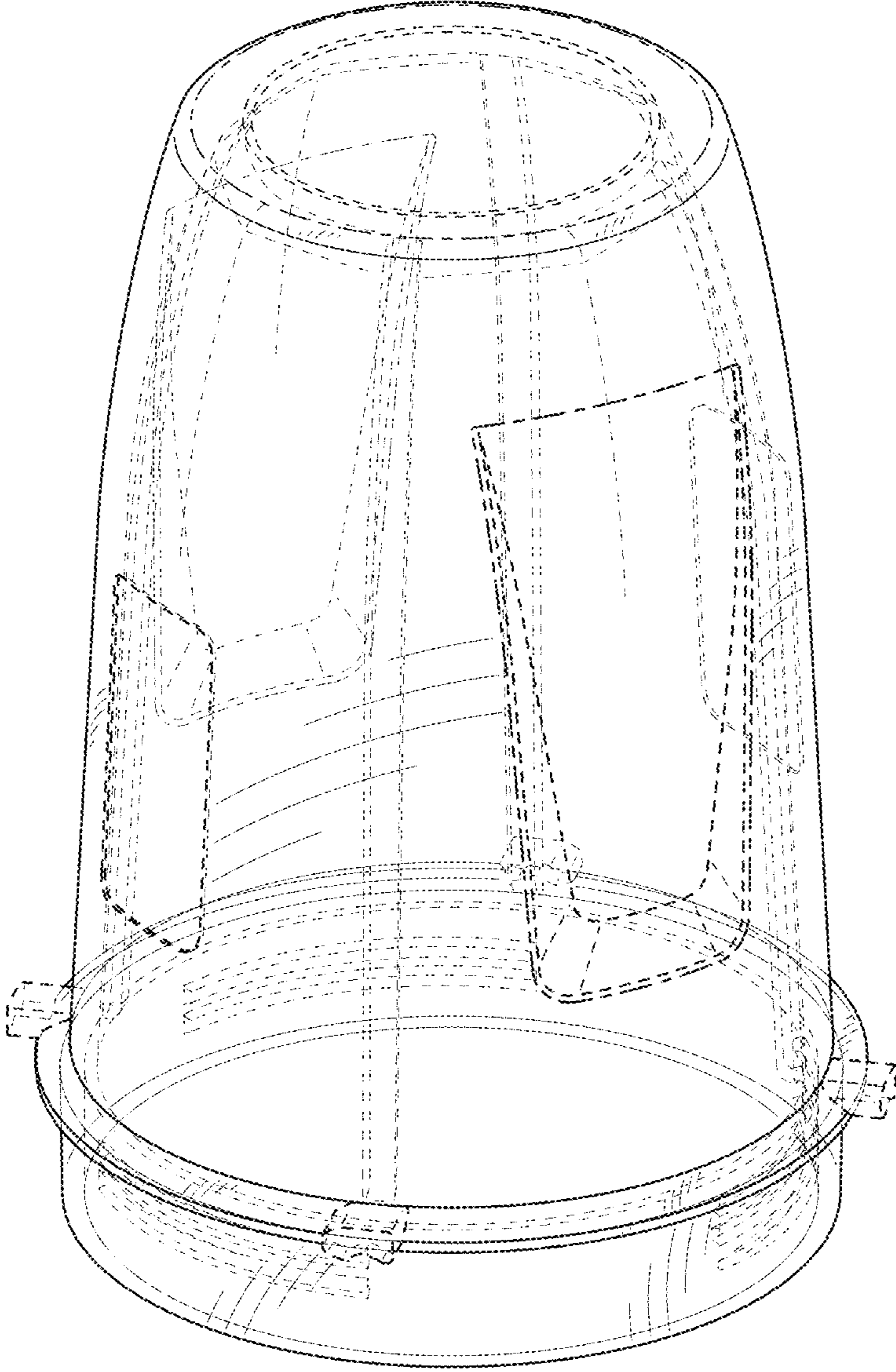

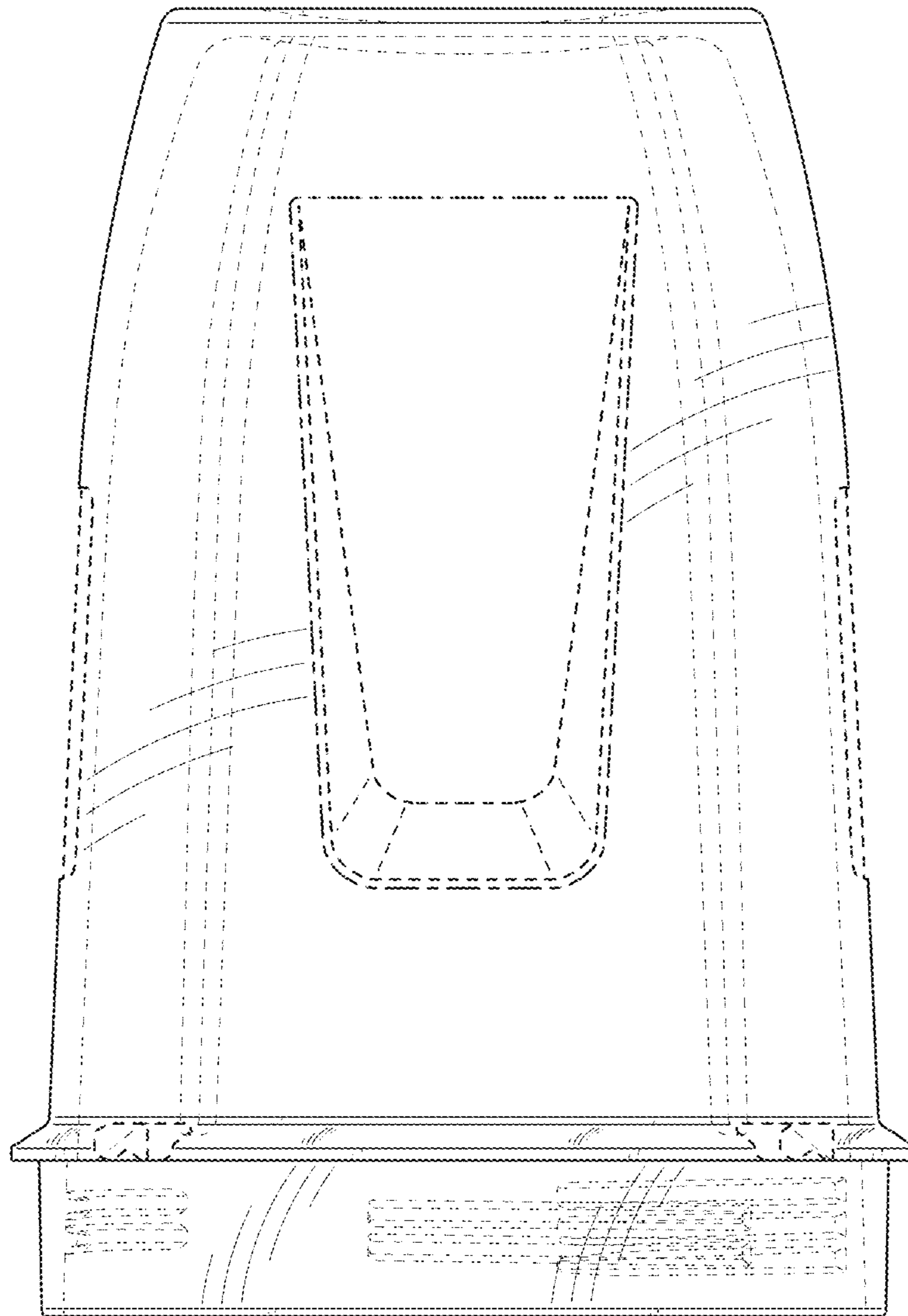

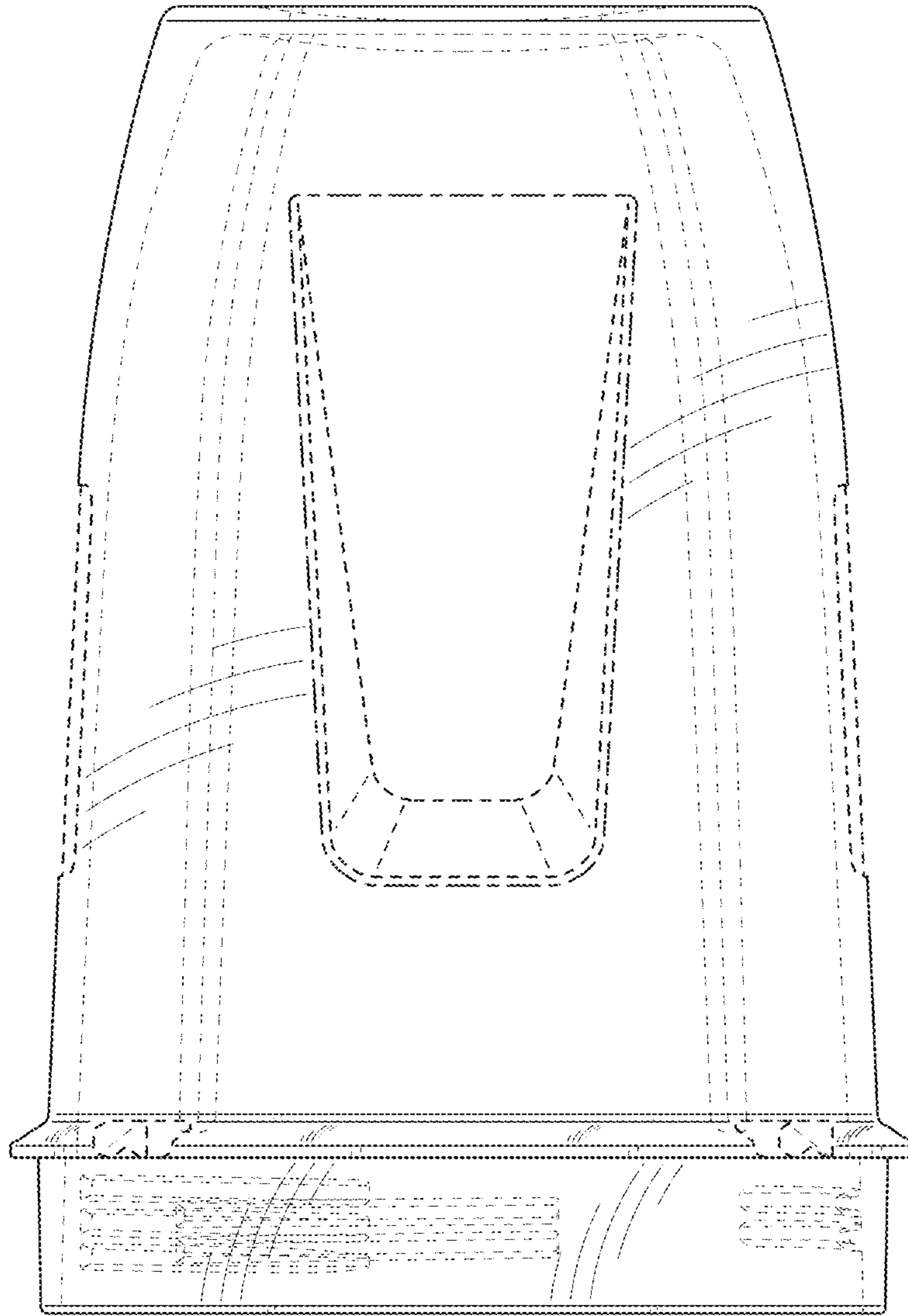

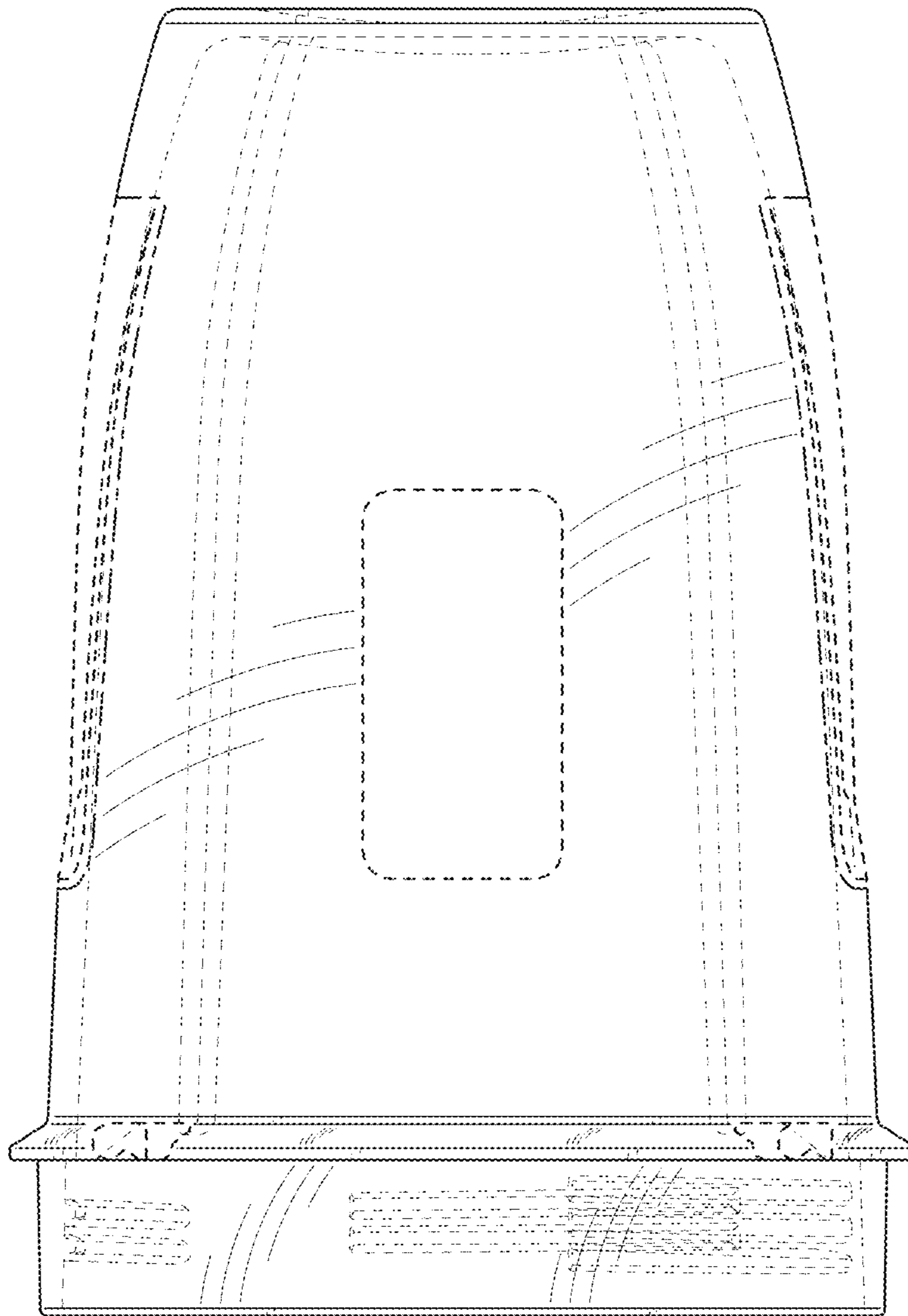

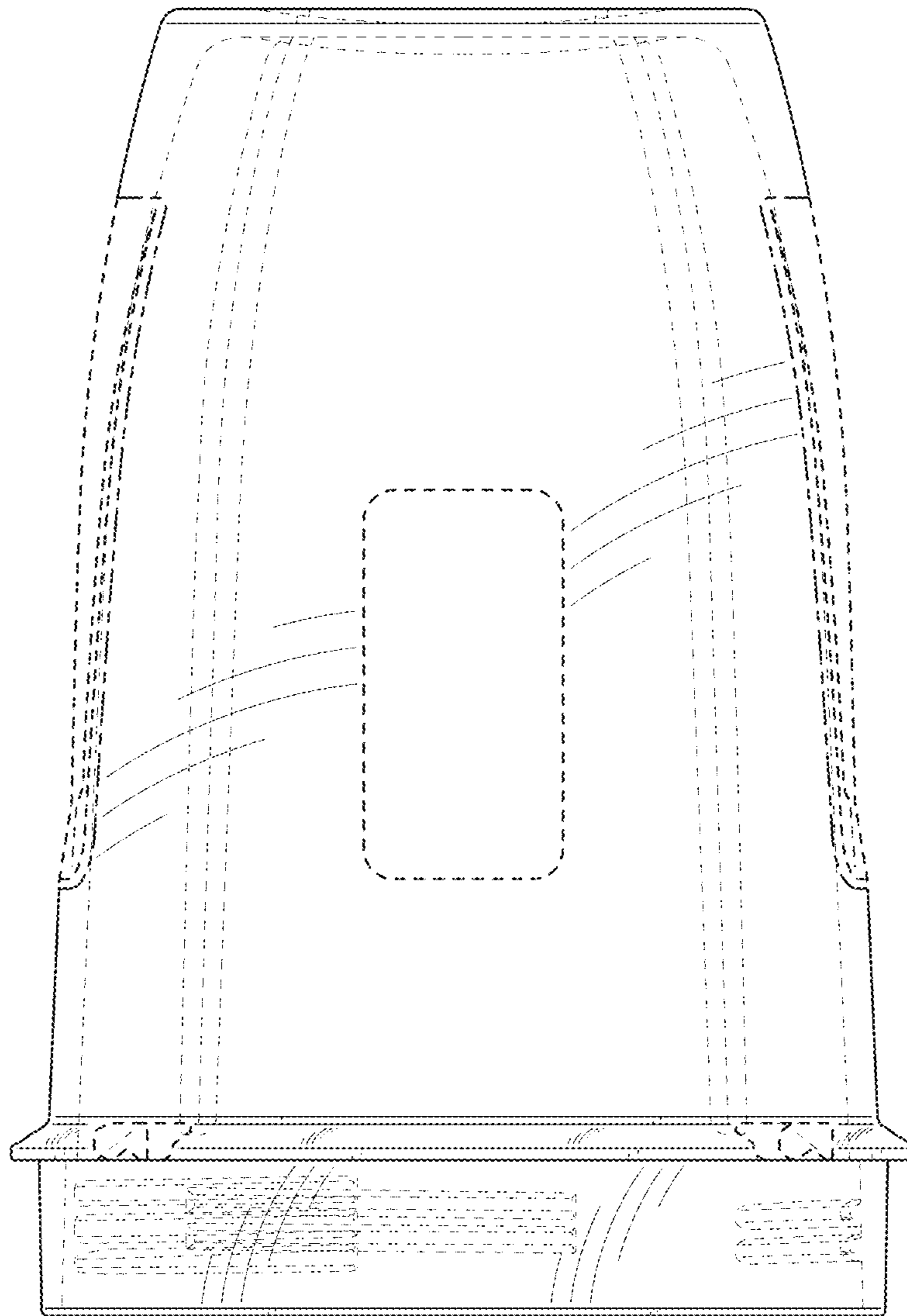

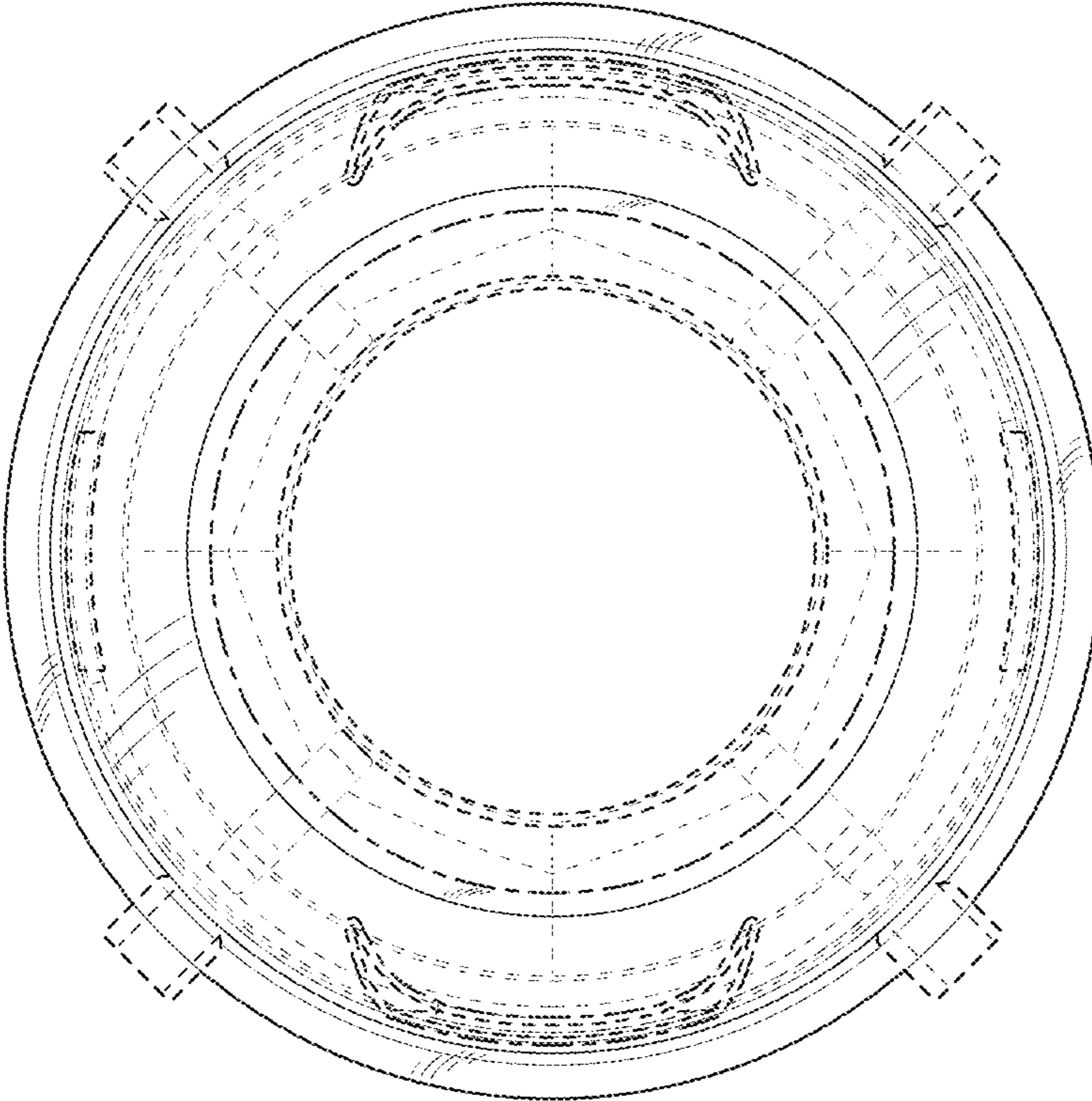

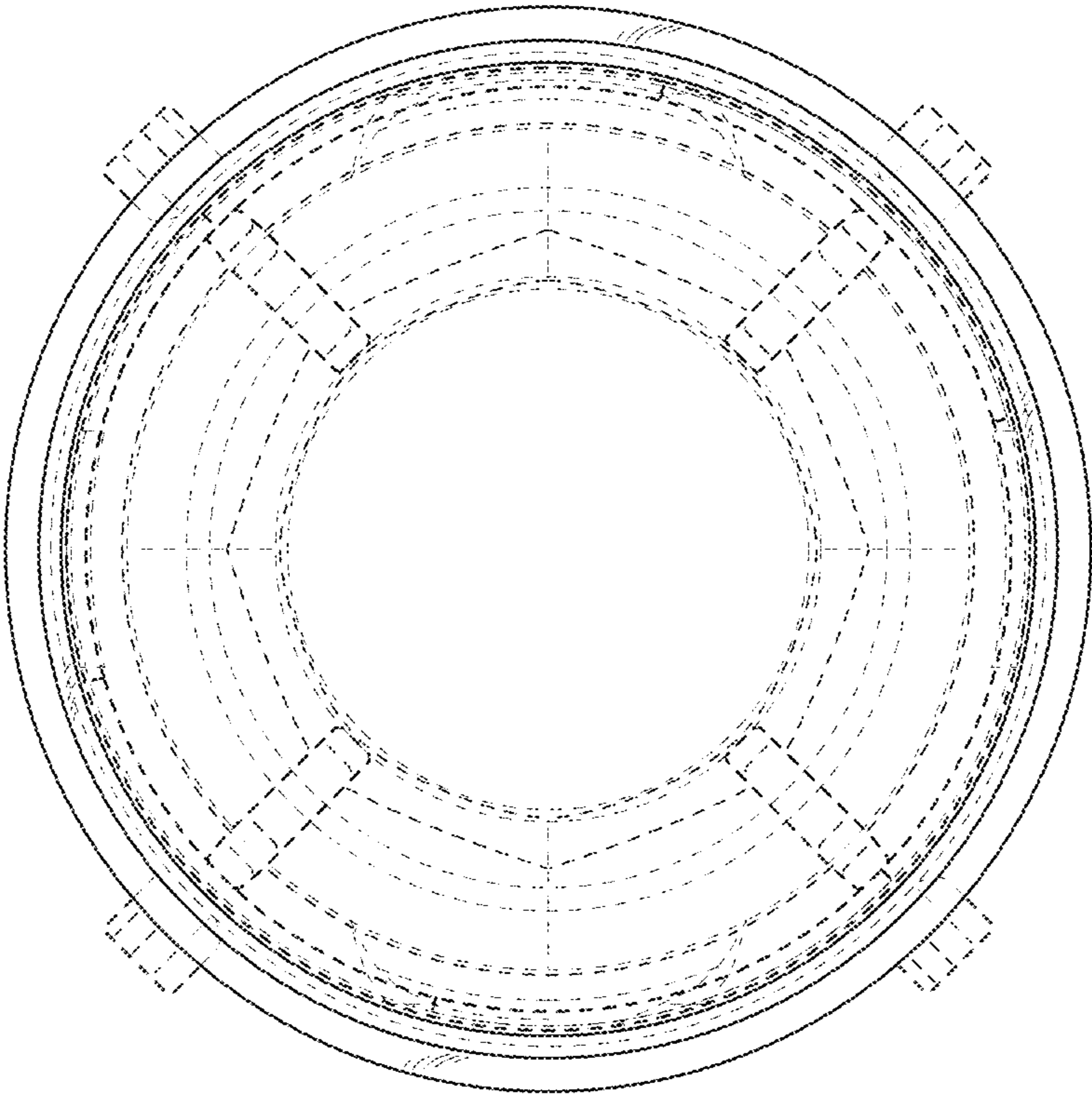

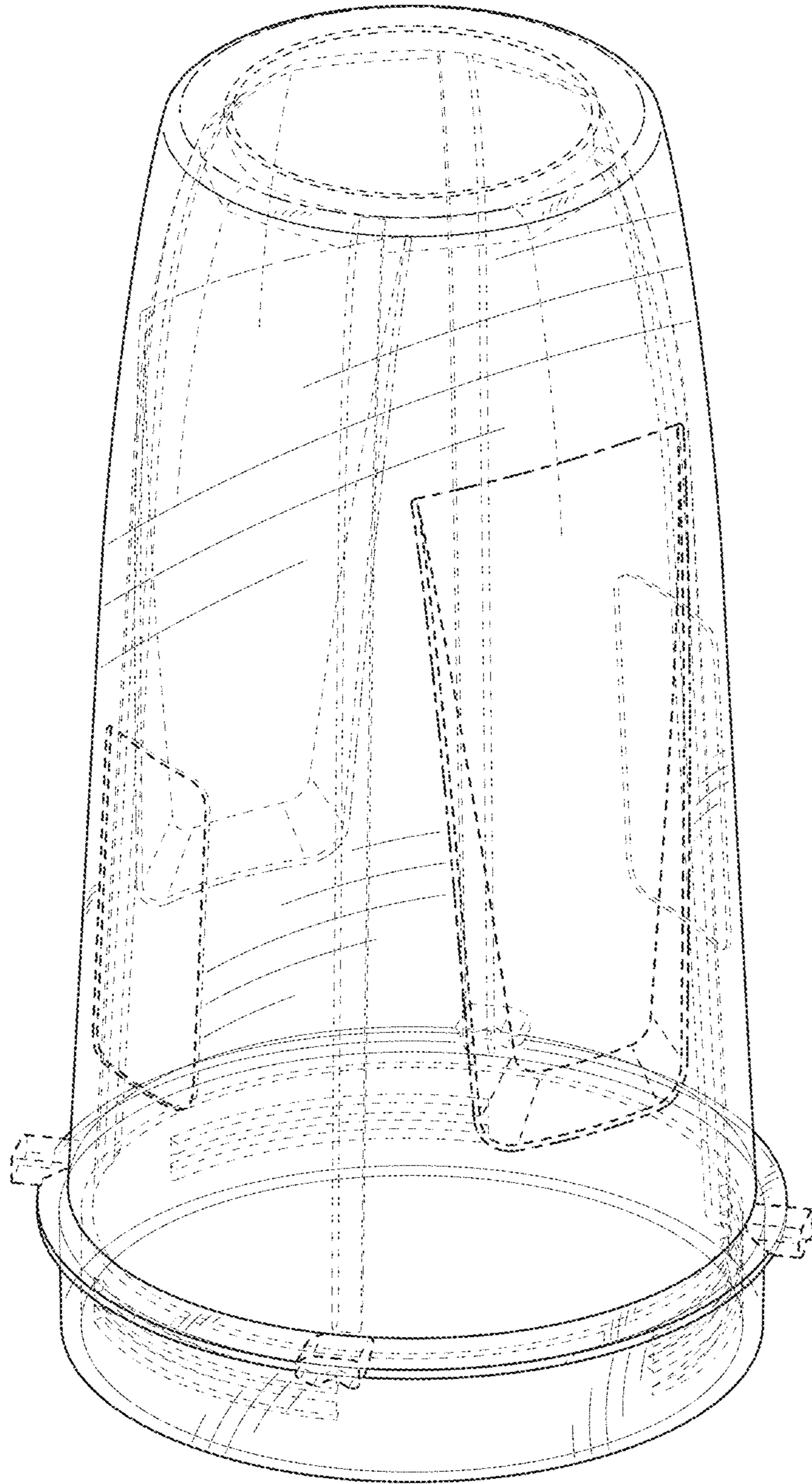

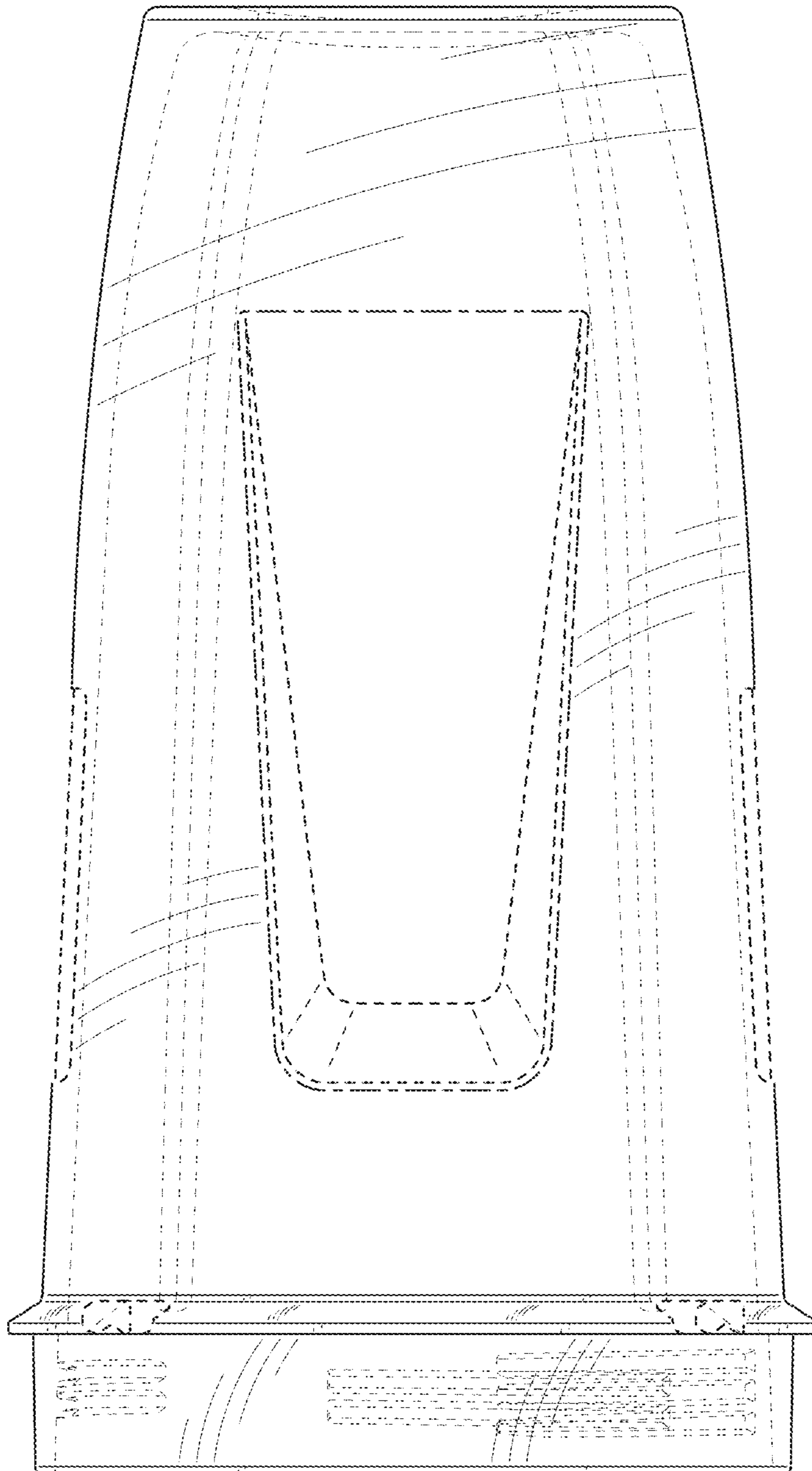

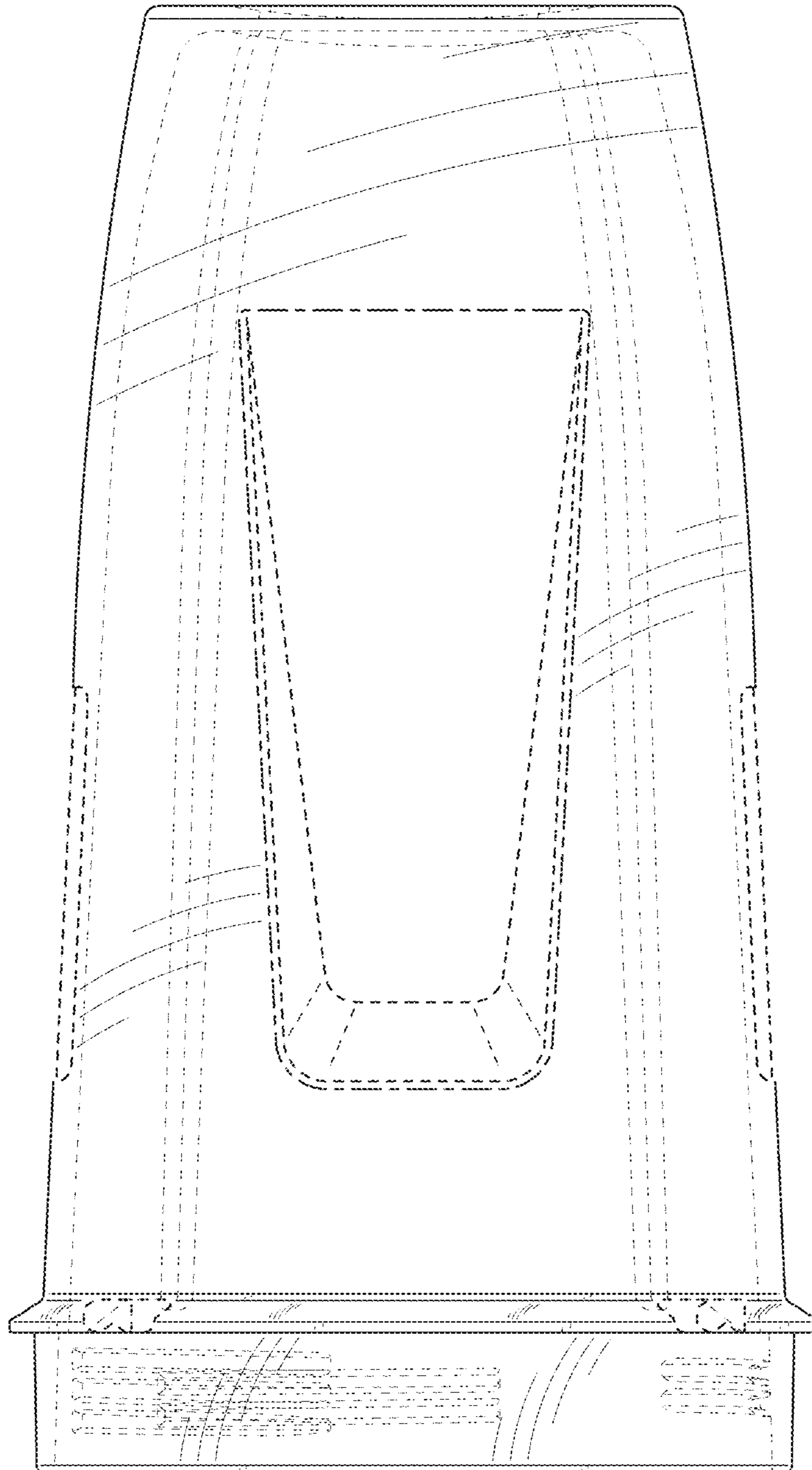

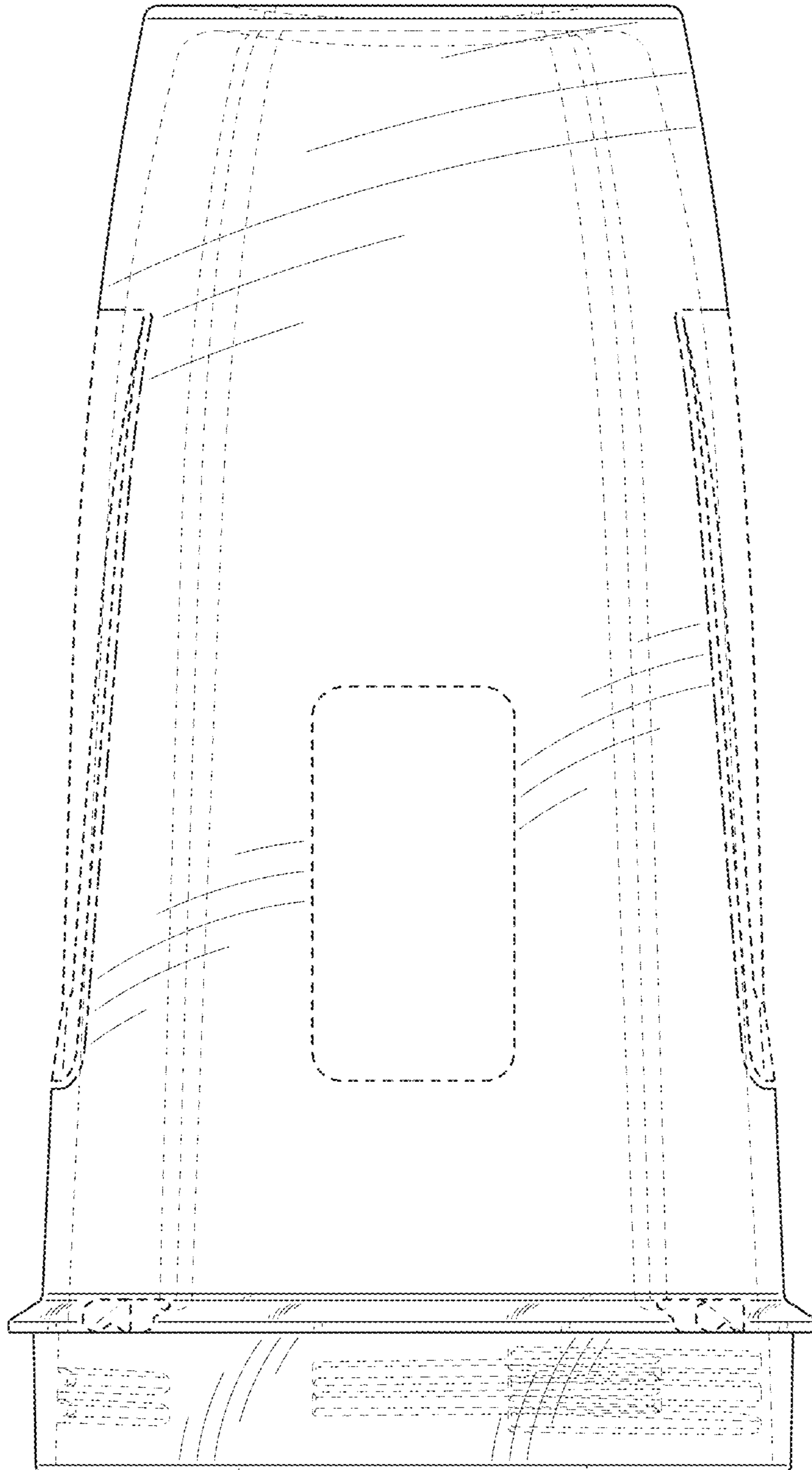

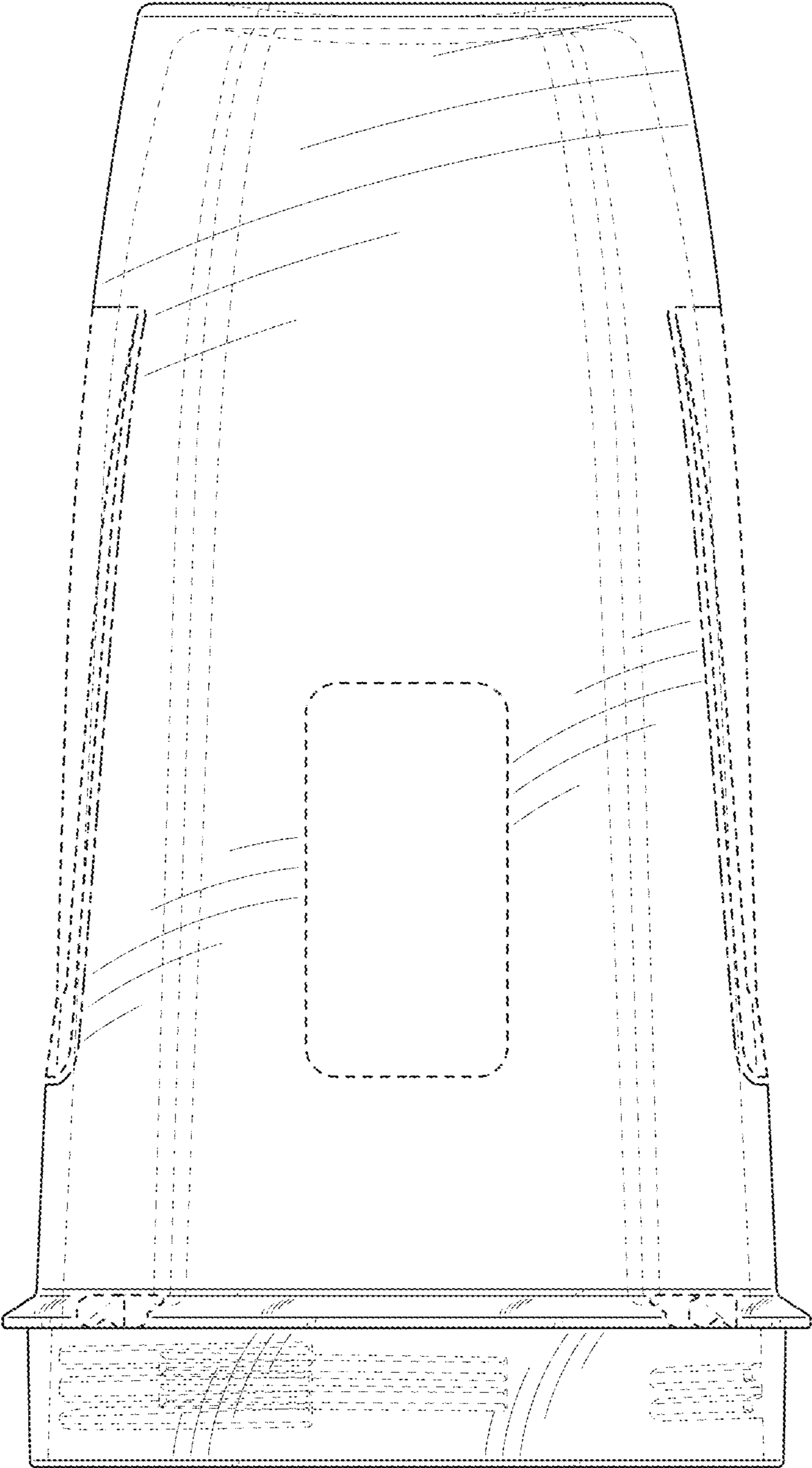

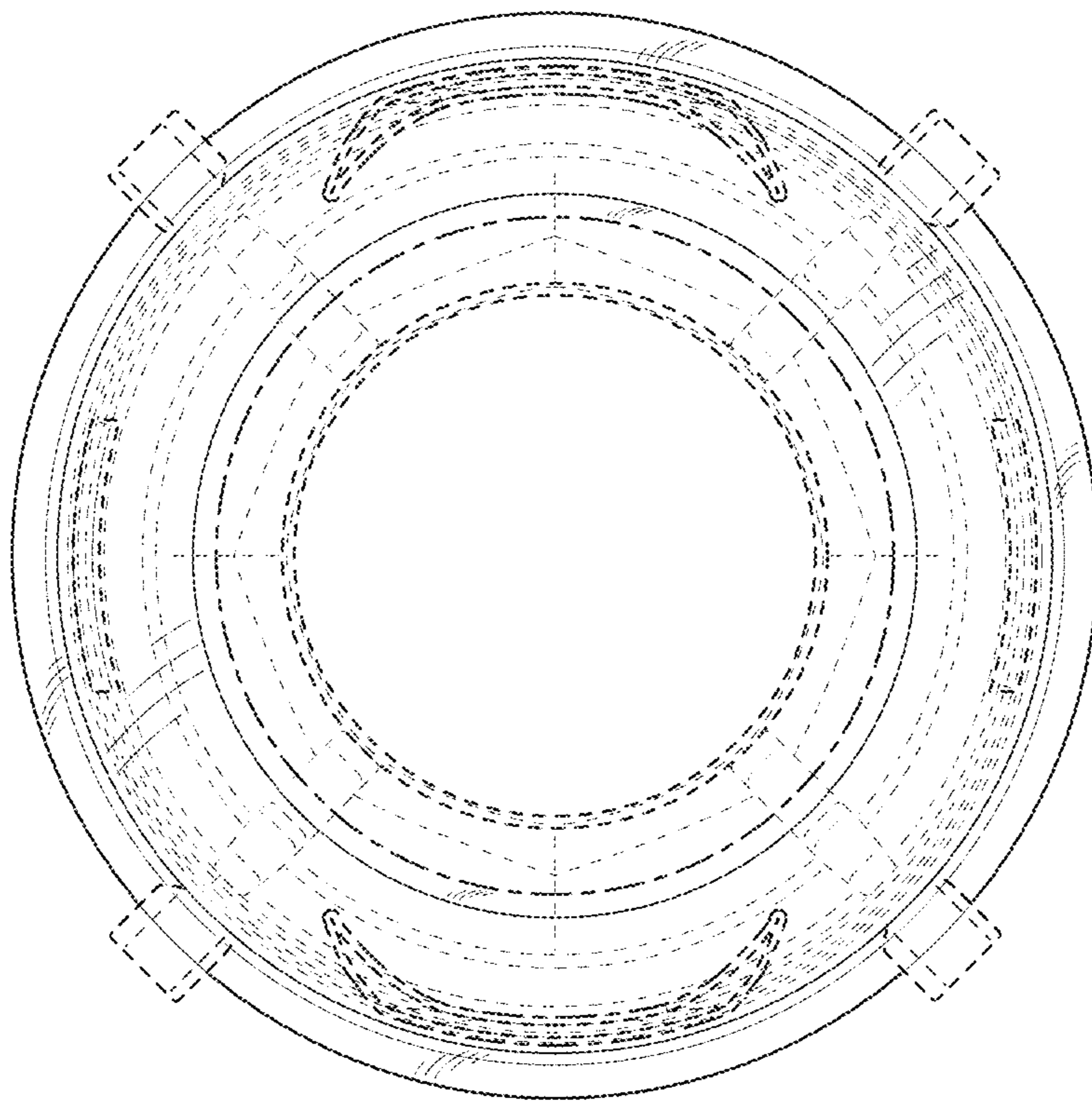

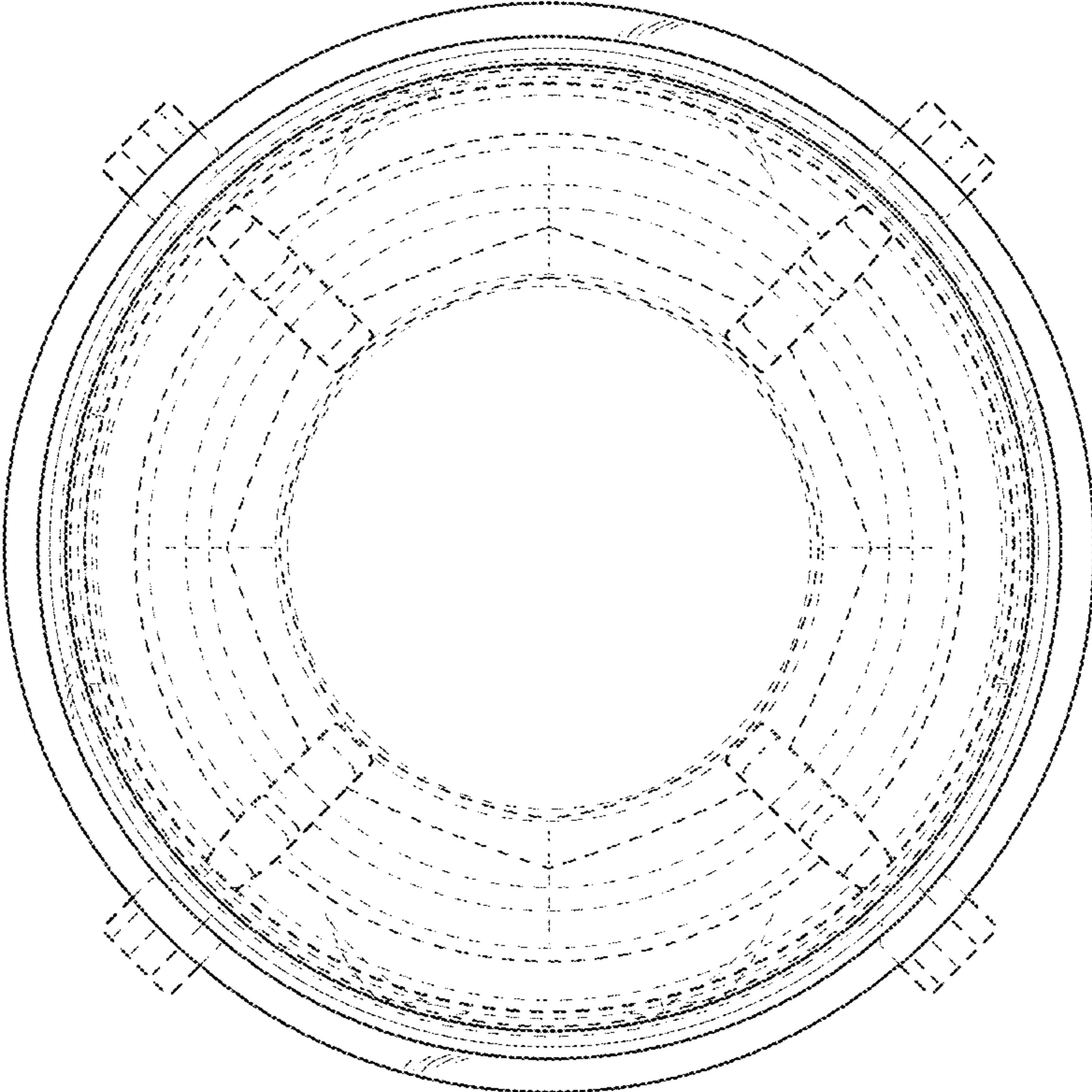

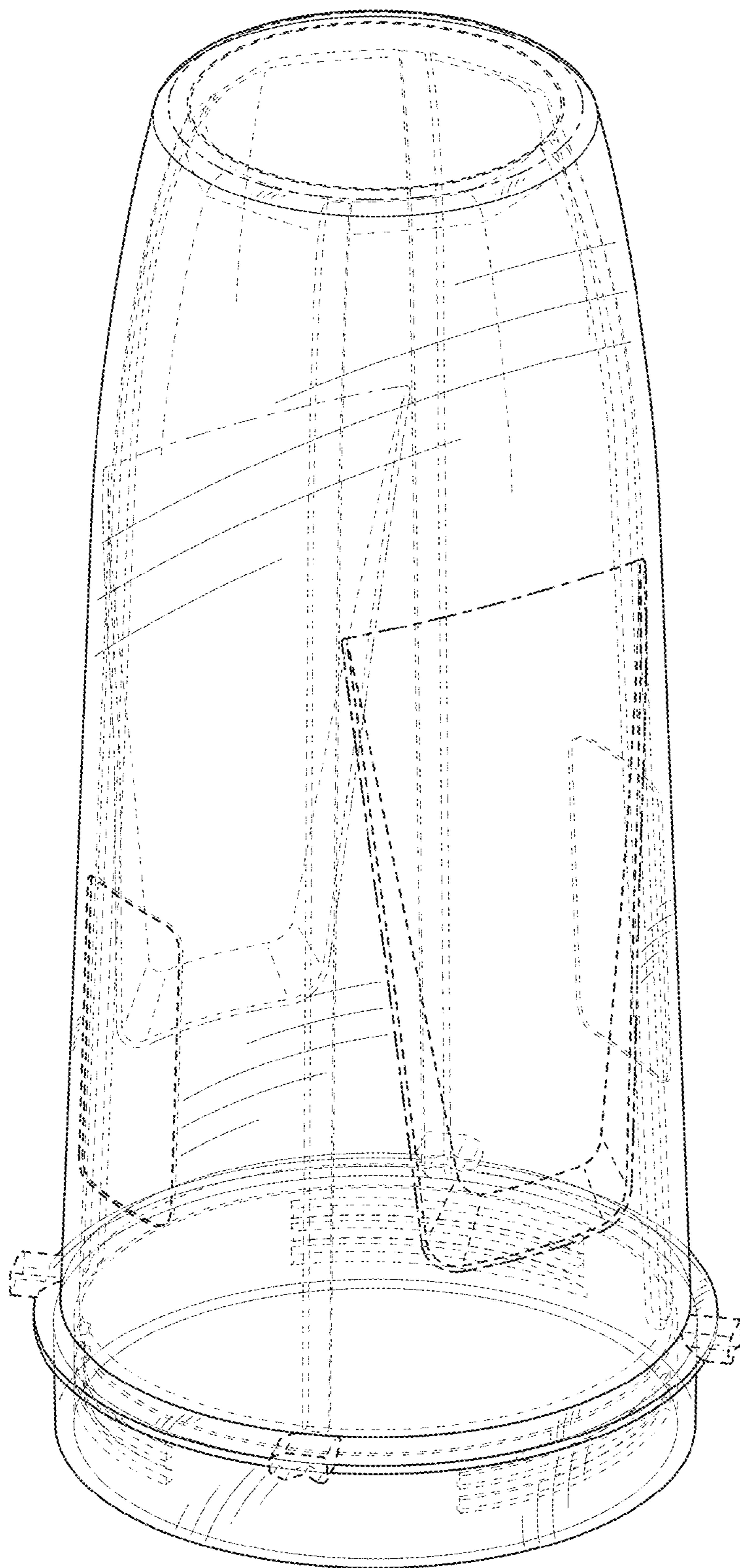

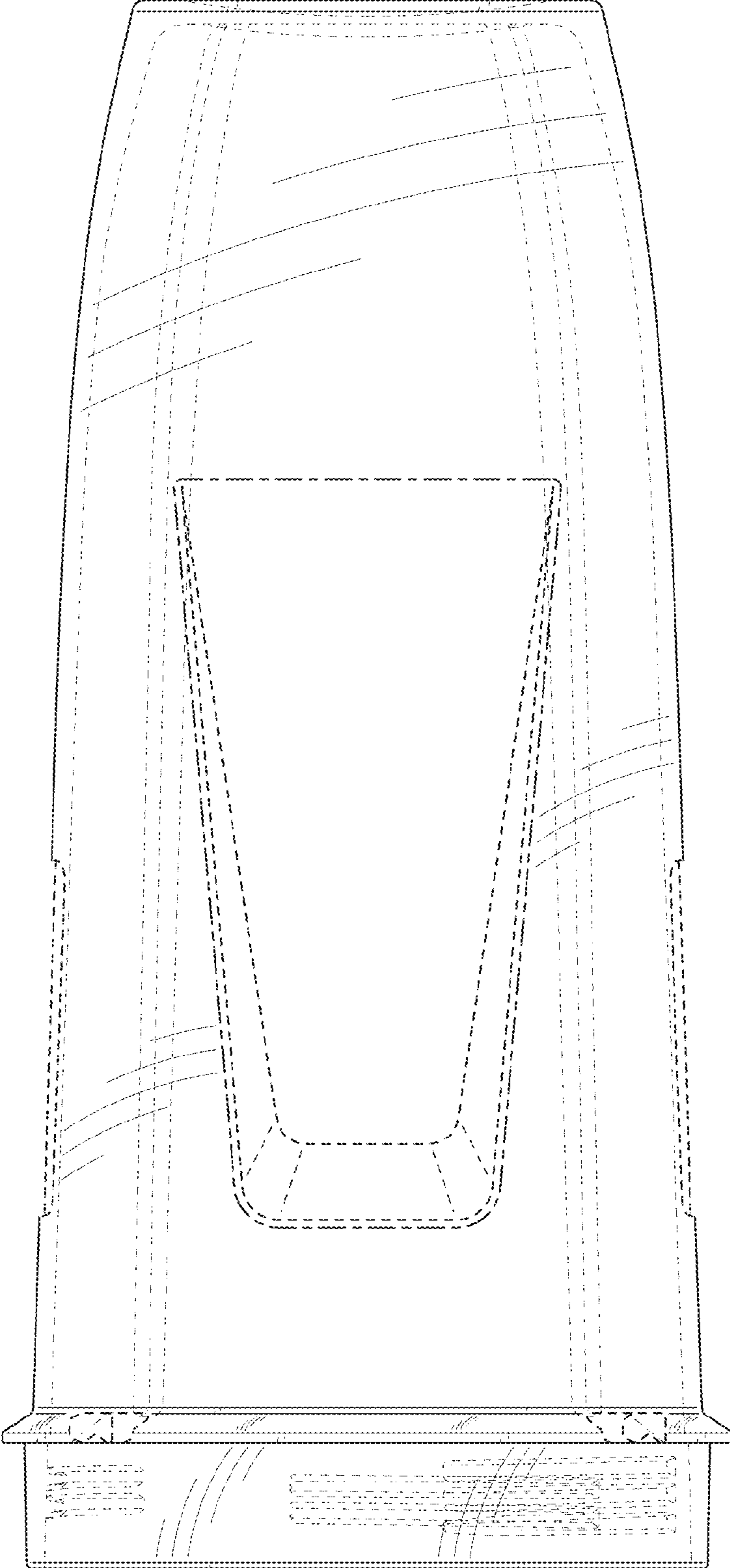

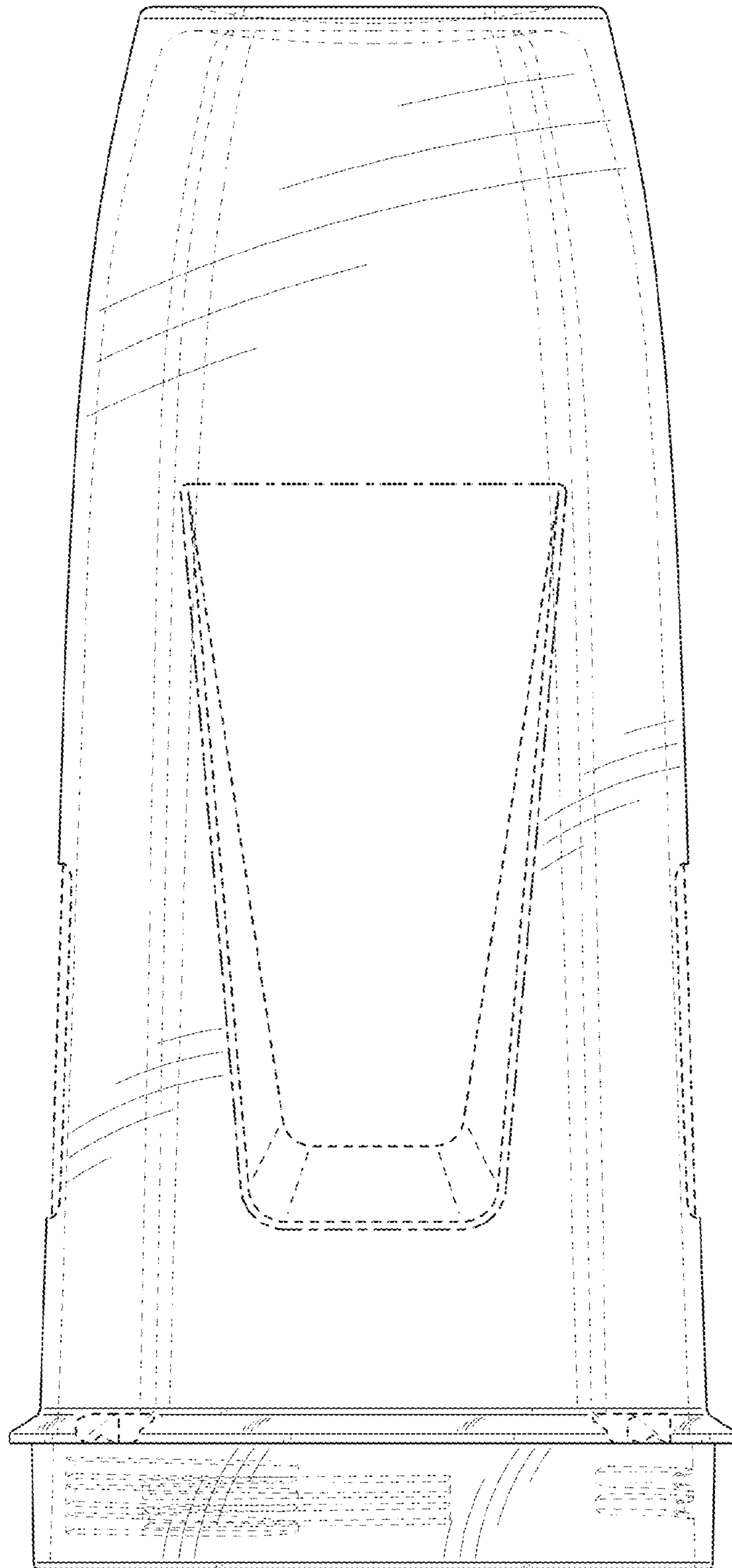

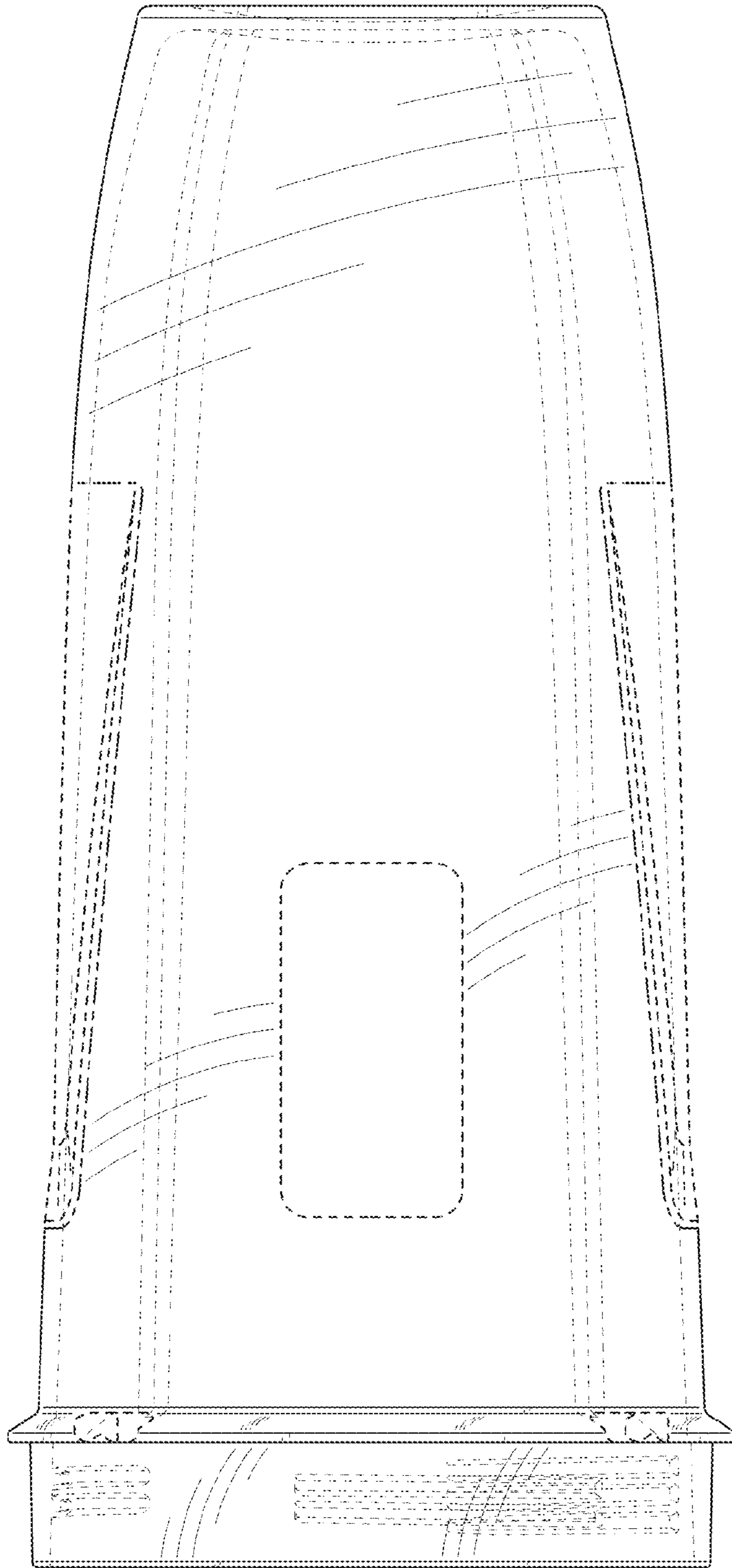

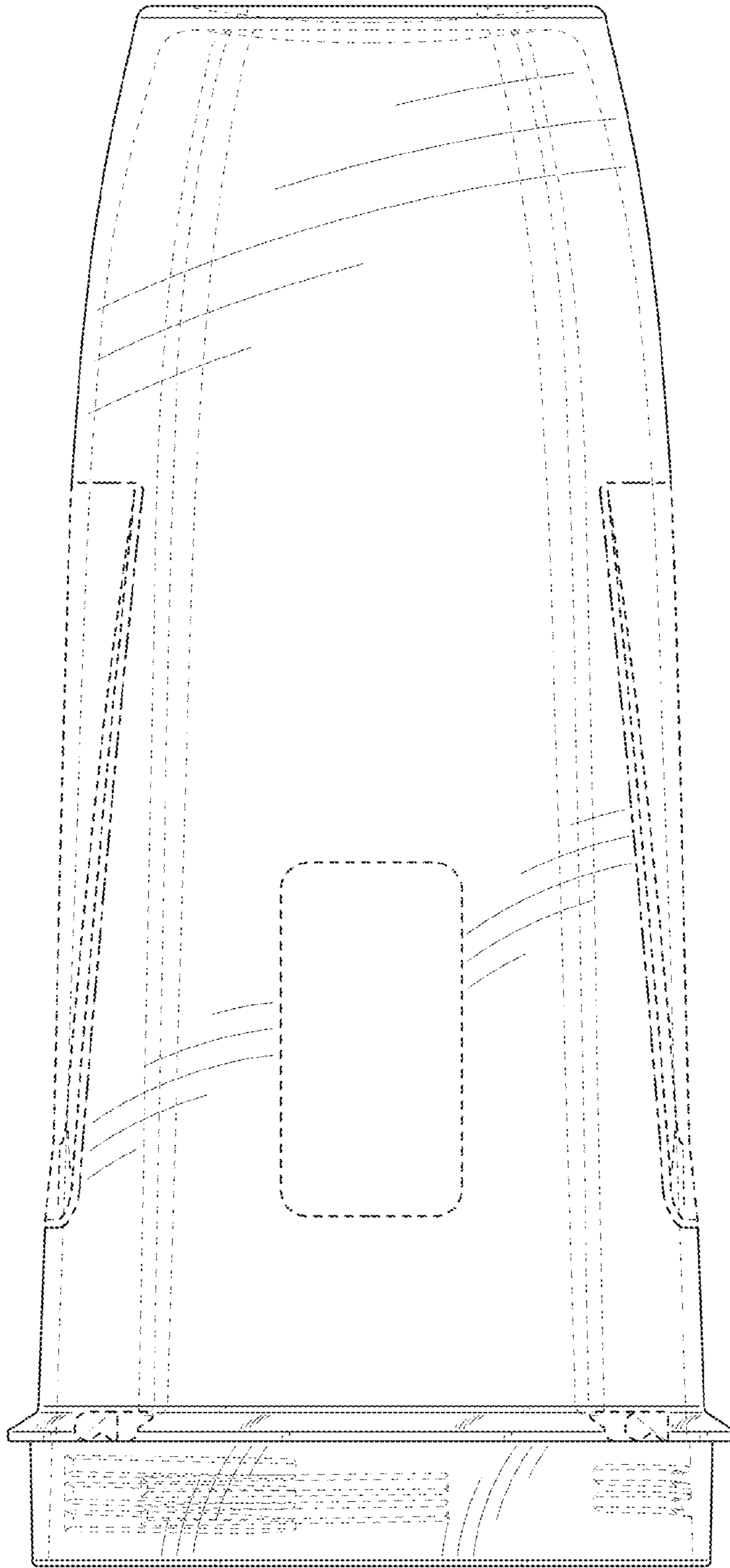

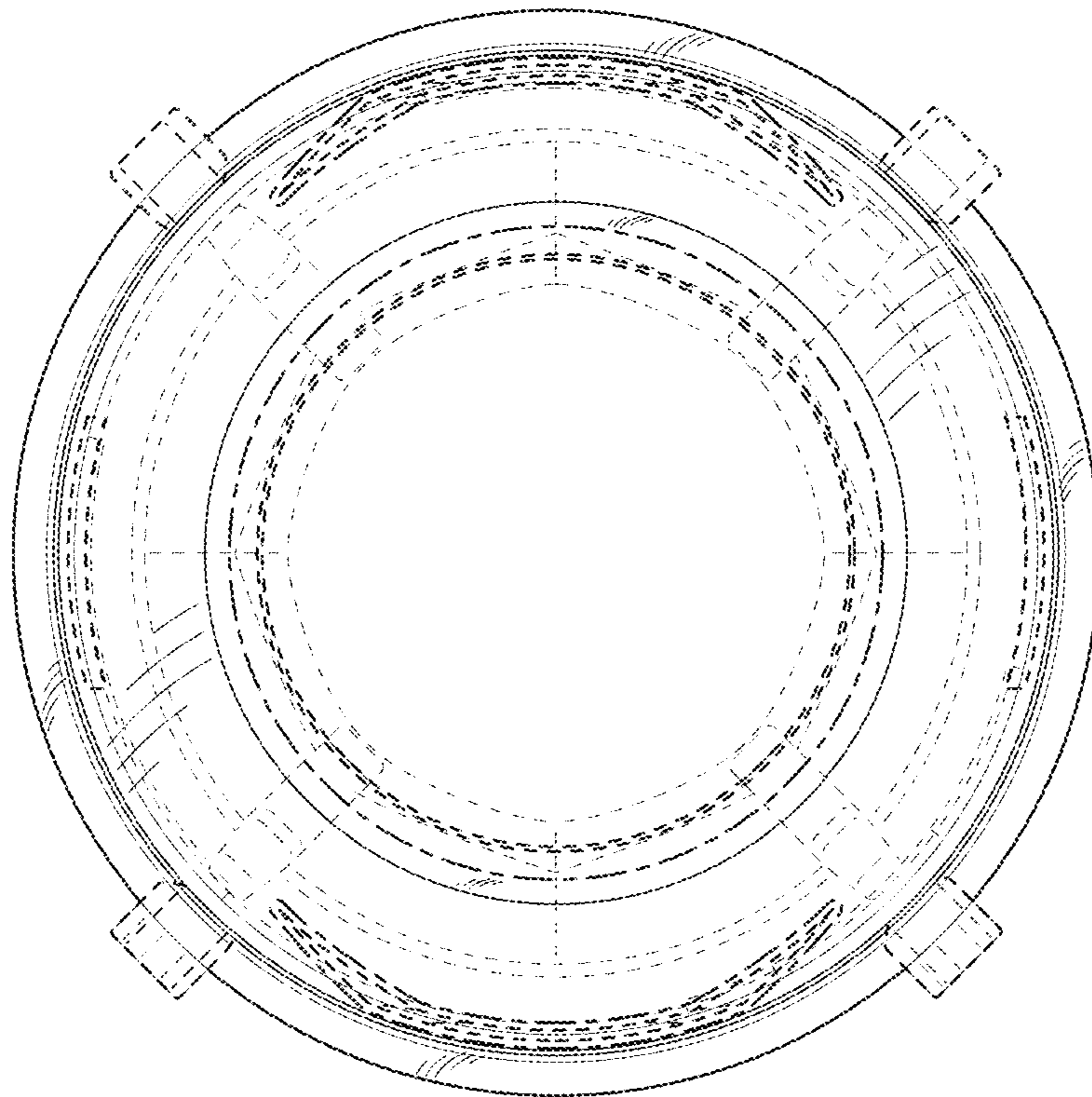

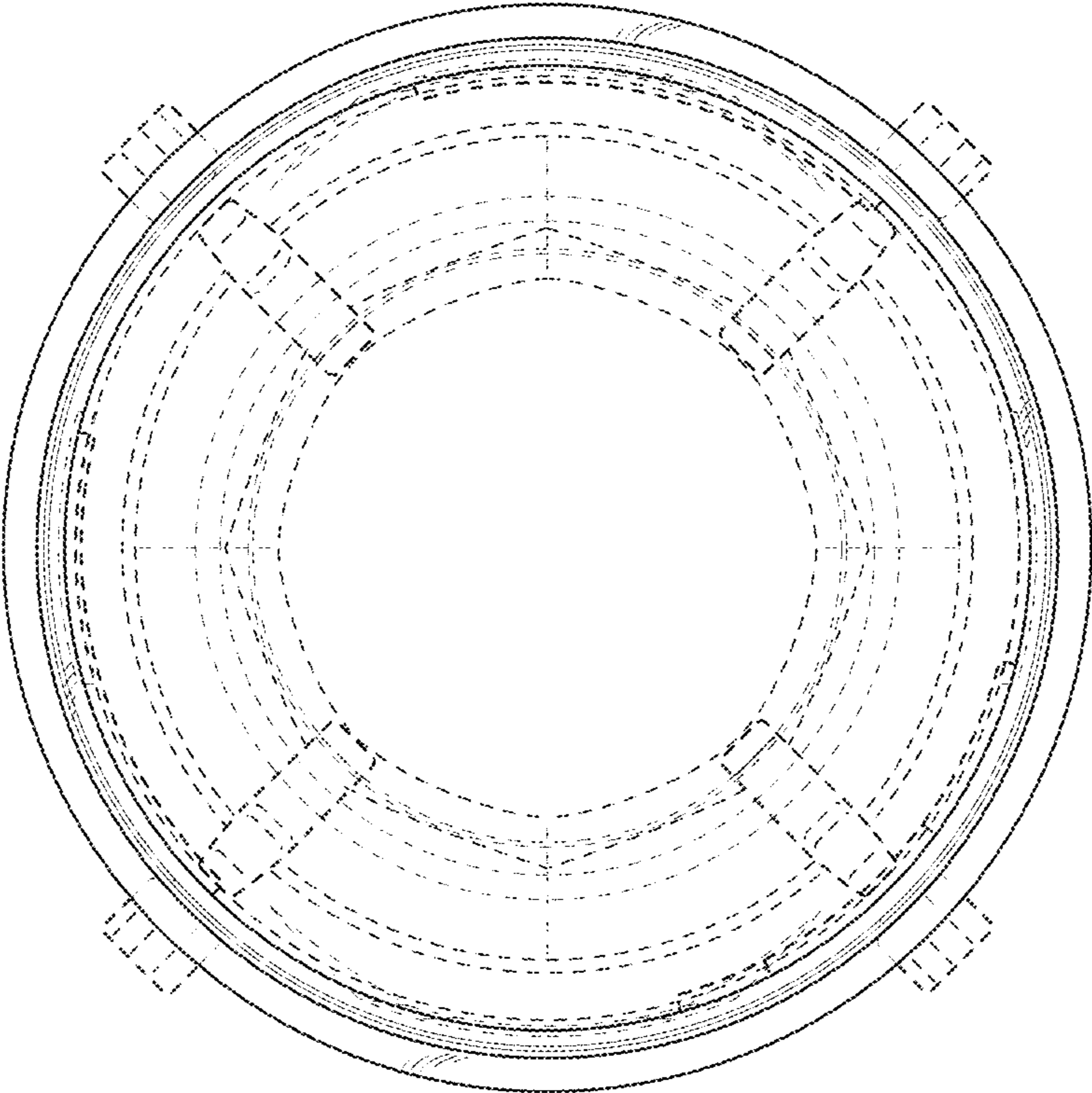
