**DESCRIPTION**

FIG. 1 is a perspective view showing a first embodiment of the applicator;

FIG. 11 is a plan view of a third side of the applicator of FIG. 8;

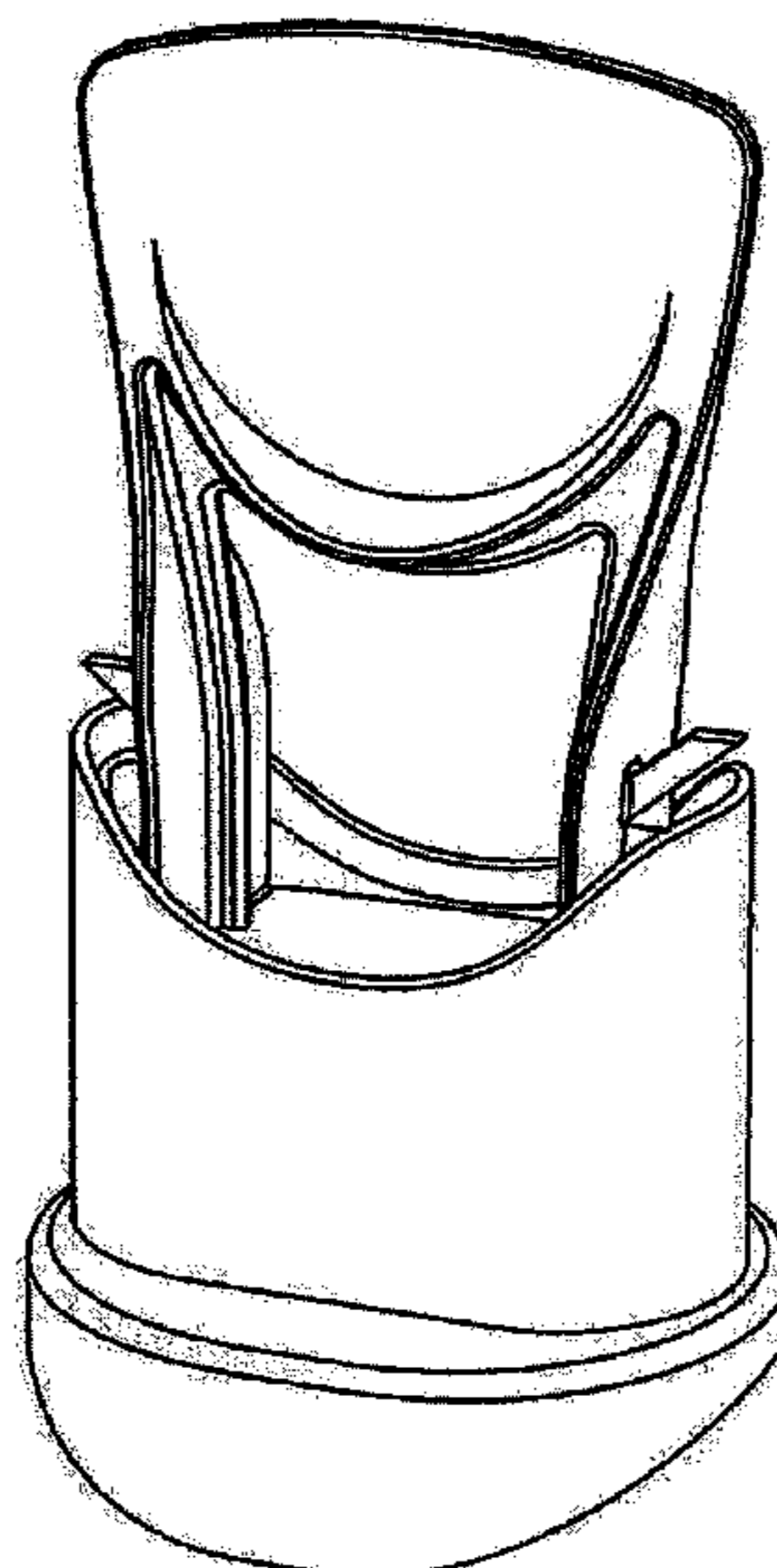
FIG. 12 is a plan view of fourth side of the applicator of FIG. 8;

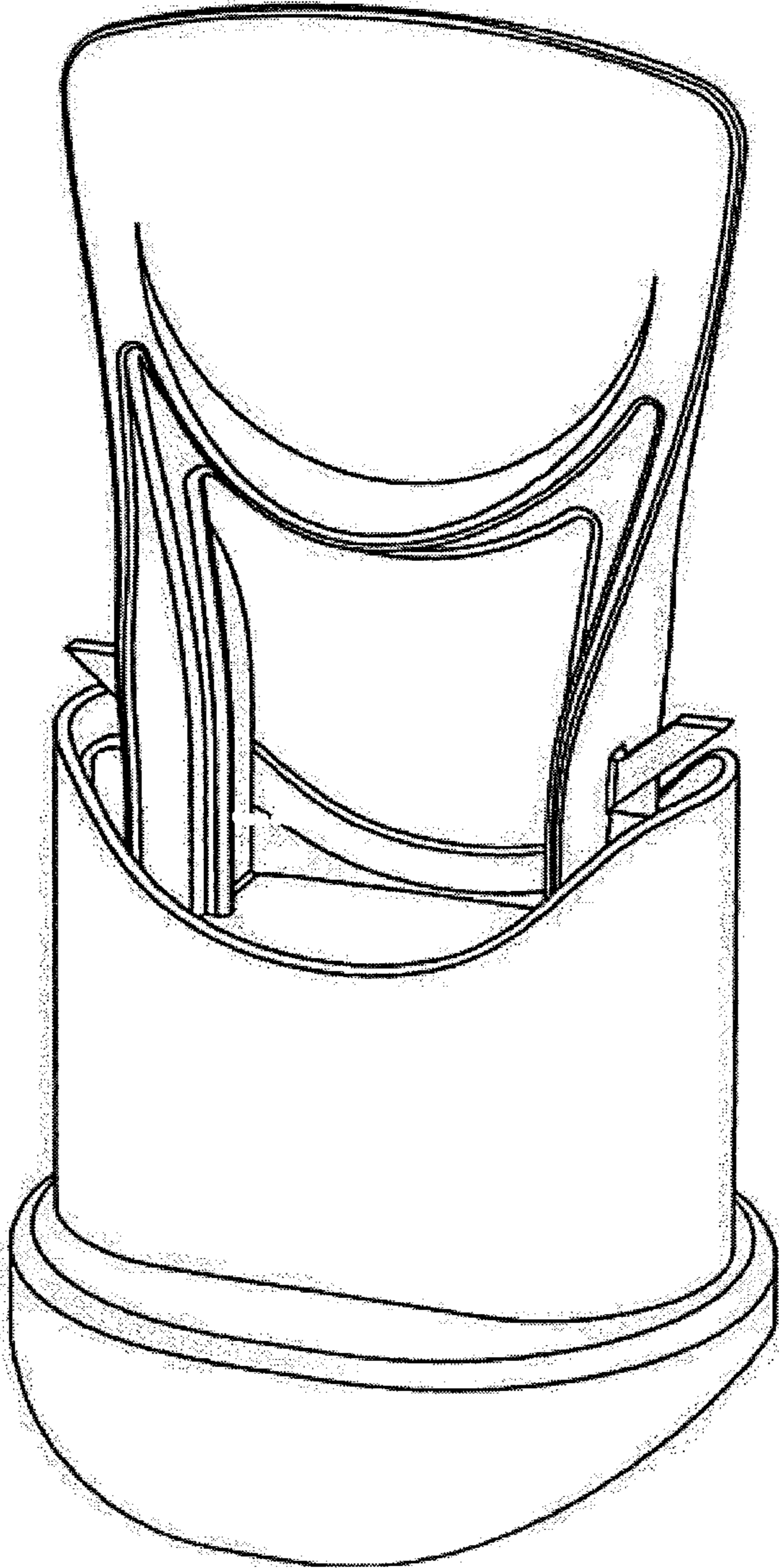

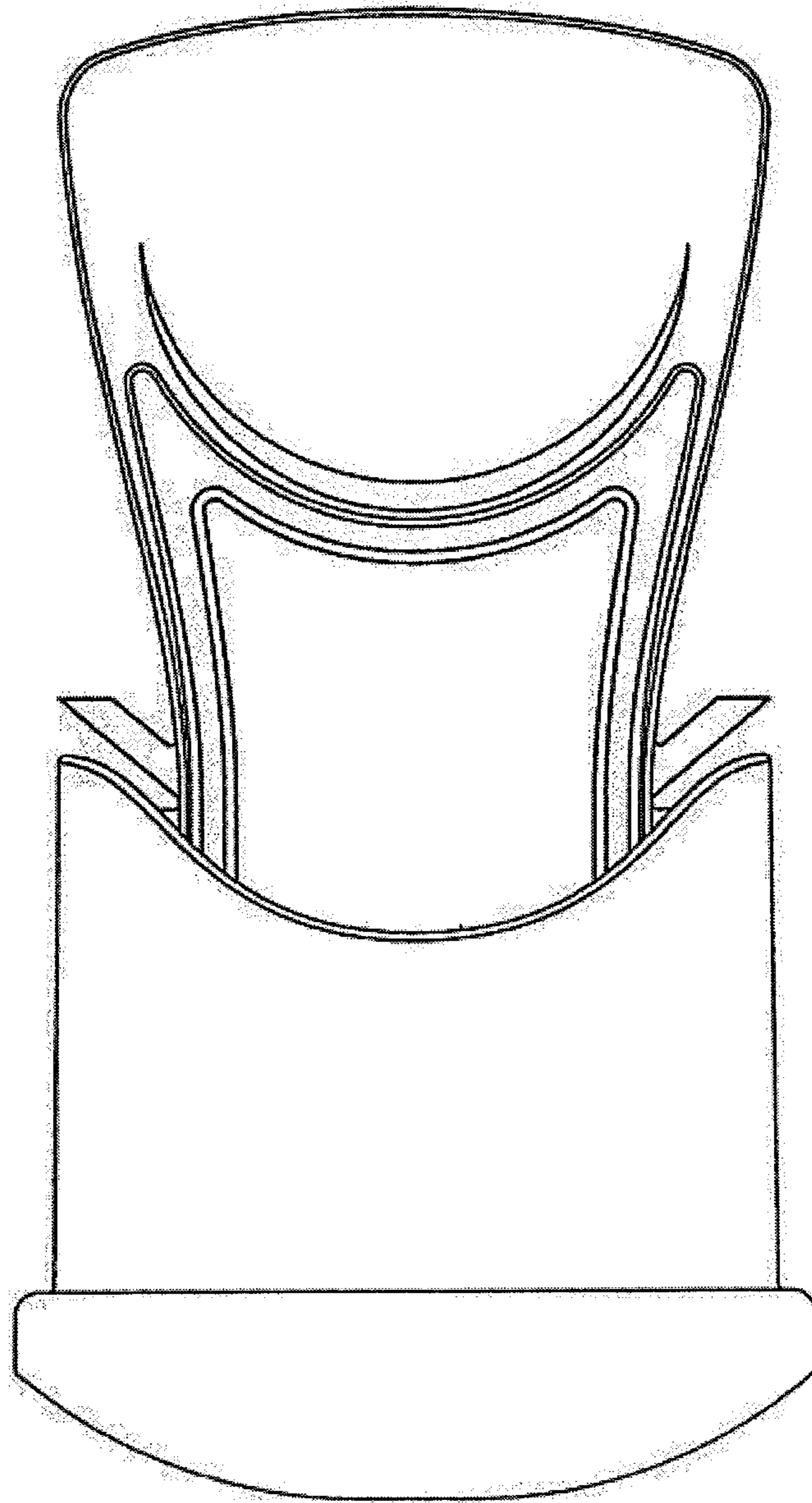

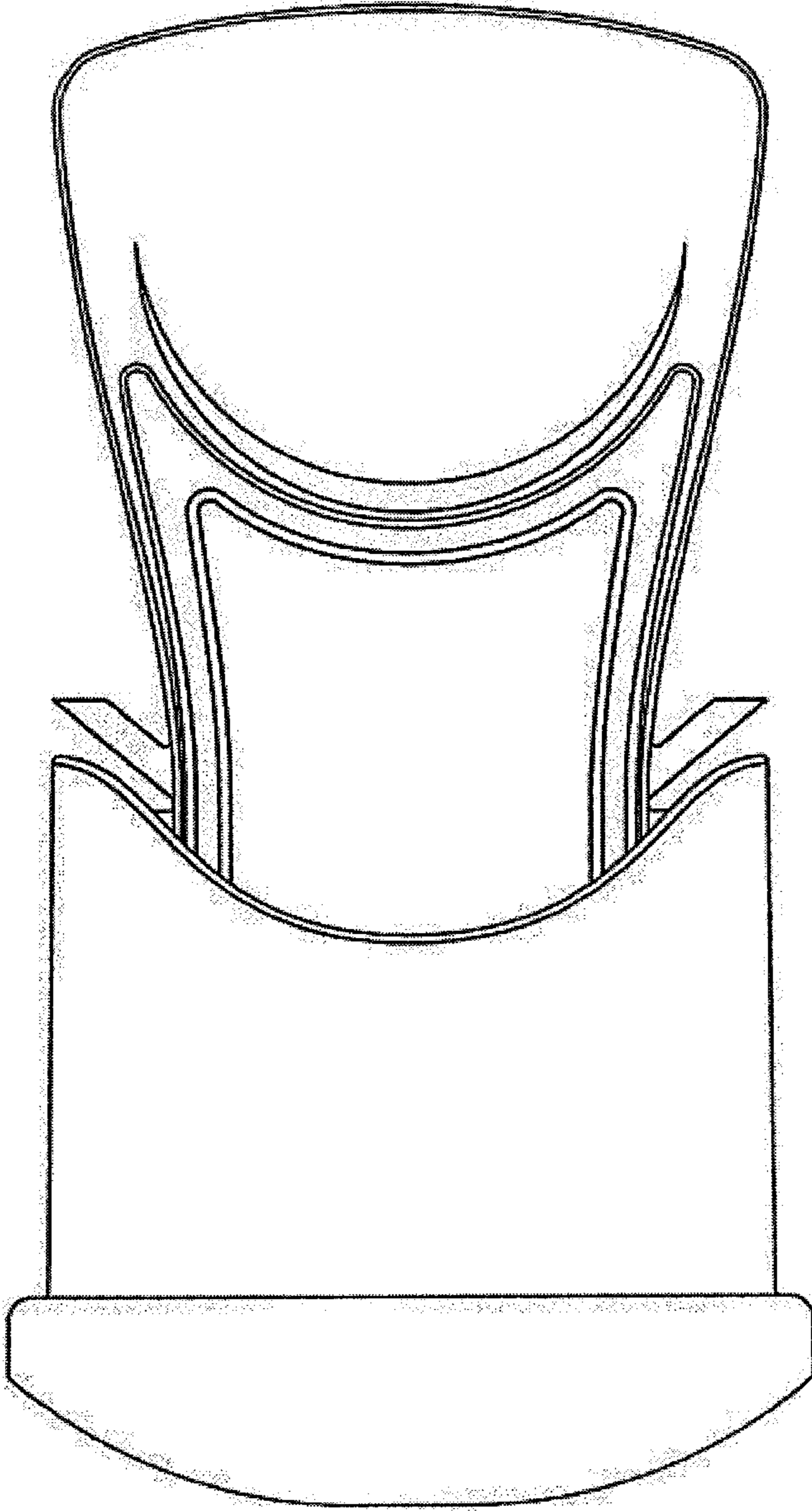

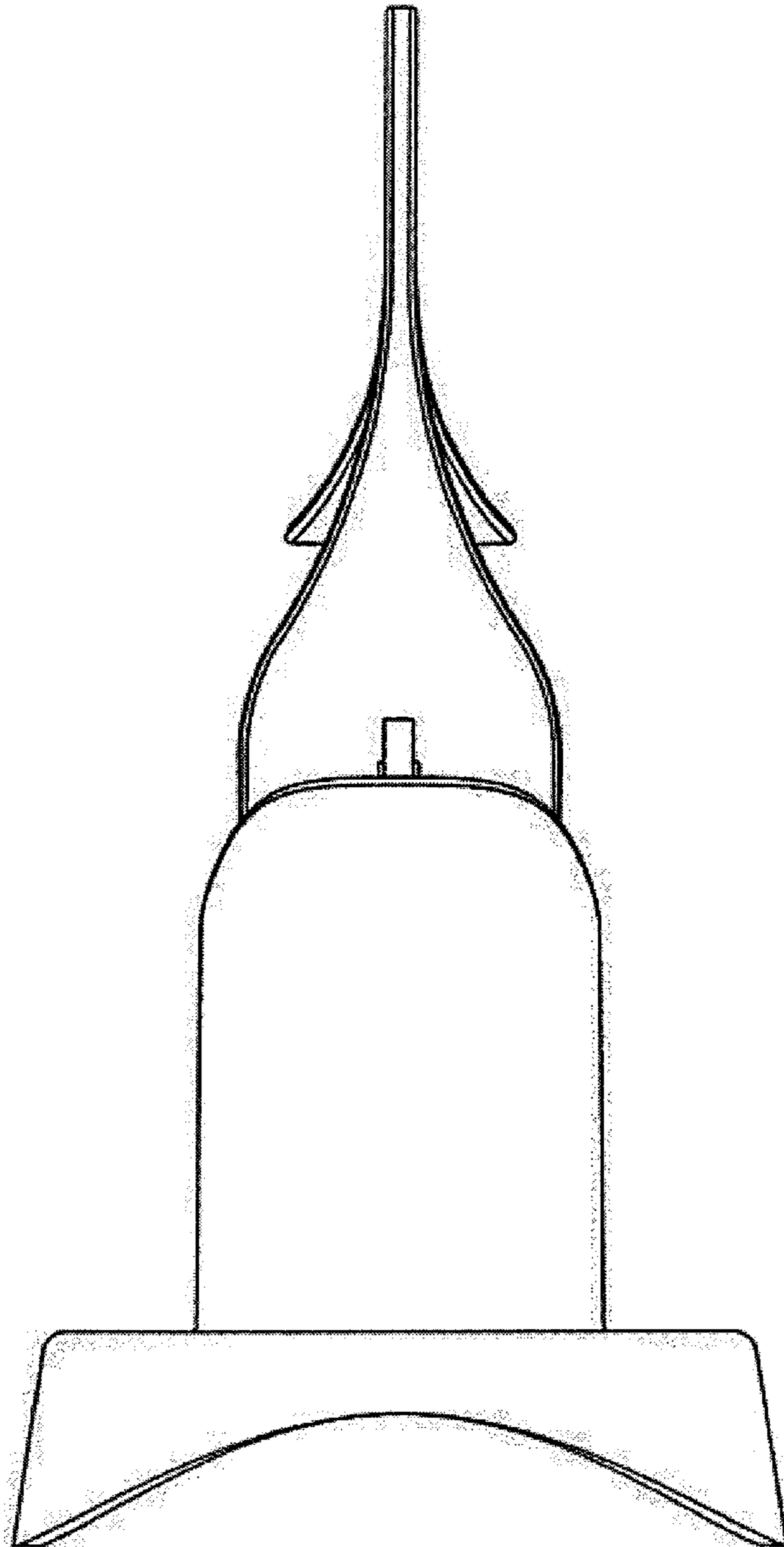
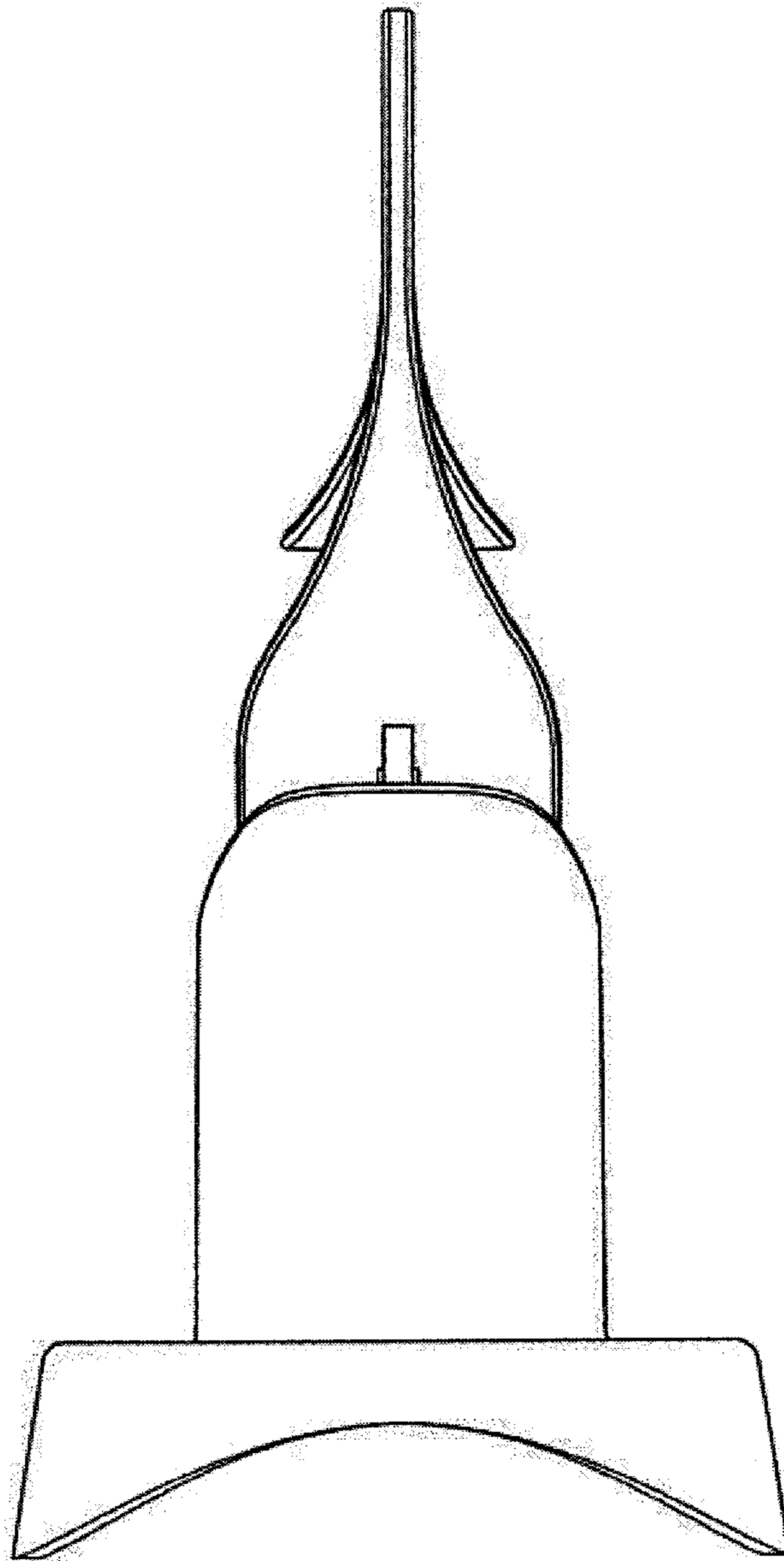

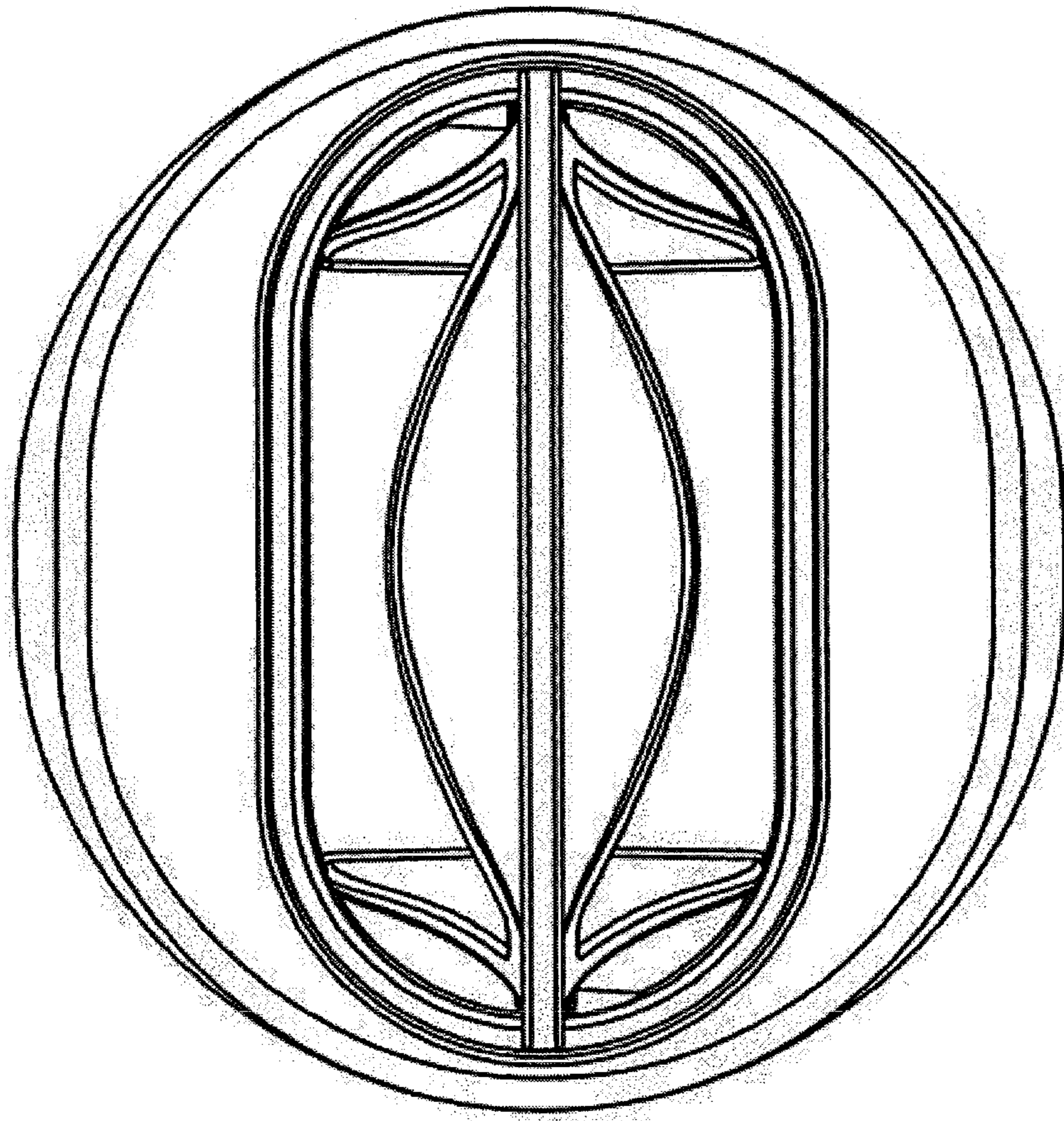
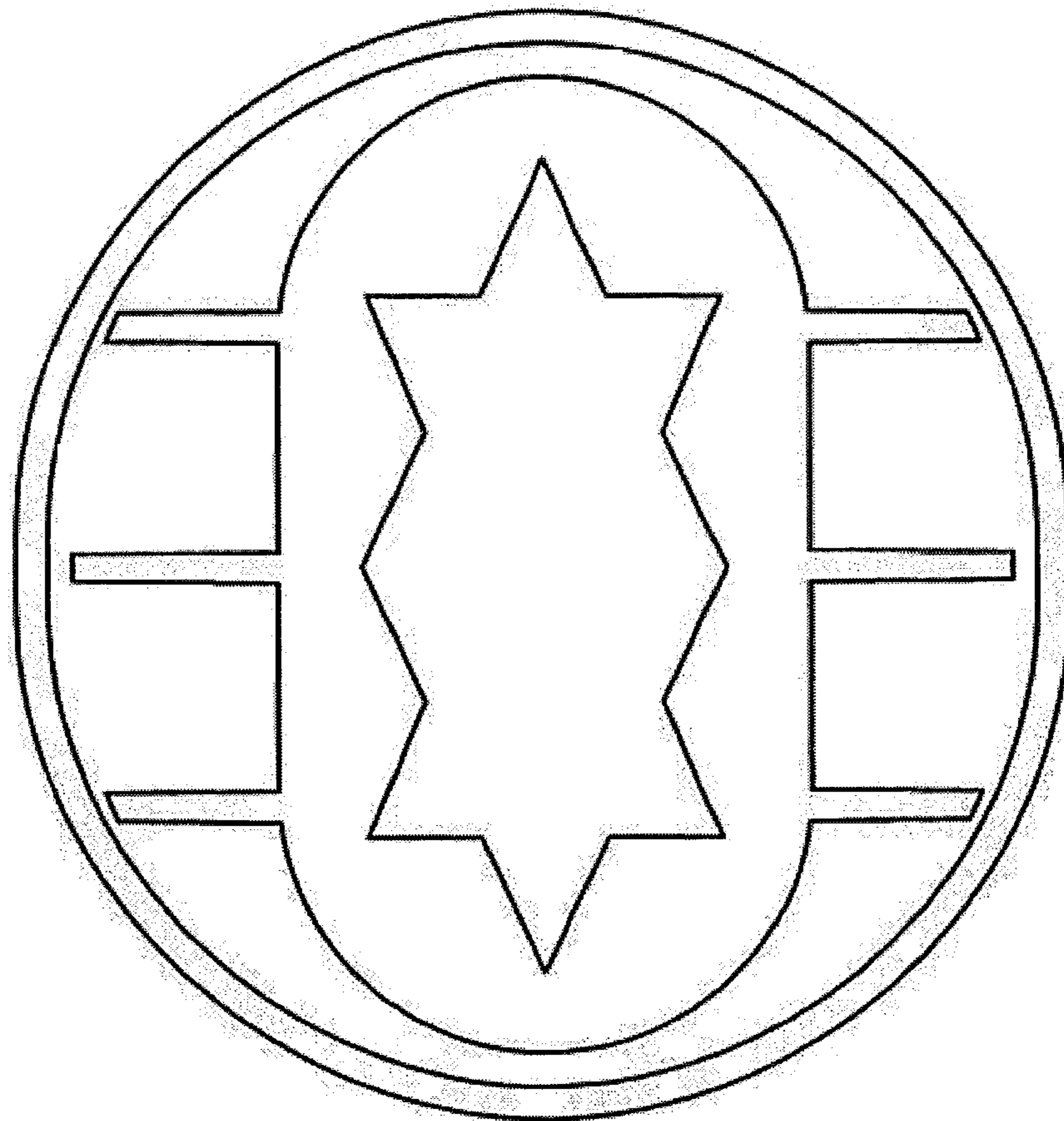

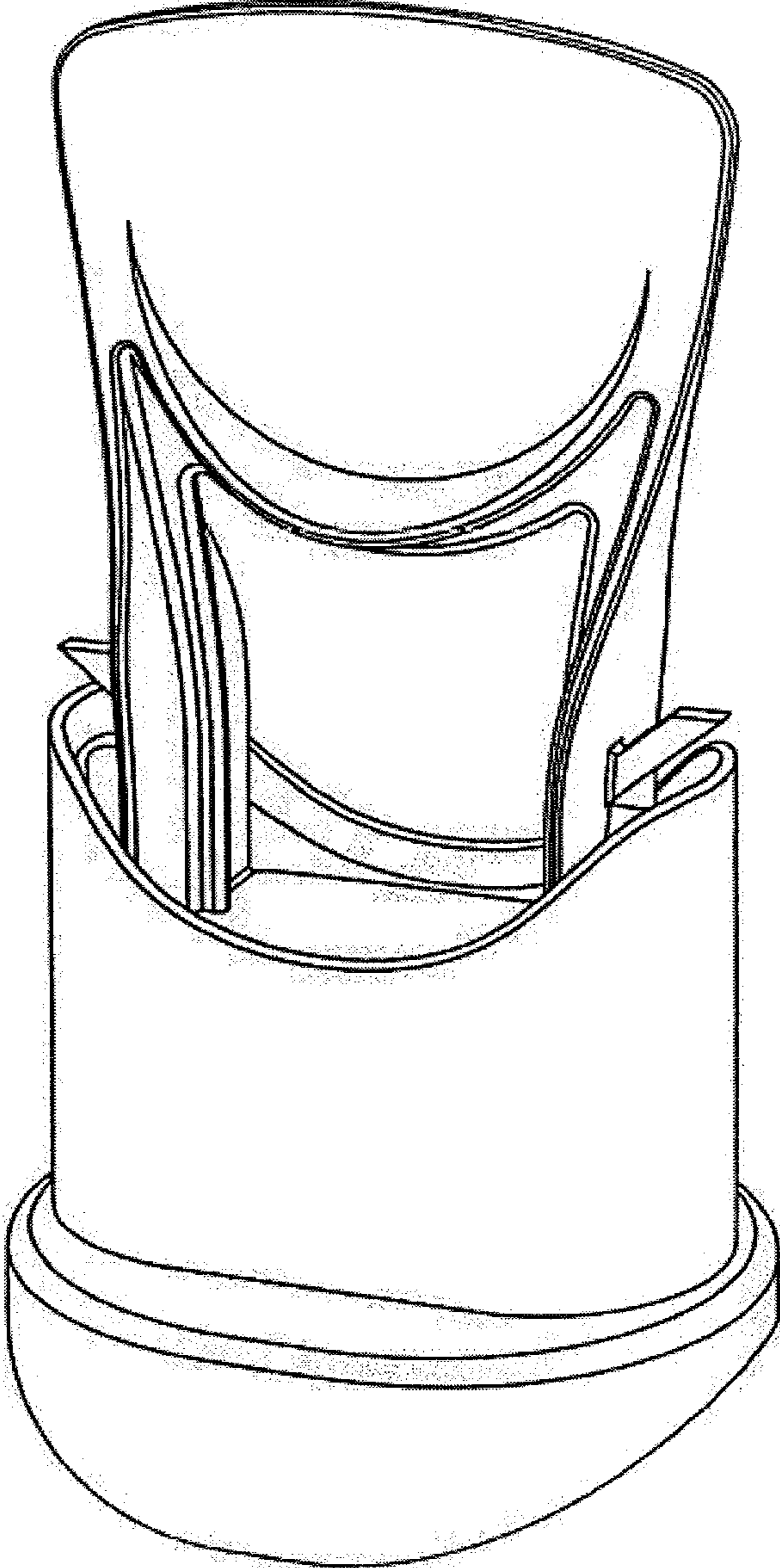

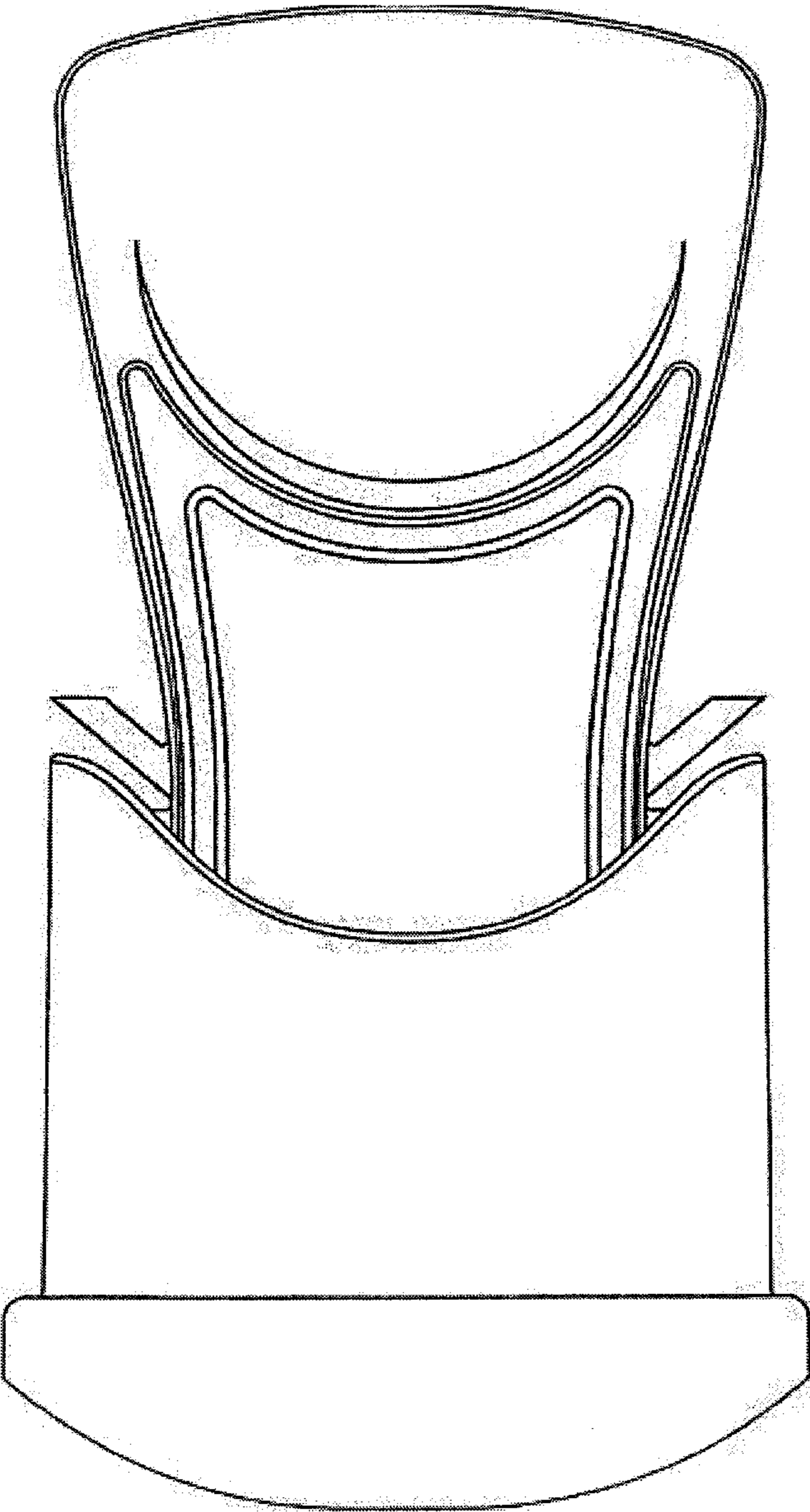

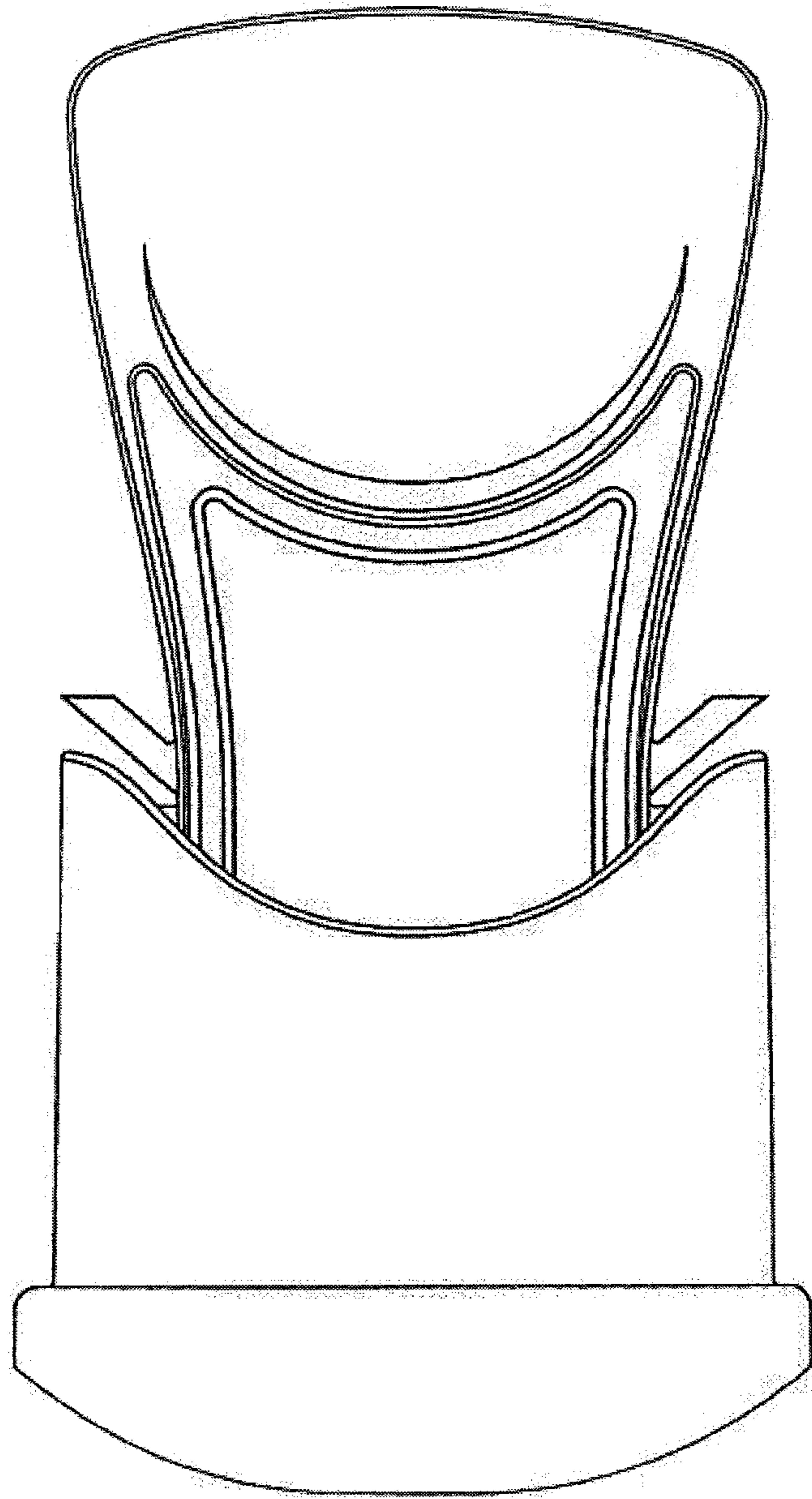
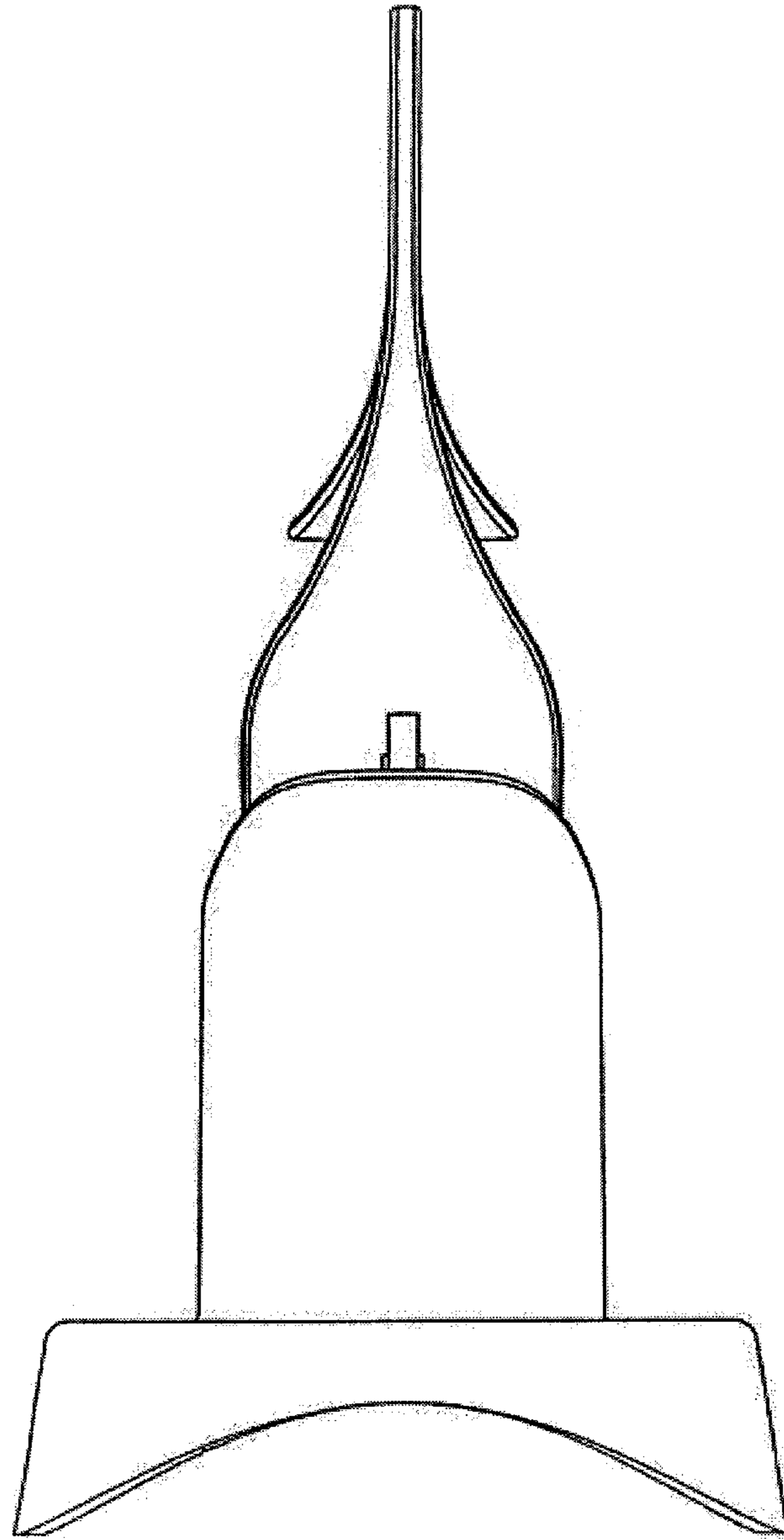
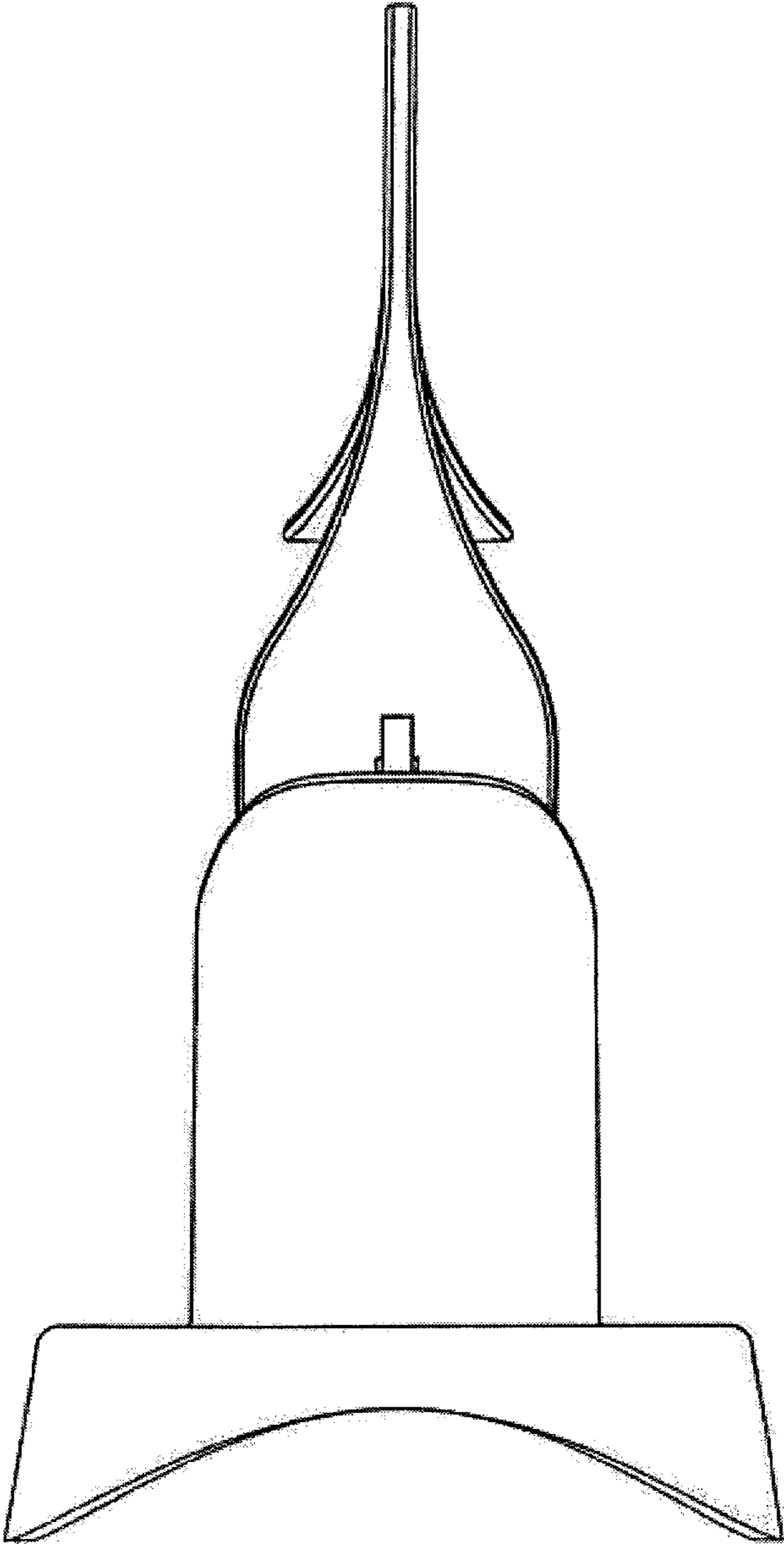

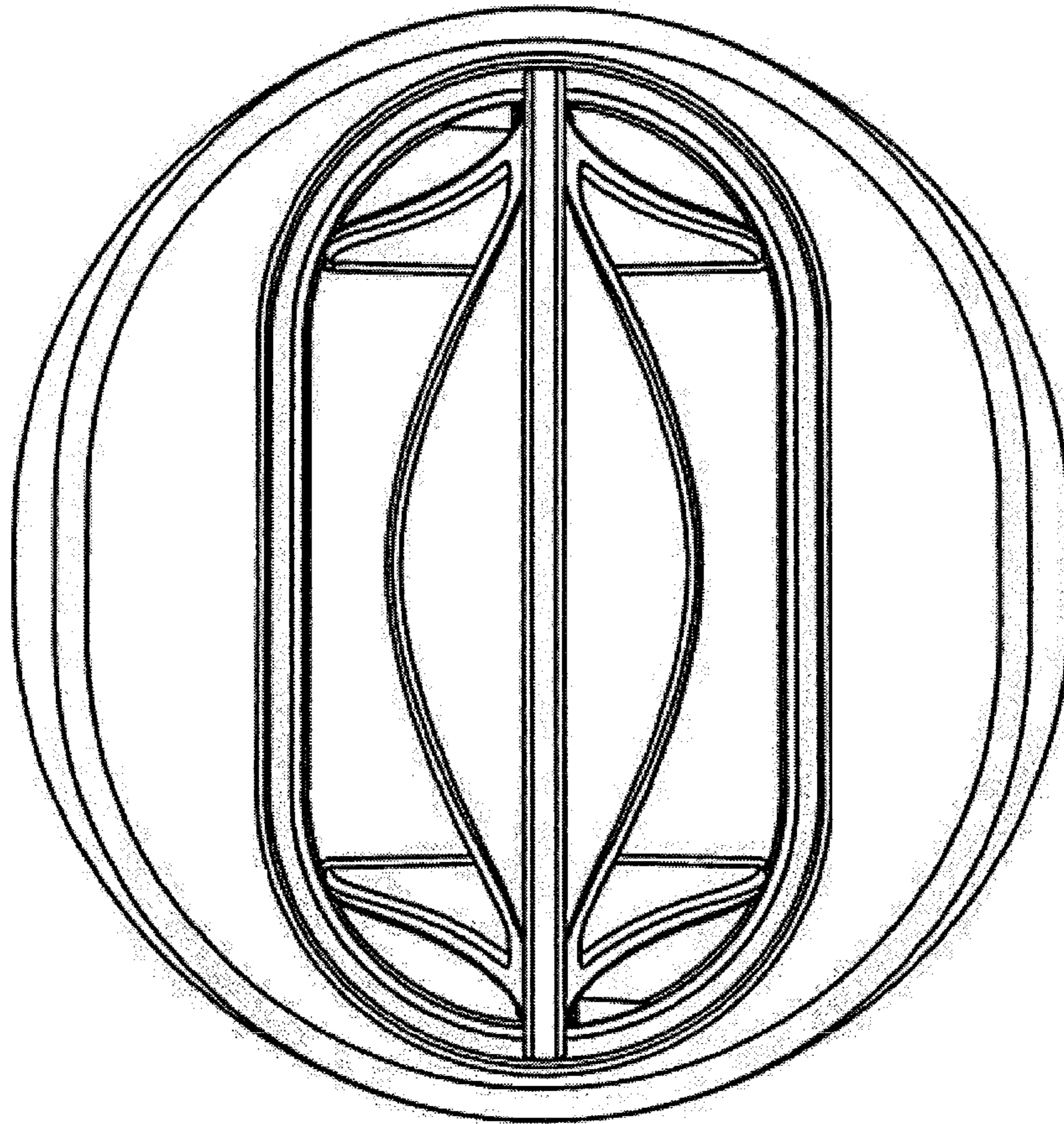

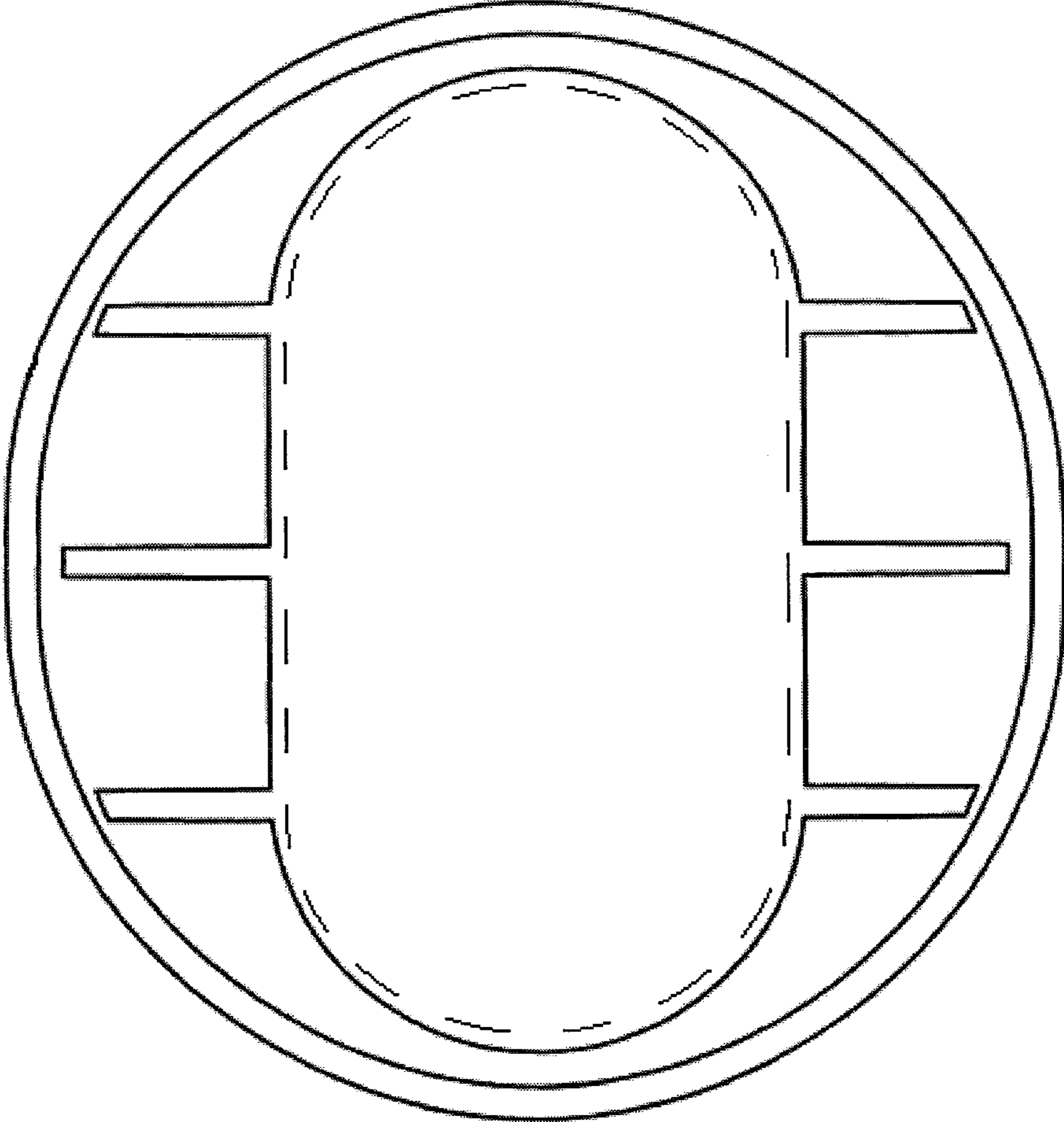
