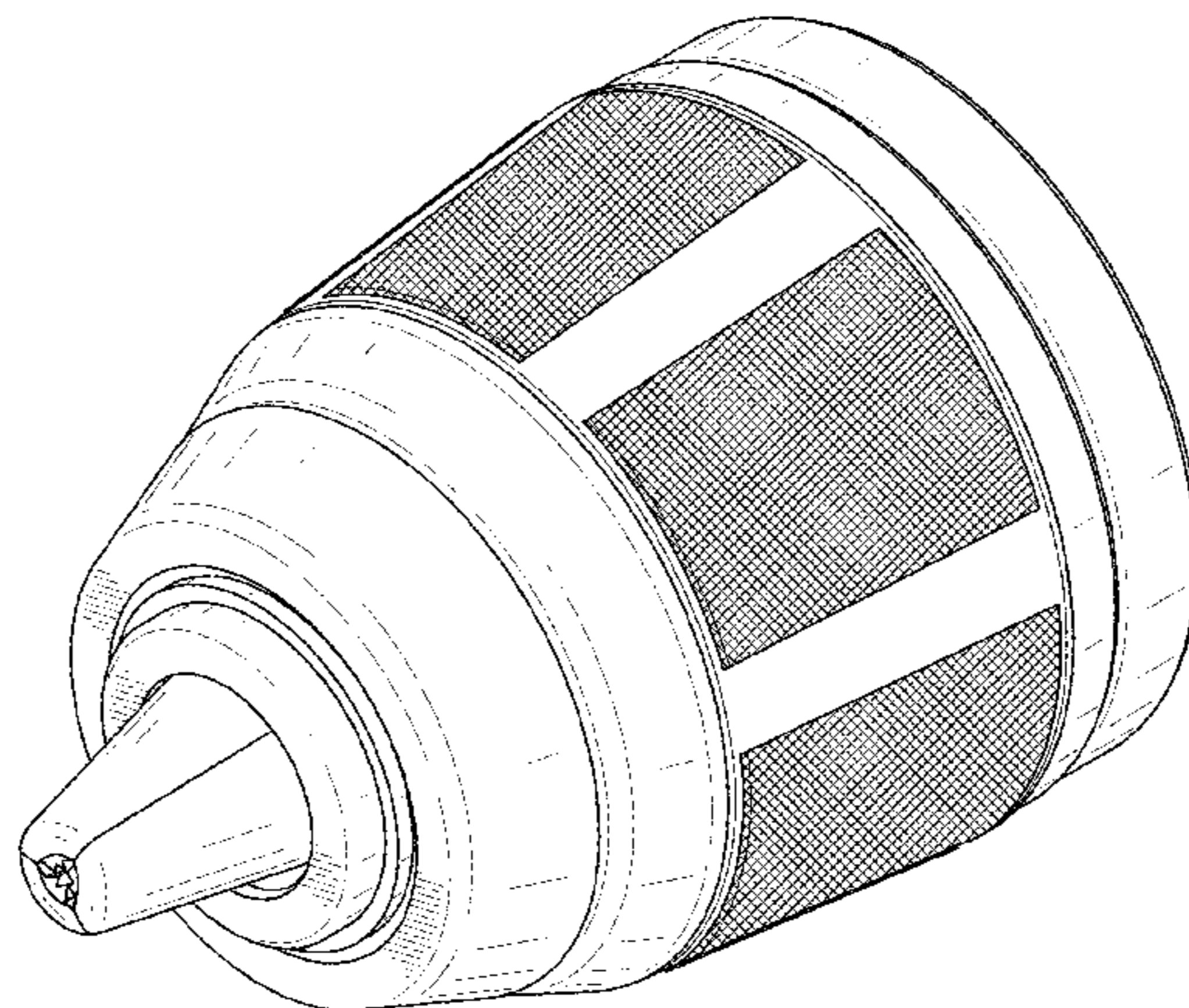
(57) **CLAIM**

The ornamental design for a drill chuck with a conical clamping sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a drill chuck with a conical clamping sleeve according to the present invention. FIG. 2 is a left side view of the drill chuck with a conical clamping sleeve of FIG. 1. FIG. 3 is a top side view of the drill chuck with a conical clamping sleeve of FIG. 1. FIG. 4 is a front side view of the drill chuck with a conical clamping sleeve of FIG. 1. FIG. 5 is a bottom side view of the drill chuck with a conical clamping sleeve of FIG. 1. FIG. 6 is a rear side view of the drill chuck with a conical clamping sleeve of FIG. 1; and, FIG. 7 is a right side view of the drill chuck with a conical clamping sleeve of FIG. 1. The broken lines illustrate environmental structure and portions drill chuck with a conical clamping sleeve that forms no part of the claimed design.

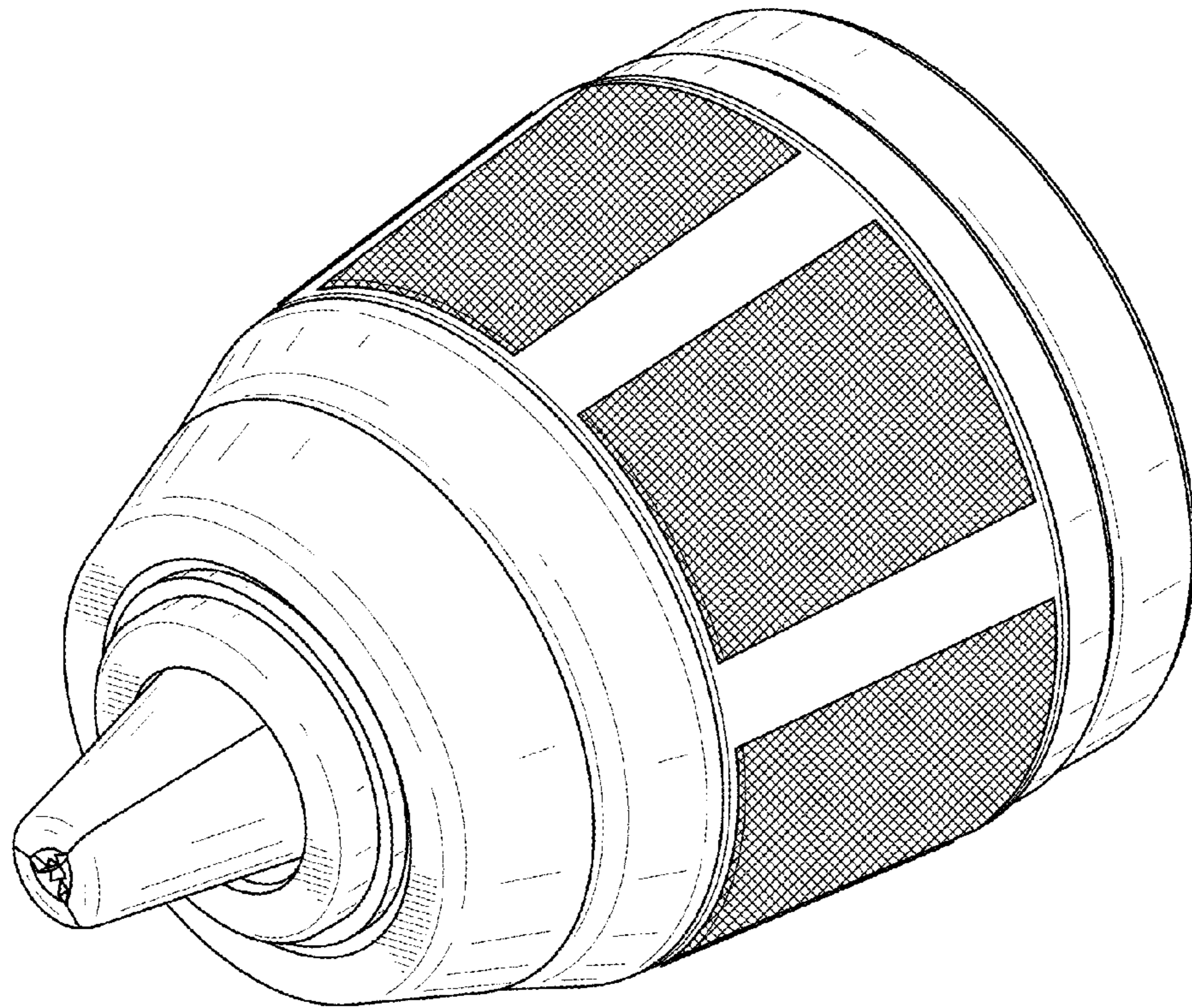

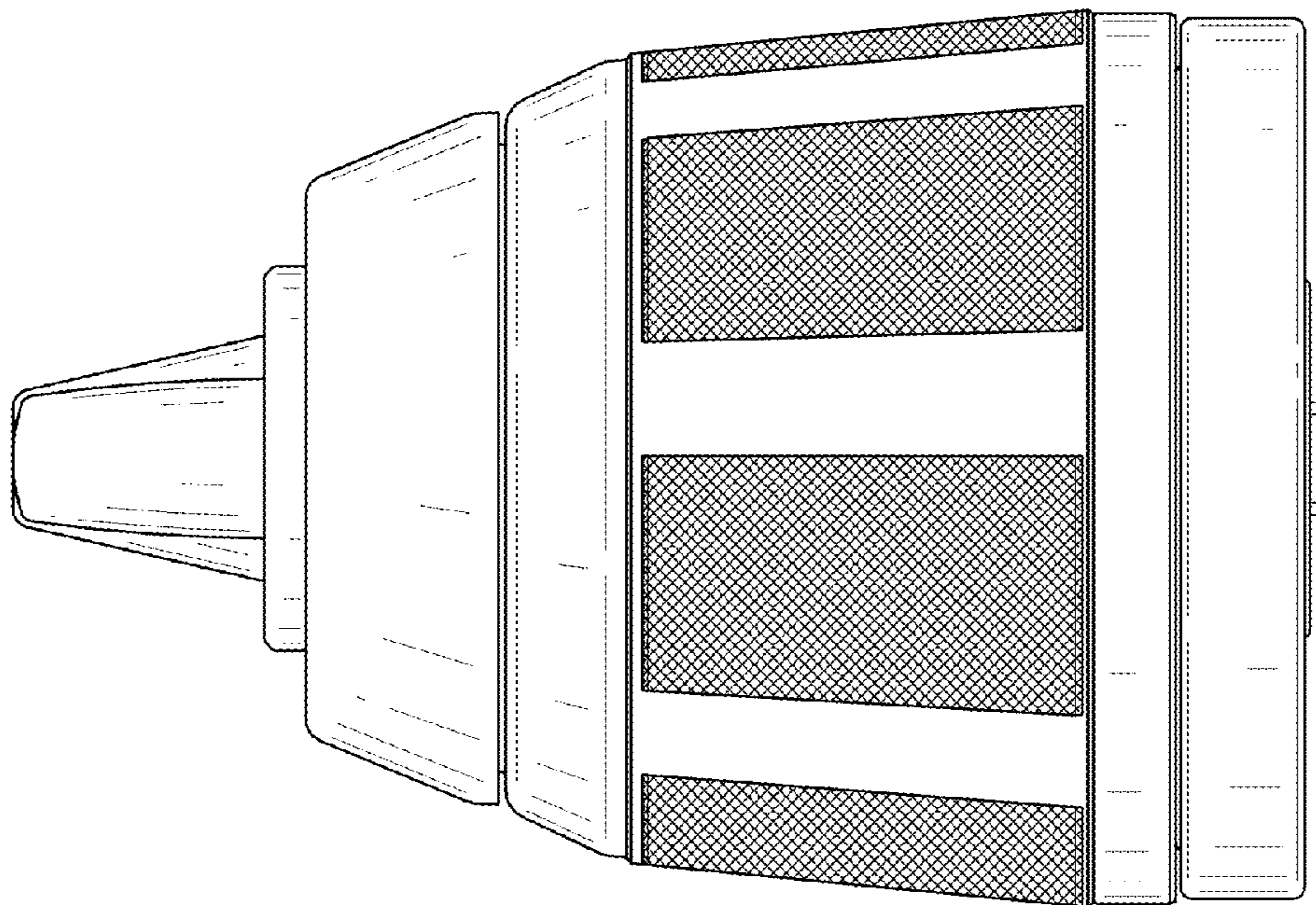

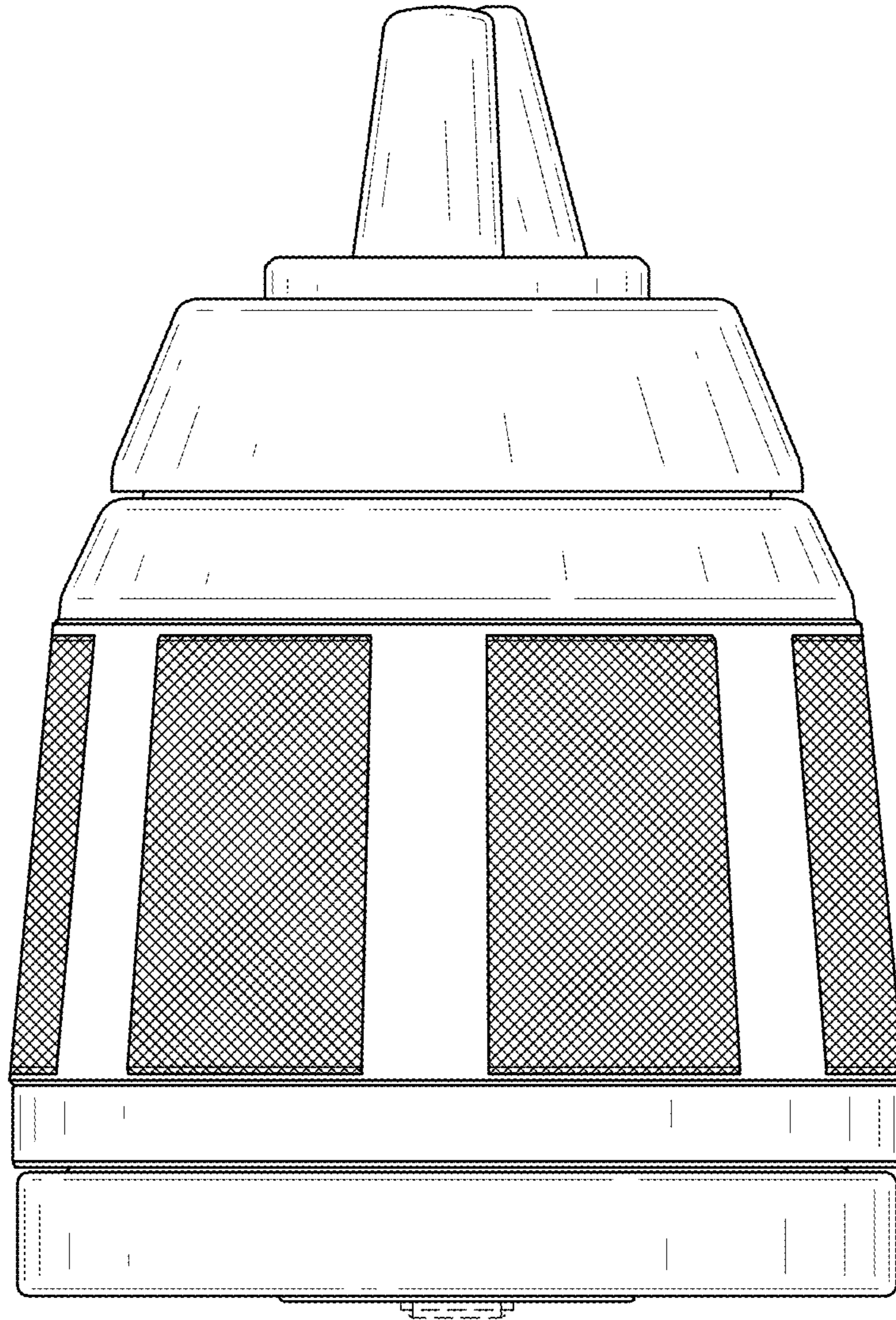

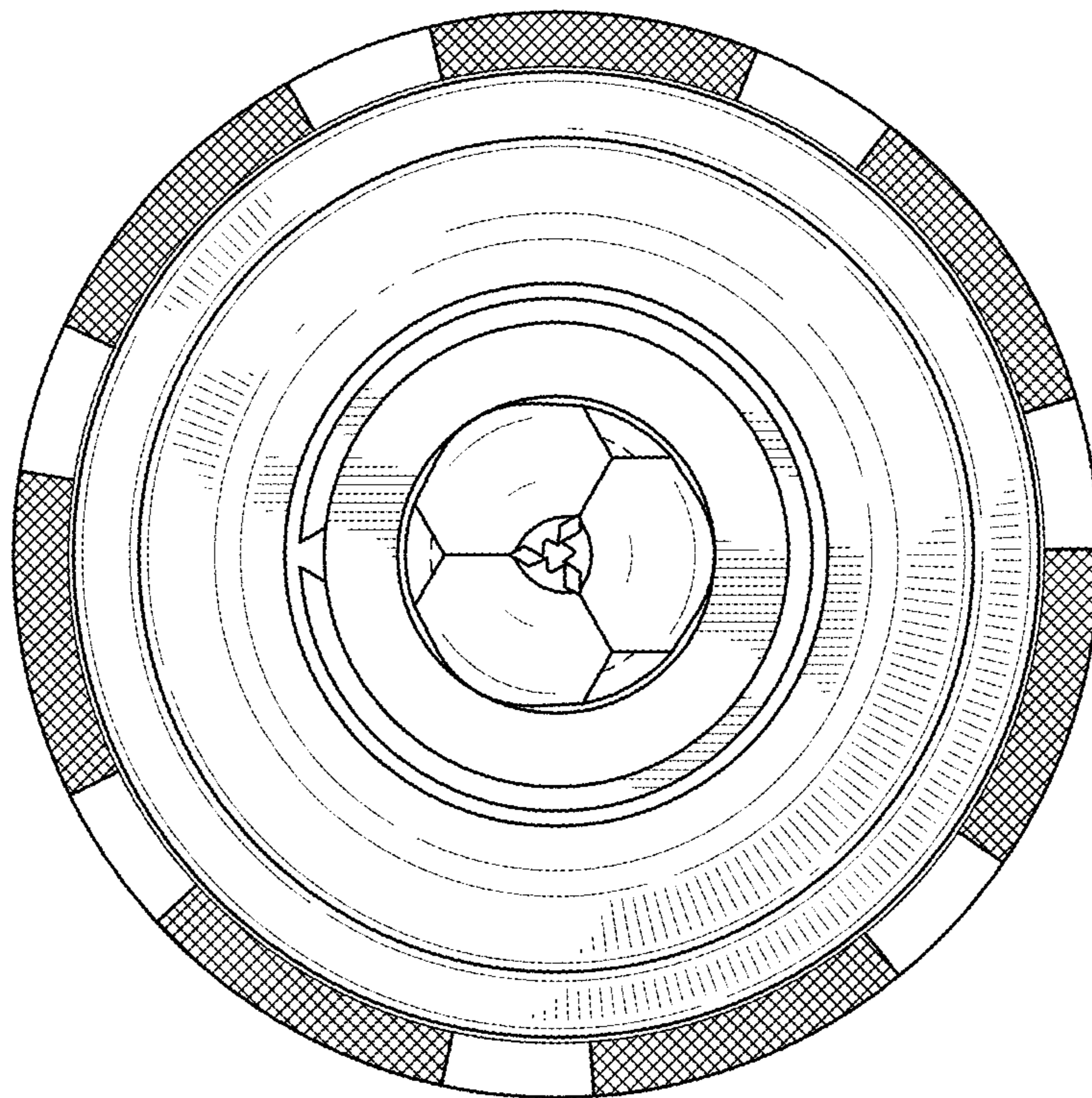

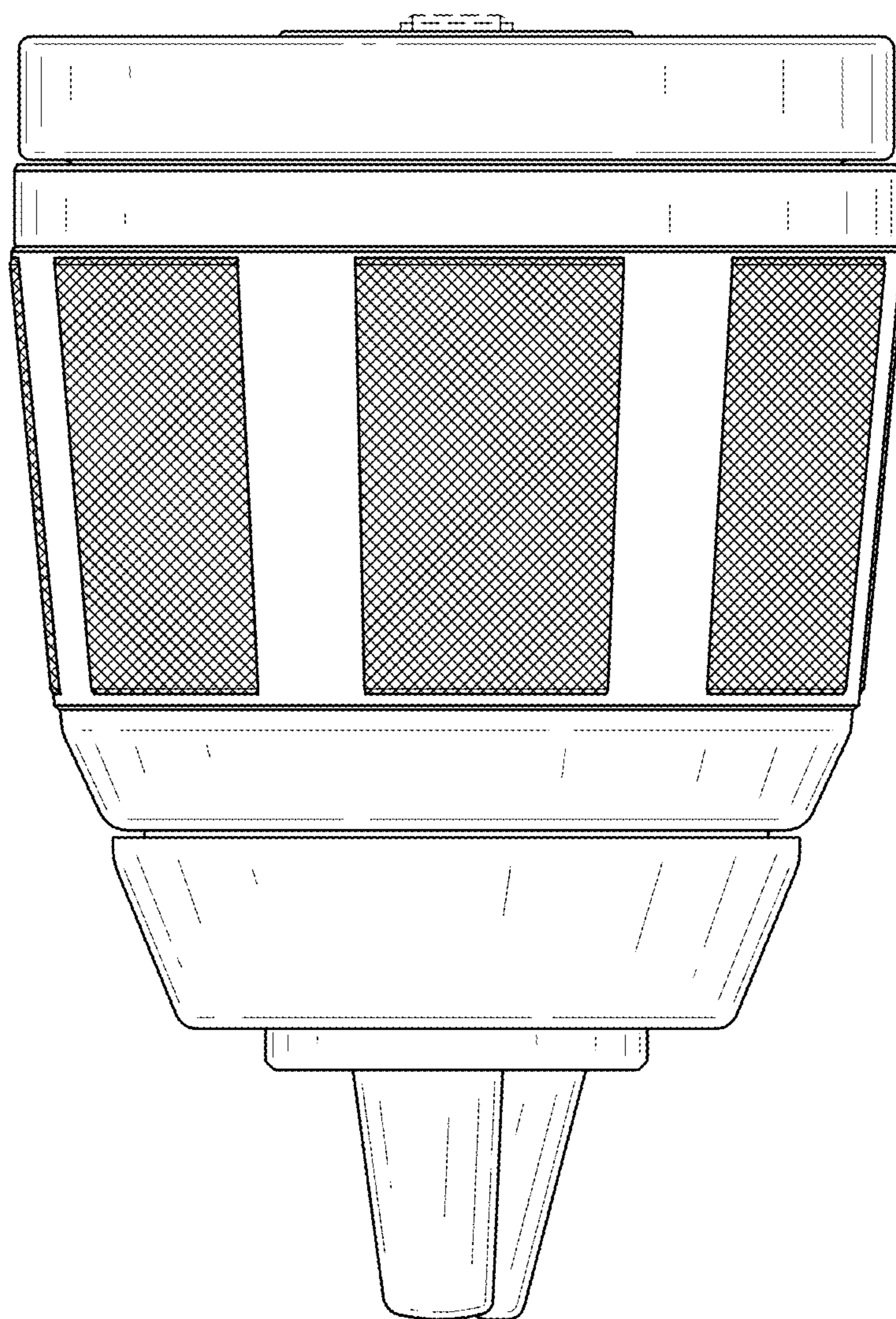

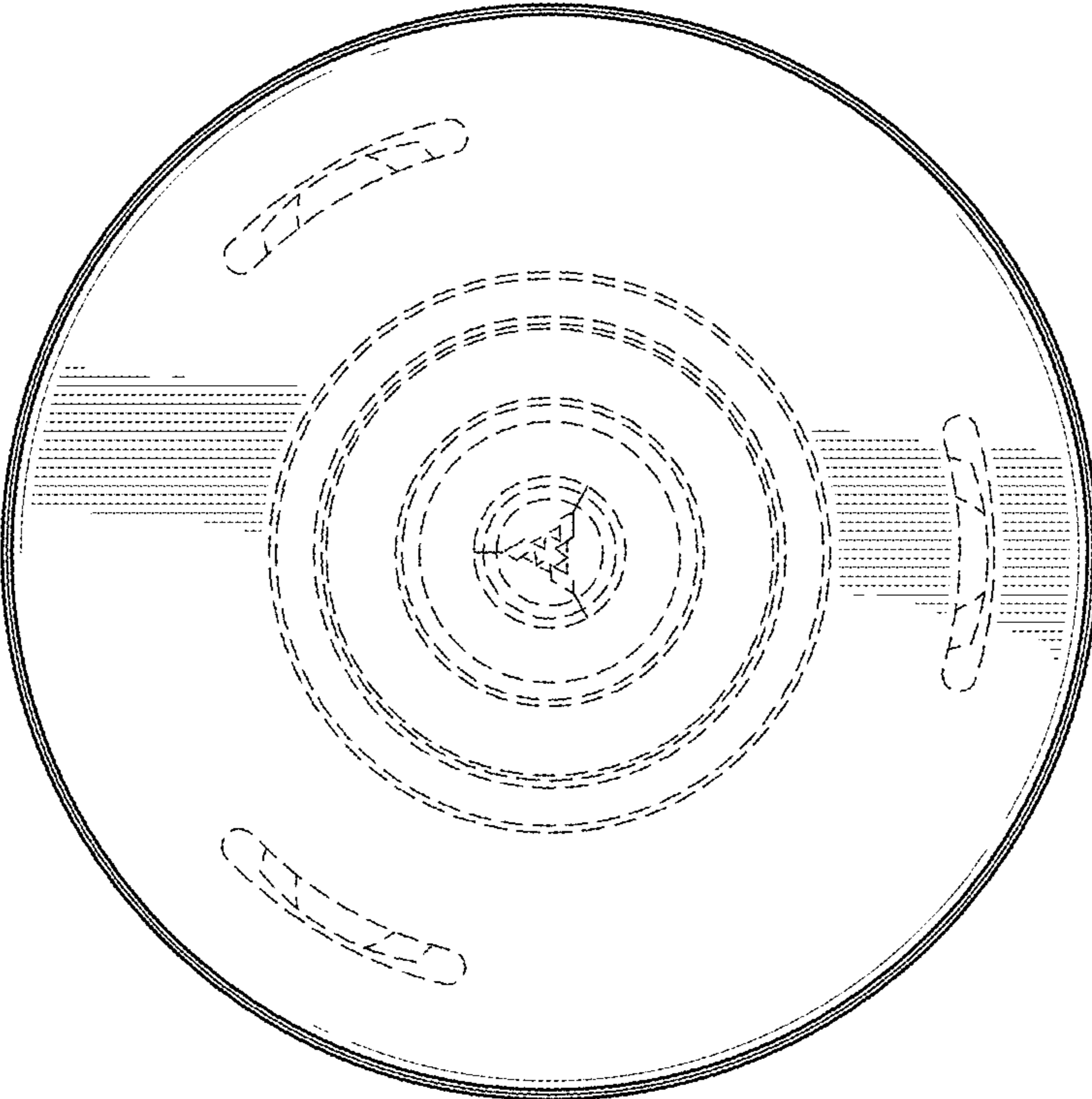

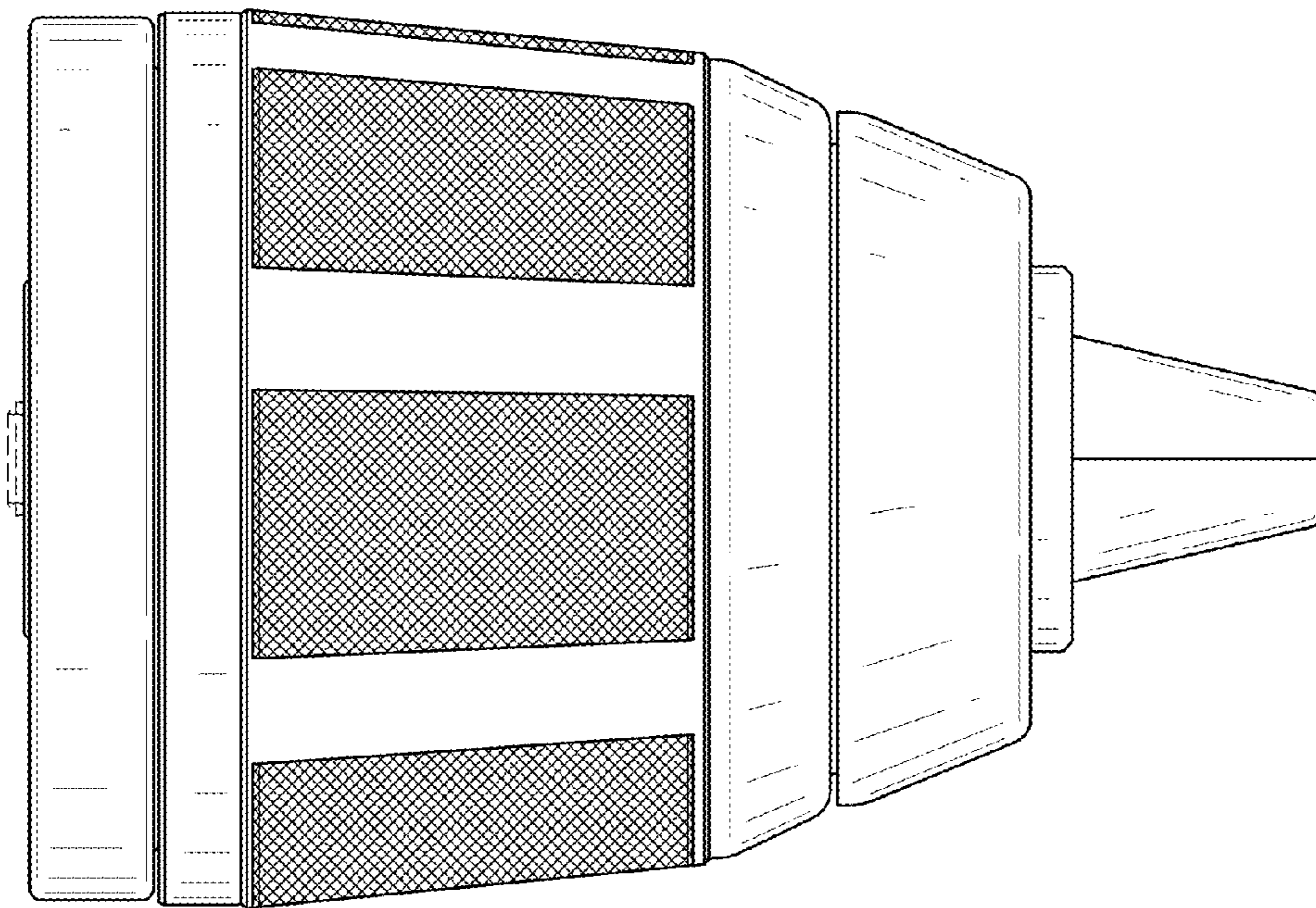
