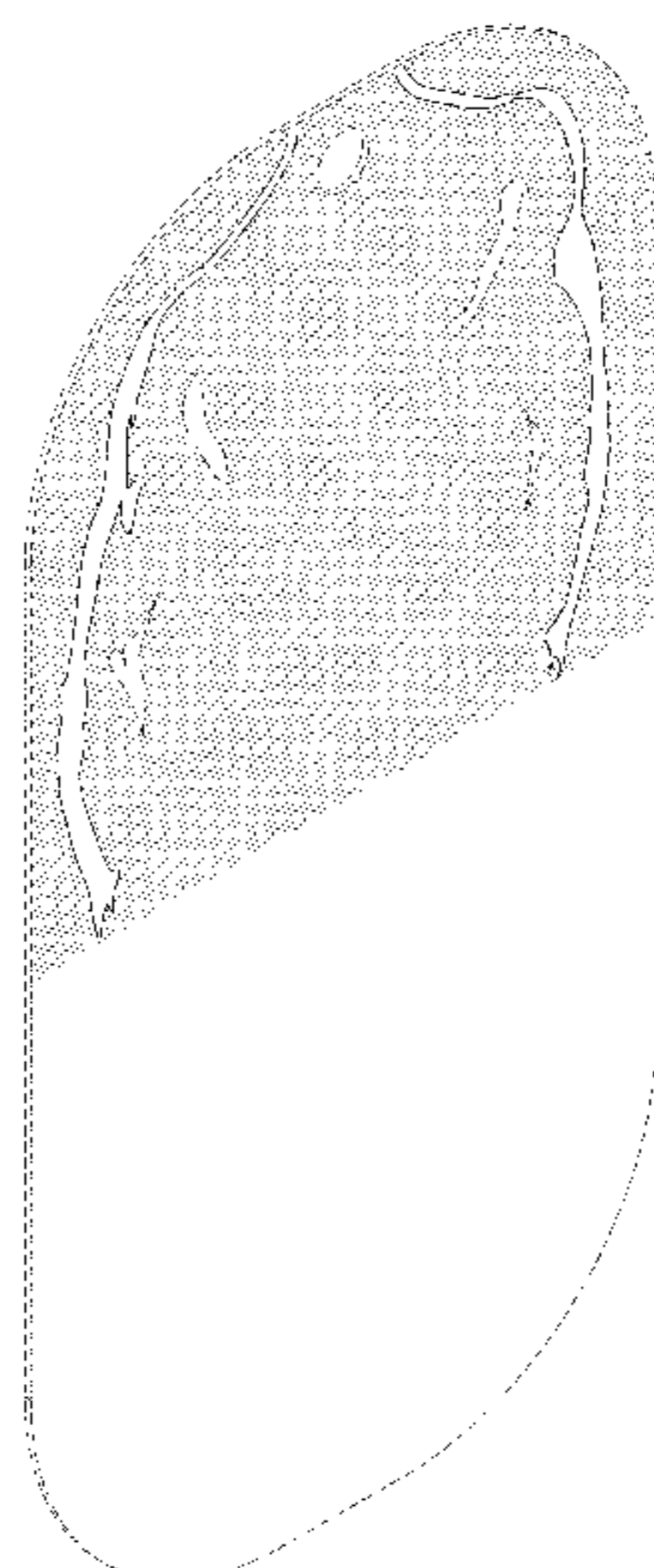
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is perspective view of a package showing my new design having a black color and a body silhouette; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a right view thereof; FIG. 5 is a left view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. 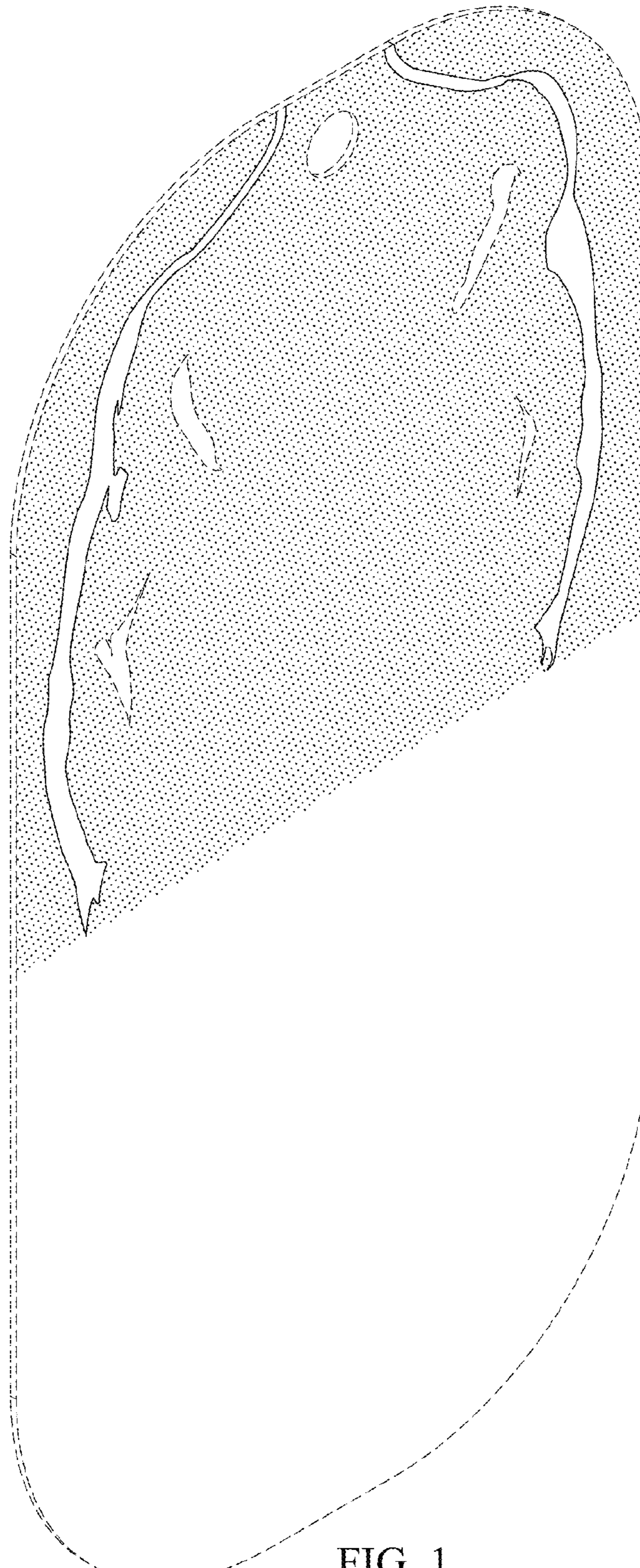

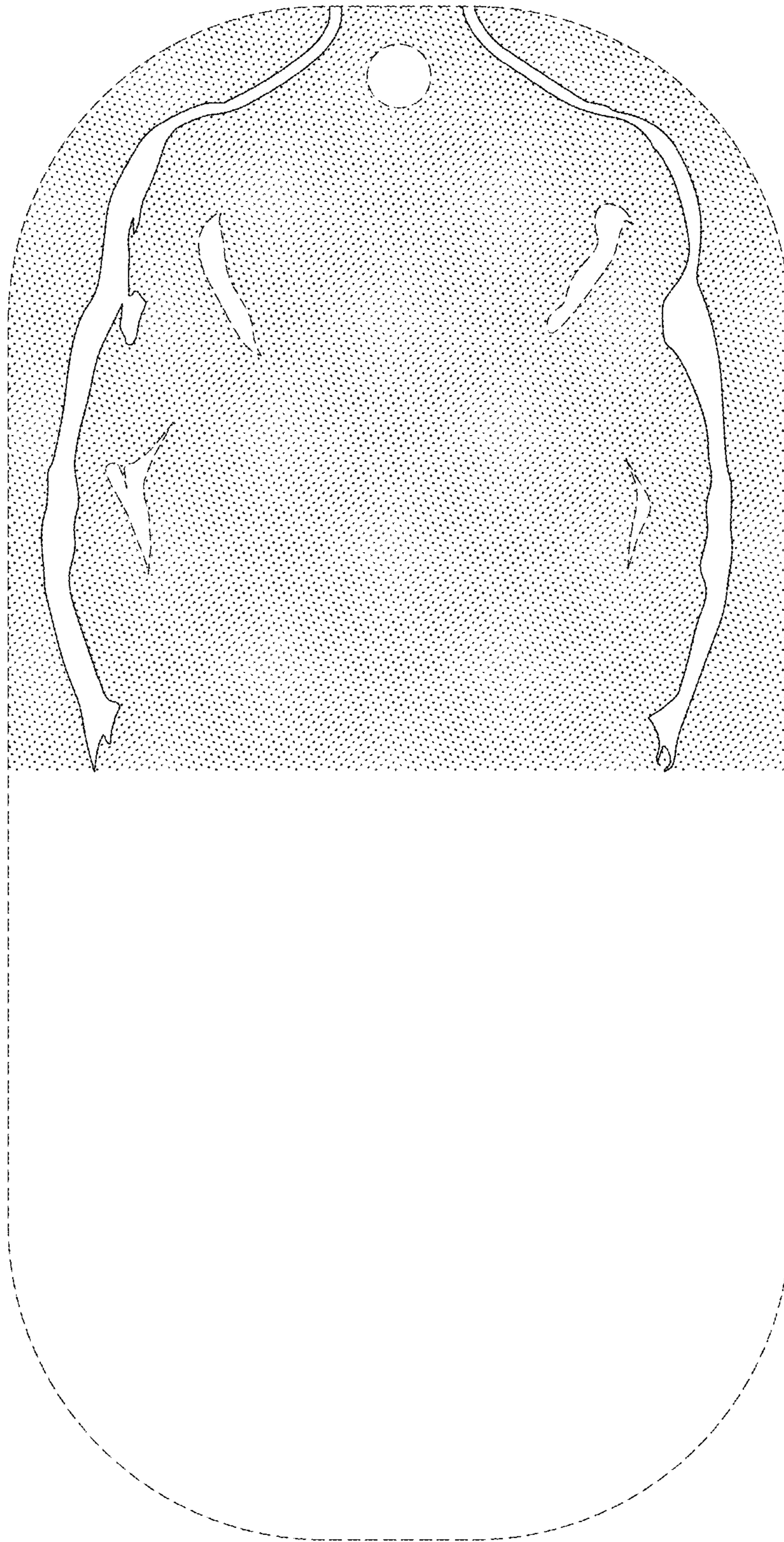

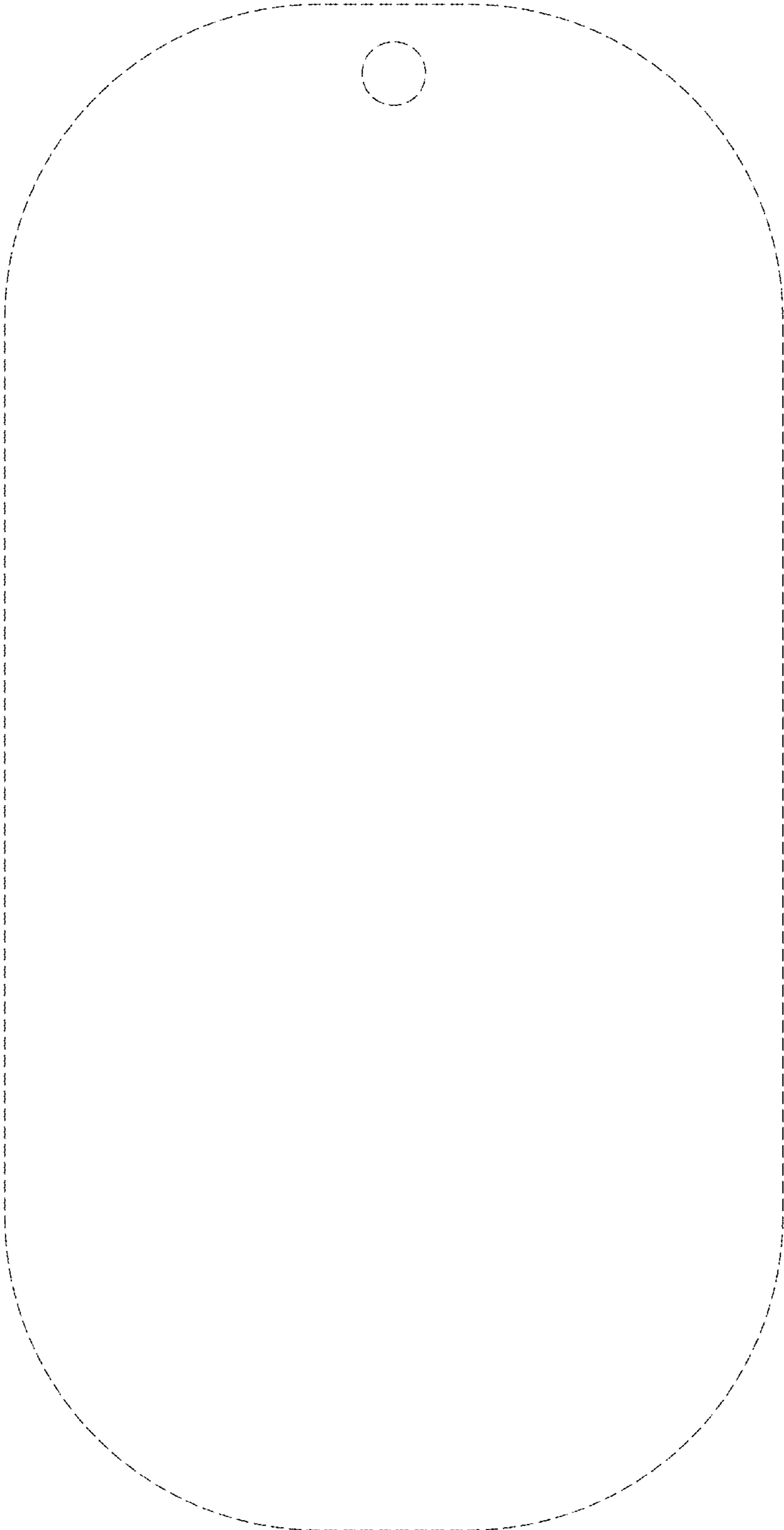
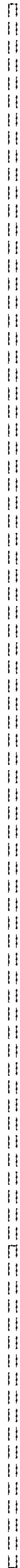
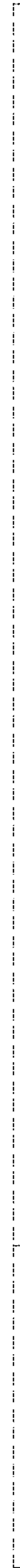

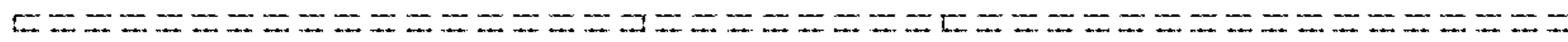

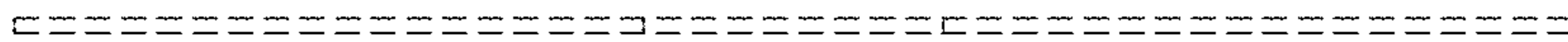
