DESCRIPTION

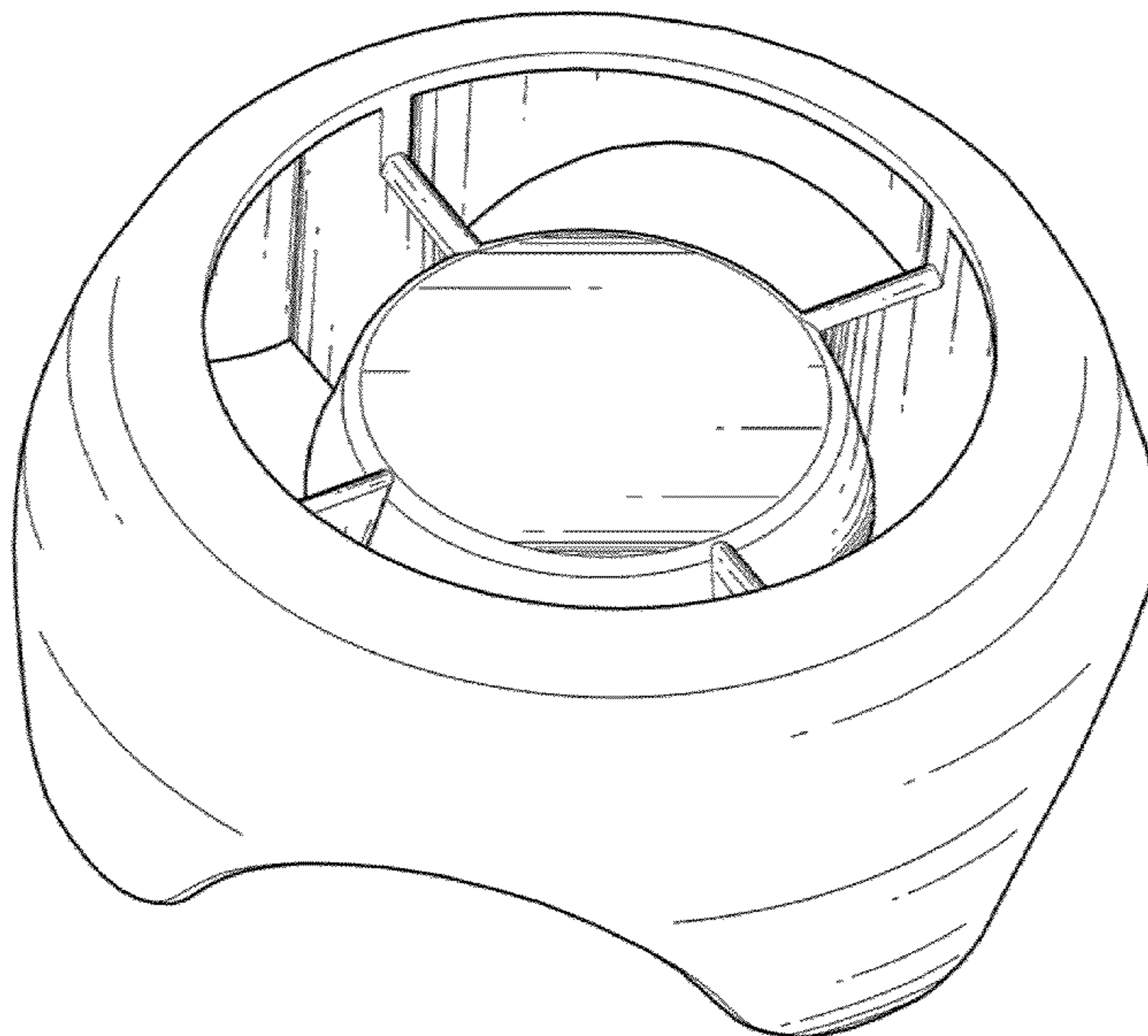
FIG. 1 is a top perspective view of my new cap for a container. FIG. 2 is a bottom perspective view of my new cap for a container of FIG. 1.

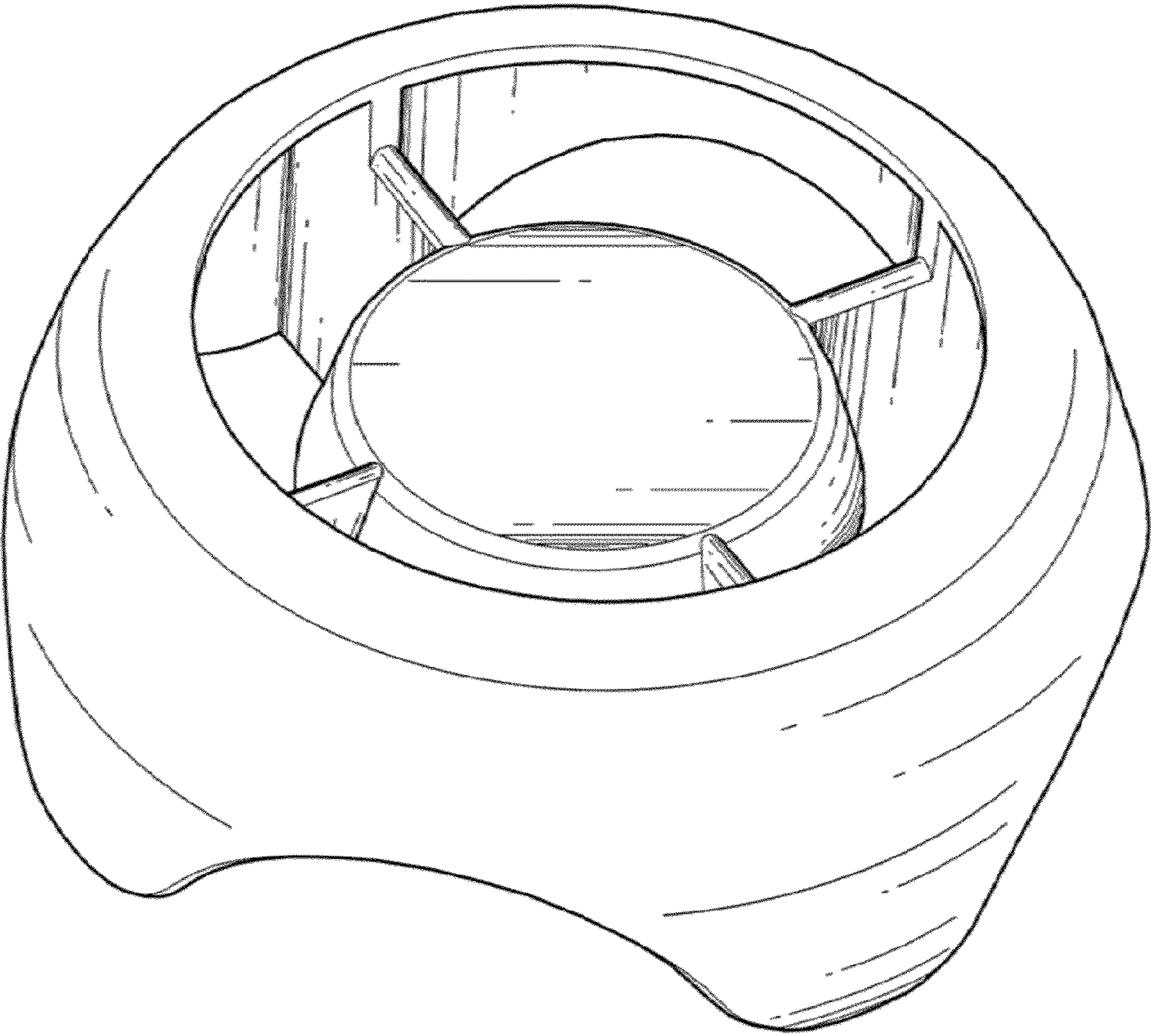

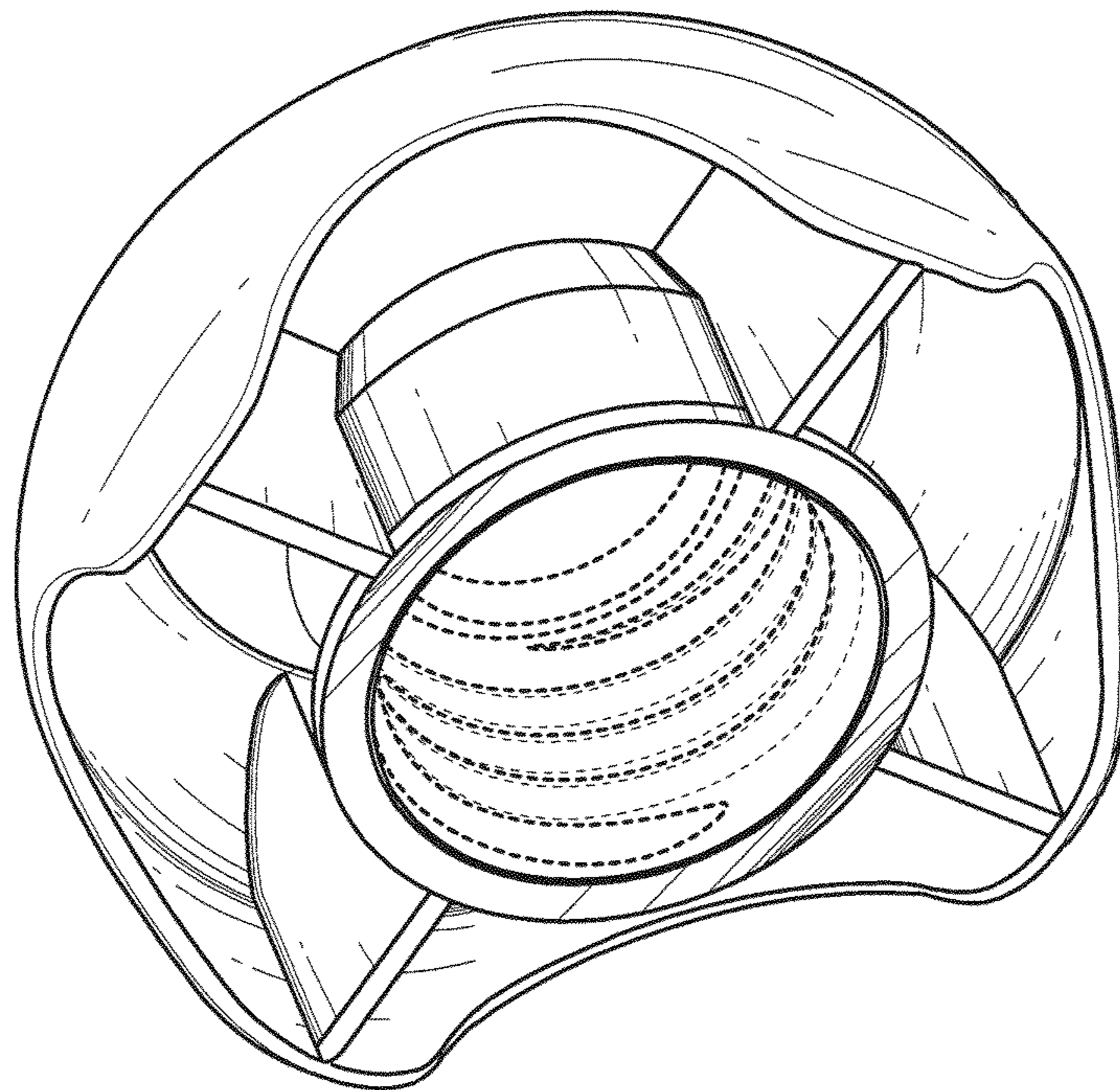

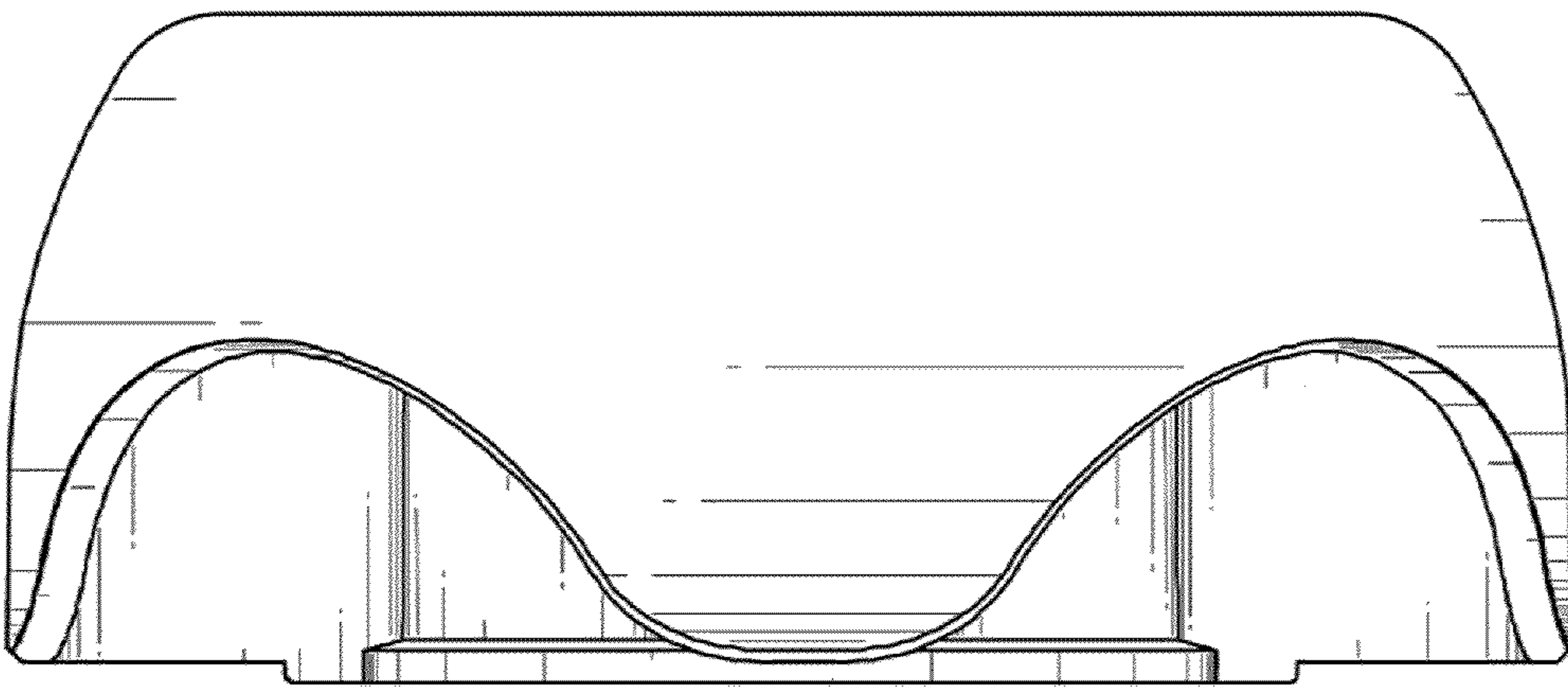

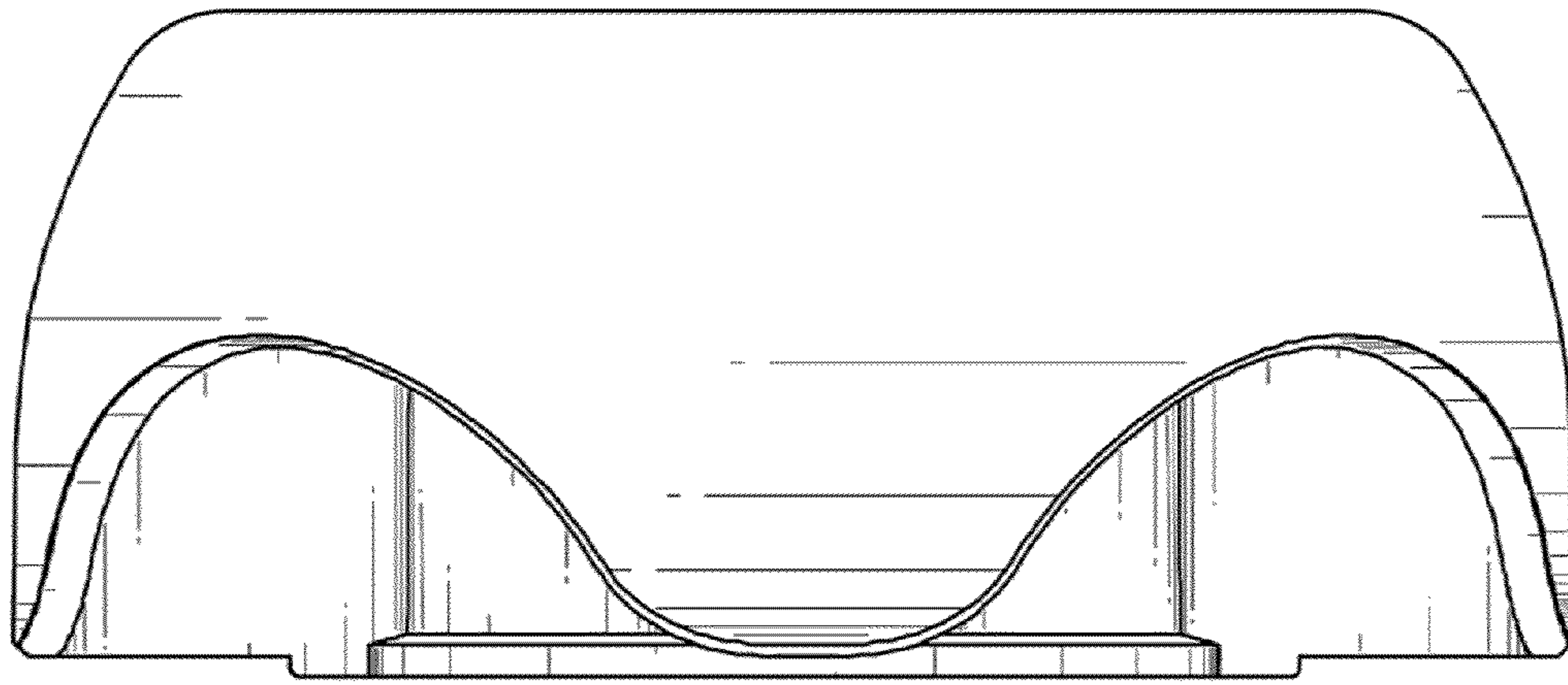

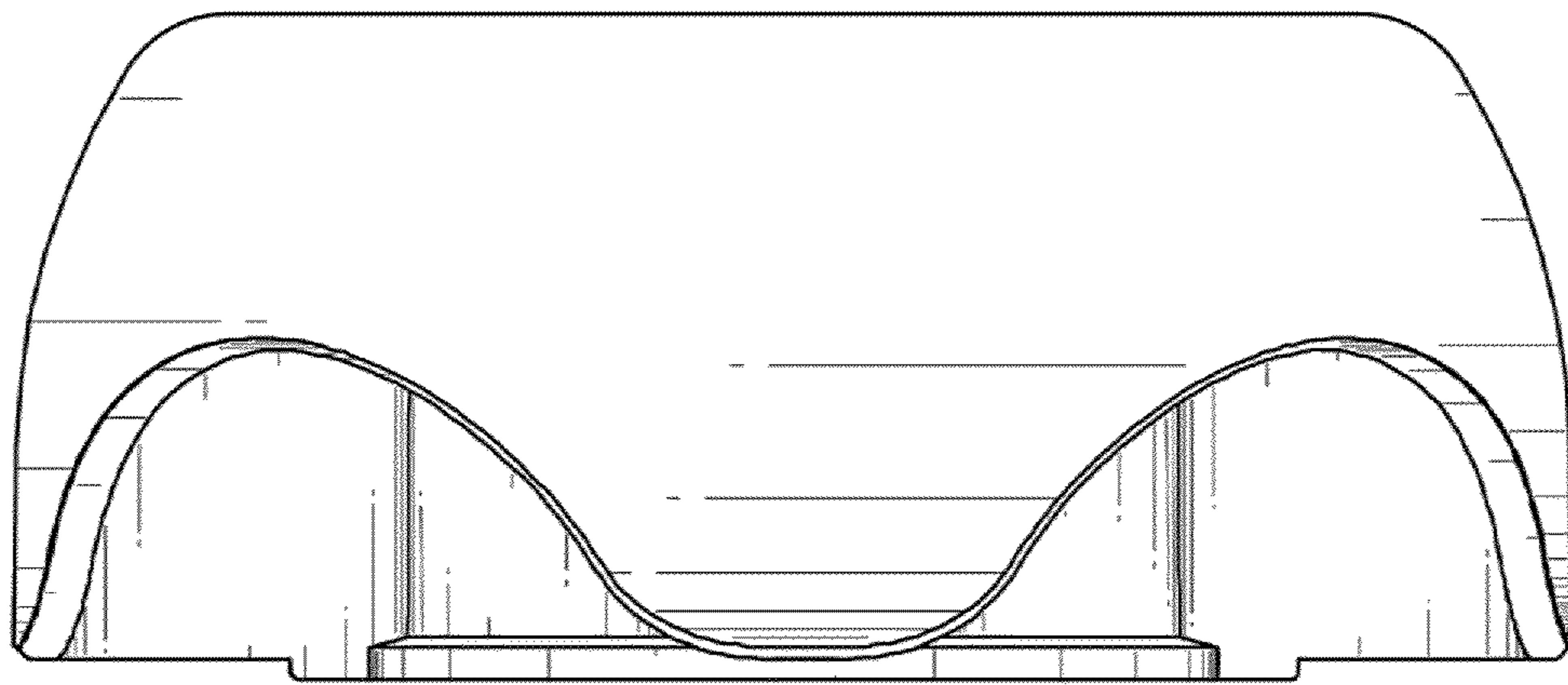

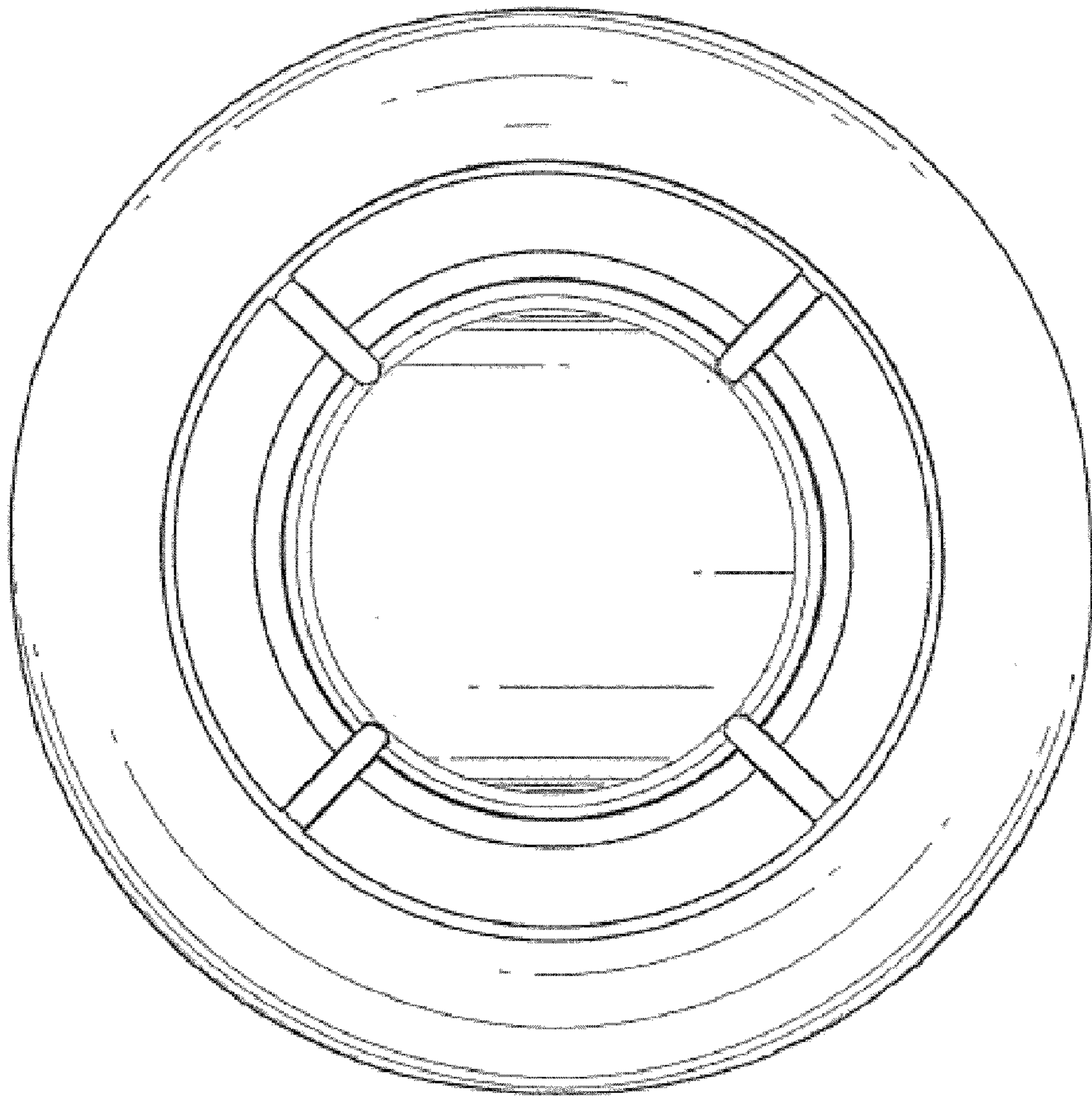

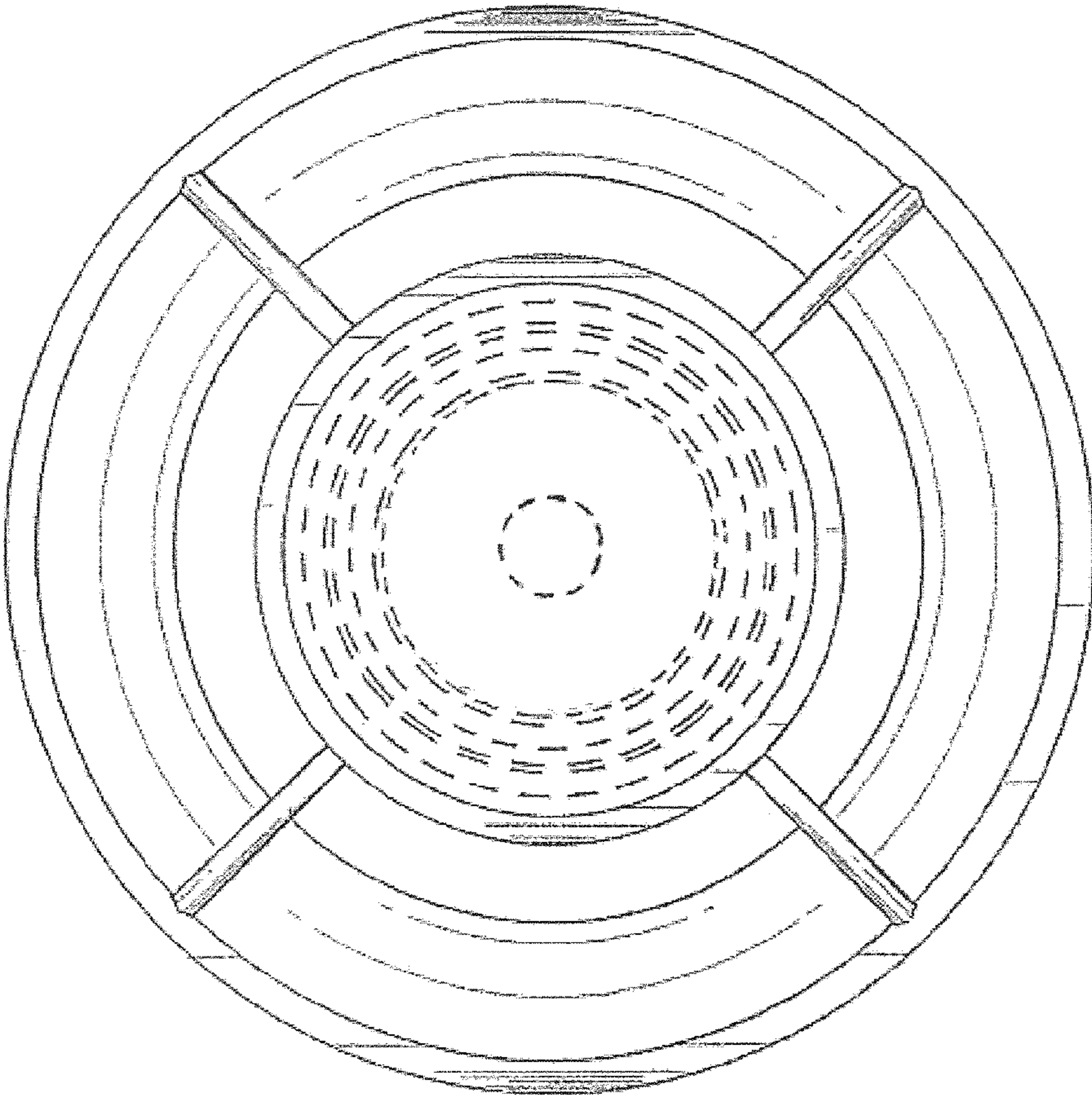
