(57) **CLAIM**

The ornamental design of an hub cover of front rim for transportation vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a three dimensional view of an hub cover of front rim for transportation vehicle showing a first preferred embodiment of our new design;
FIG. 2 is a left side view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front perspective view of a hub cover of front rim for transportation vehicle, shown in its position of use.
The broken line showing of the center of the hub, the bolts, the wheel and logo is included for the purpose of illustrating environment and forms no part of the claimed design.

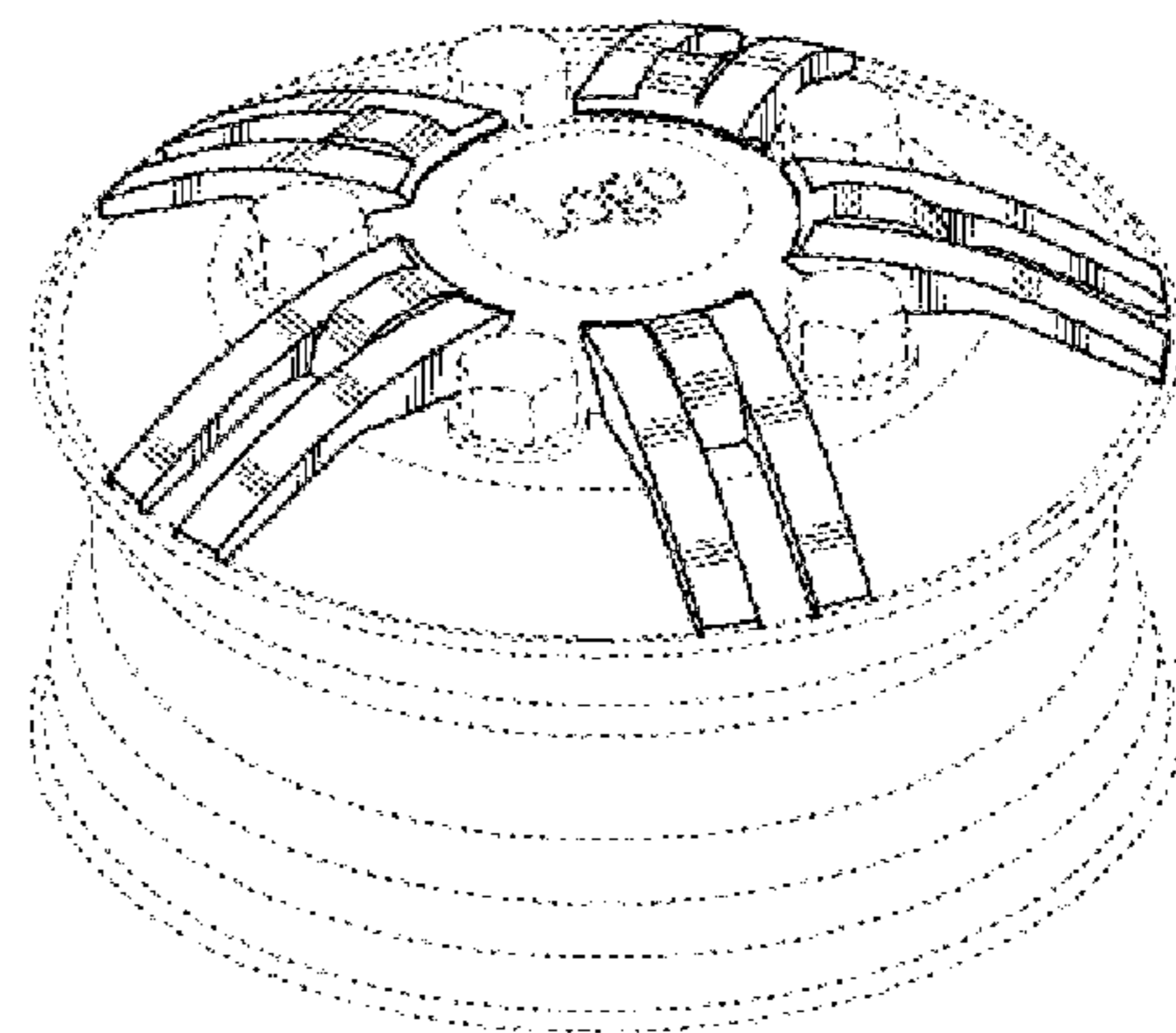
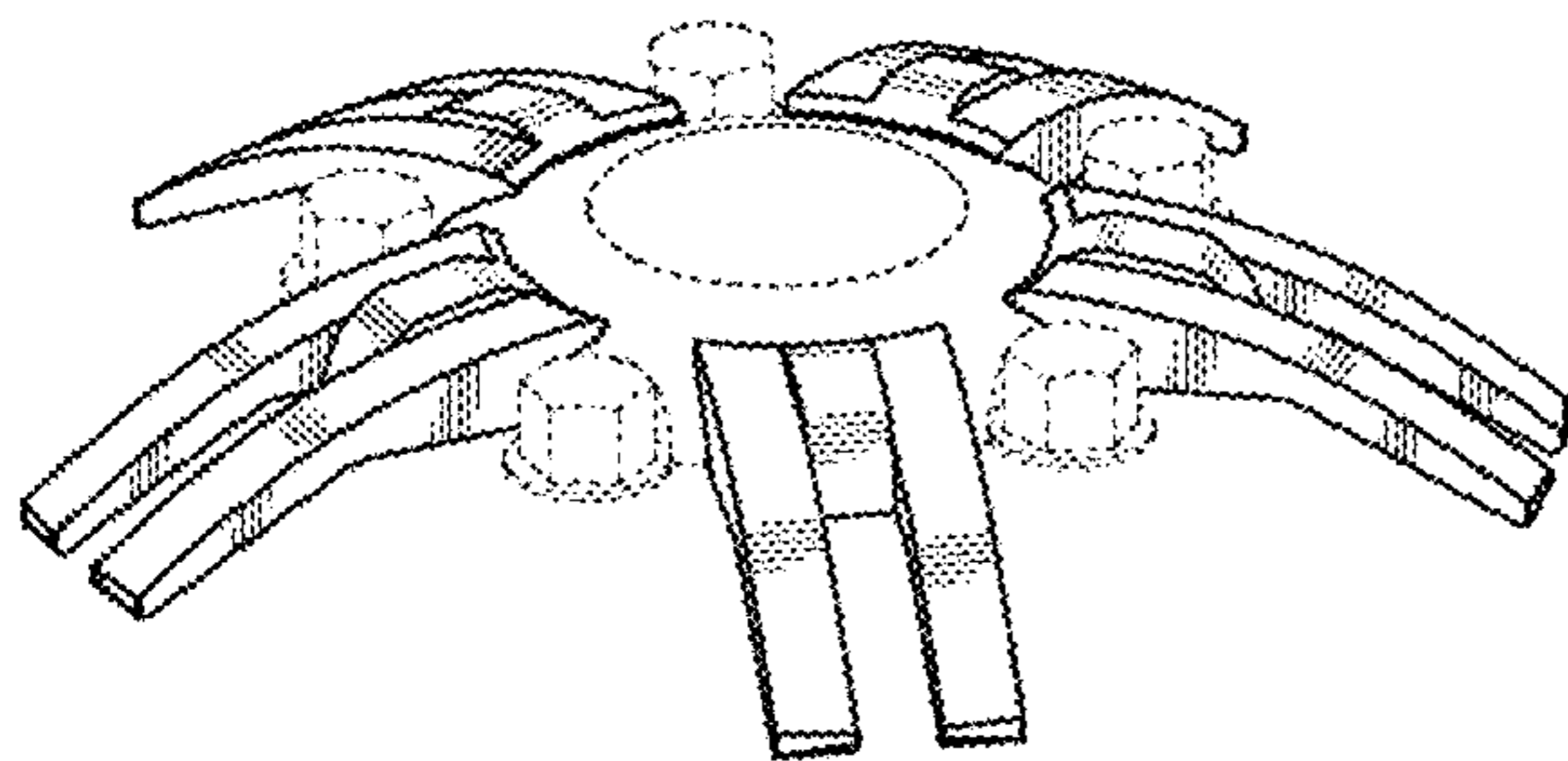

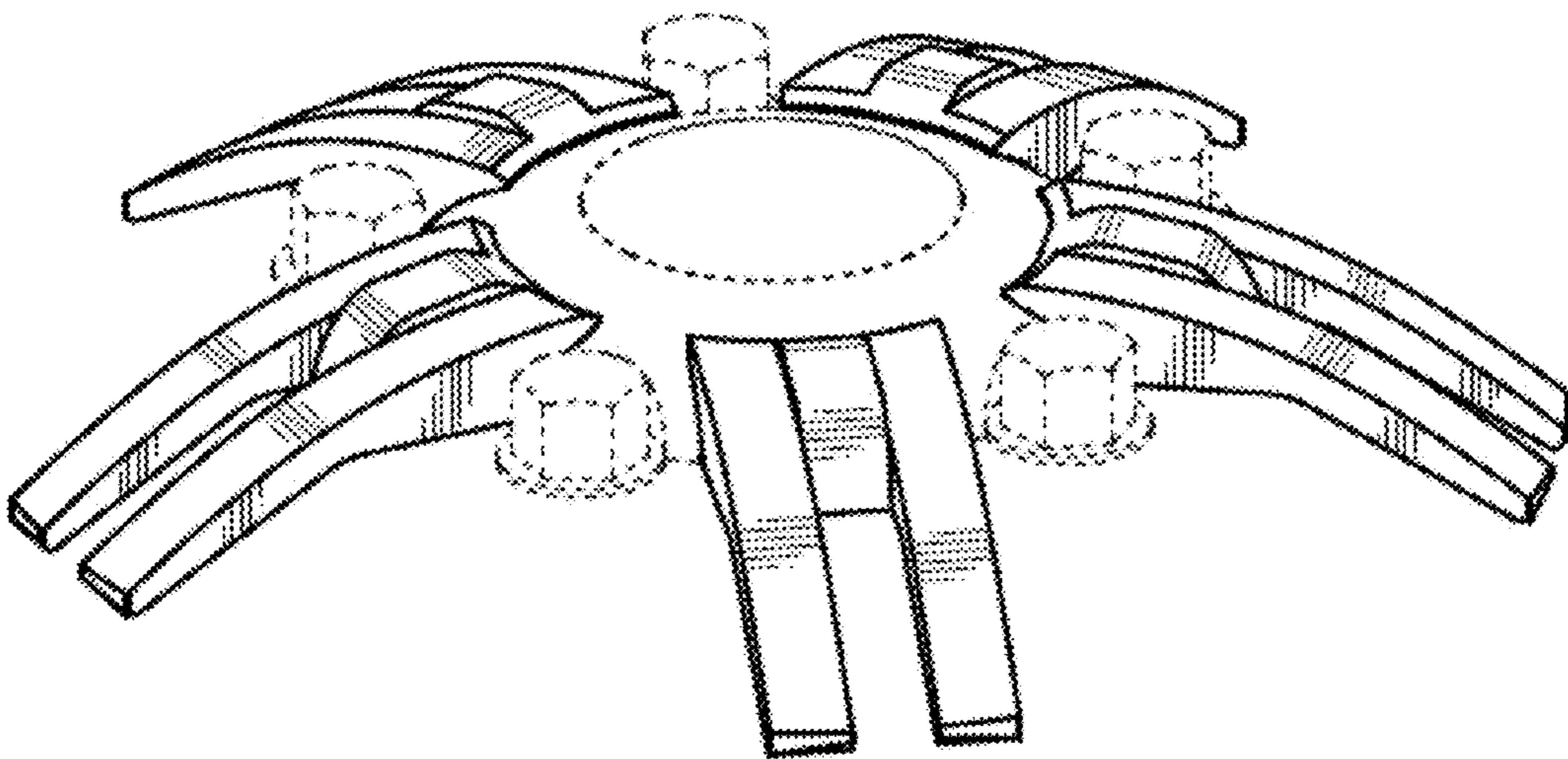

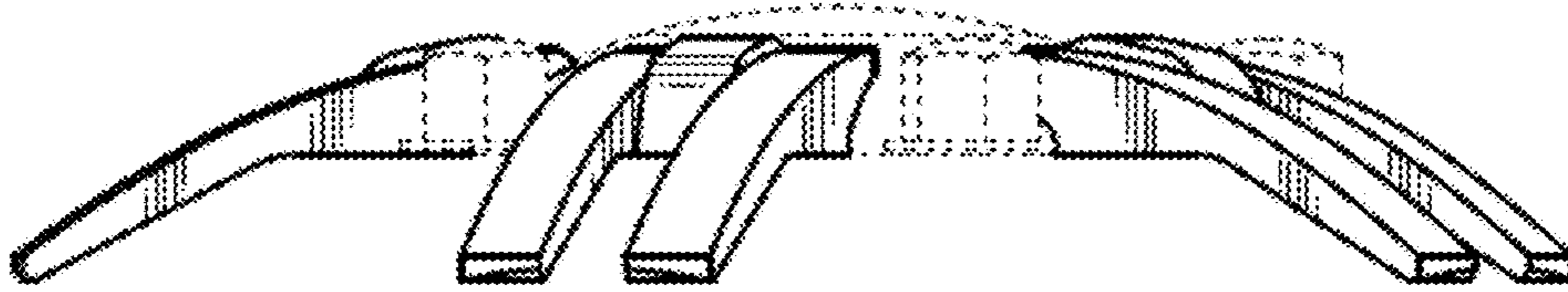

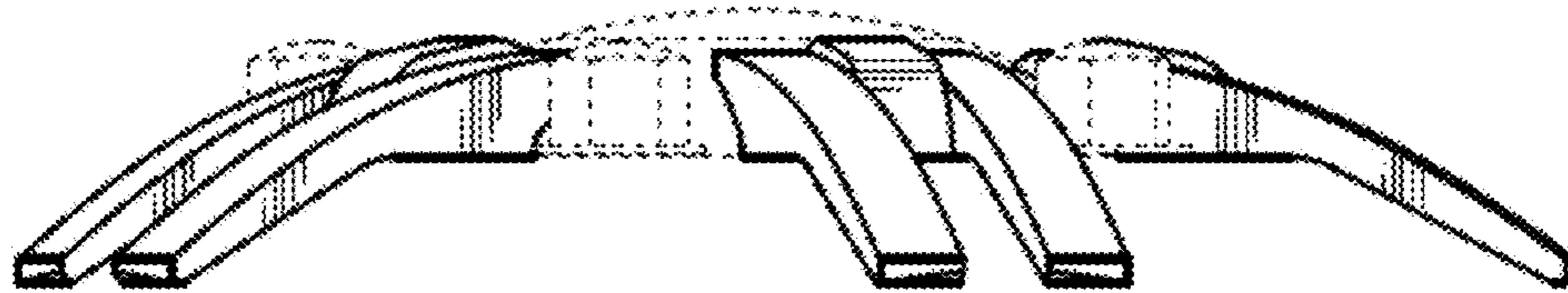

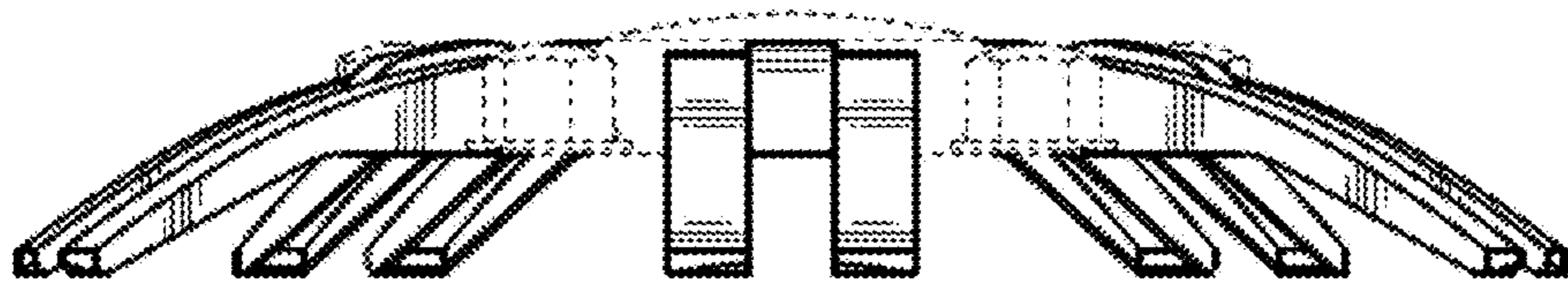

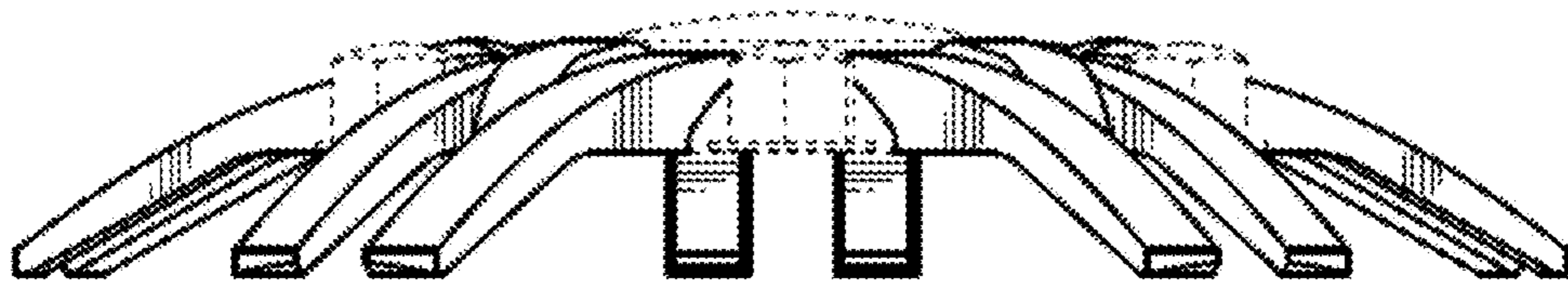

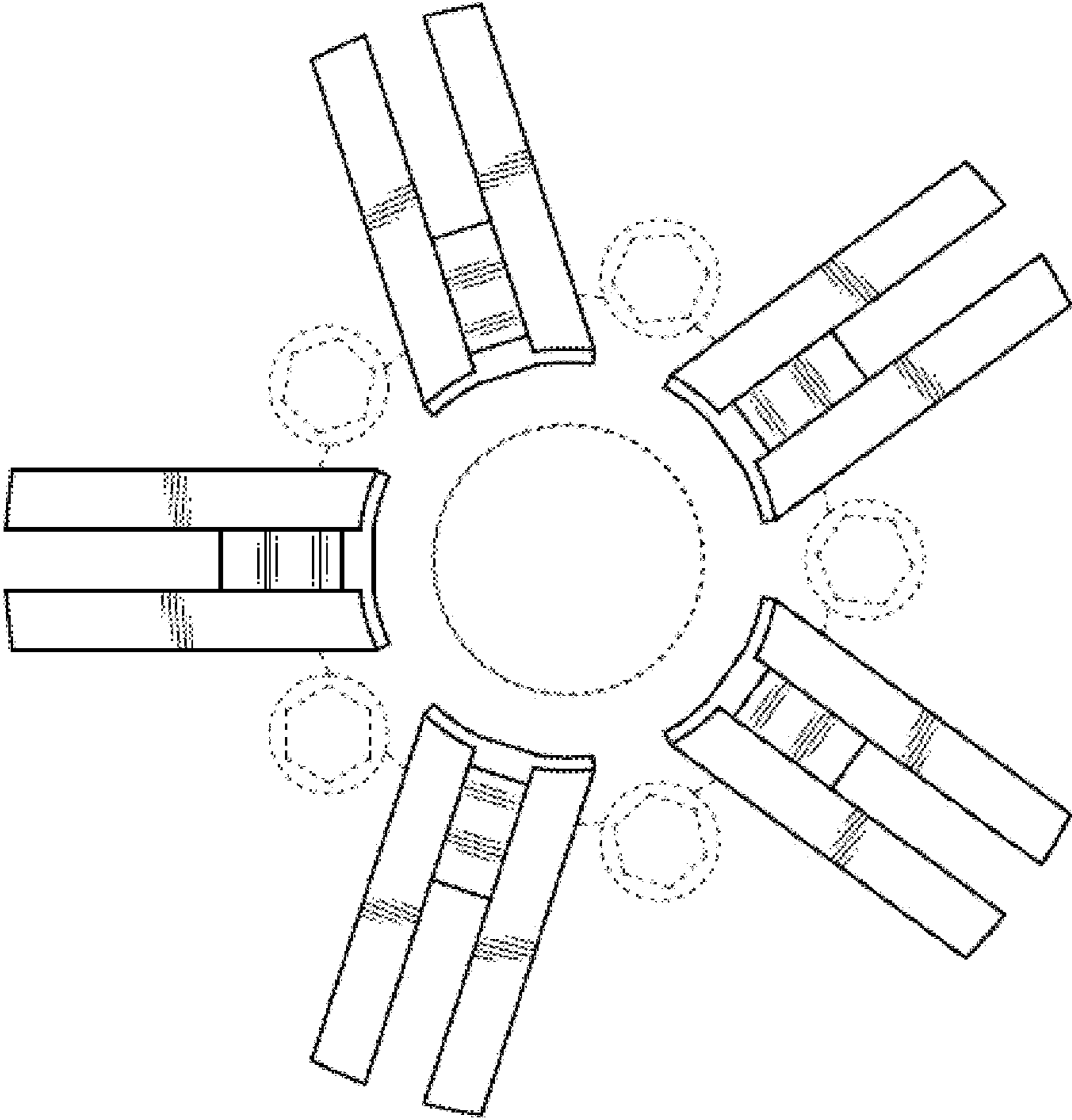

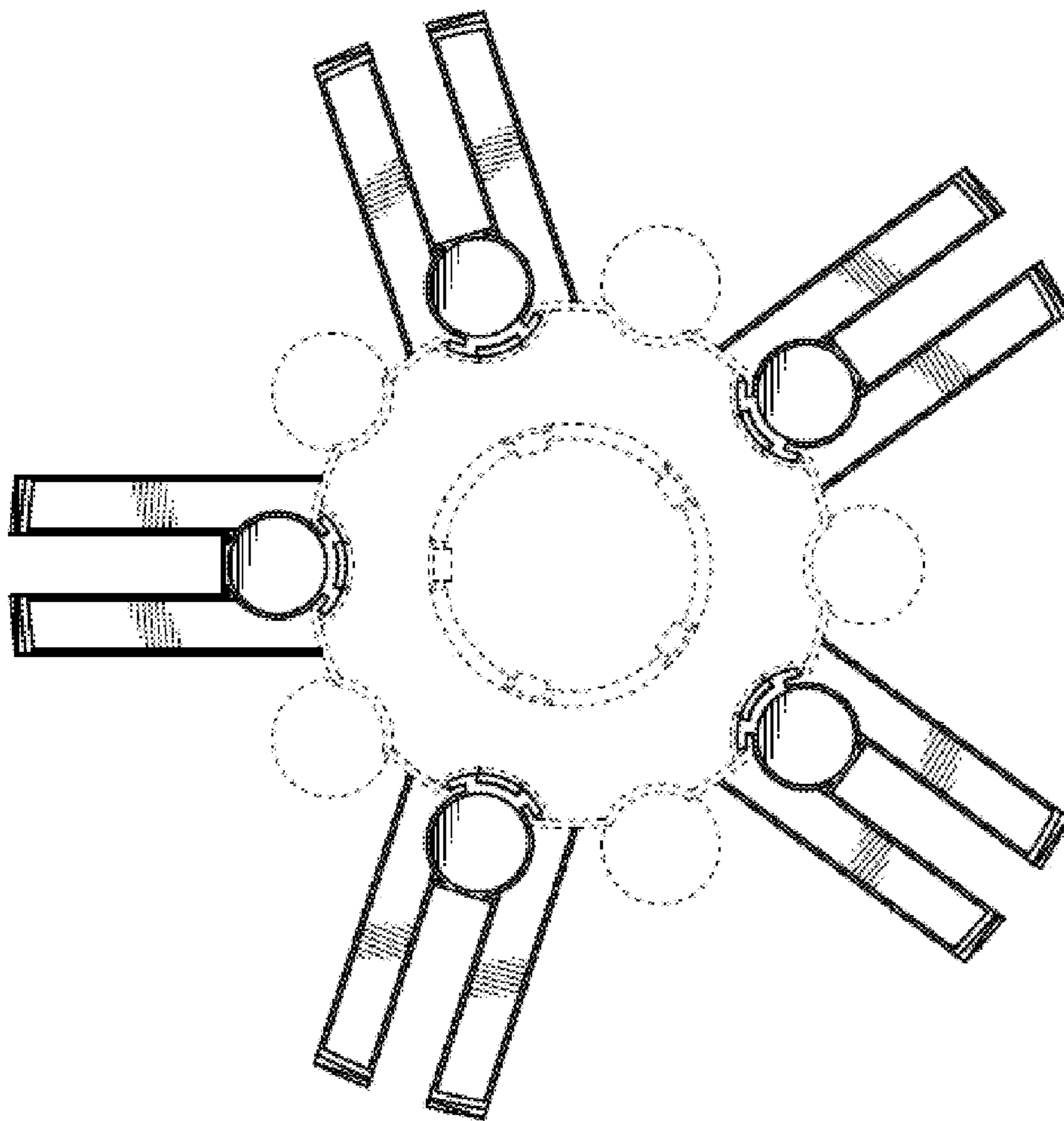
