(57) **CLAIM**

The ornamental design for a sidewall portion of an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of sidewall portion of an automobile tire according to a first embodiment of my new design;

FIG. 2 is a front view thereof;

FIG. 6 is a rear view thereof;

FIG. 7 is a bottom view thereof;

FIG. 9 is a section view taken along line 9-9 in FIG. 8;

FIG. 10 is a perspective view of sidewall portion of an automobile tire according to a second embodiment of my new design;

FIG. 12 is a top view thereof;

FIG. 13 is a right side view thereof;

FIG. 14 is a left side of view thereof;

FIG. 15 is a rear view thereof;

FIG. 16 is a bottom view thereof;

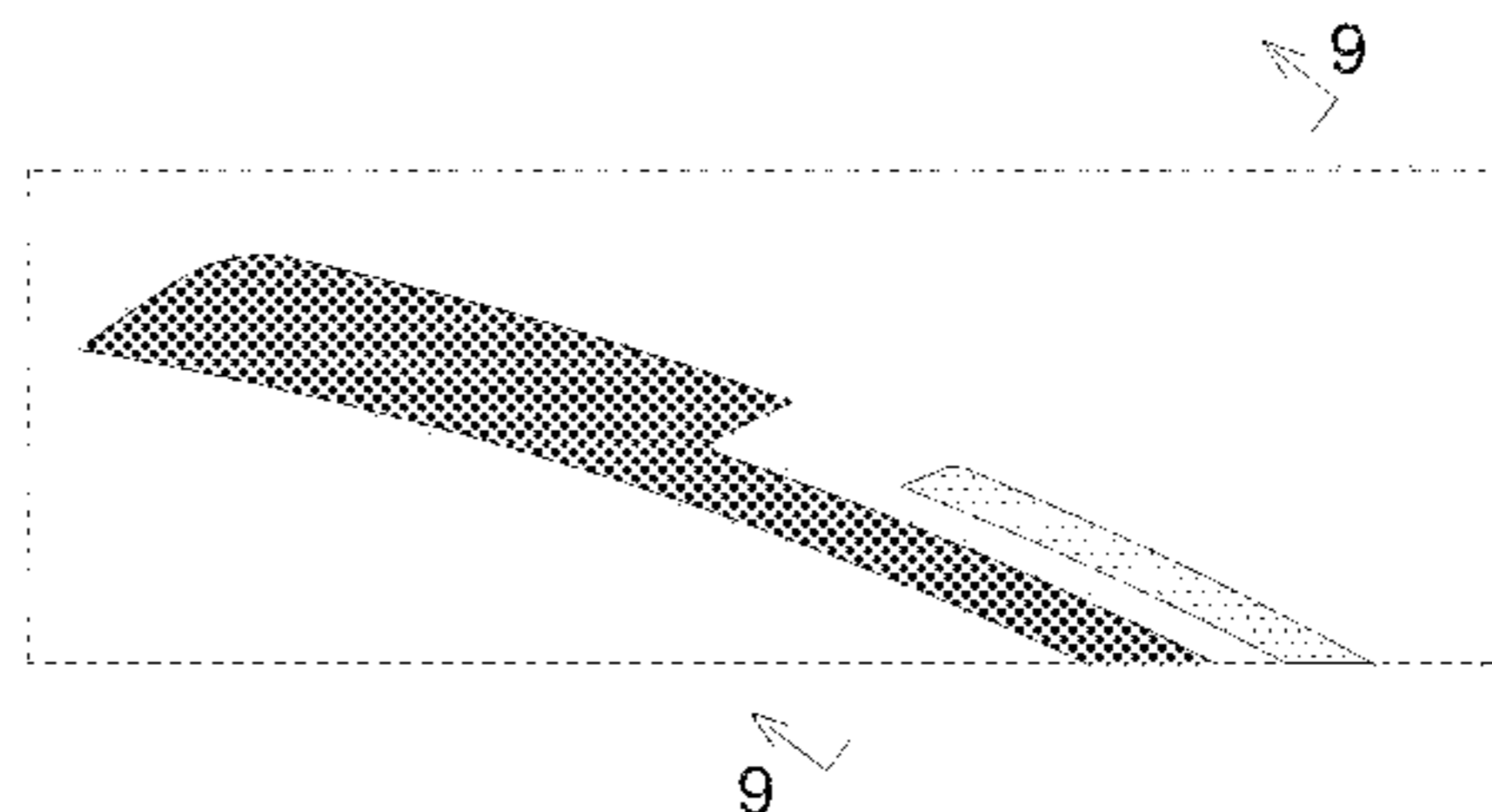
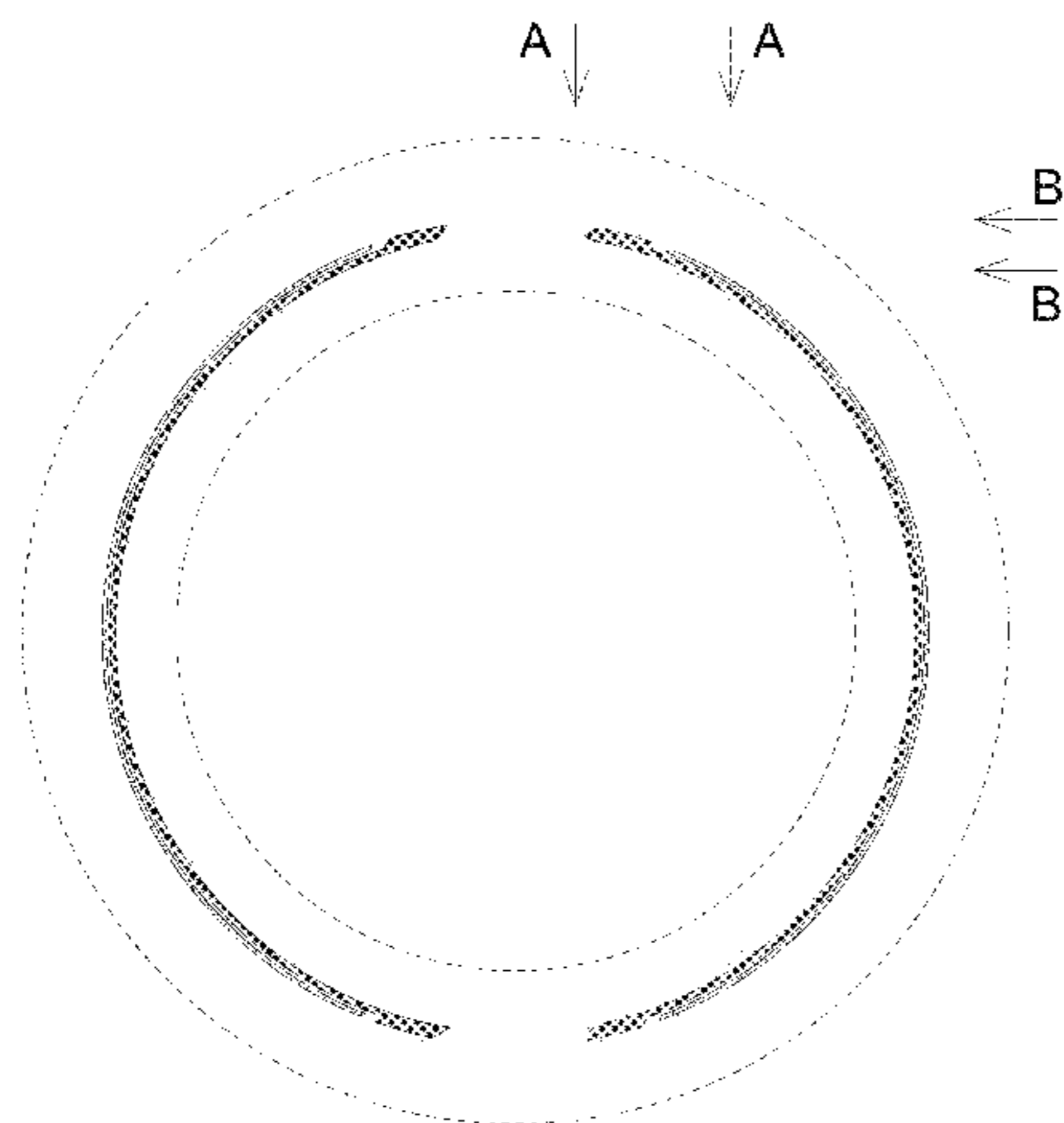
FIG. 17 is a fragmentary enlarged view showing the details of the sidewall portion defined by cross-section by lines A-A and B-B in FIG. 11; and,

FIG. 18 is a section view taken along line 18-18 in FIG. 17.

The broken lines are used to show portions of the tire that are not being claimed, and thus form no part of the claimed design.

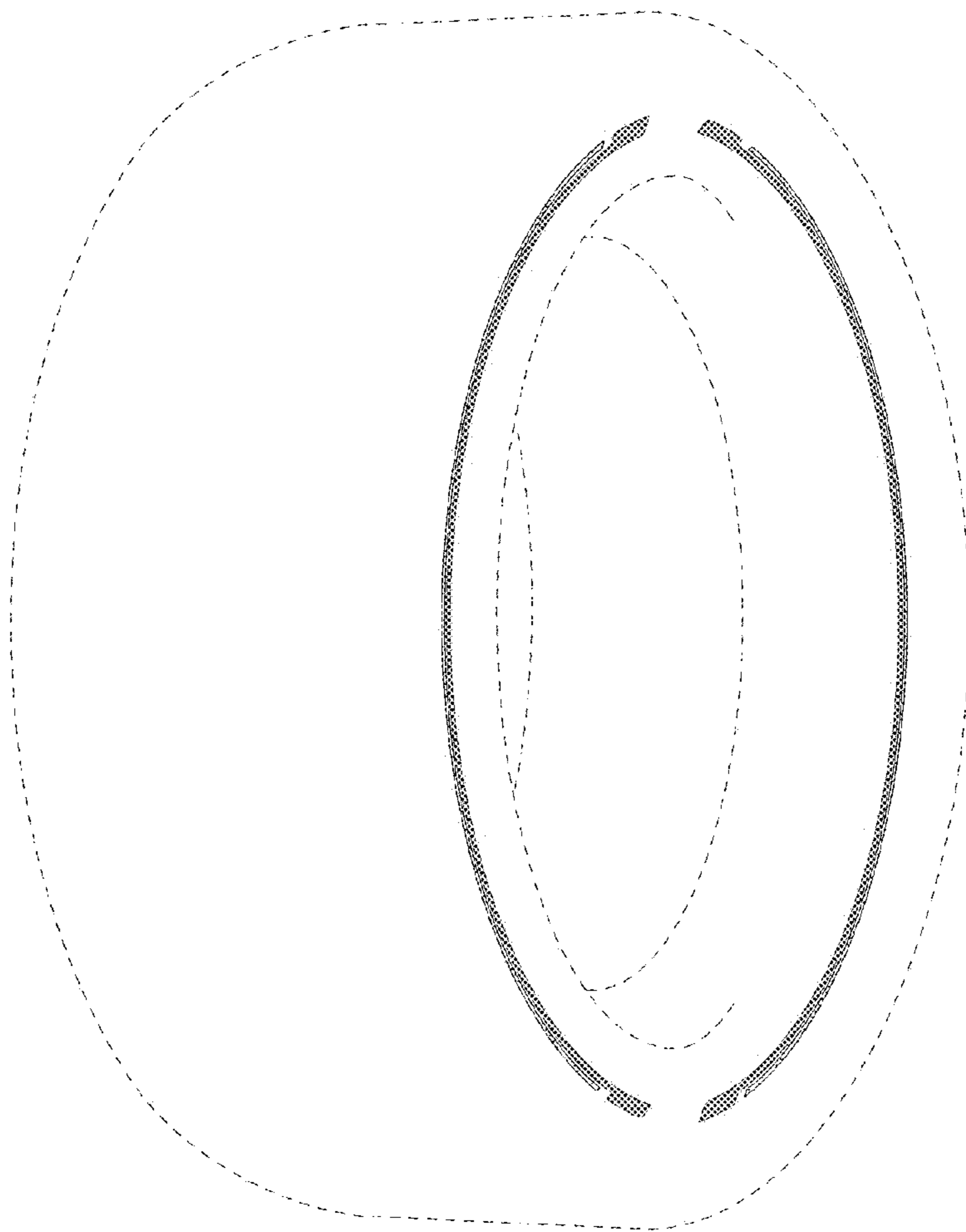

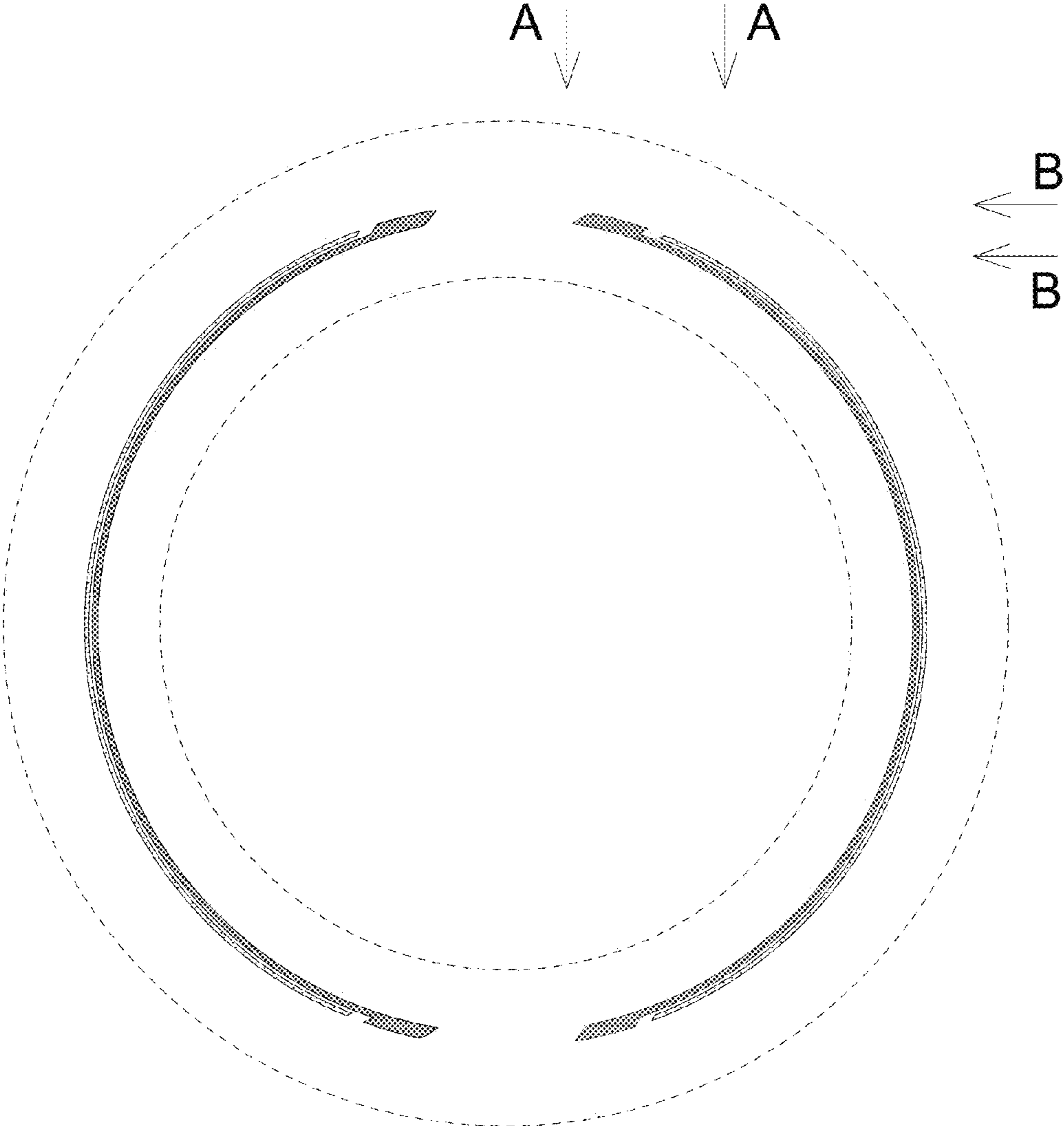

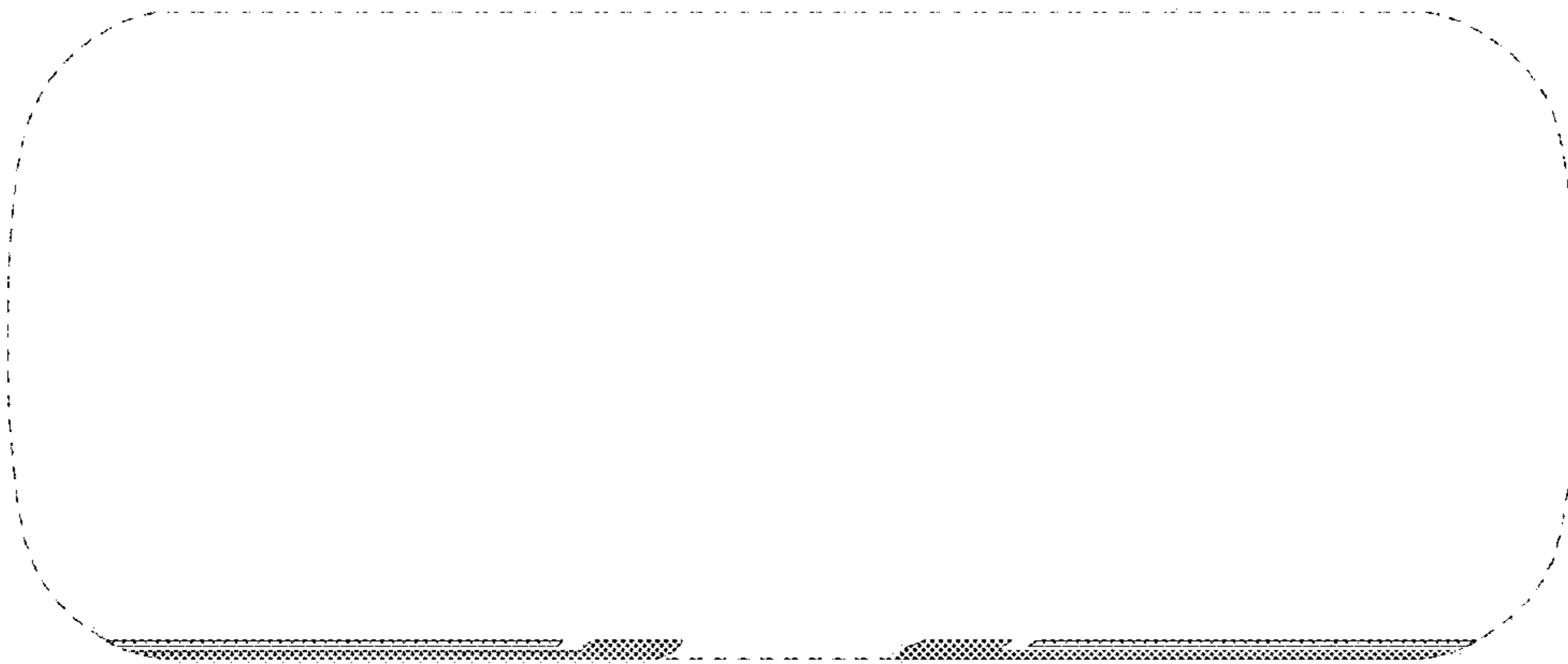

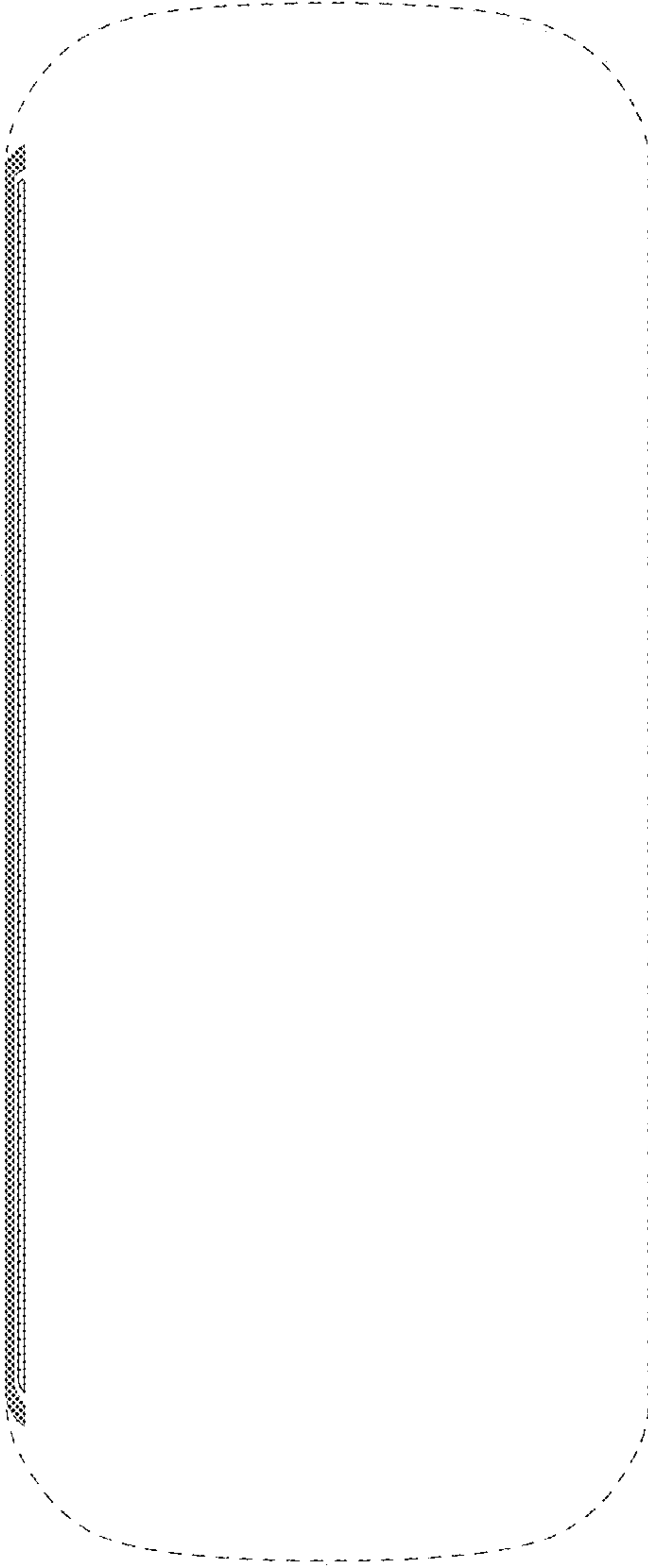

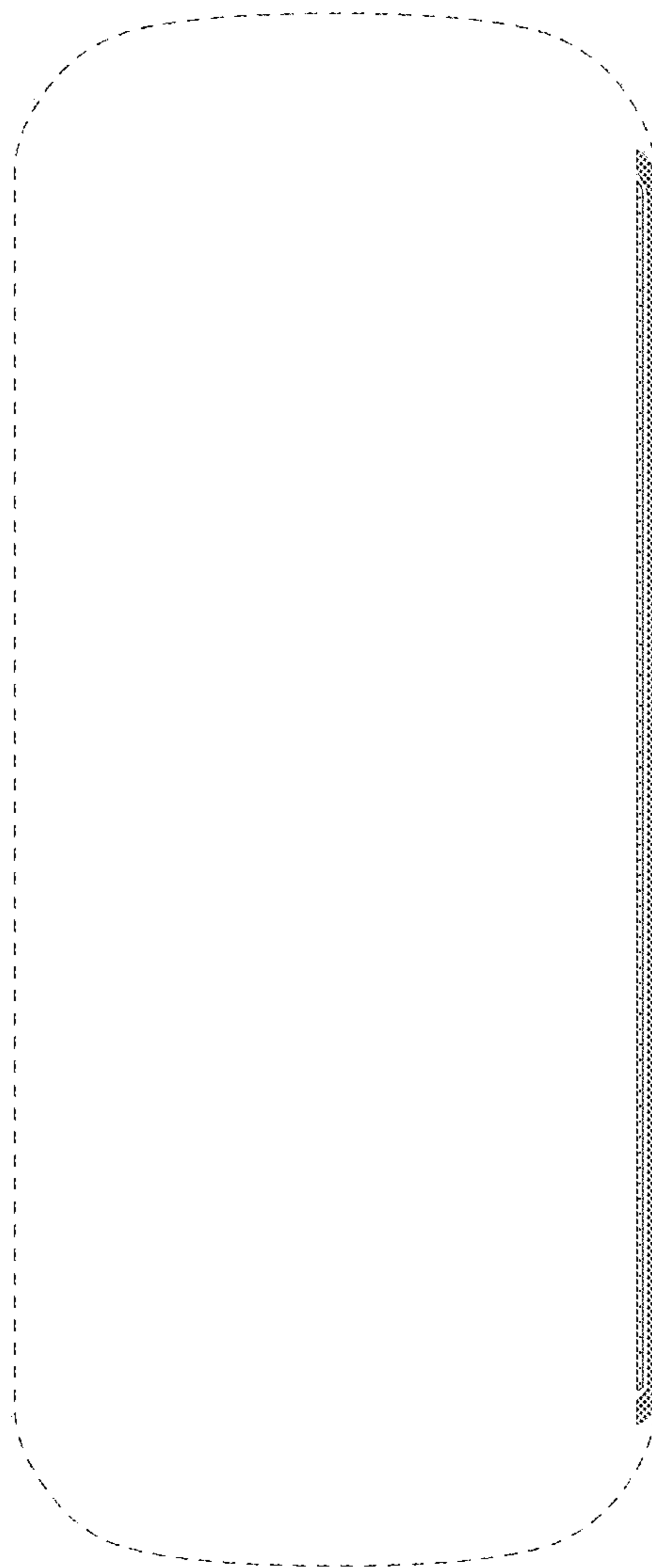

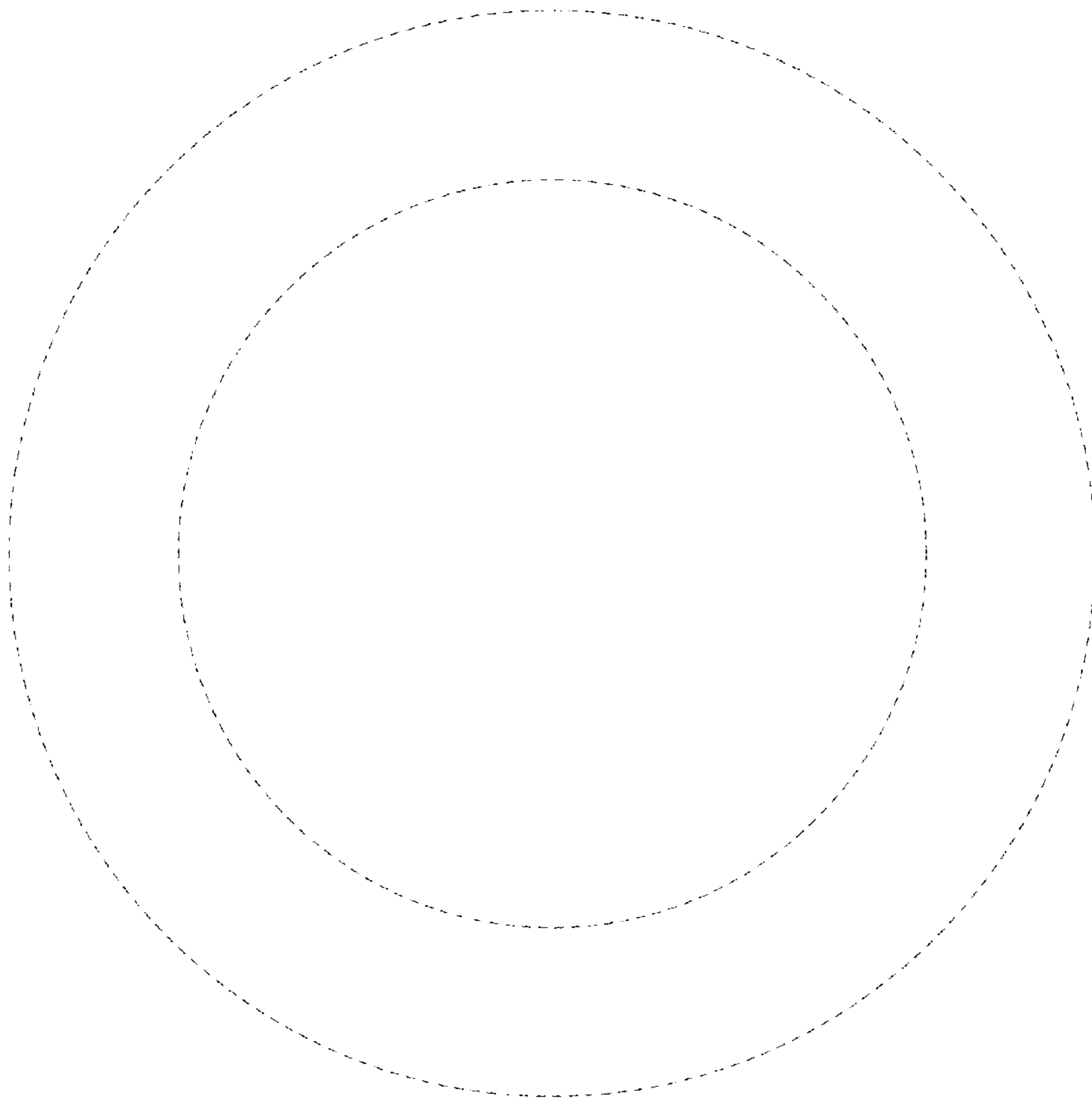

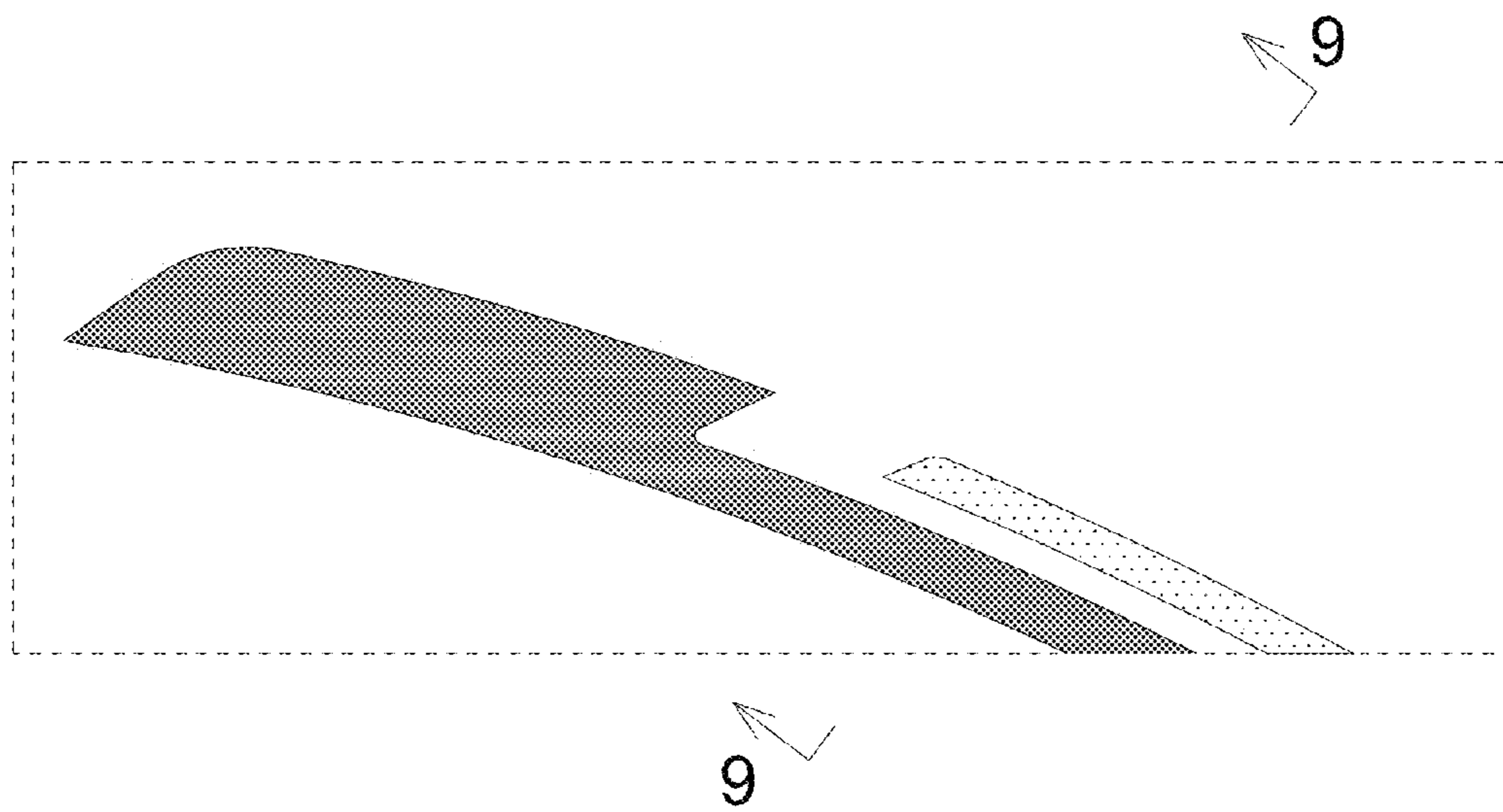

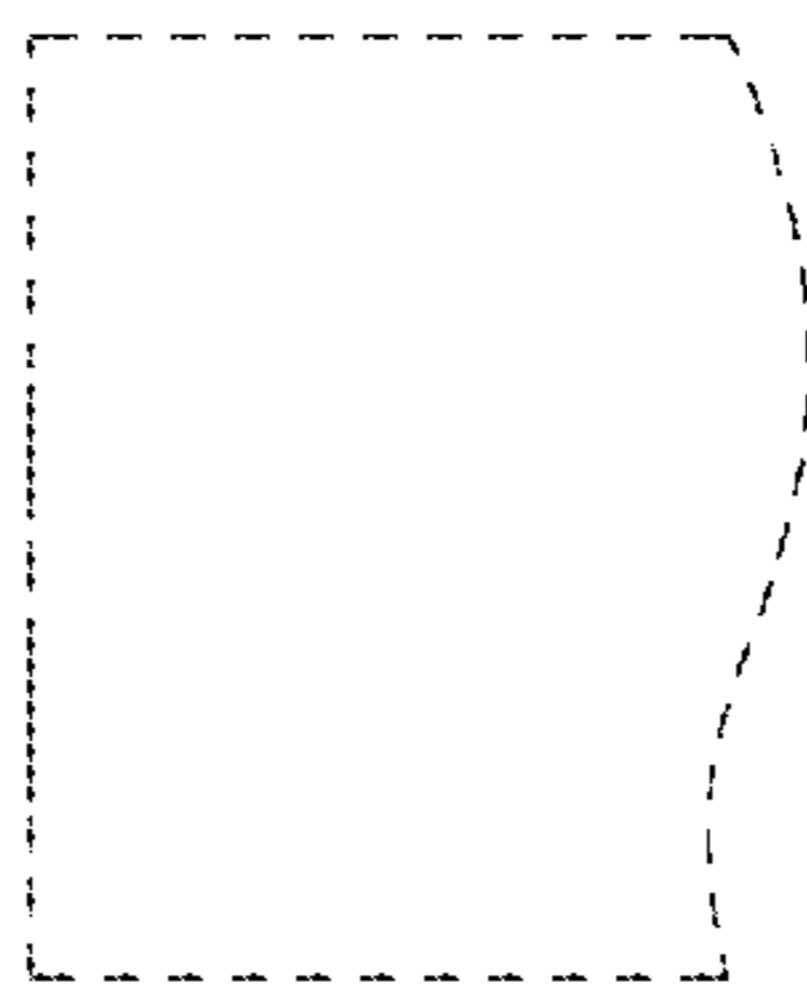

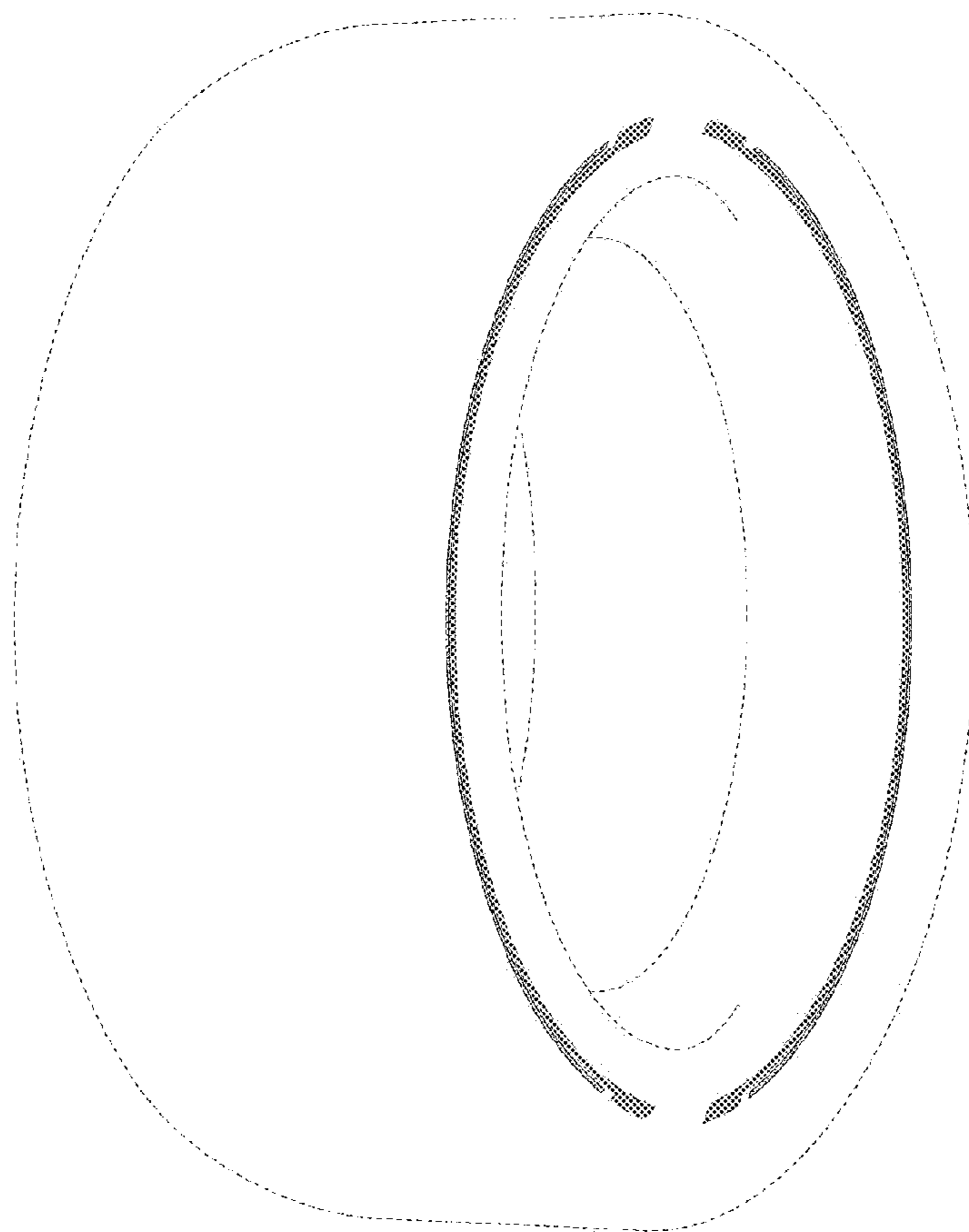

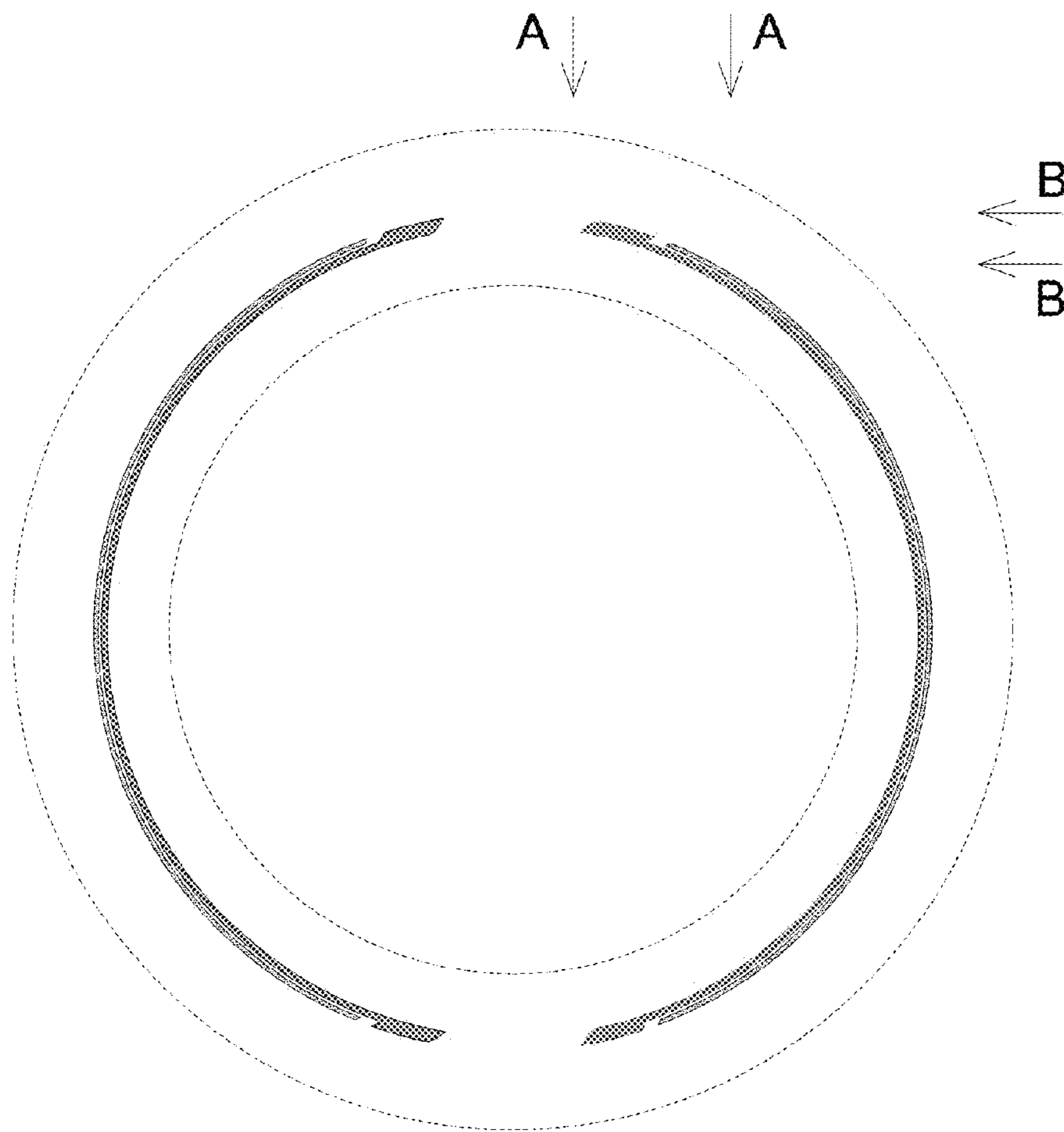

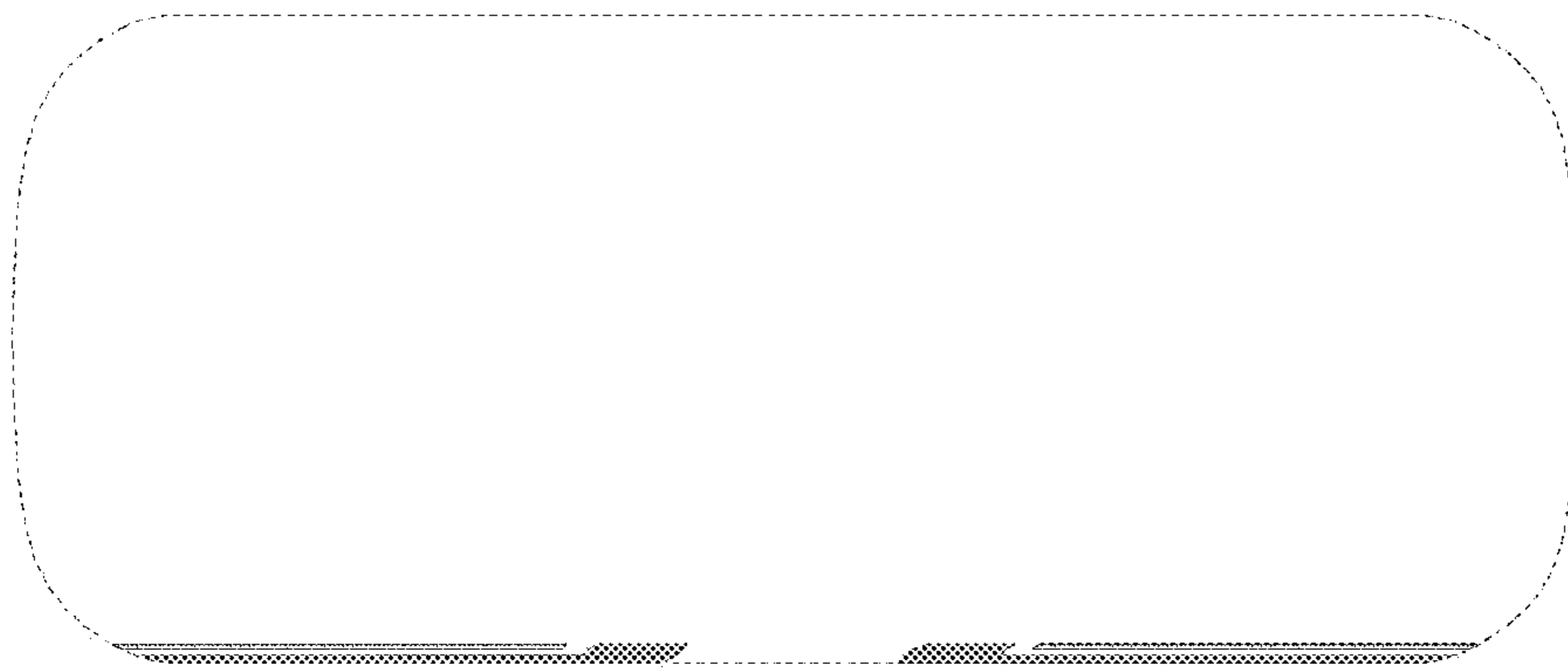

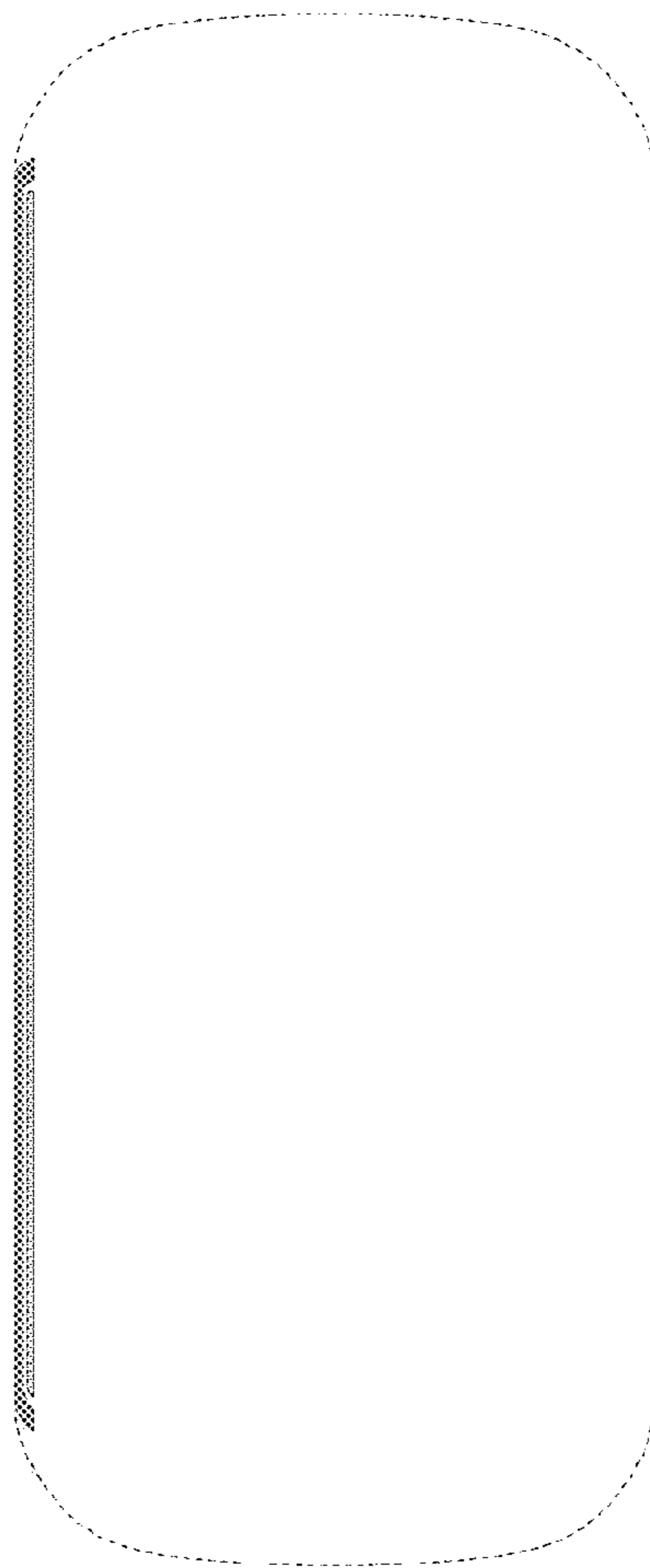

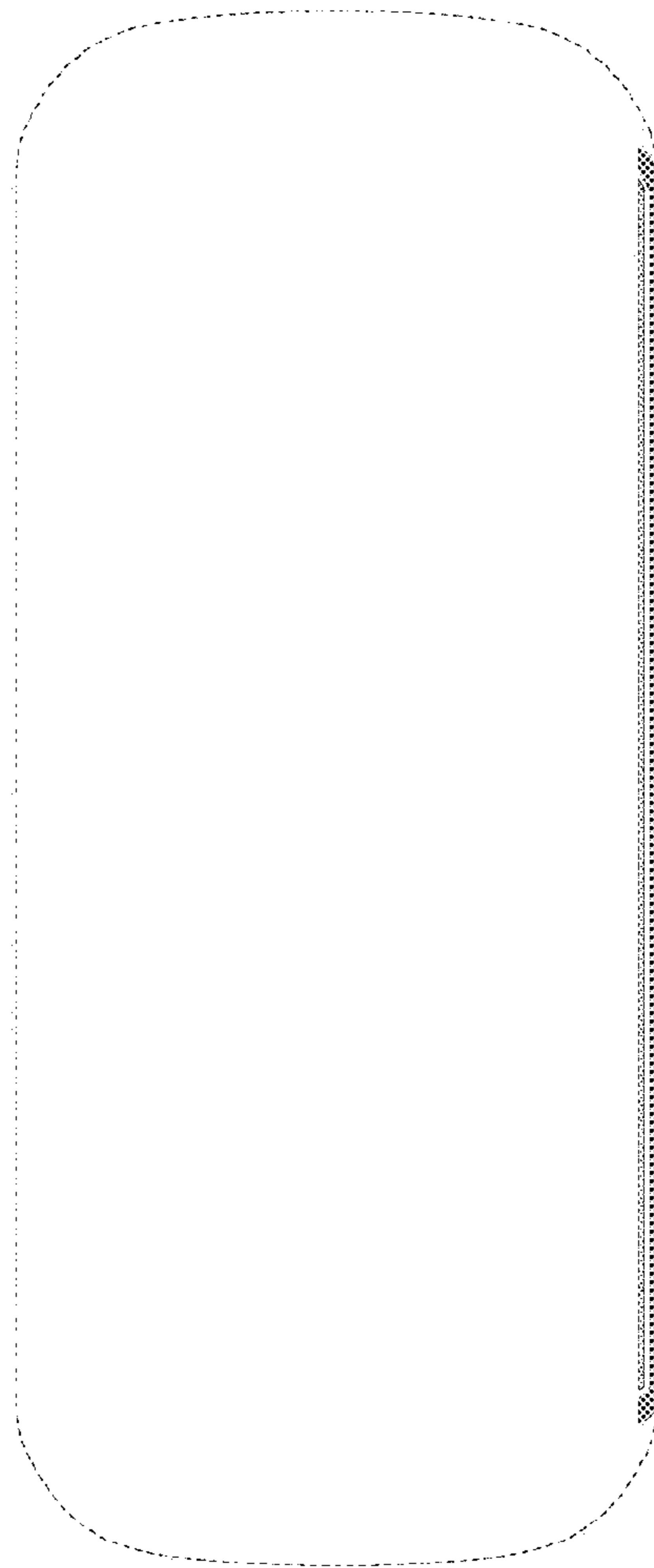

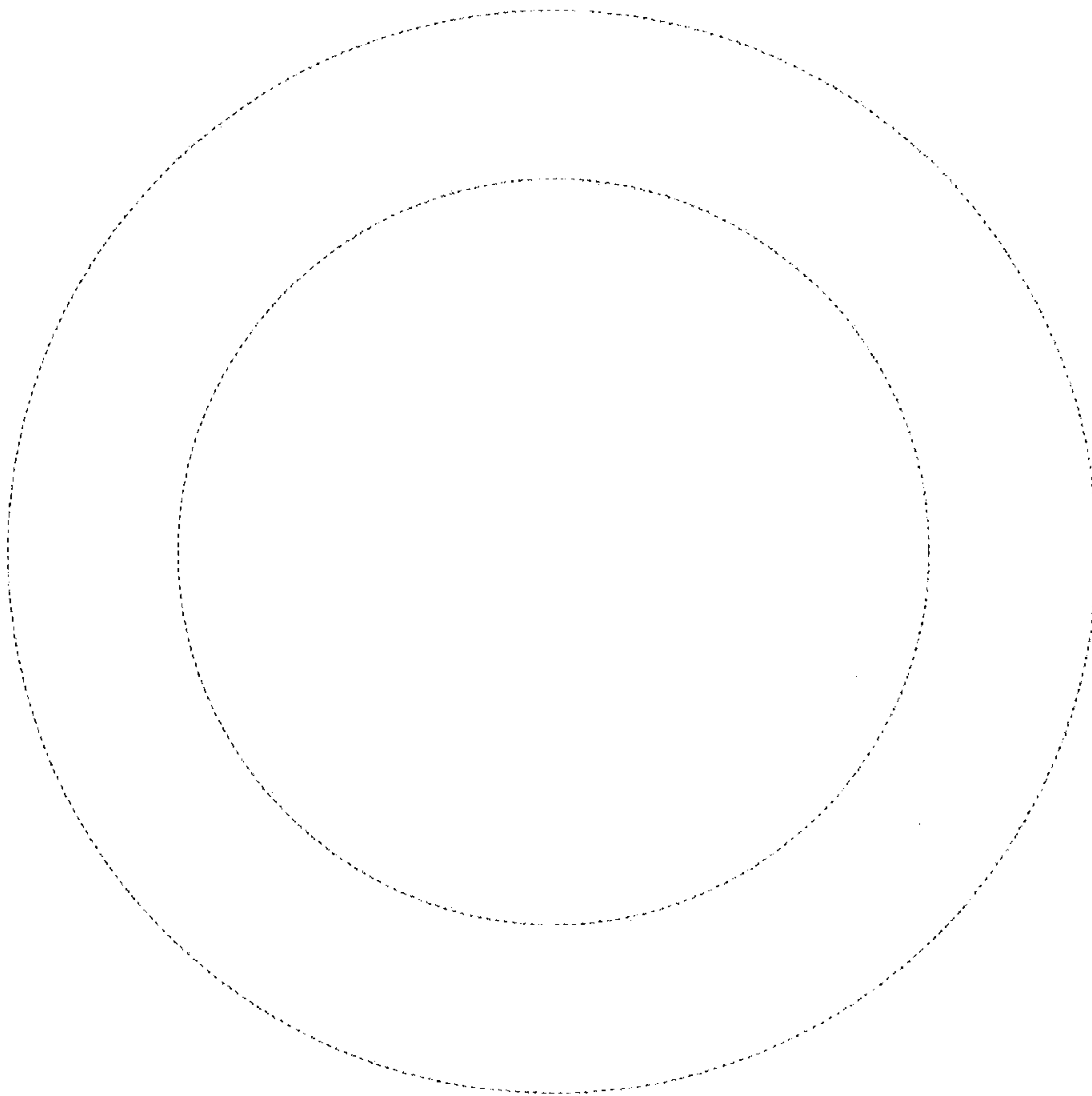

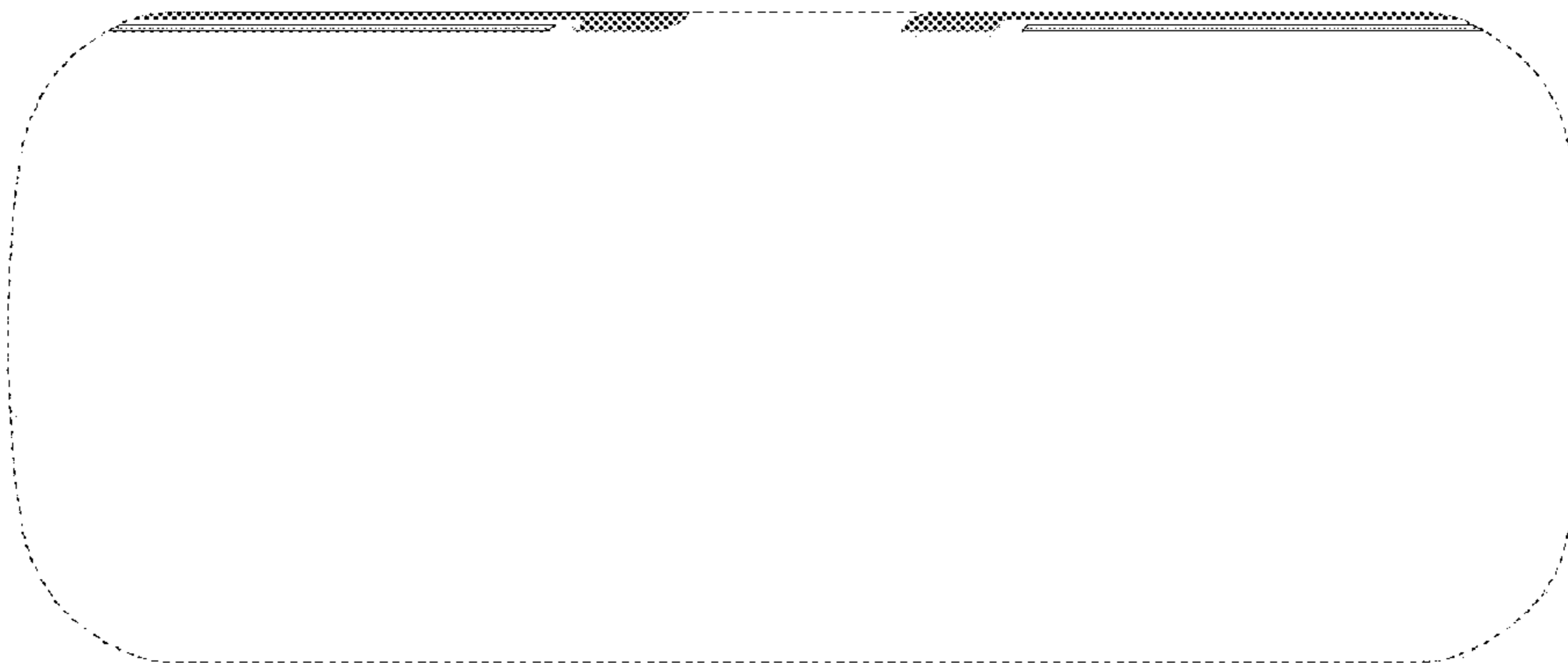

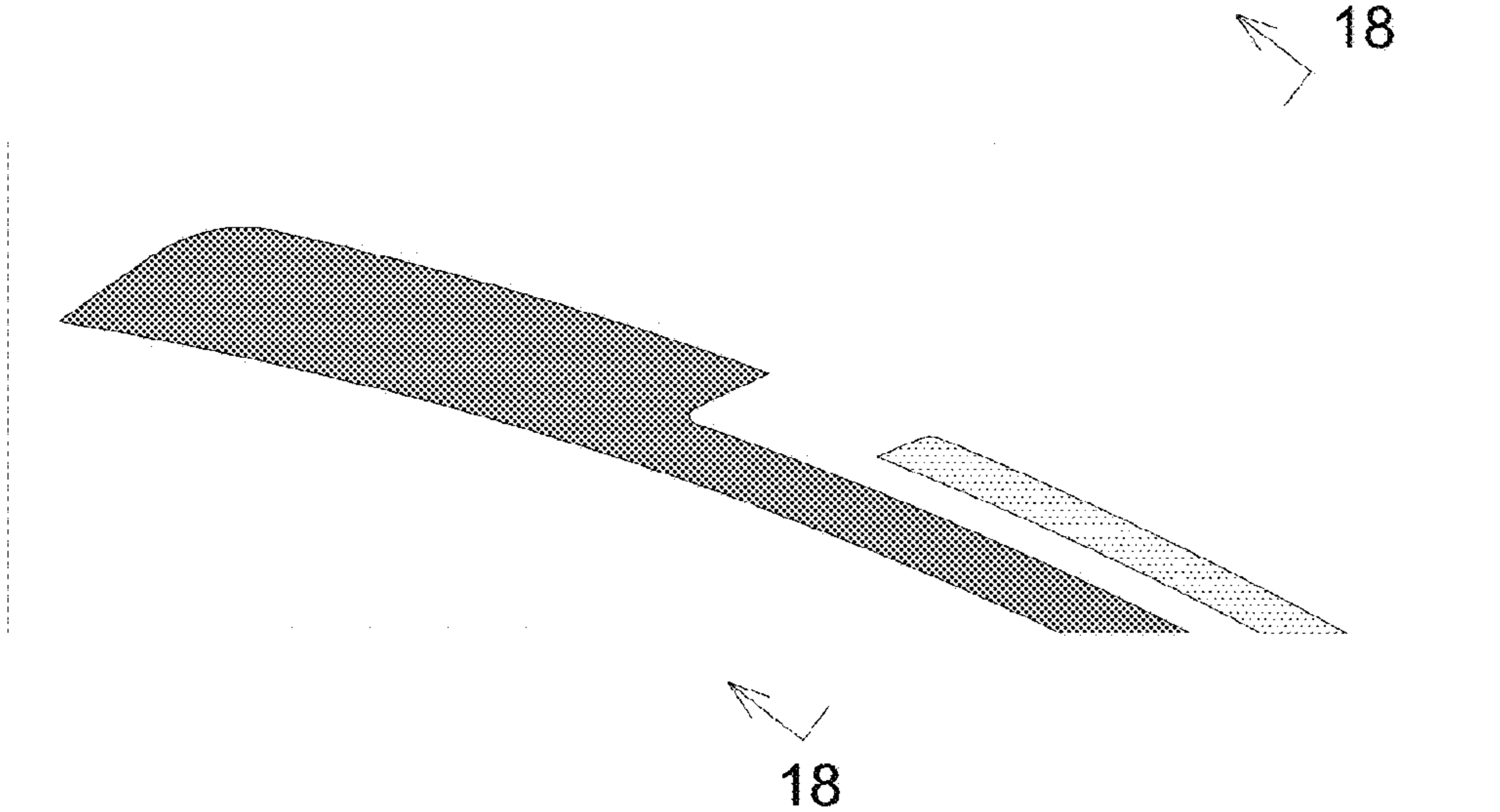
