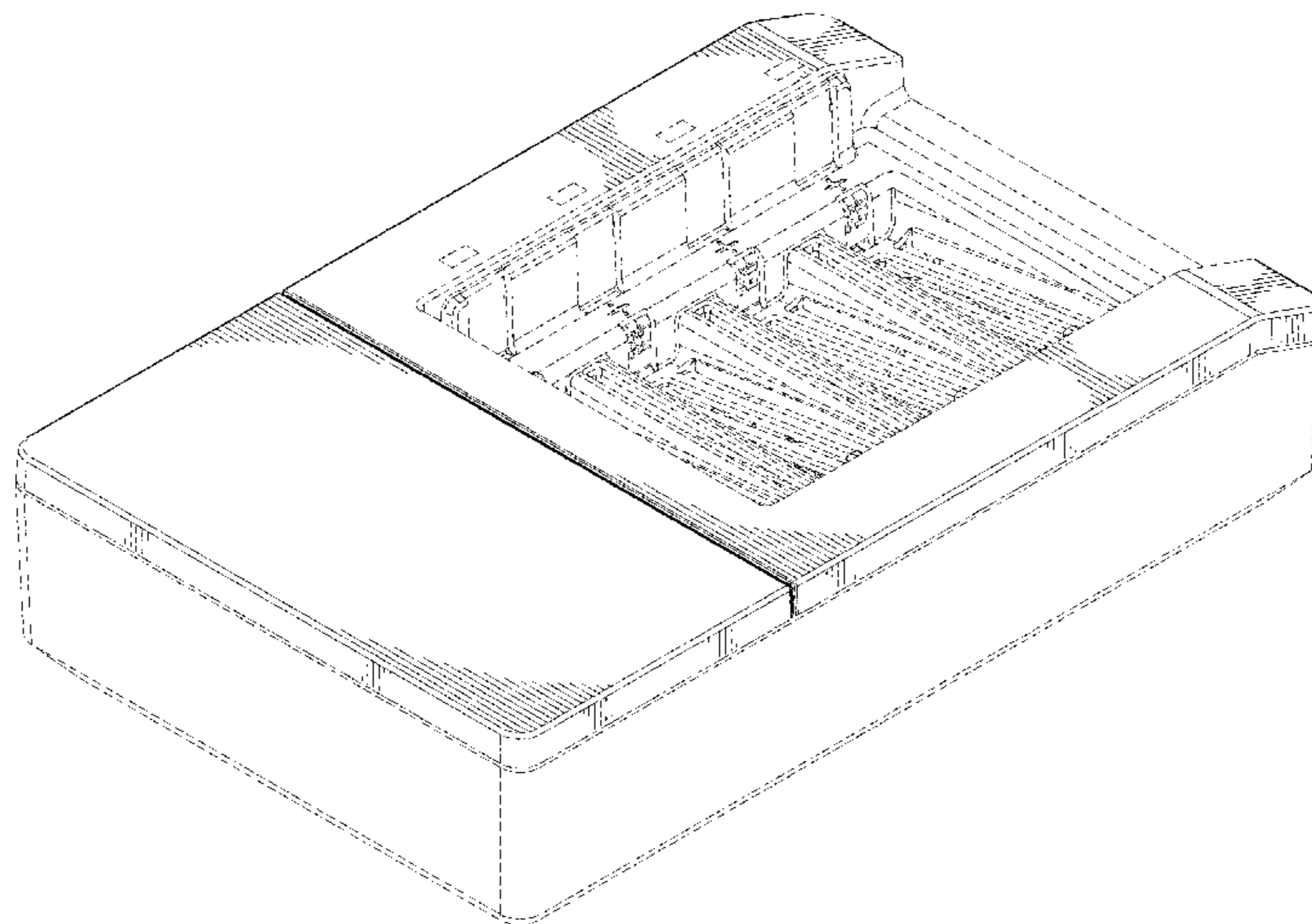
The ornamental design for a battery charger, as shown and described above.

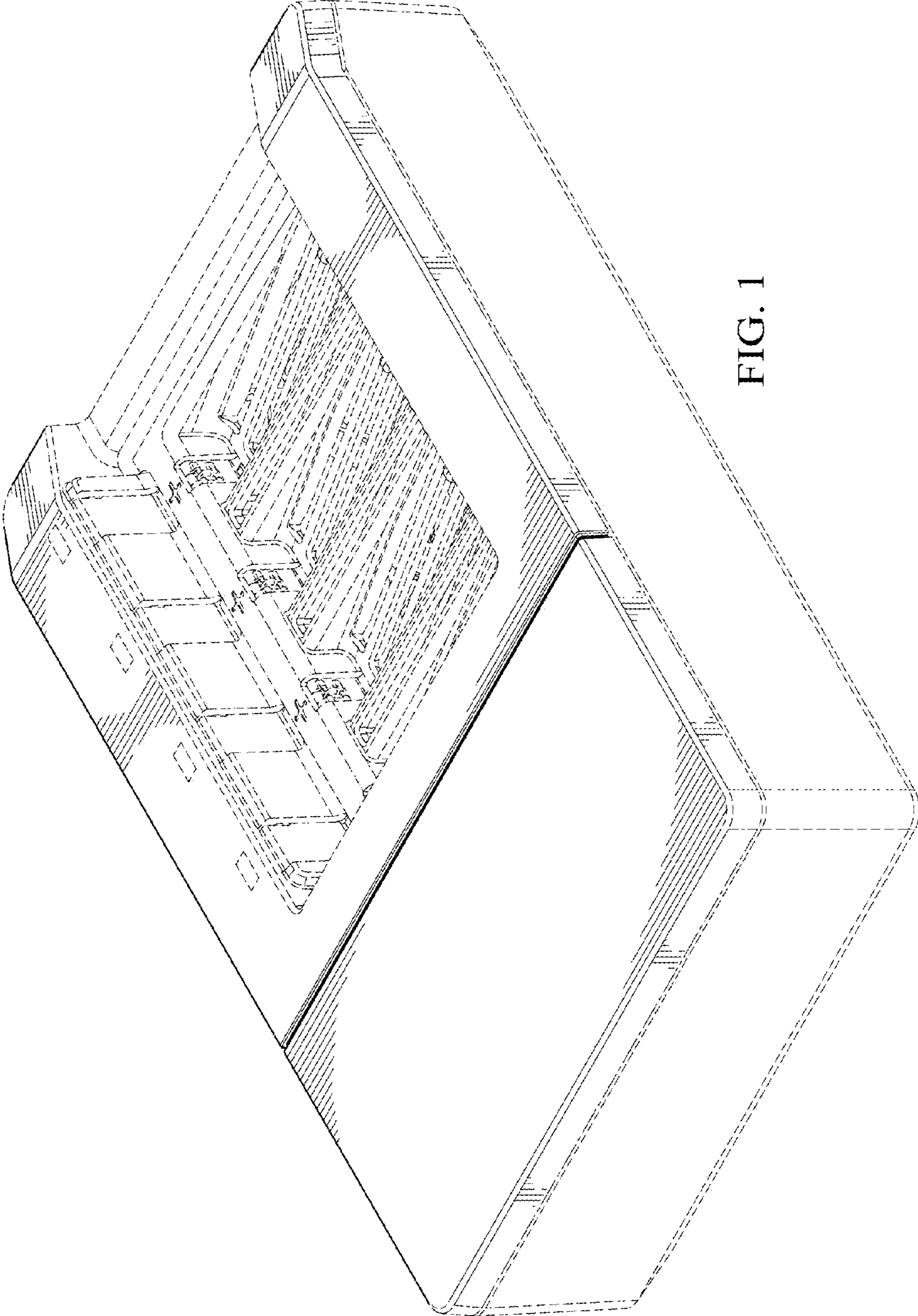

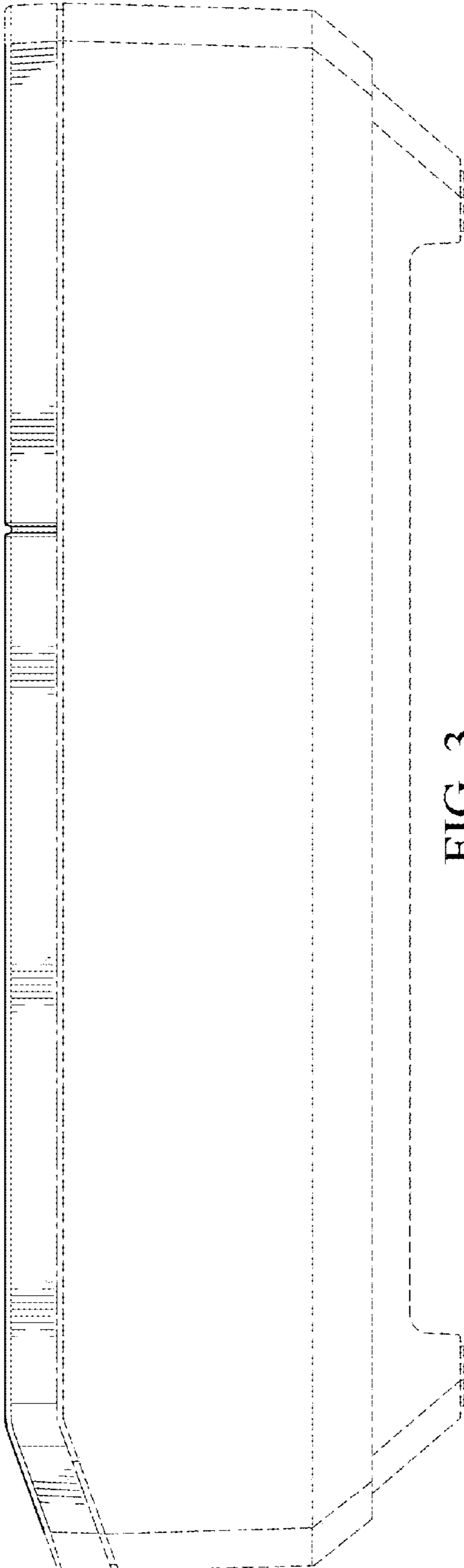

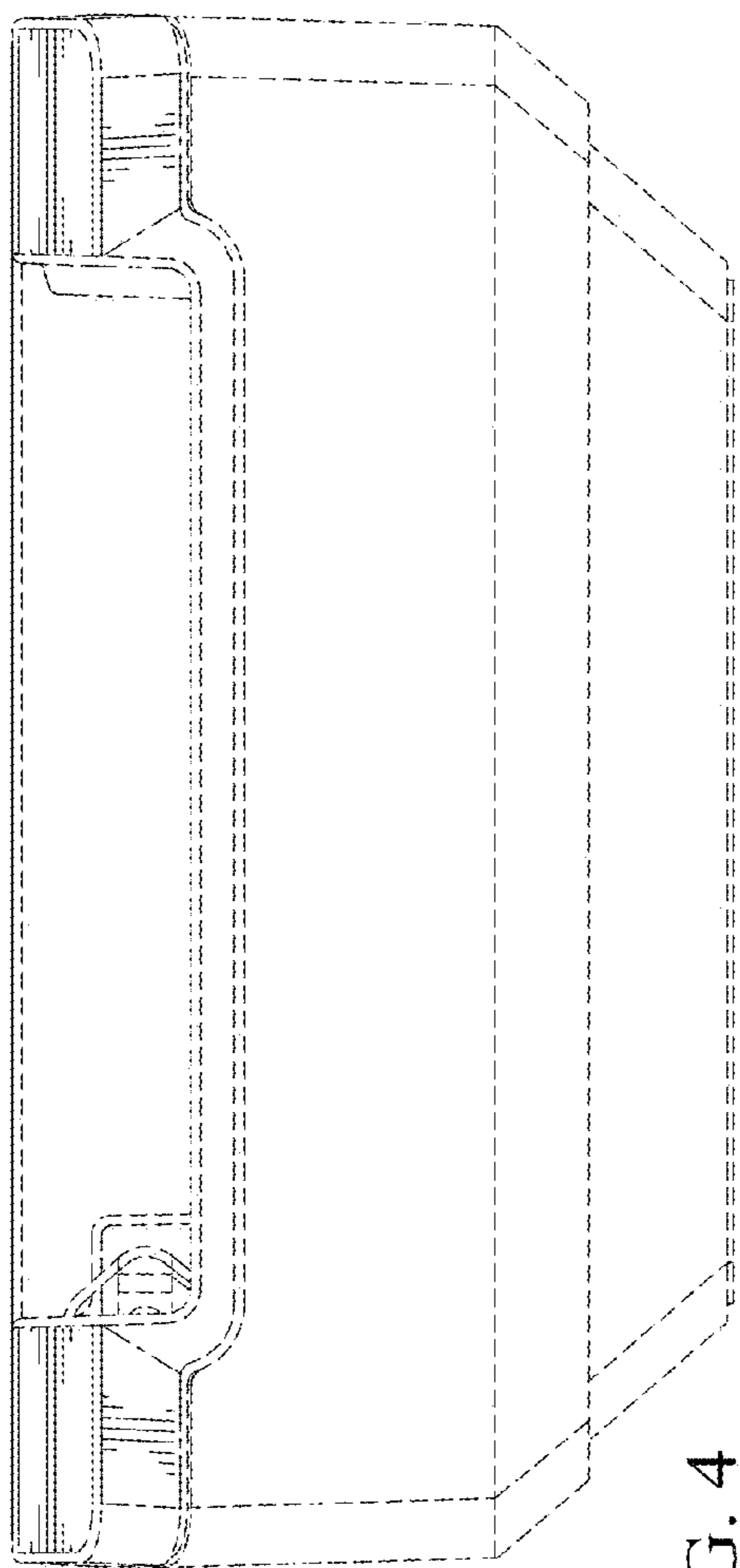

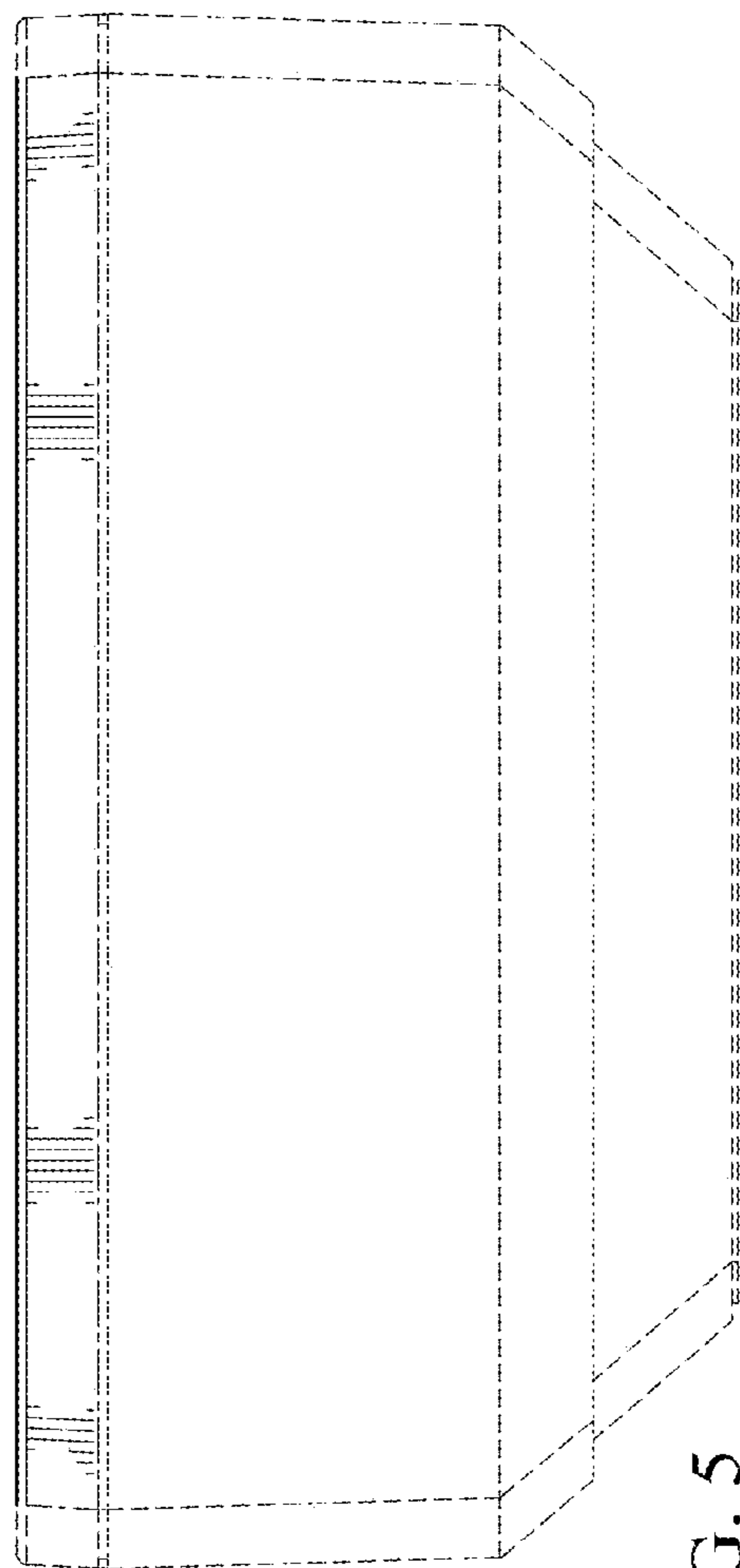

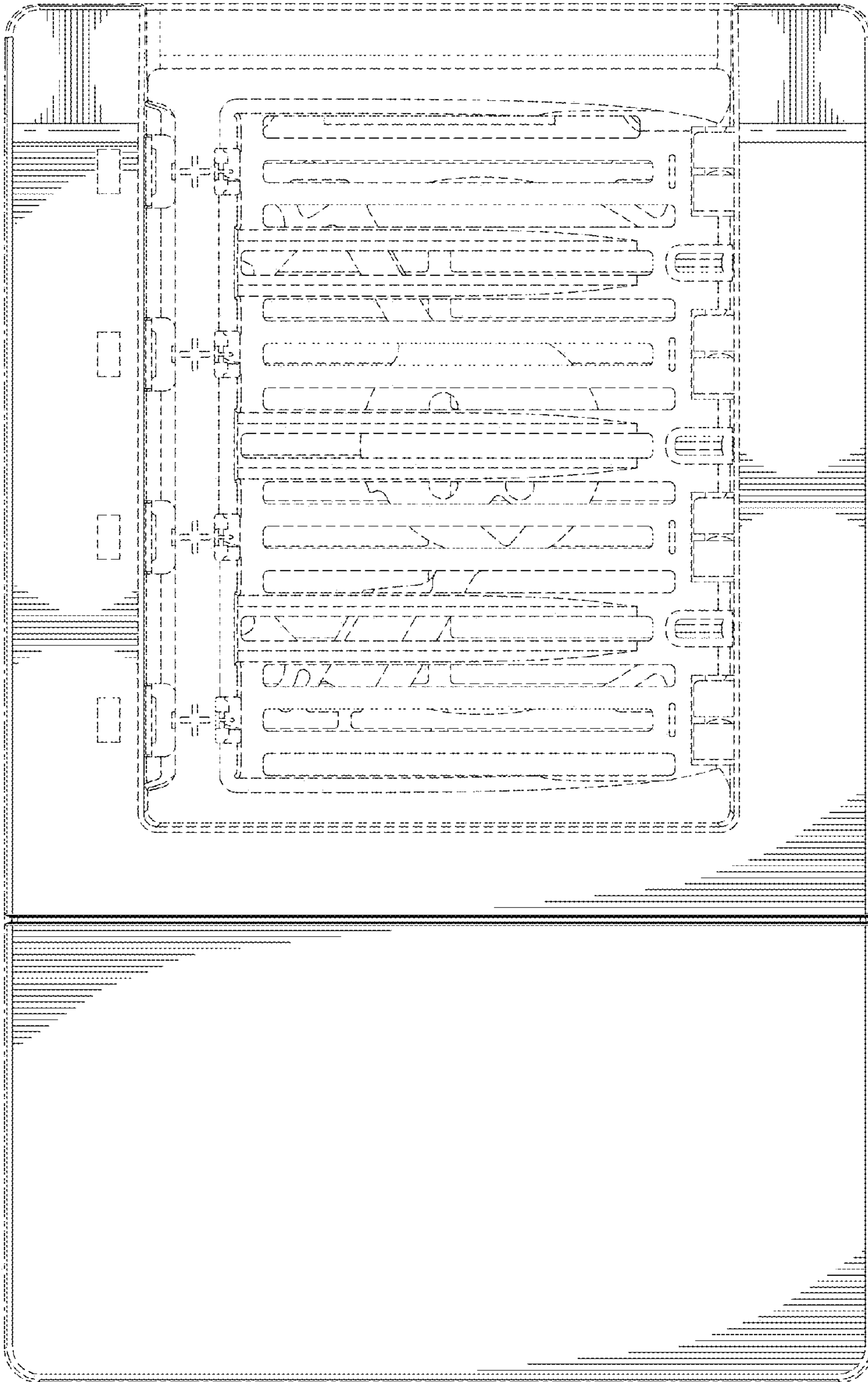

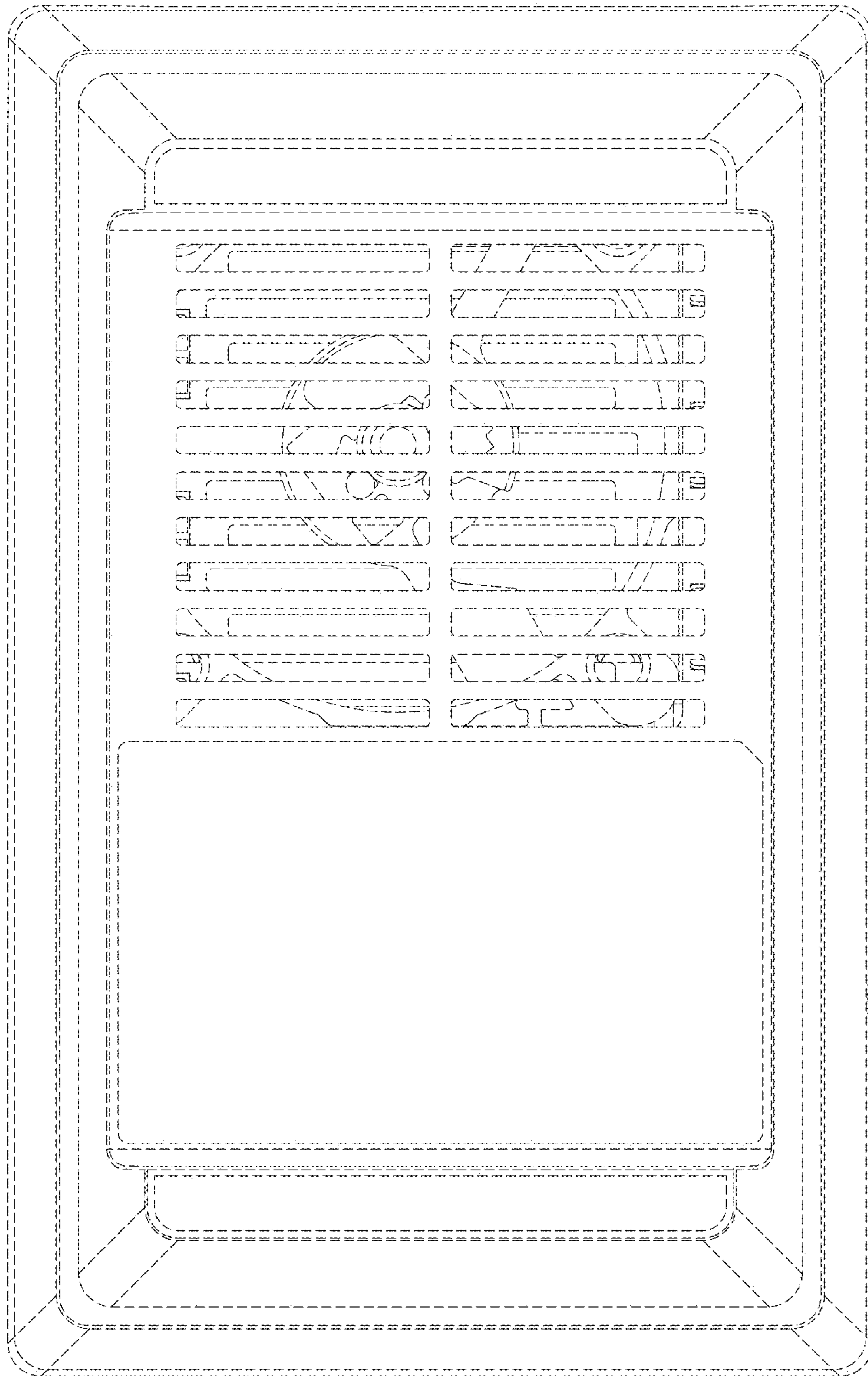

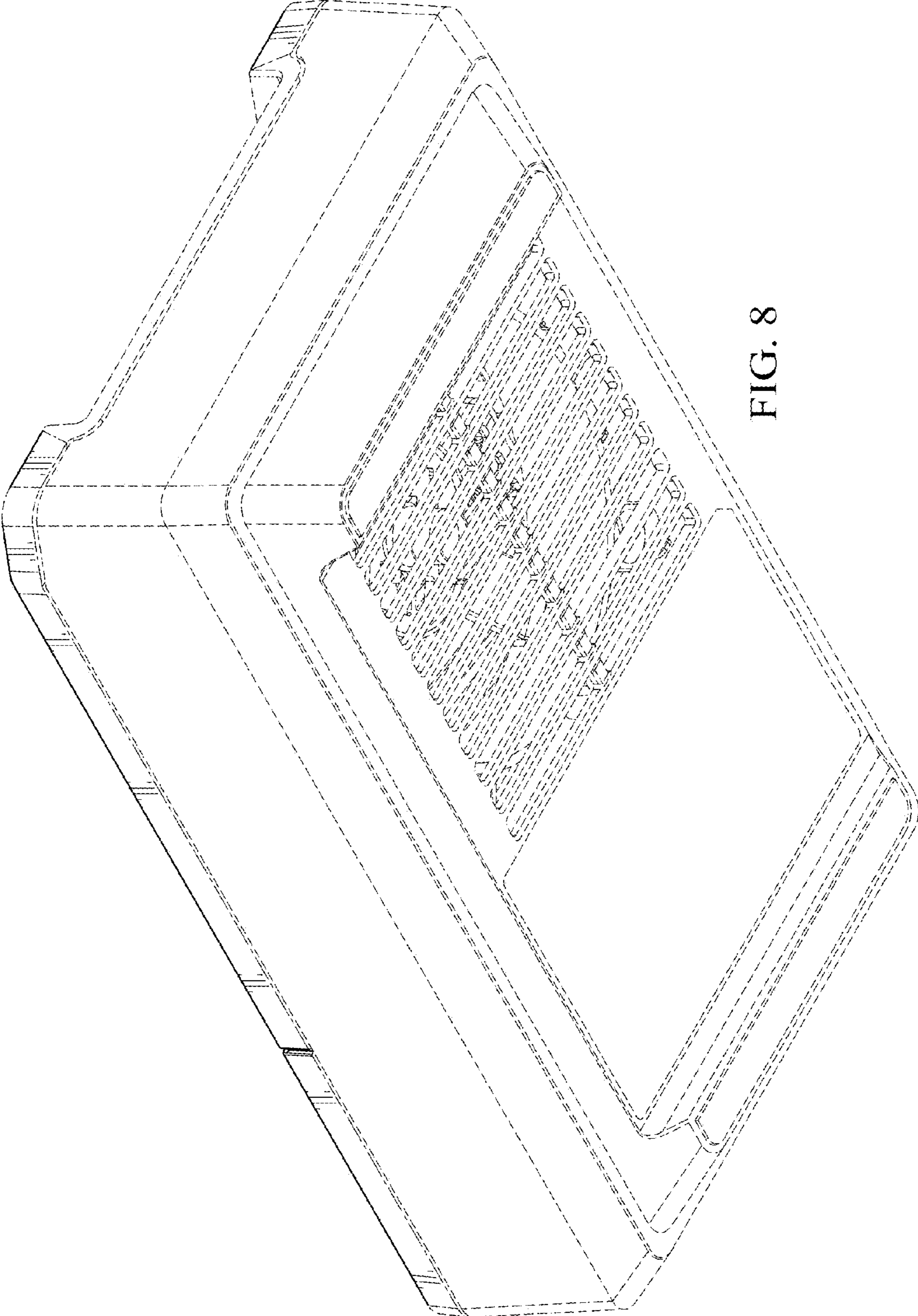
