FIG. 5 is a left plane view thereof;

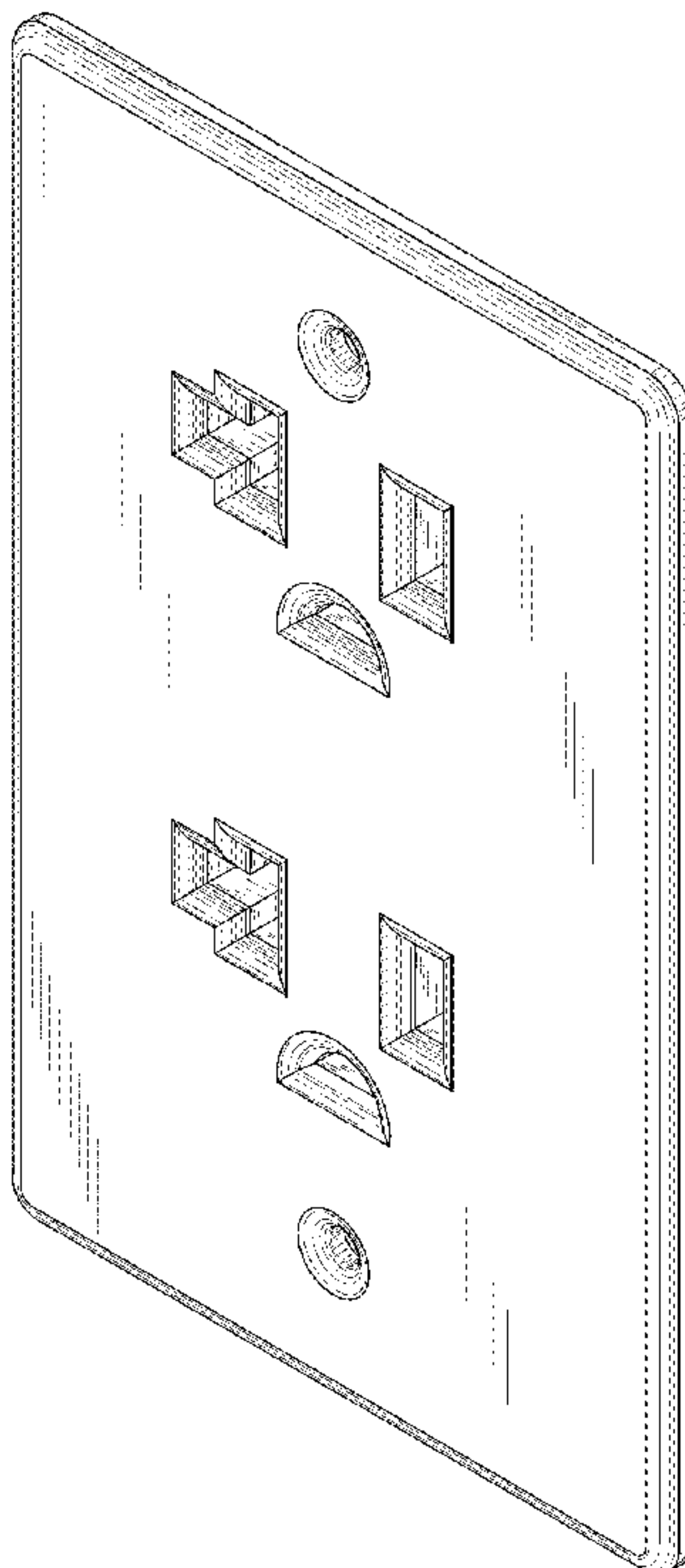
FIG. 6 is a right plane view thereof;

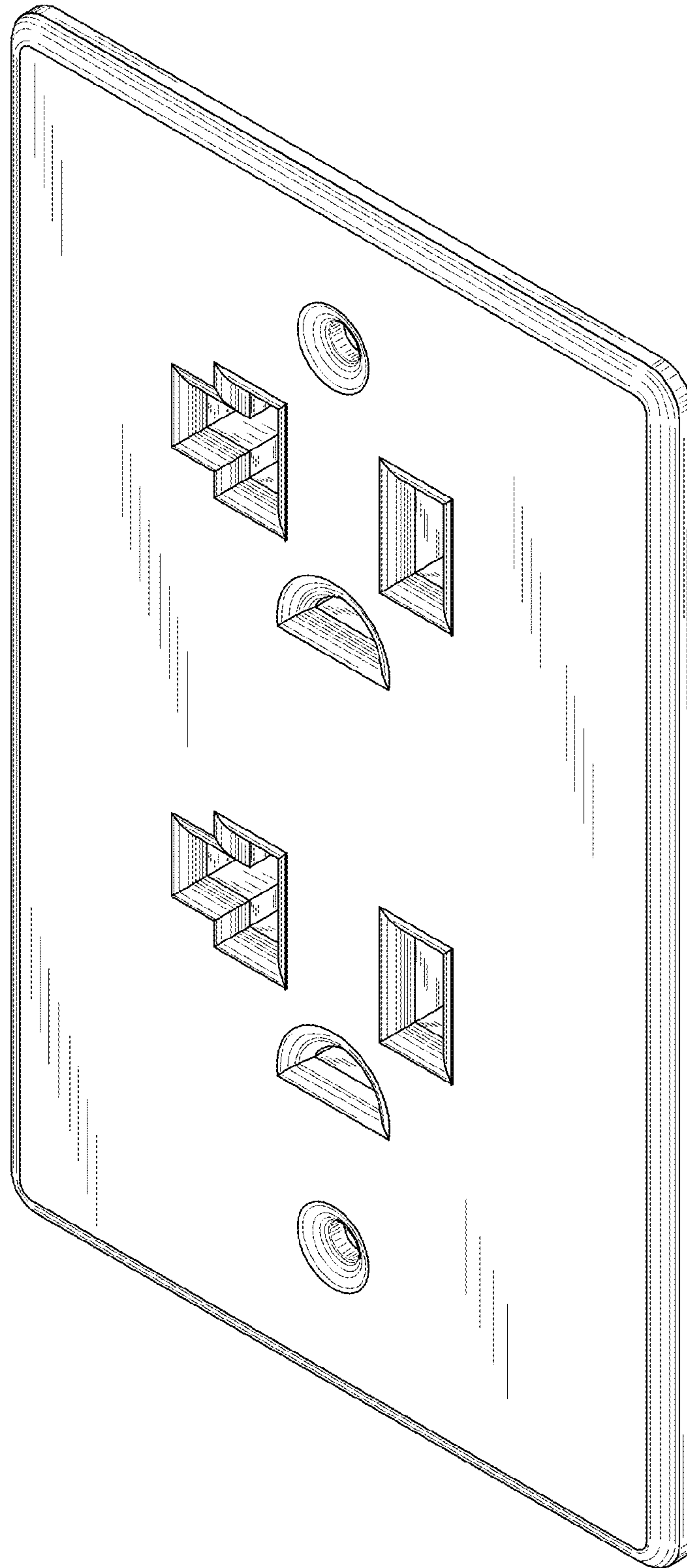

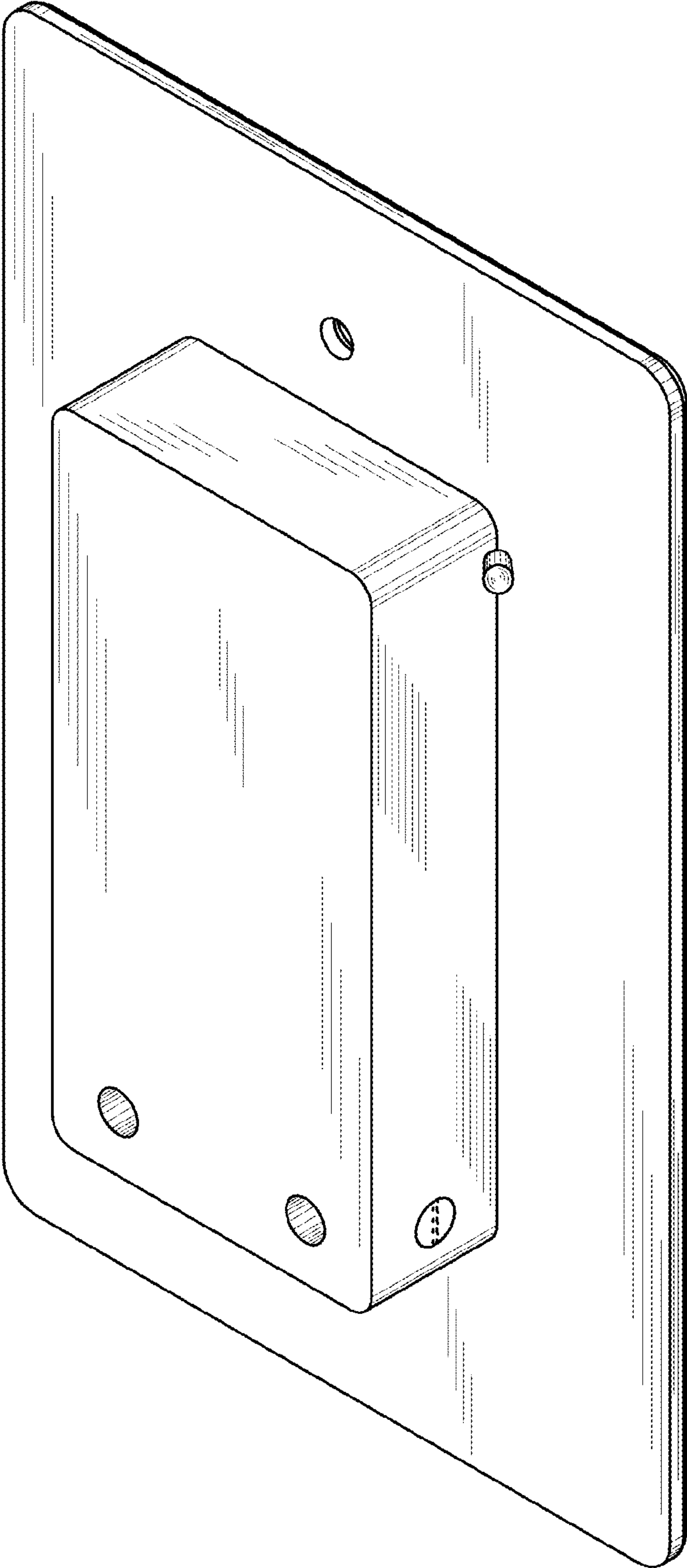

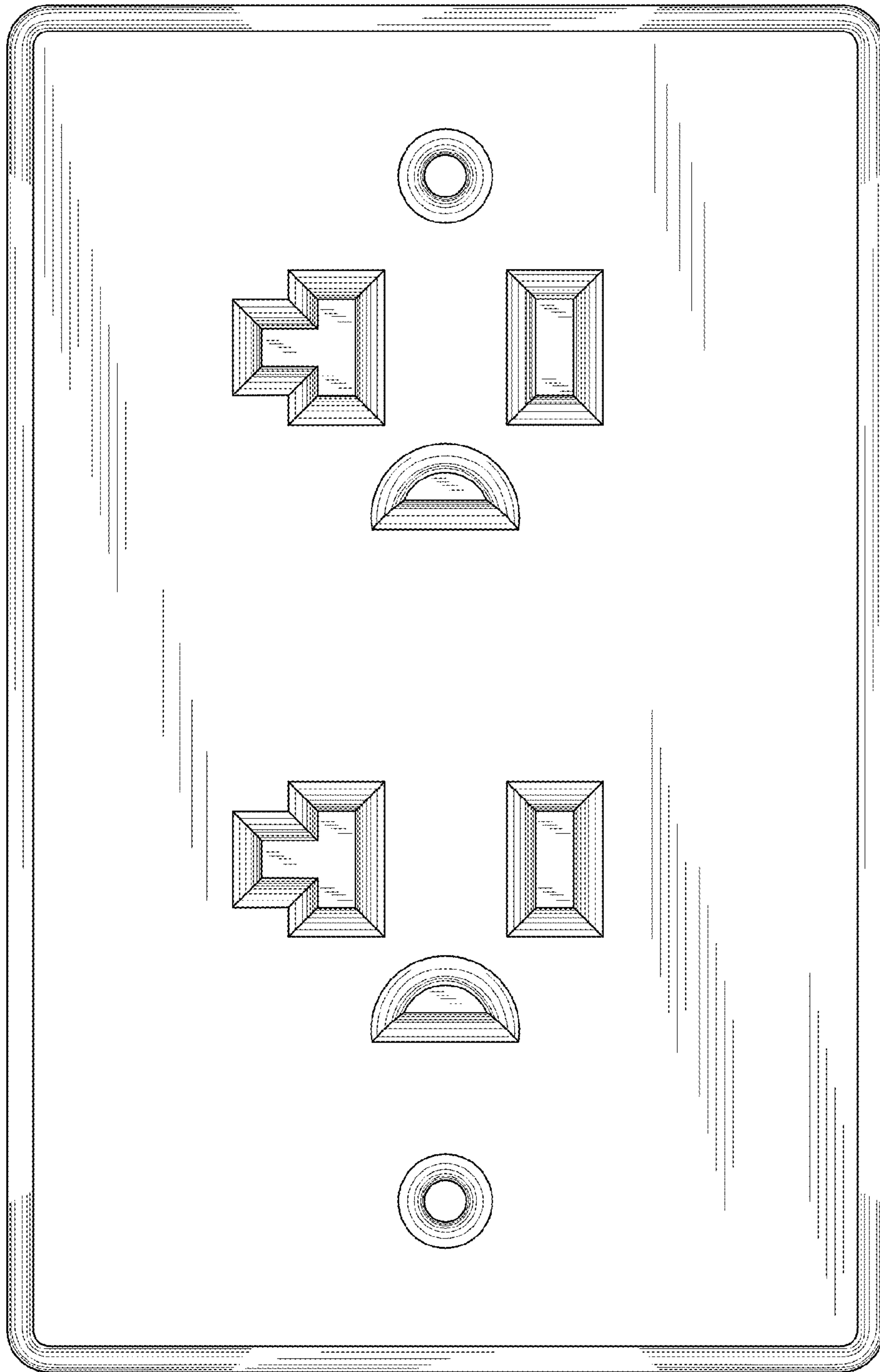

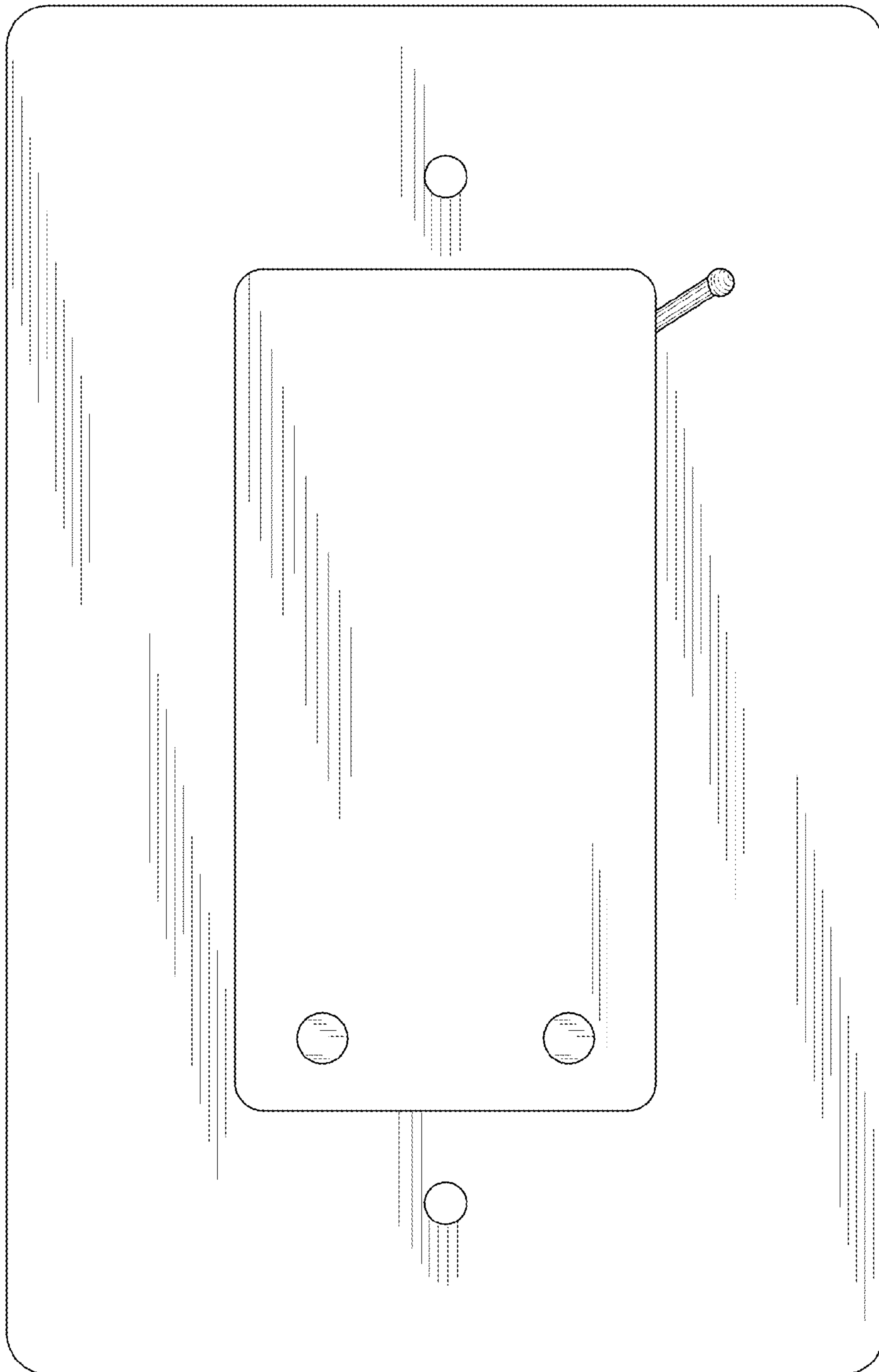

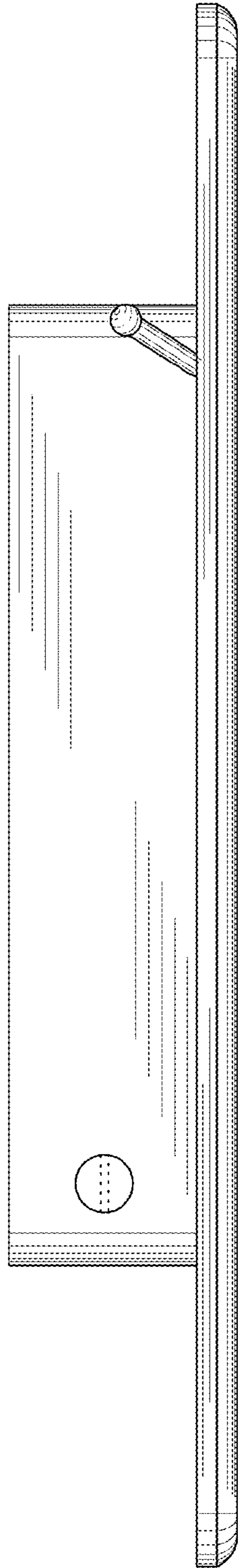

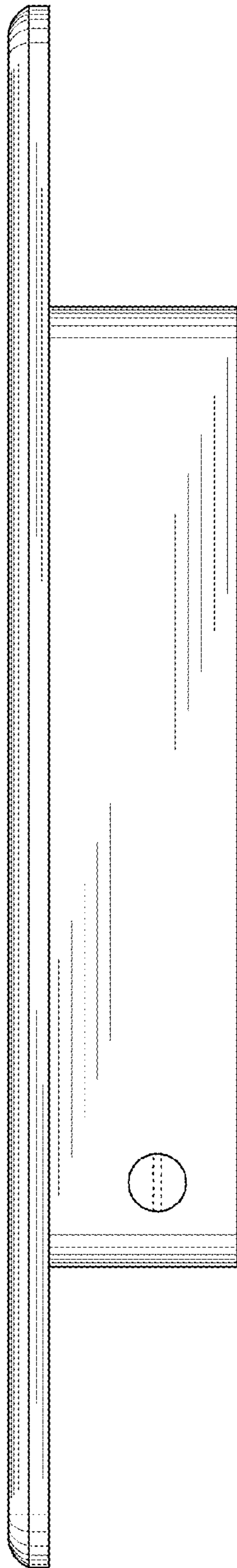

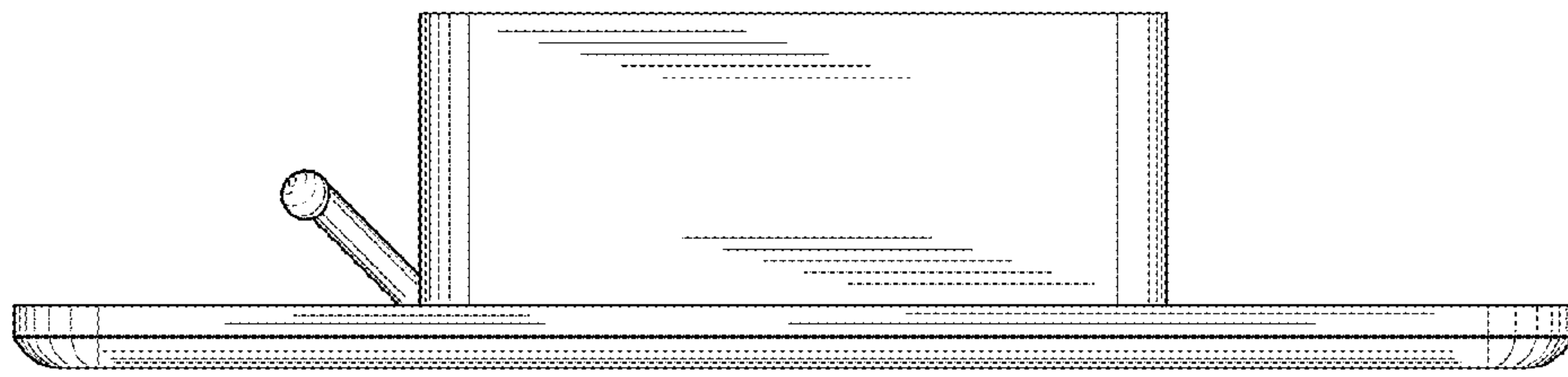

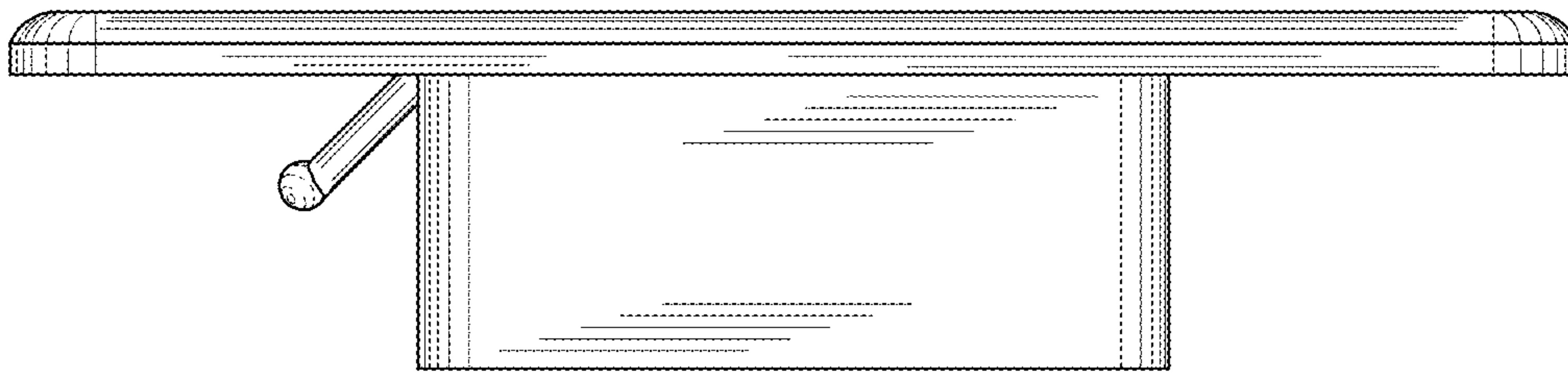
