DESCRIPTION

FIG. 6 is a perspective view of the front, right side and bottom thereof.

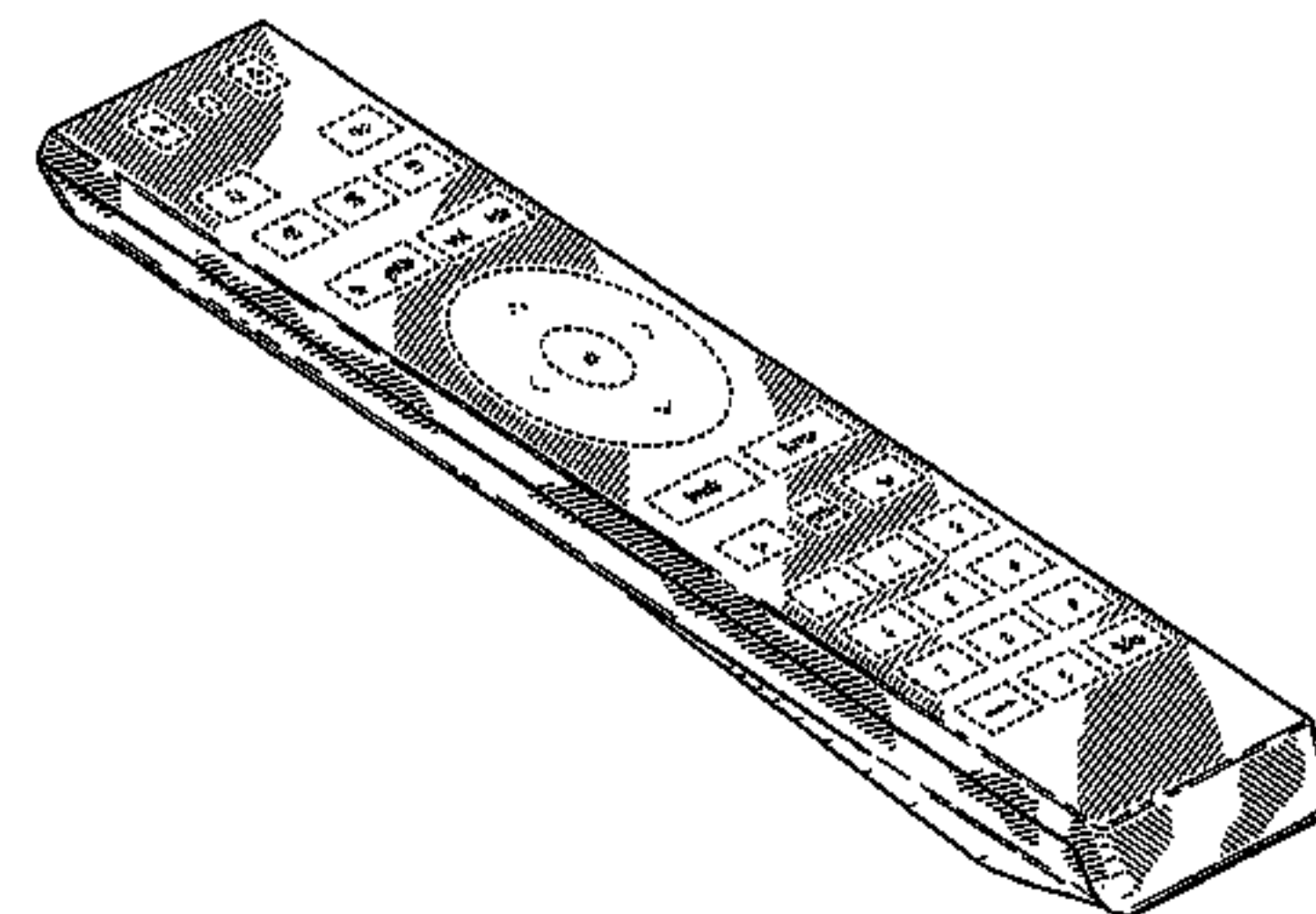
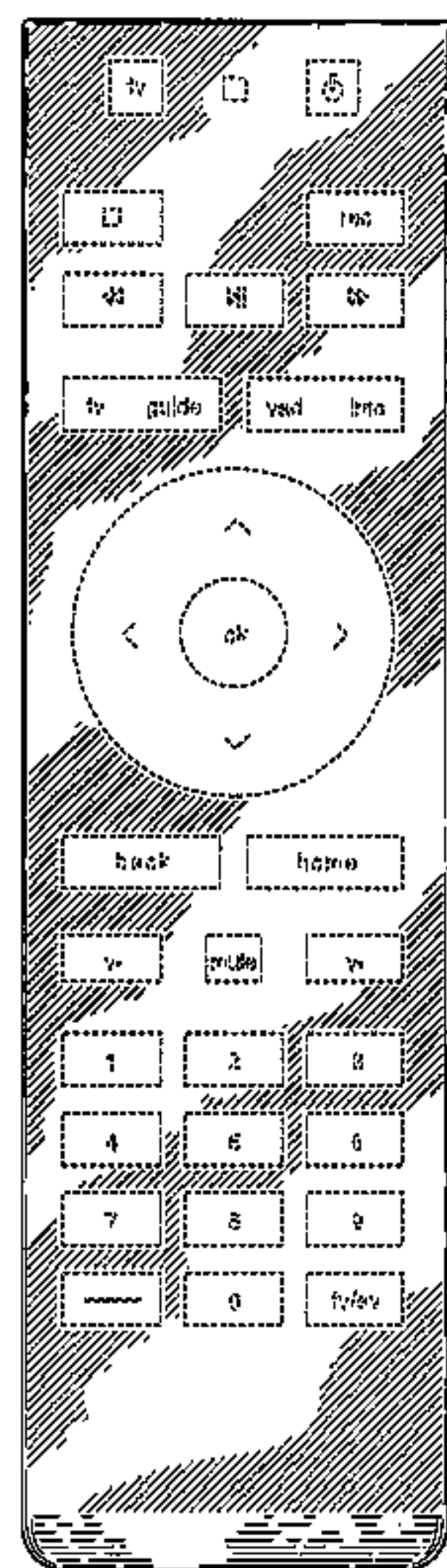
The broken lines in the figures illustrate unclaimed environment and form no part of the claimed design.

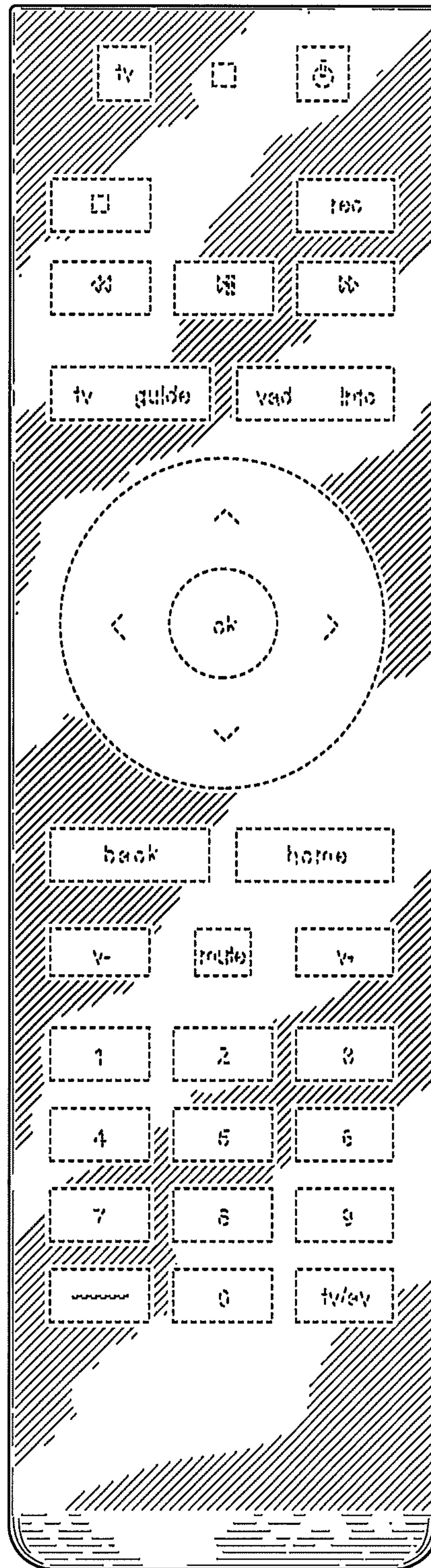

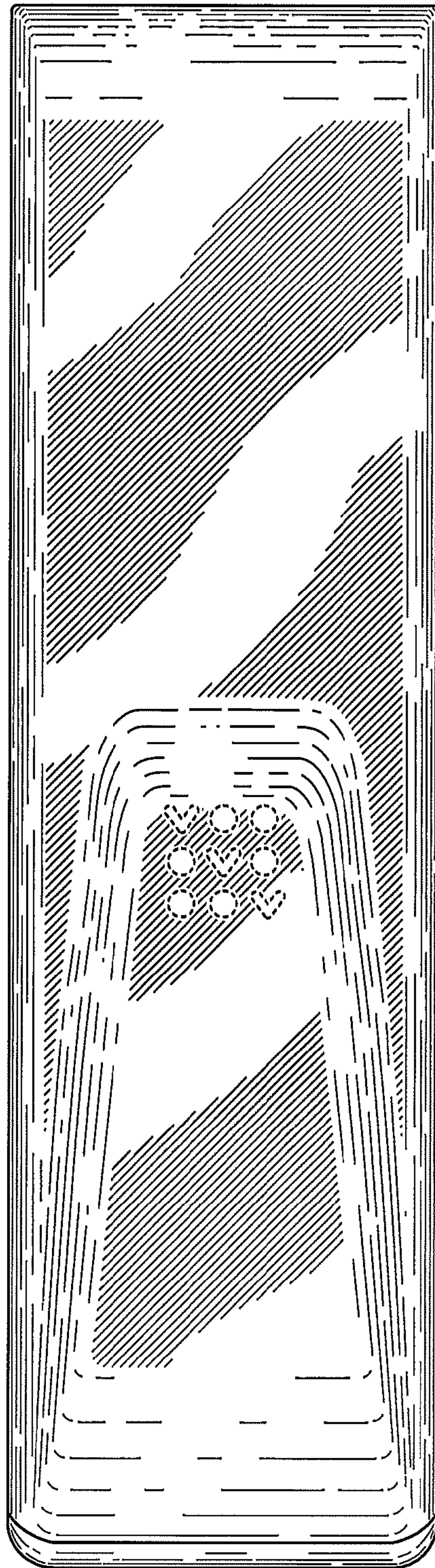

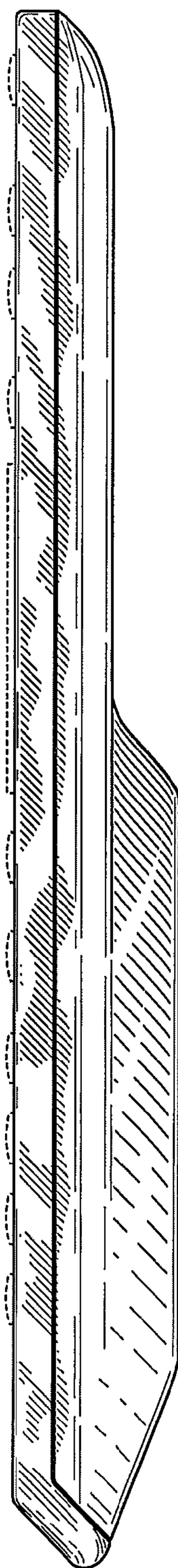

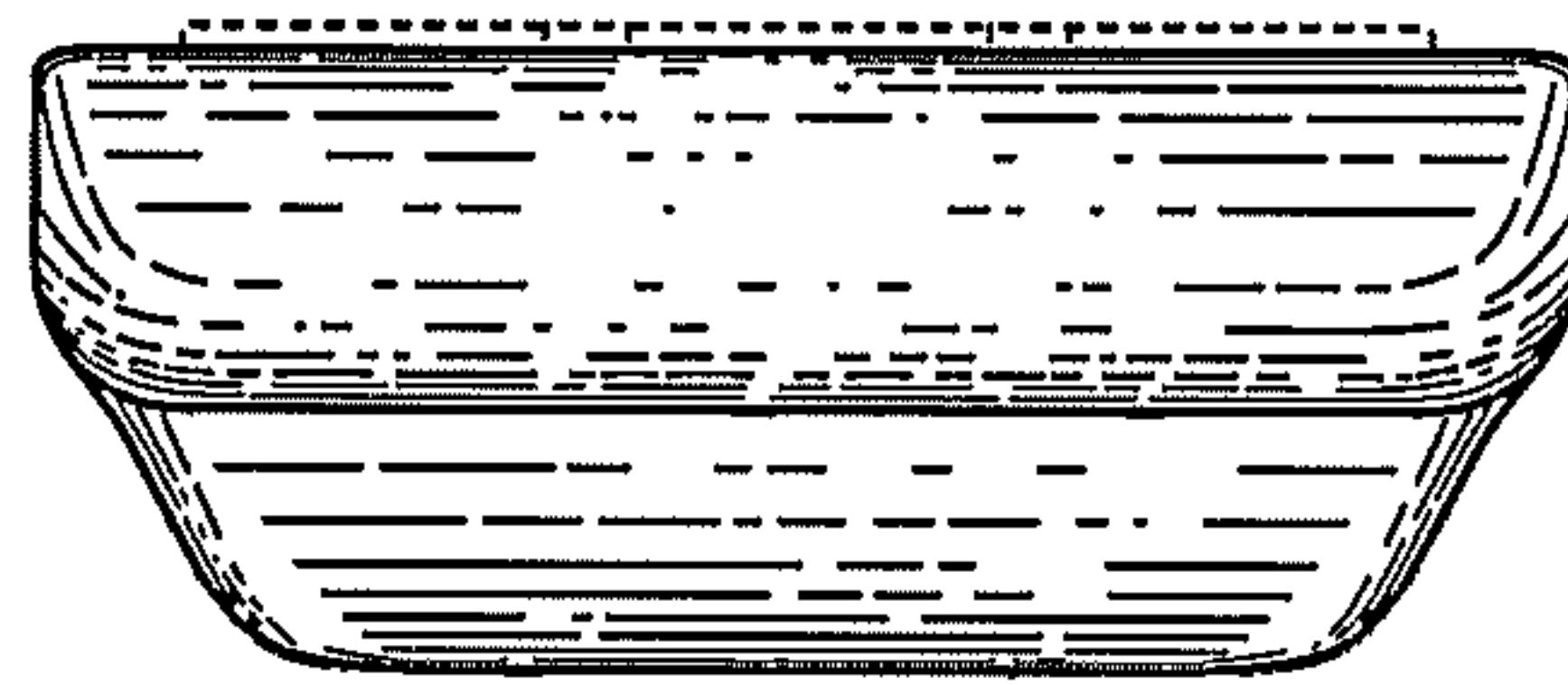

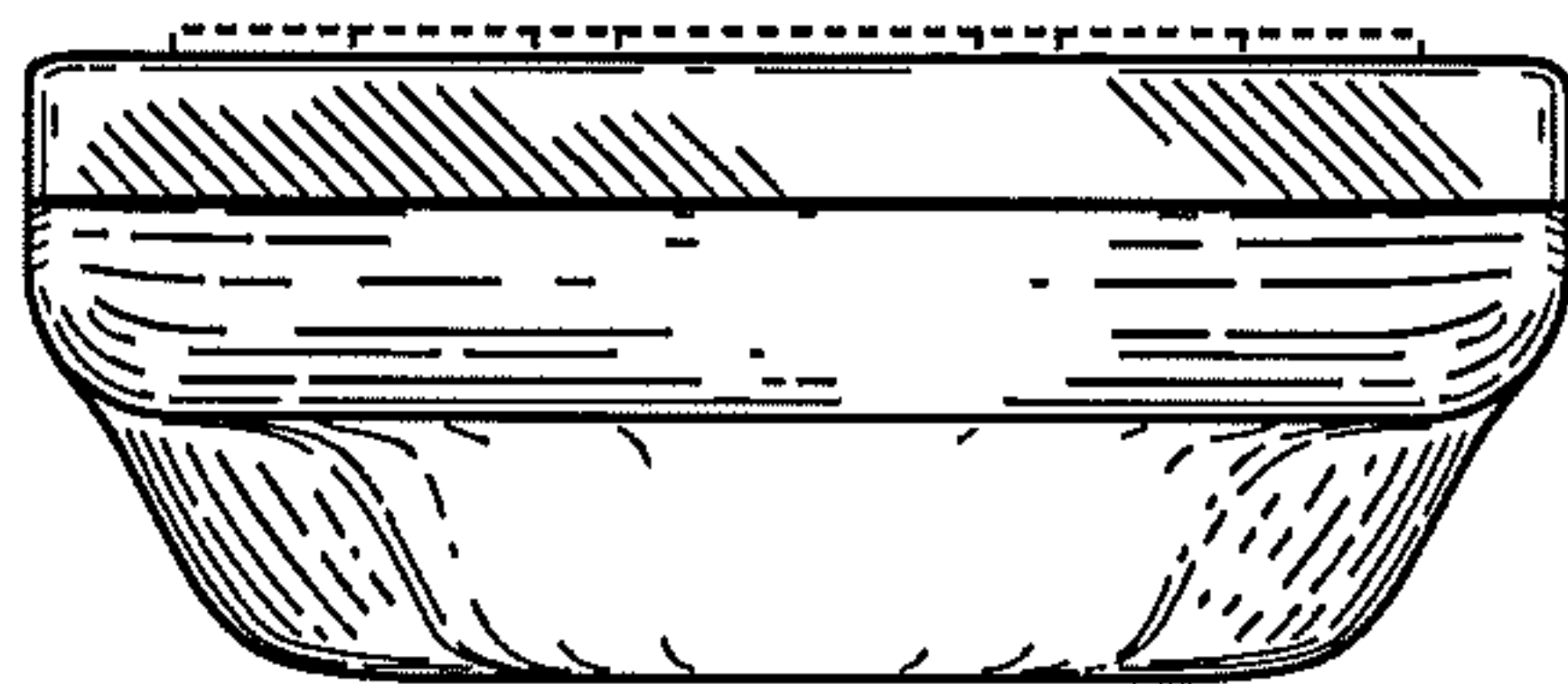

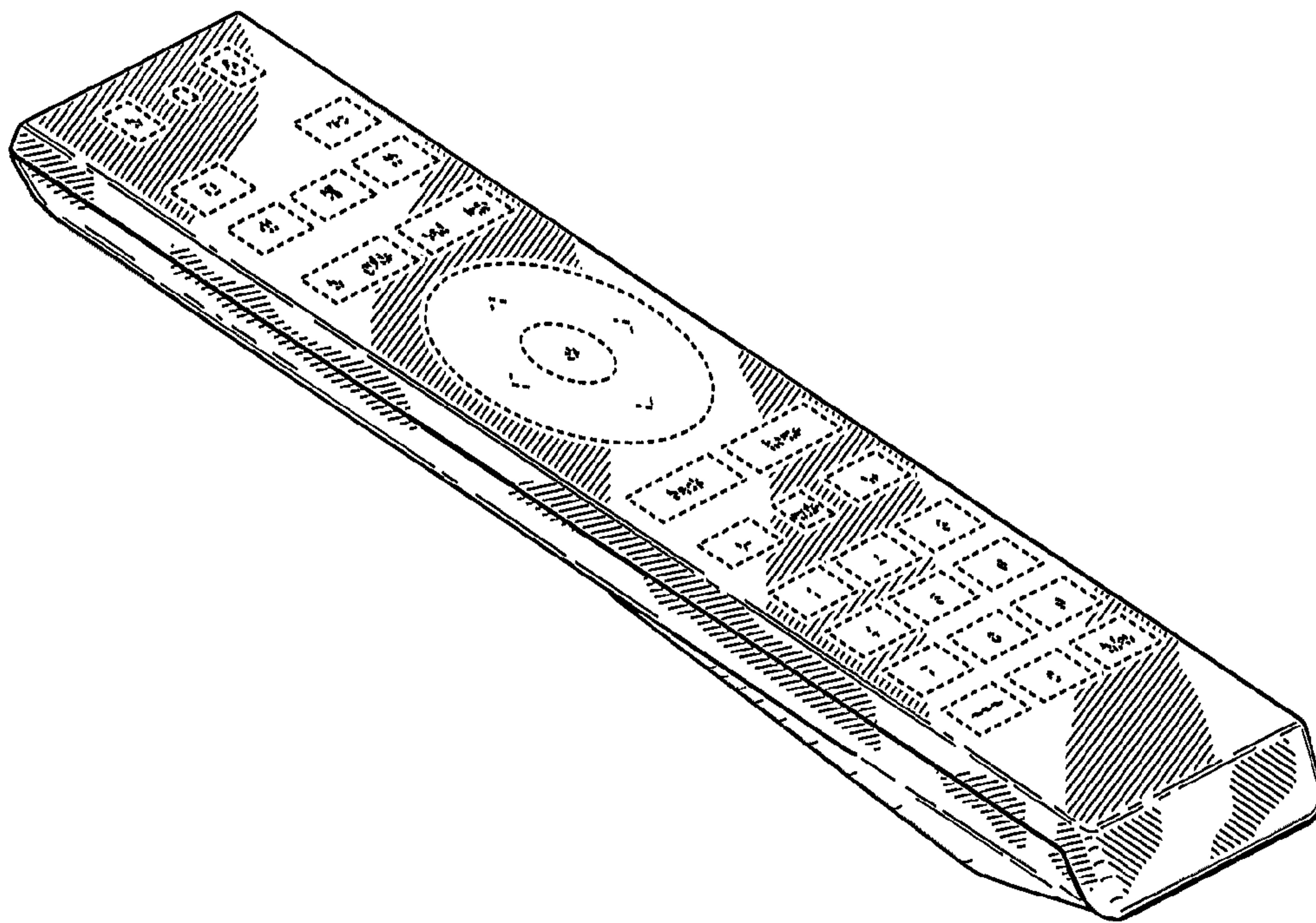
