**DESCRIPTION**

FIG. 16 is a right side view thereof;

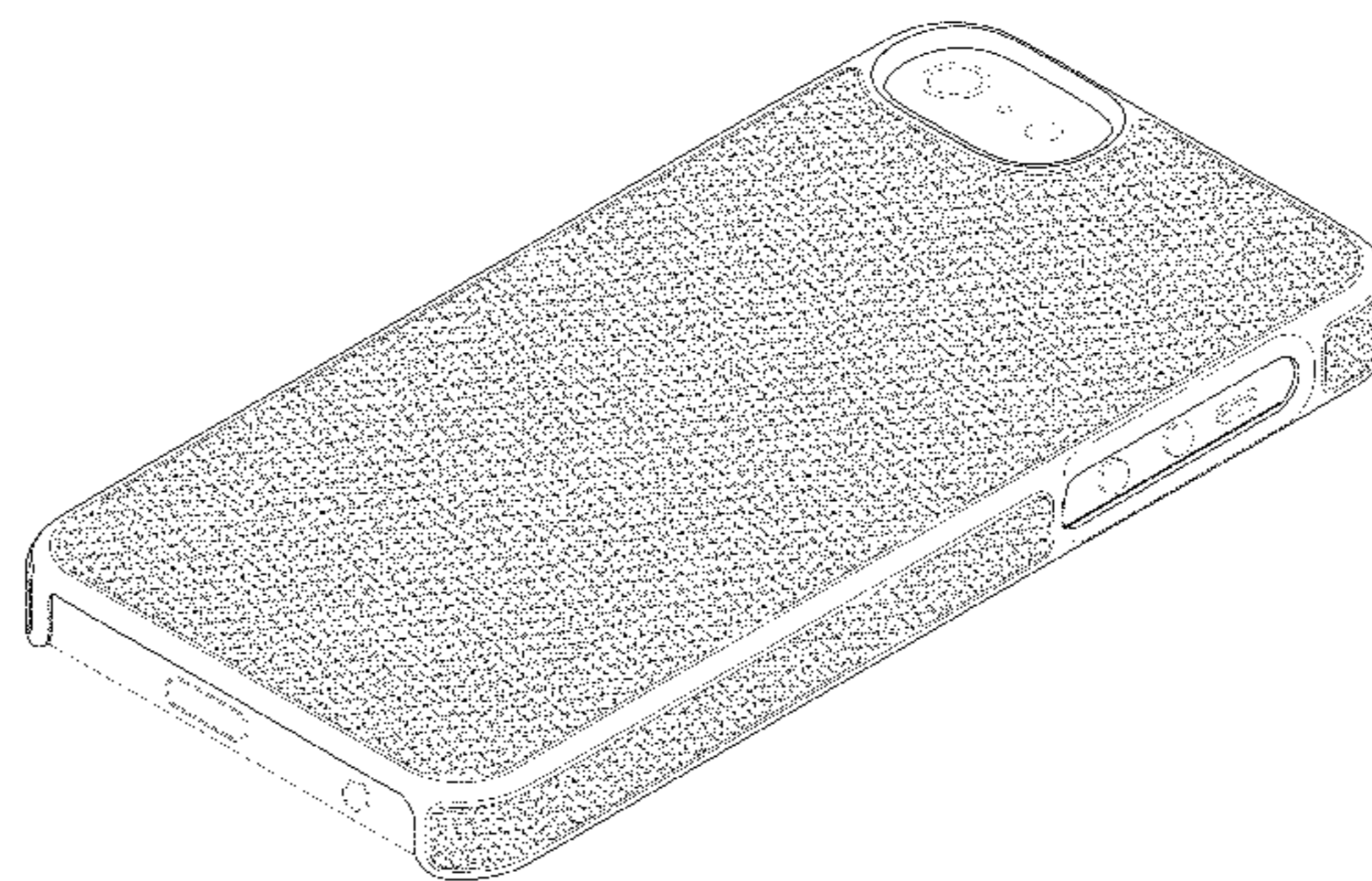
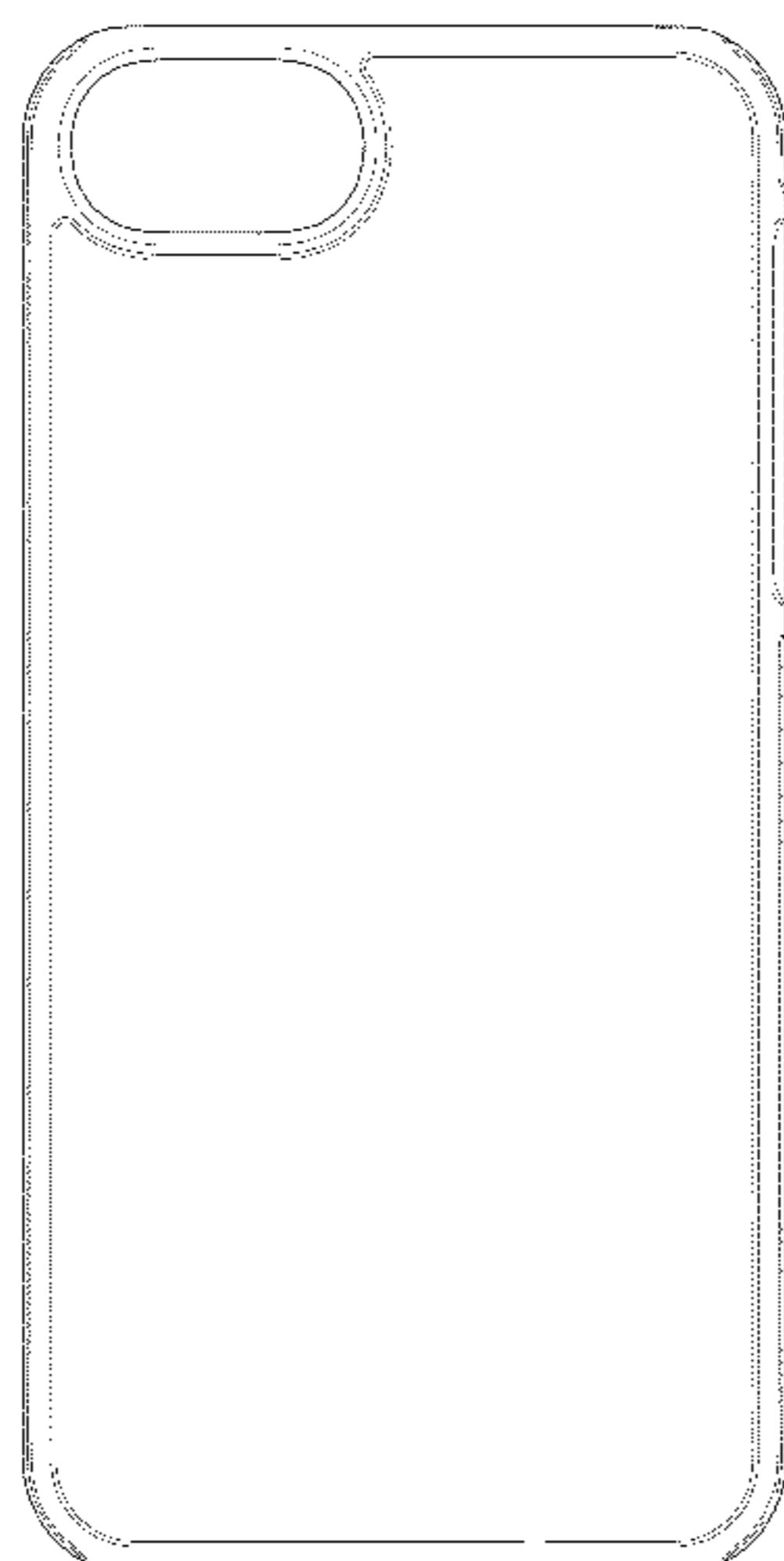
FIG. 17 is a front view thereof; and,

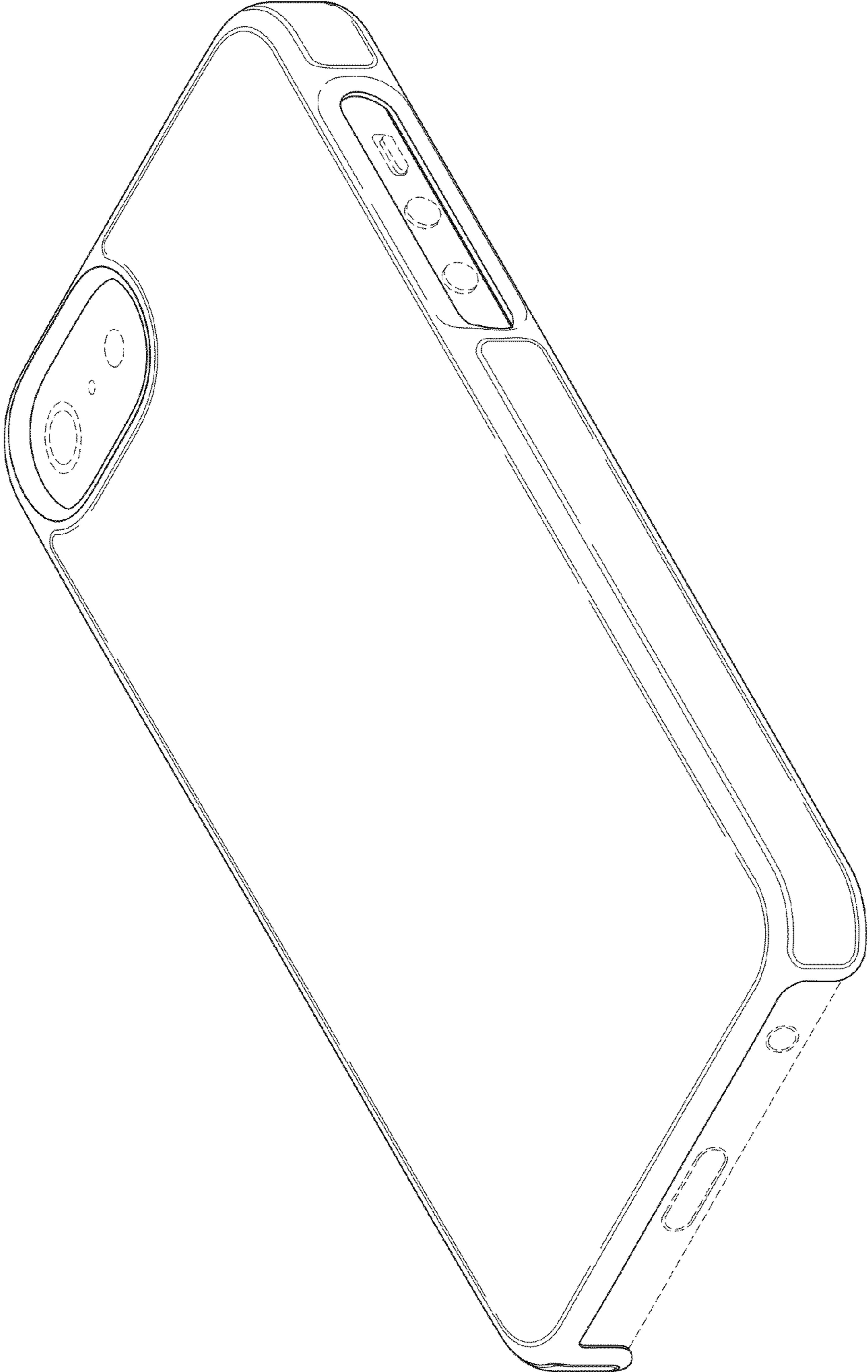

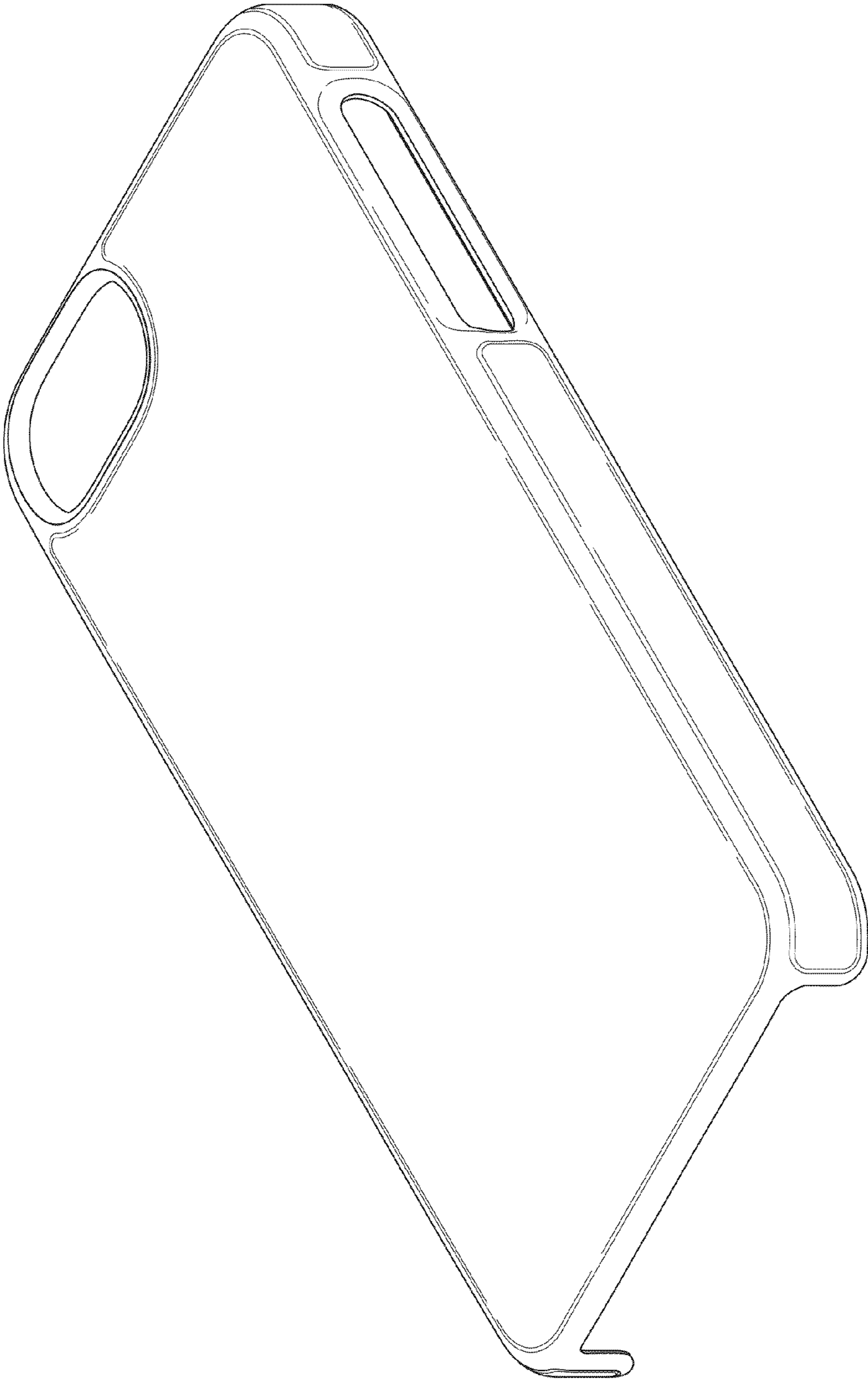

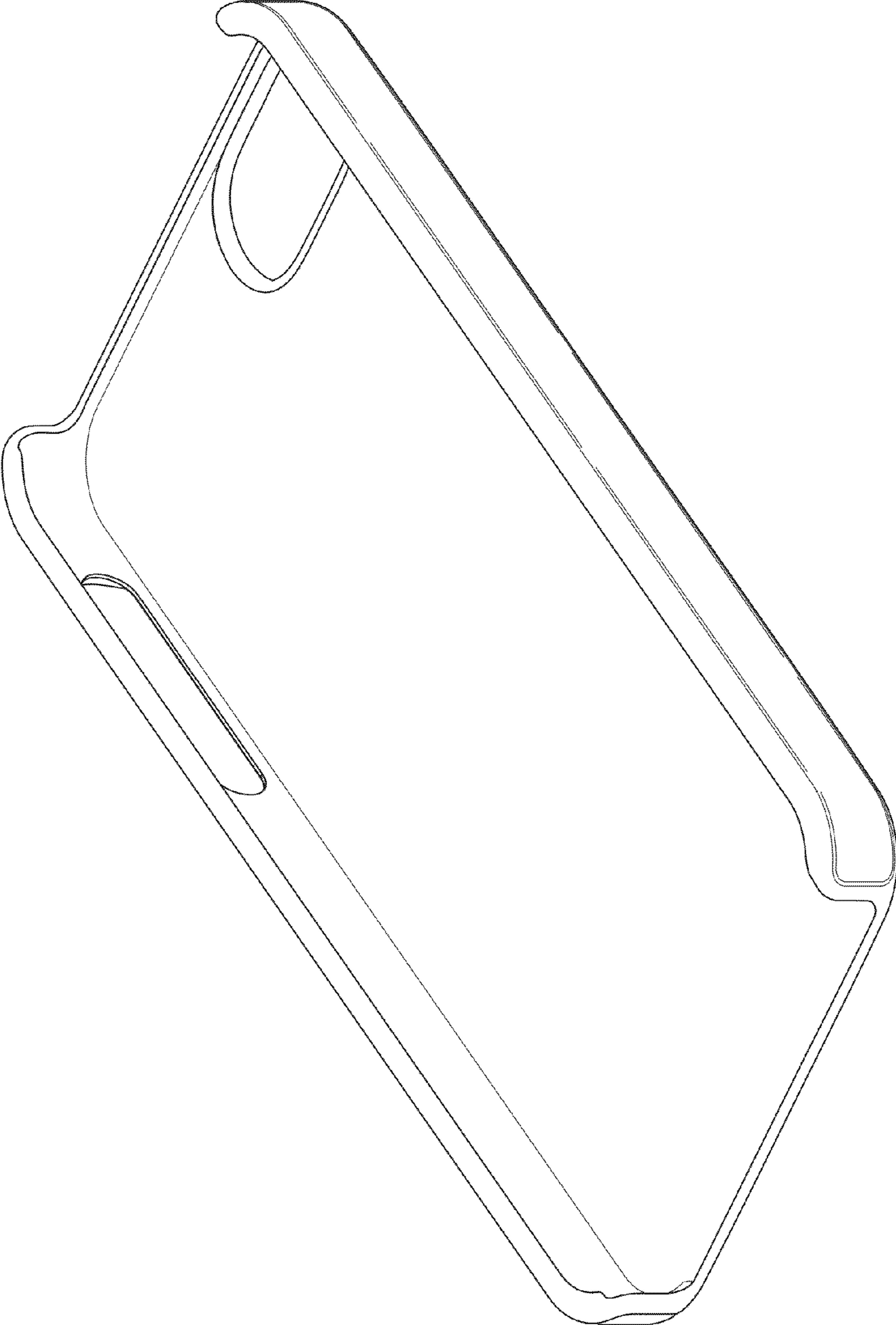

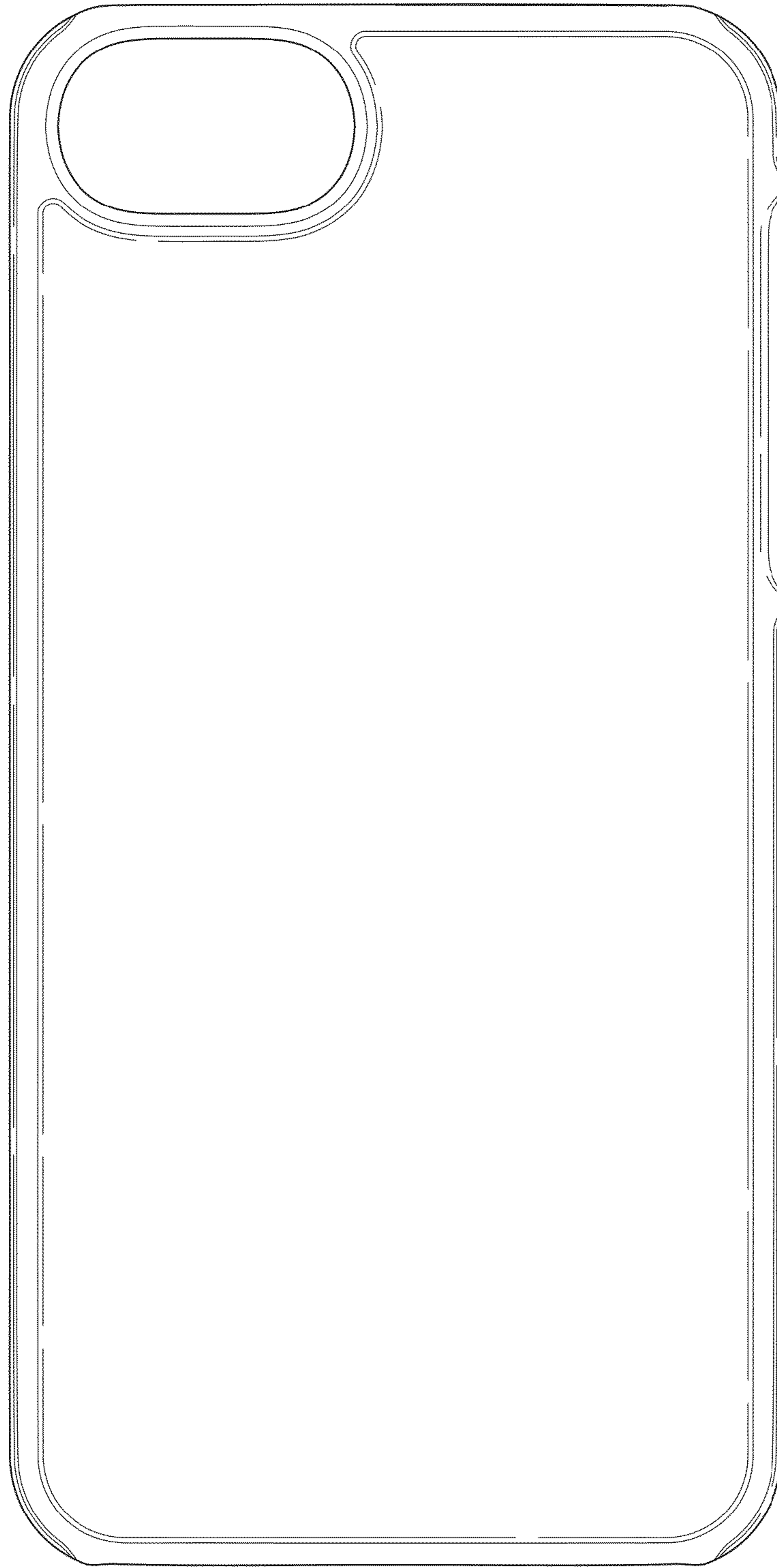

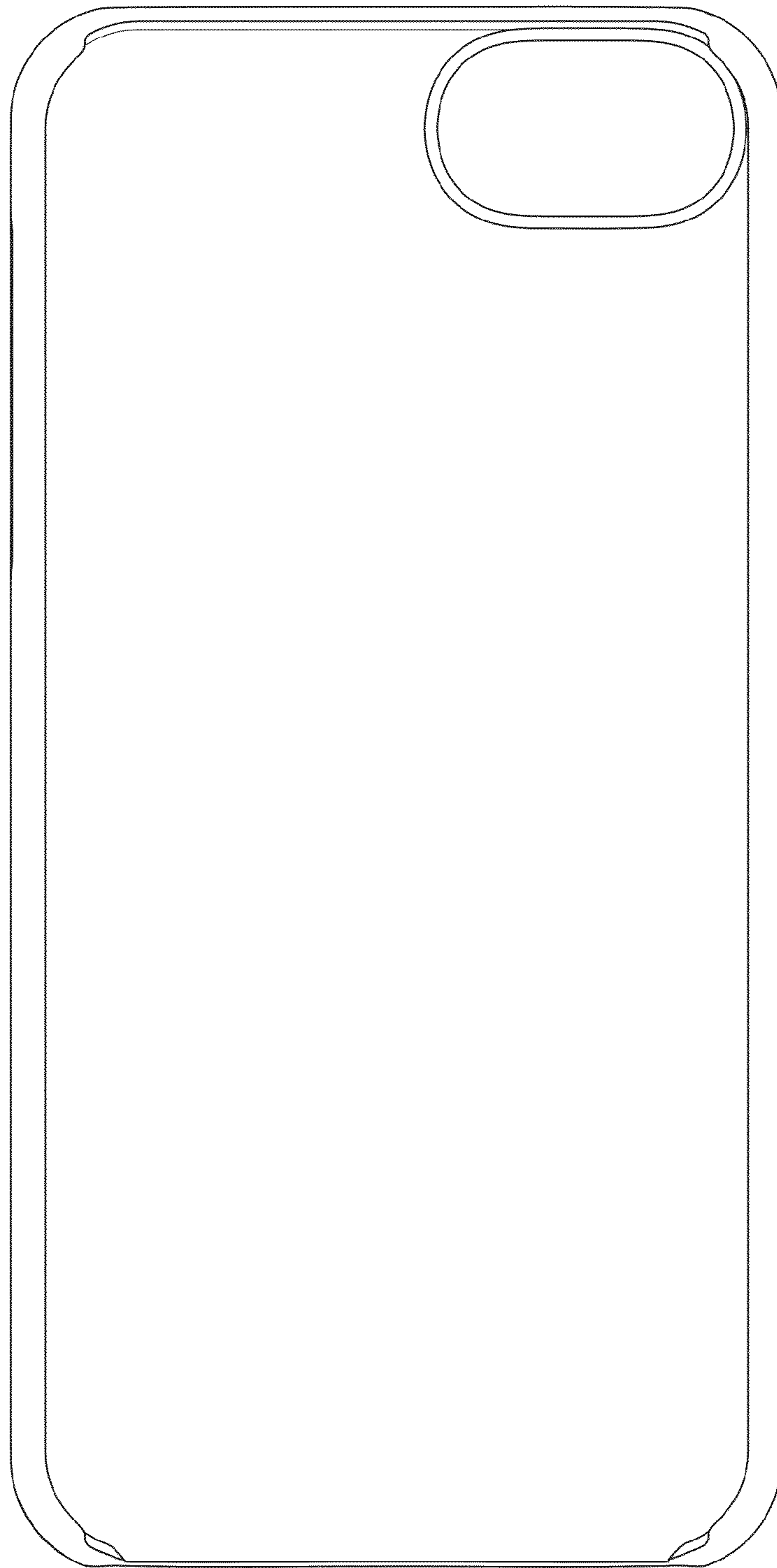

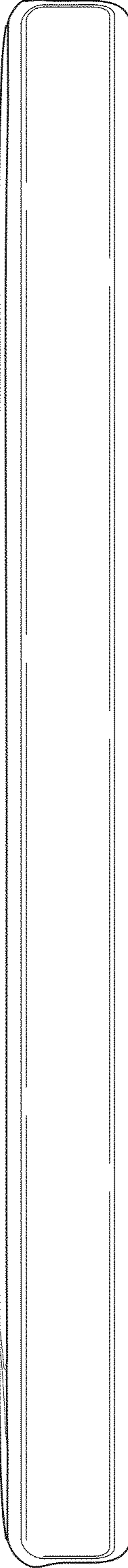

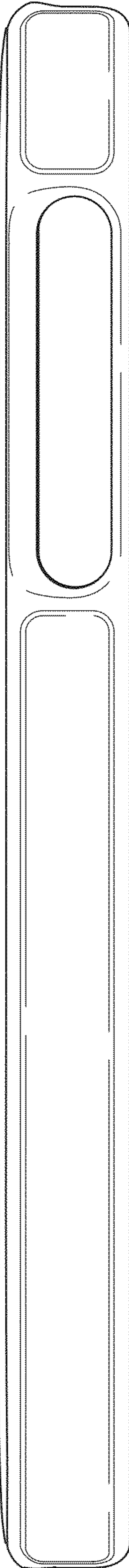

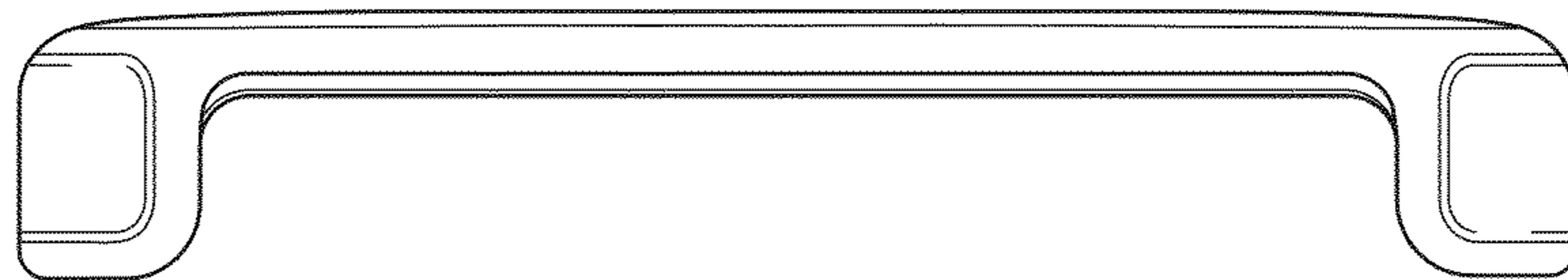

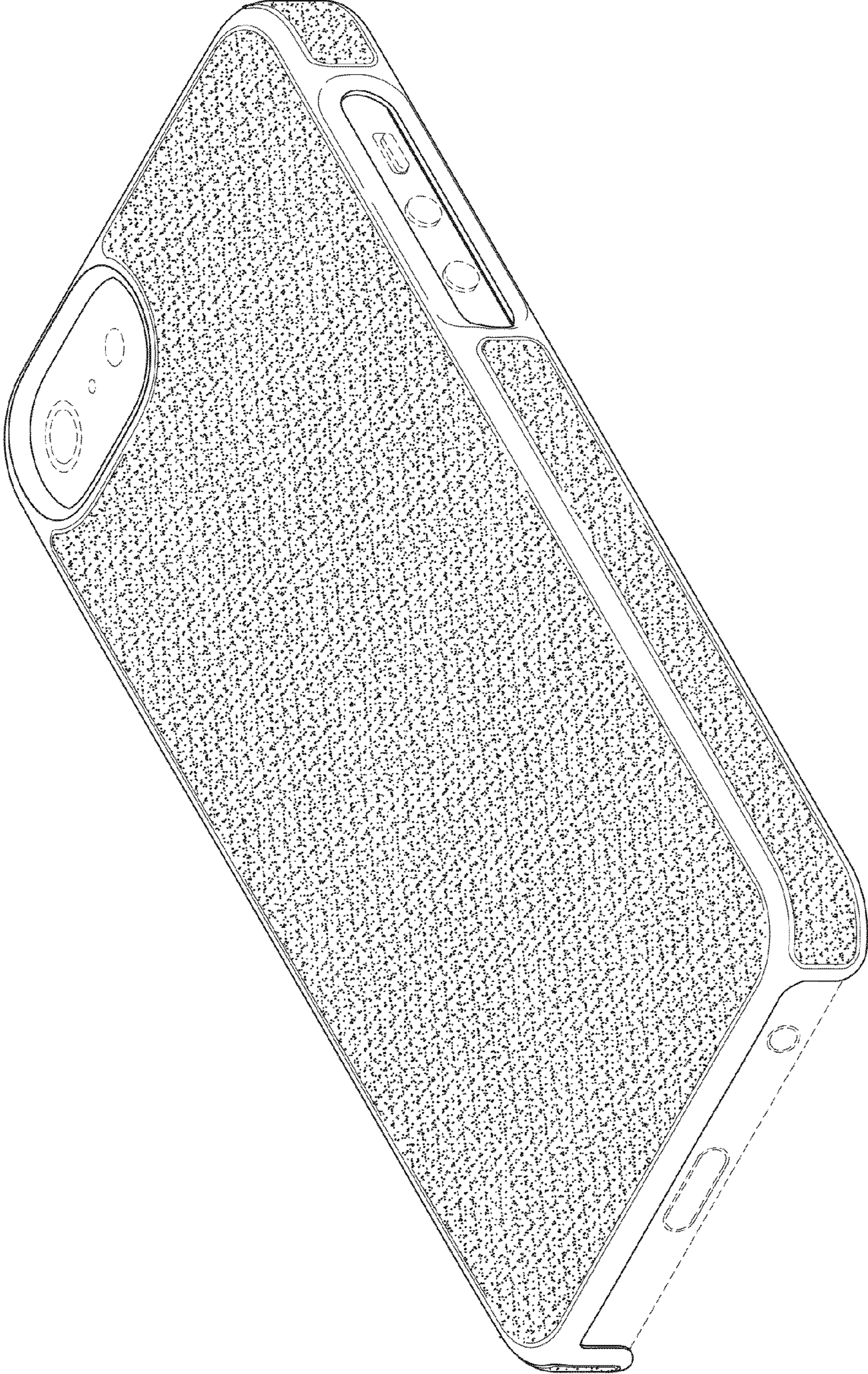

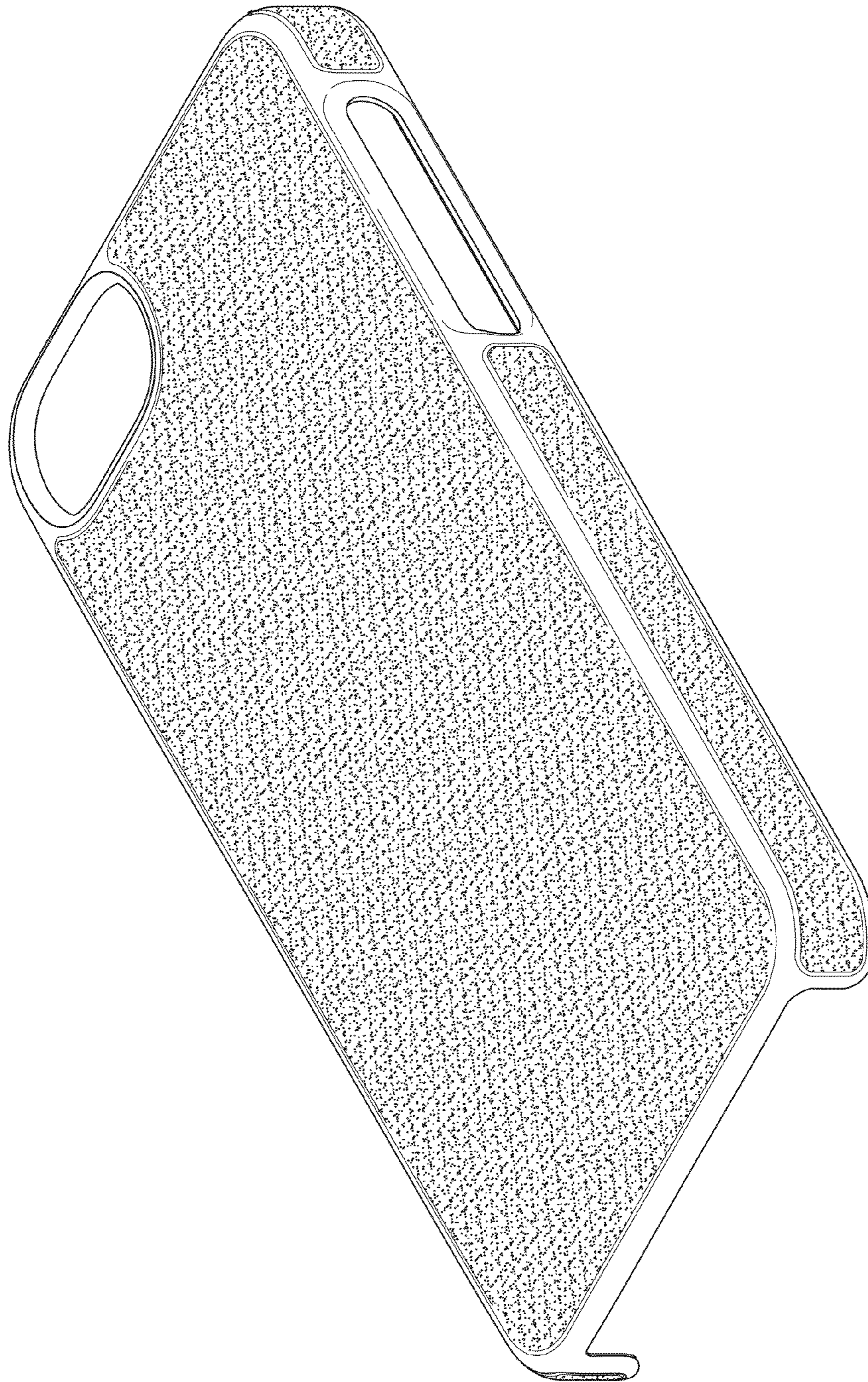

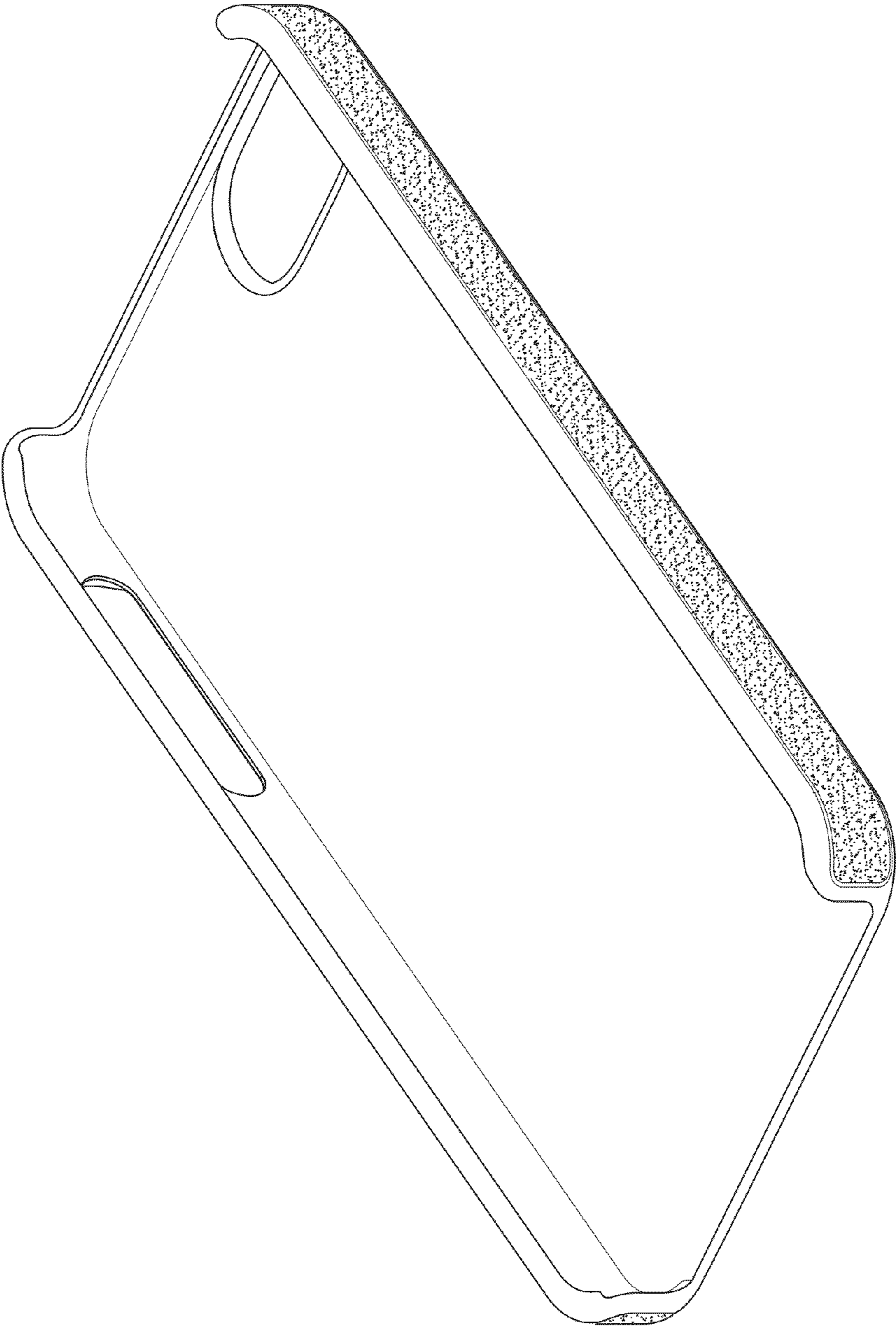

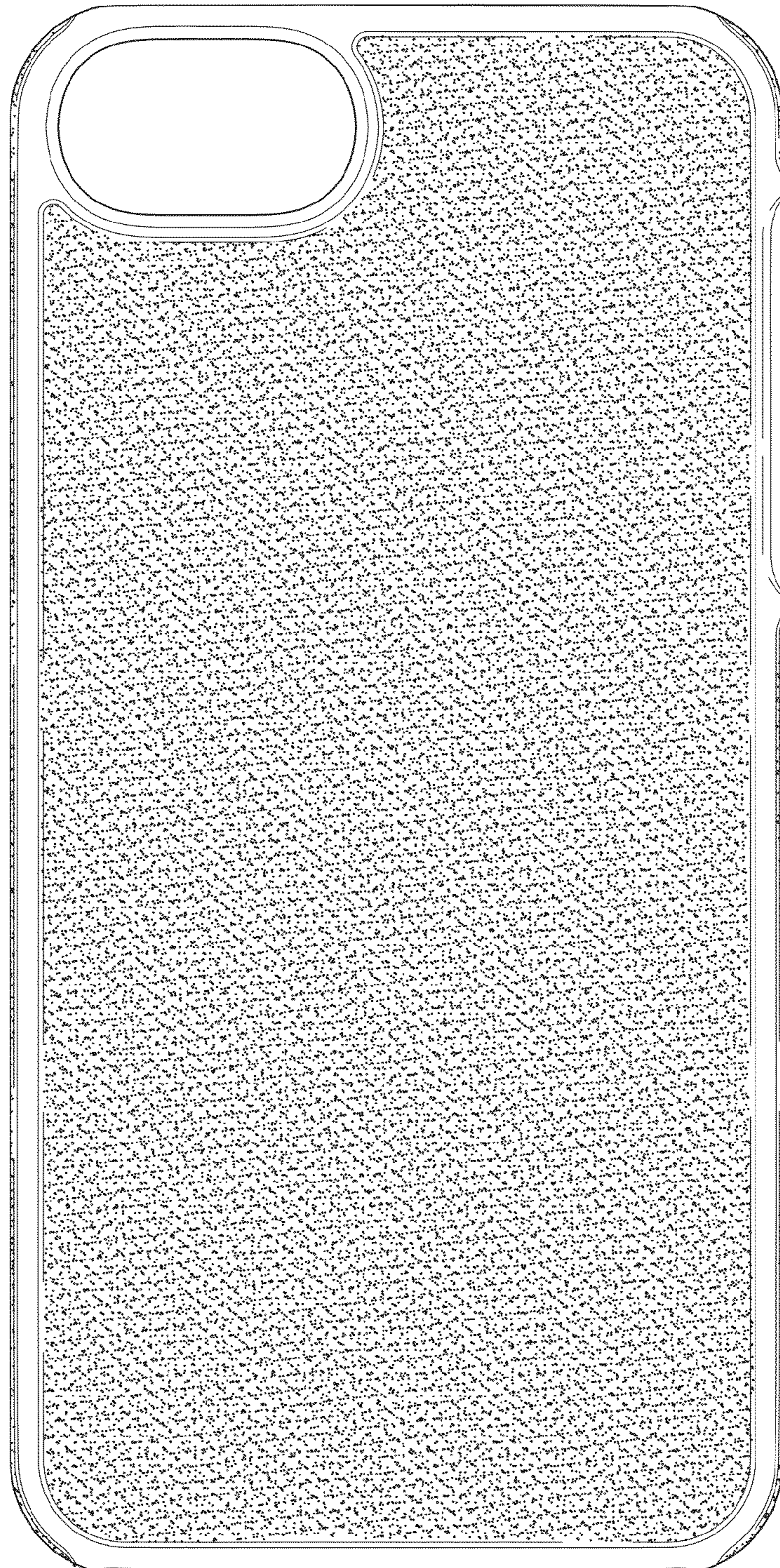

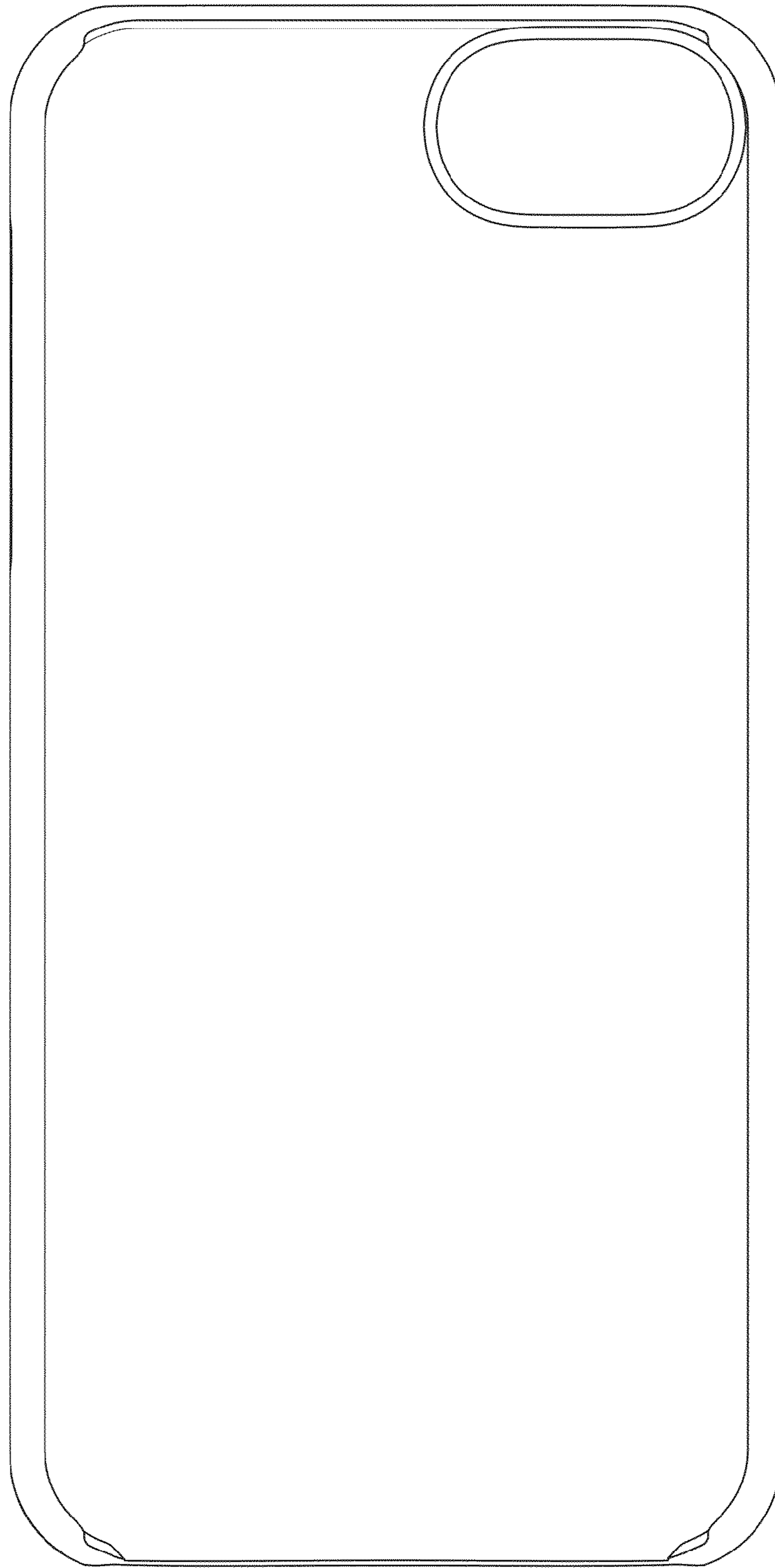

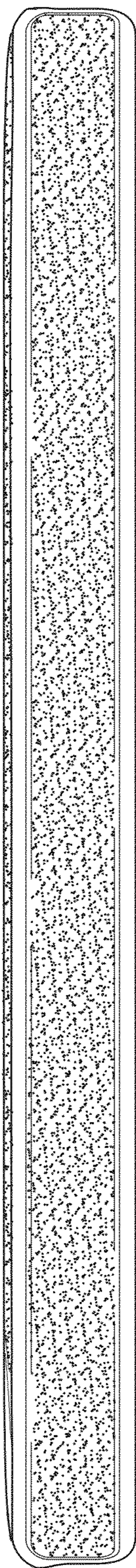

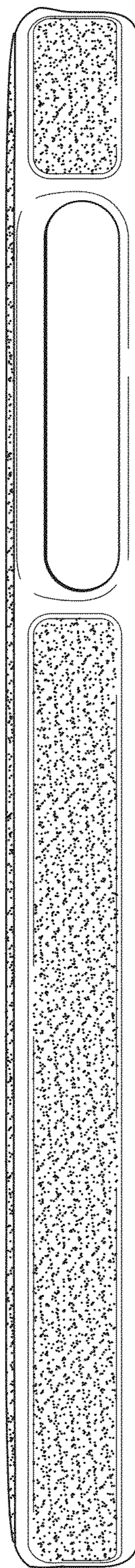

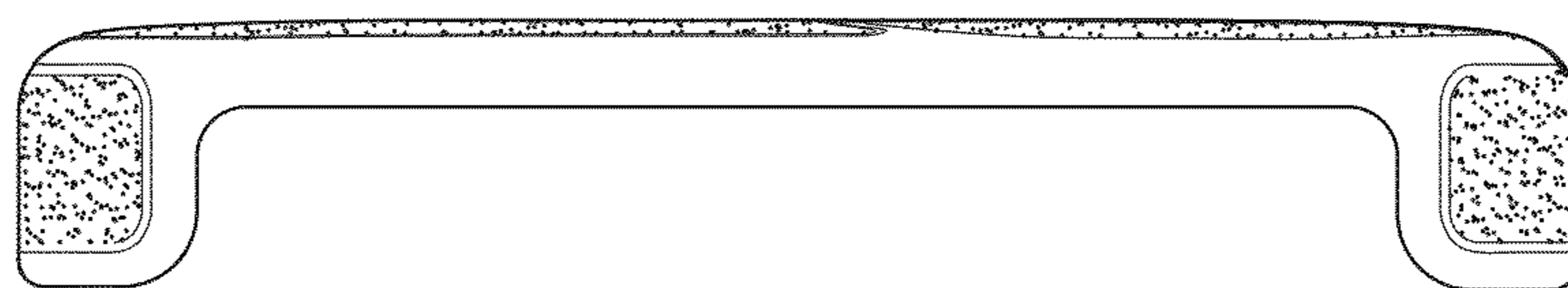

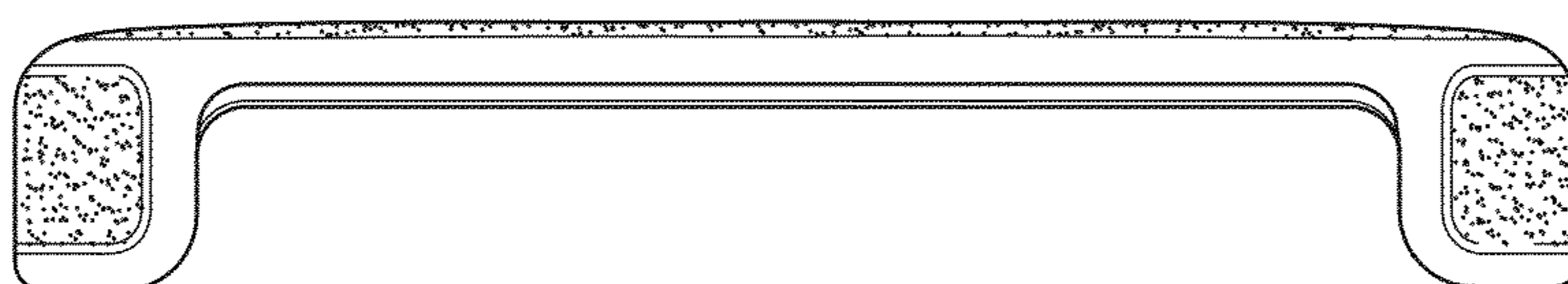
