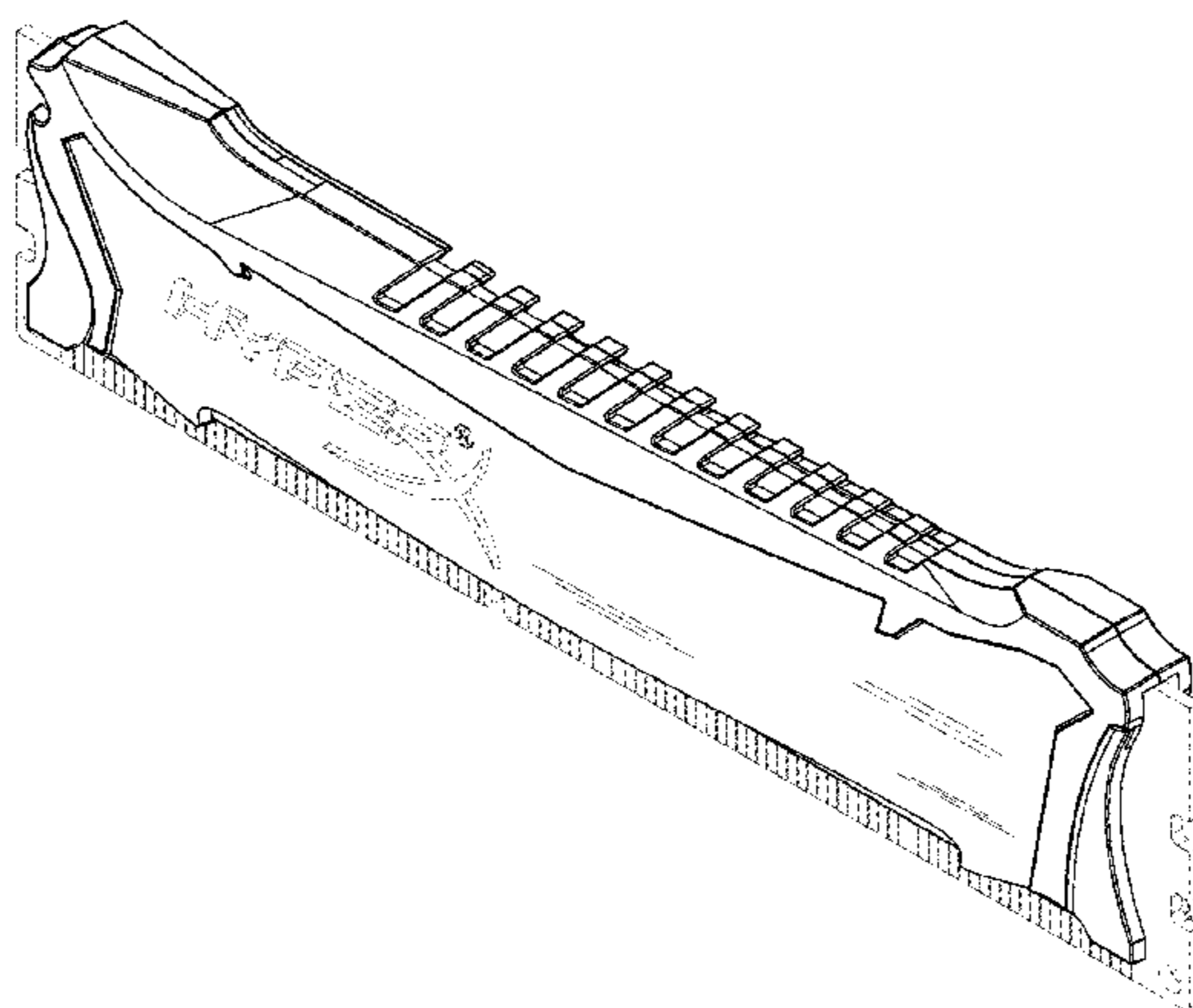
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a memory module showing the claimed design;

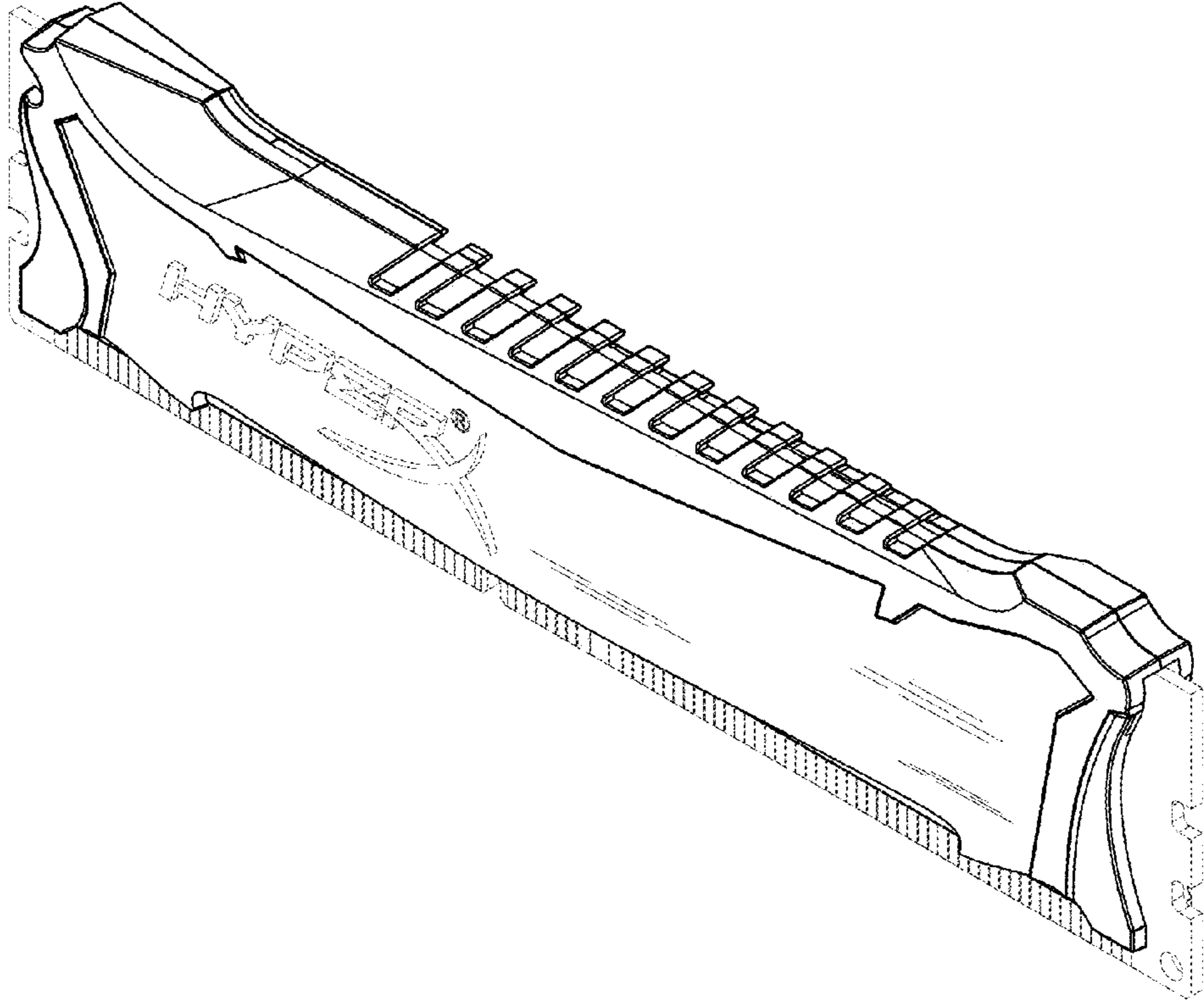

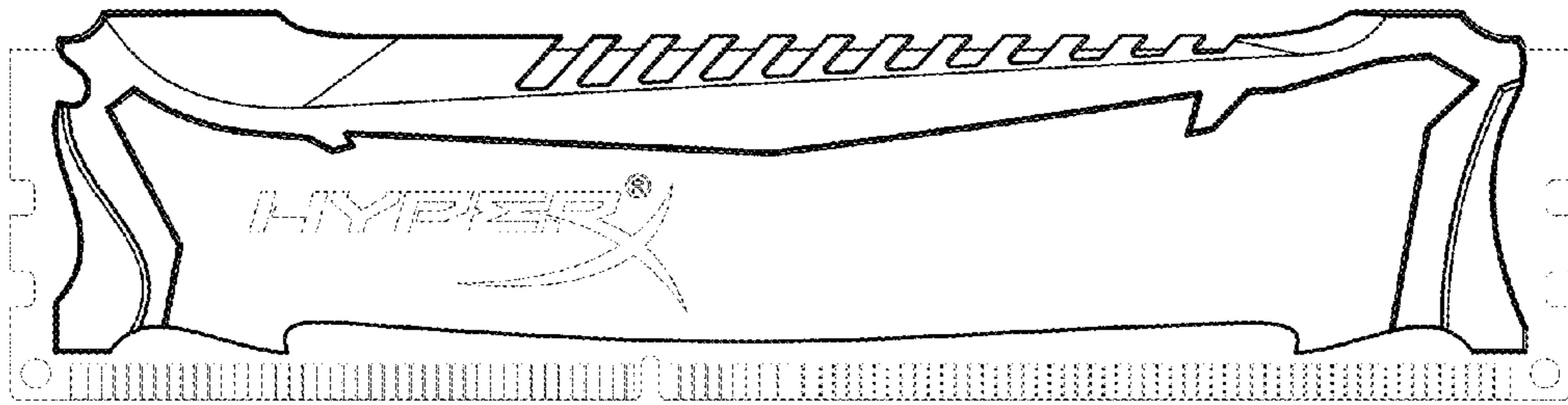

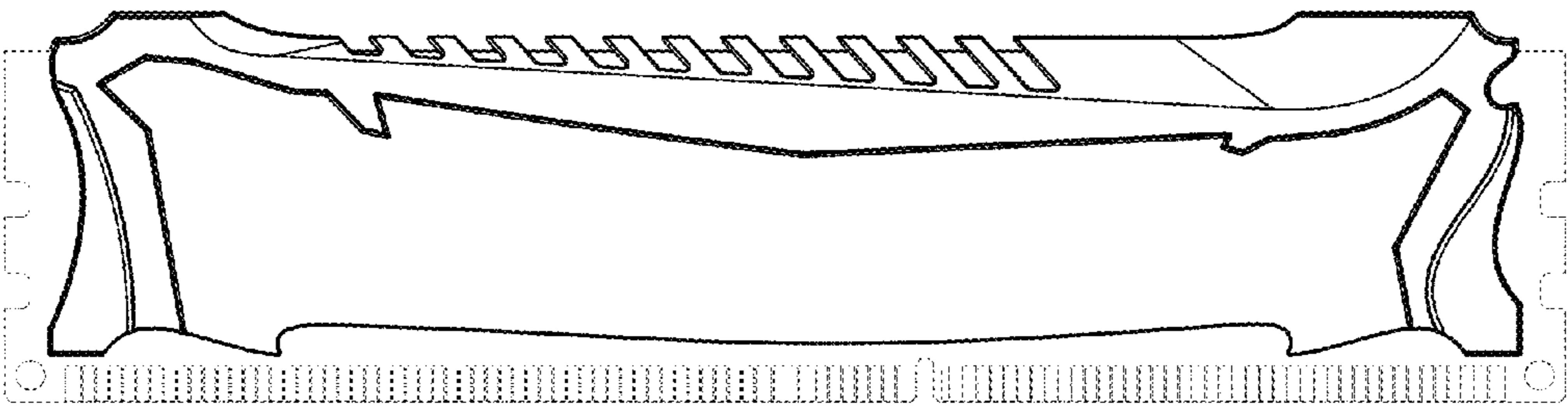

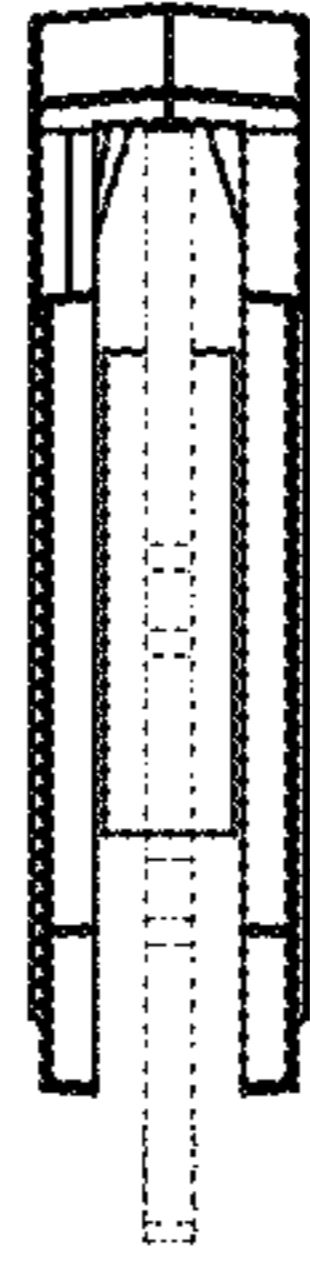

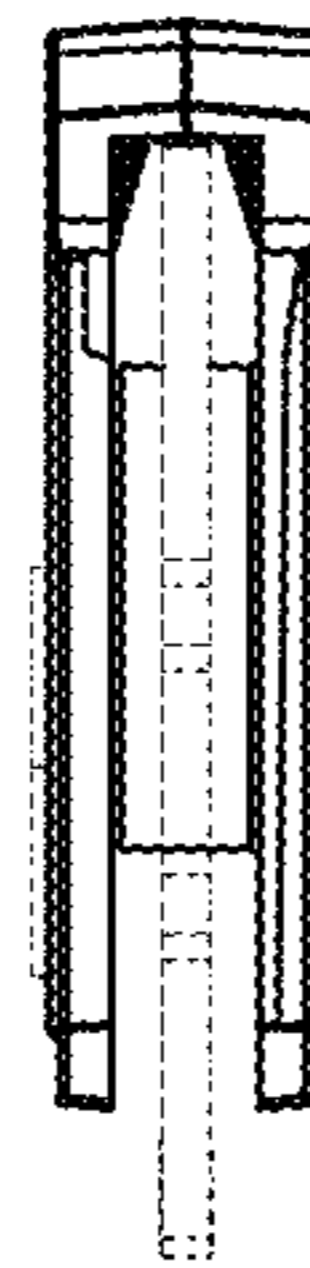

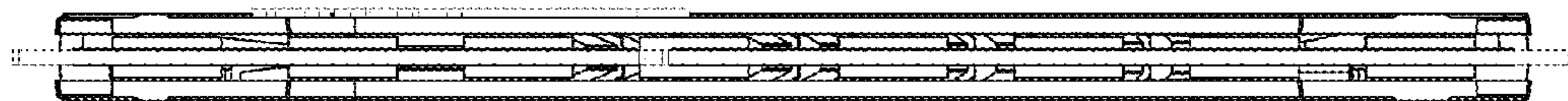
