(57) **CLAIM**

We claim the ornamental design for an iron club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an iron club head, as viewed from the toe and front sides, according to an embodiment of the design.

FIG. 2 is a front elevation view of the iron club head of FIG. 1.

FIG. 3 is a rear elevation view of the iron club head of FIG. 1. FIG. 4 is a side elevation view from a toe side of the iron club head of FIG. 1.

FIG. 5 is a side elevation view from an opposite heel side of the iron club head of FIG. 1.

FIG. 6 is a top plan view of the iron club head of FIG. 1.

FIG. 7 is a bottom plan view of the iron club head of FIG. 1; and,

FIG. 8 is a perspective view of the iron club head of FIG. 1, as viewed from the toe and rear sides.

The dashed lines in the drawings are for purposes of illustrating environmental structure as well as portions of the design that form no part of the claimed design.

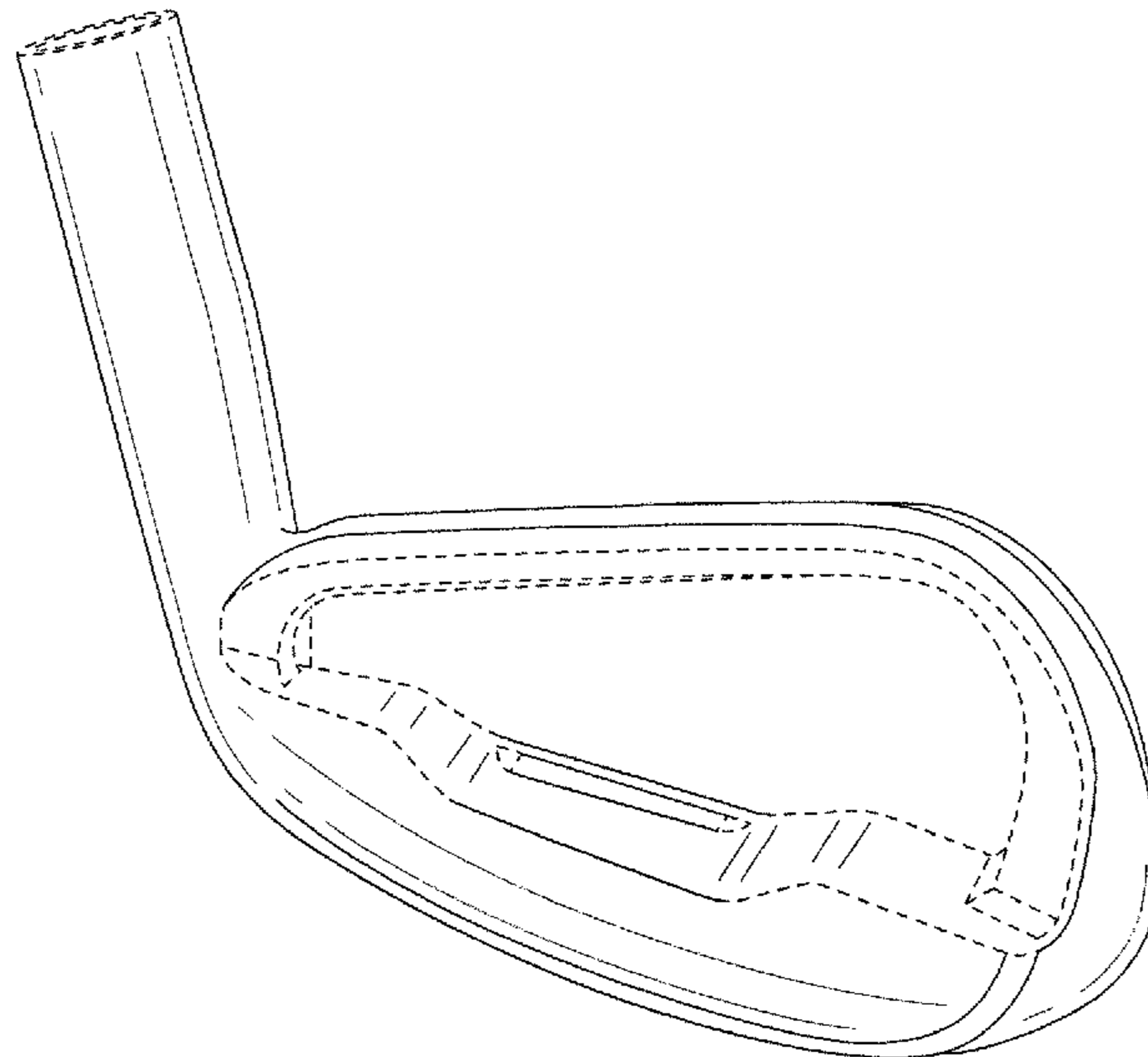

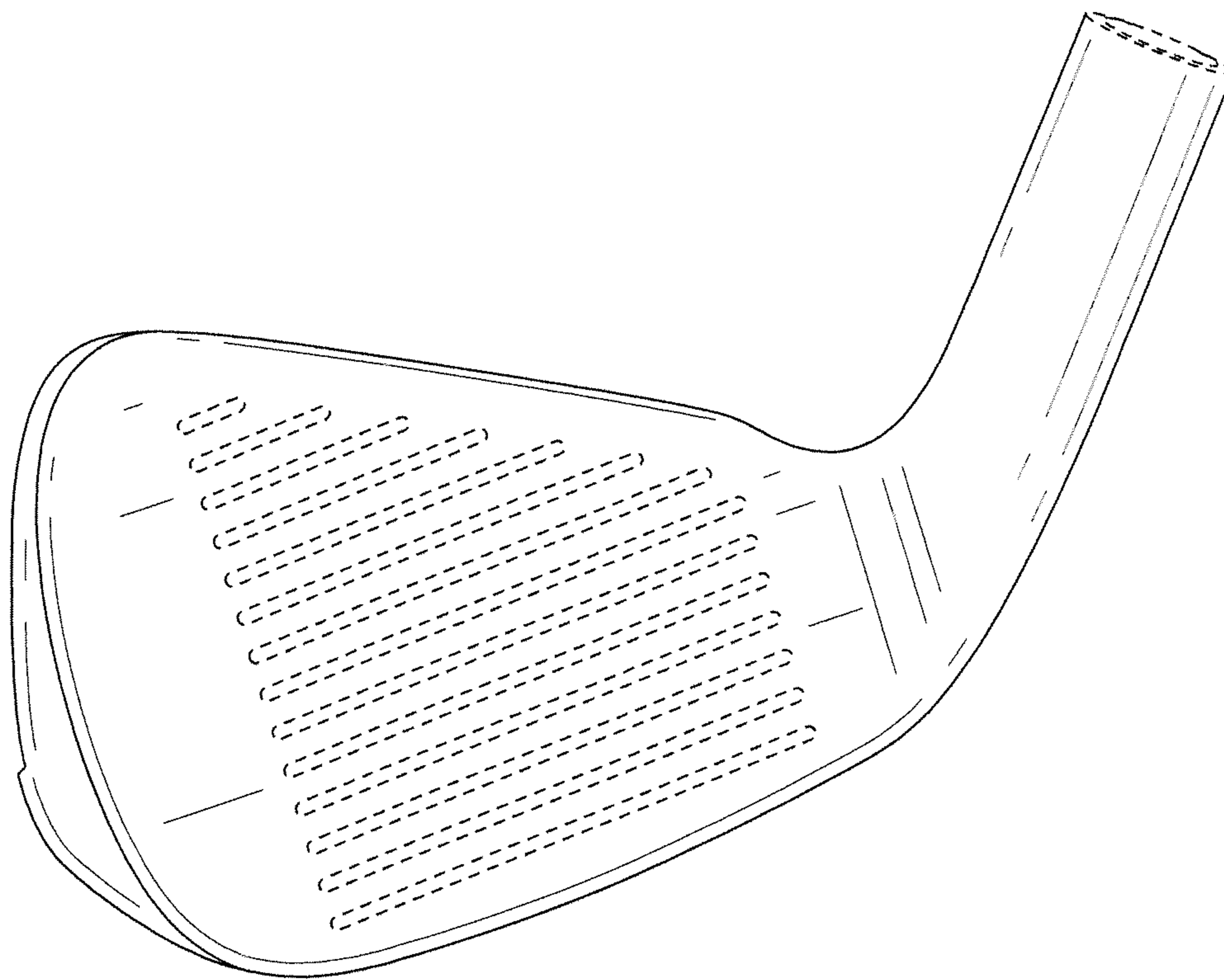

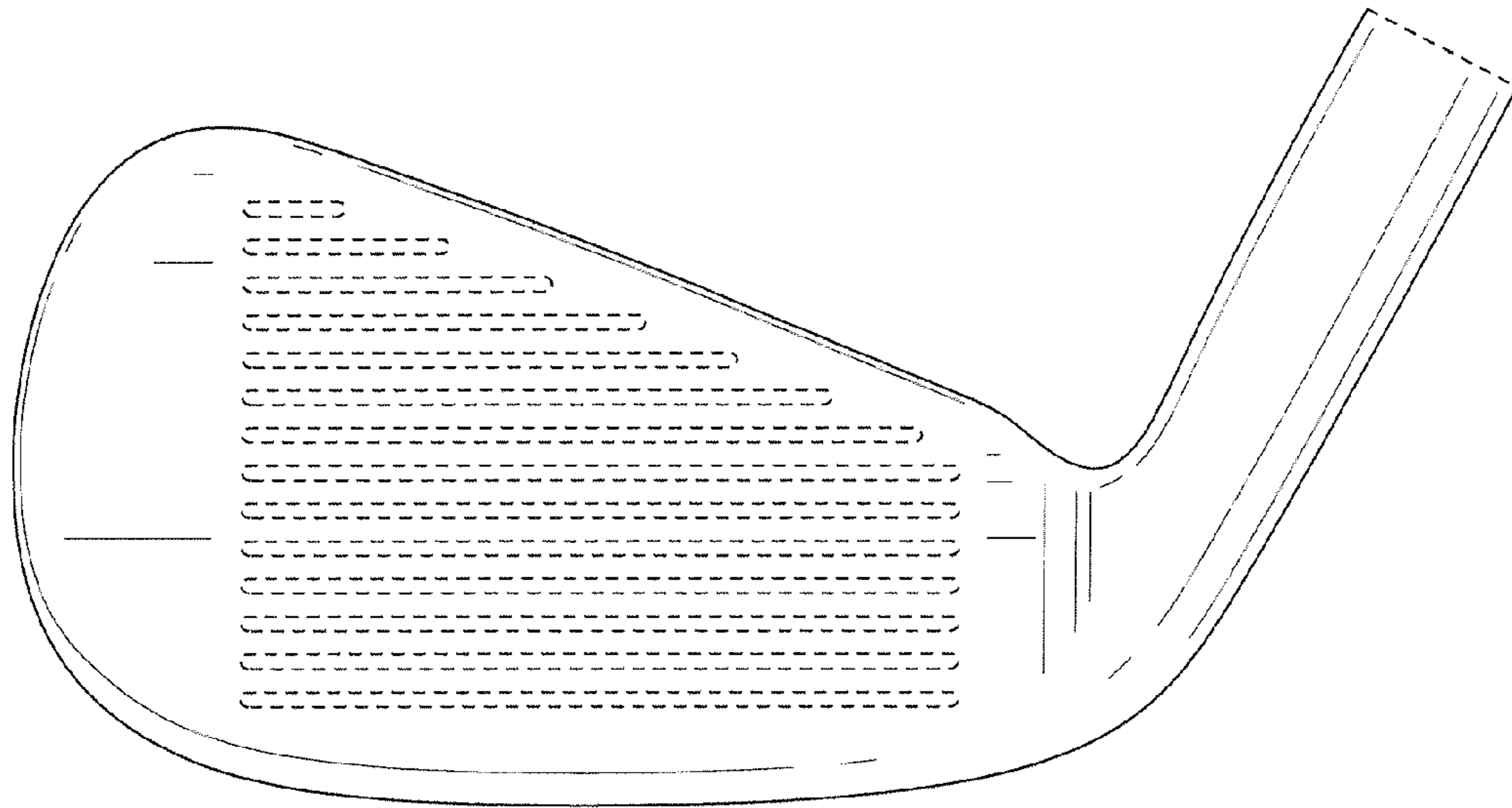

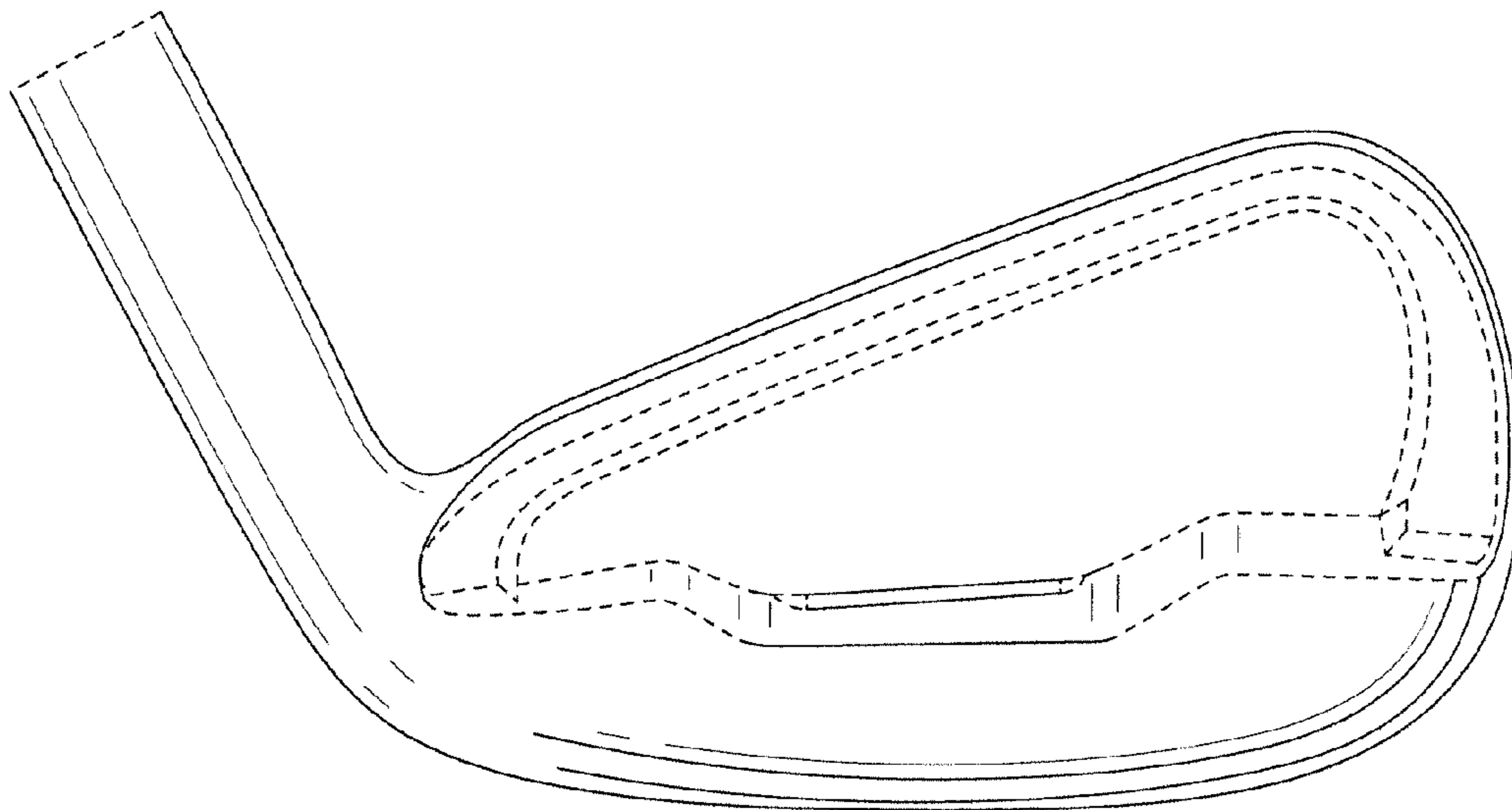

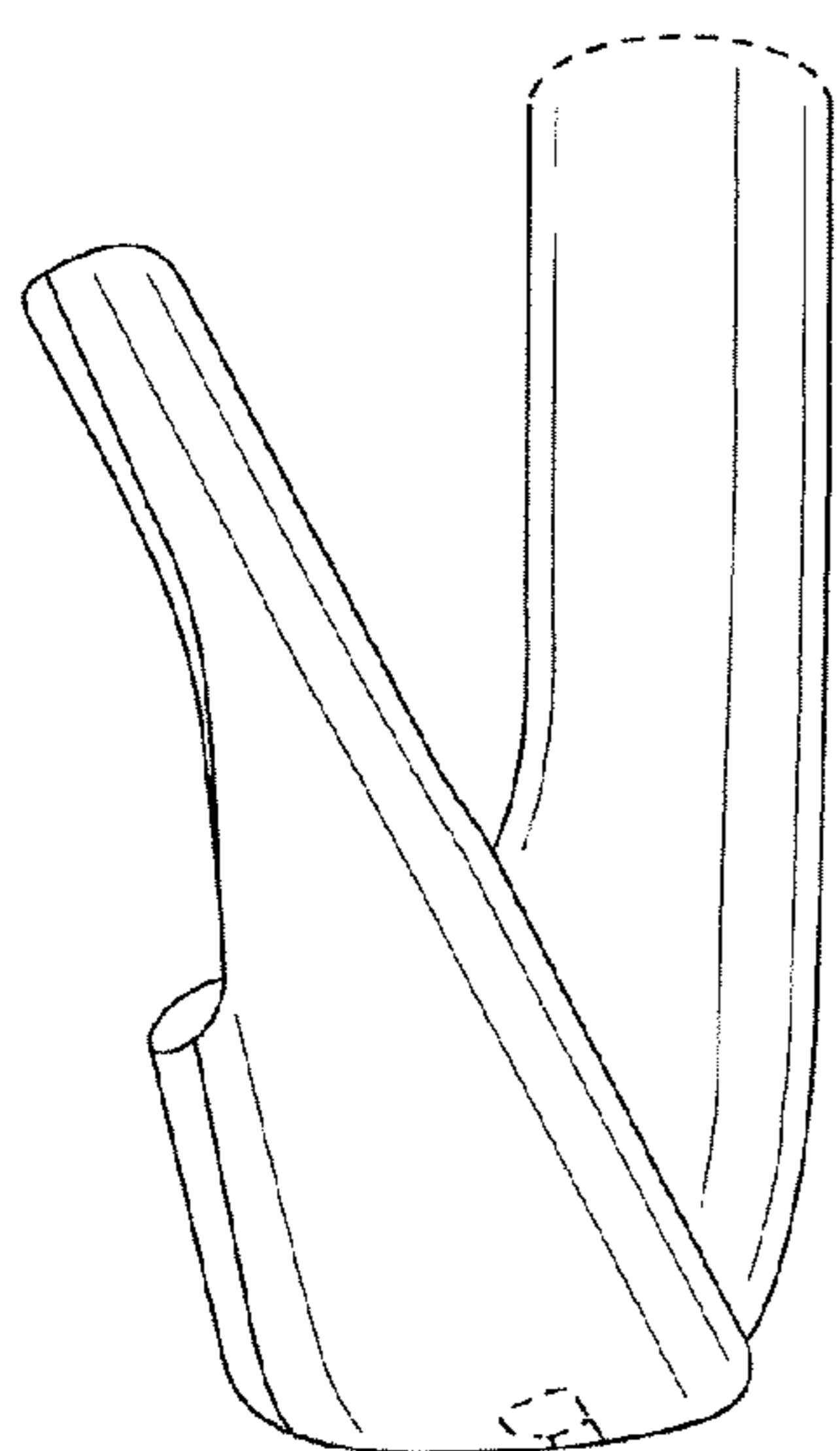

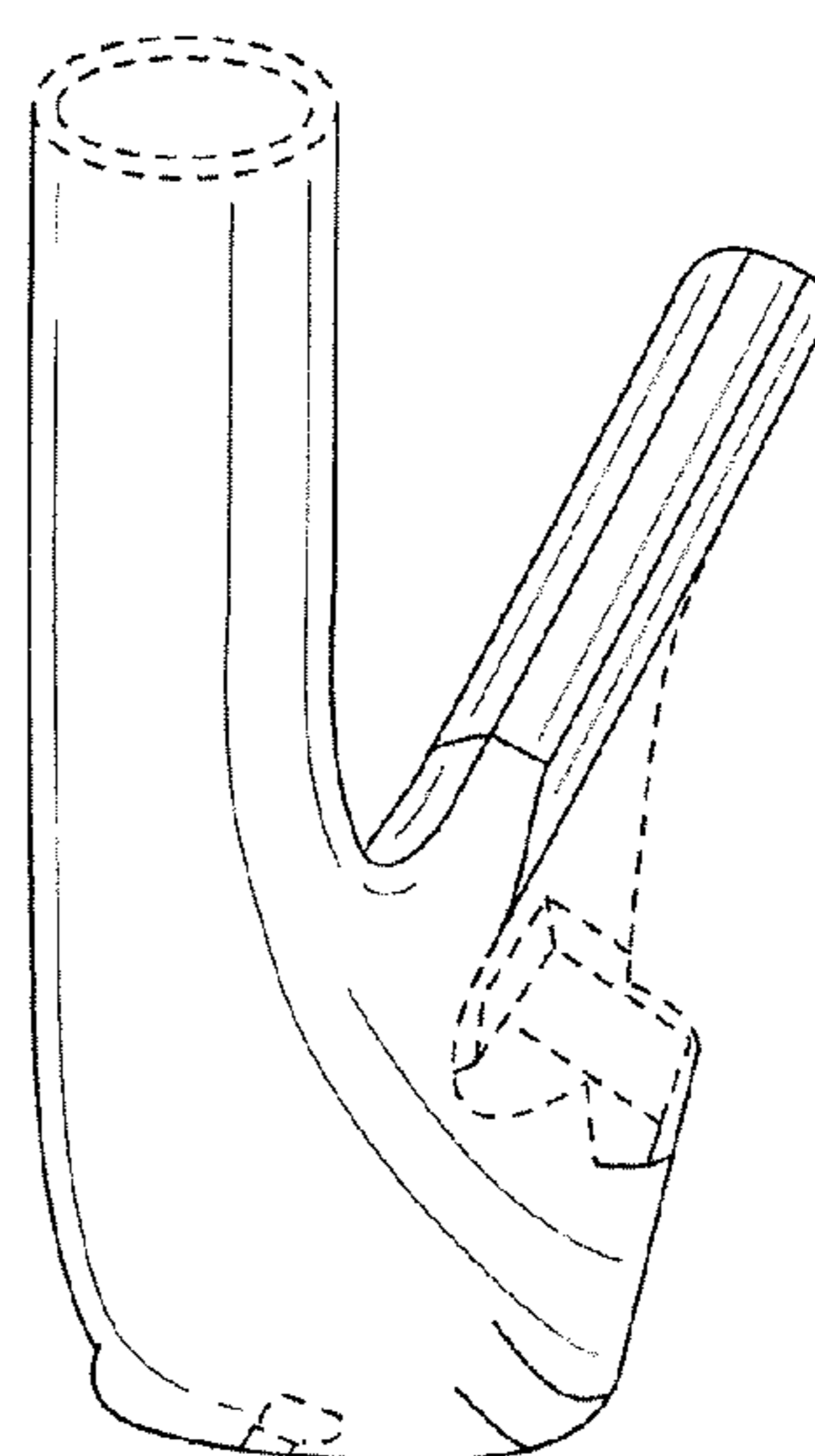

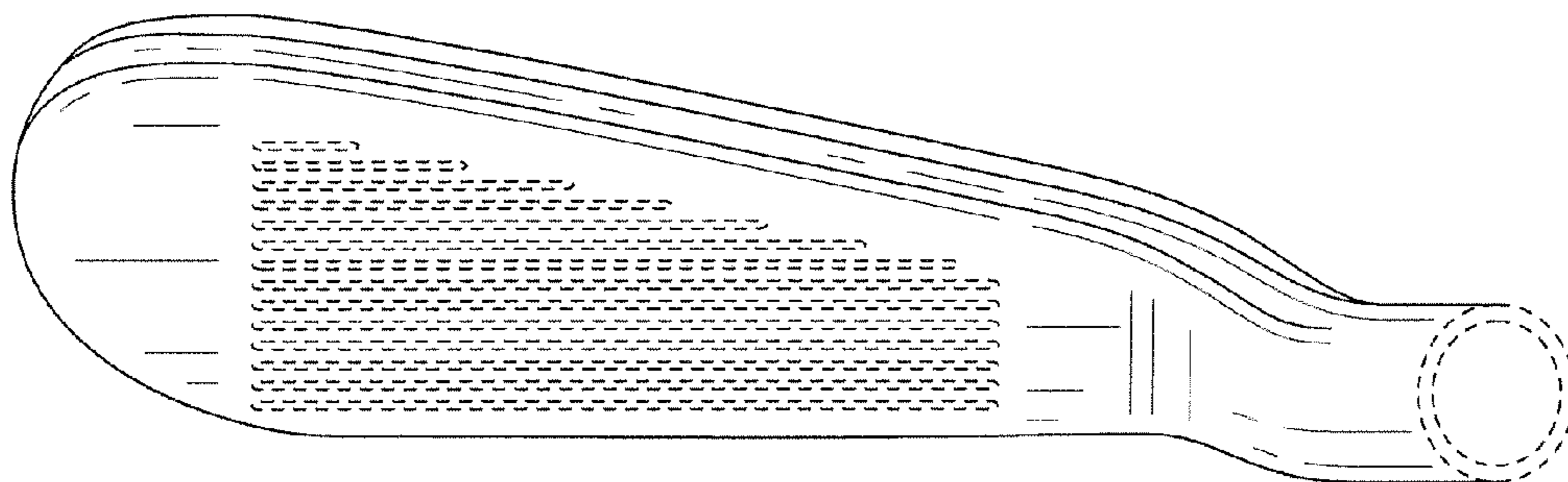

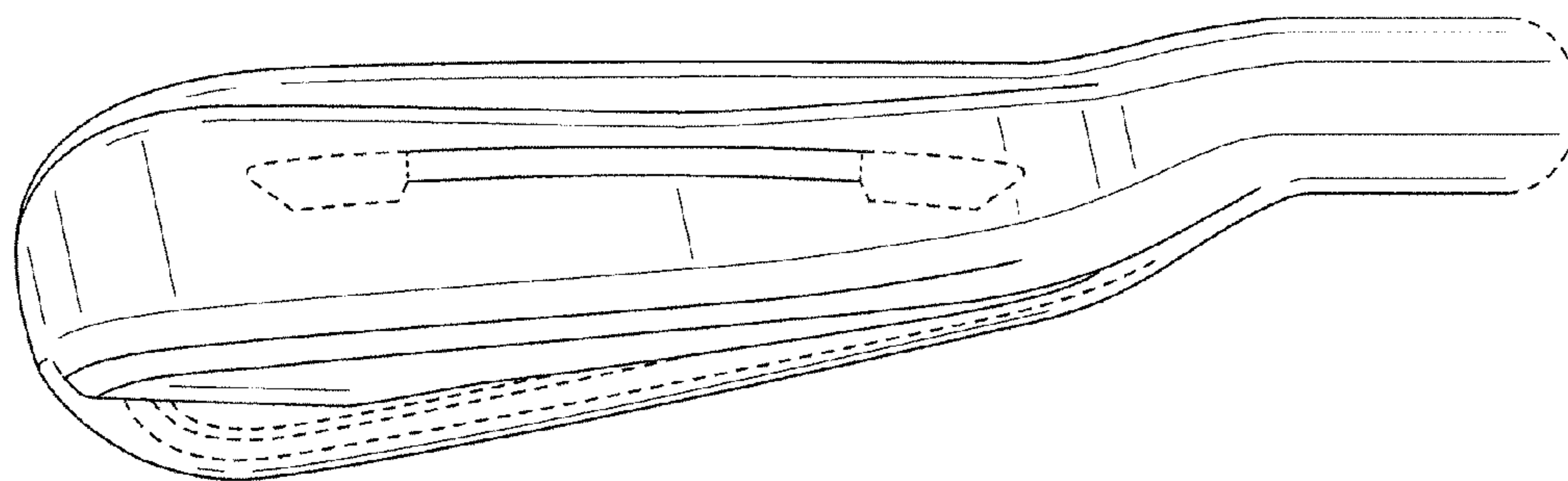

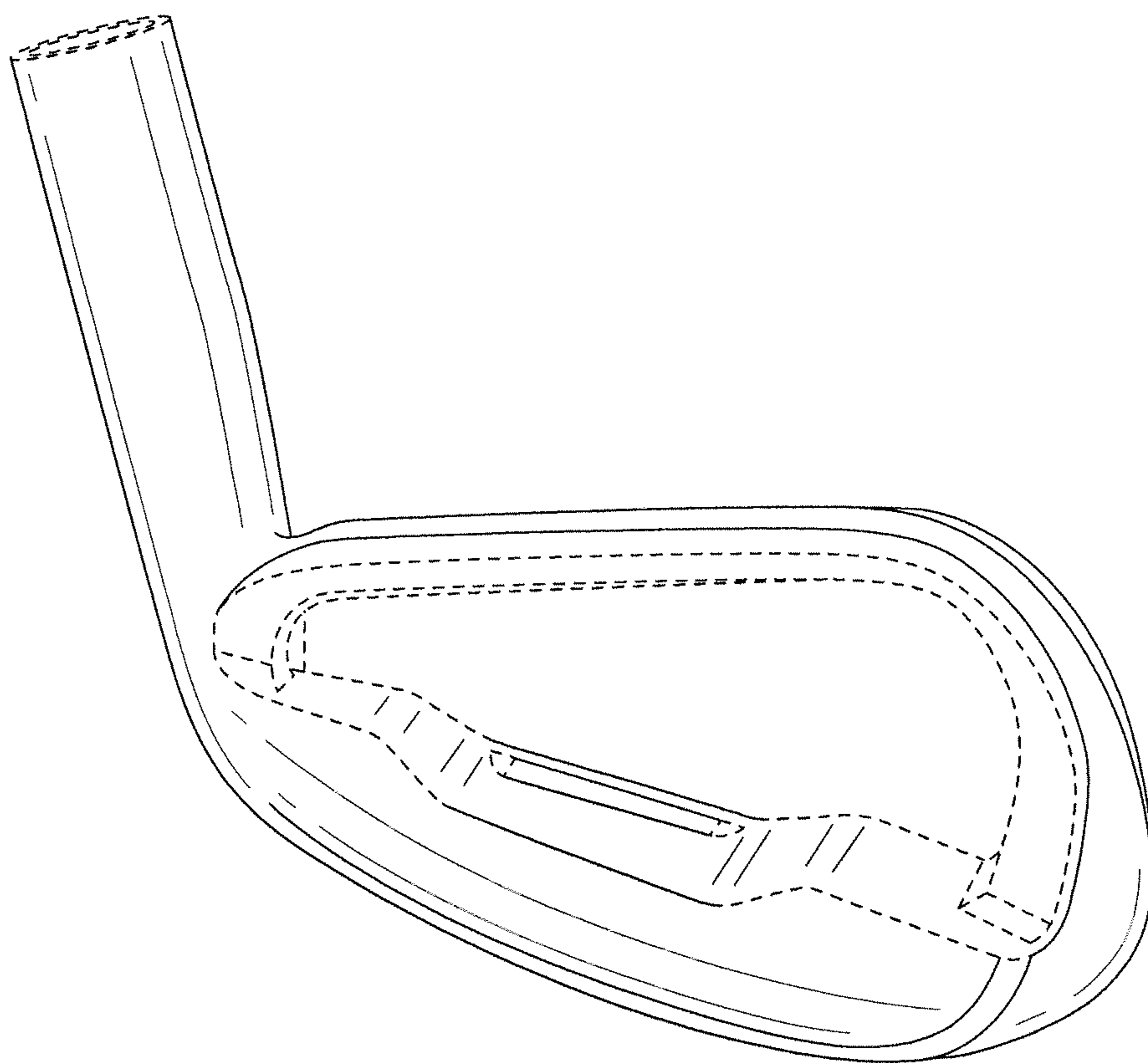
