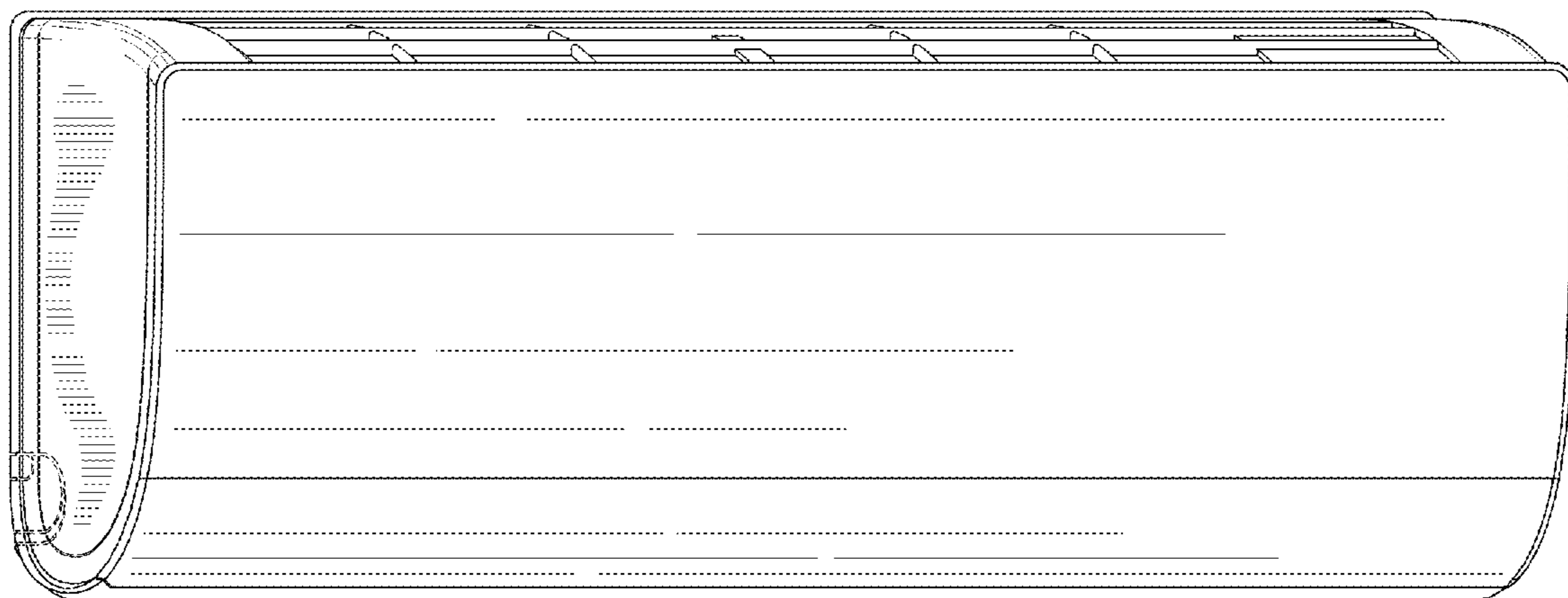
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a split type air conditioner showing our new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a top plan view thereof.
The semi-circular element in FIGS. 1-3 is set forth in broken lines and forms no part of the claimed design.

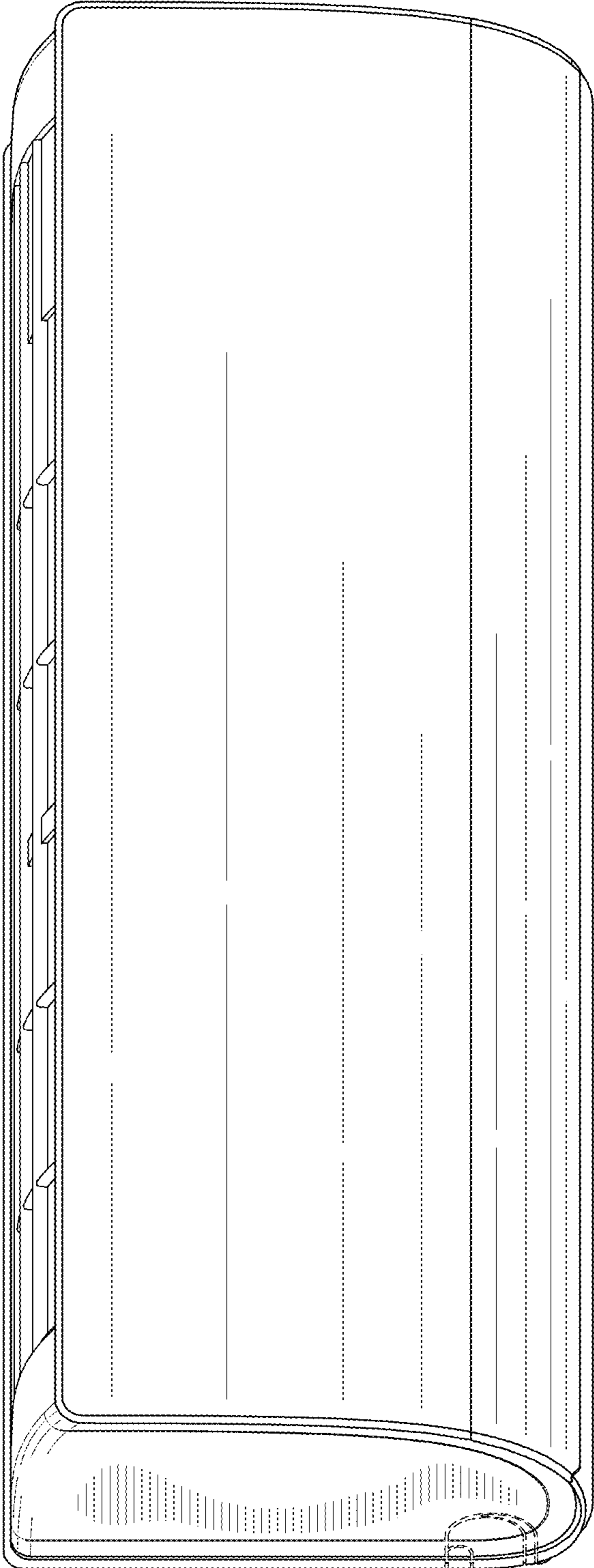

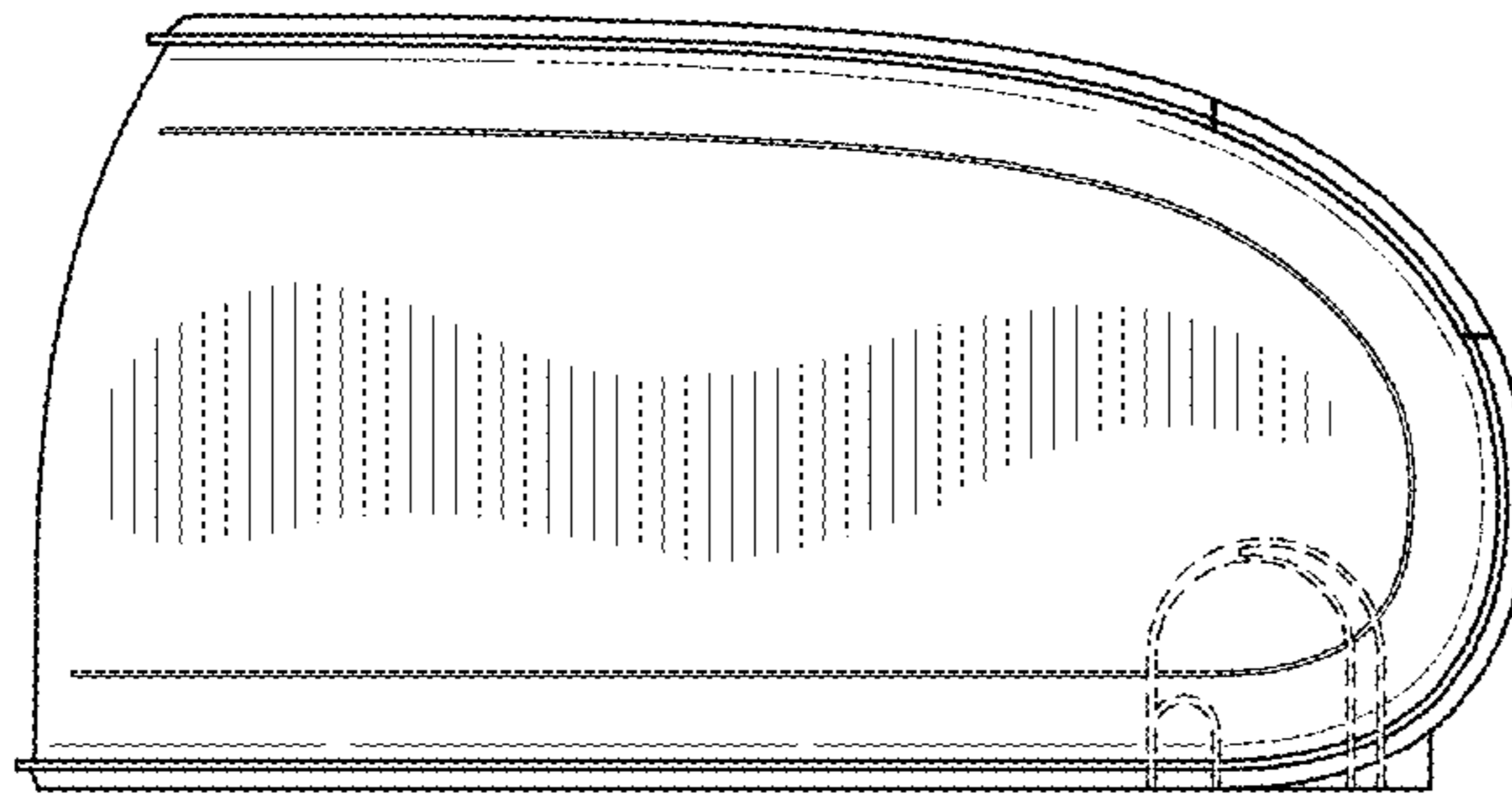

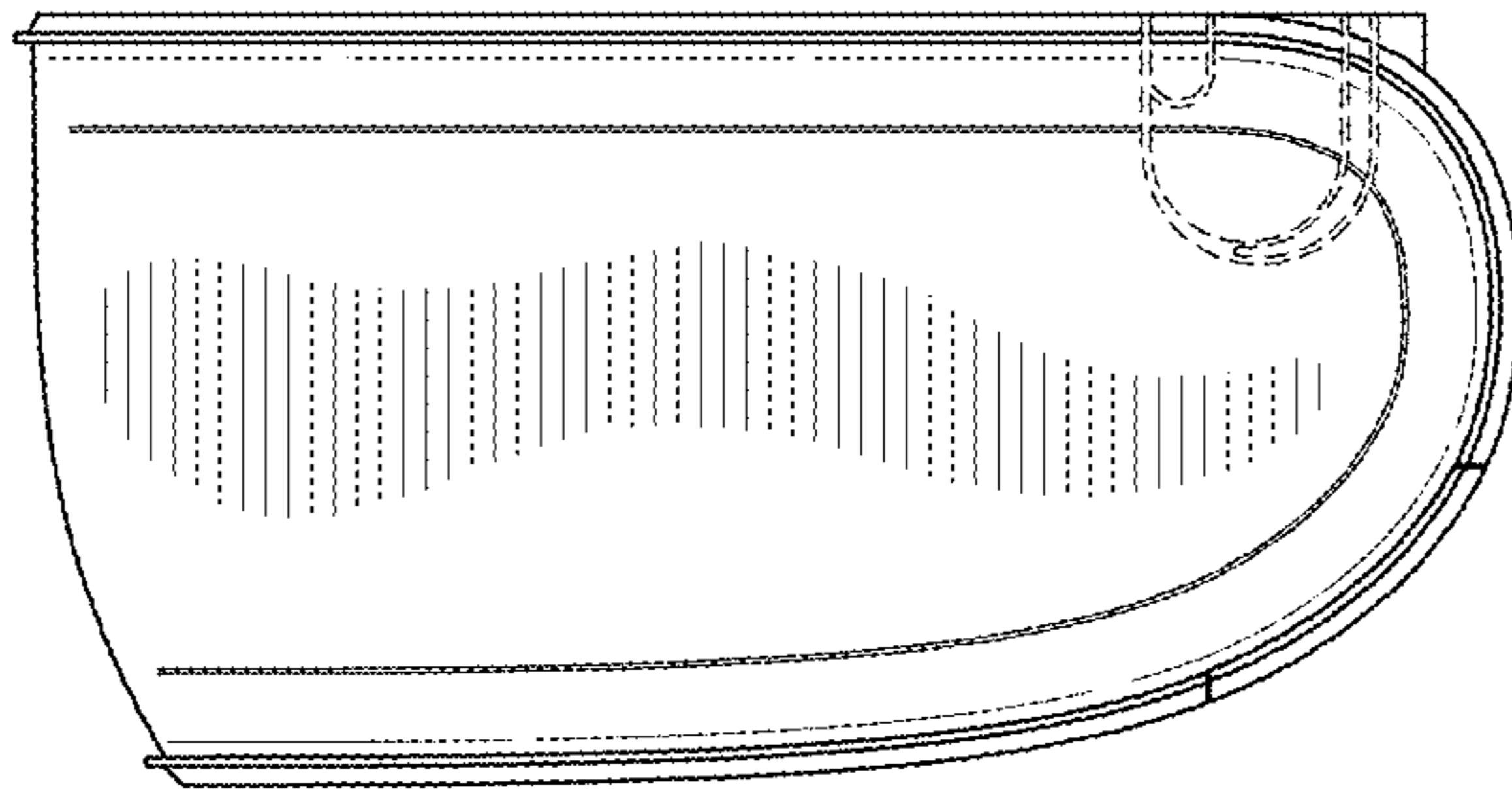

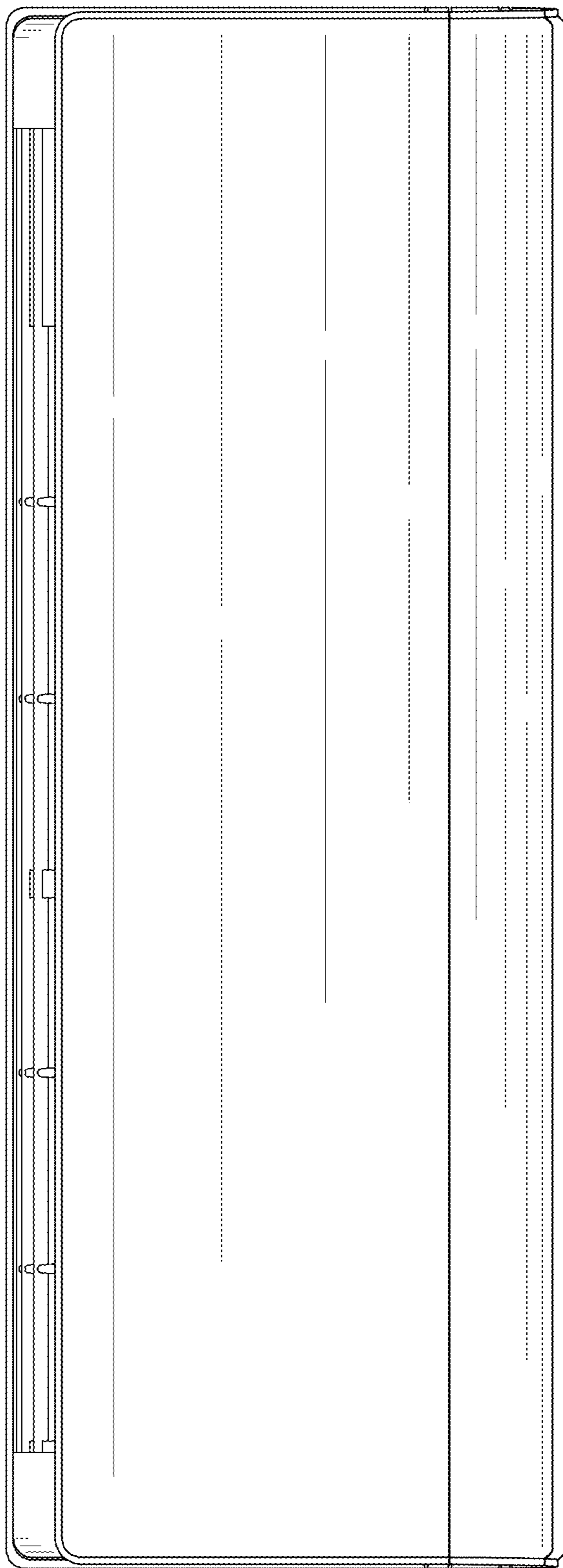

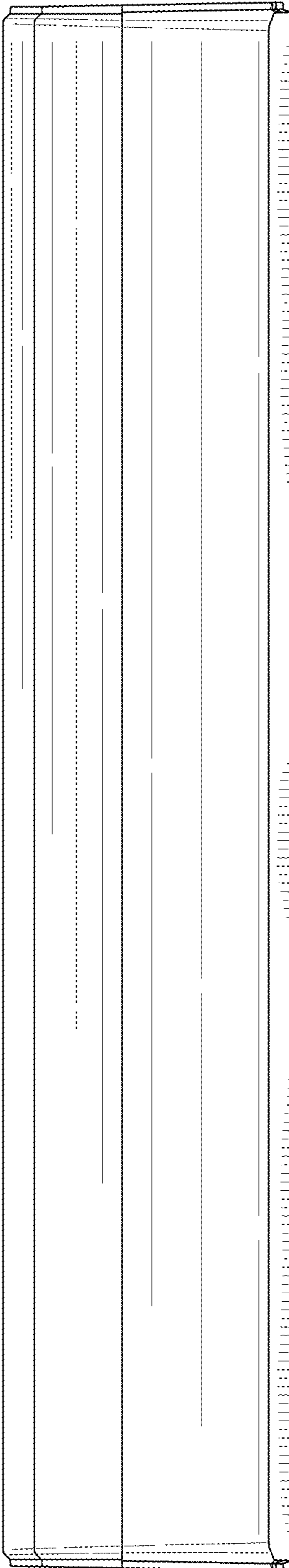

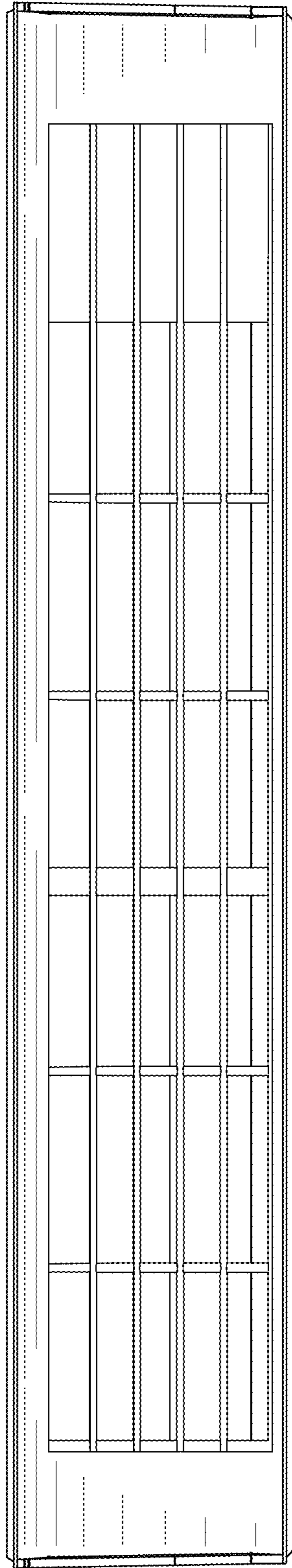
