DESCRIPTION

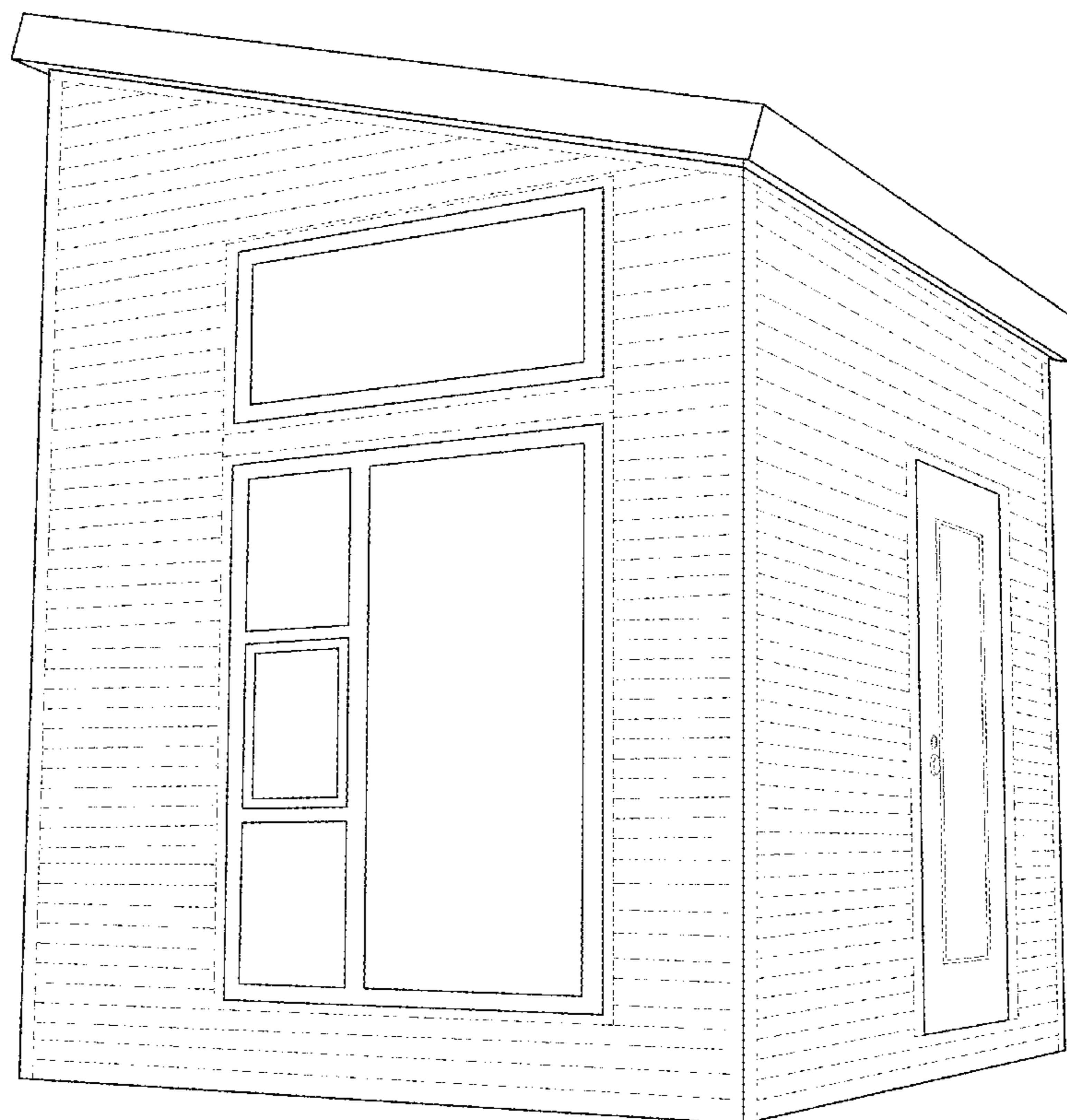
FIG. 1 is a perspective view of a prefabricated house showing my design;

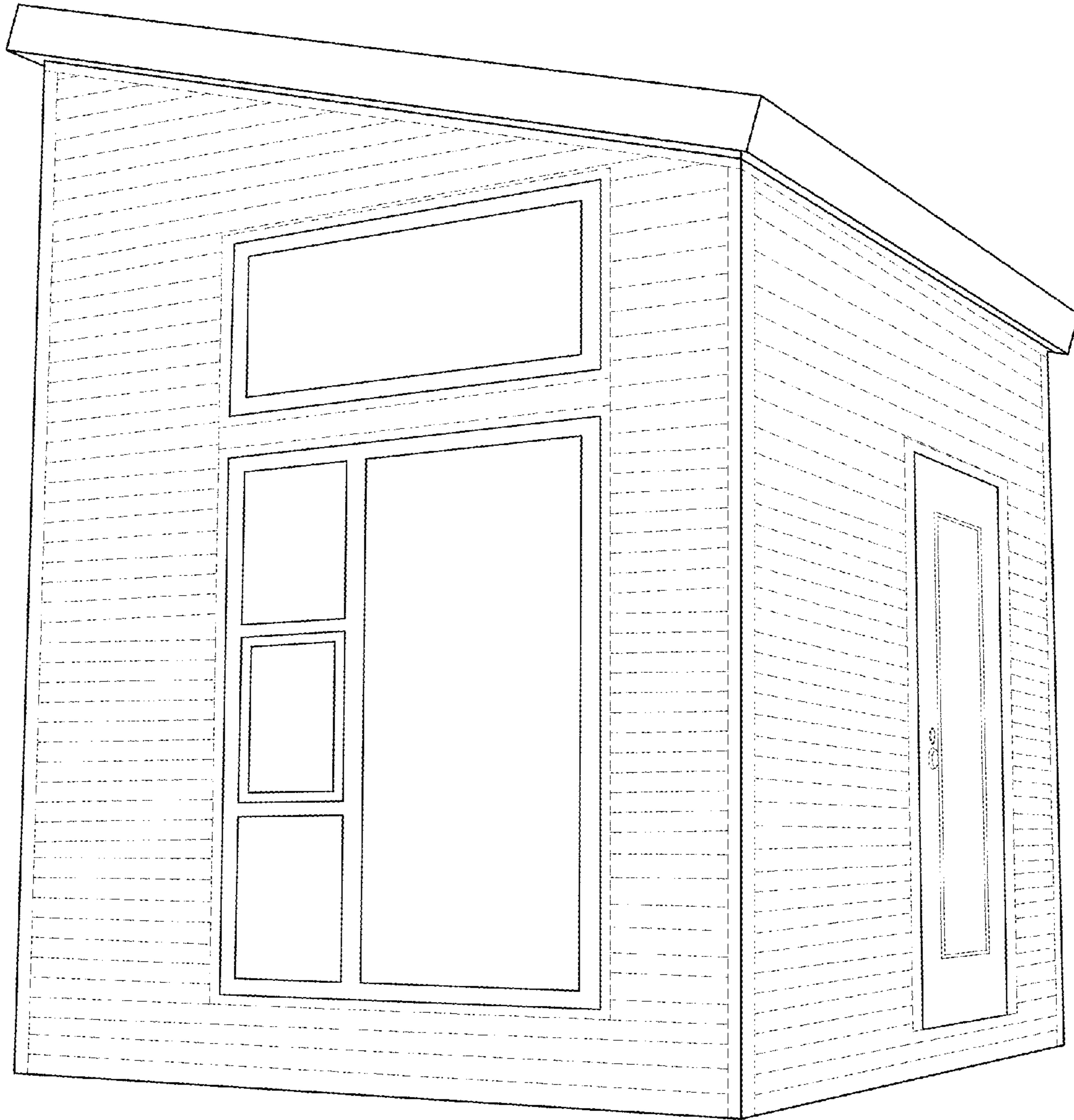

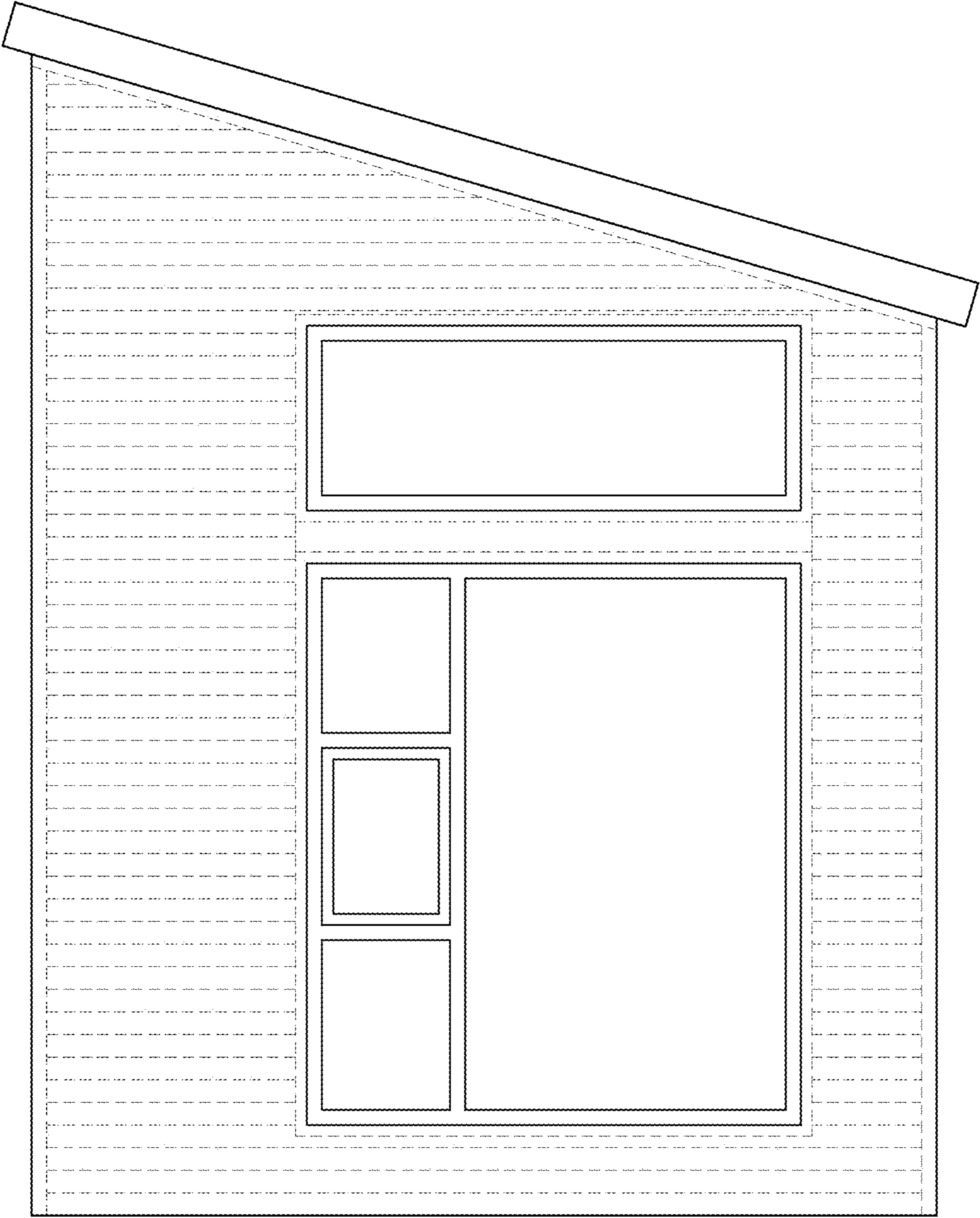

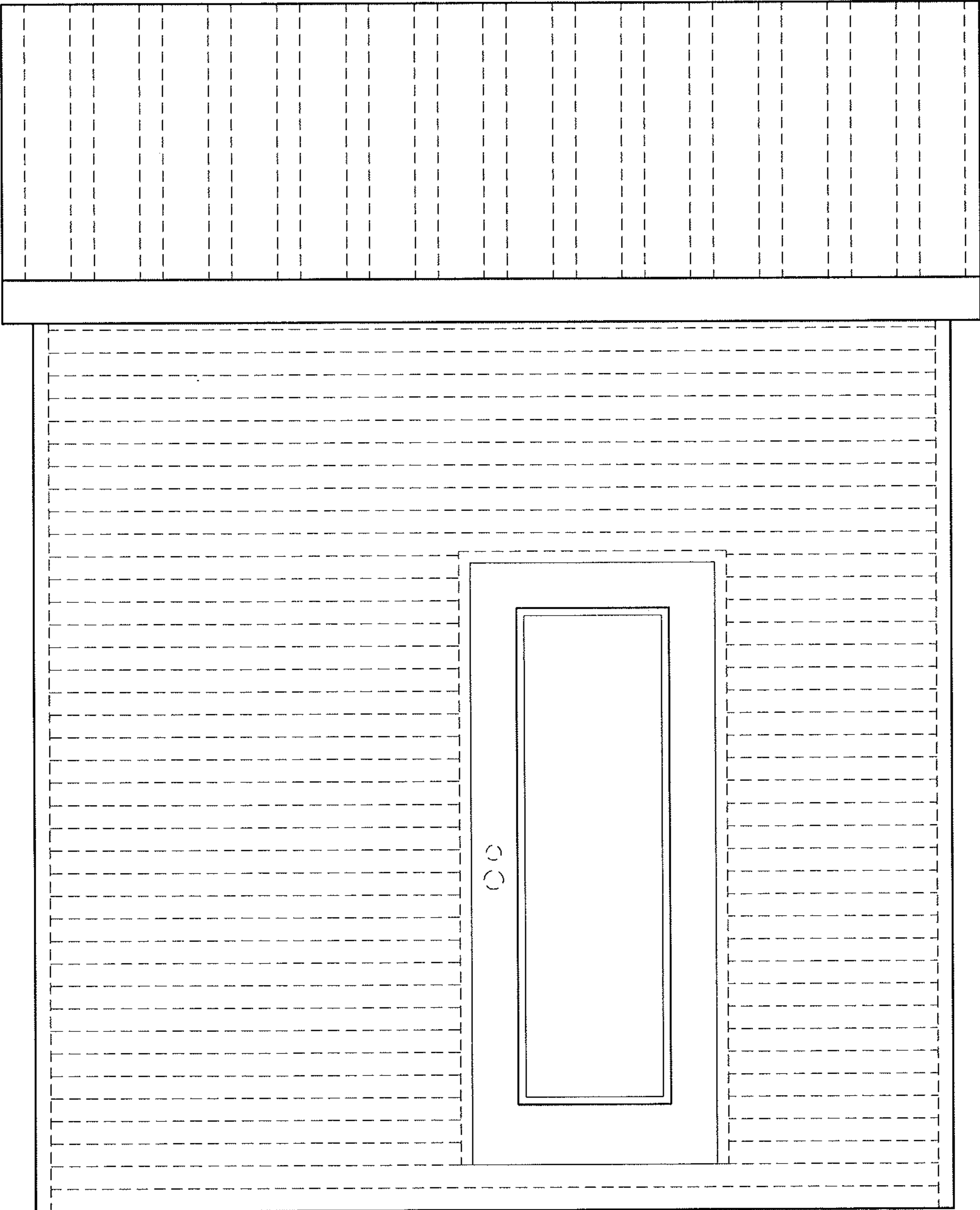

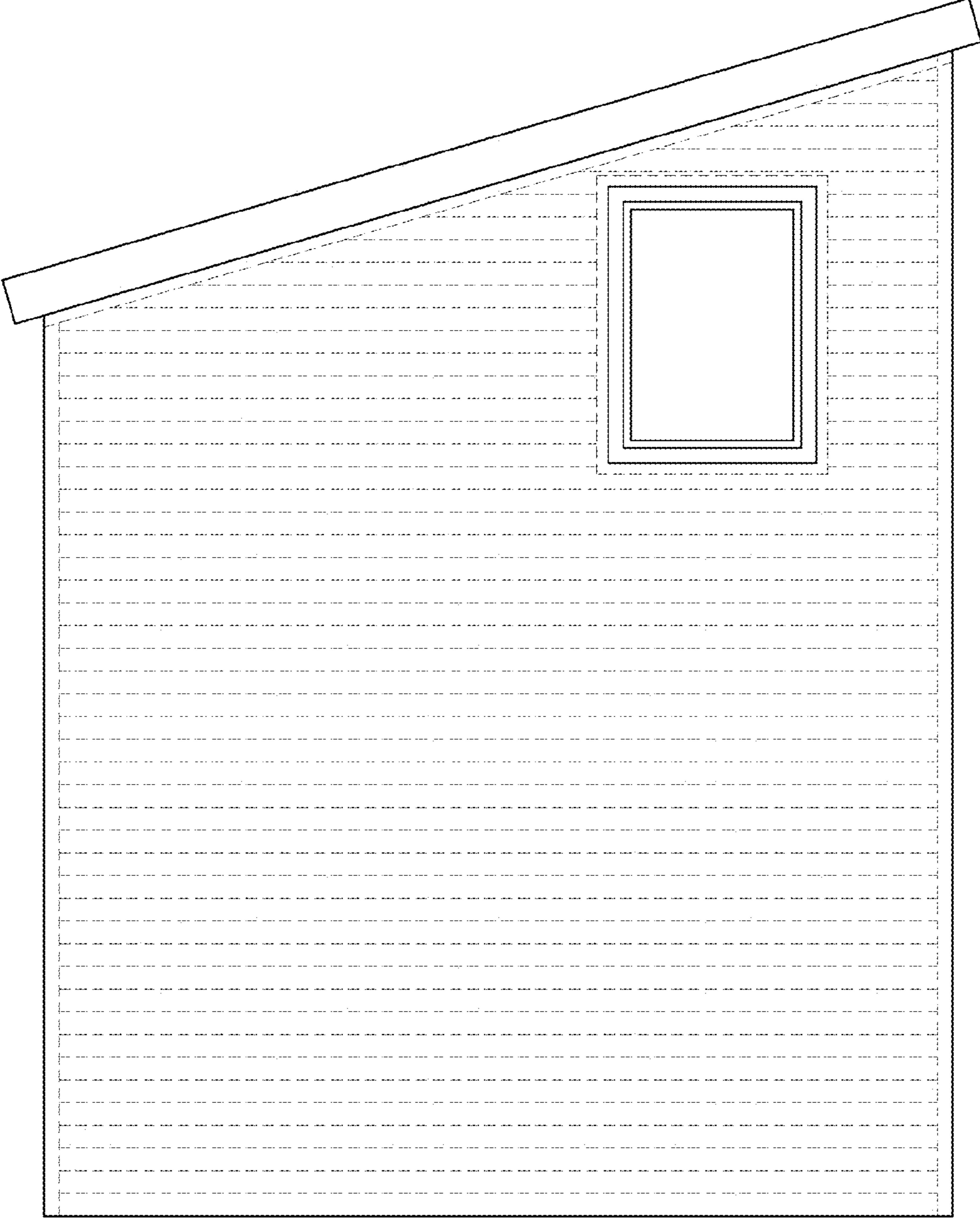

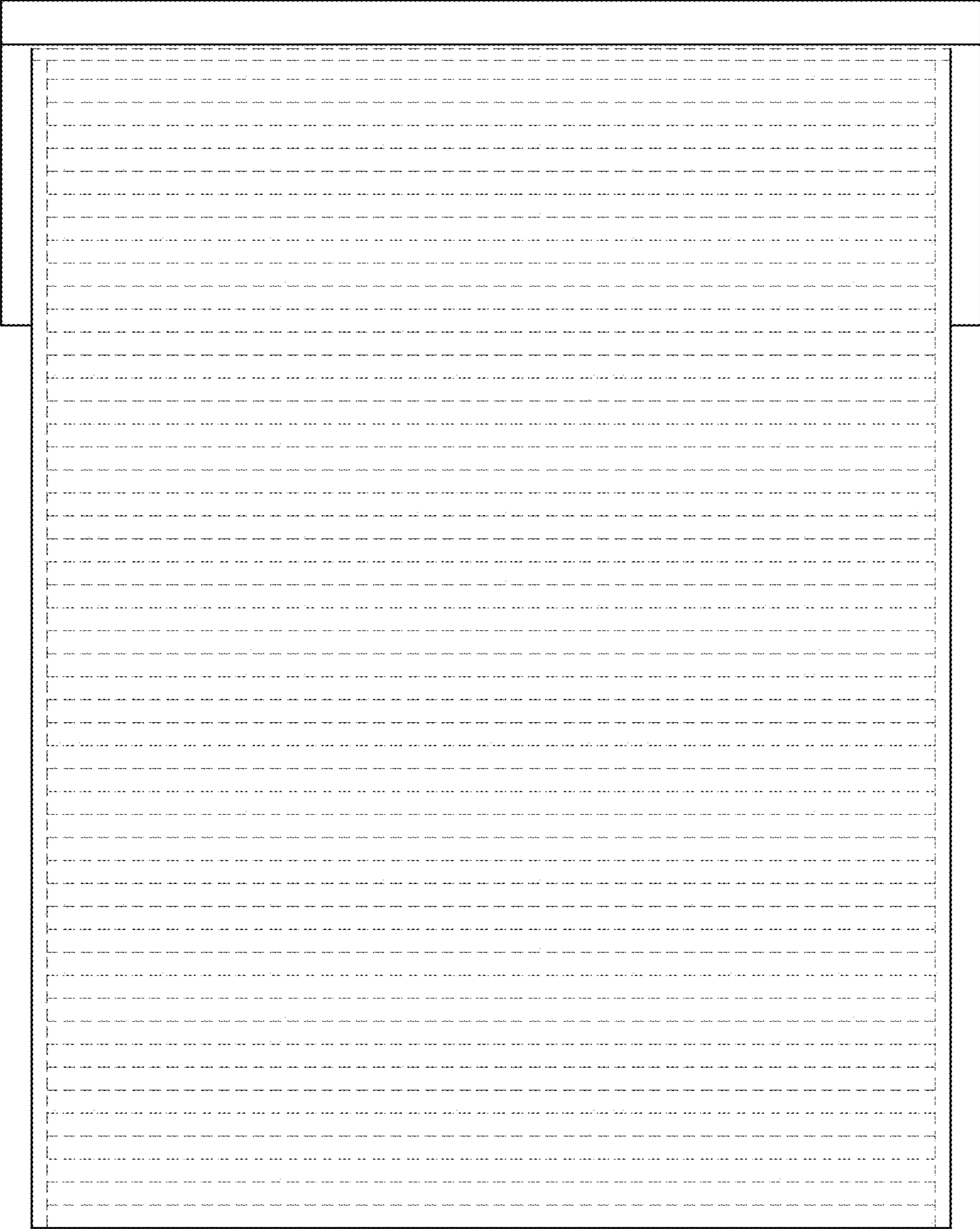

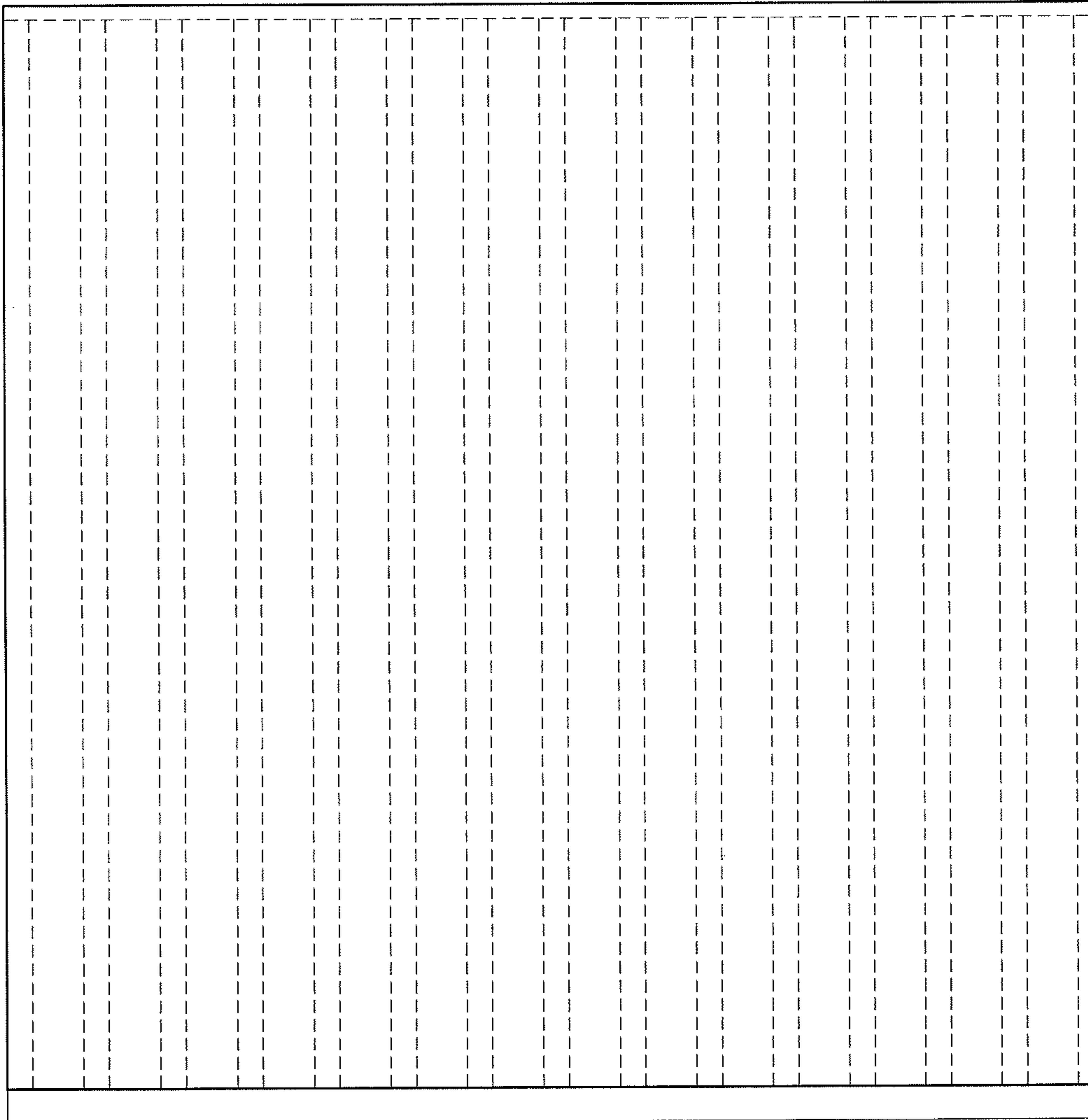
