FIG. 6 is a front view thereof.

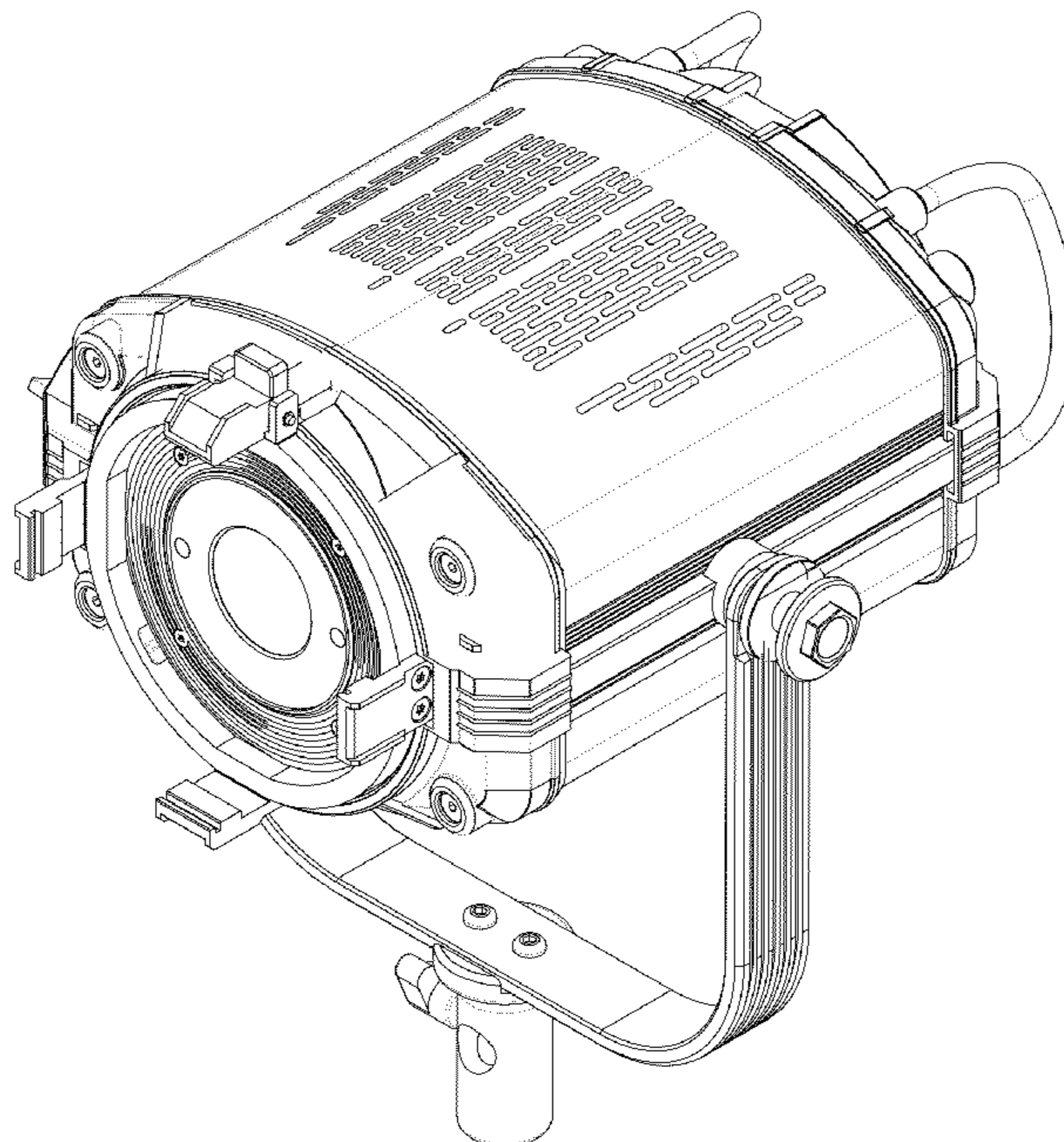
FIG. 7 is a rear view thereof.

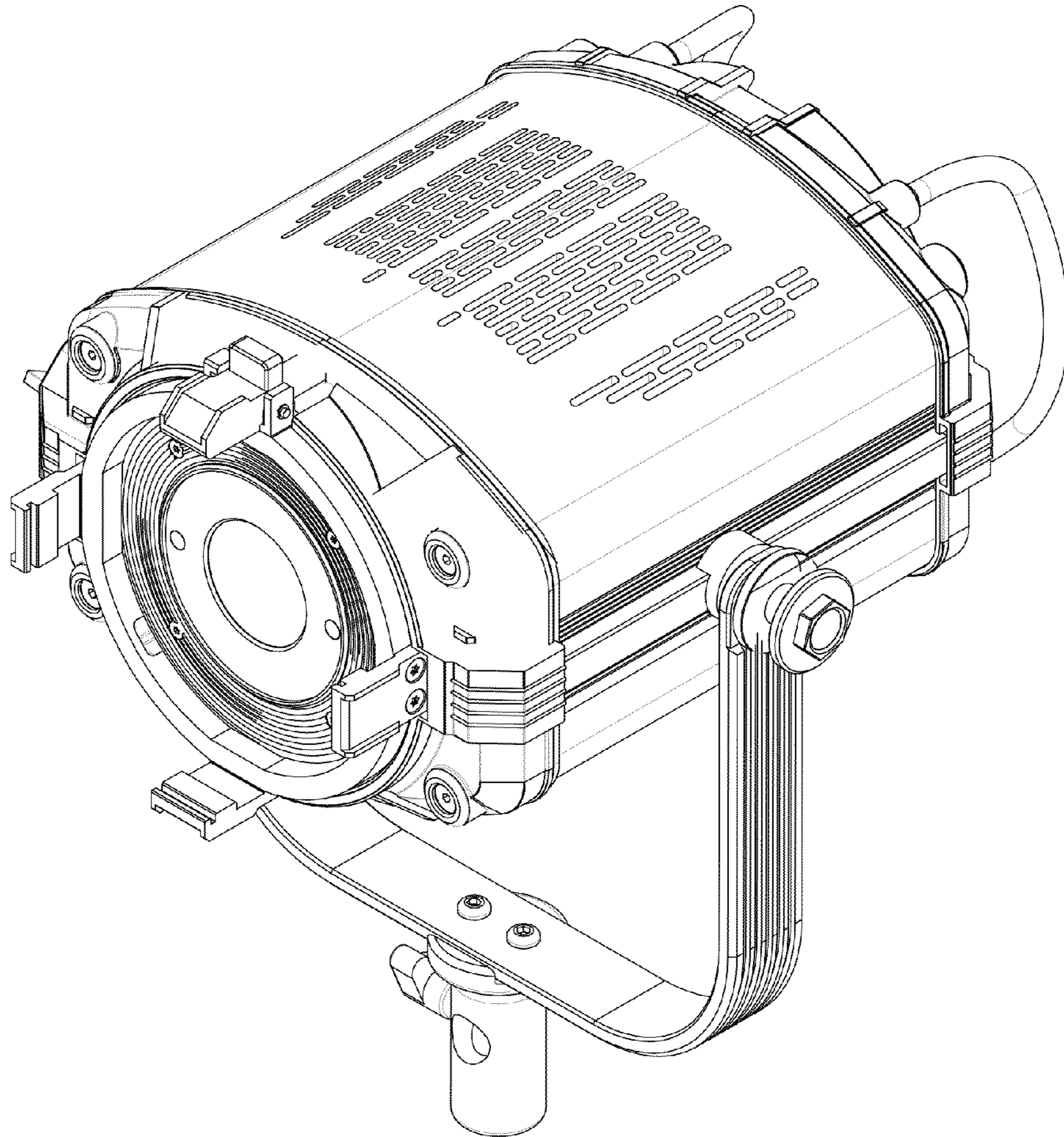

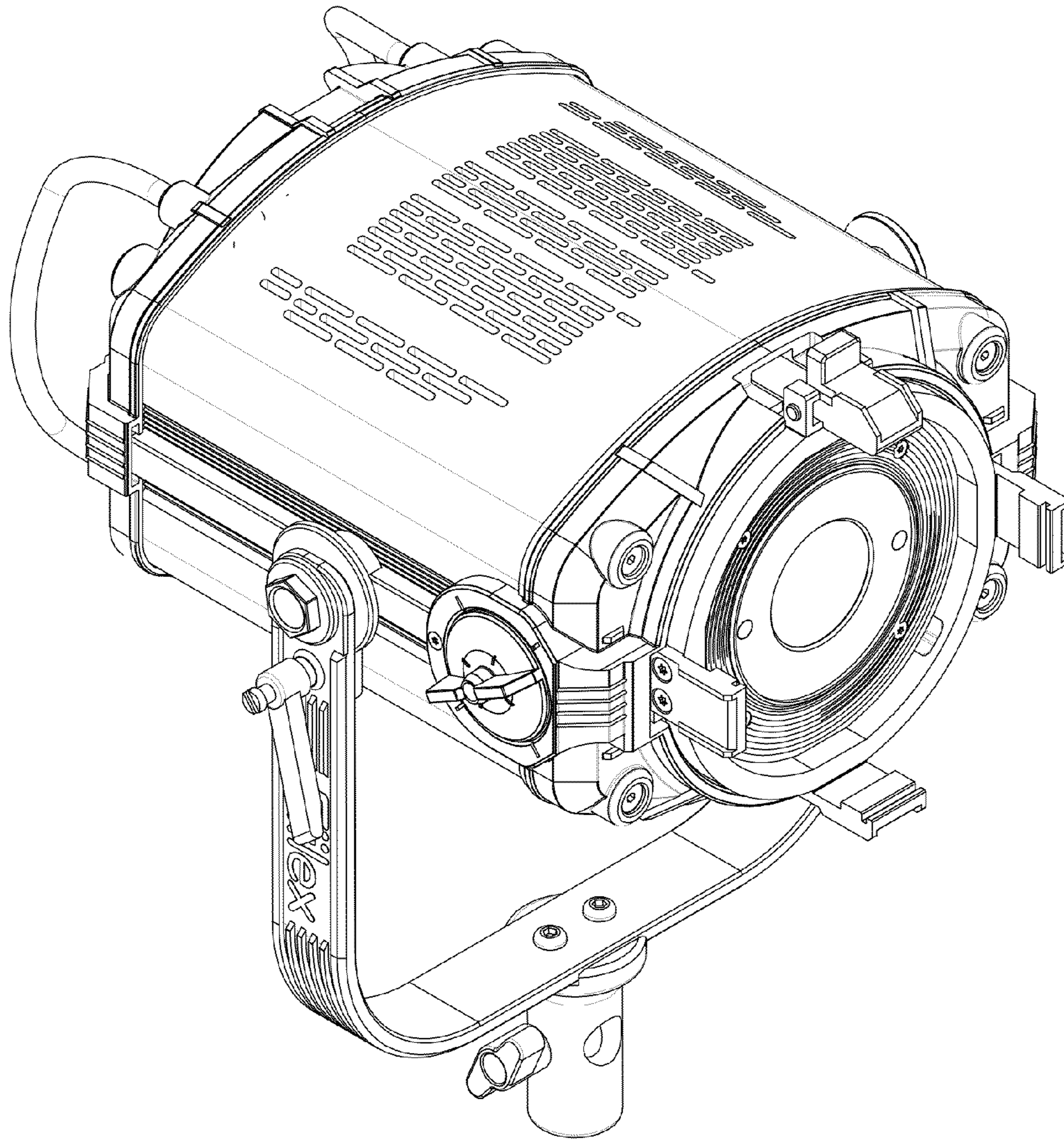

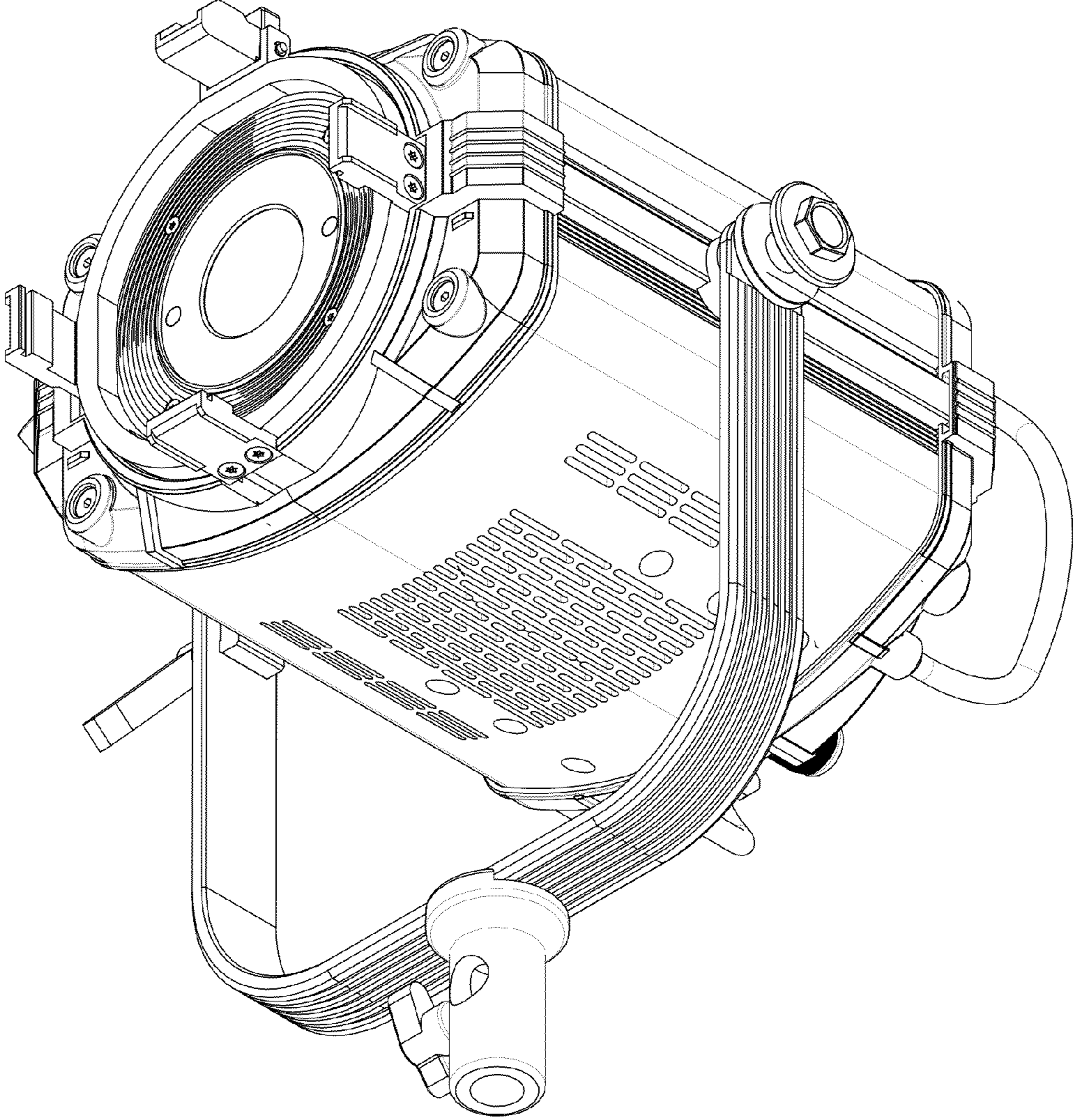

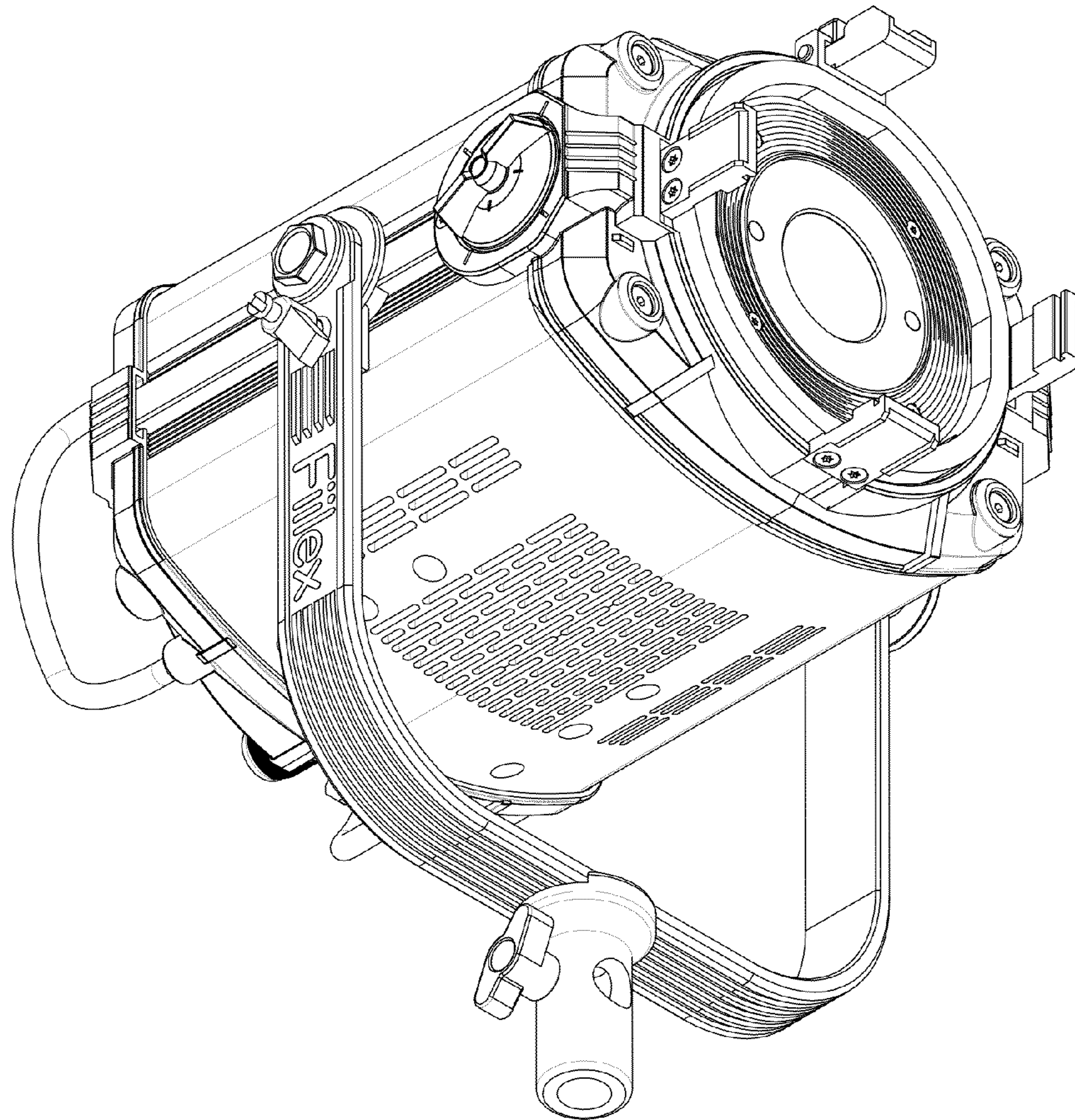

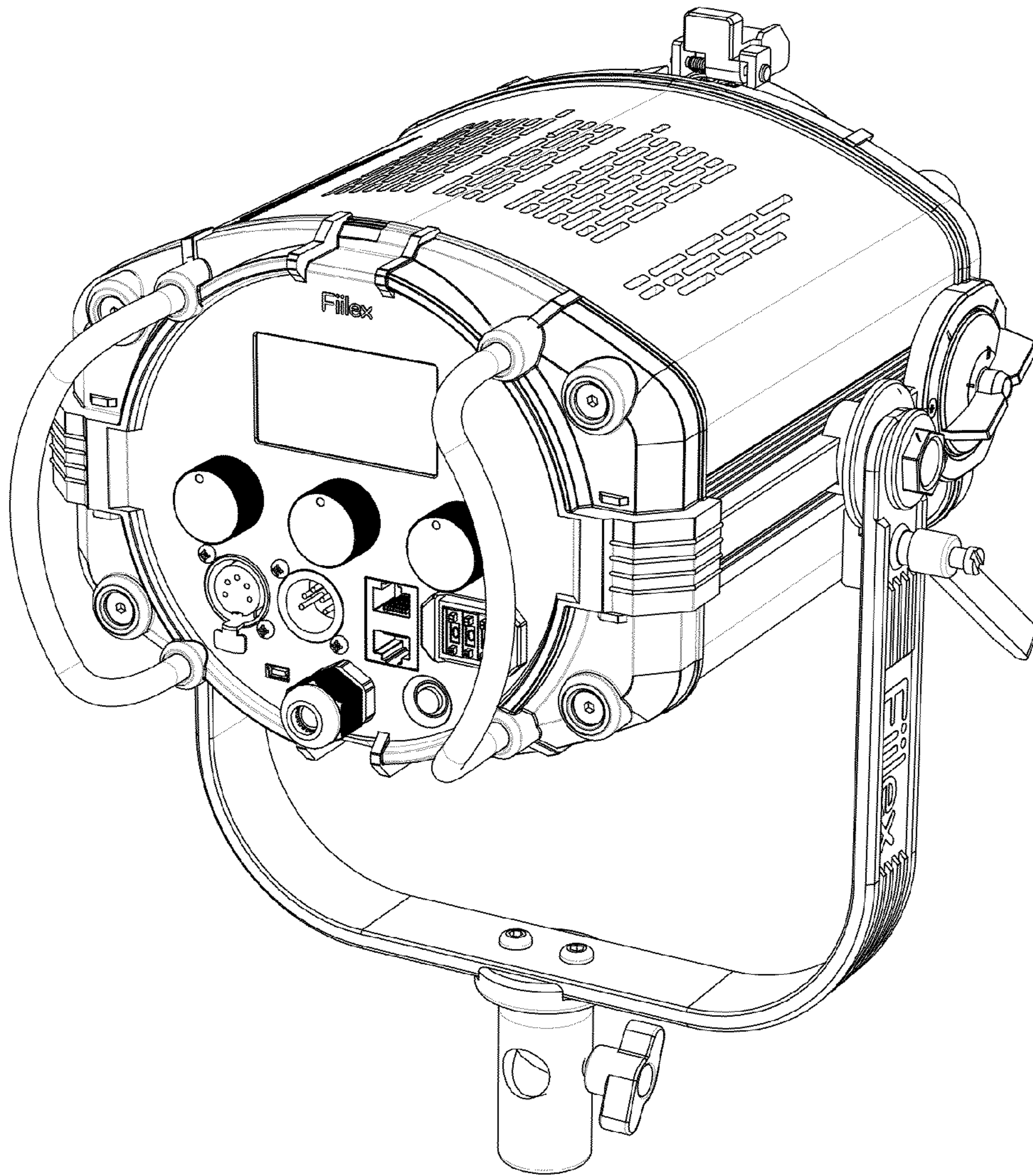

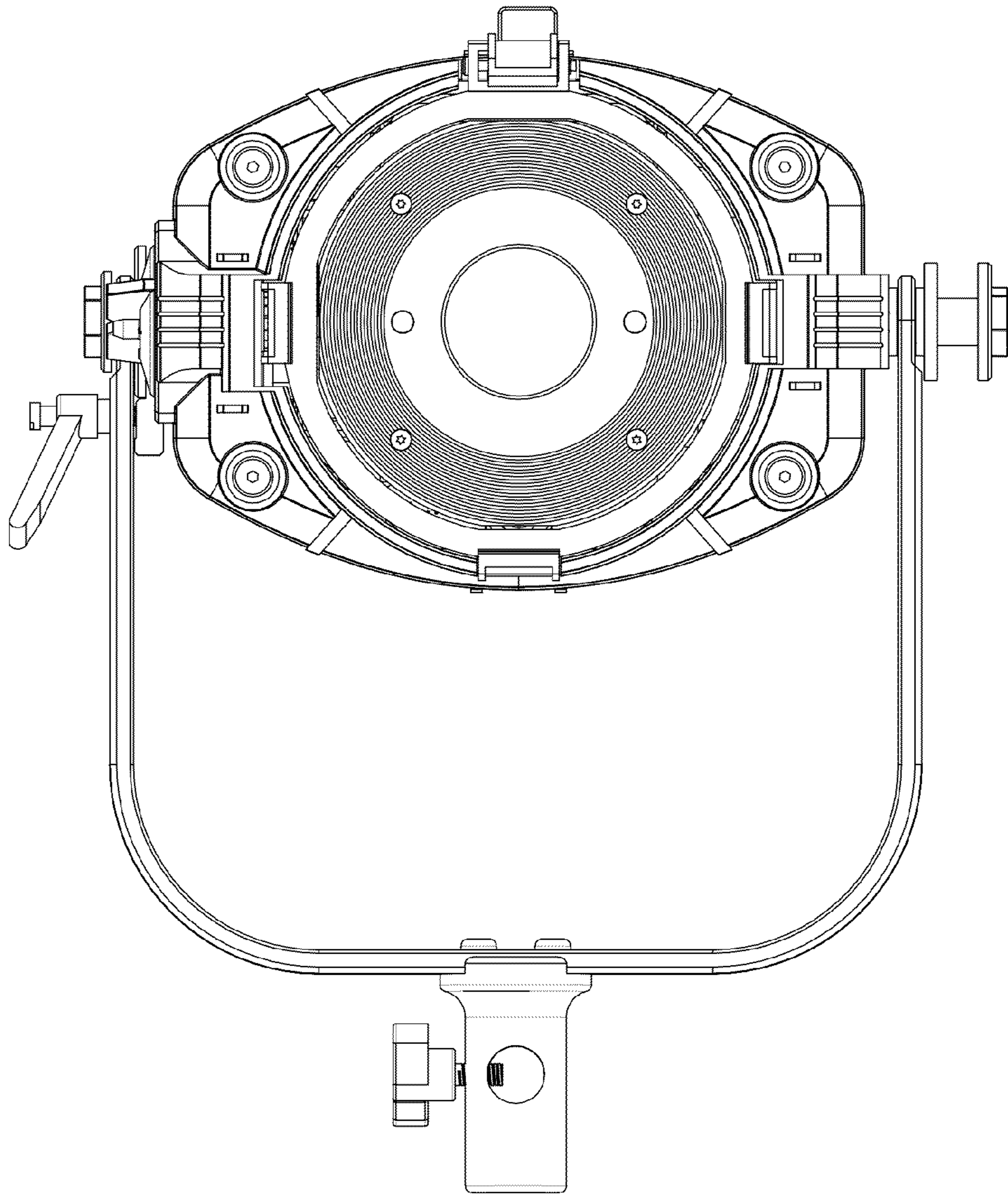

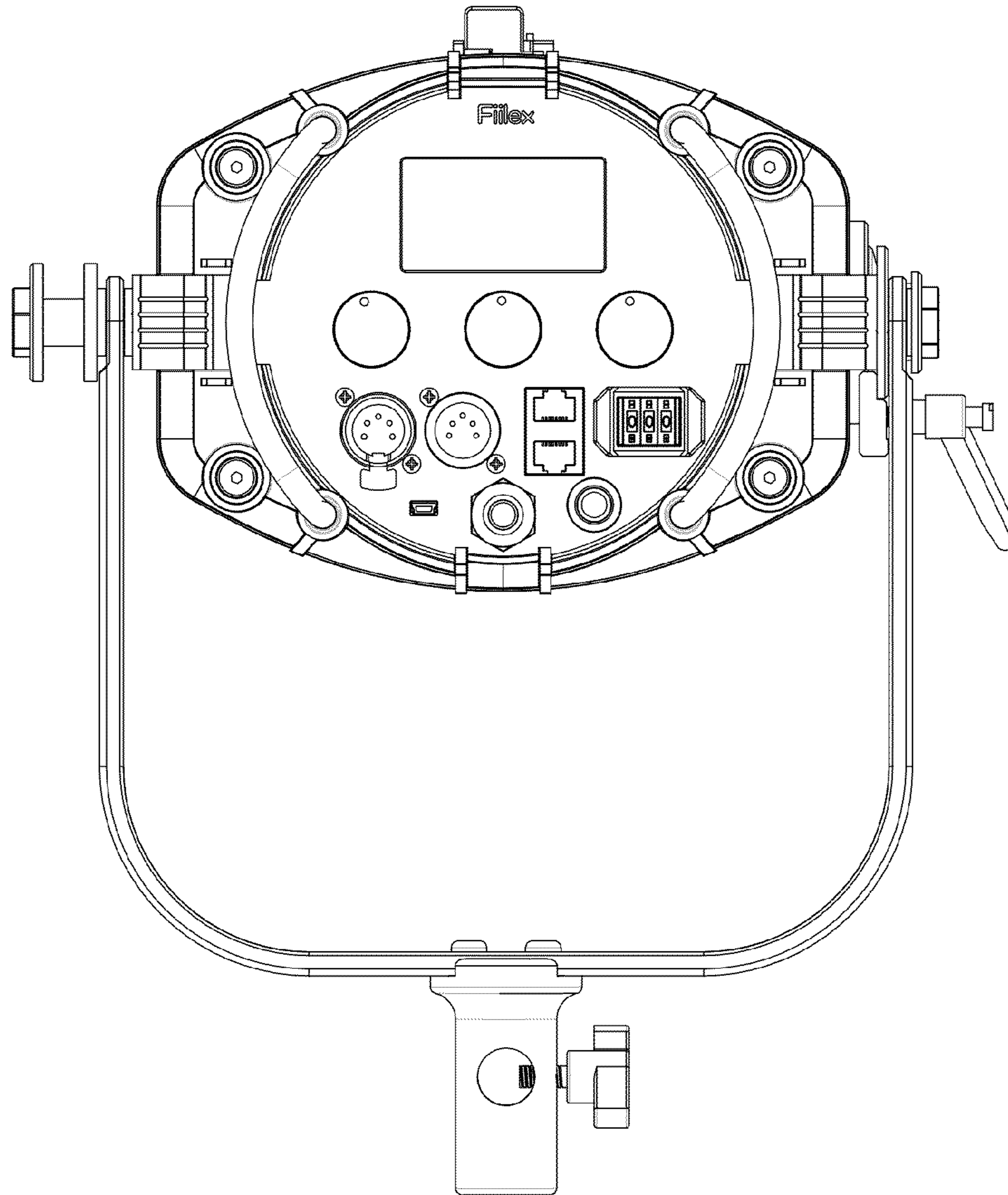

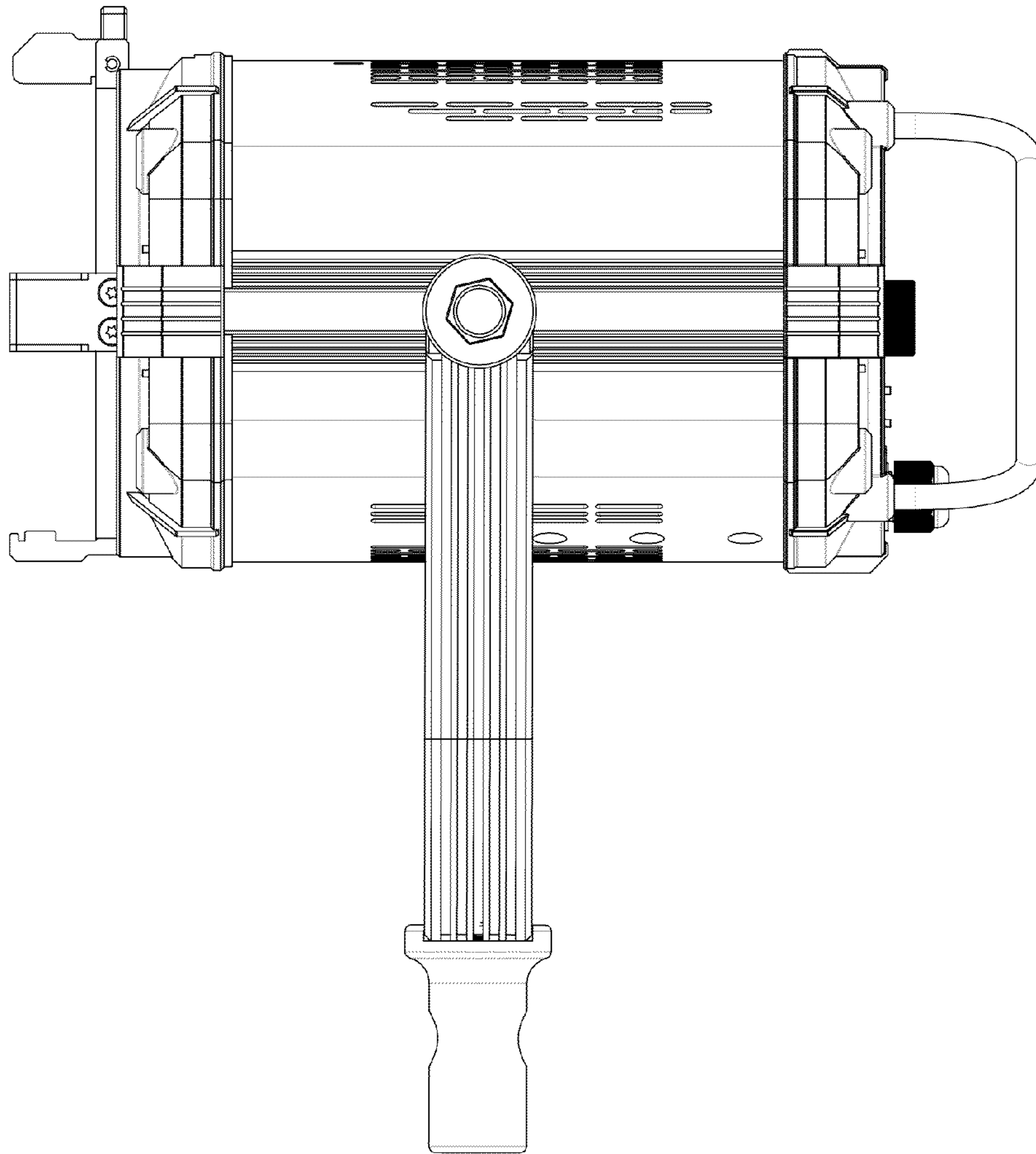

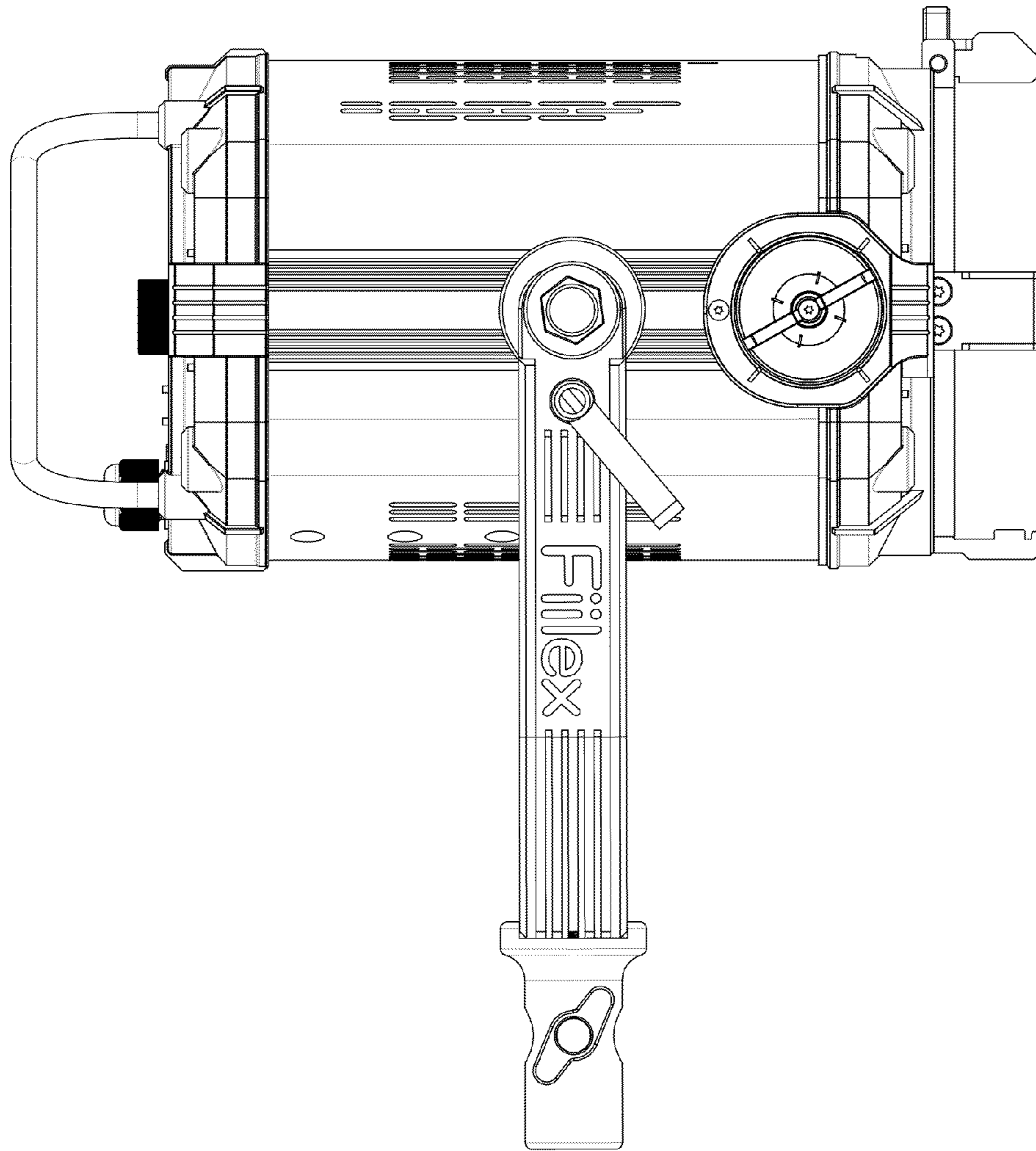

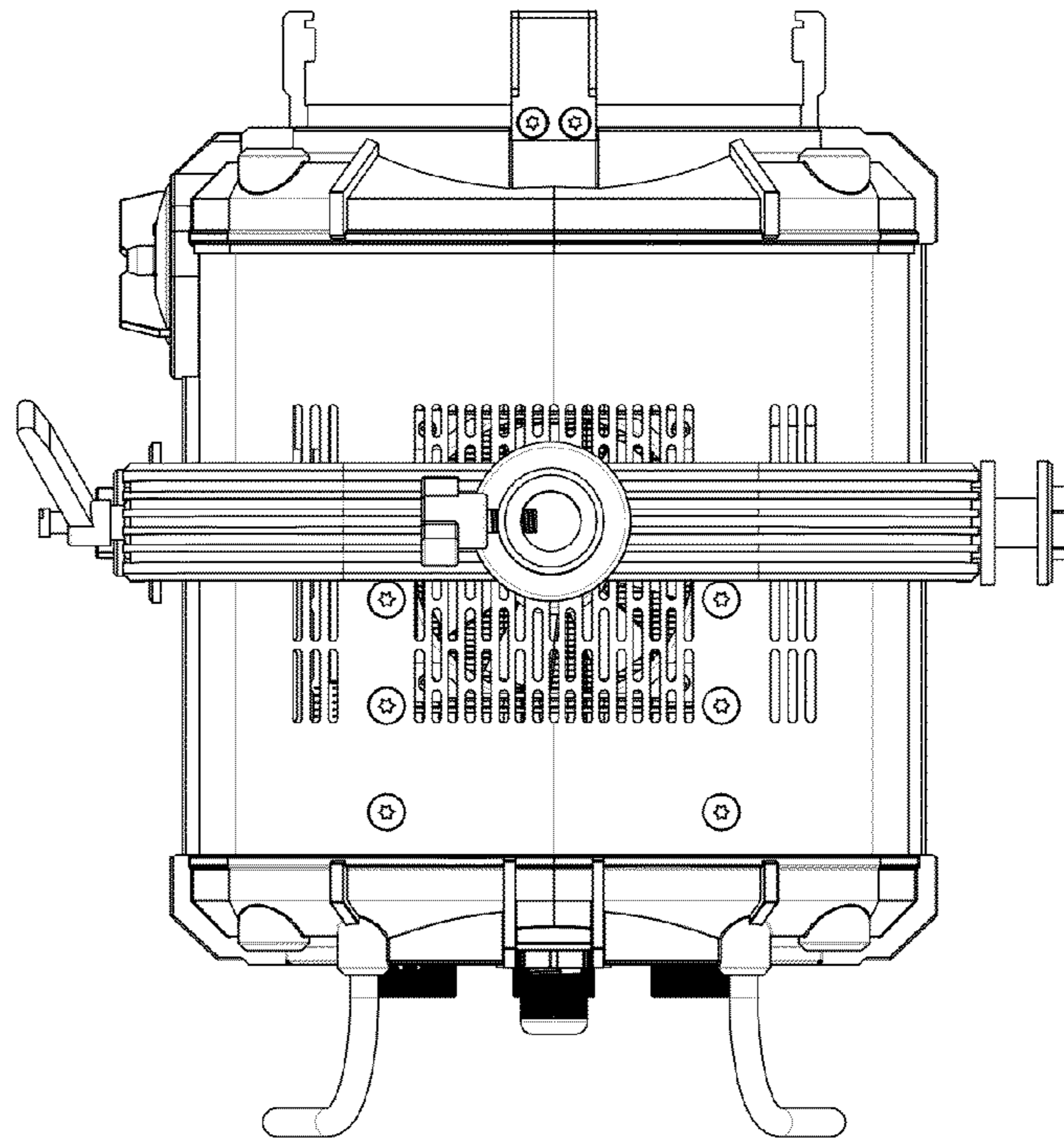

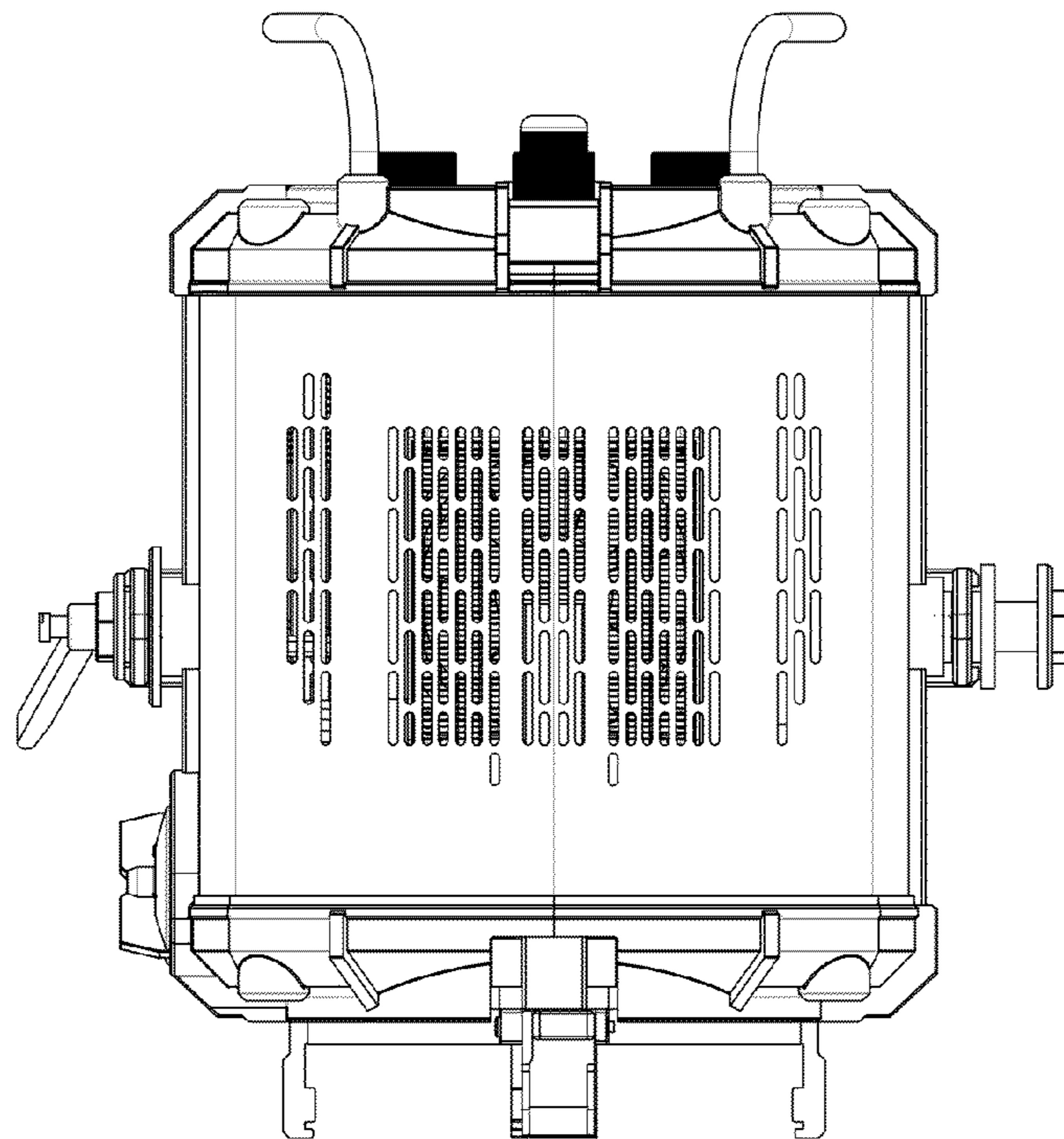
