DESCRIPTION

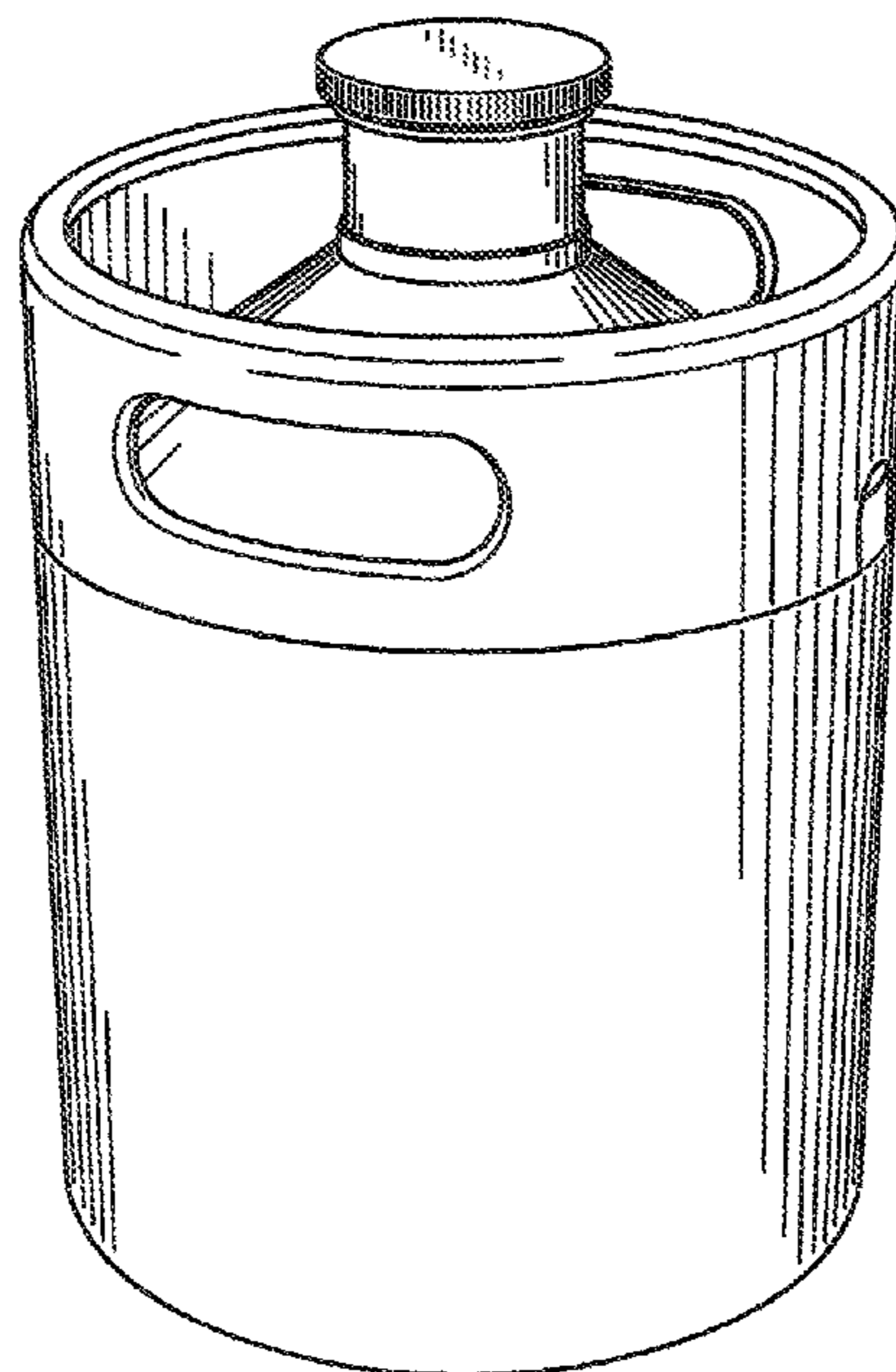
FIG. 1 is a front perspective view of a mini-keg growler showing my new design;

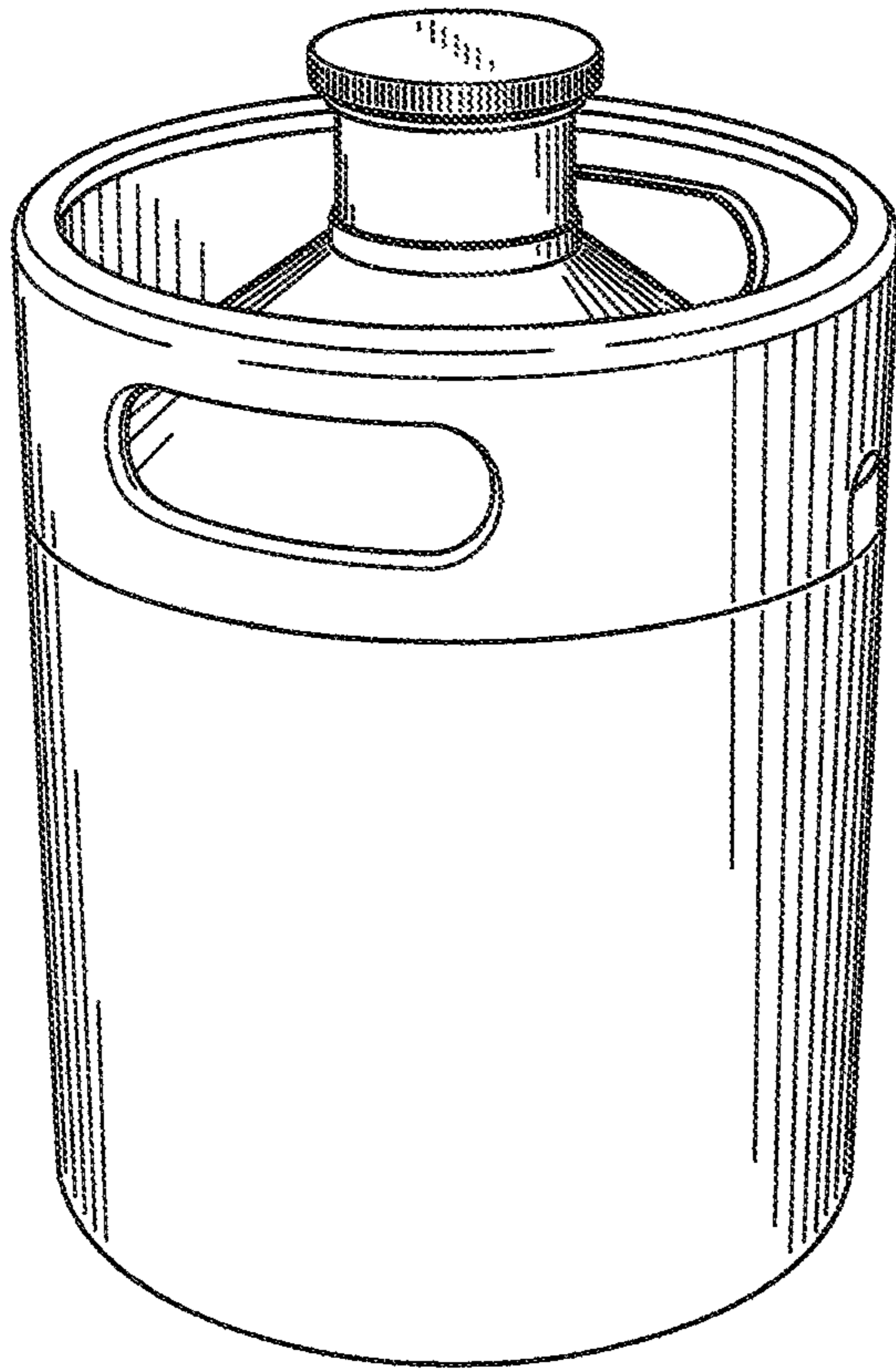

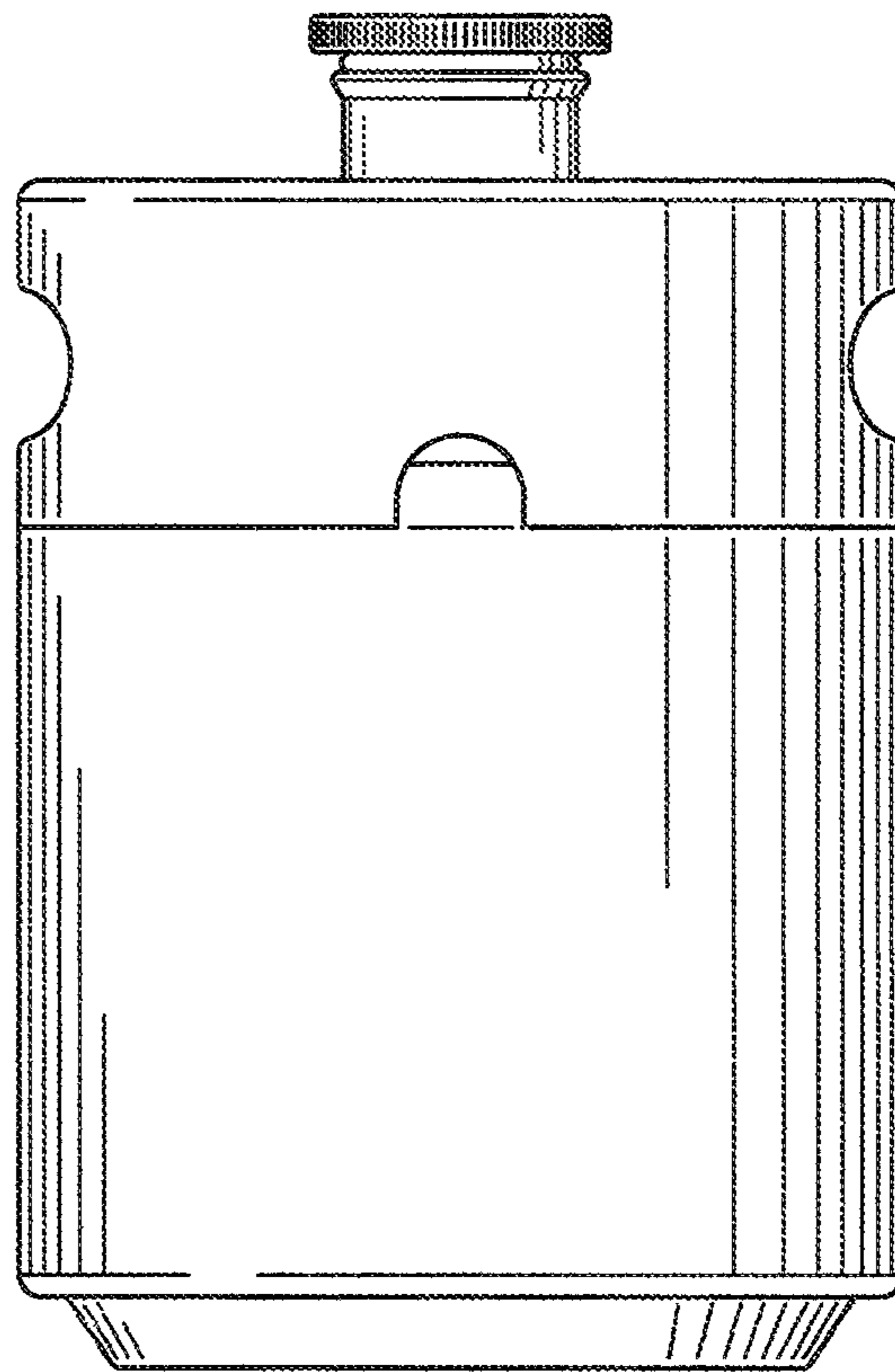

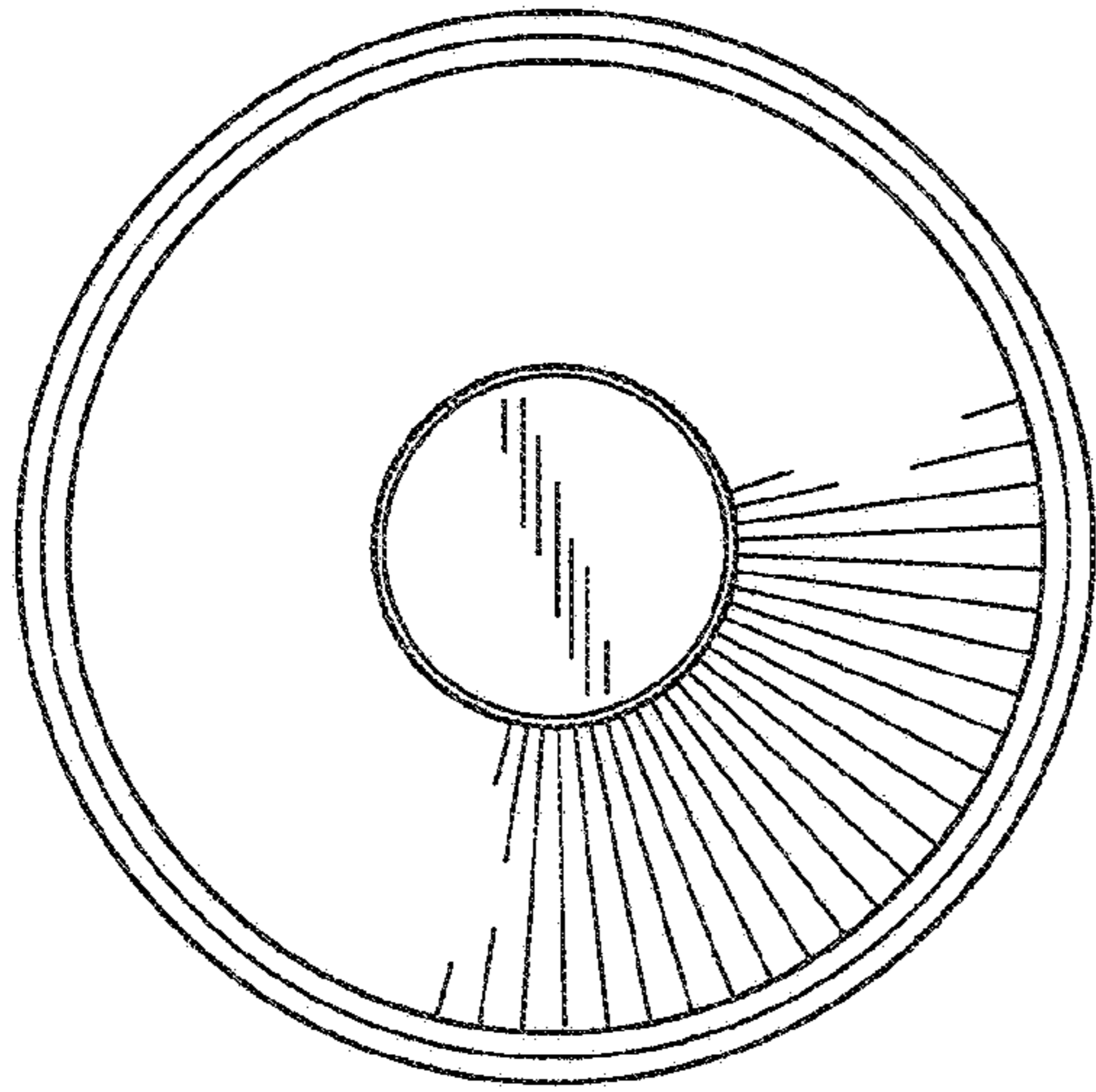

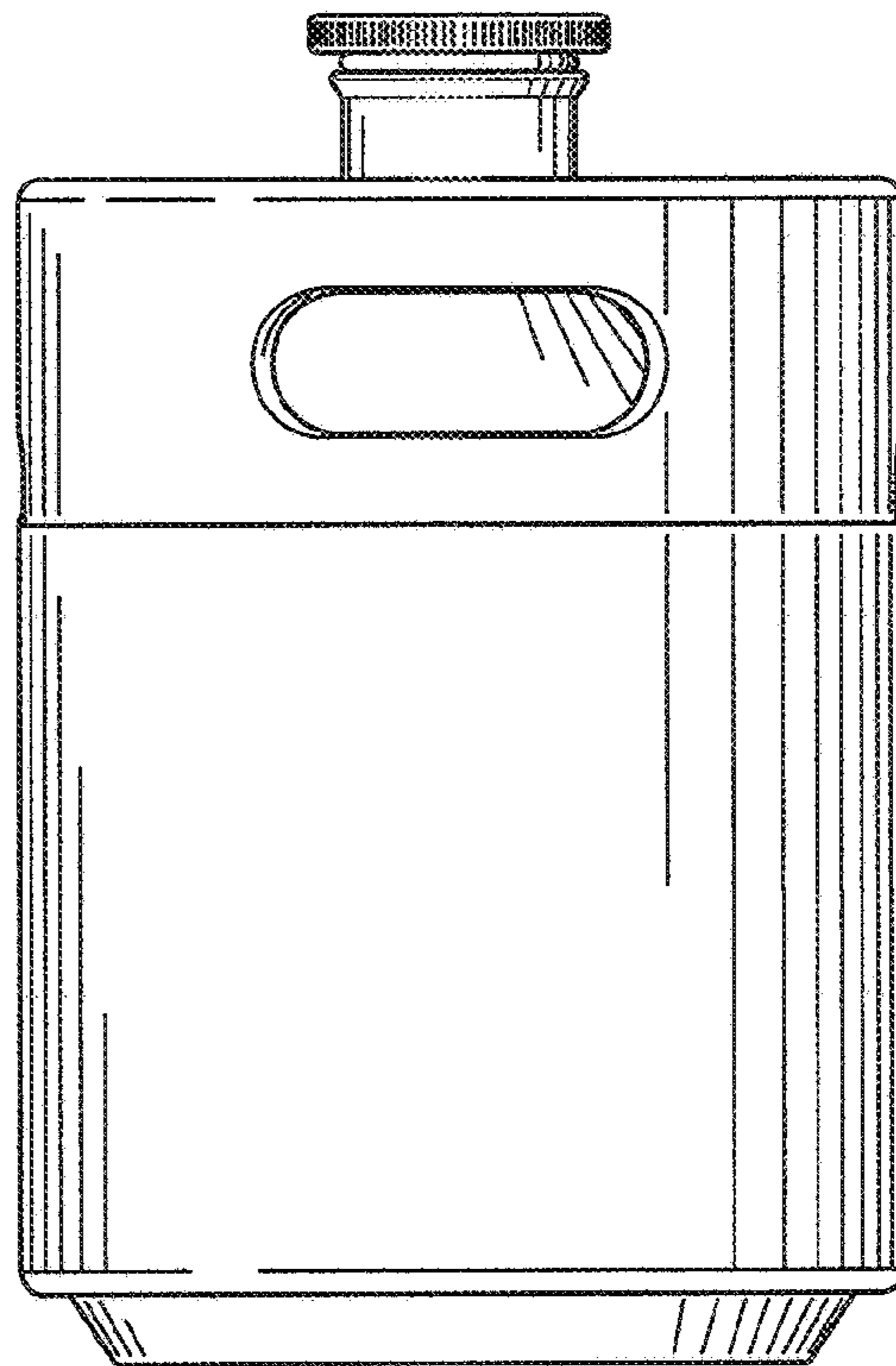

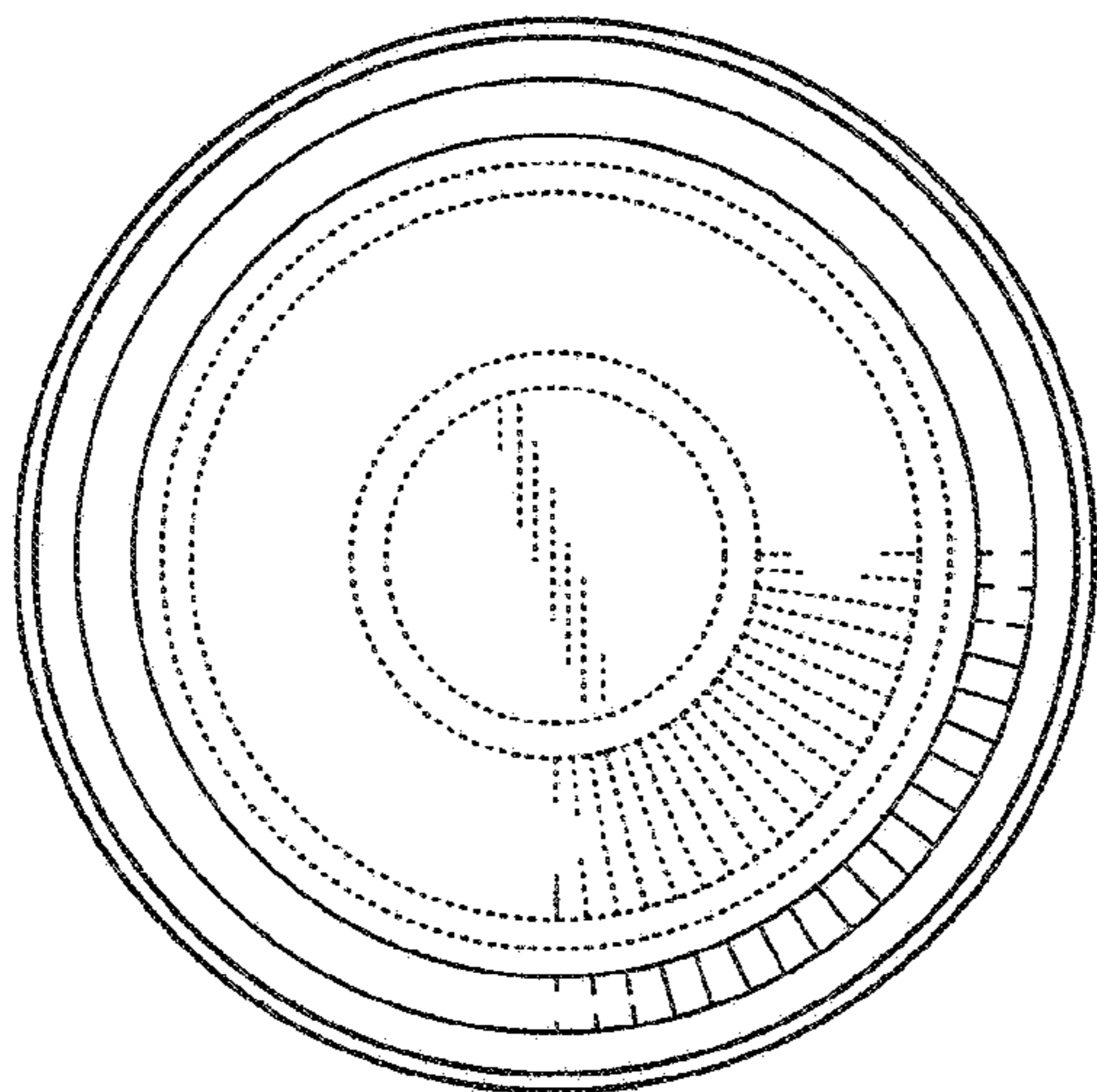
