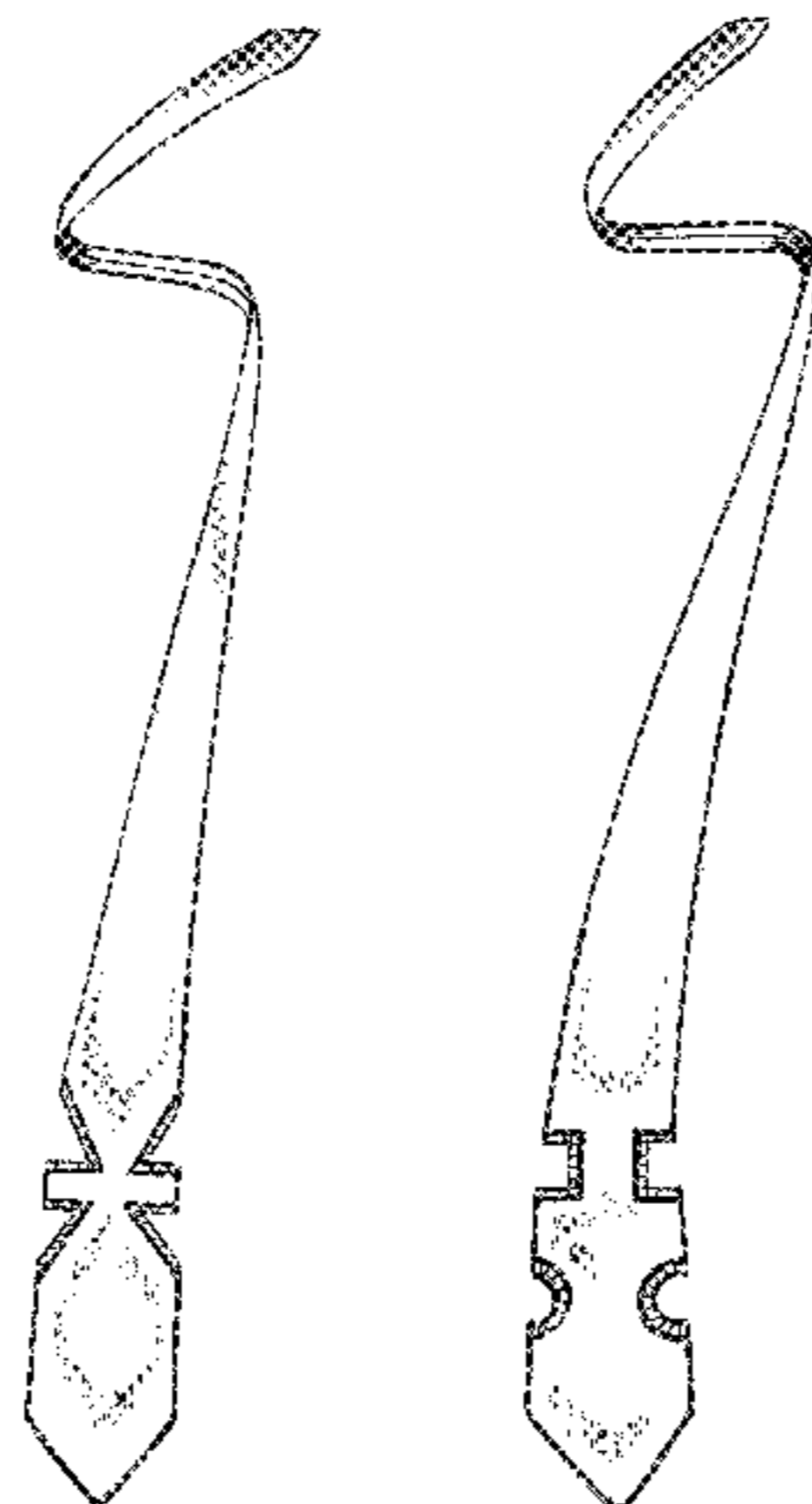
The ornamental design for a necktie, as shown and described.

DESCRIPTION

FIG. 28 is a view of the tie when worn with a coat thereof.
The ties have cut-out shapes, yet still maintain the sense of formality attached to ties as a mode of dressing. These ties can be worn by both men and women.
The broken lines shown in the drawings illustrate environmental matter included in order to show how the design may appear when worn and form no part of the claimed design.

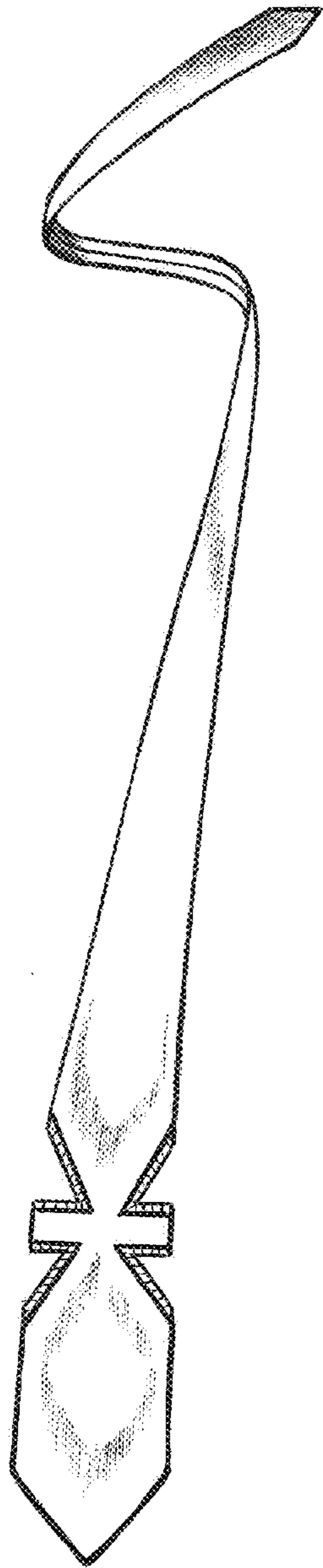

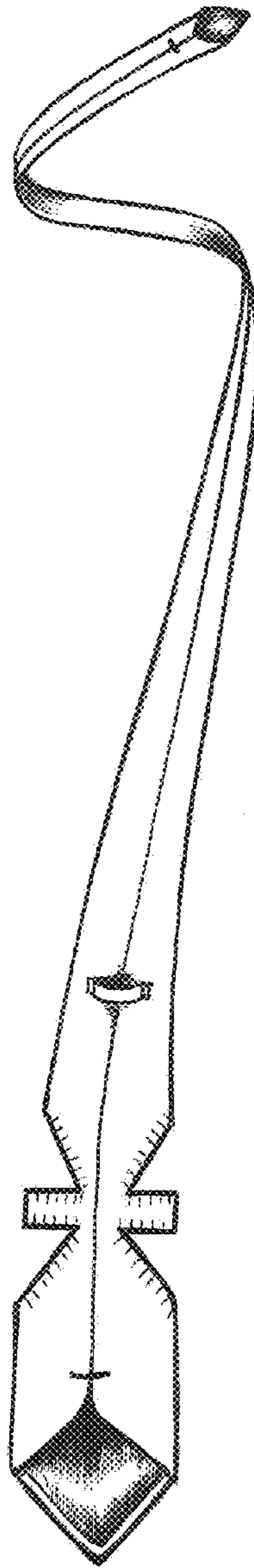

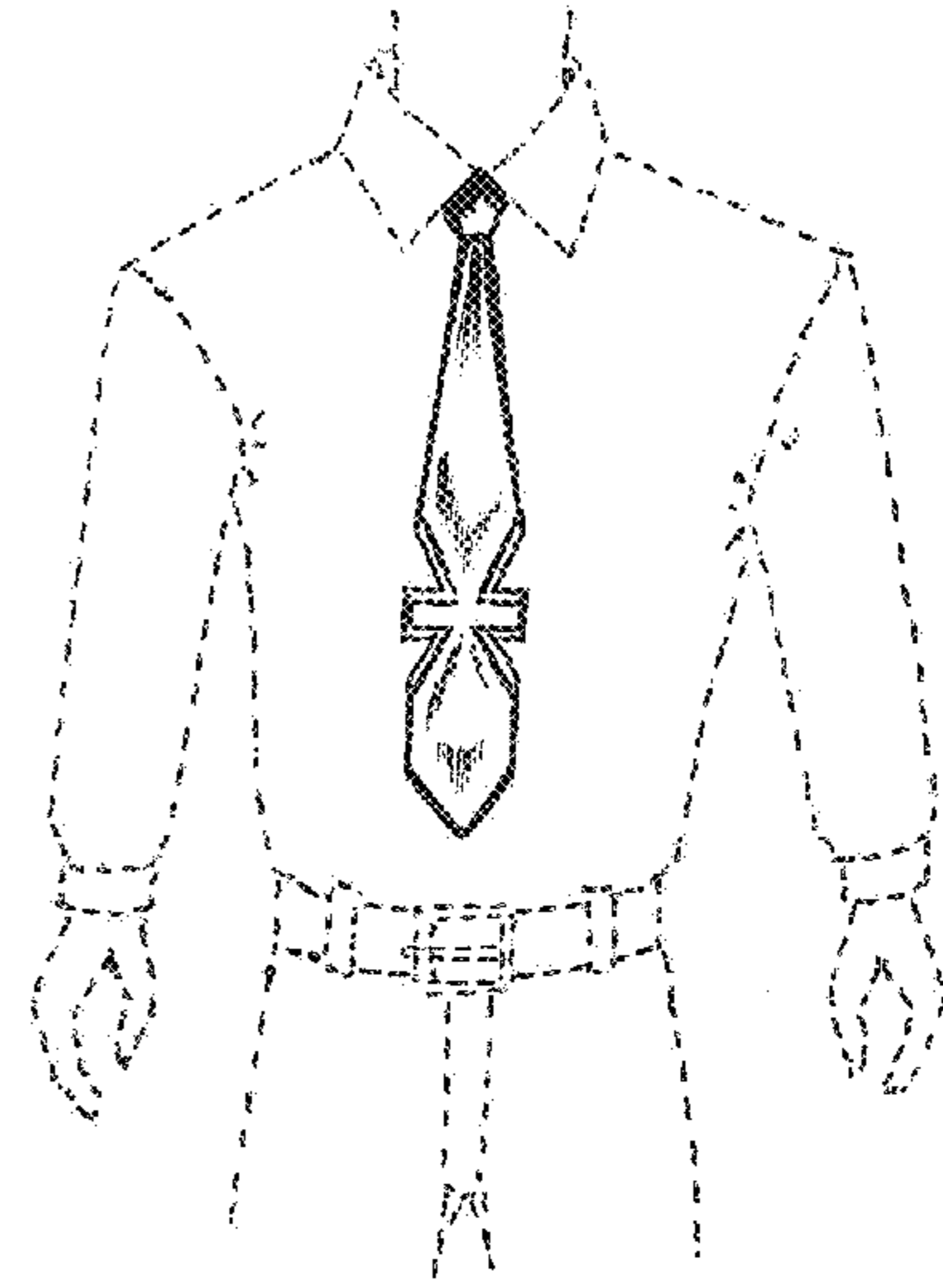

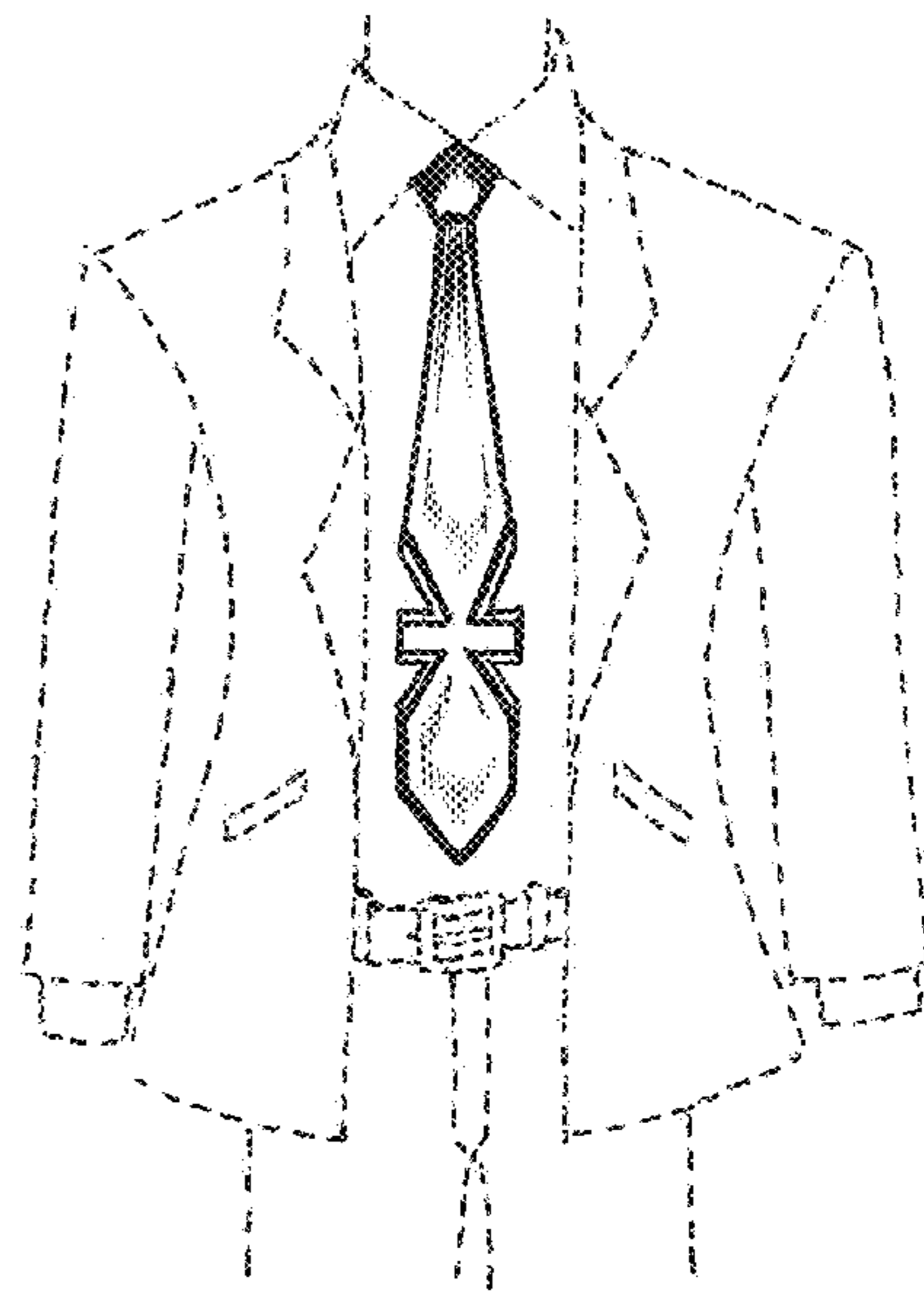

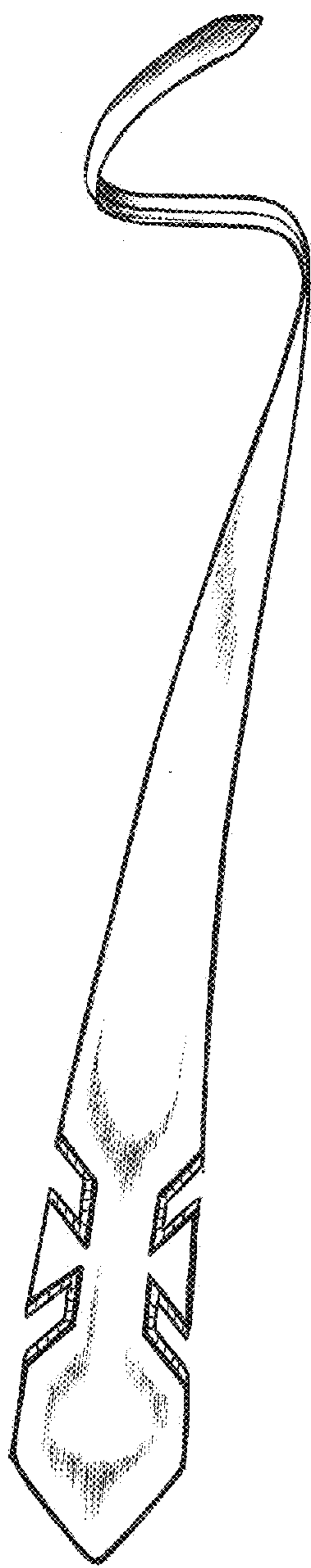

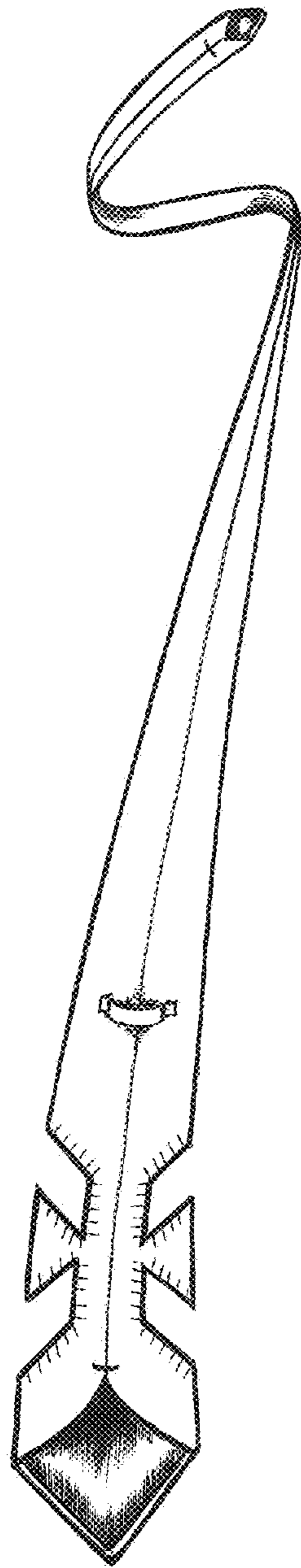

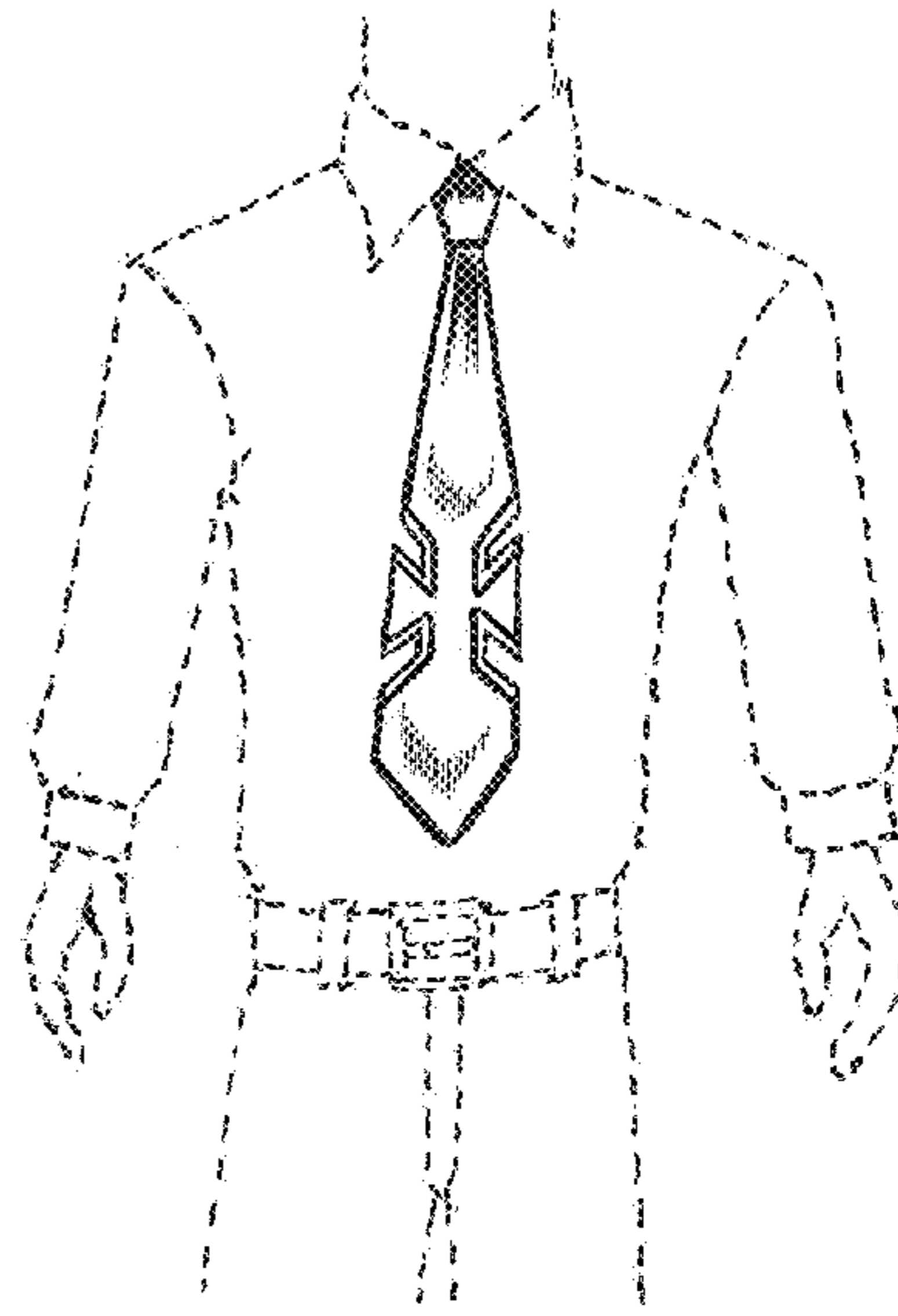

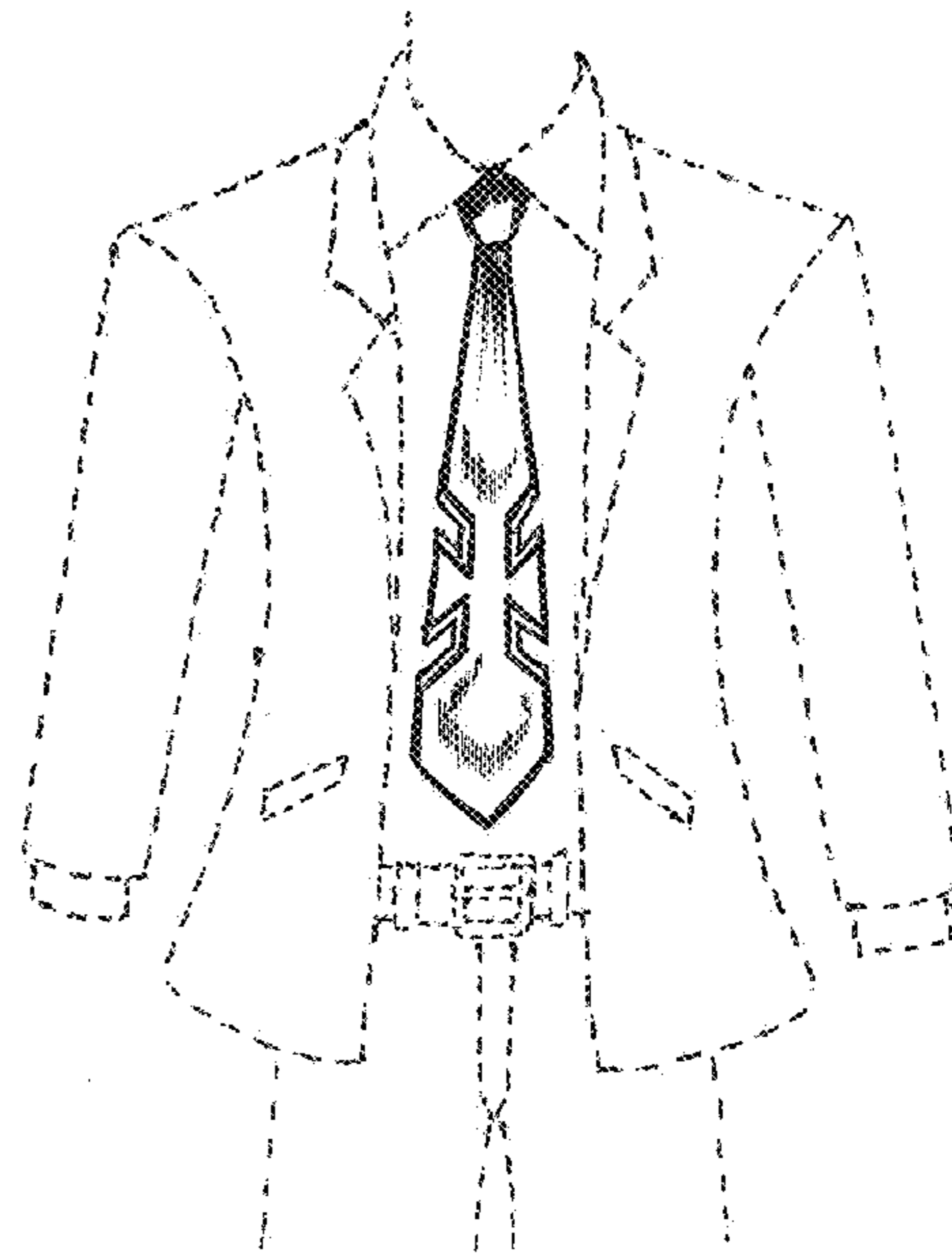

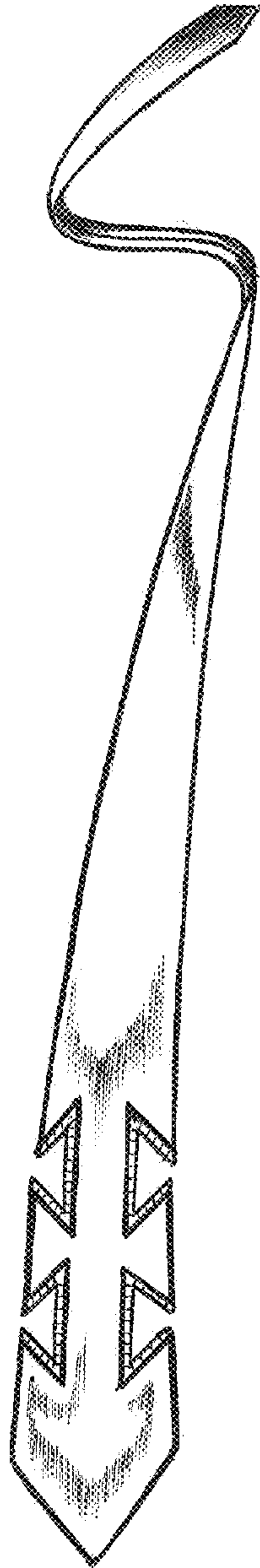

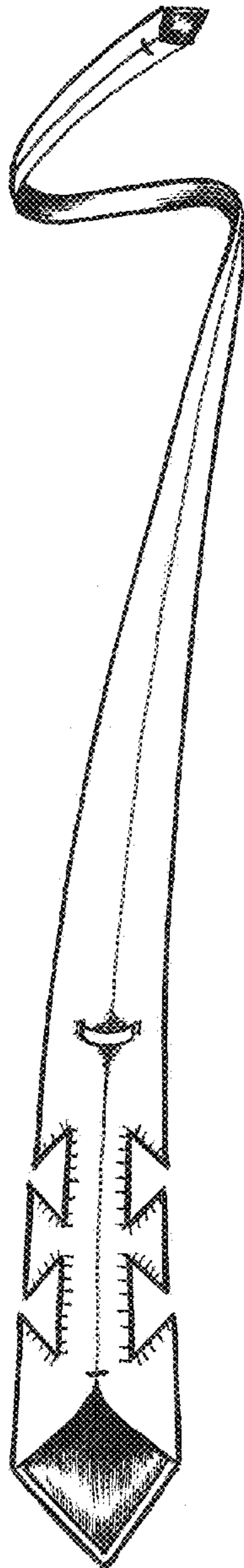

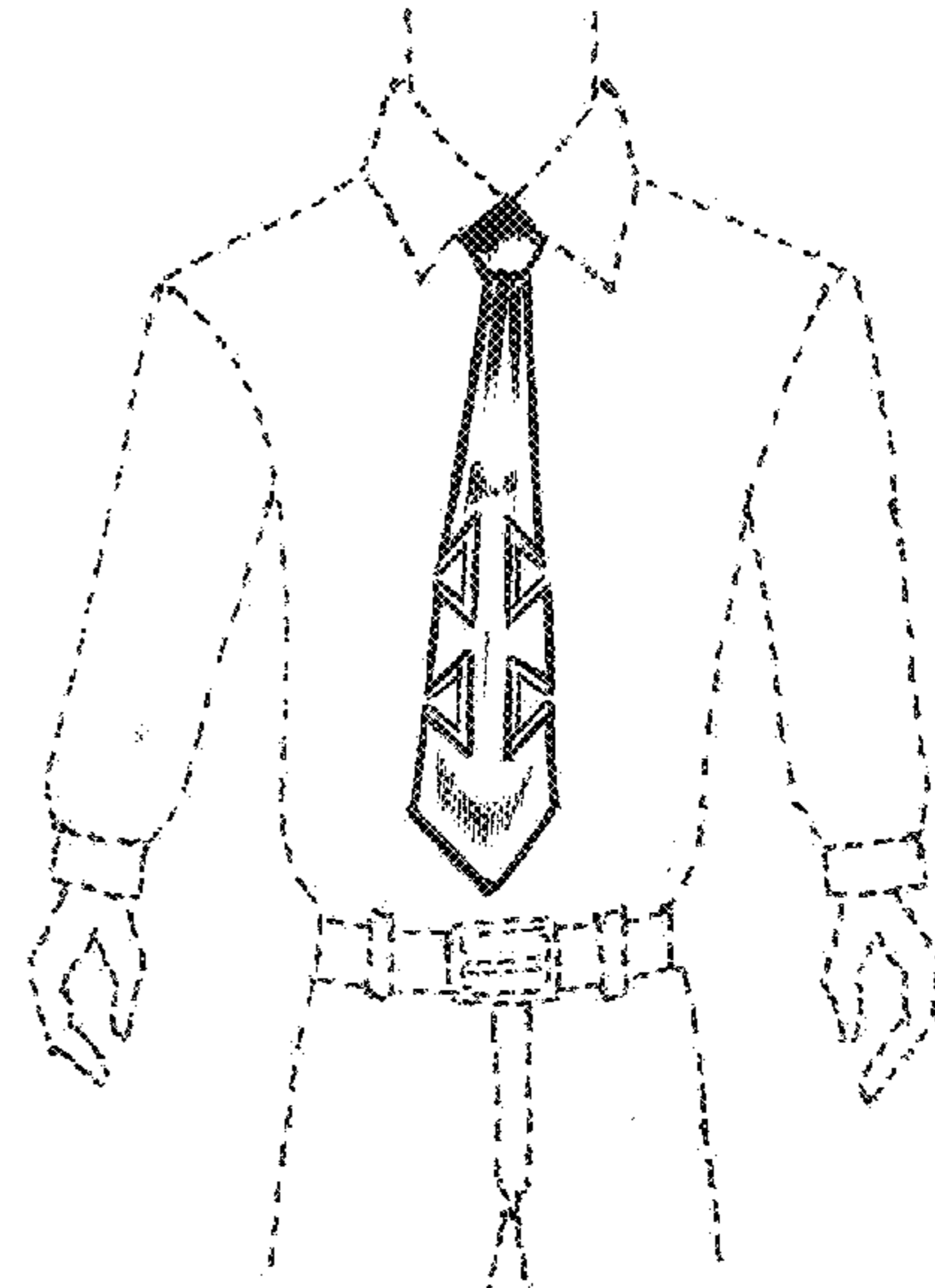

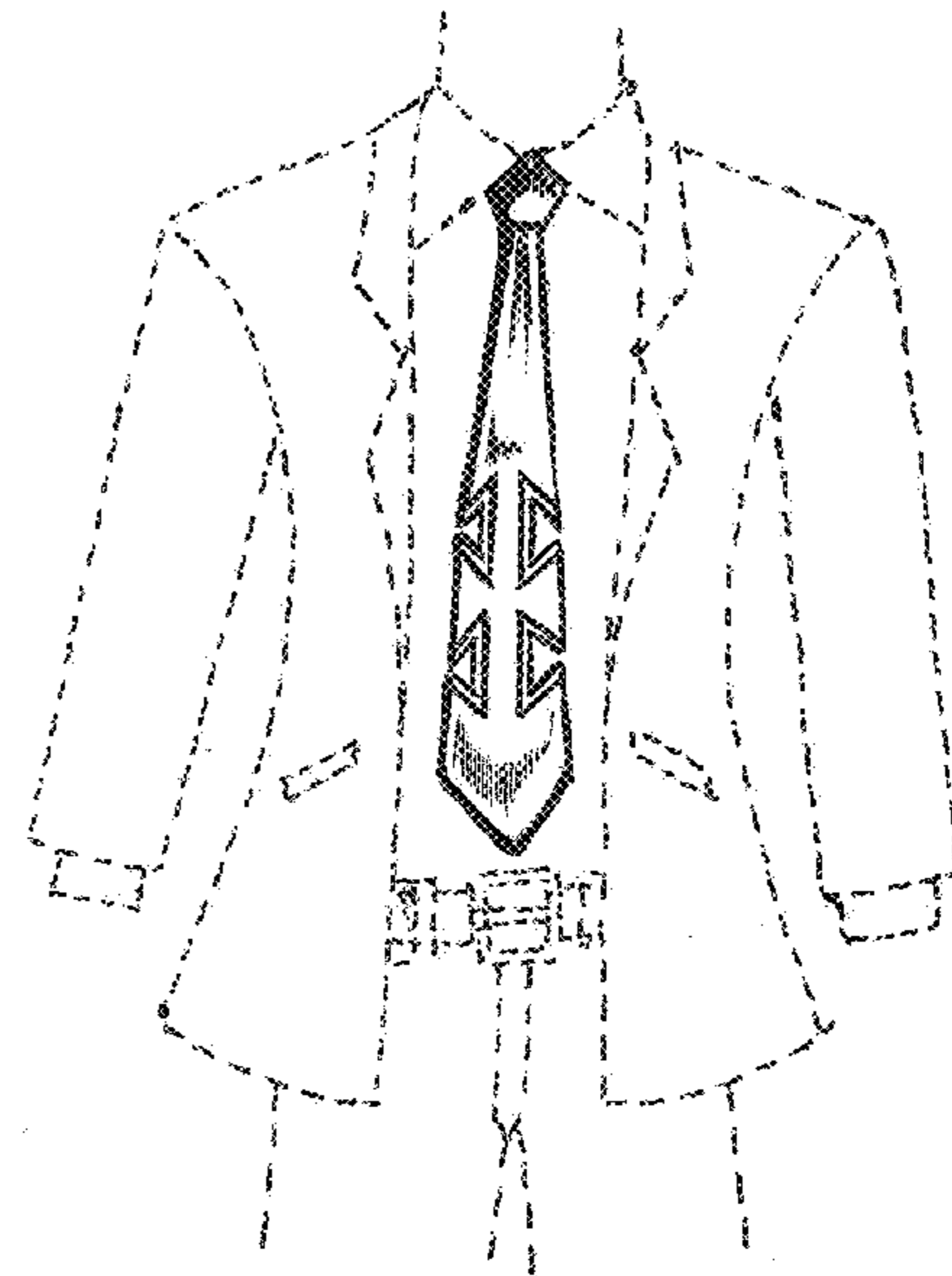

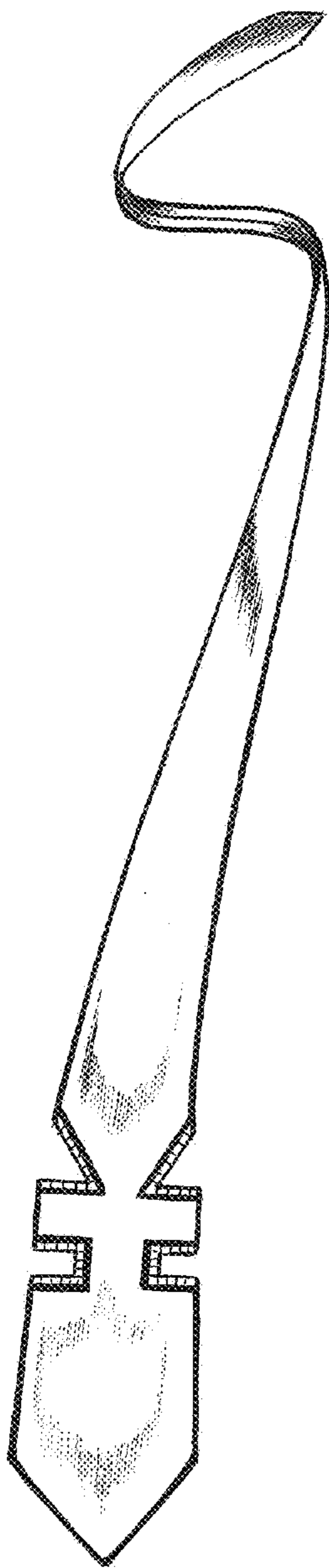

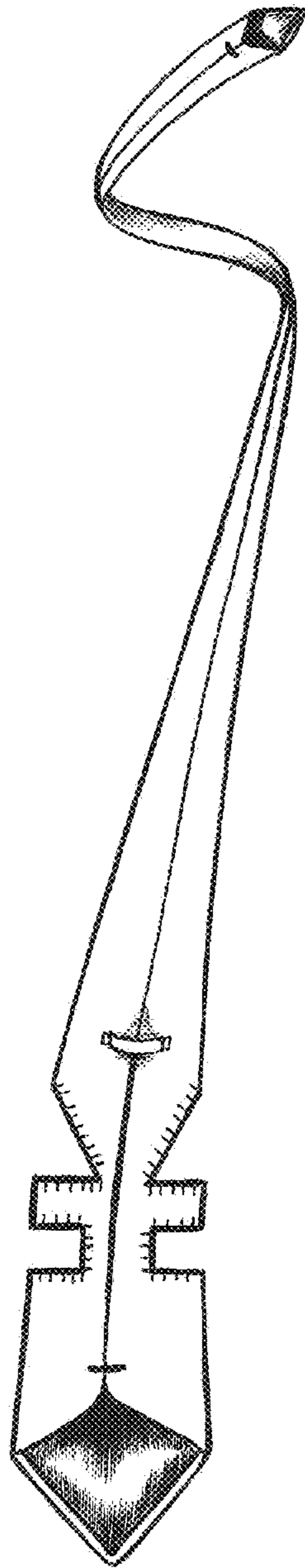

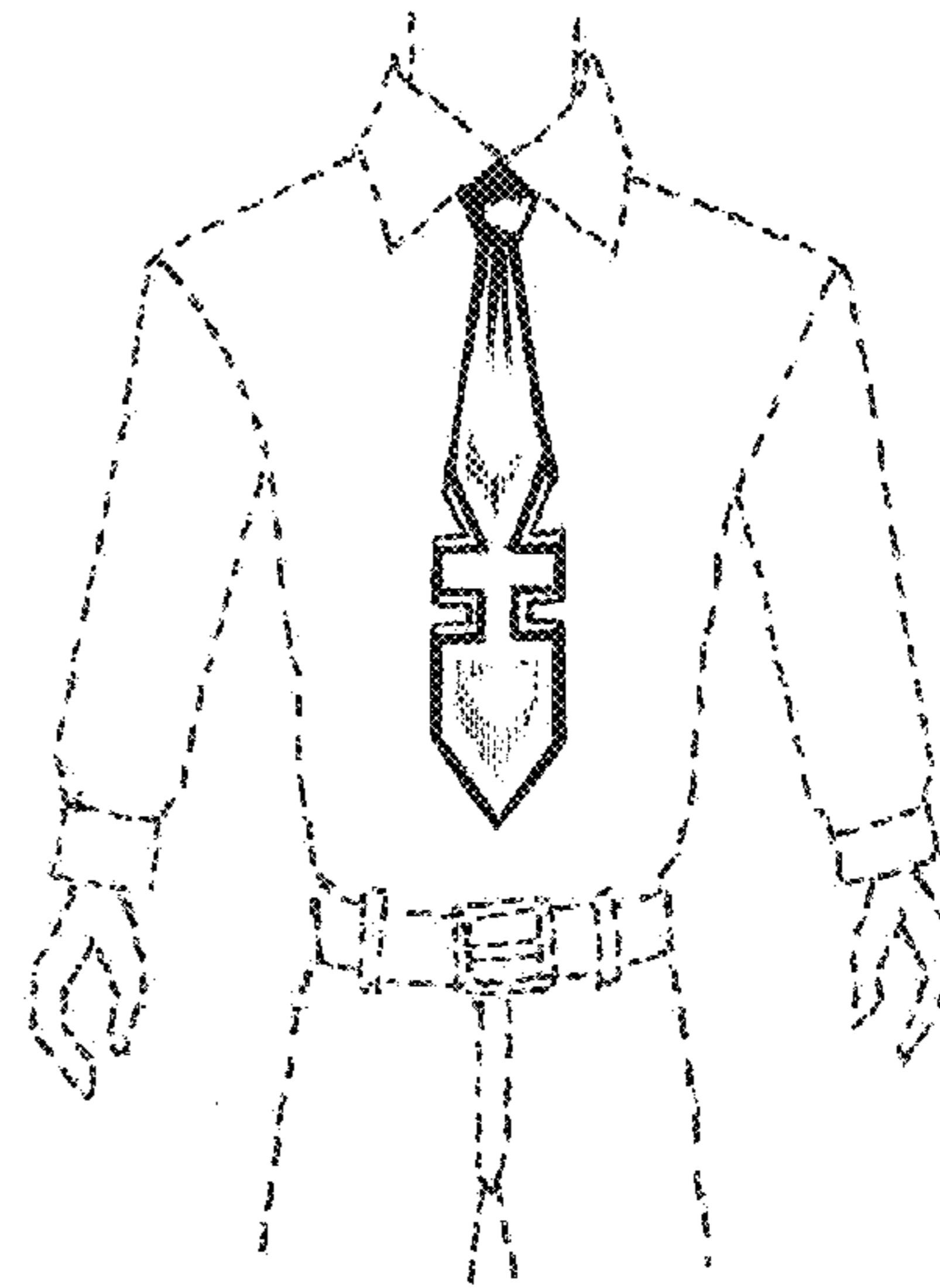

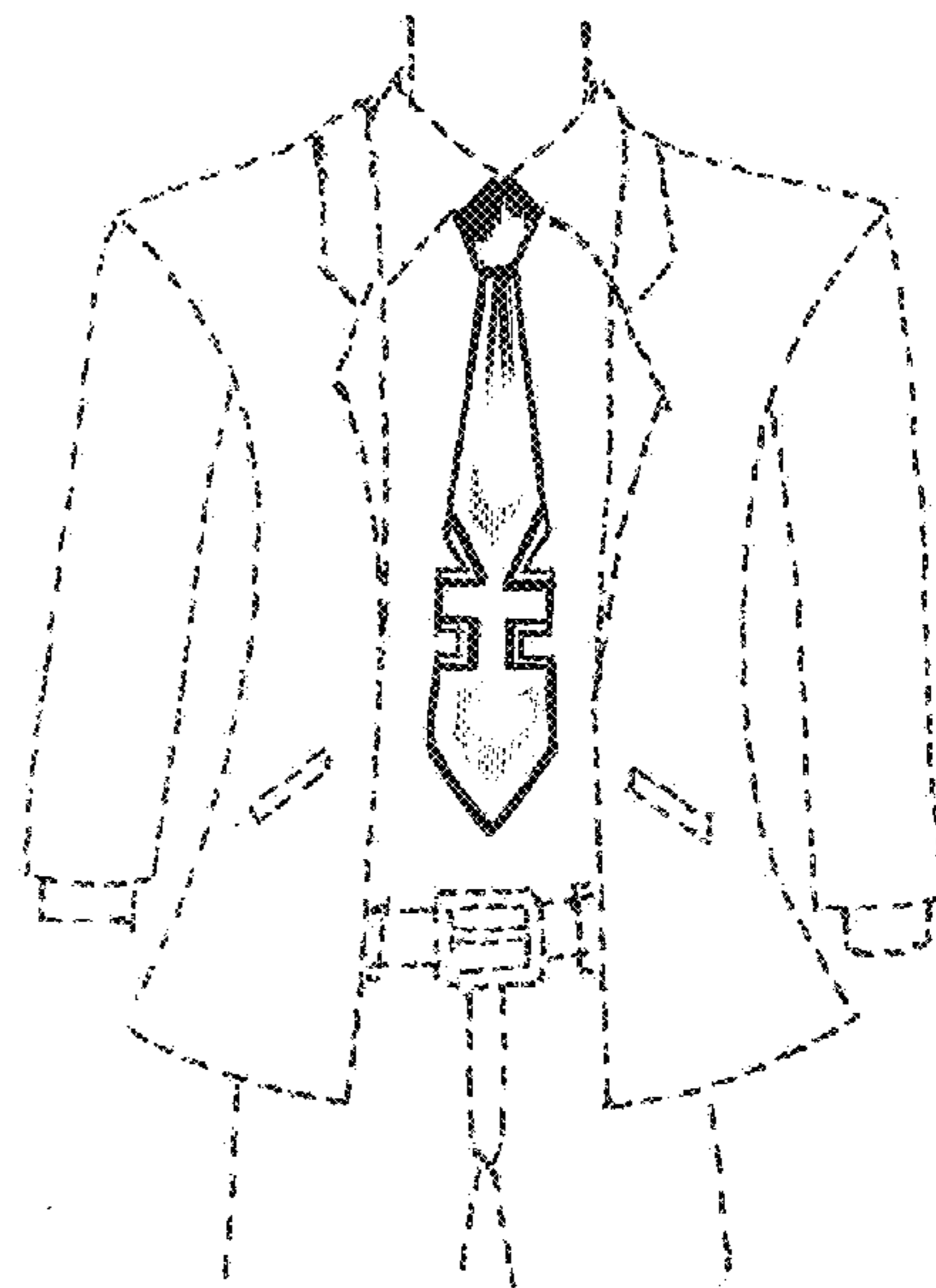

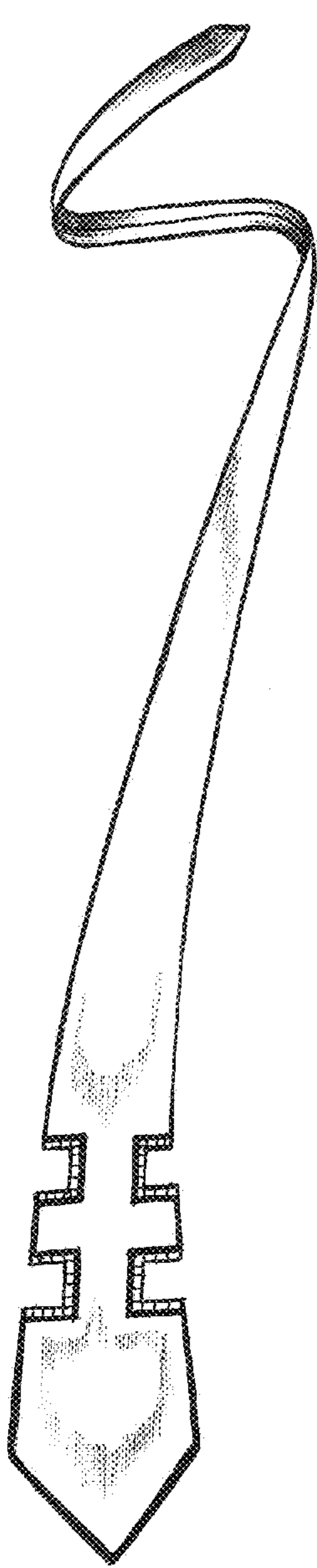

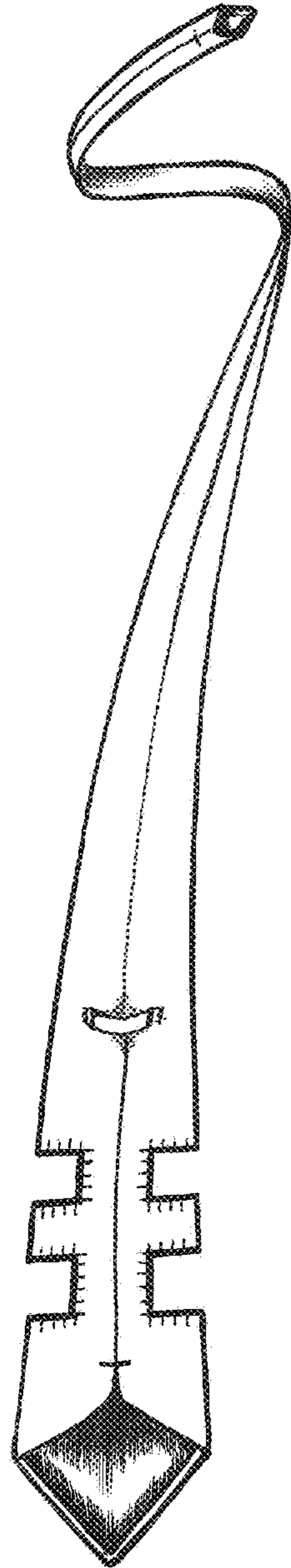

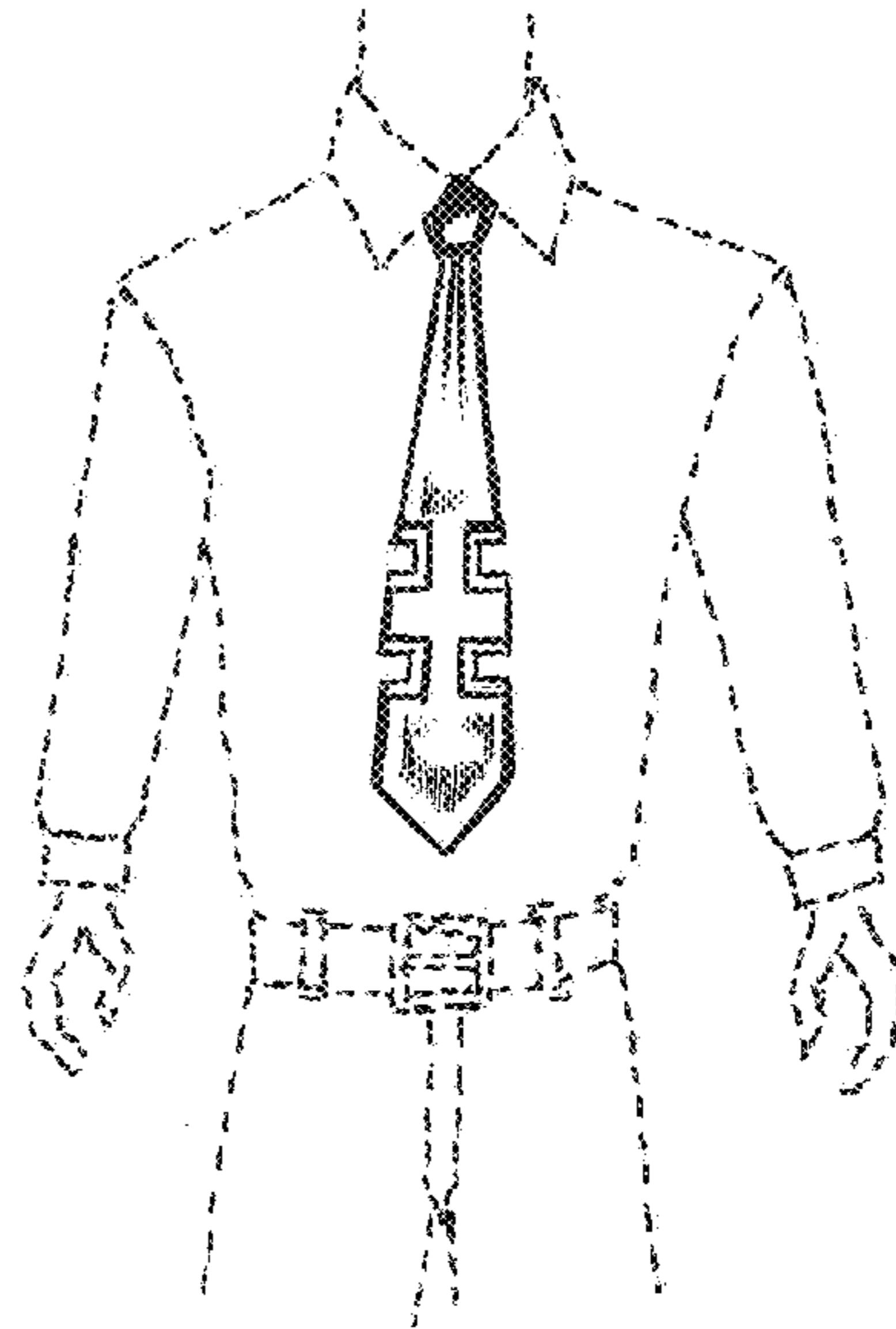

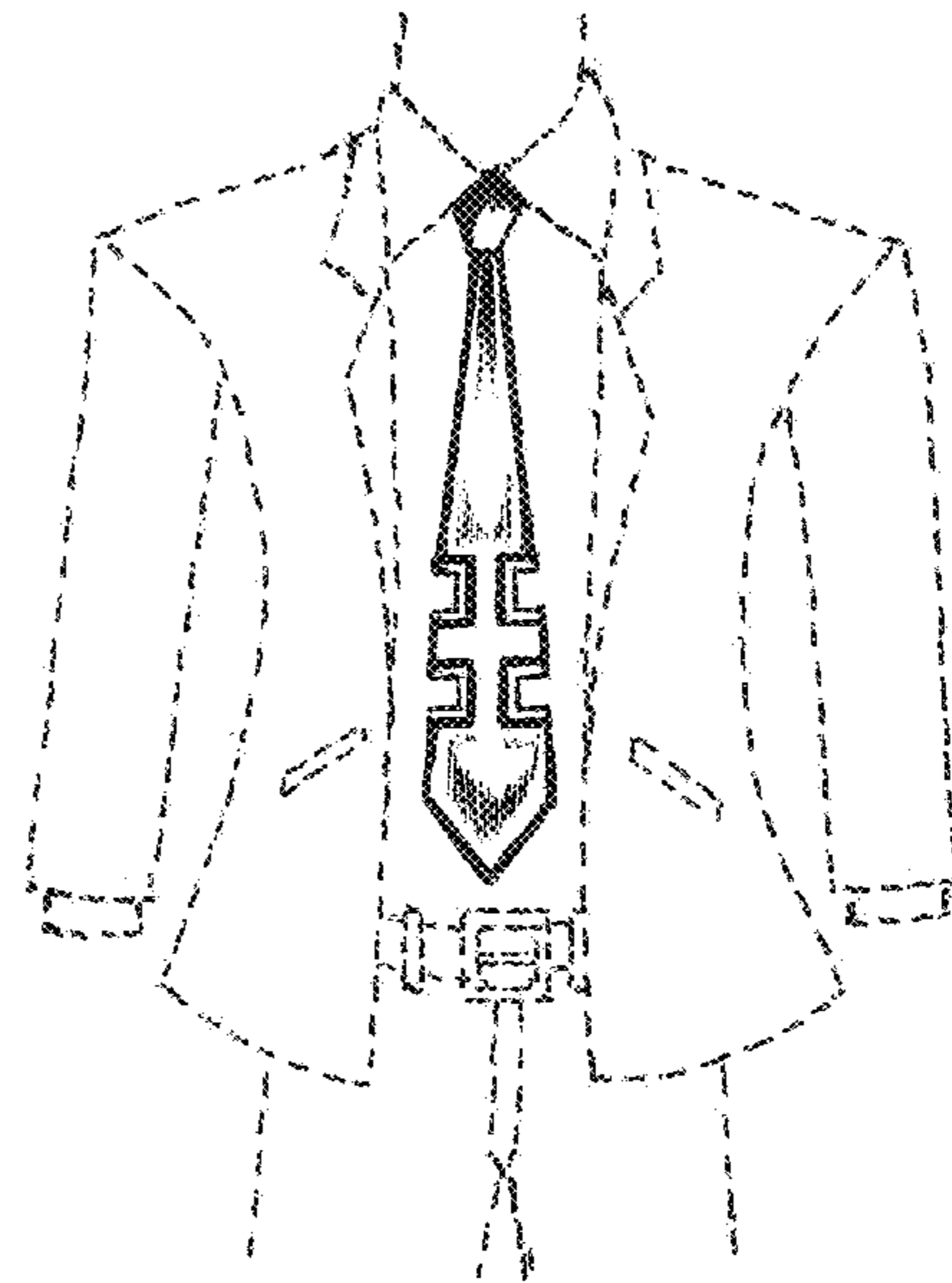

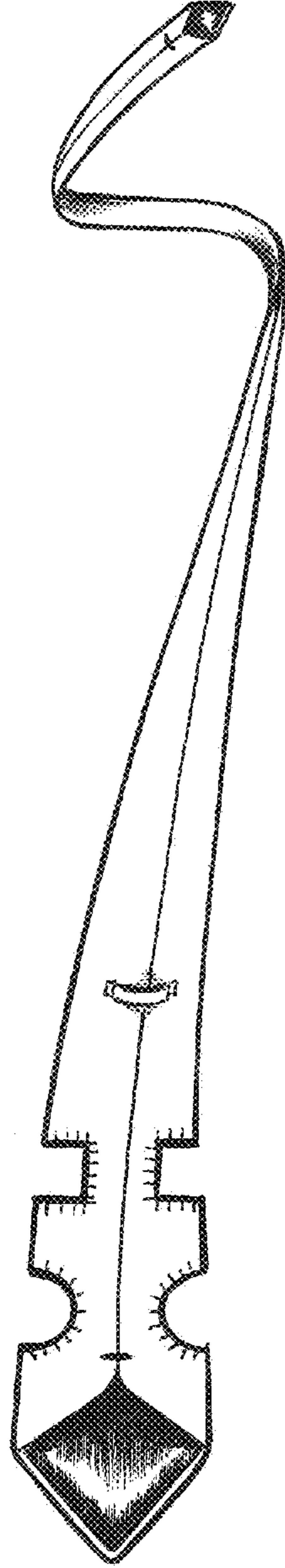

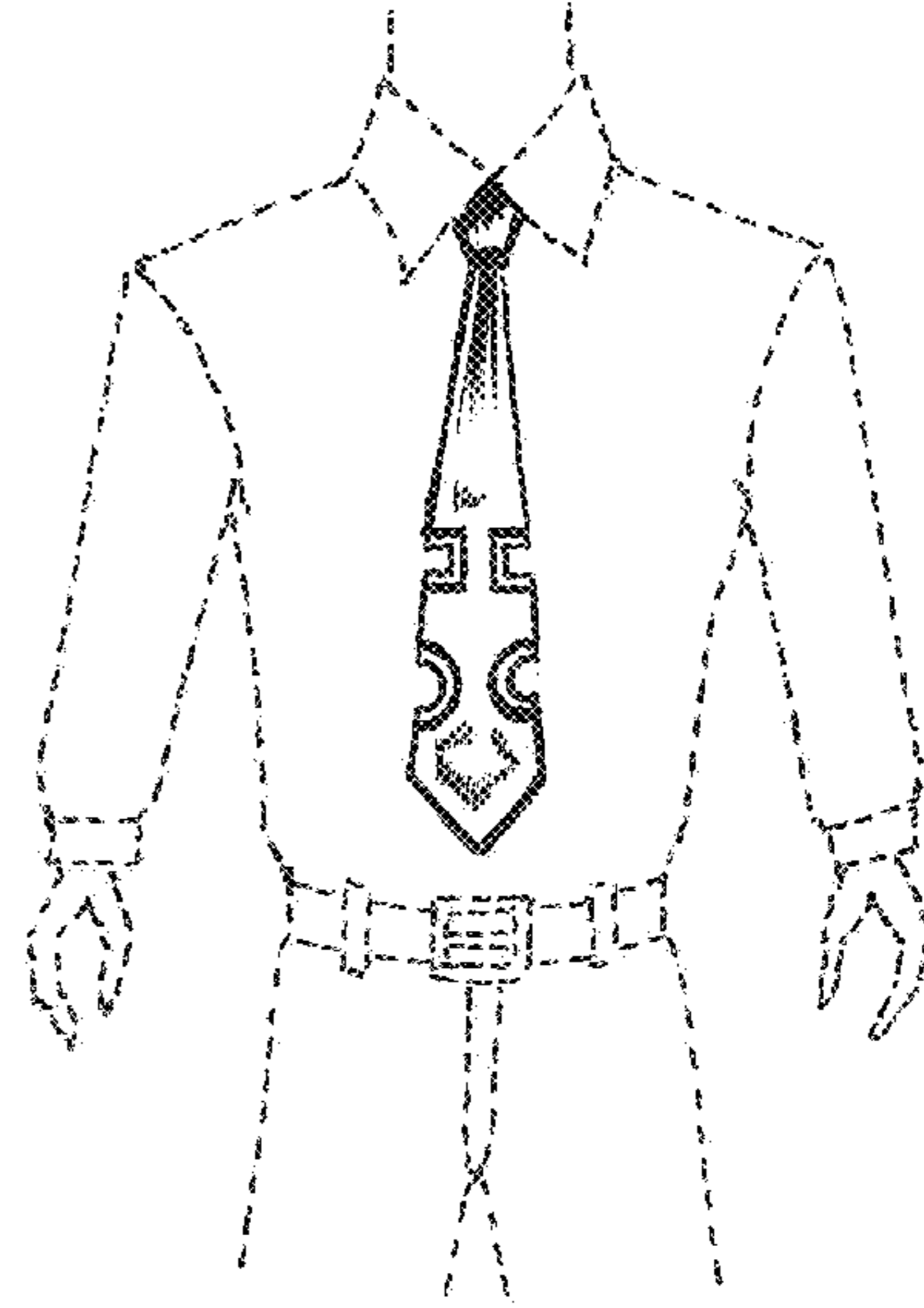

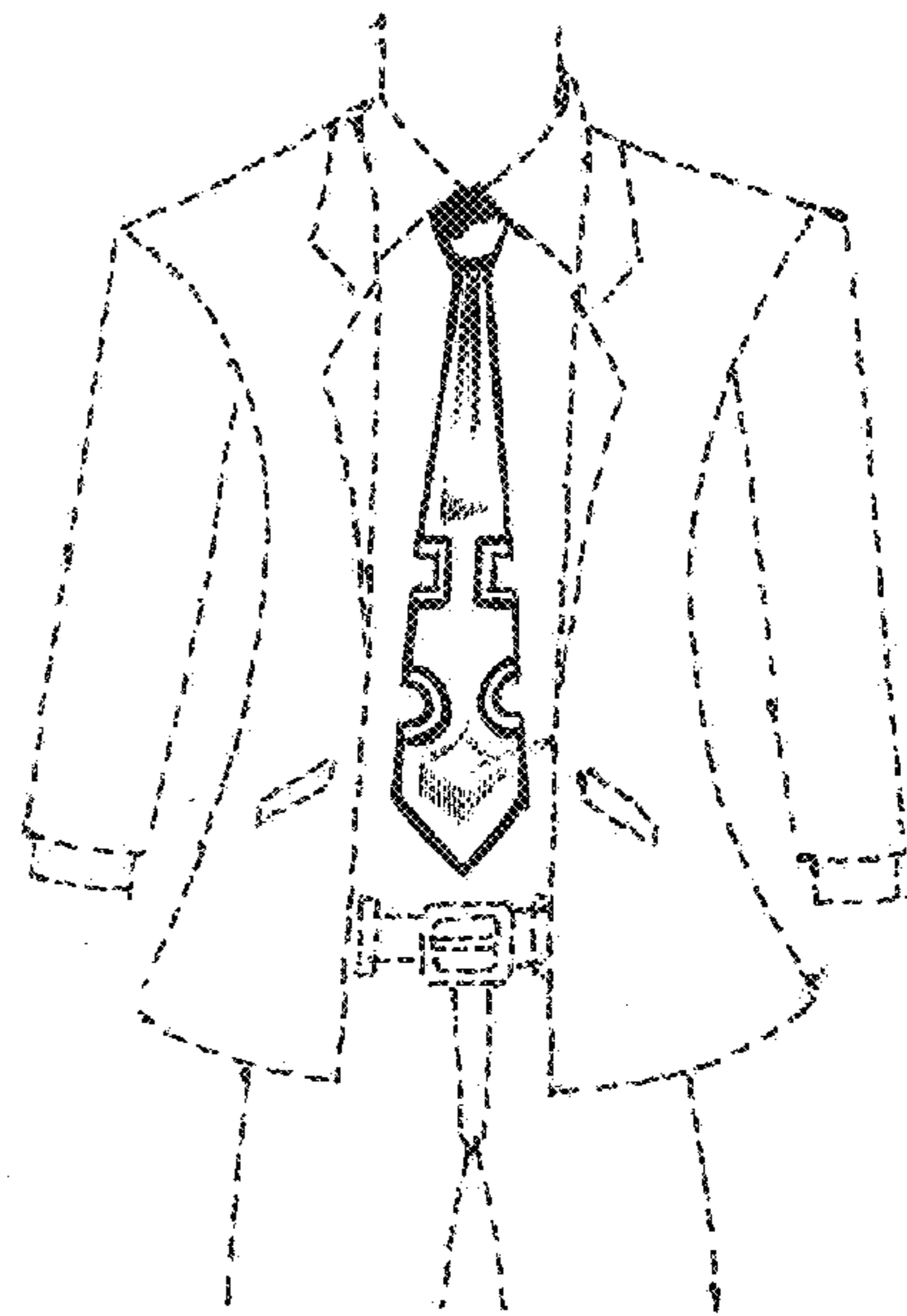

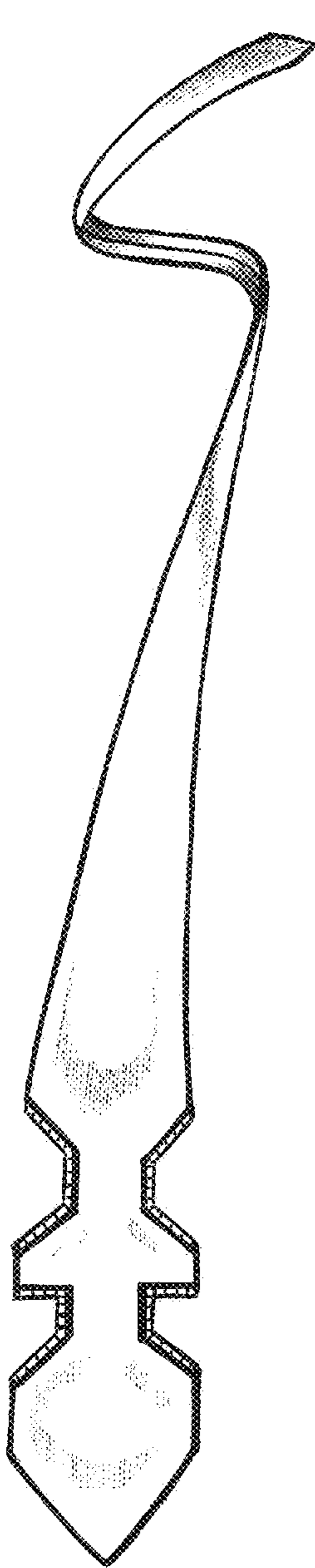

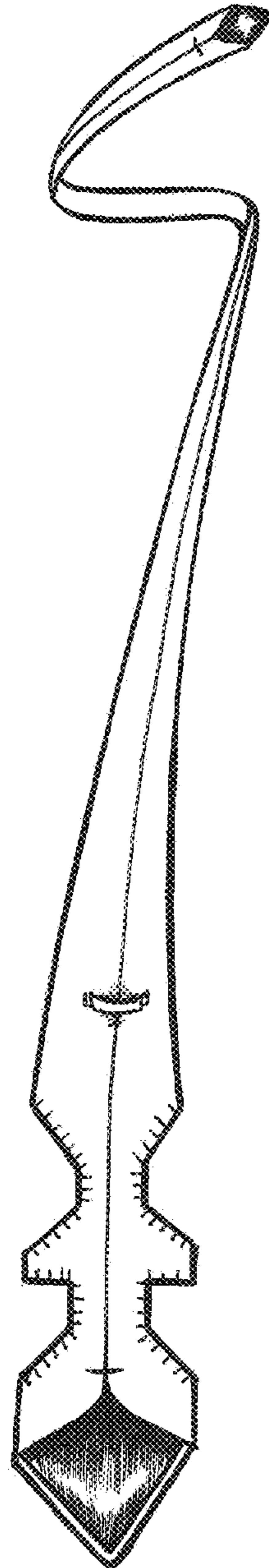

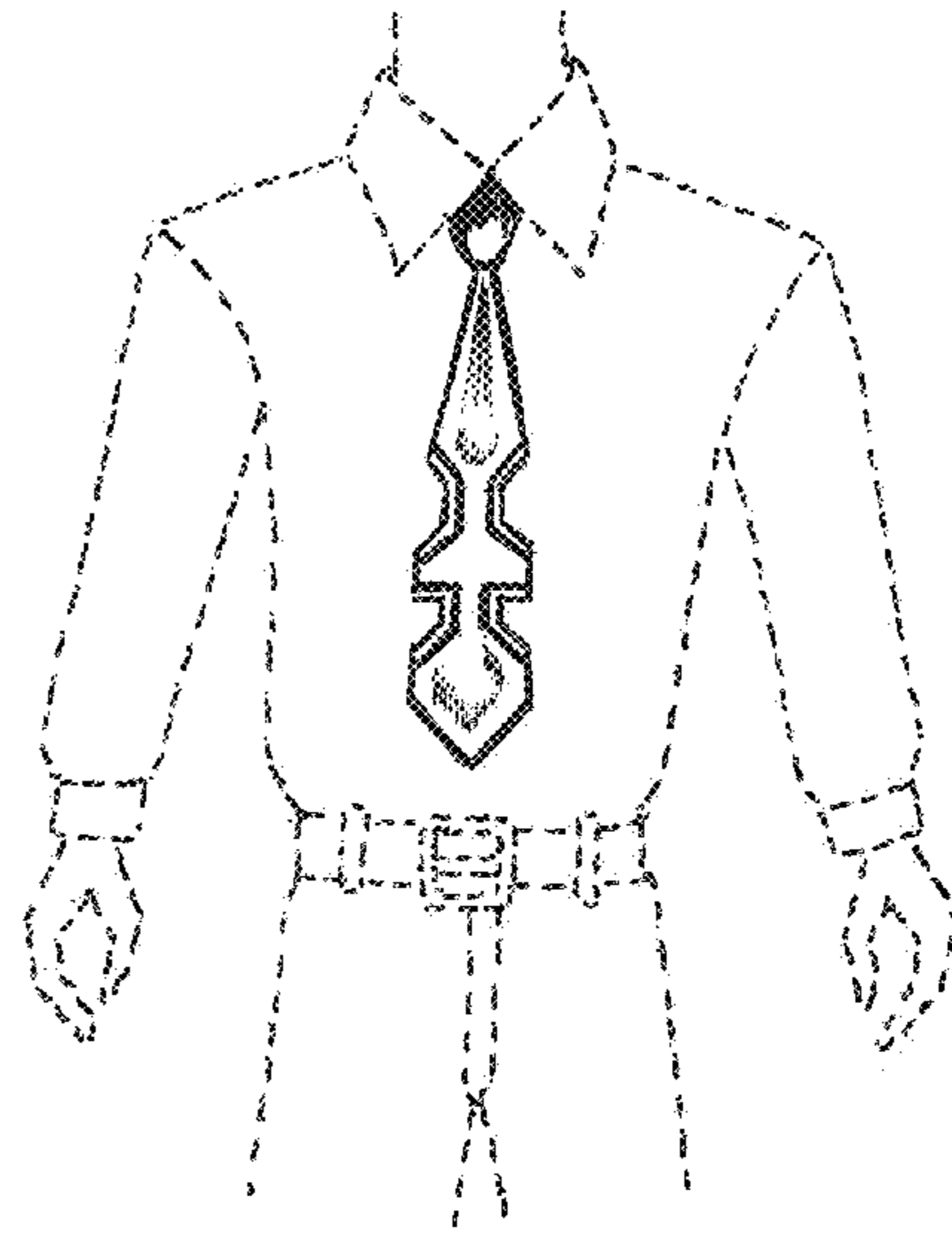

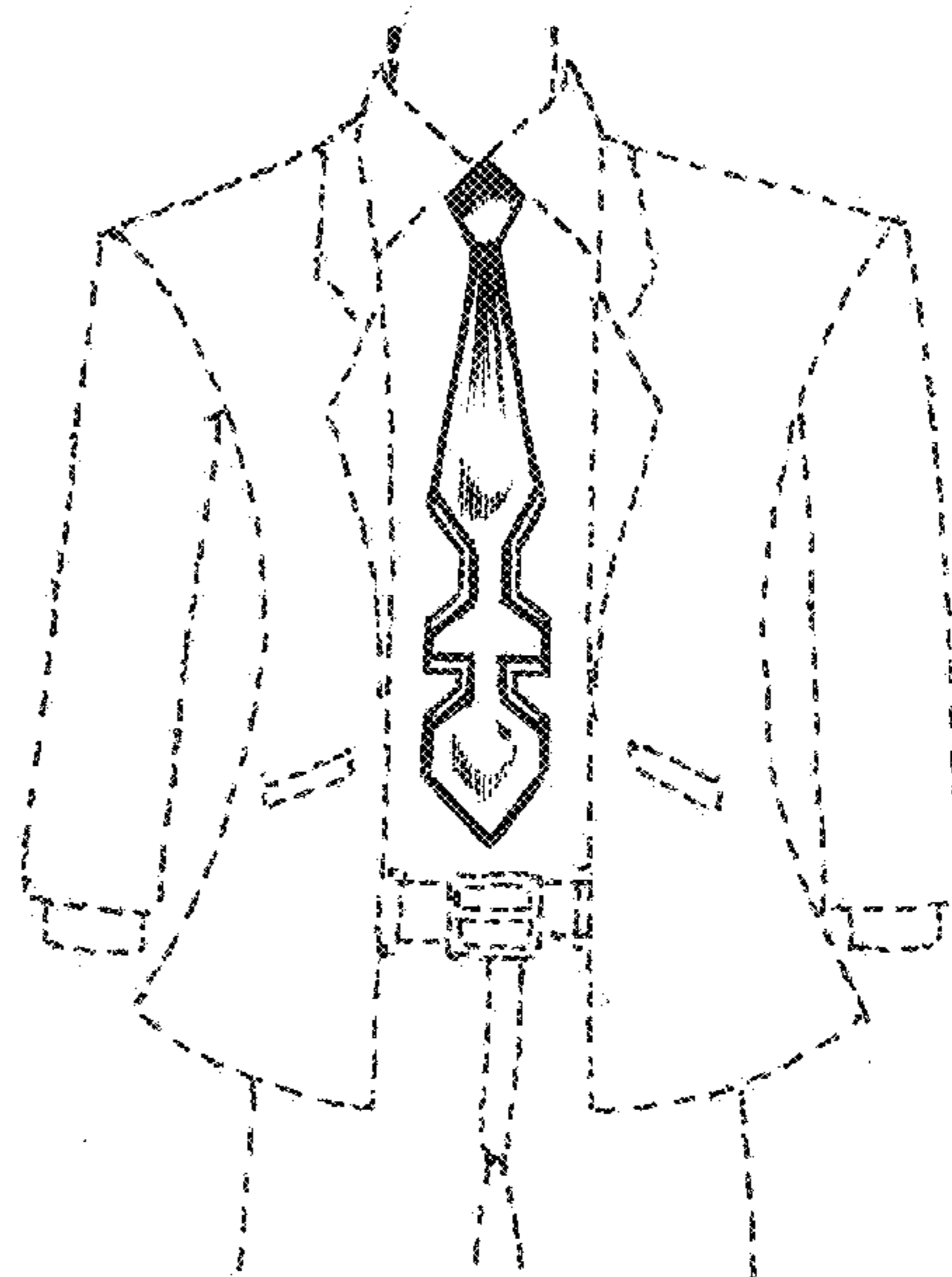
