The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of one side of a shoe outsole showing my new design;

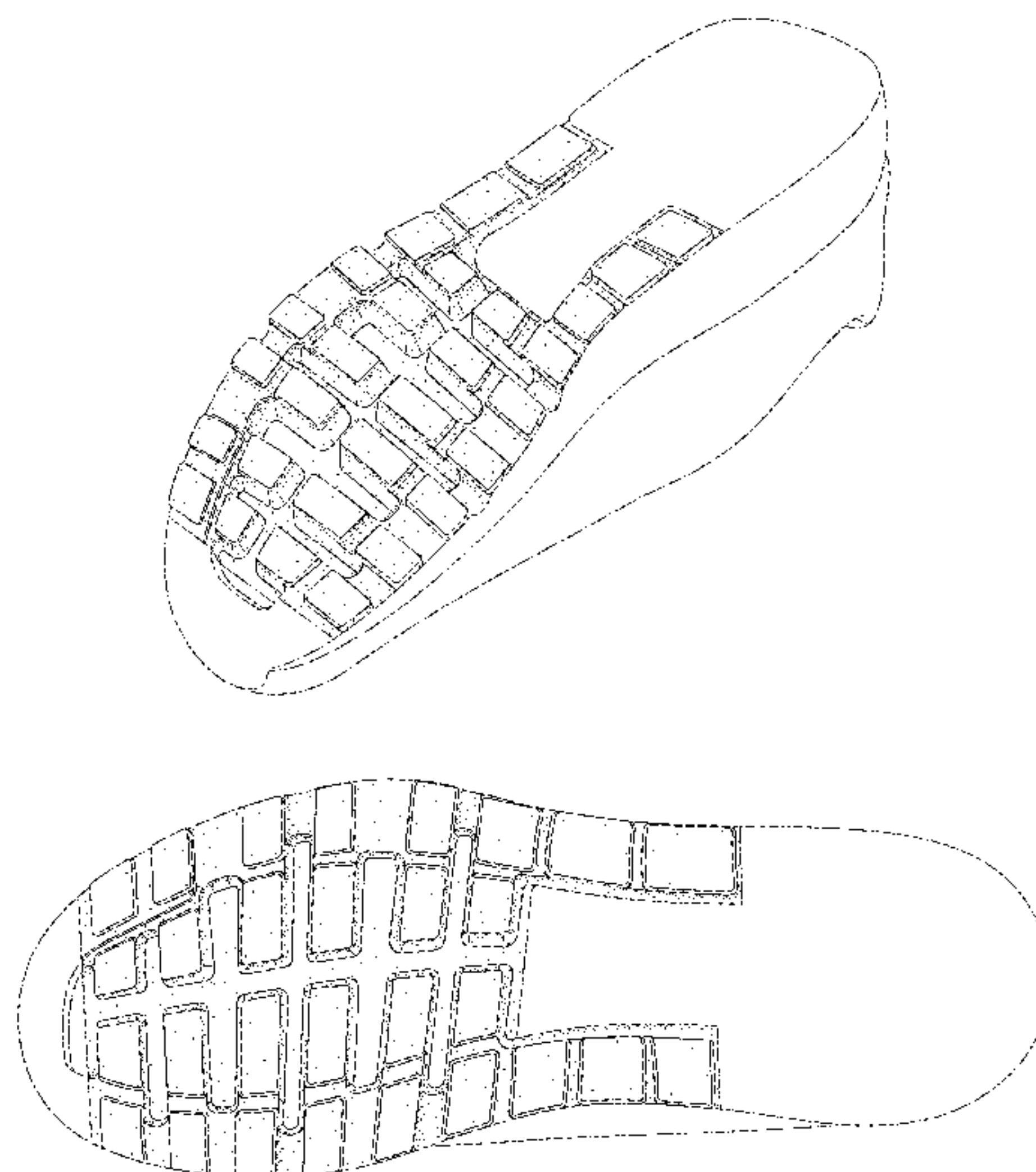
FIG. 2 is a top view thereof;

FIG. 3 is a rear perspective view thereof; and,

FIG. 4 is a front perspective view of the other side thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines showing the remainder of the shoe and shoe sole are for environmental purposes only and form no part of the claimed design.

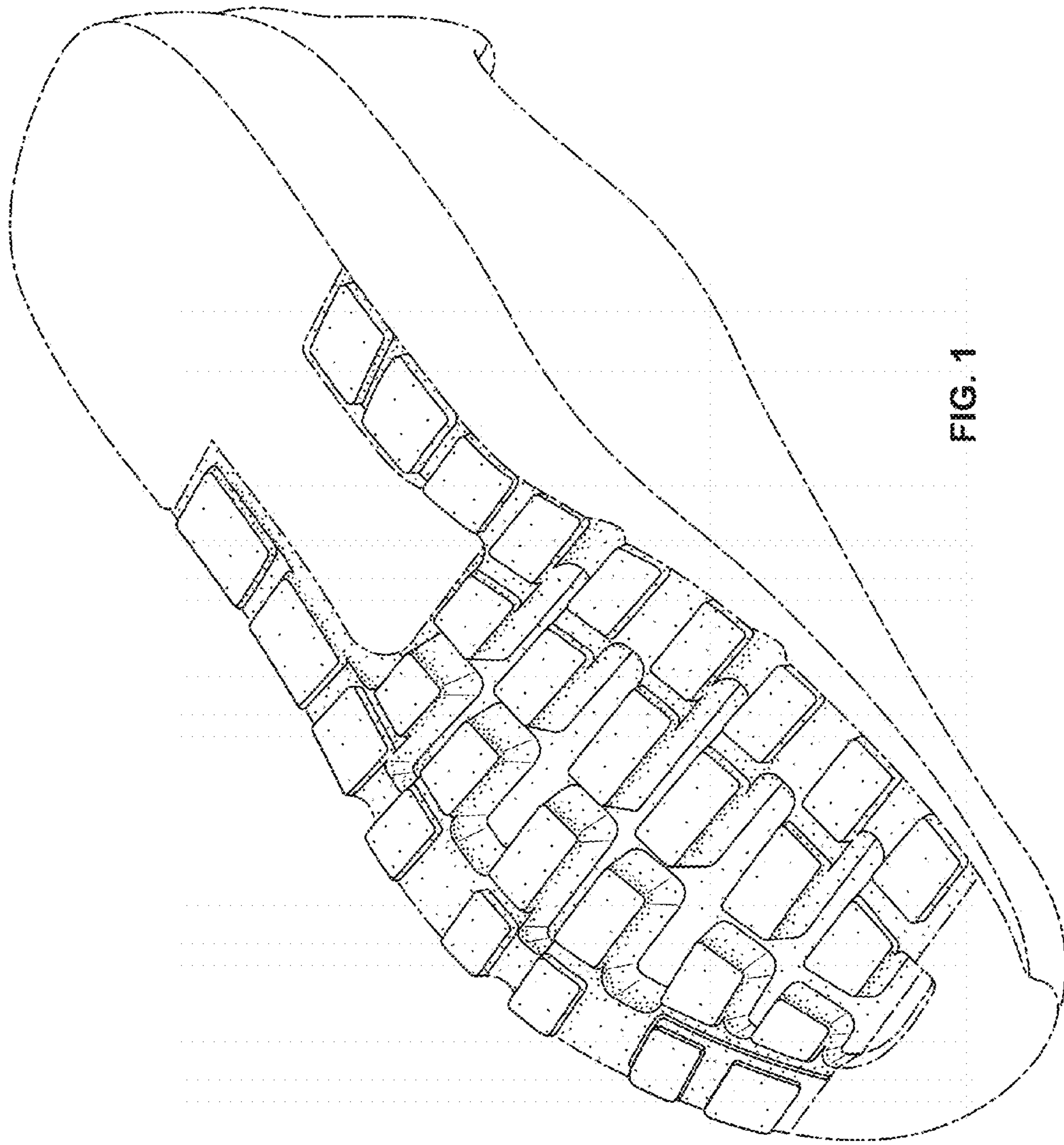

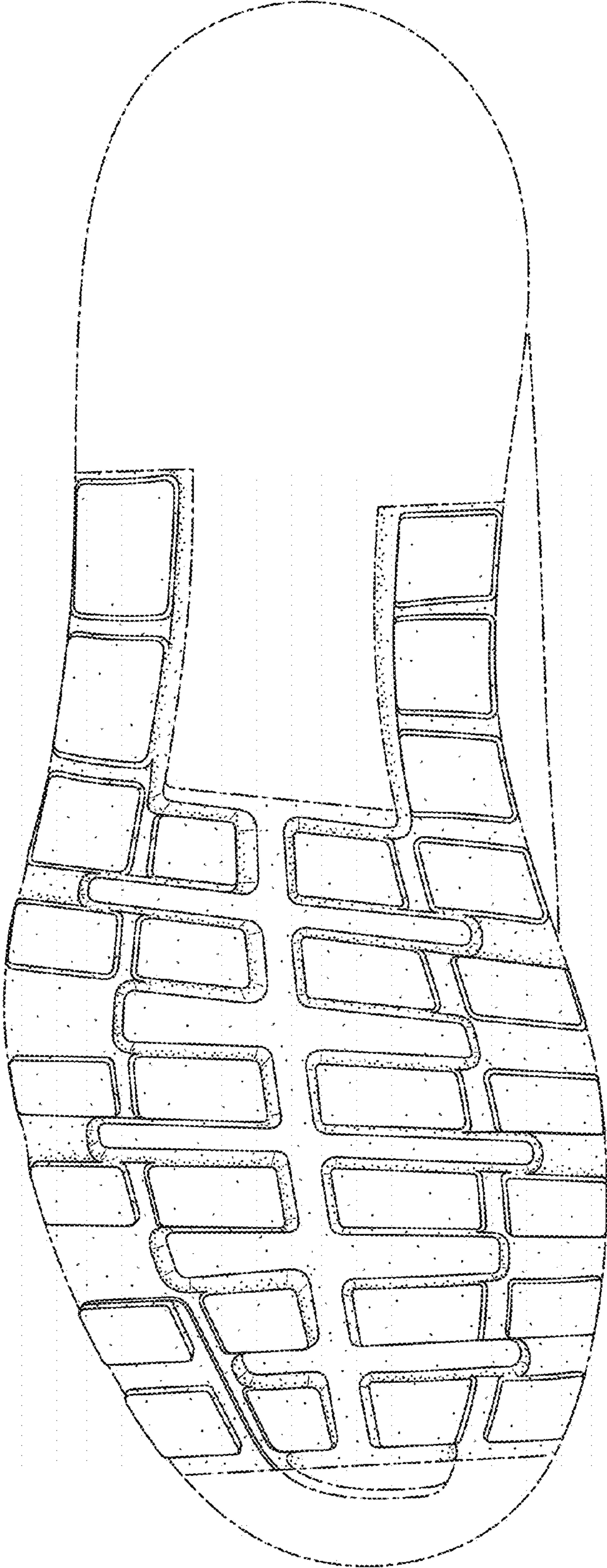

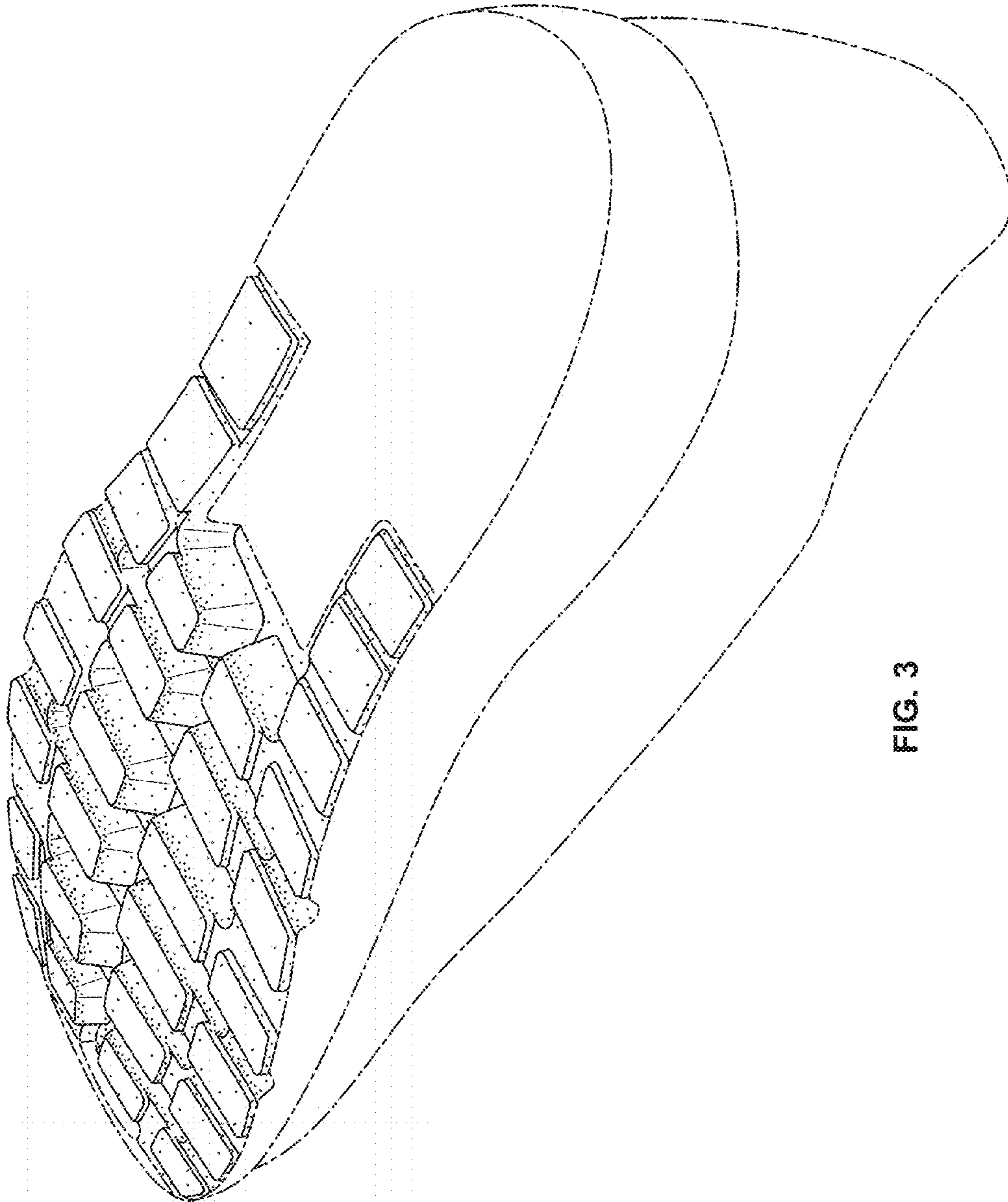

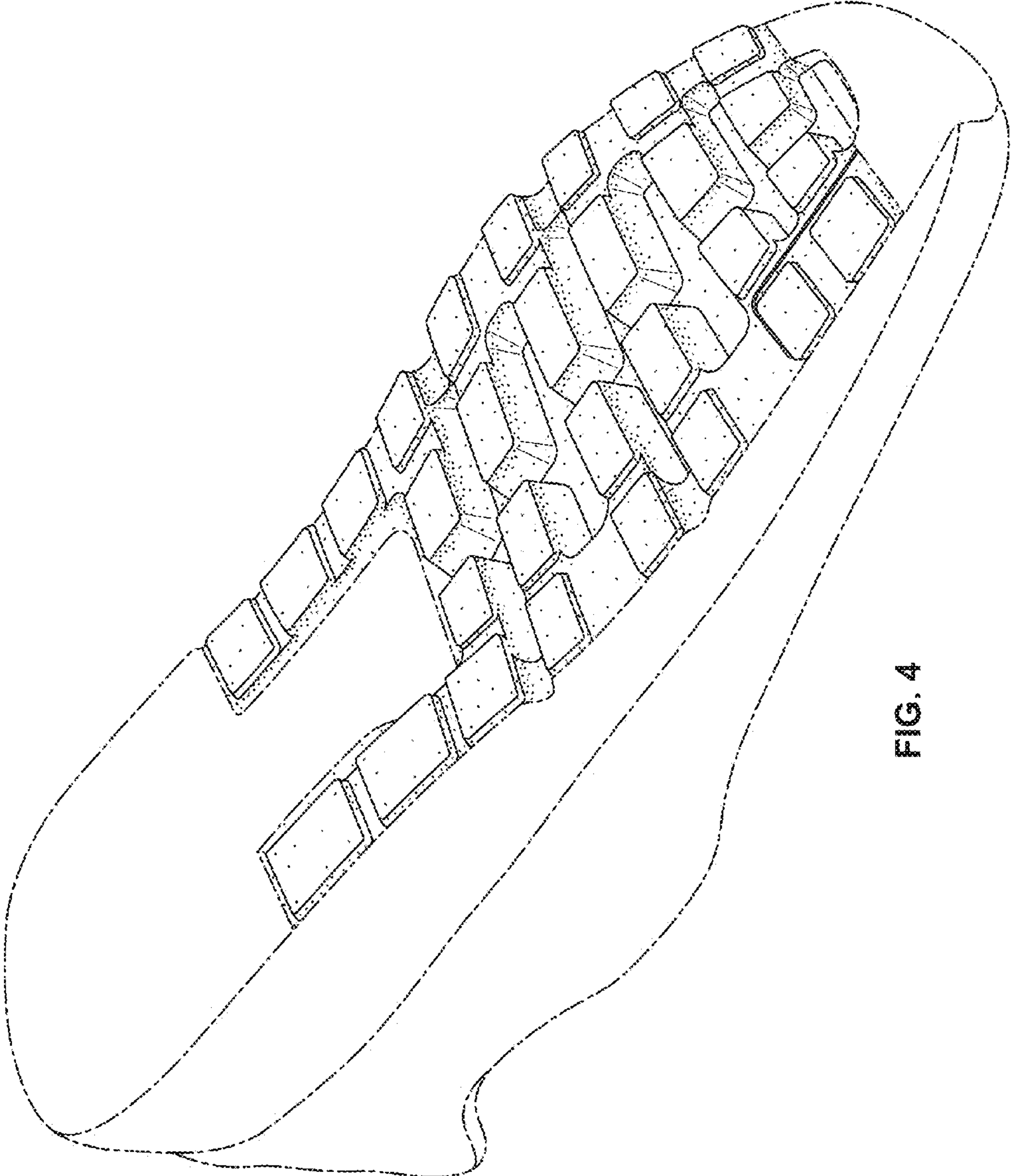
