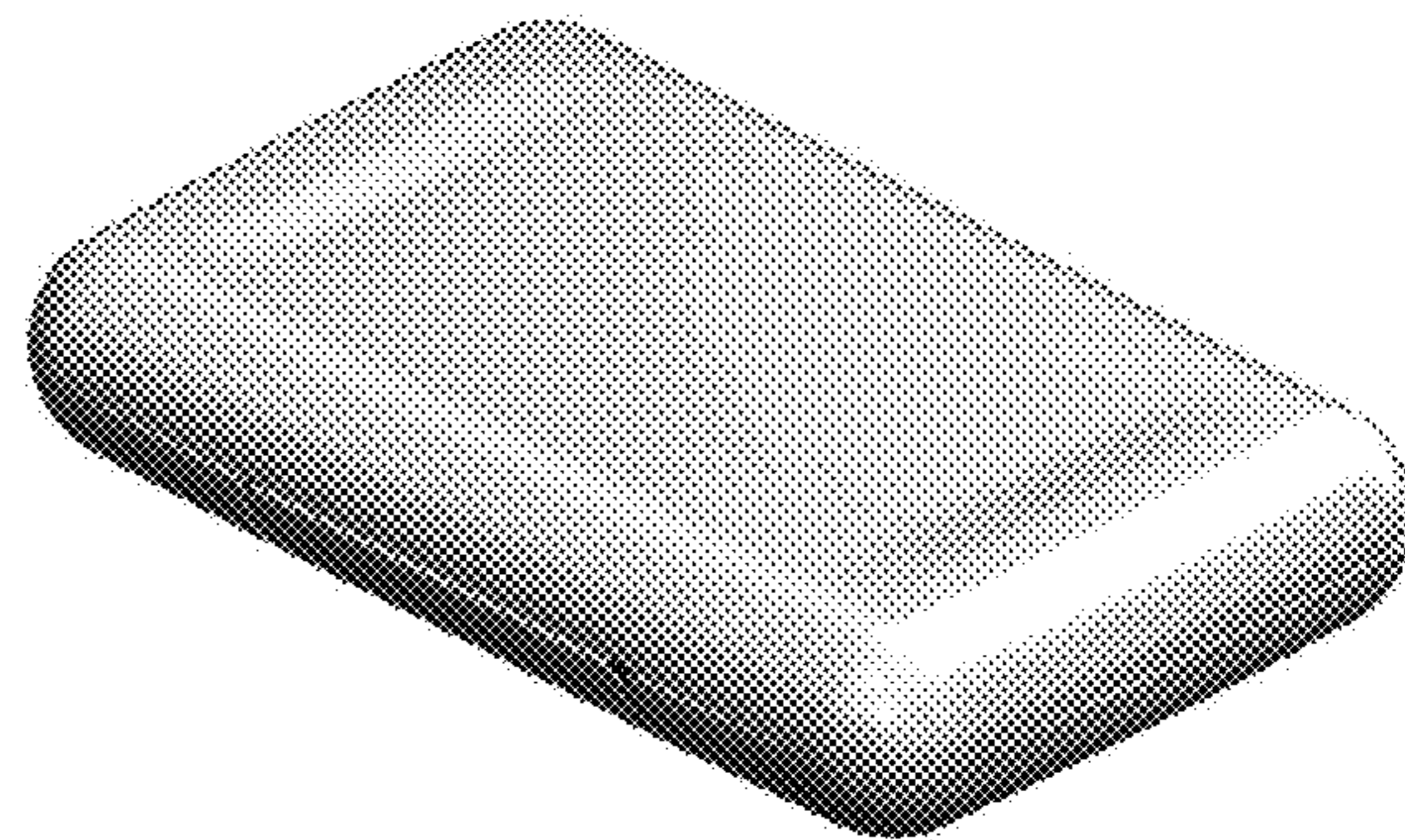
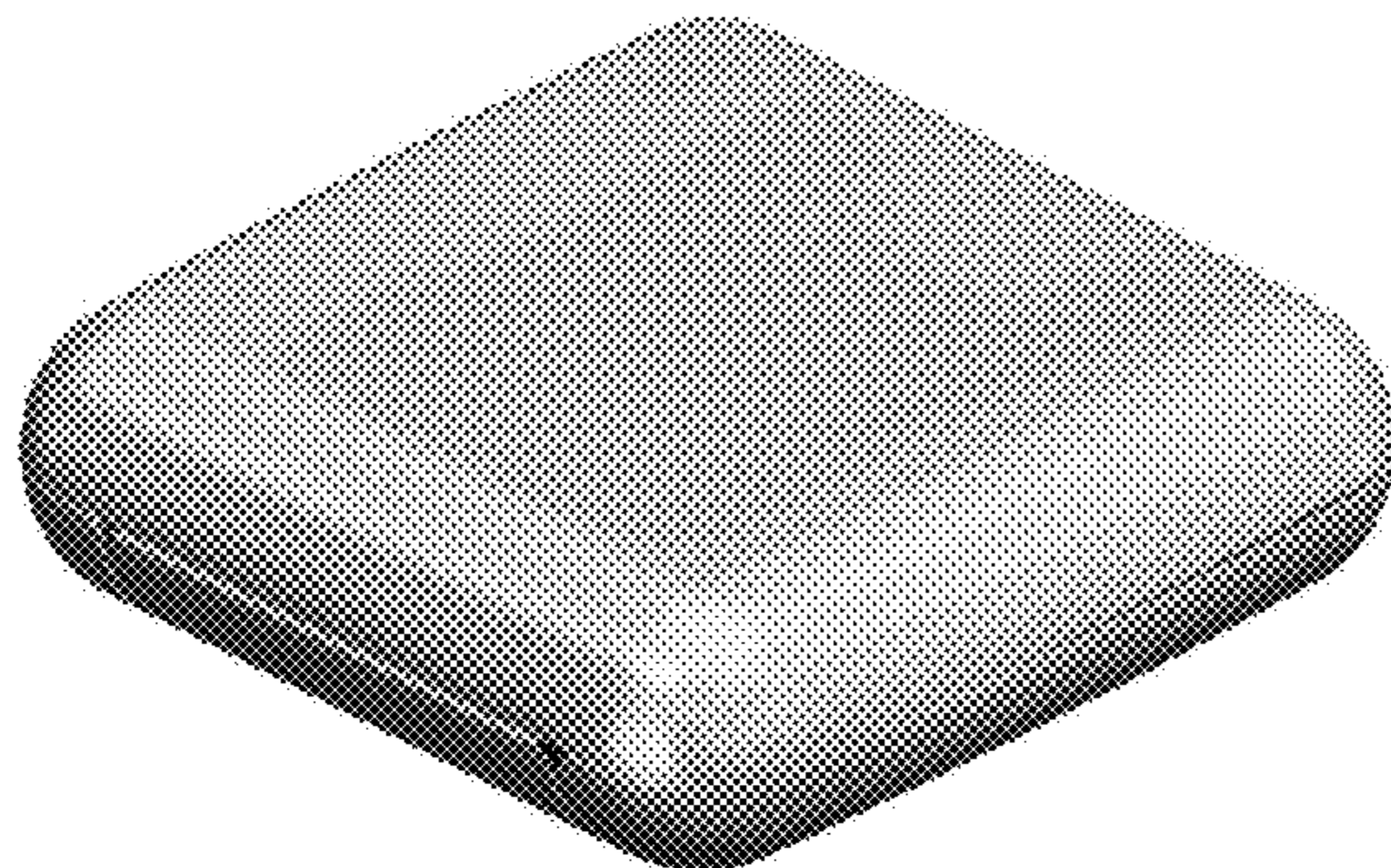
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a case, FIG. 2 is a bottom perspective view thereof, FIG. 3 is a front elevational view thereof, FIG. 4 is a rear elevational view thereof, FIG. 5 is a right-side elevational view thereof, left-side view being a mirror image thereof, FIG. 6 is a top planar view thereof, FIG. 7 is a top perspective view of a second embodiment of the case; FIG. 8 is a bottom perspective view thereof, FIG. 9 is a front elevational view thereof, FIG. 10 is a rear elevational view thereof, FIG. 11 is a left-side elevational view thereof, right-side view being a mirror image thereof, FIG. 12 is a top planar view thereof, FIG. 13 is a top perspective view of a third embodiment of the case; FIG. 14 is a bottom perspective view thereof, FIG. 15 is a front elevational view thereof, FIG. 16 is a rear elevational view thereof, FIG. 17 is a left-side elevational view thereof, right-side view being a mirror image thereof, FIG. 18 is a top planar view thereof, FIG. 19 is a top perspective view of a fourth embodiment of the case; FIG. 20 is a bottom perspective view thereof, FIG. 21 is a front elevational view thereof, FIG. 22 is a rear elevational view thereof, FIG. 23 is a right-side elevational view thereof, left-side view being a mirror image thereof; and, FIG. 24 is a top planar view thereof.

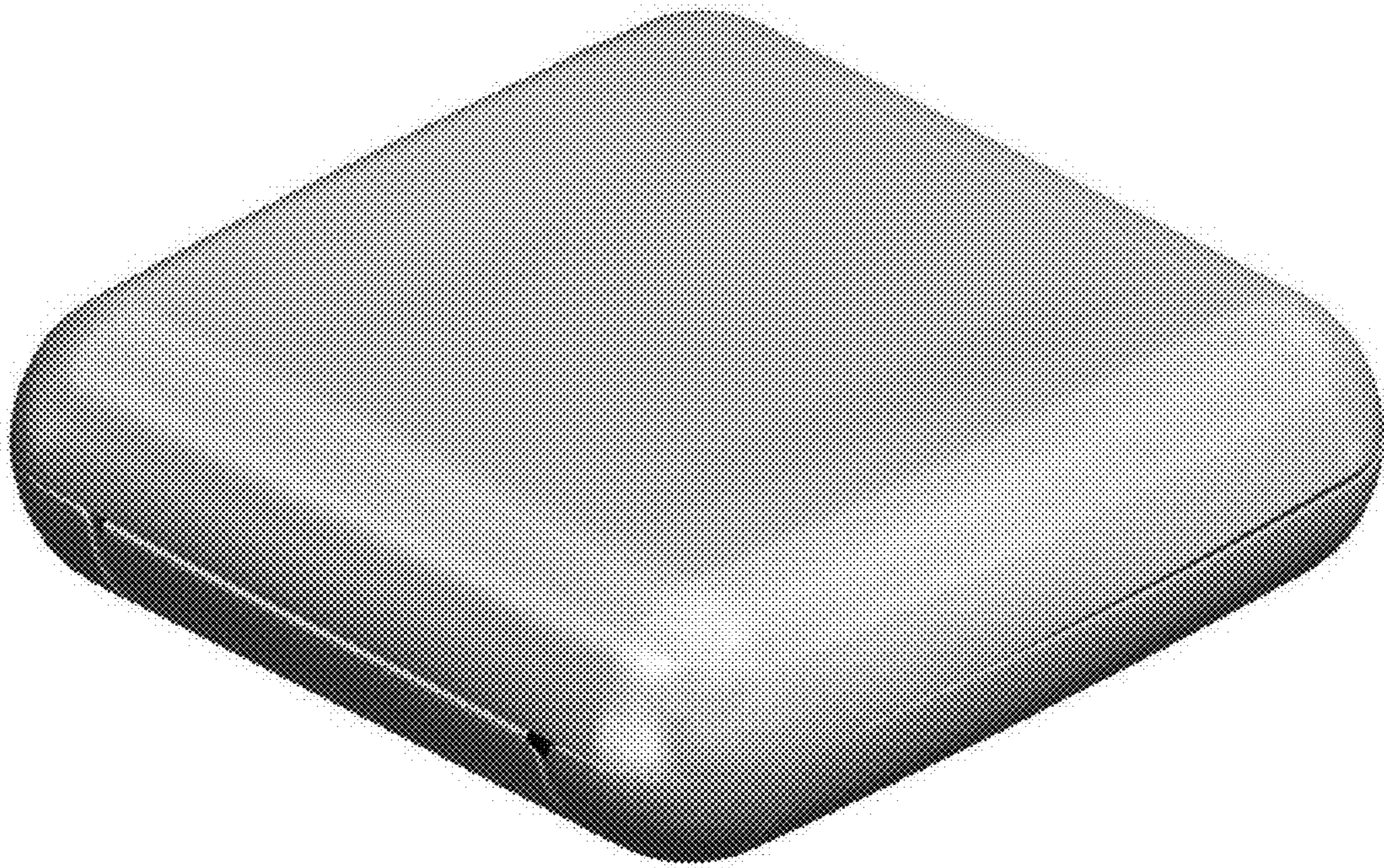

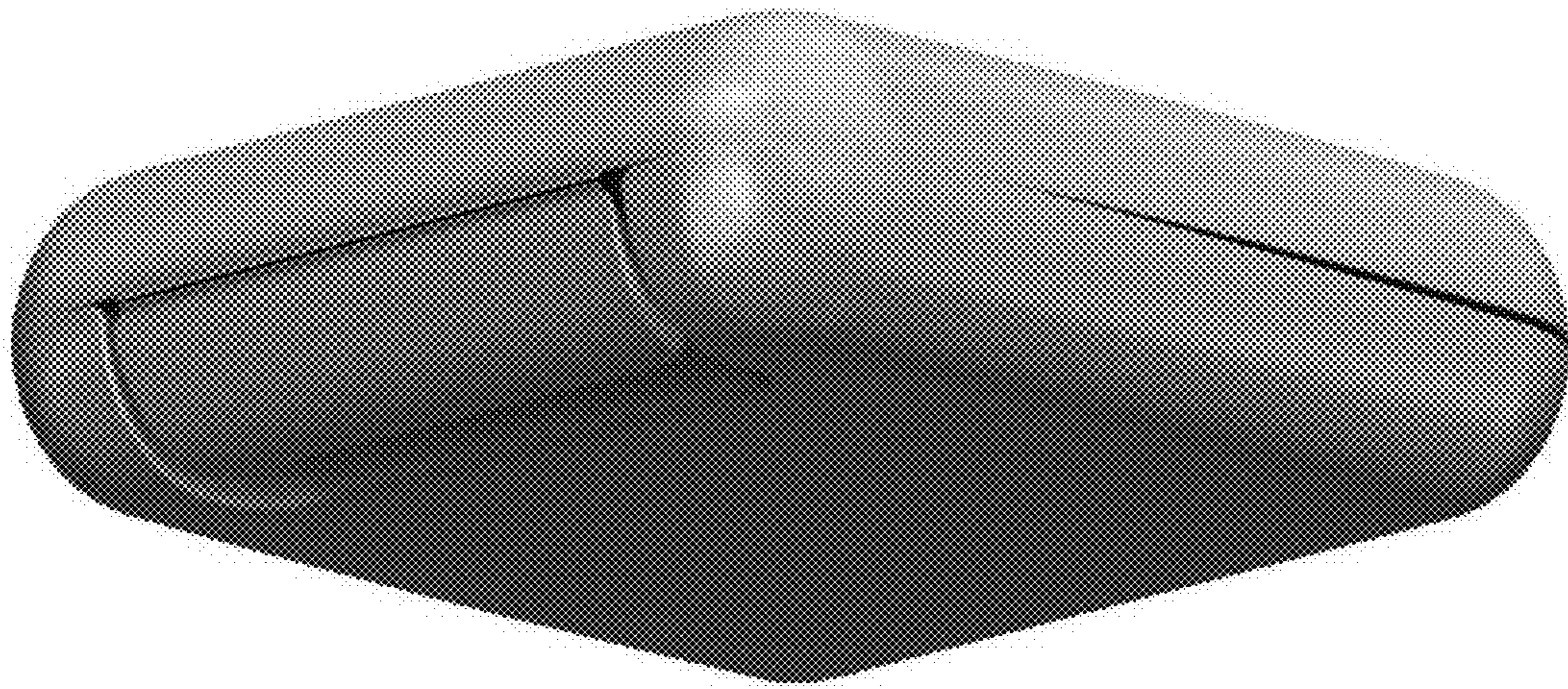

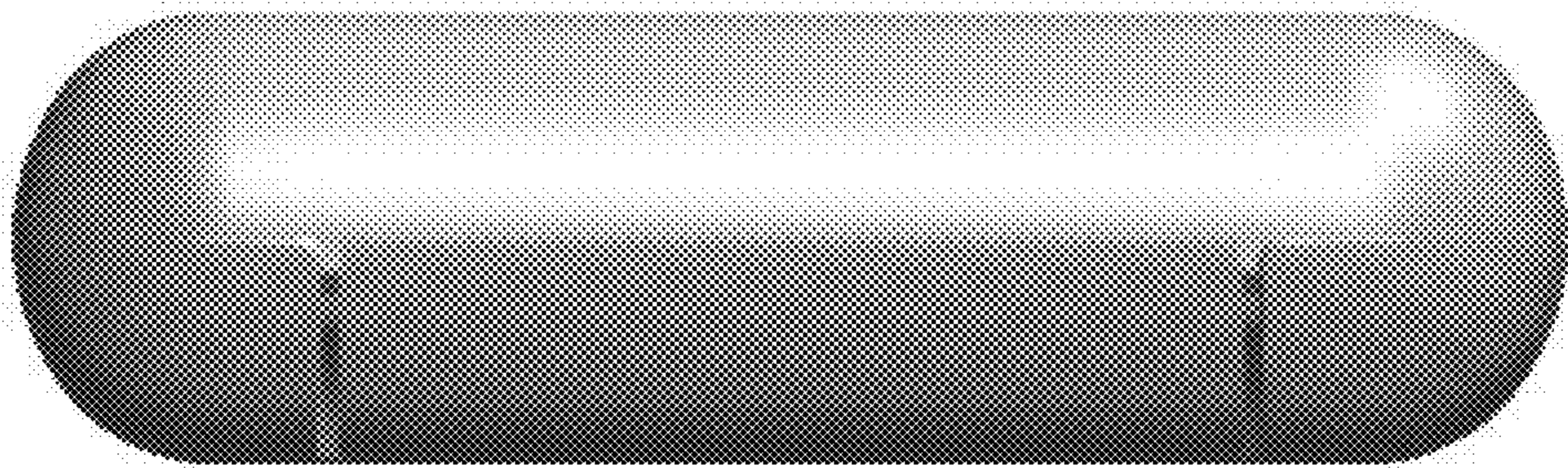

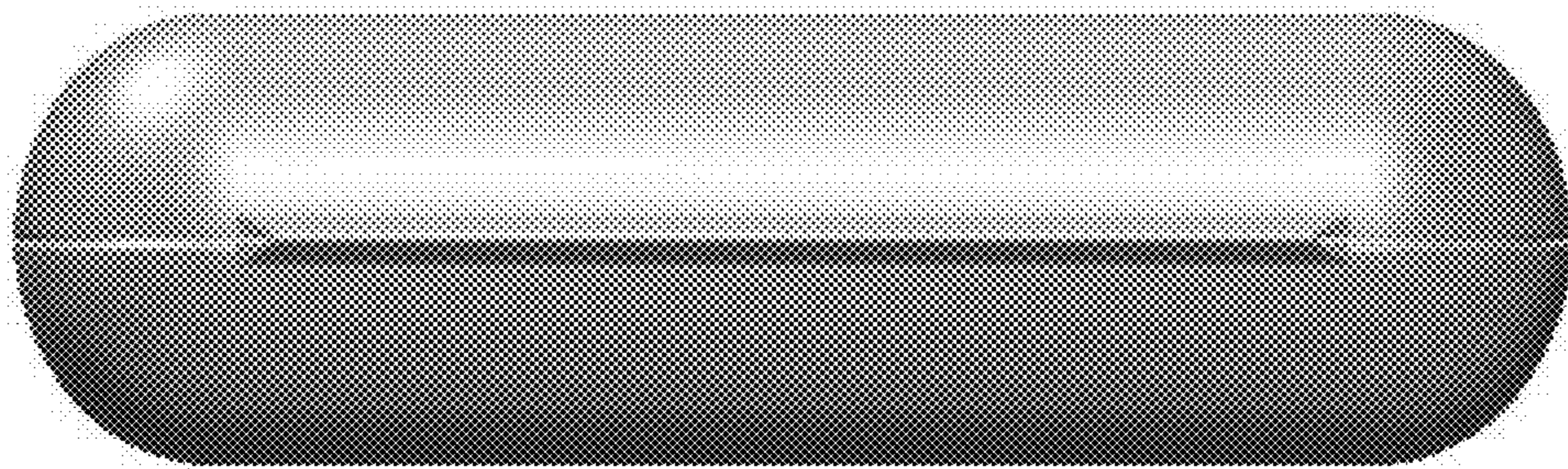

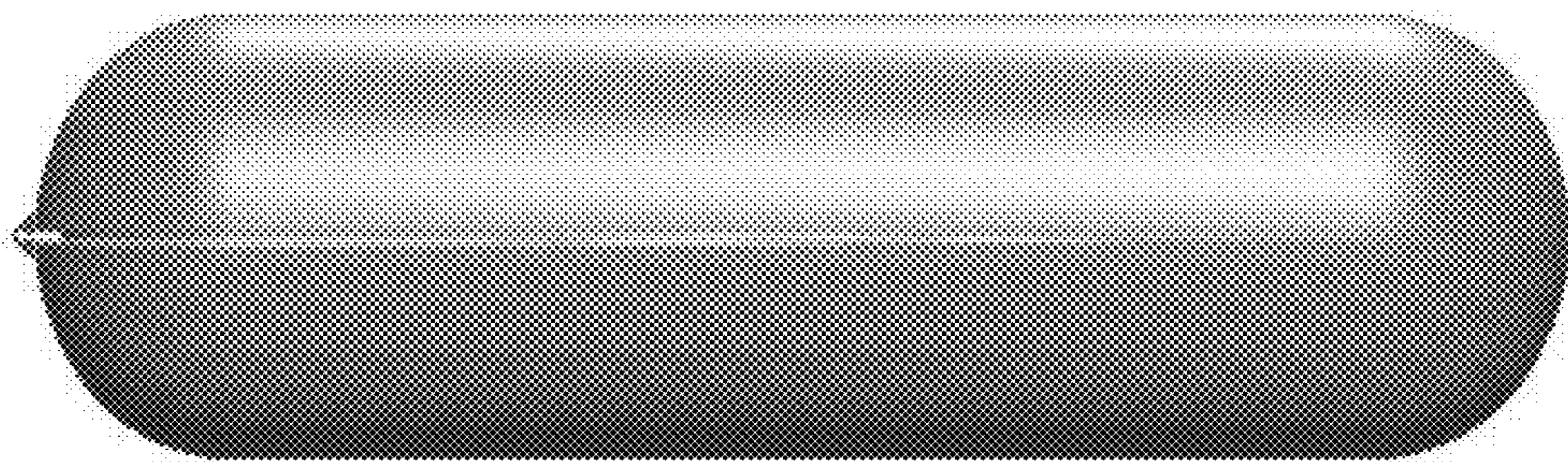

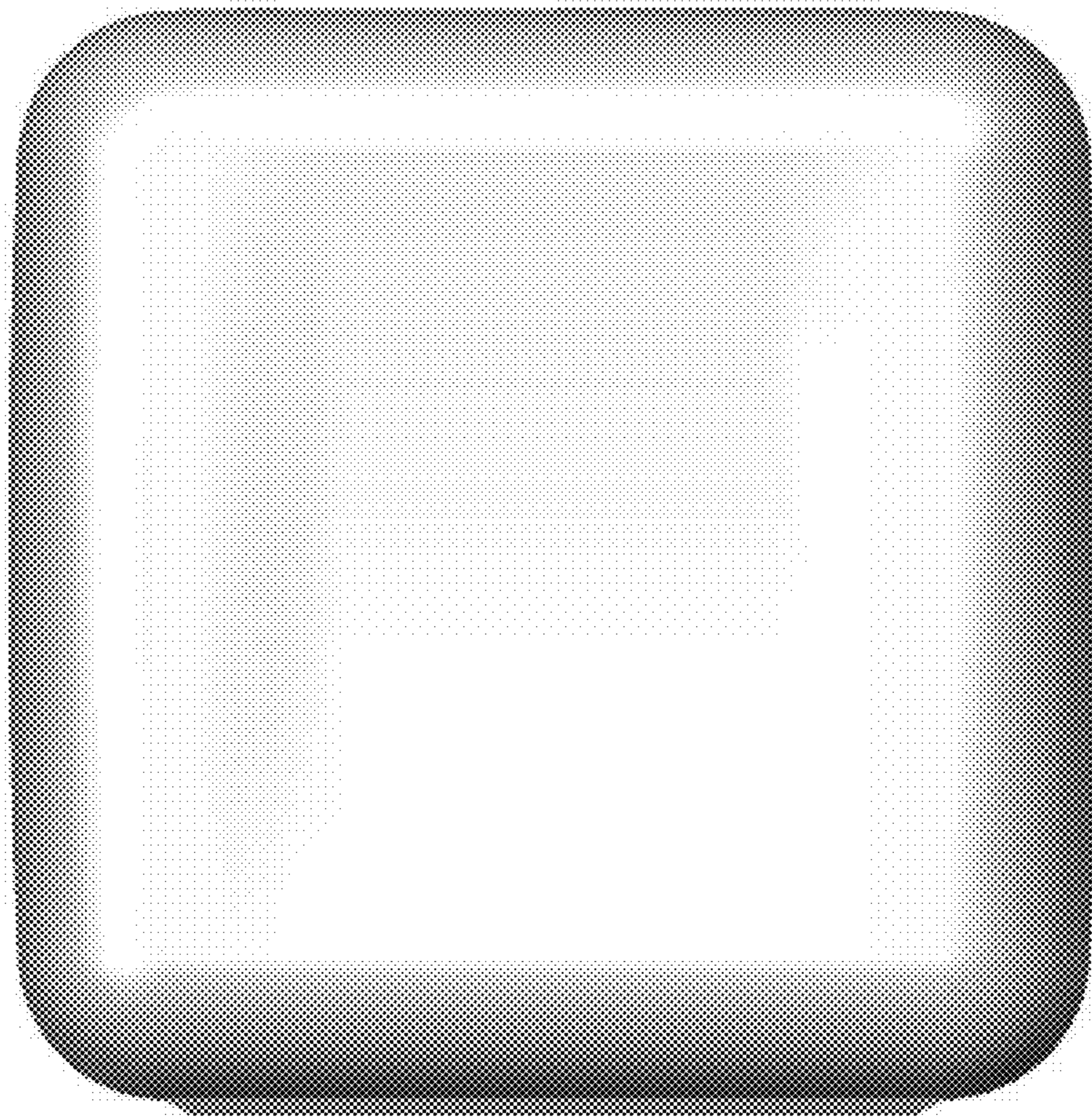

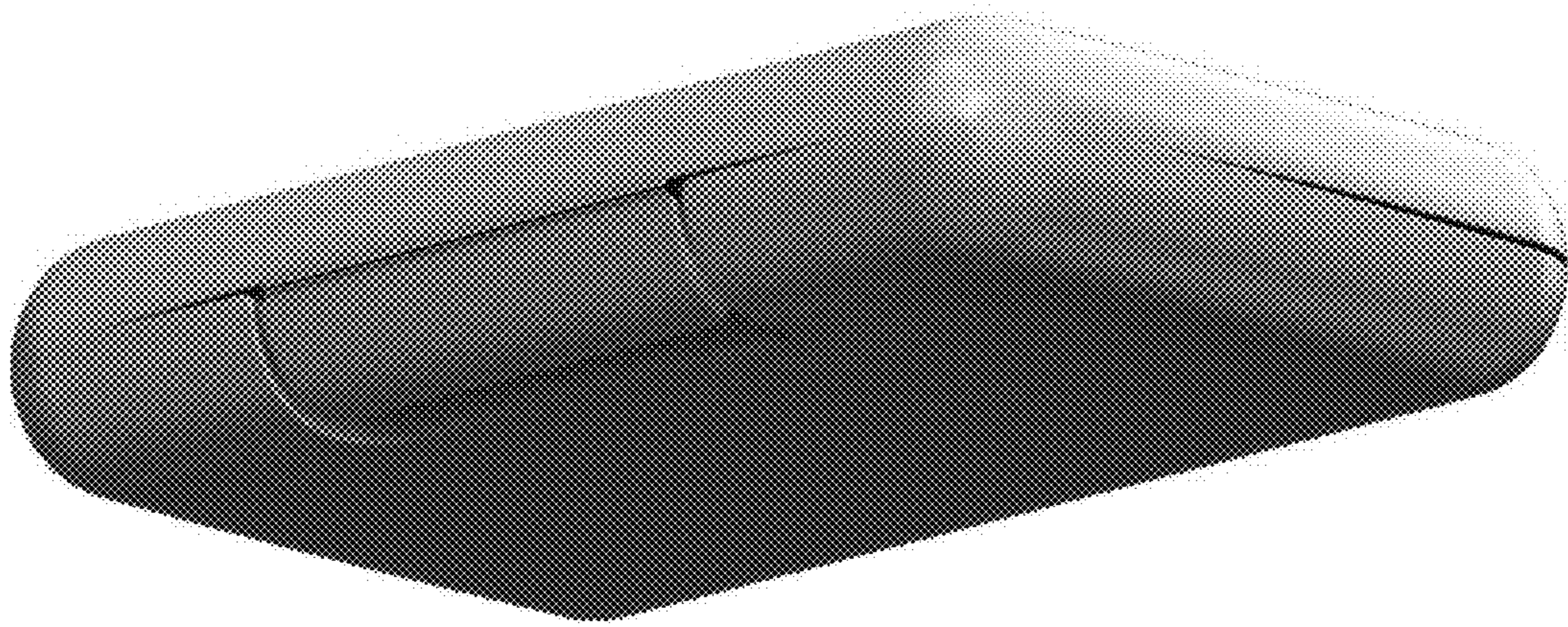

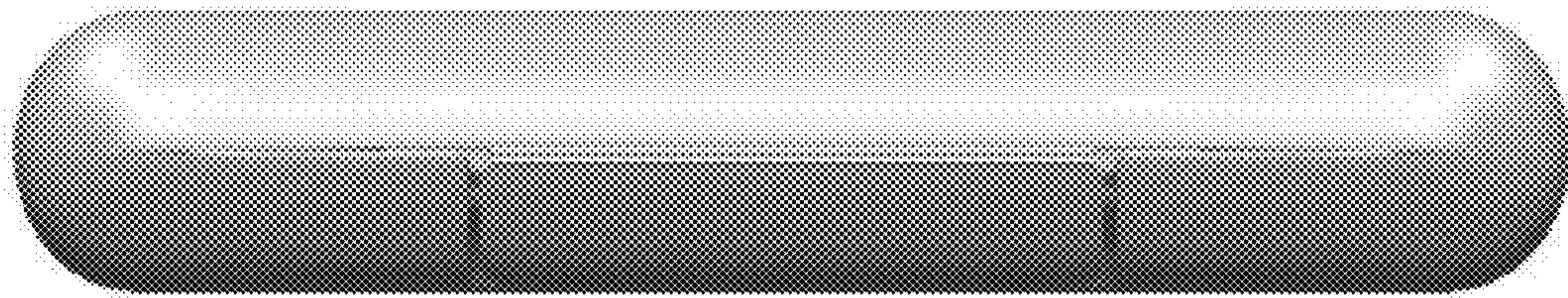

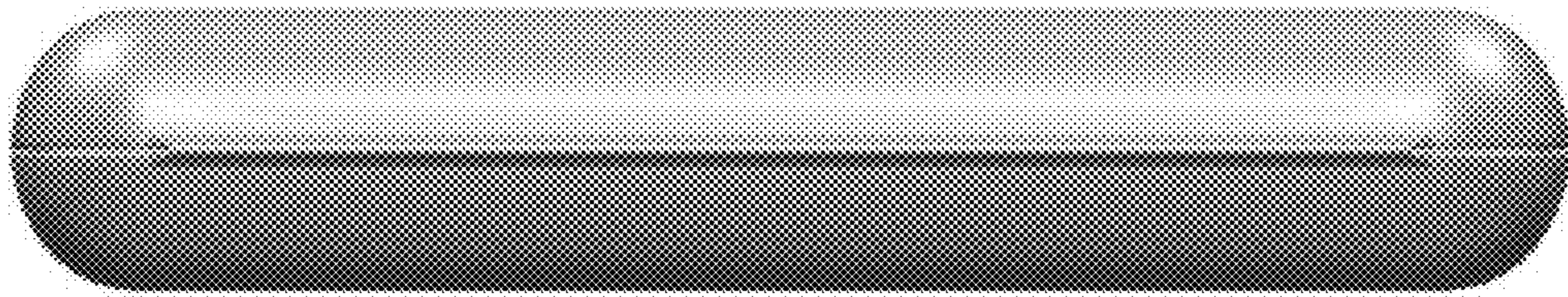

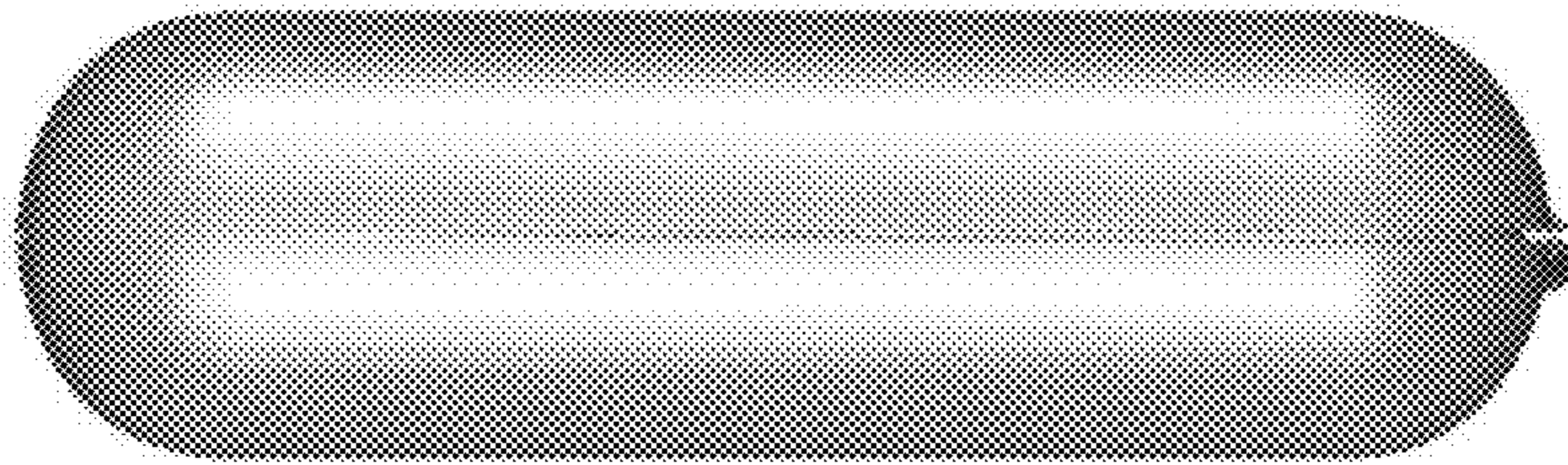

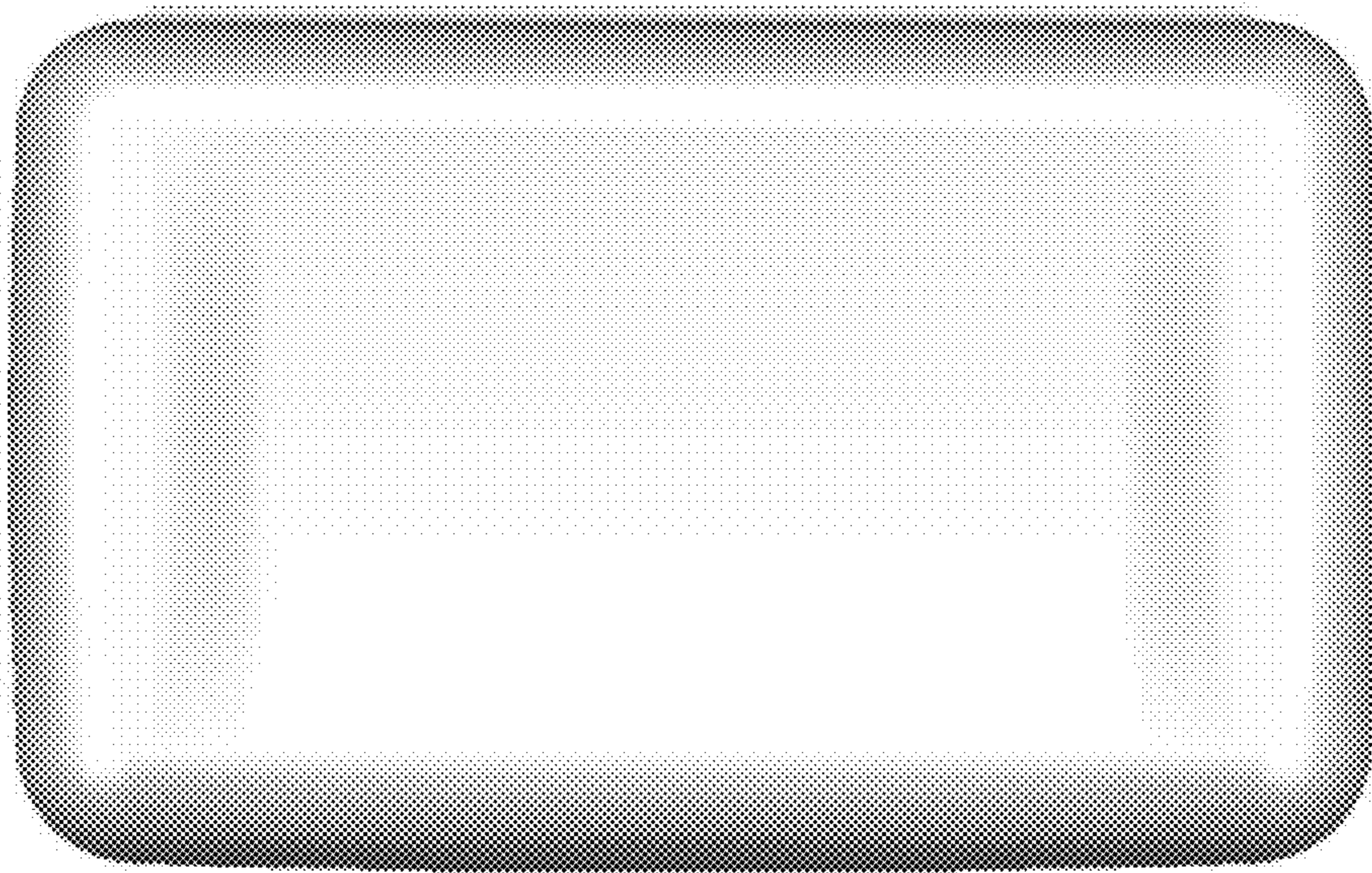

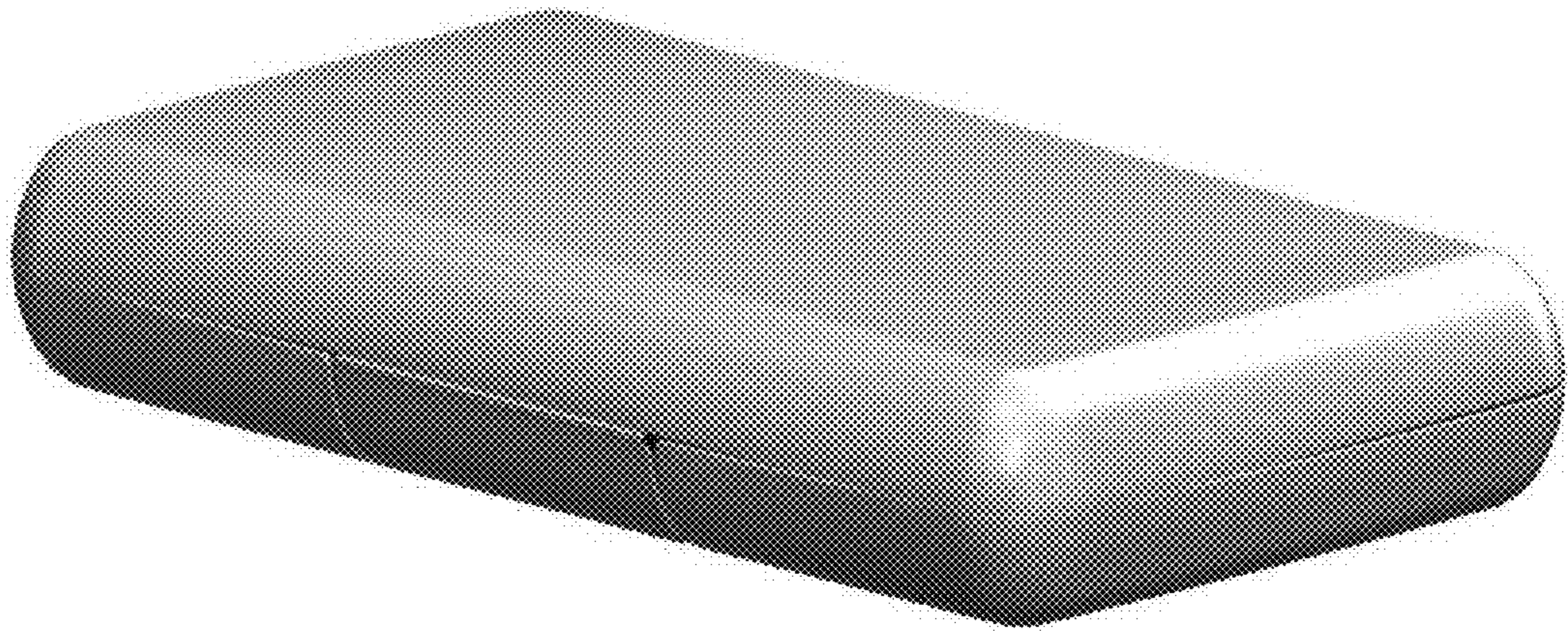

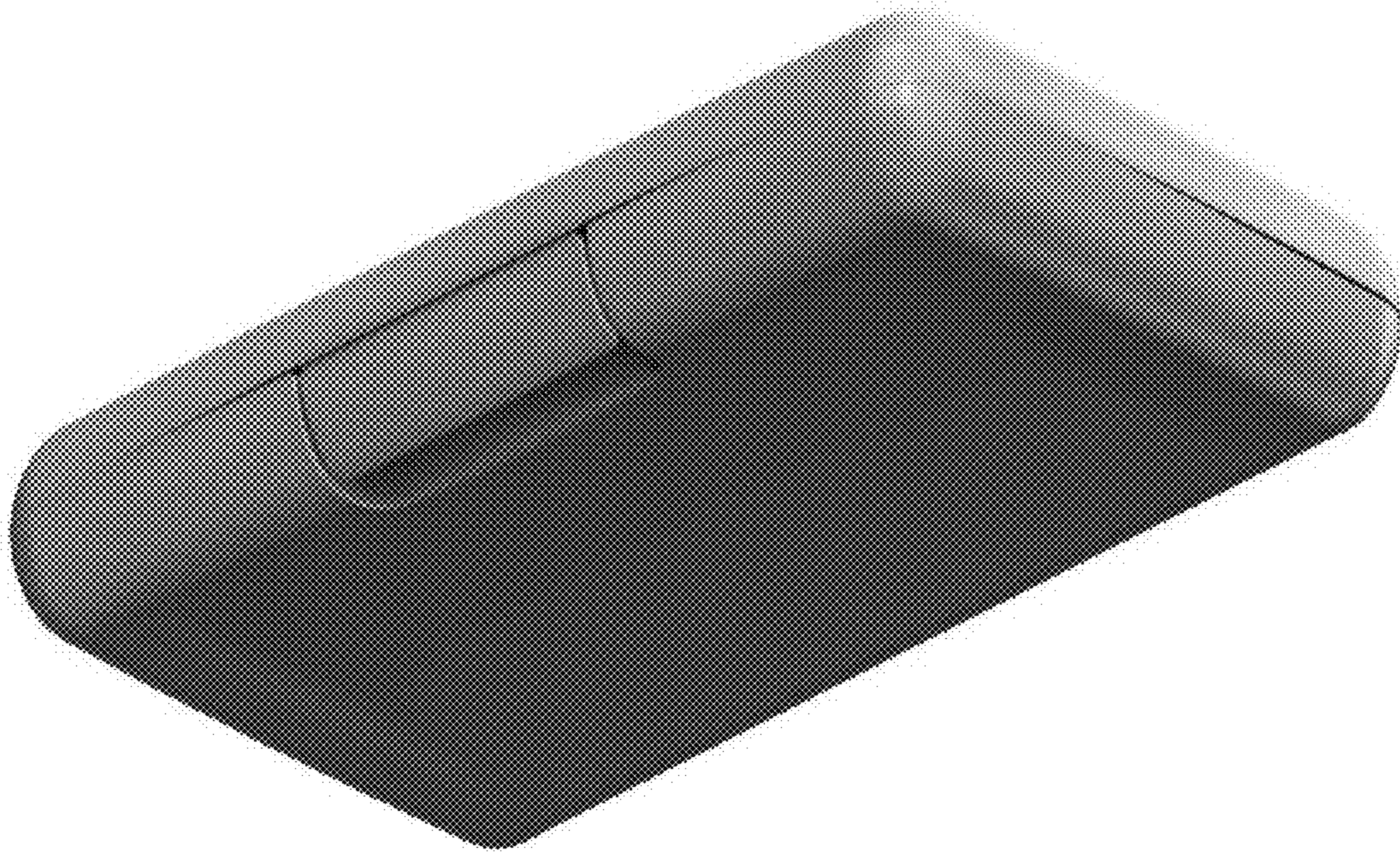

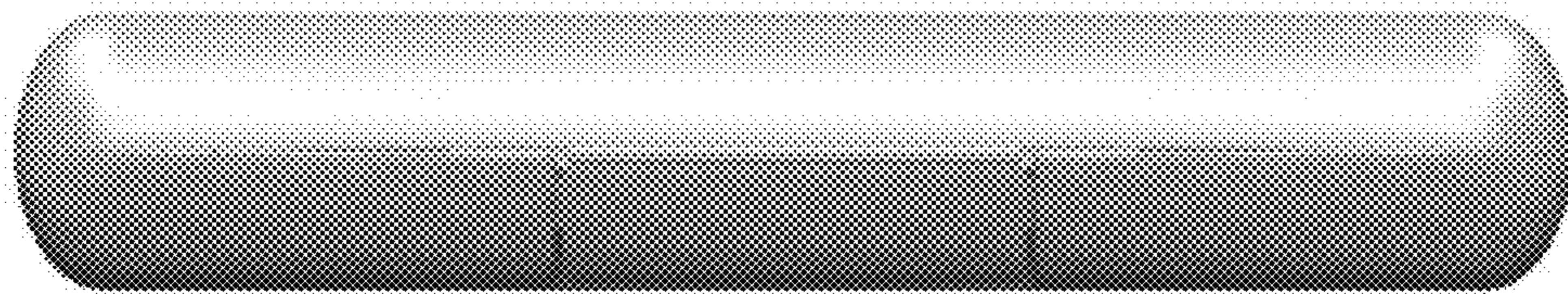

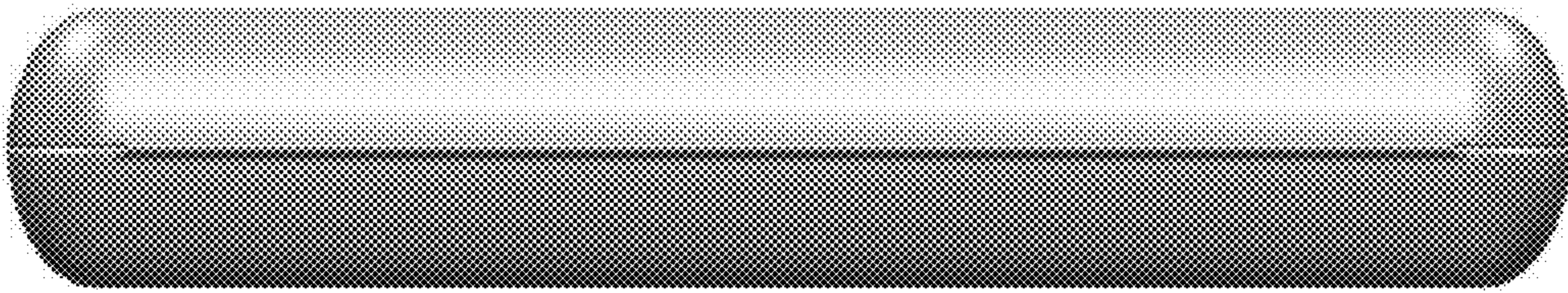

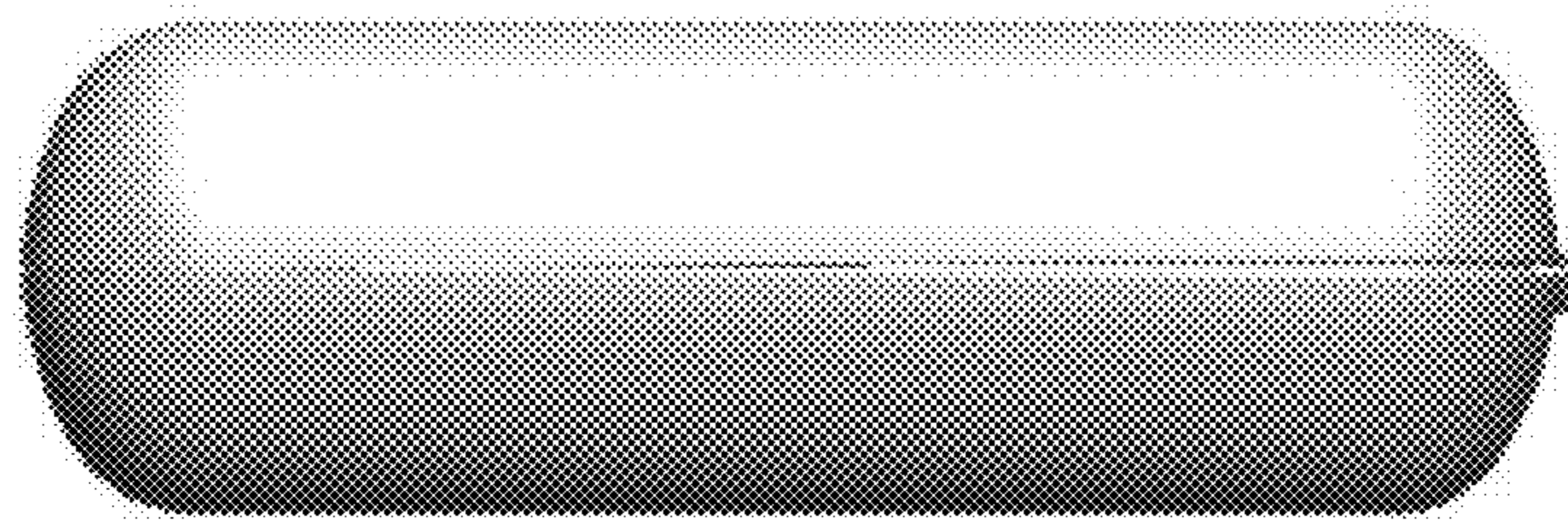

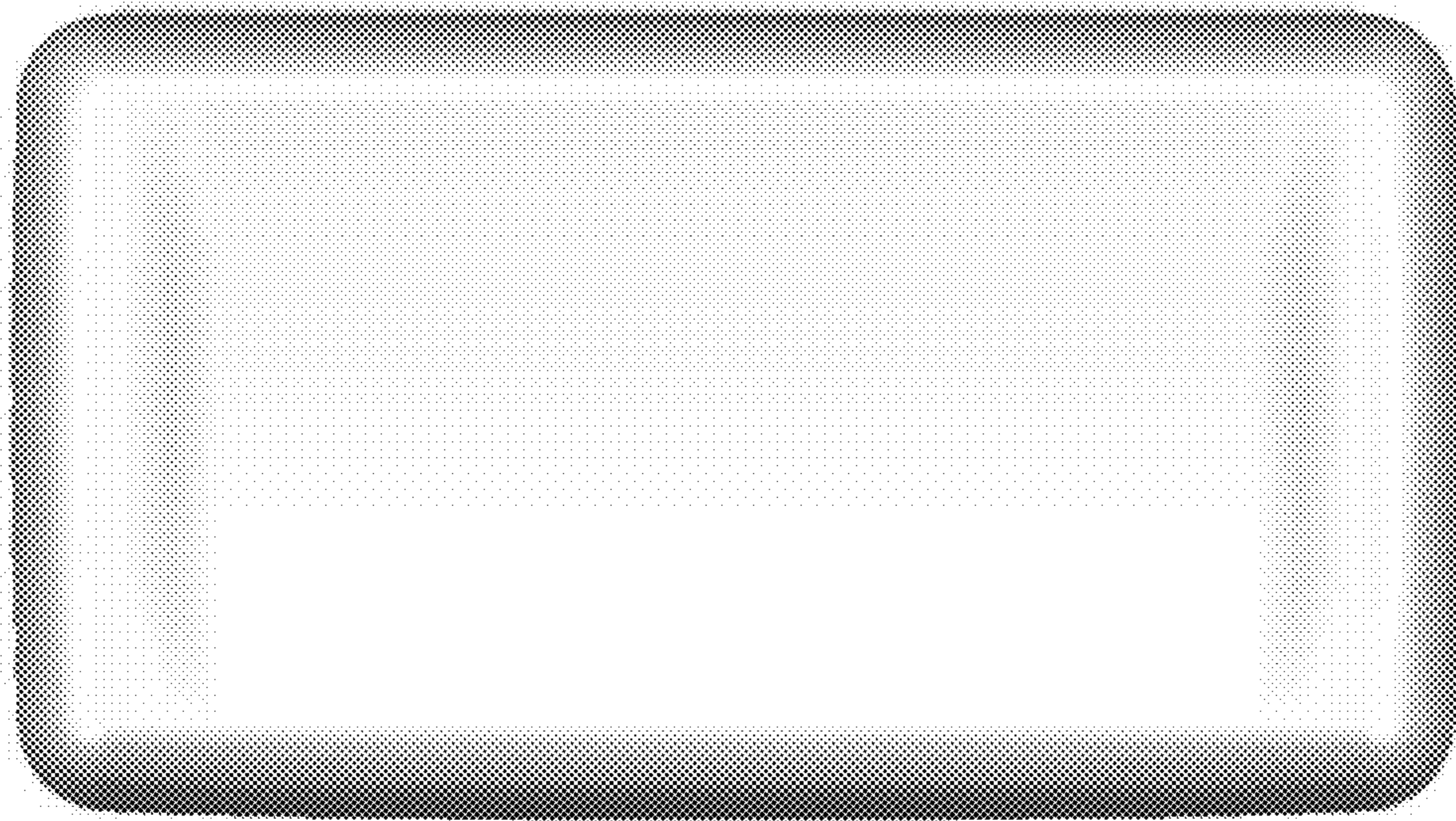

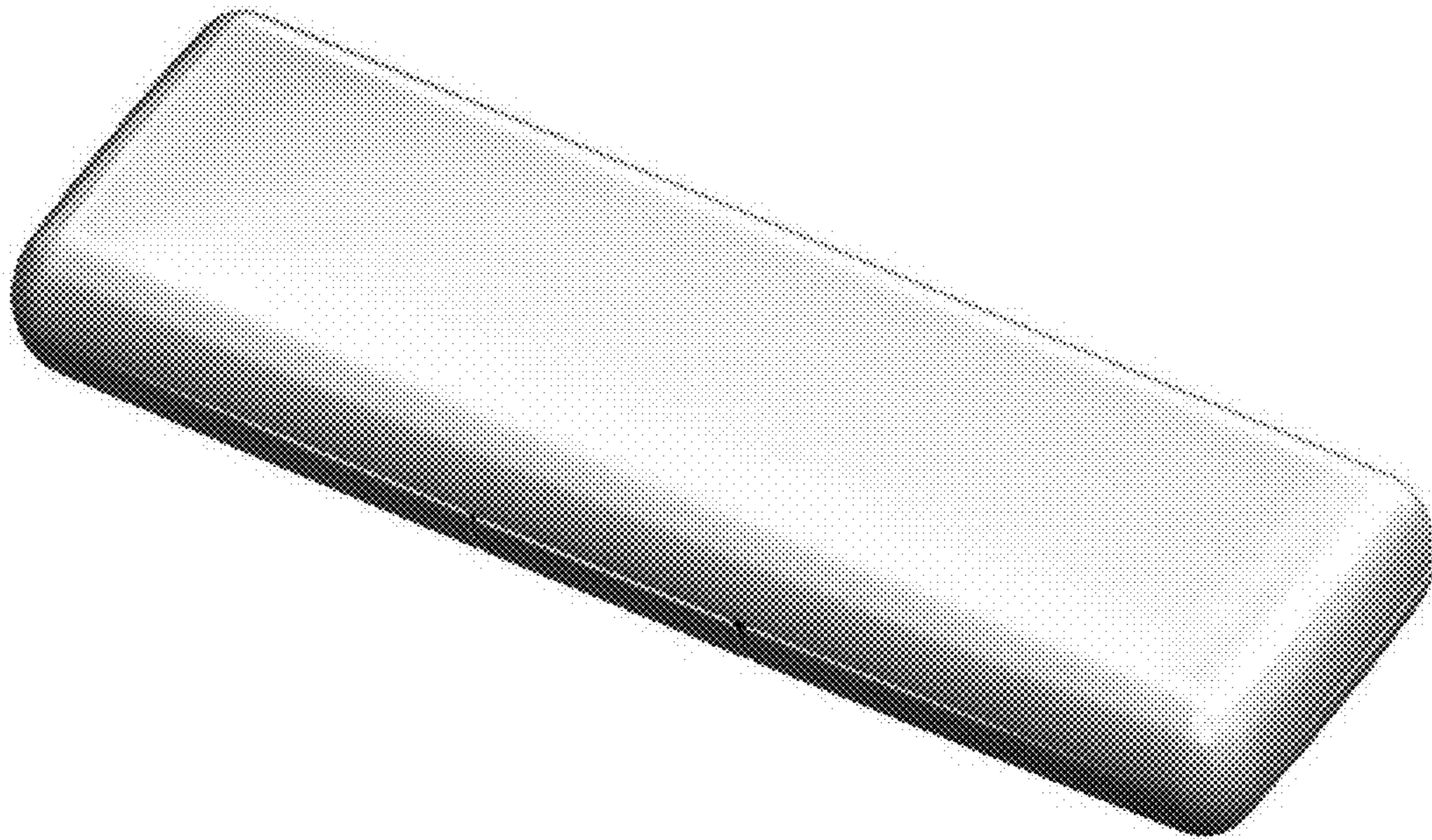

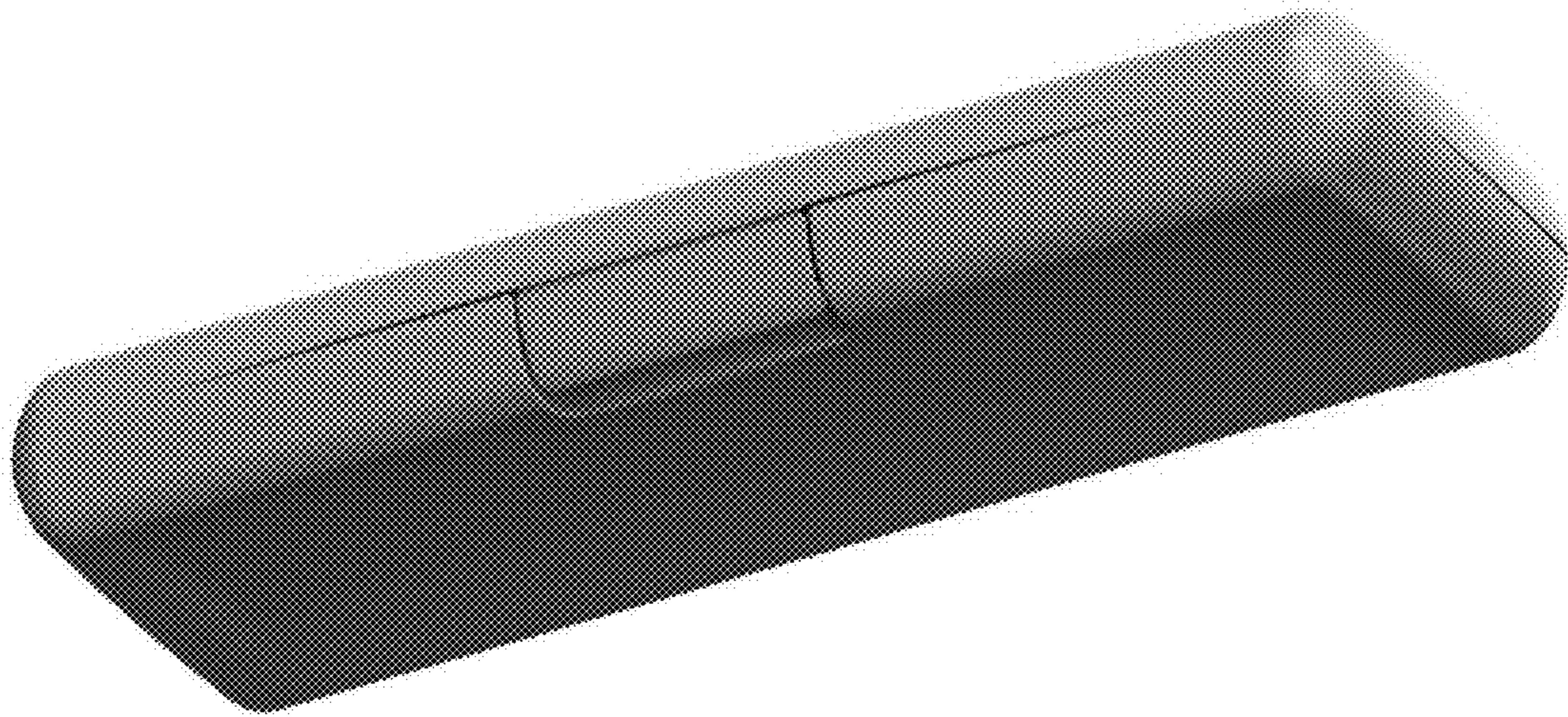

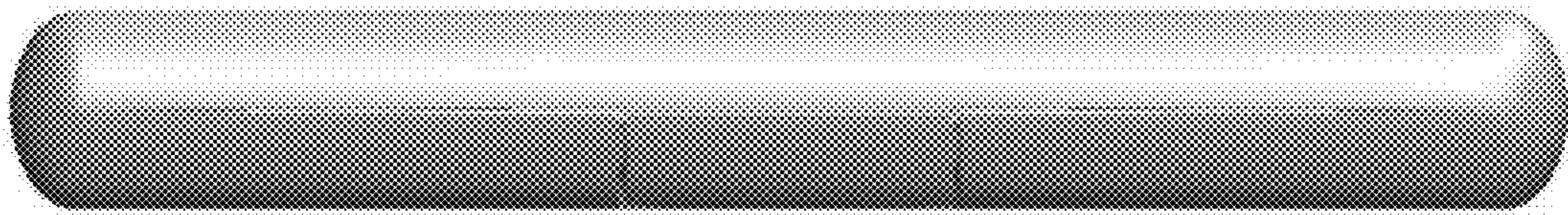

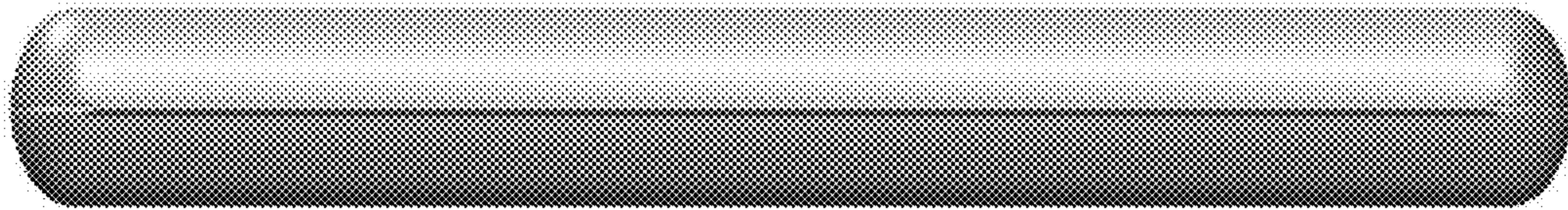

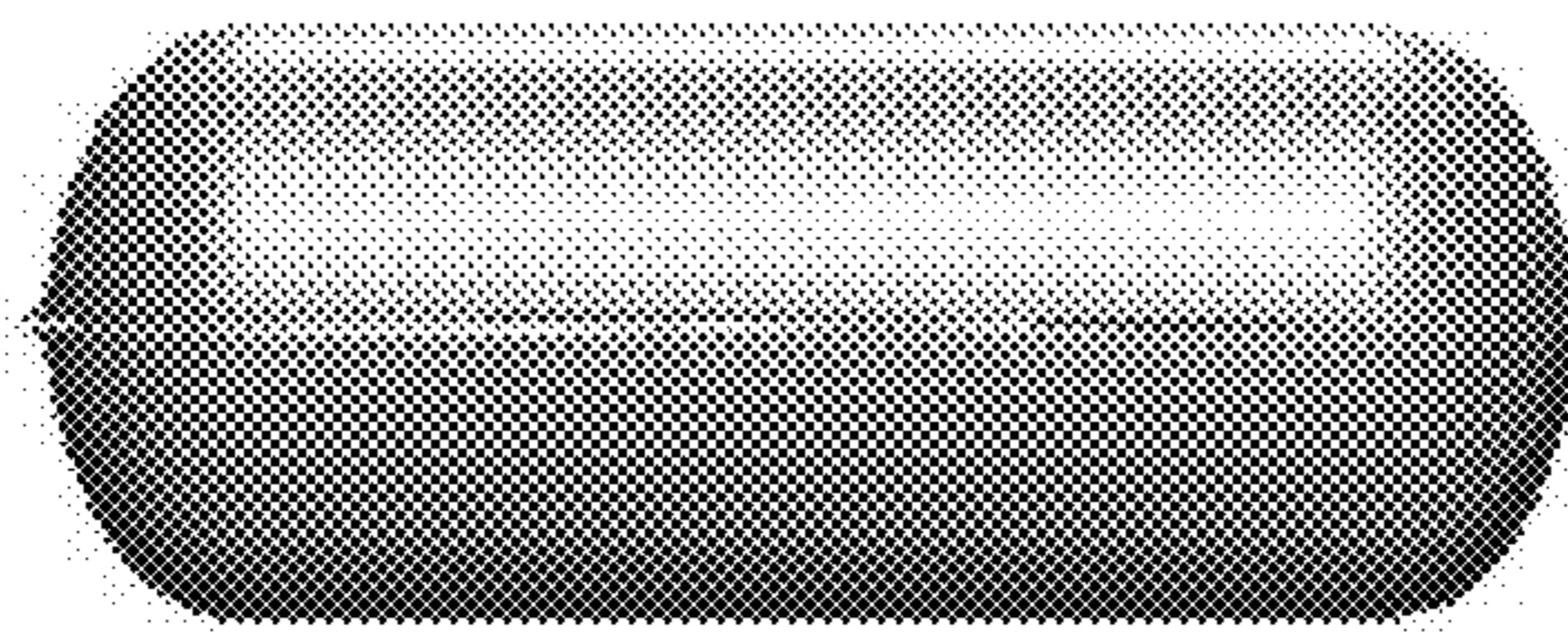
