FIG. 4 is a right side elevation thereof.

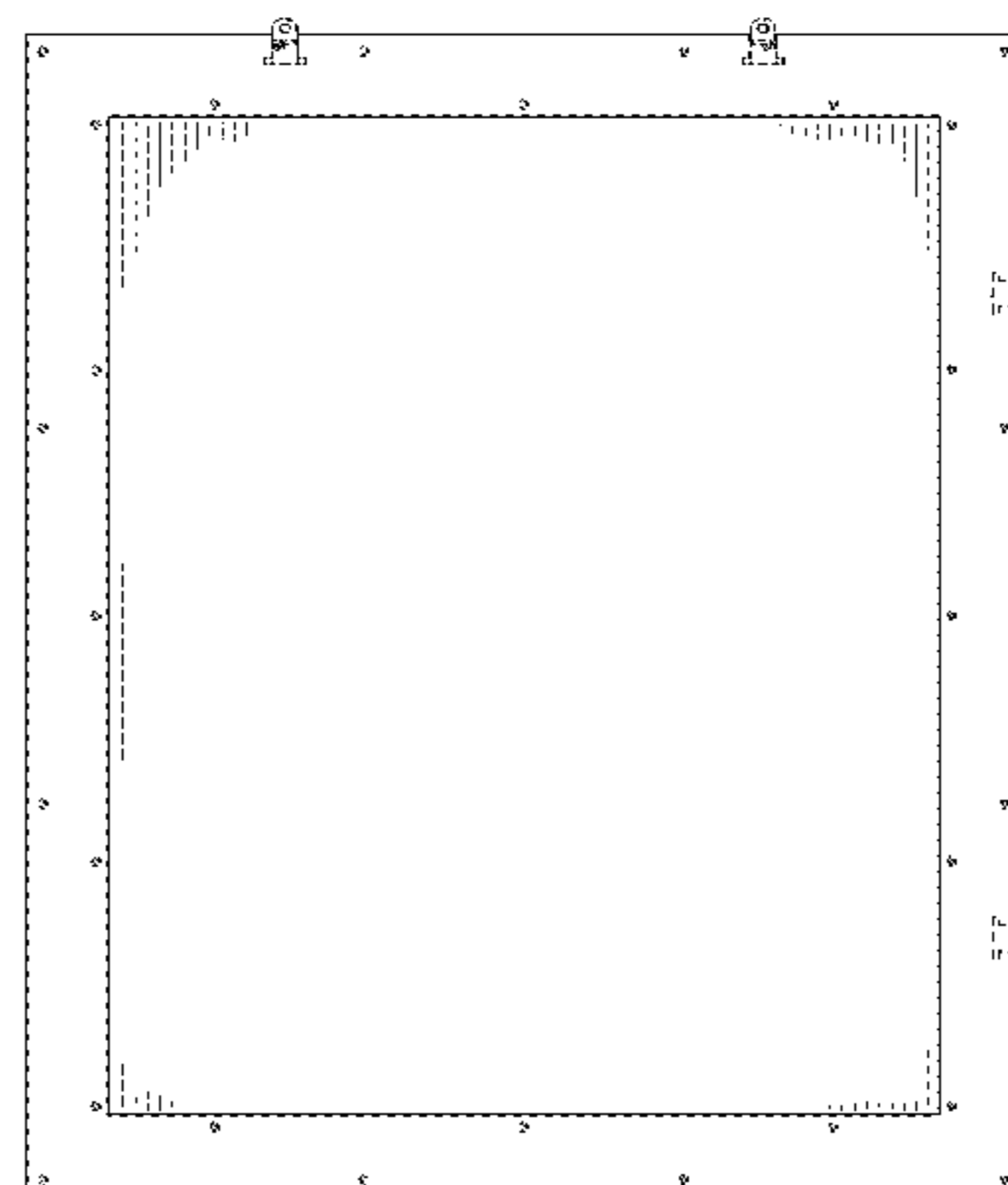
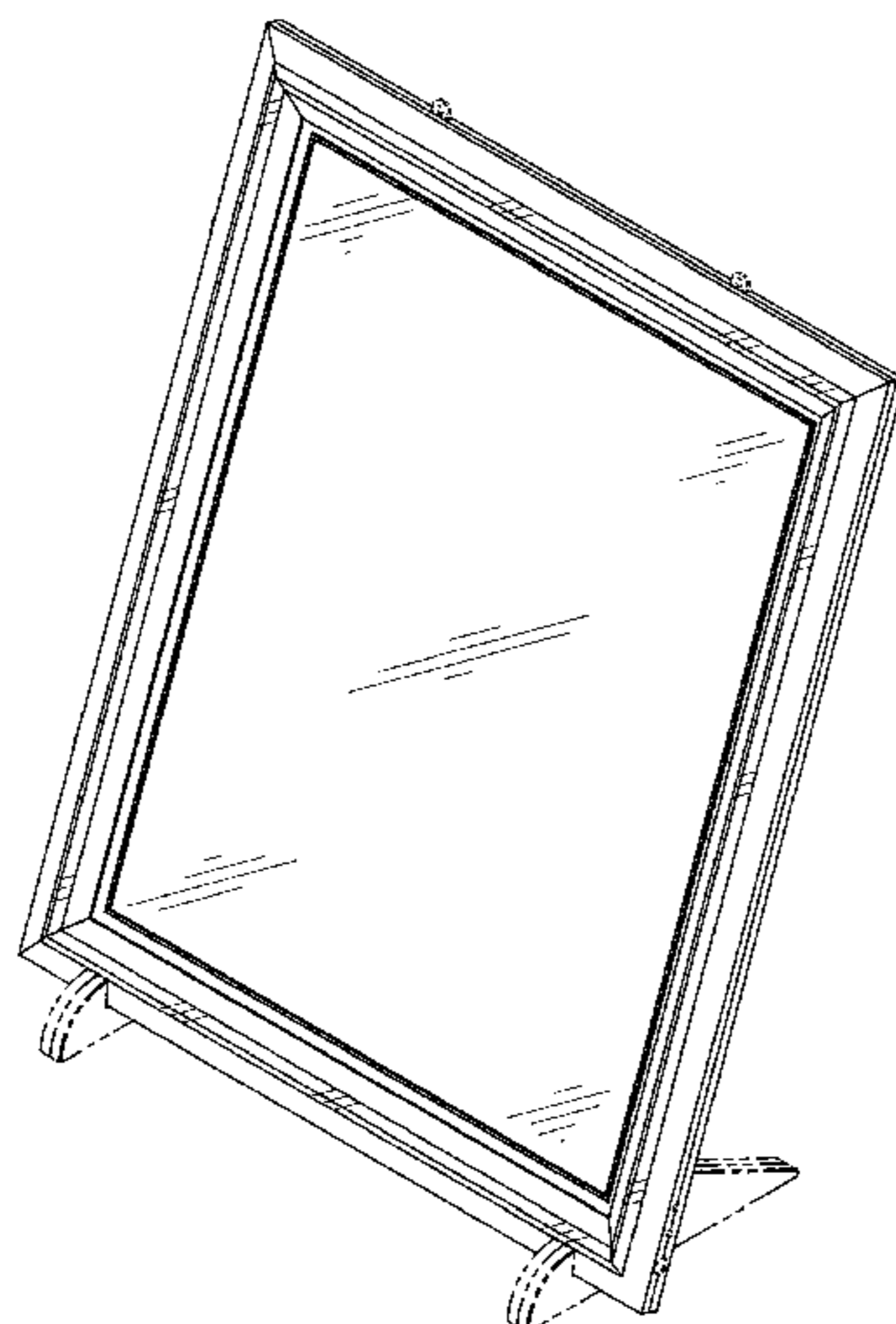
FIG. 5 is a left side elevation thereof.

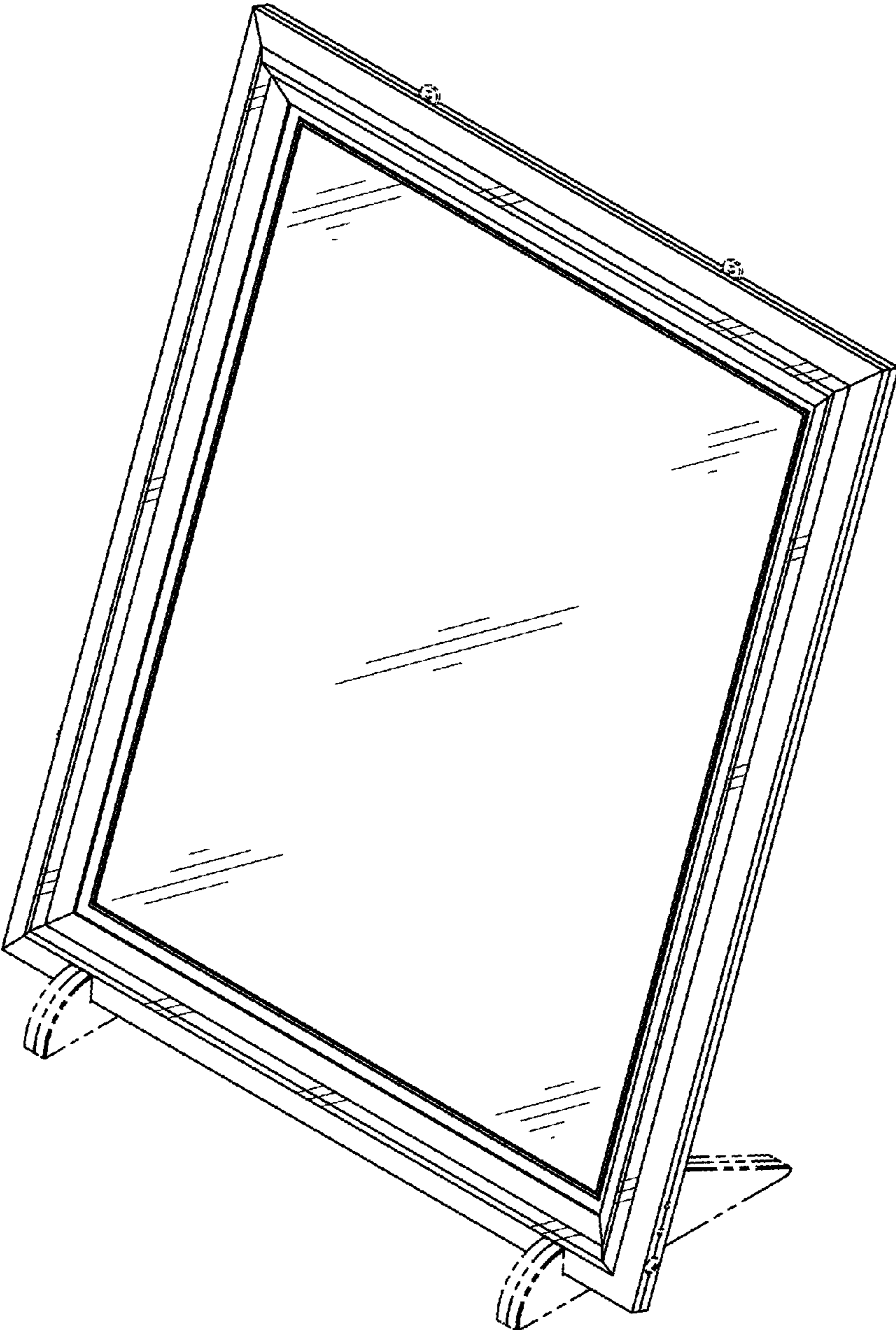

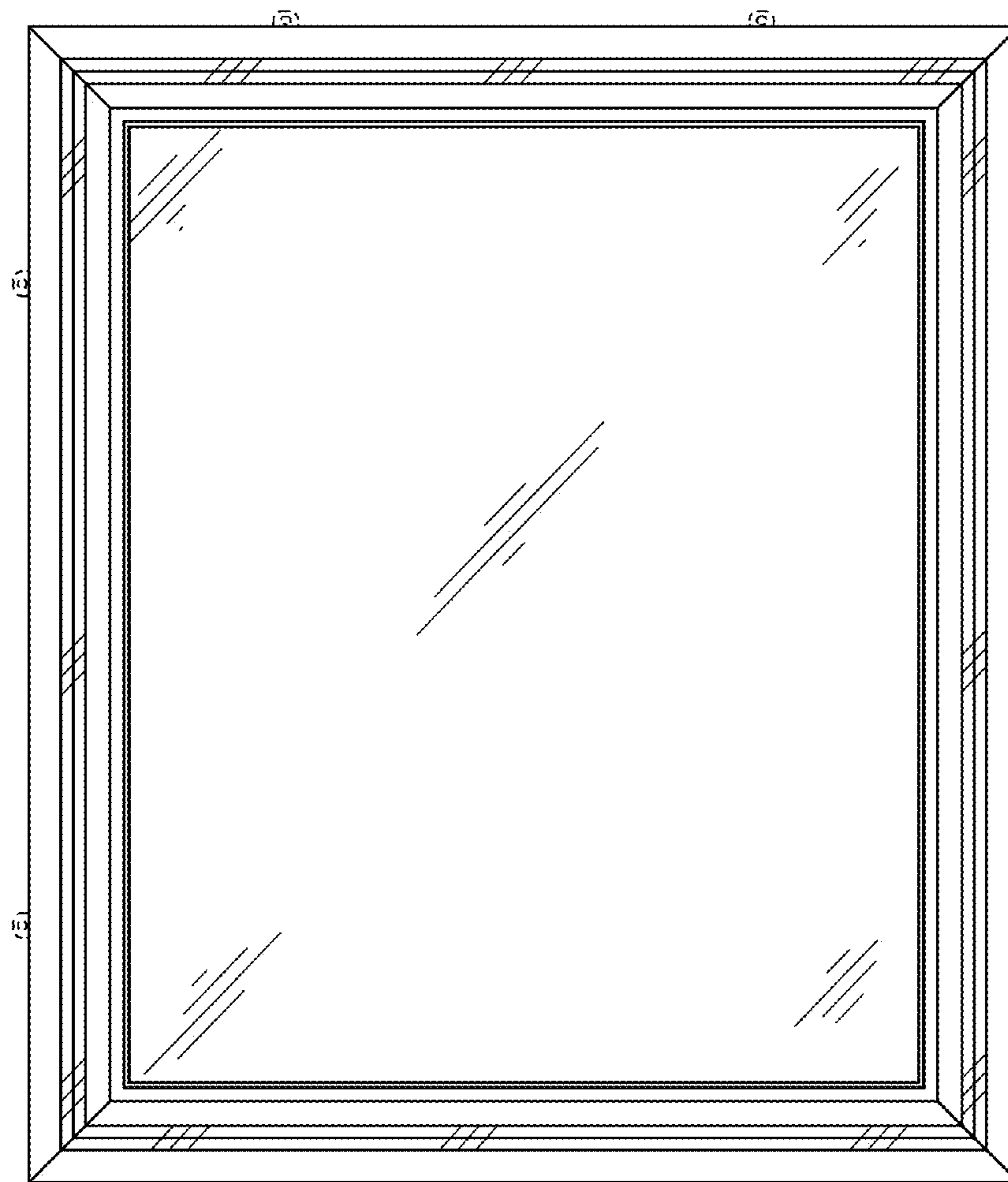

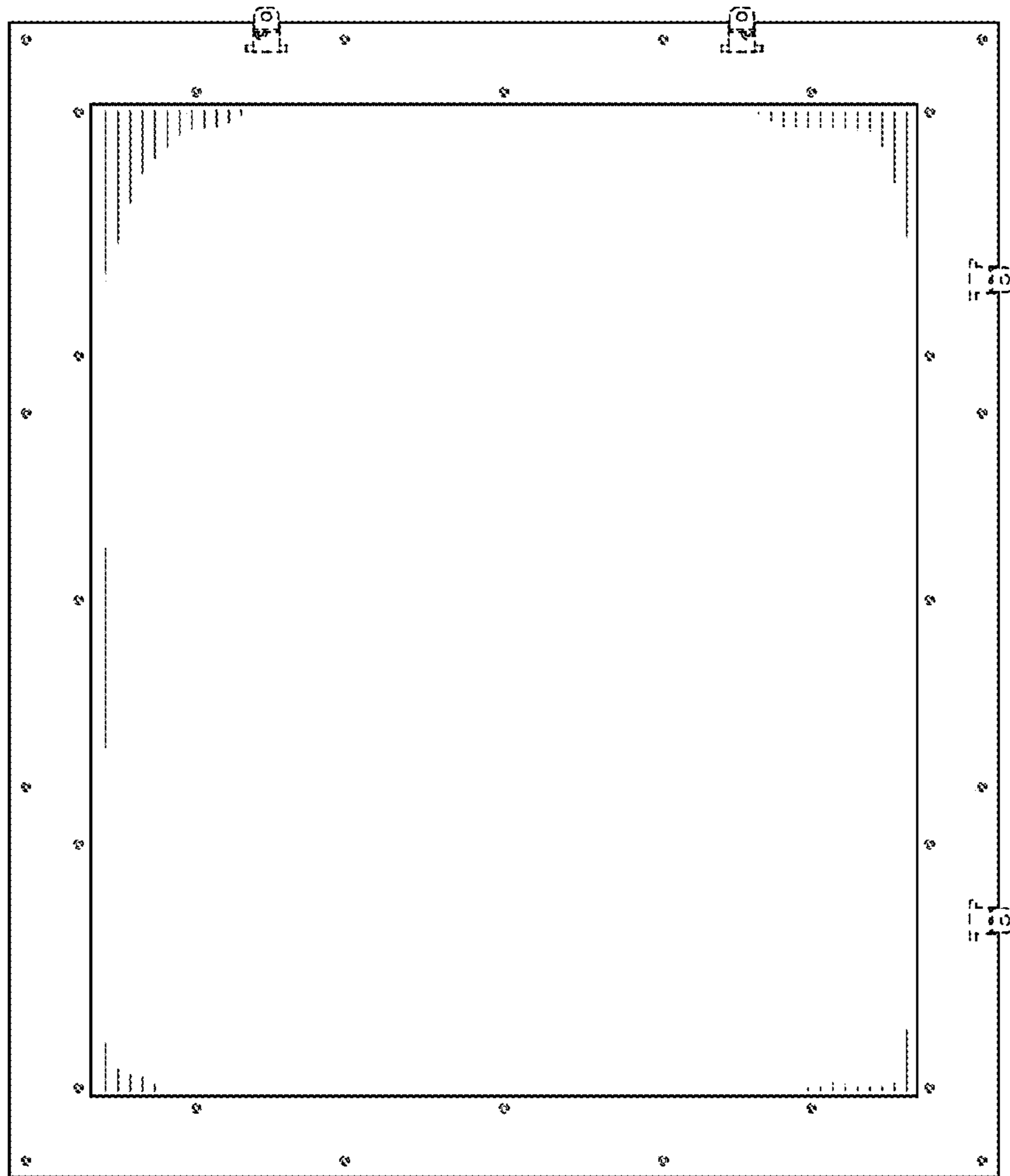

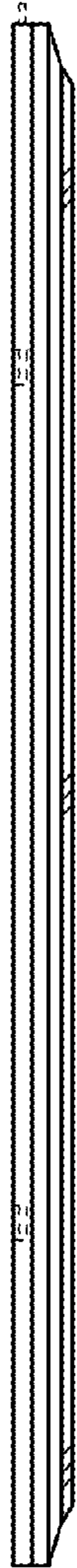

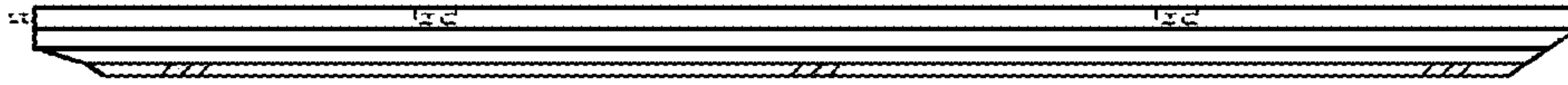

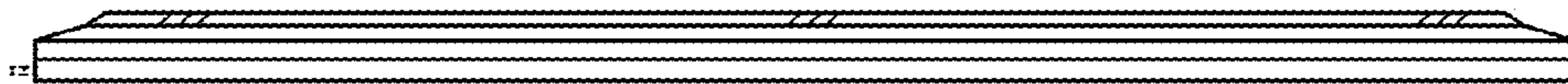
