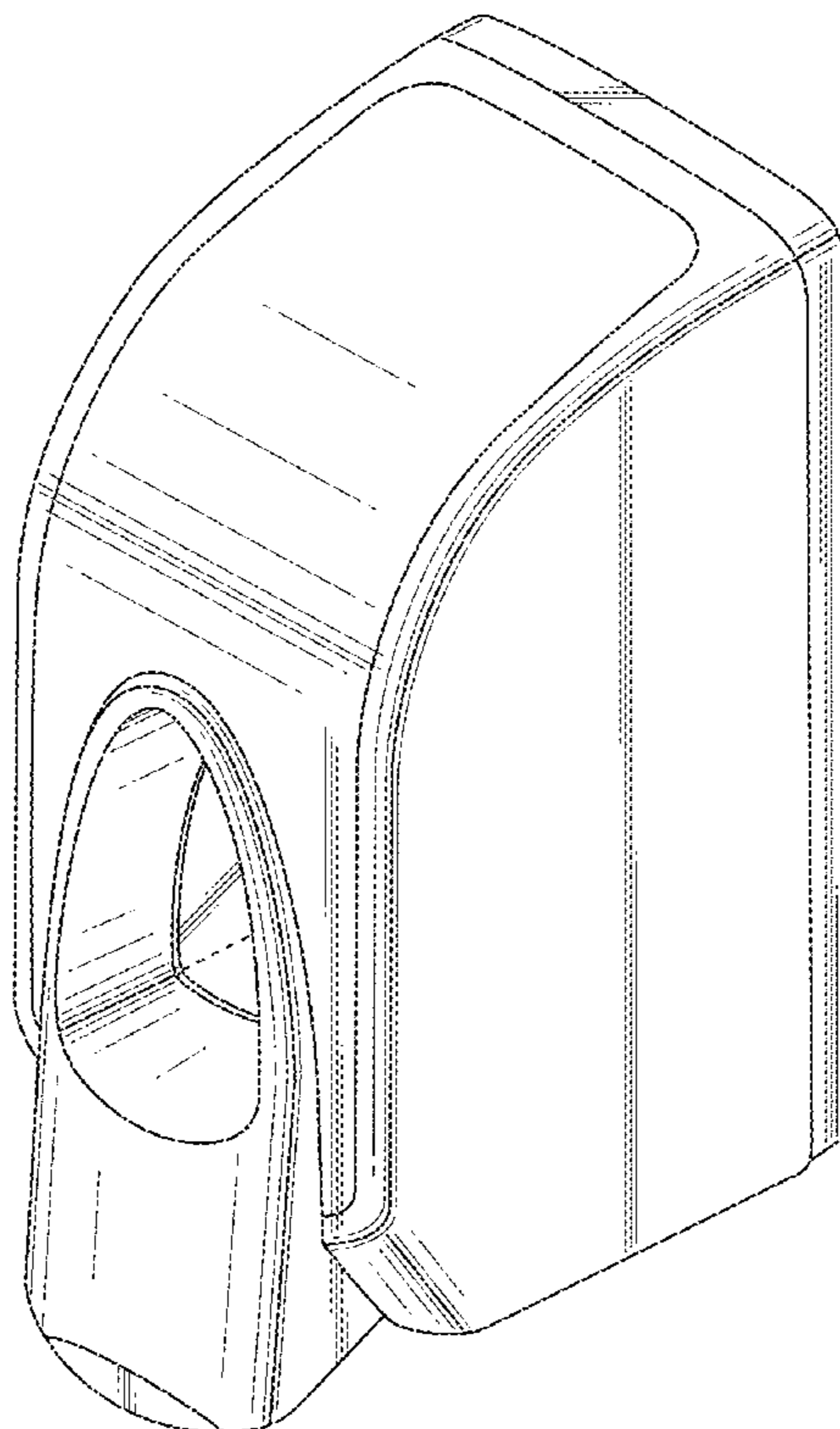
(57) **CLAIM**

The ornamental design for a manual spray soap dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the manual spray soap dispenser; FIG. 2 is a front view of the manual spray soap dispenser; FIG. 3 is a back side view of the manual spray soap dispenser; FIG. 4 is a left side view of the manual spray soap dispenser; FIG. 5 is a right side view of the manual spray soap dispenser; FIG. 6 is a top view of the manual spray soap dispenser; and, FIG. 7 is a bottom view of the manual spray soap dispenser. 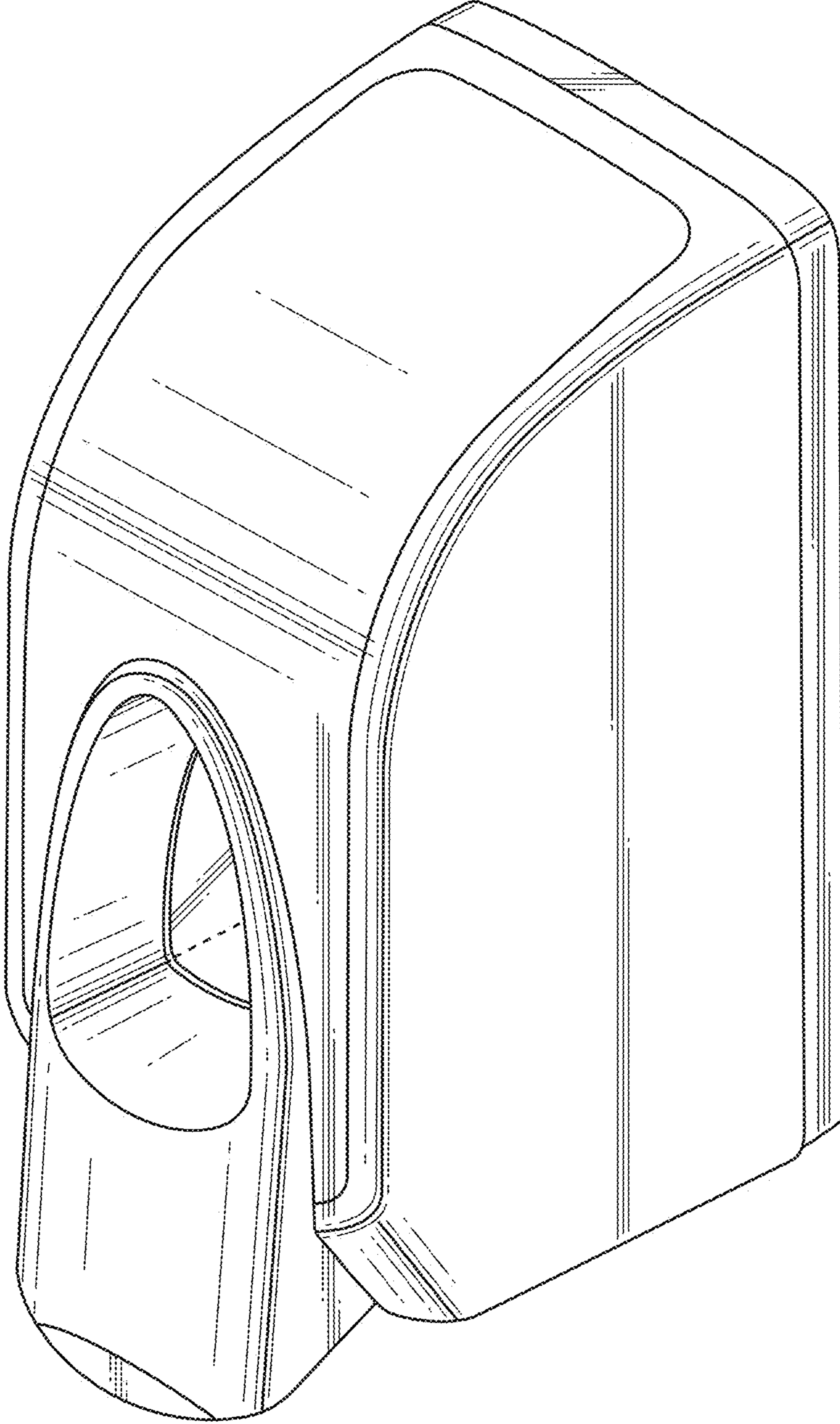

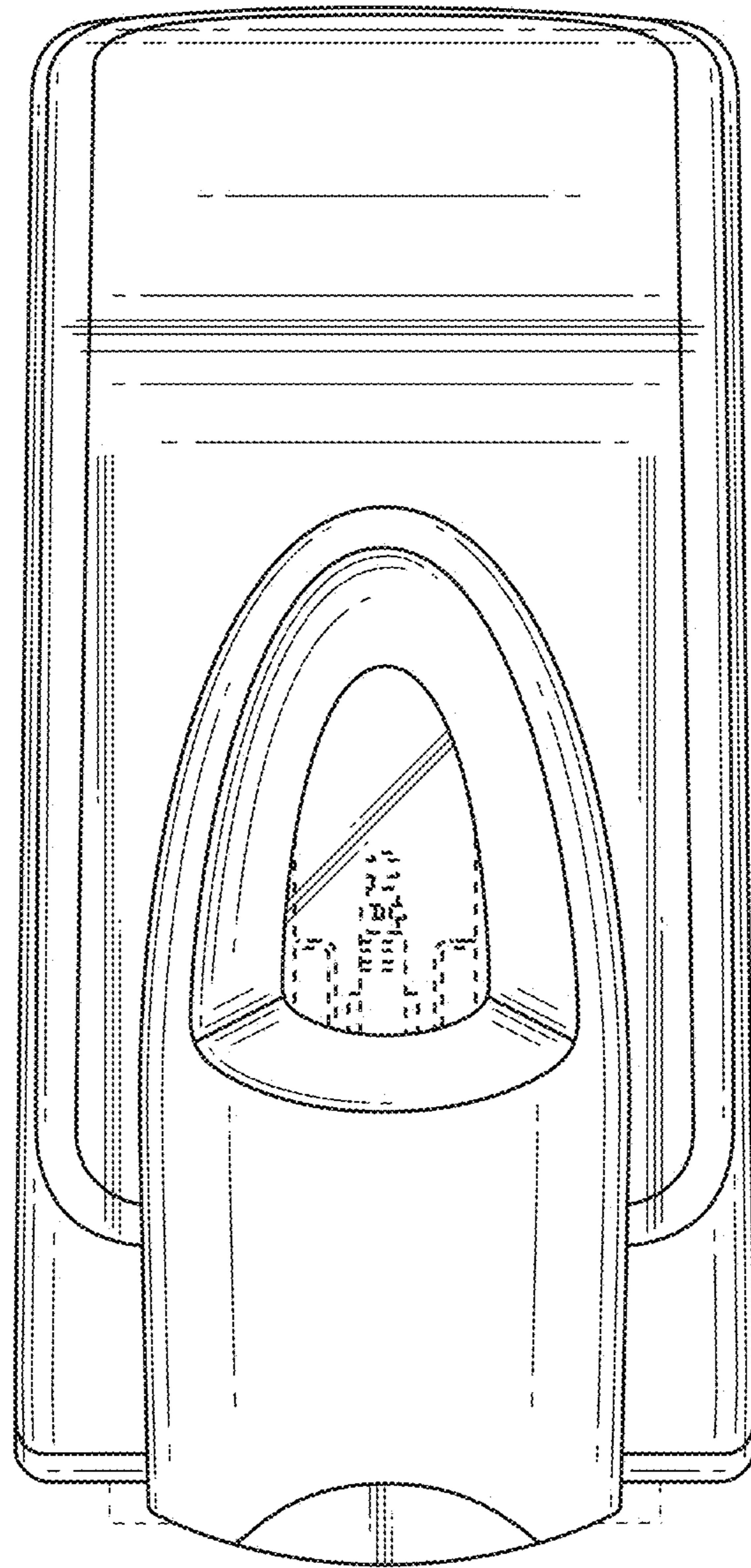

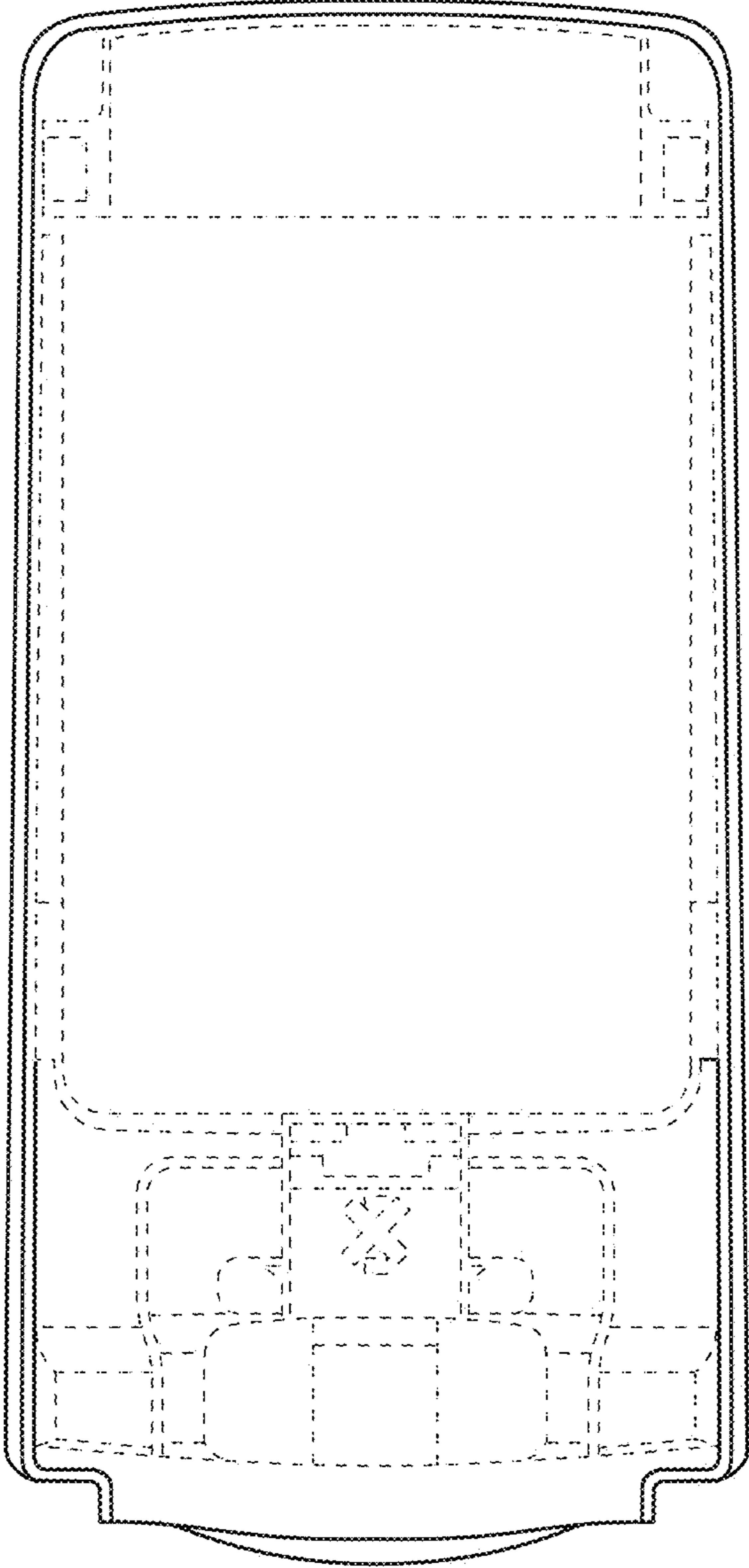

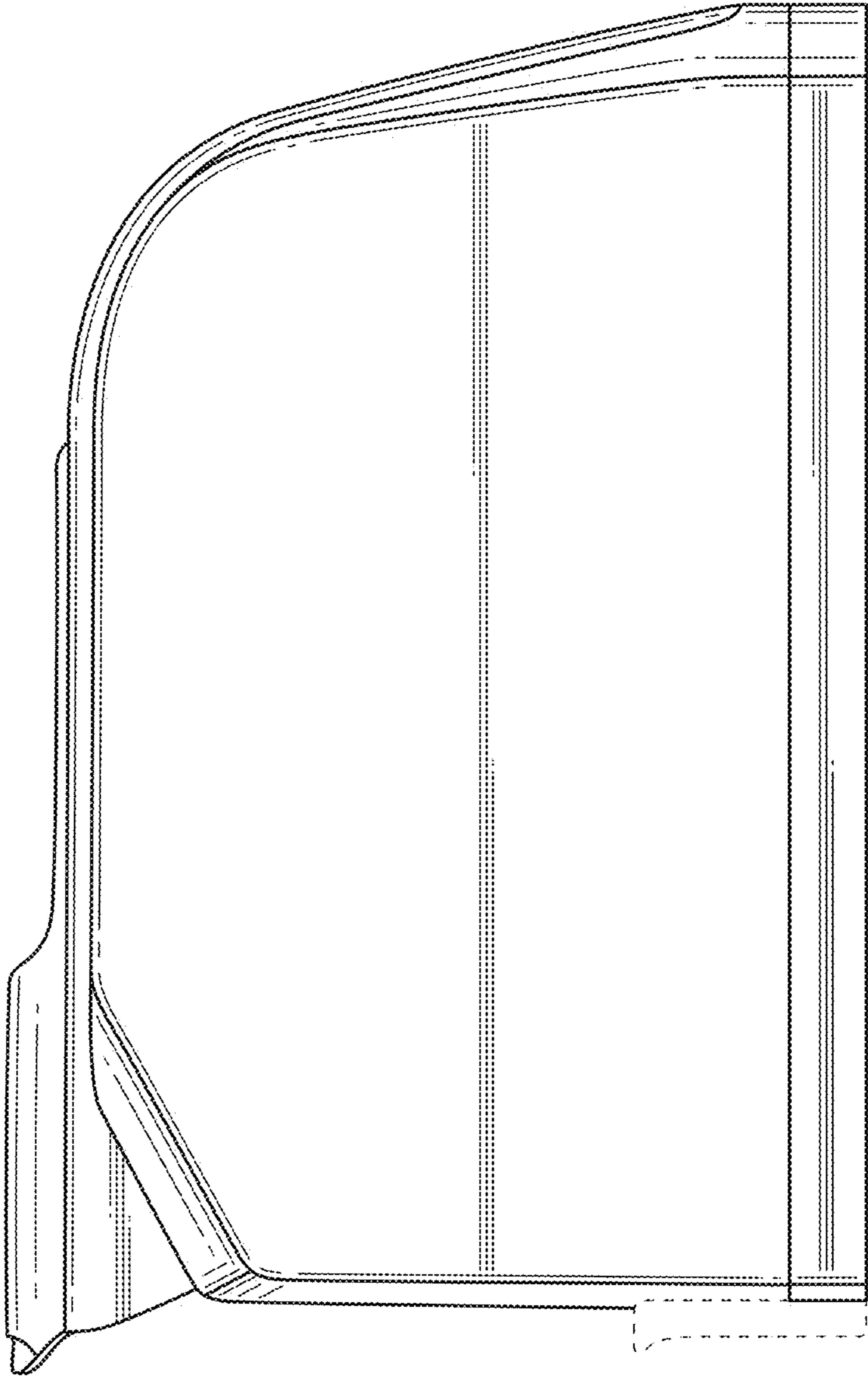

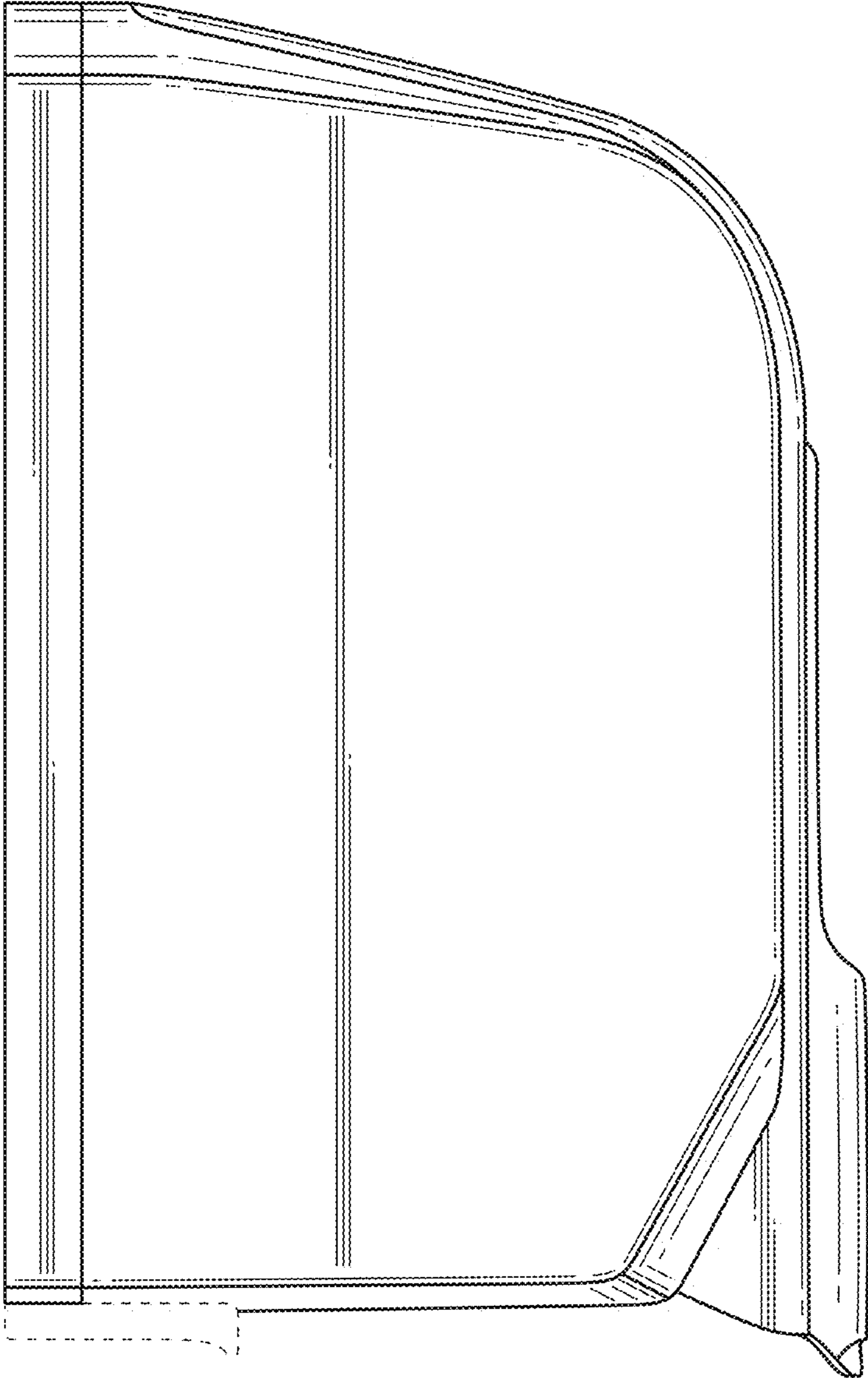

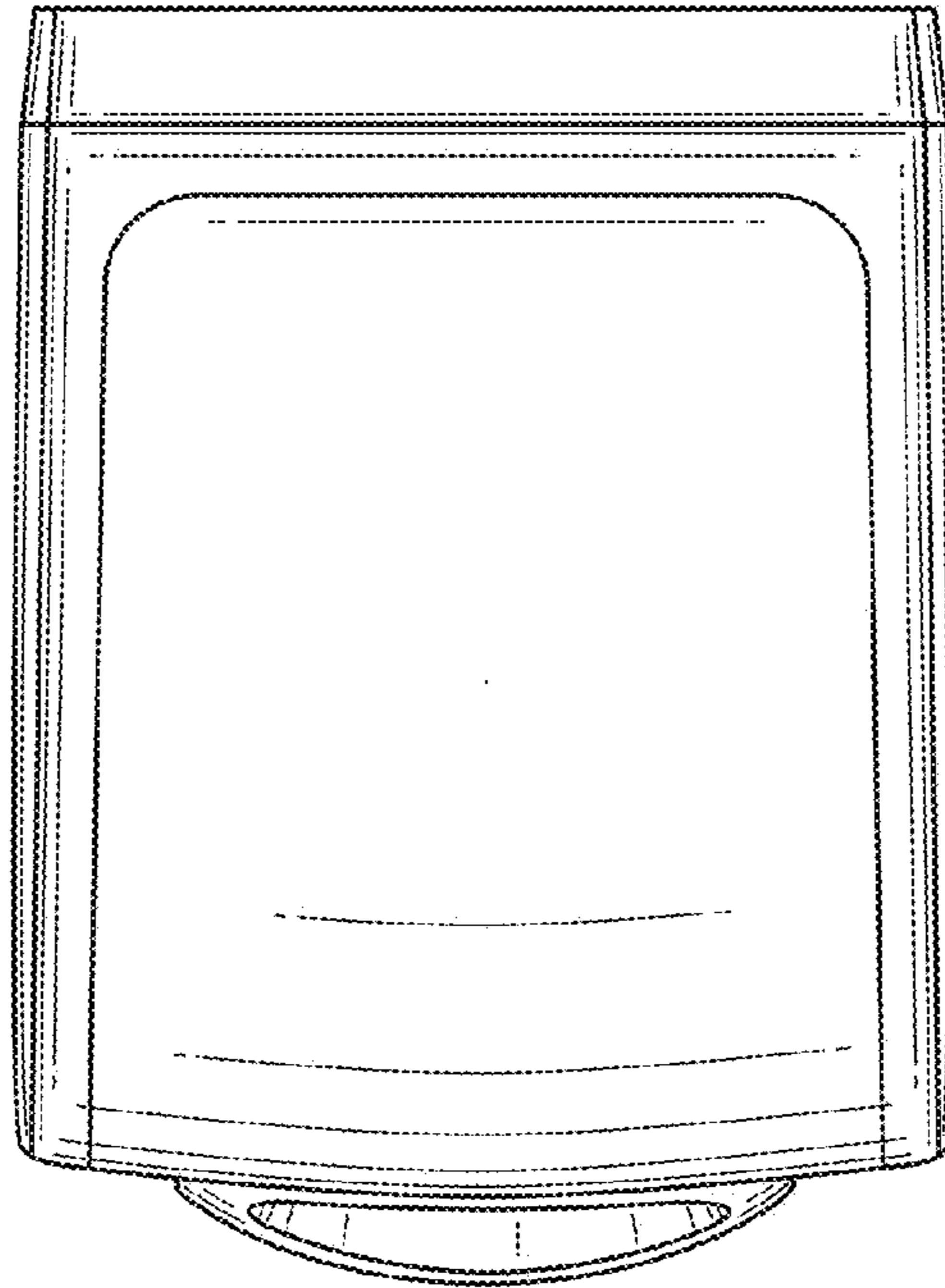

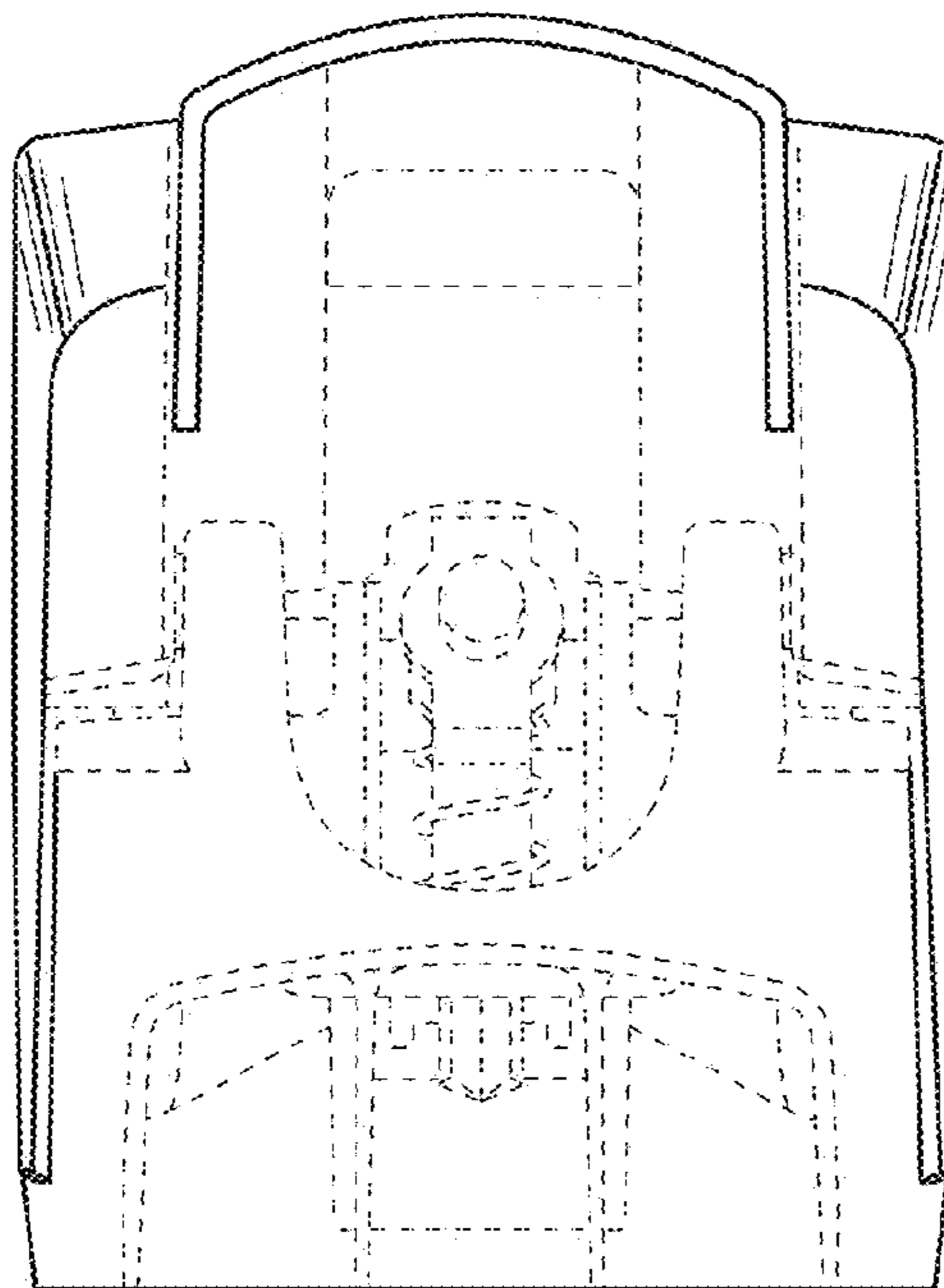
