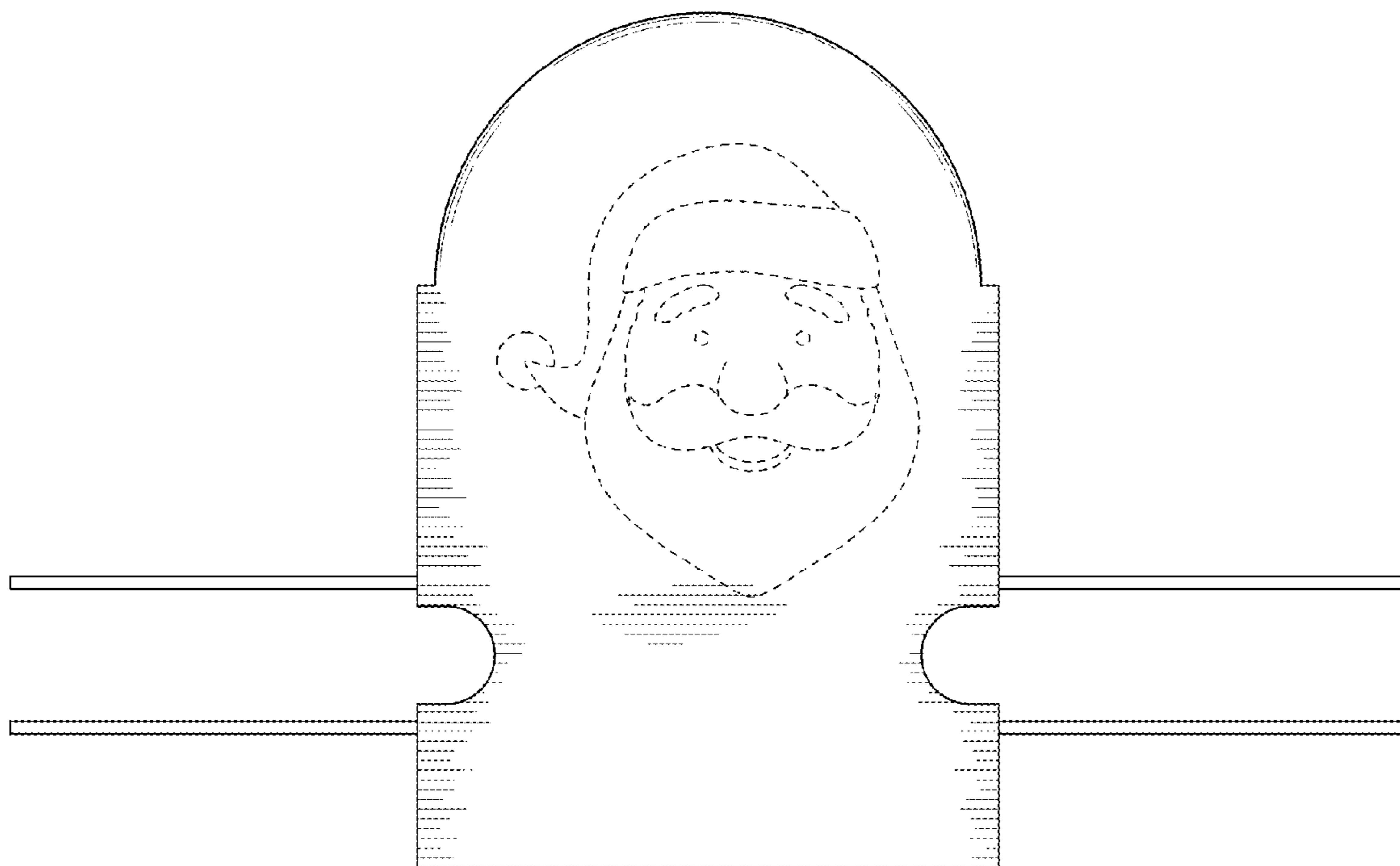
The ornamental design of a round top seatback cover, as shown and described.

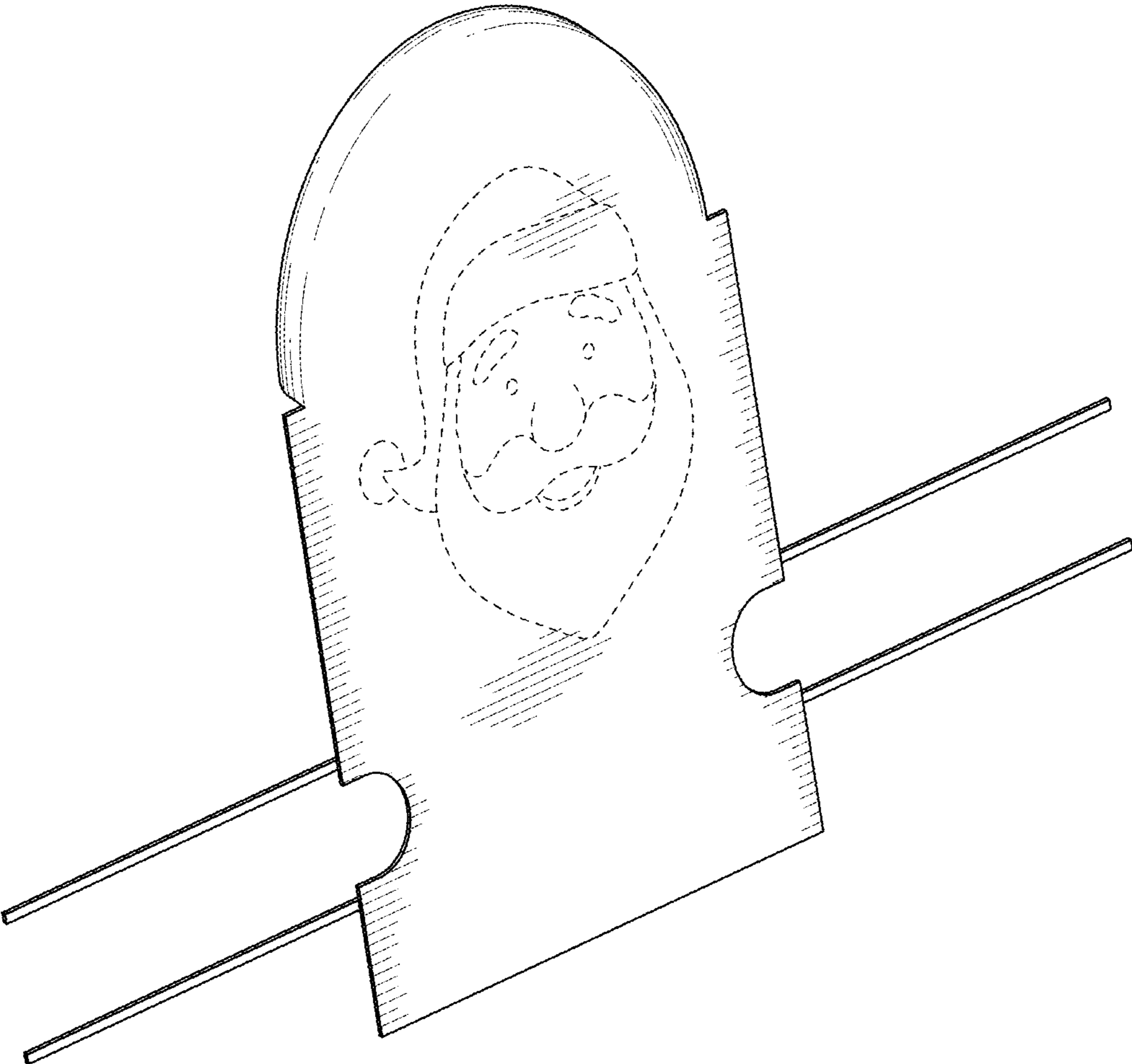
**DESCRIPTION**

FIGS. 8 and 9 are perspective views illustrating an example of the round top seatback cover when attached to an Adirondack chair.

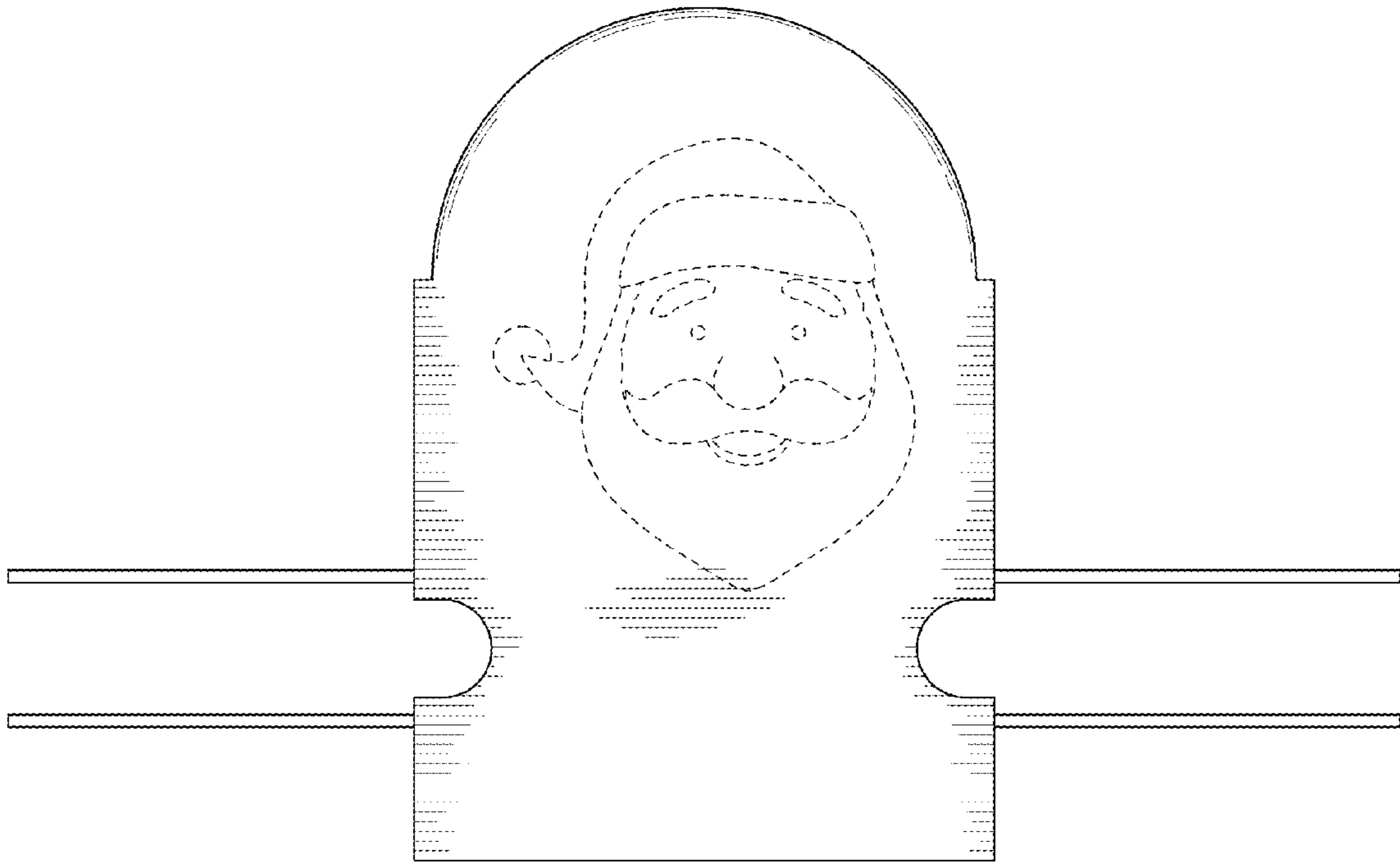
The broken line showing portions of the round top seatback cover in the figures is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

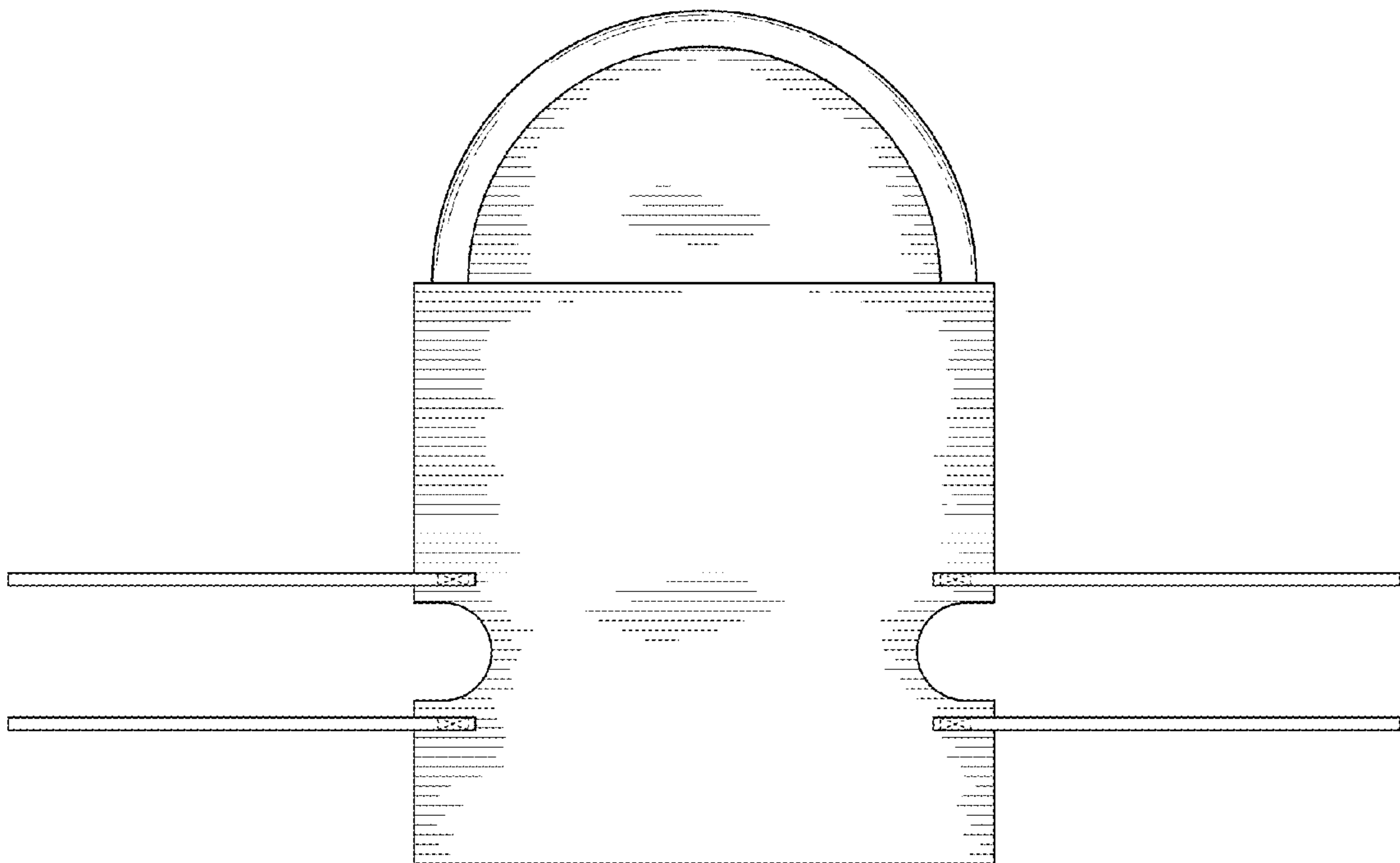




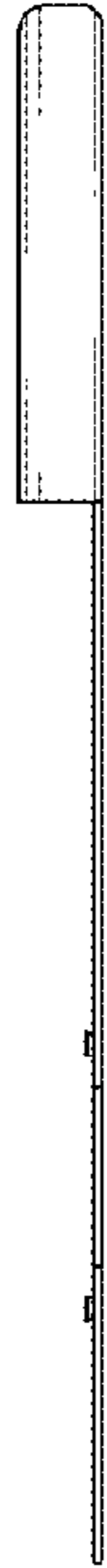

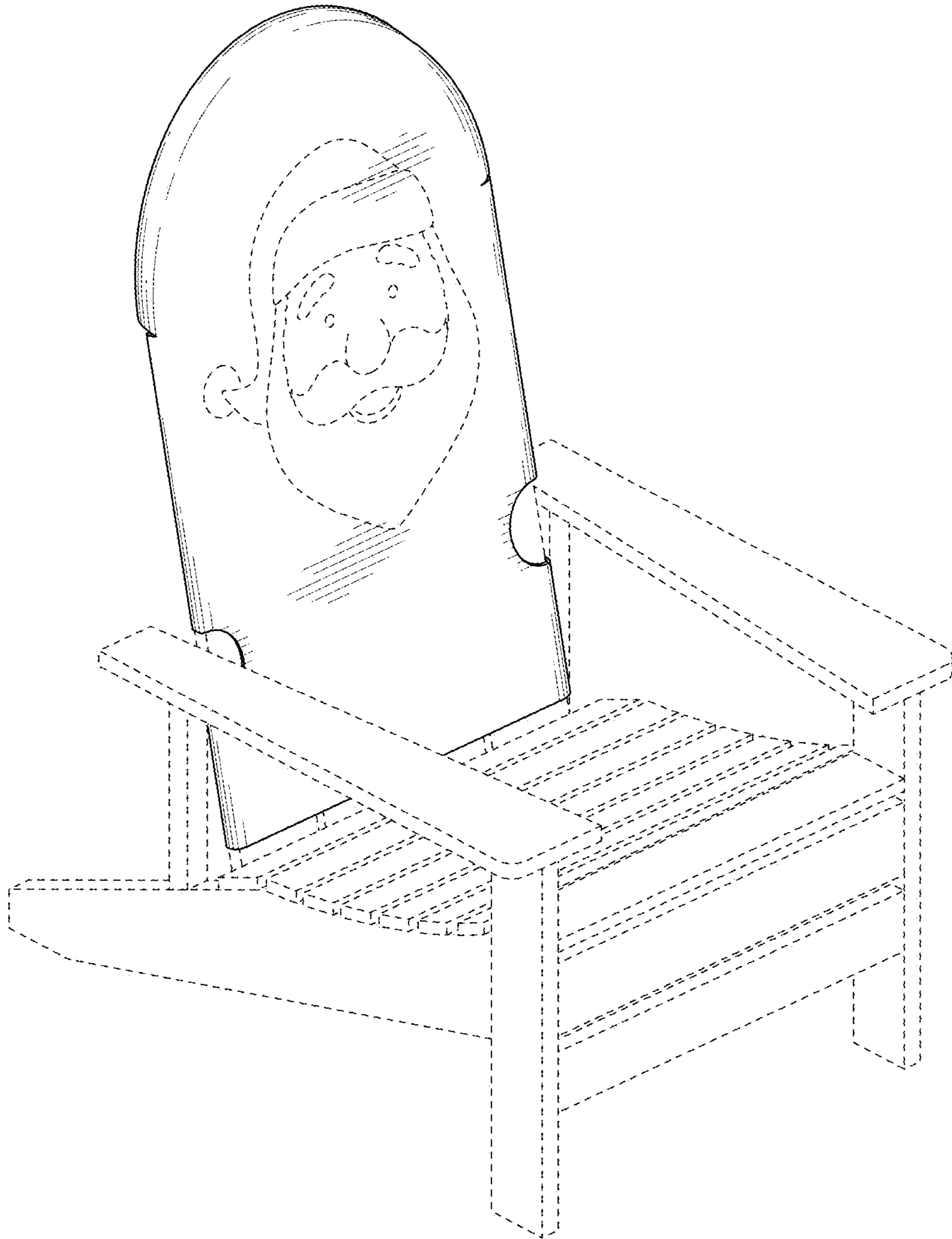

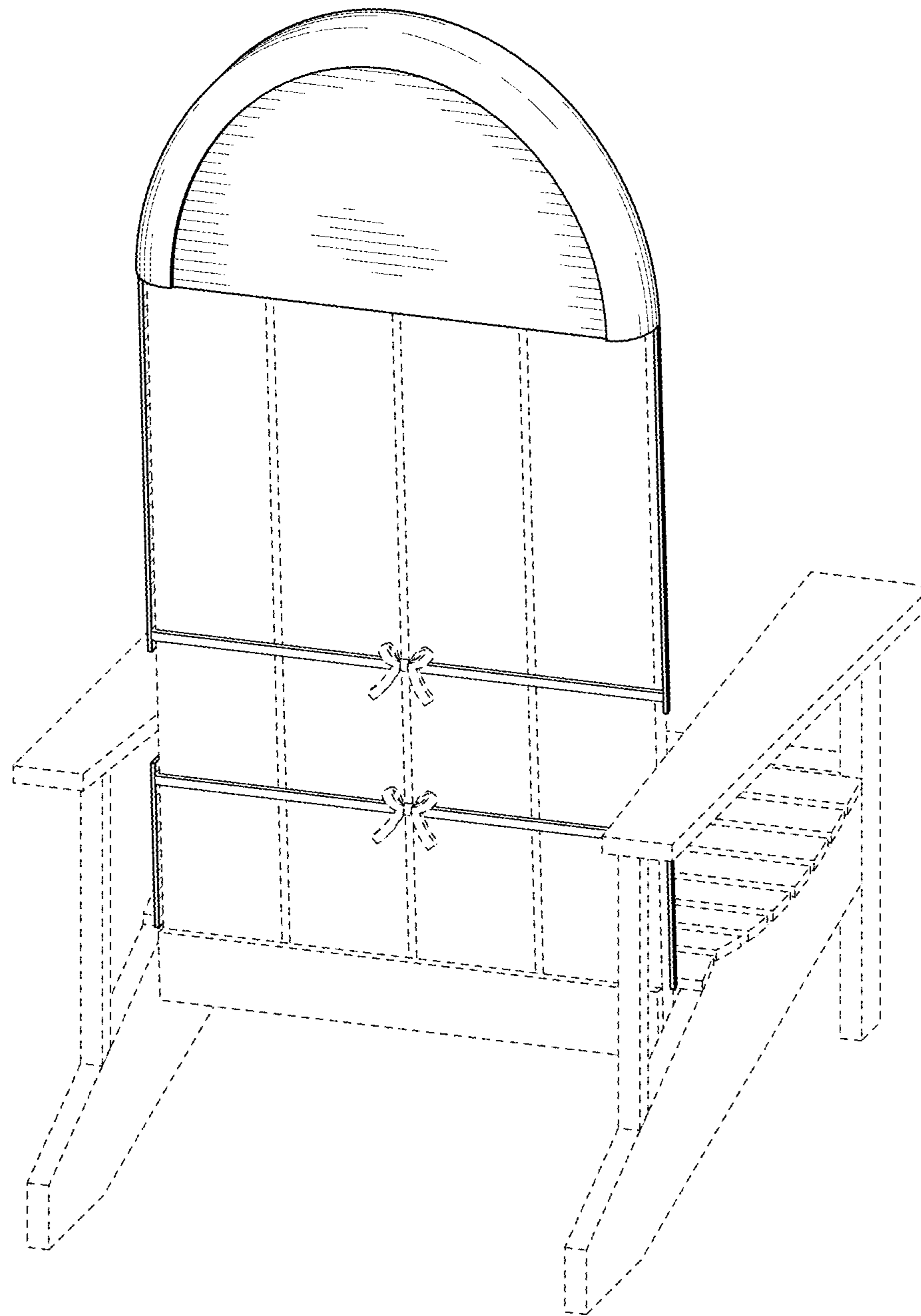
