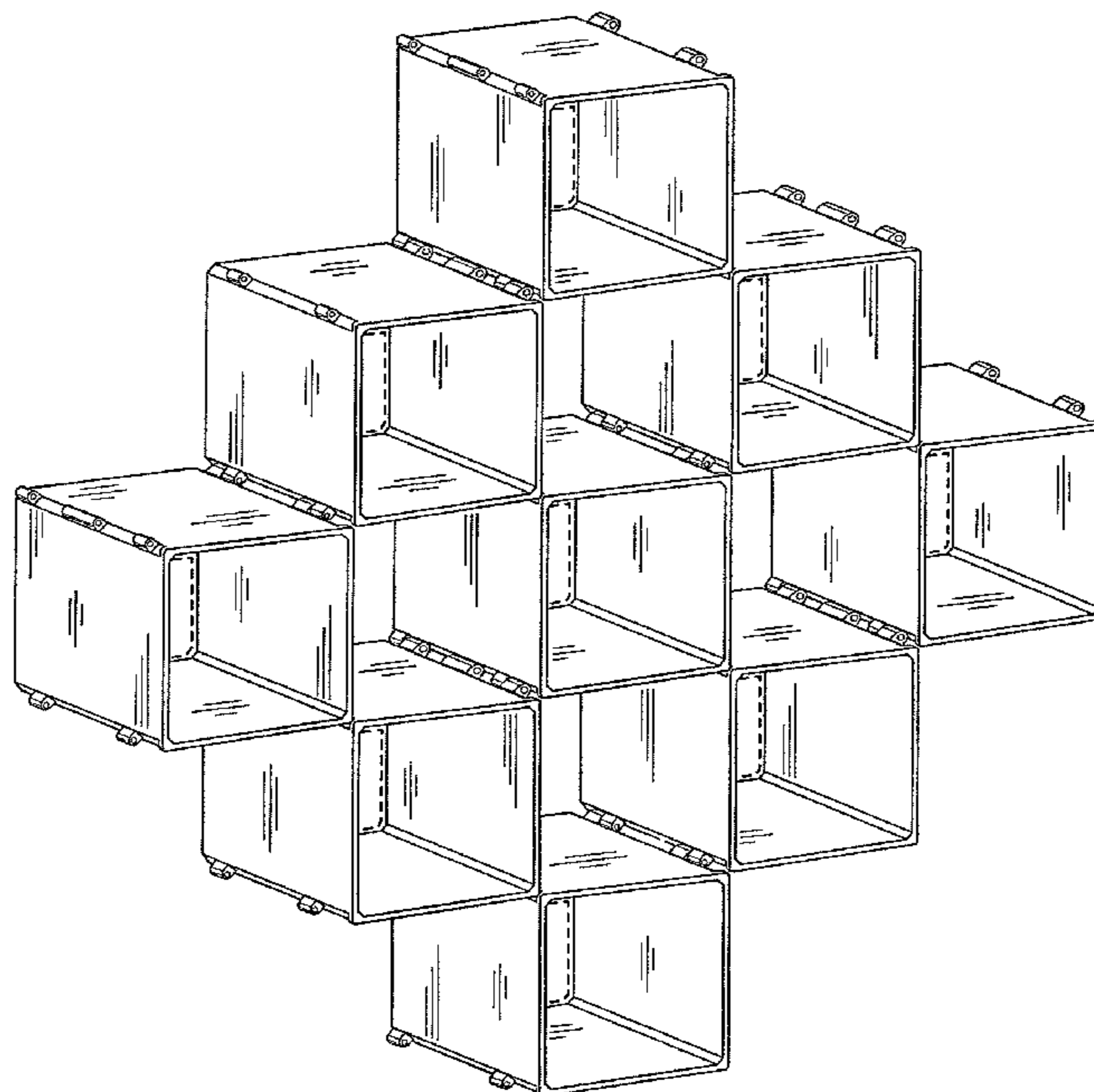
CLAIM

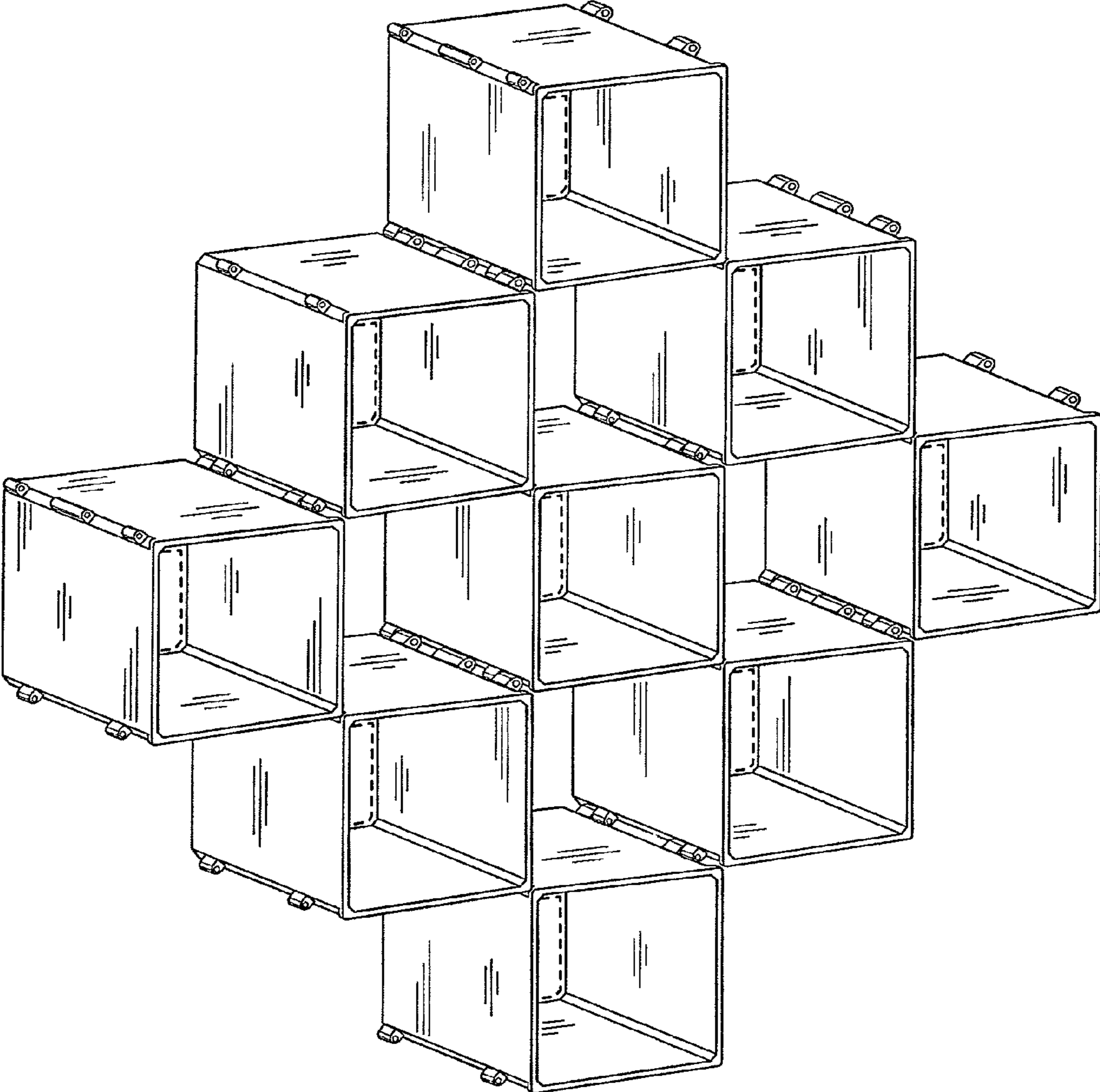

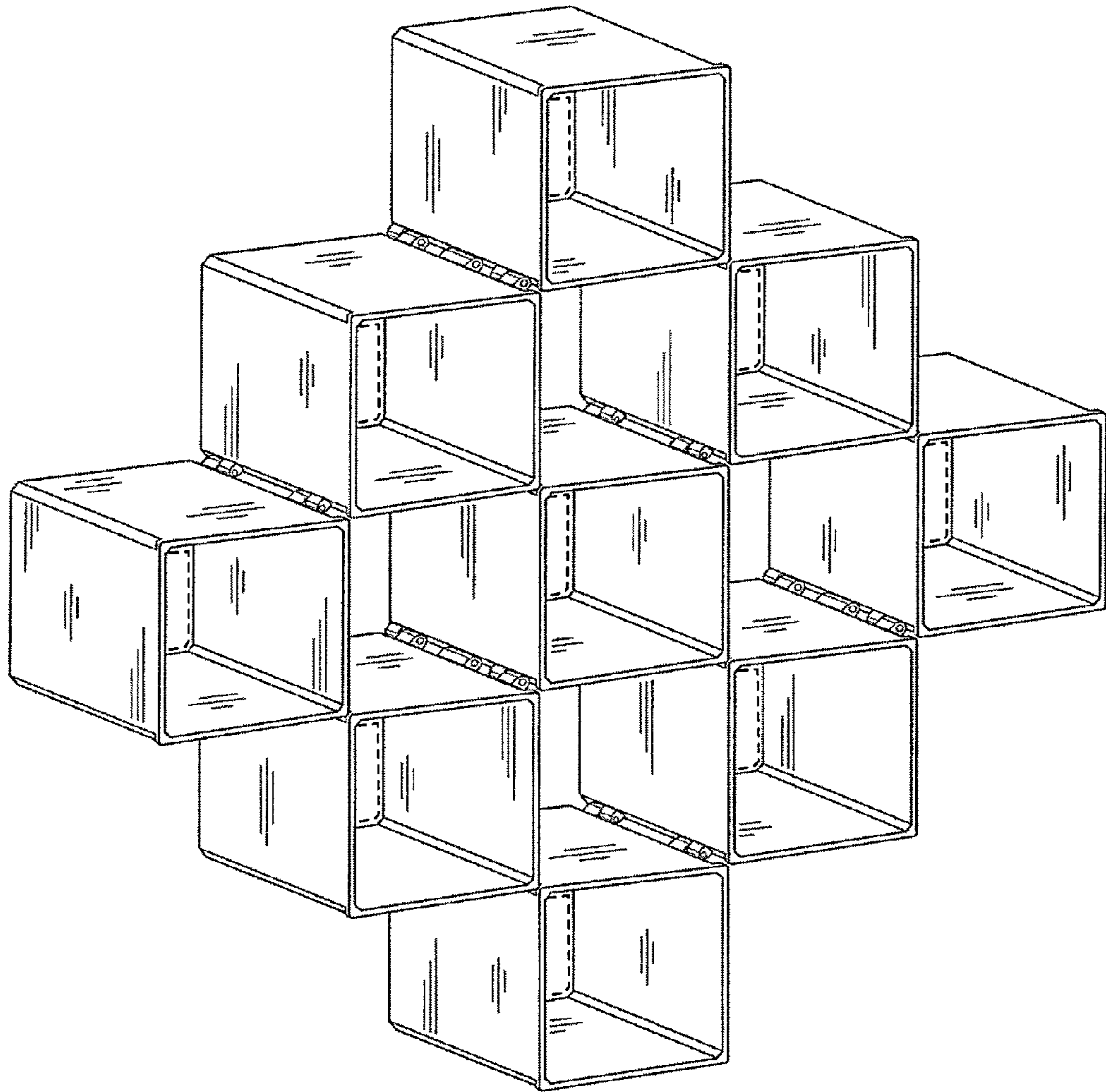
