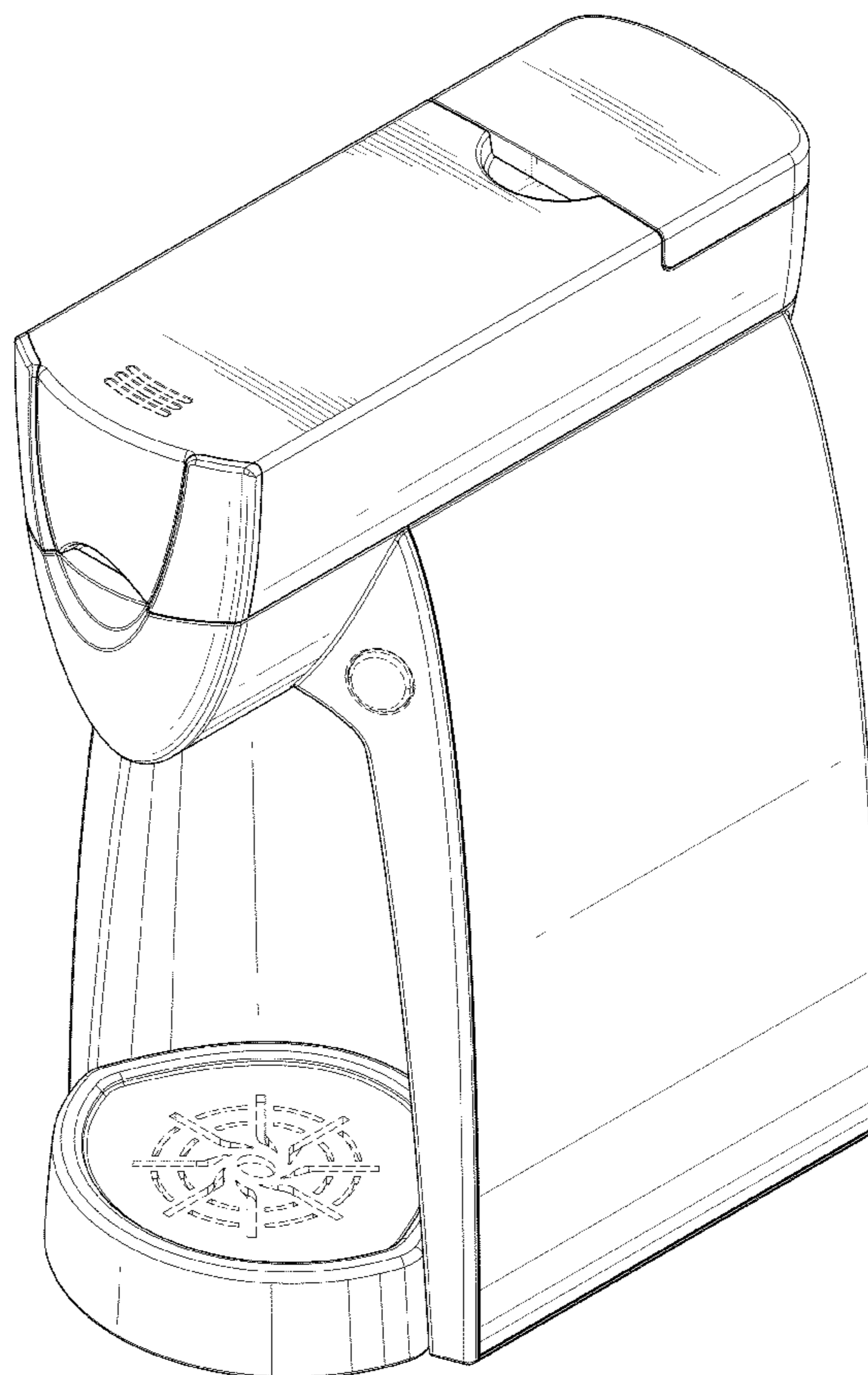
(57) **CLAIM**

The ornamental design for a coffee brewer, as shown.

DESCRIPTION

FIG. 1 is a perspective view showing the front, top and right sides of the coffee brewer;
FIG. 2 is a front elevation view of the coffee brewer;
FIG. 3 is a right side elevation view of the coffee brewer;
FIG. 4 is a left side elevation view of the coffee brewer;
FIG. 5 is a rear elevation view of the coffee brewer;

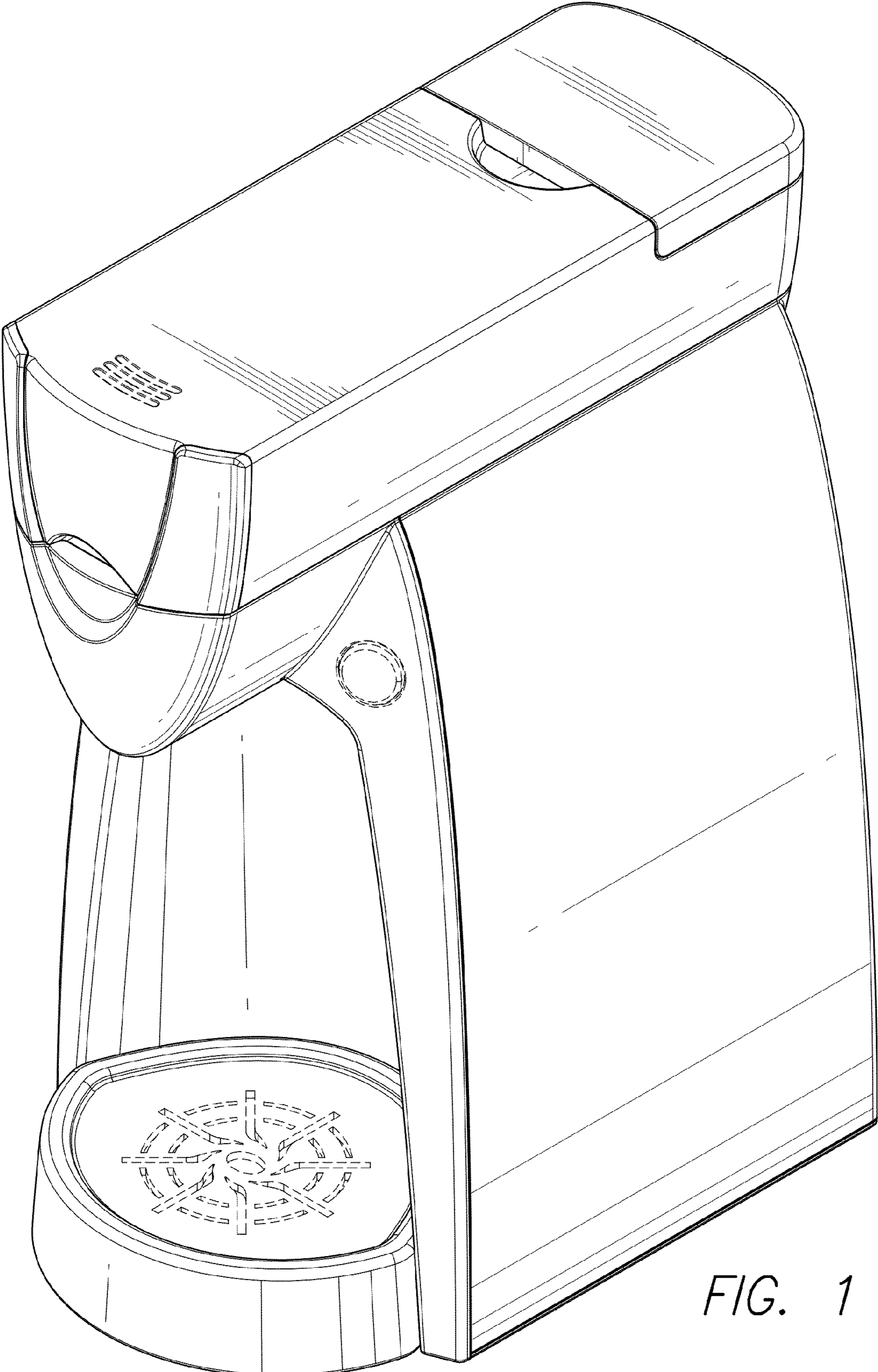

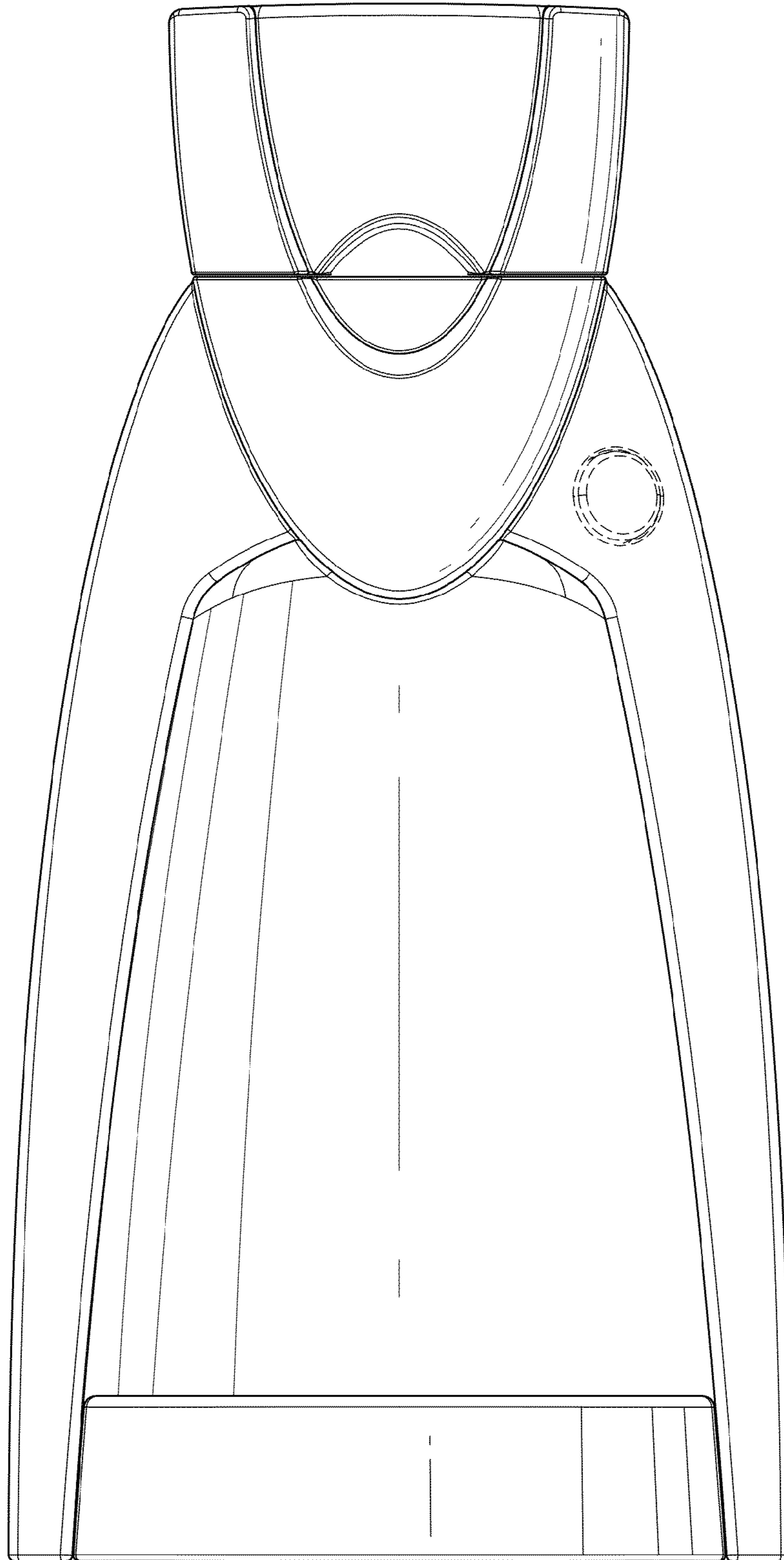

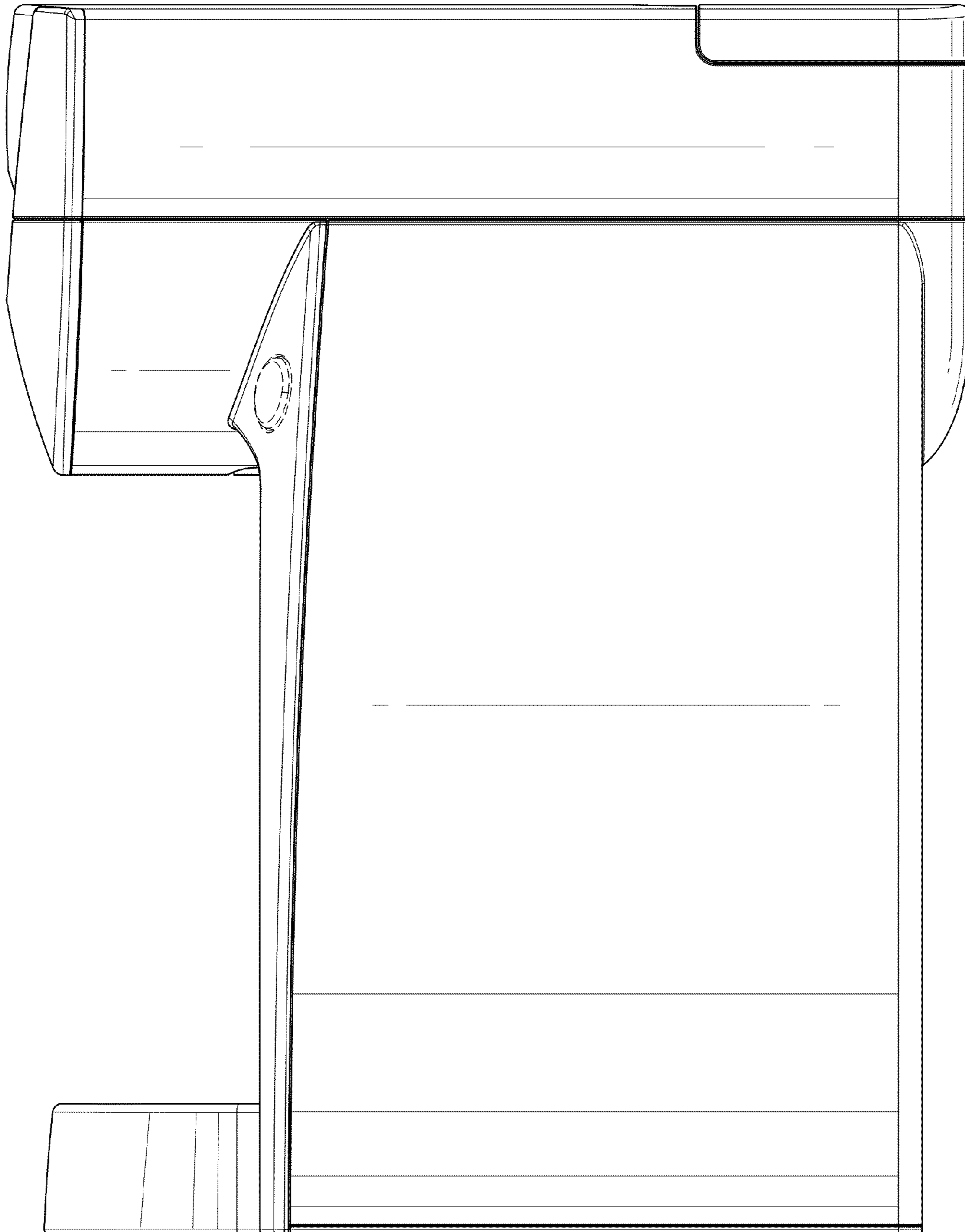

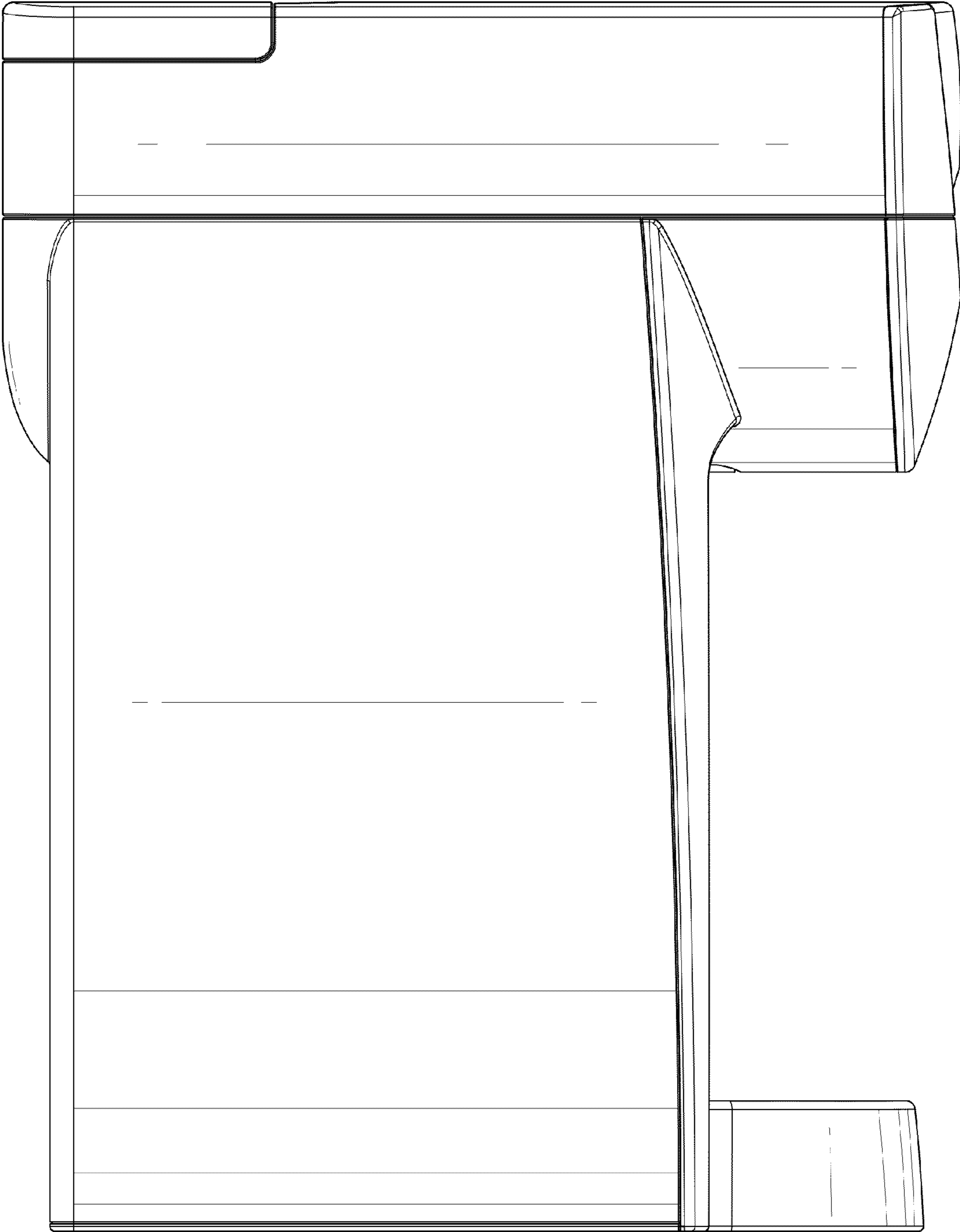

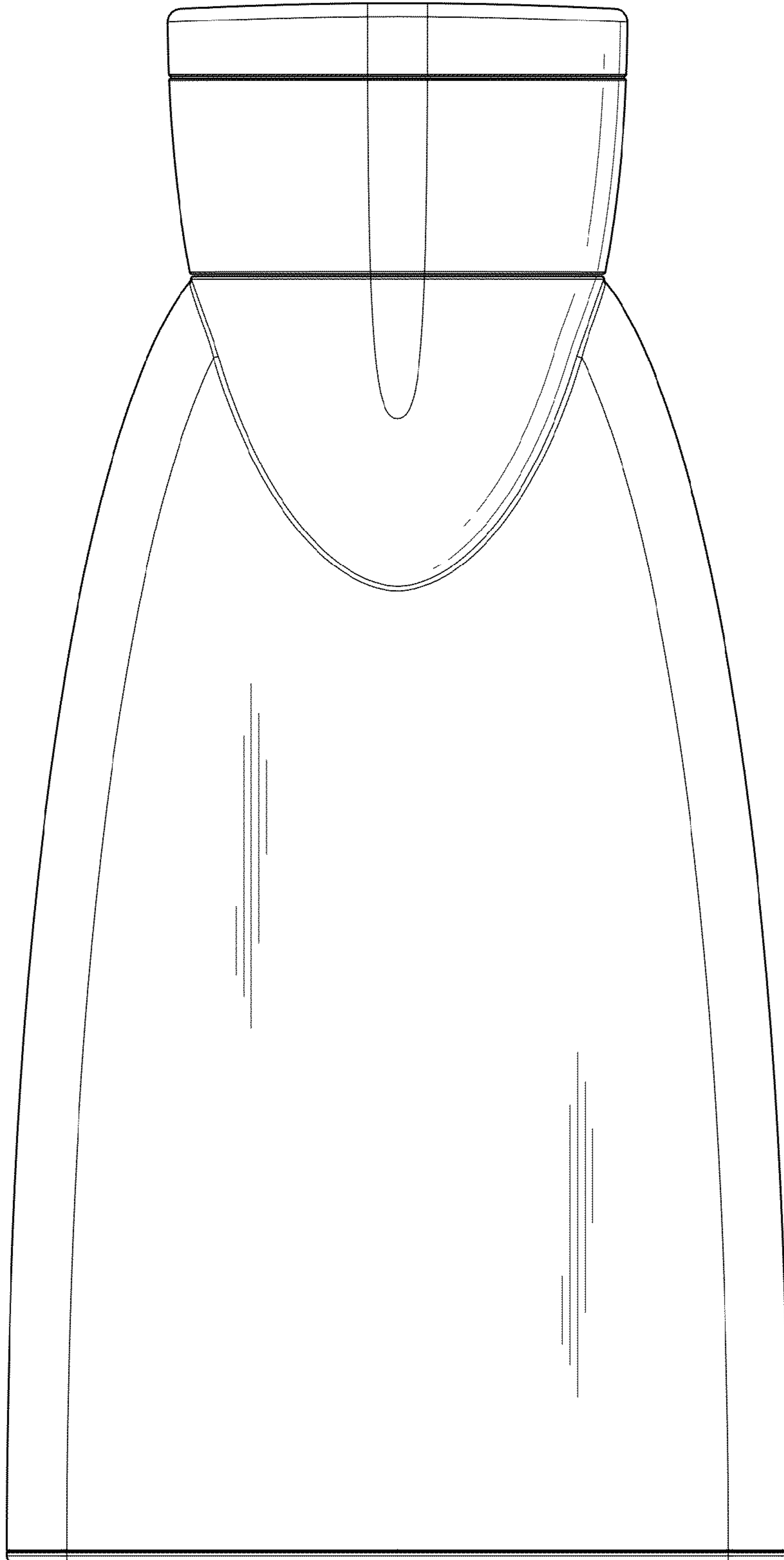

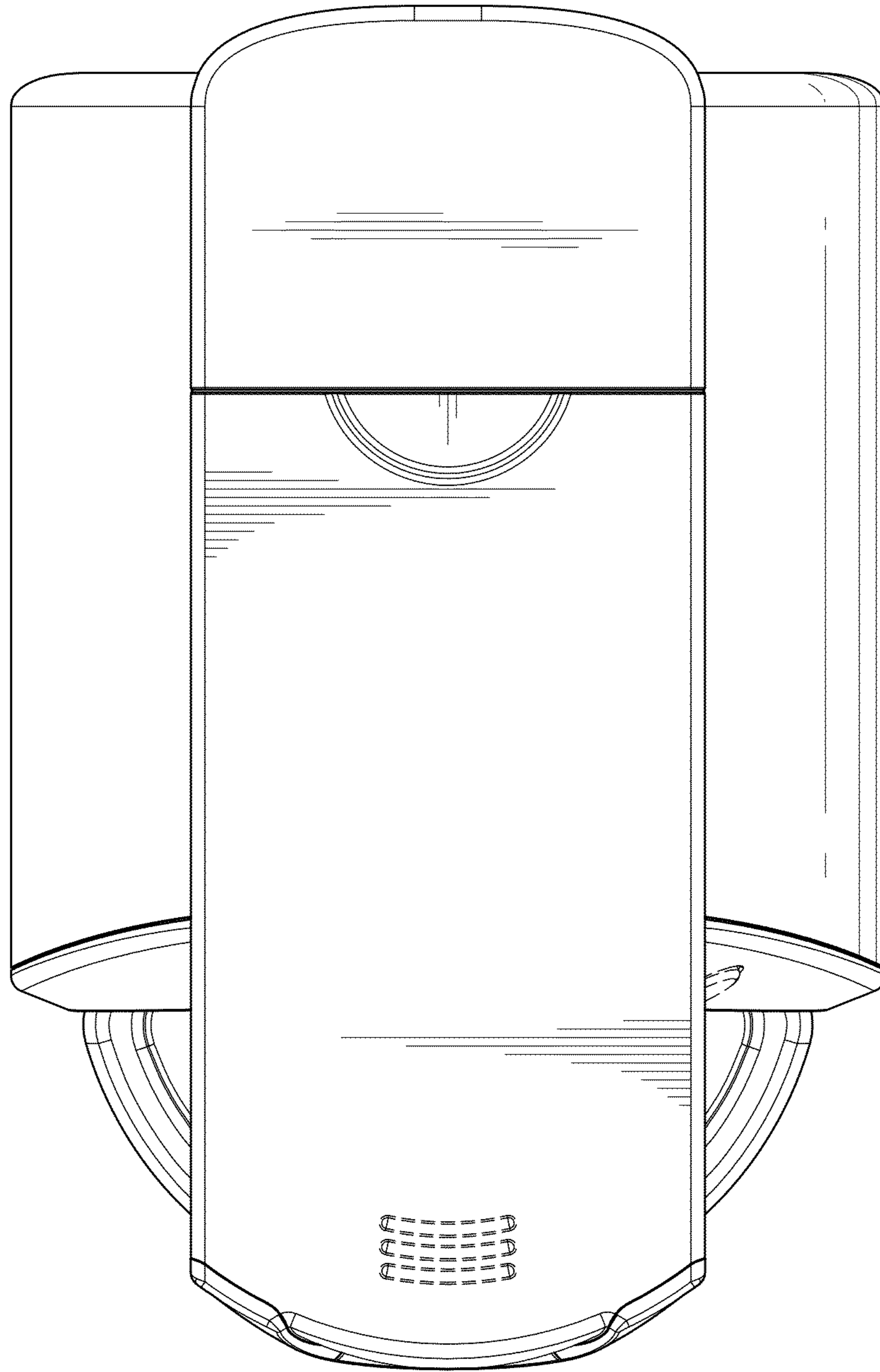

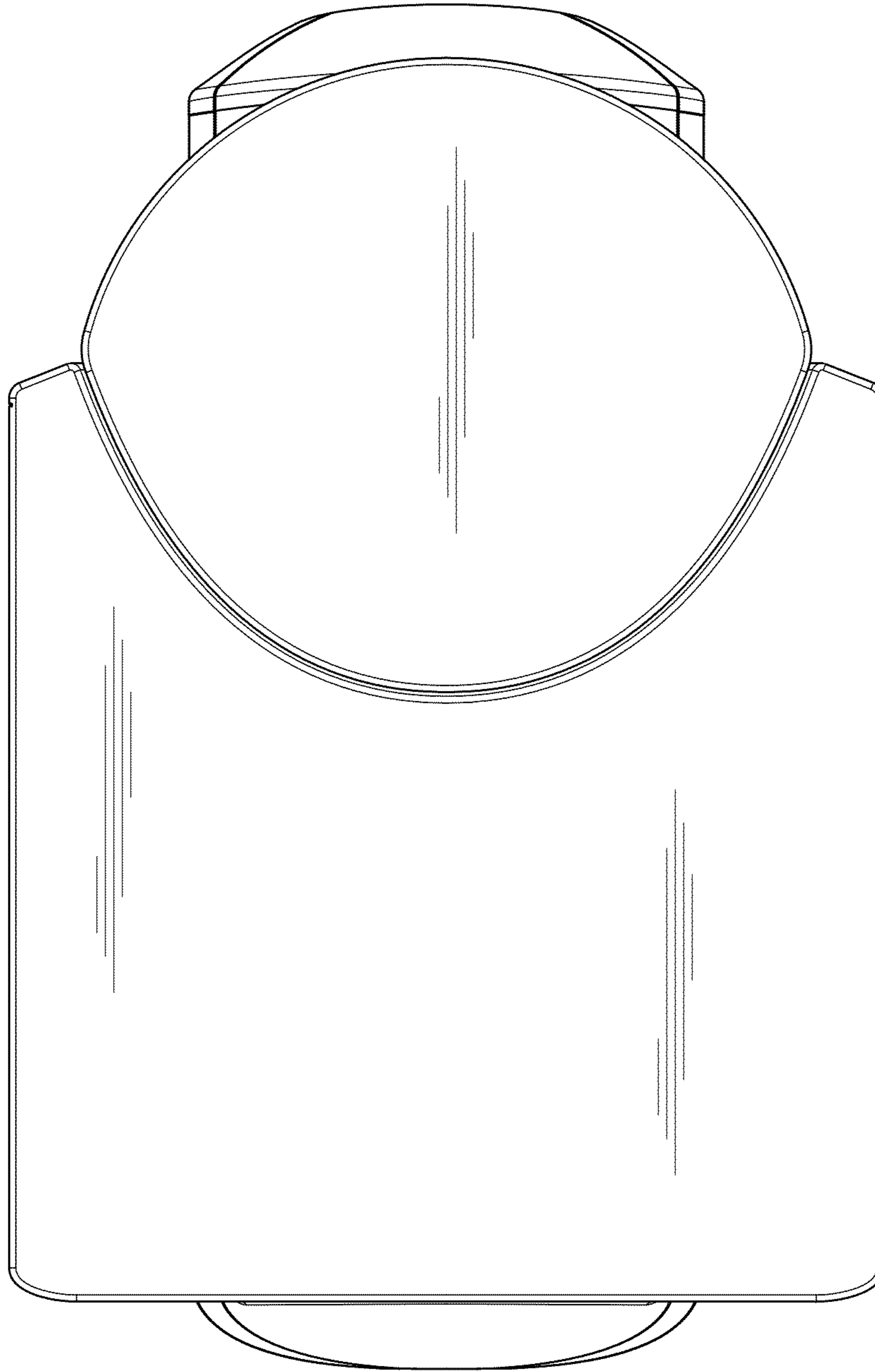
