(57) **CLAIM**

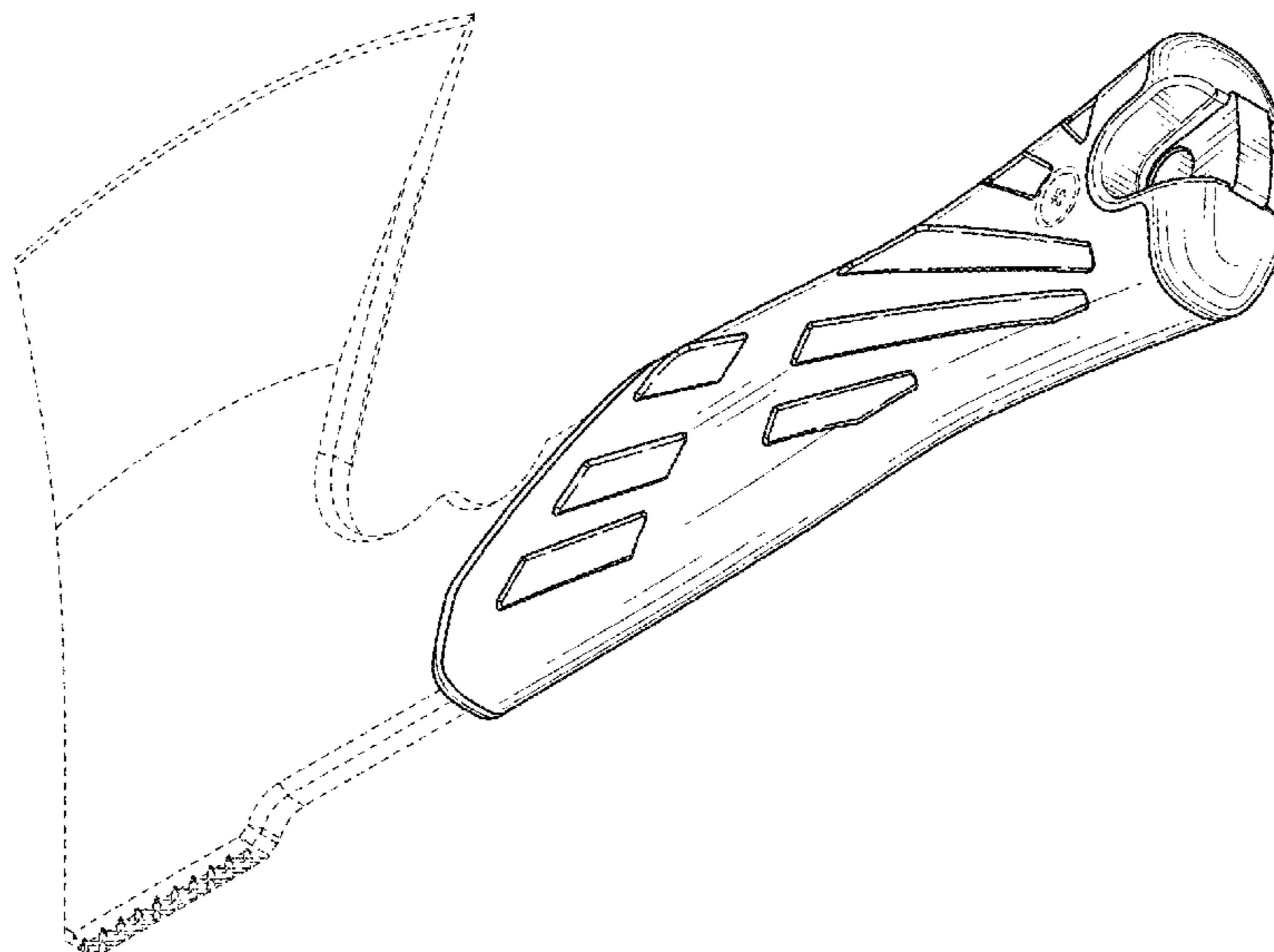
We claim the ornamental design for a hatchet, as shown and described.

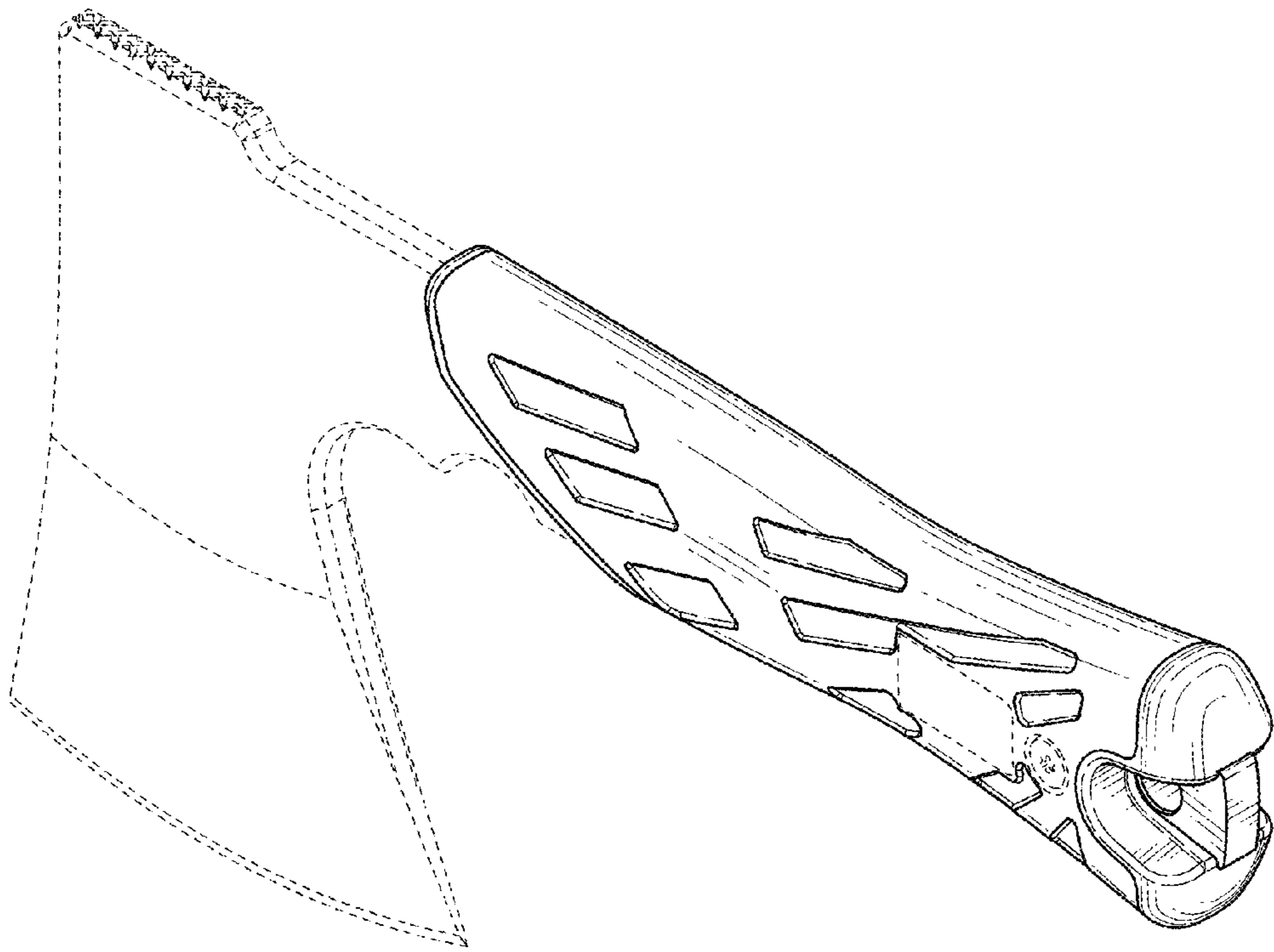

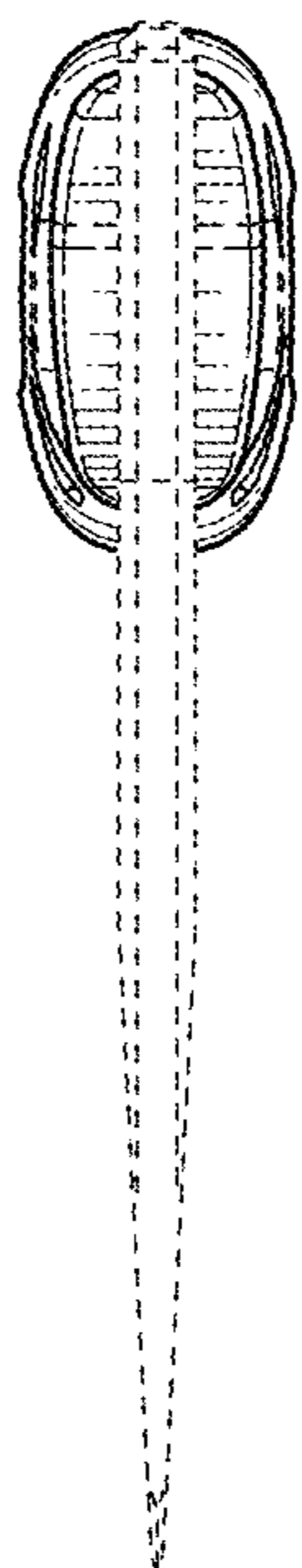

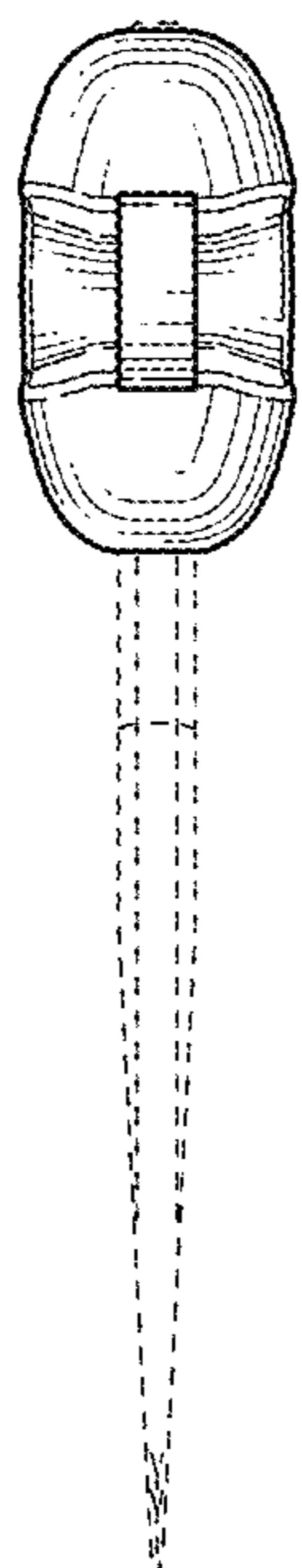

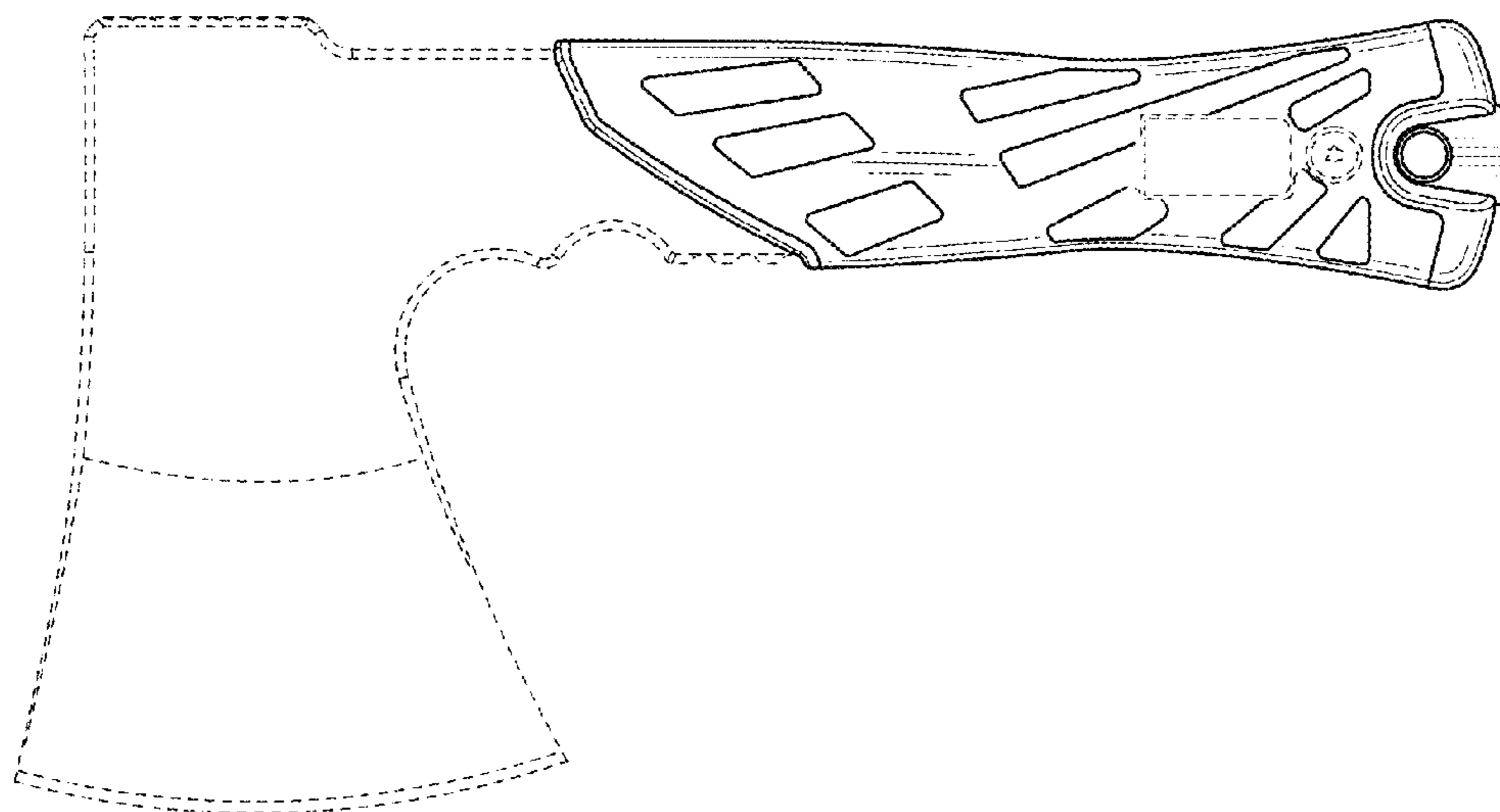

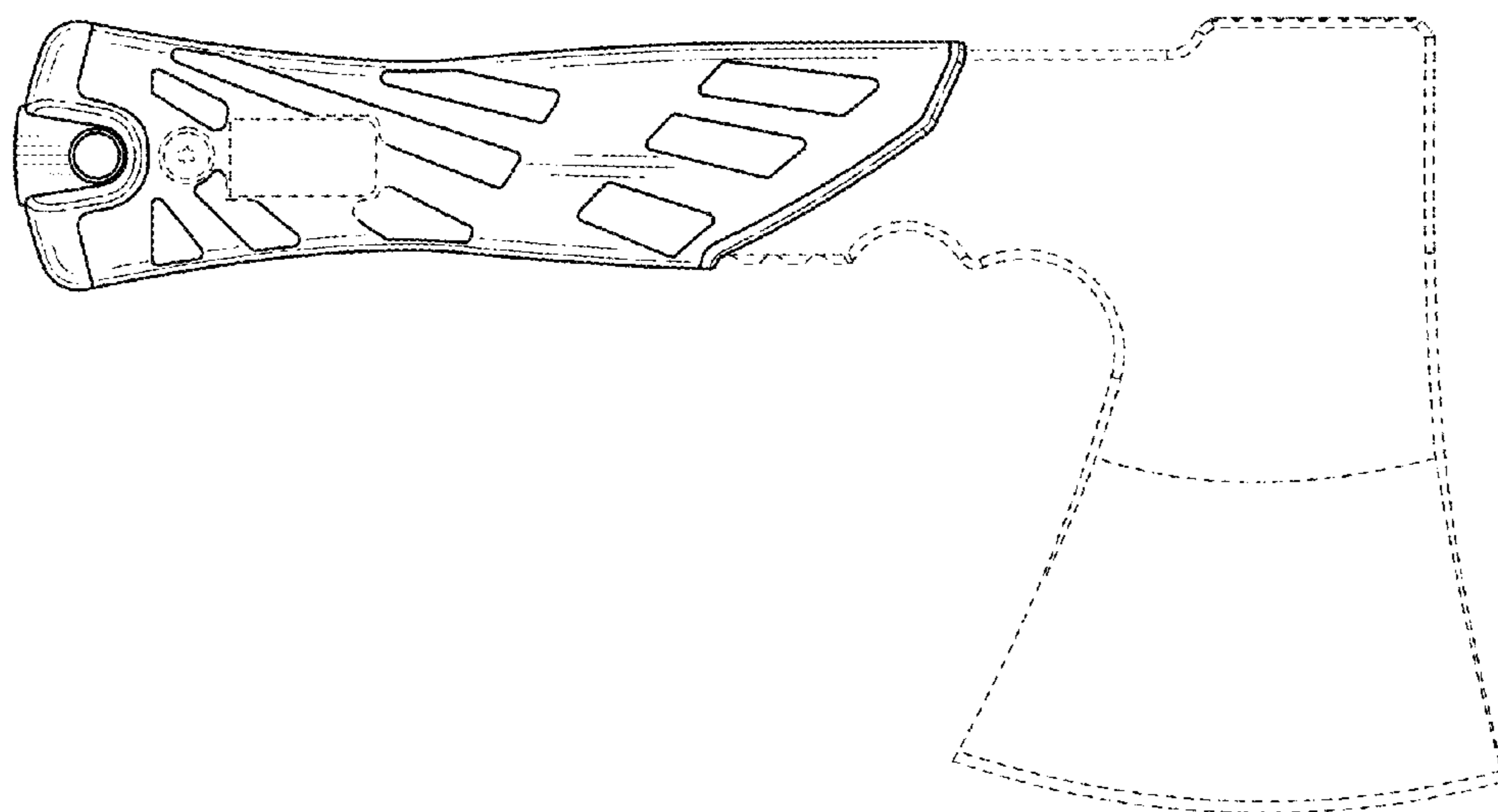

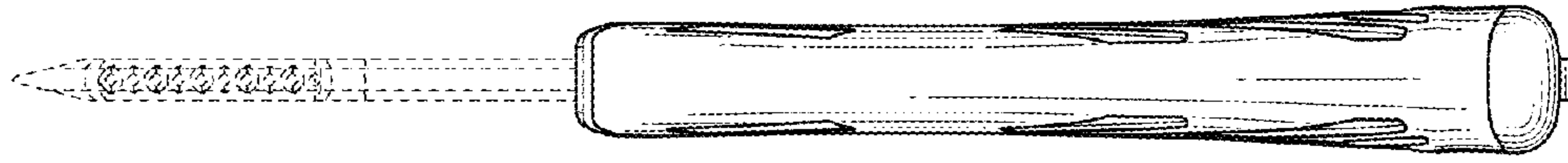

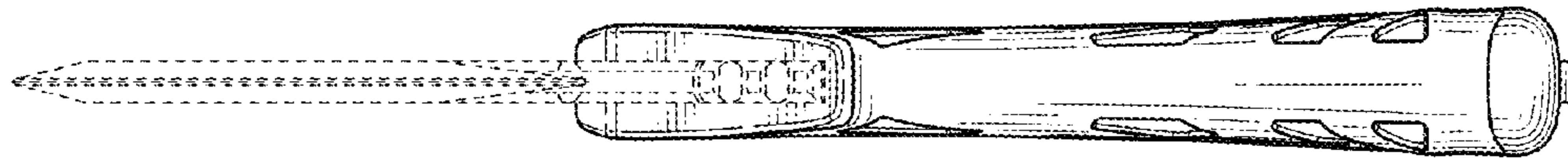

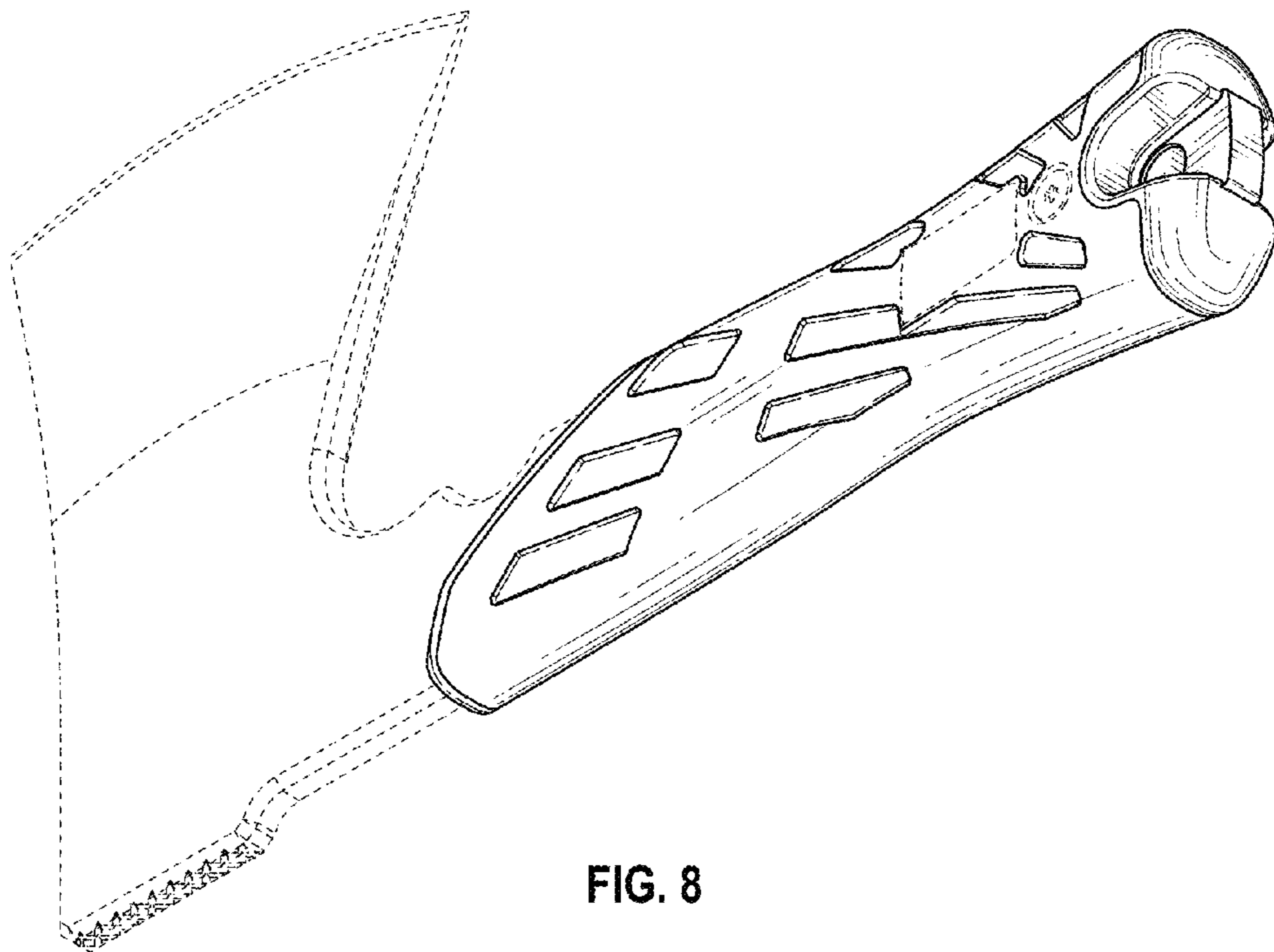

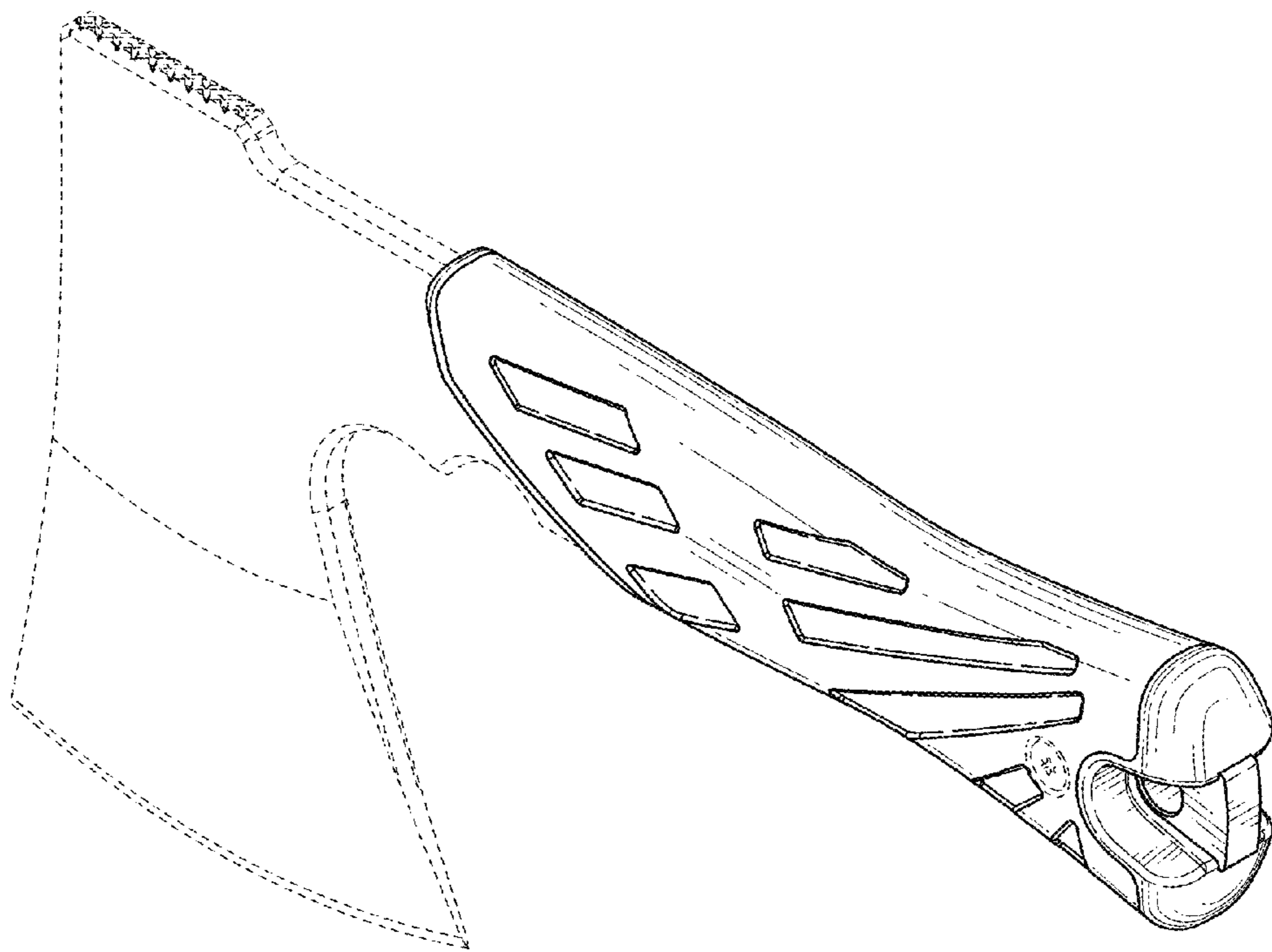

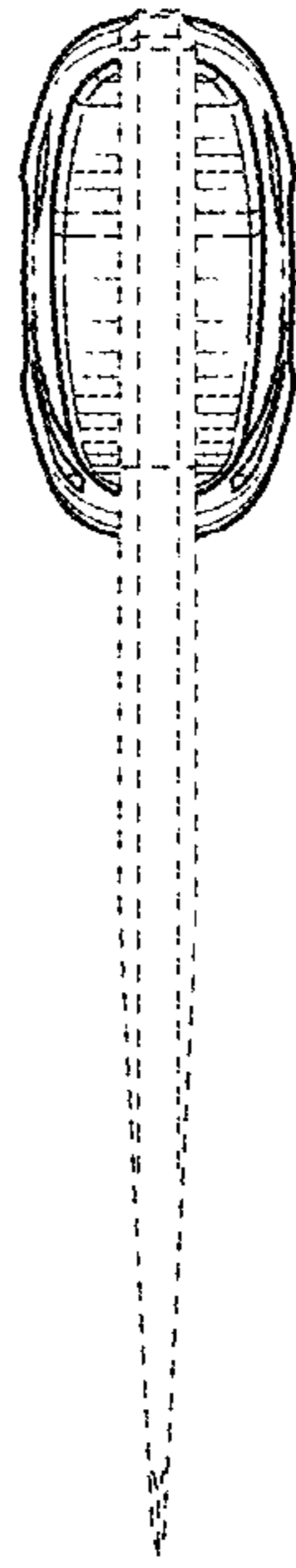

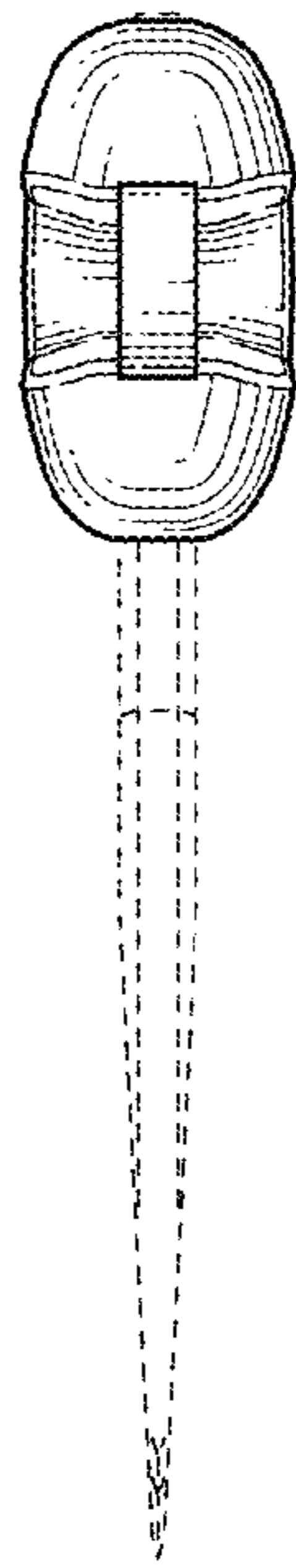

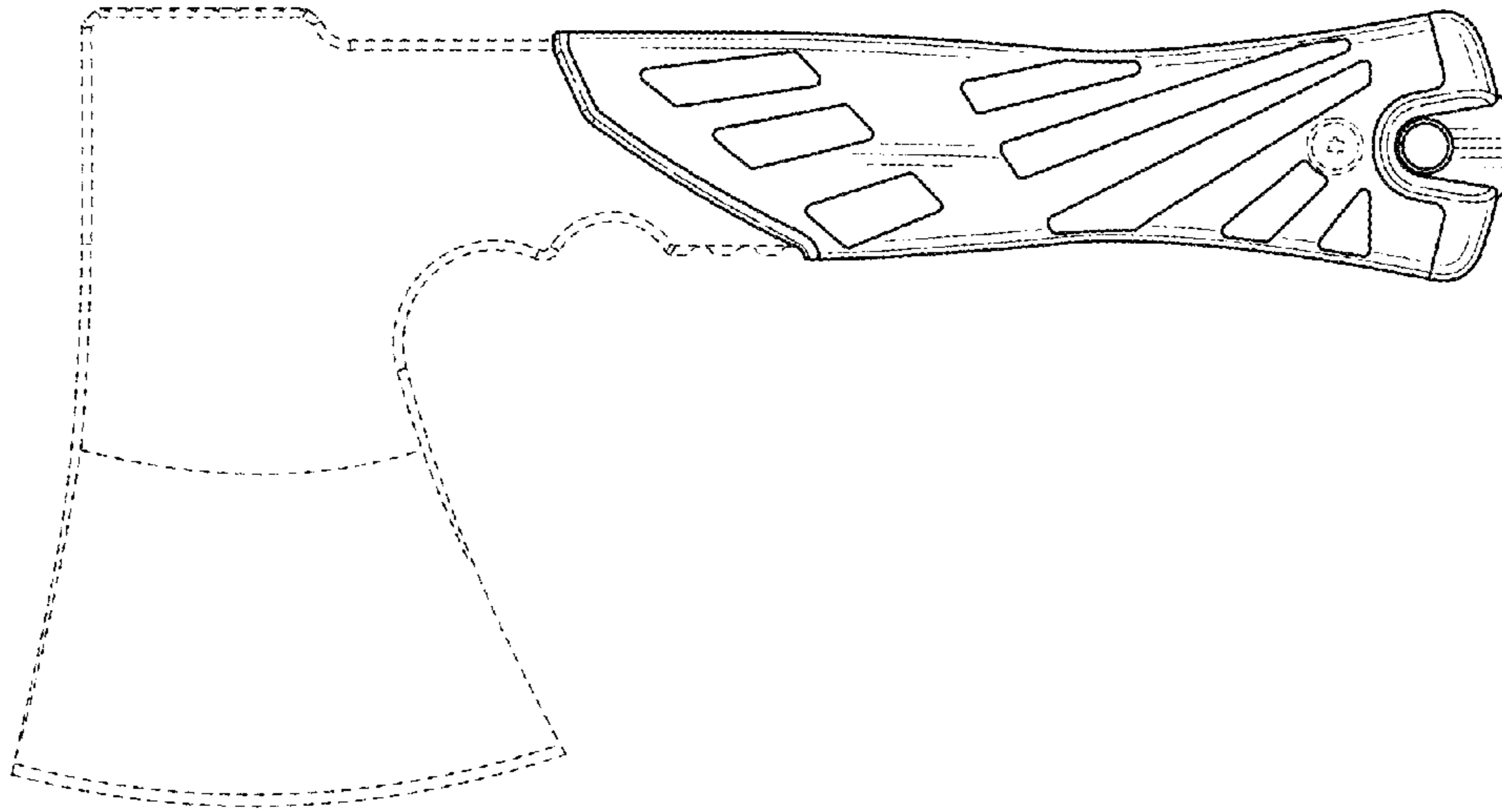

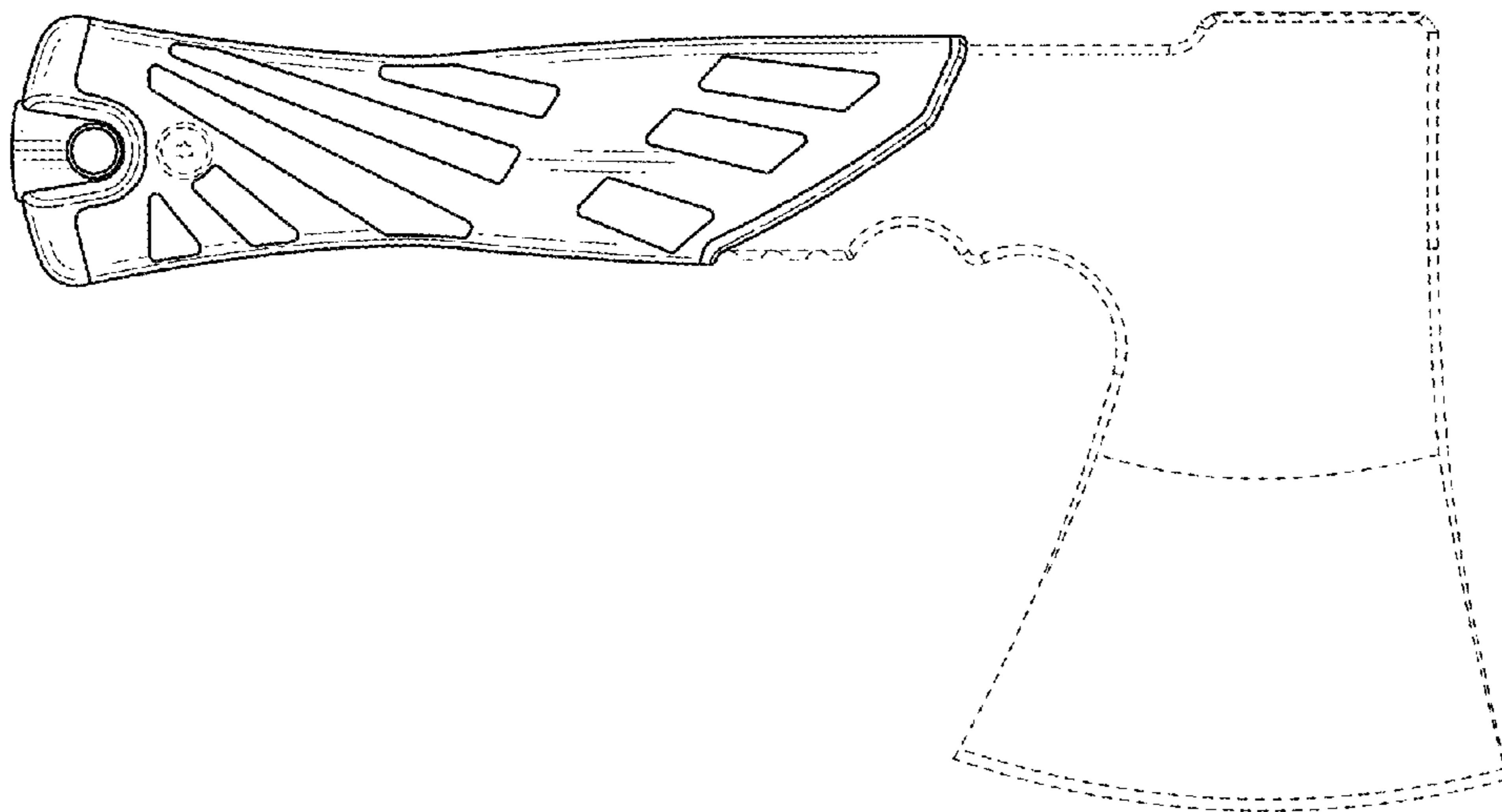

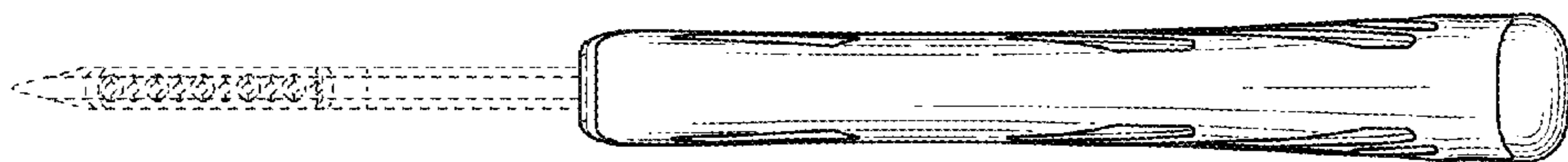

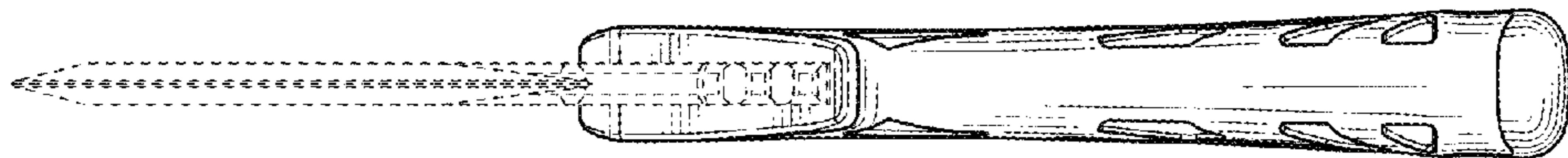

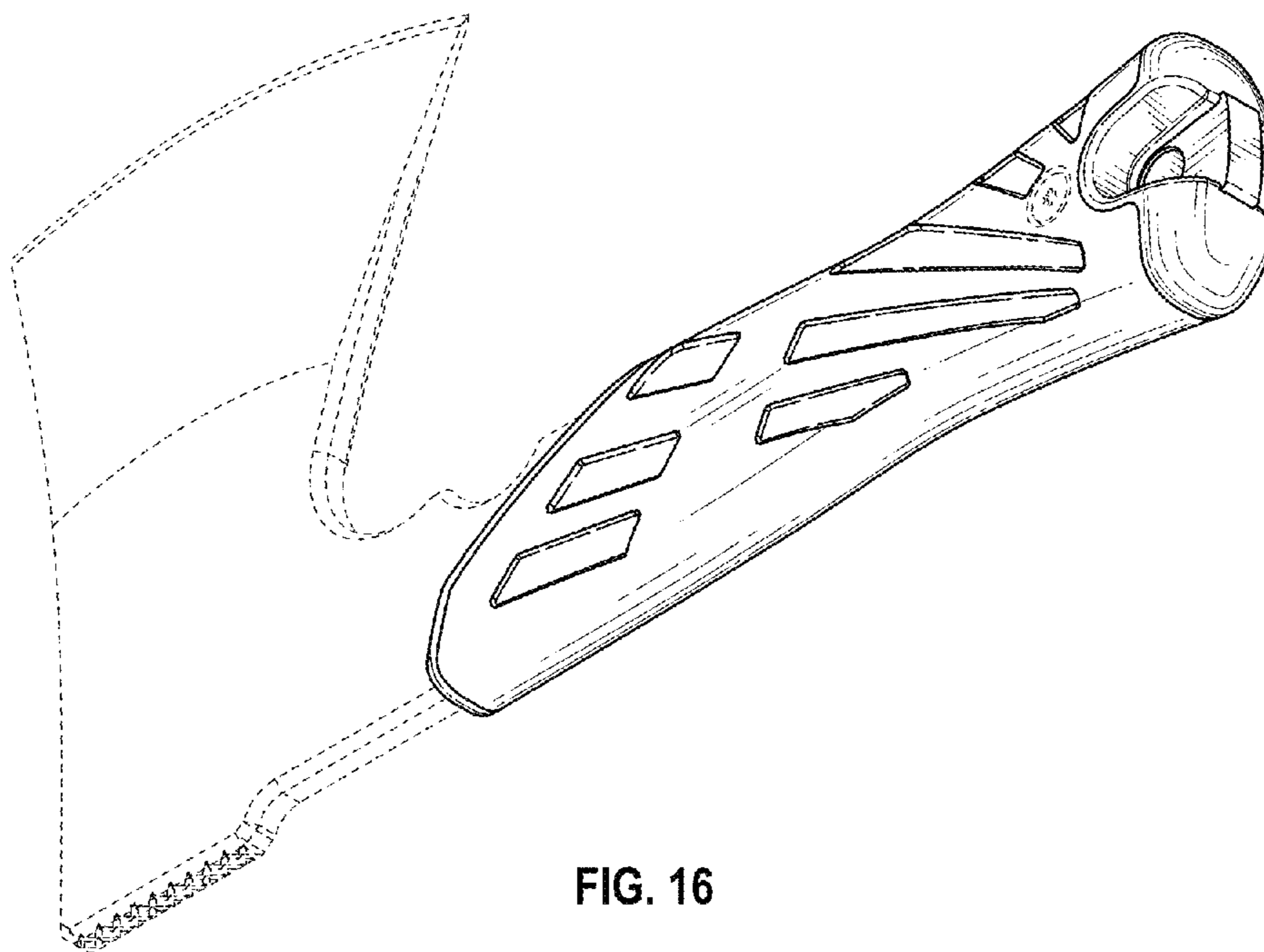
