DESCRIPTION

FIG. 1 is a top, right rear perspective view of a wrist-worn electronic display showing my new design;

FIG. 4 is a bottom view thereof;

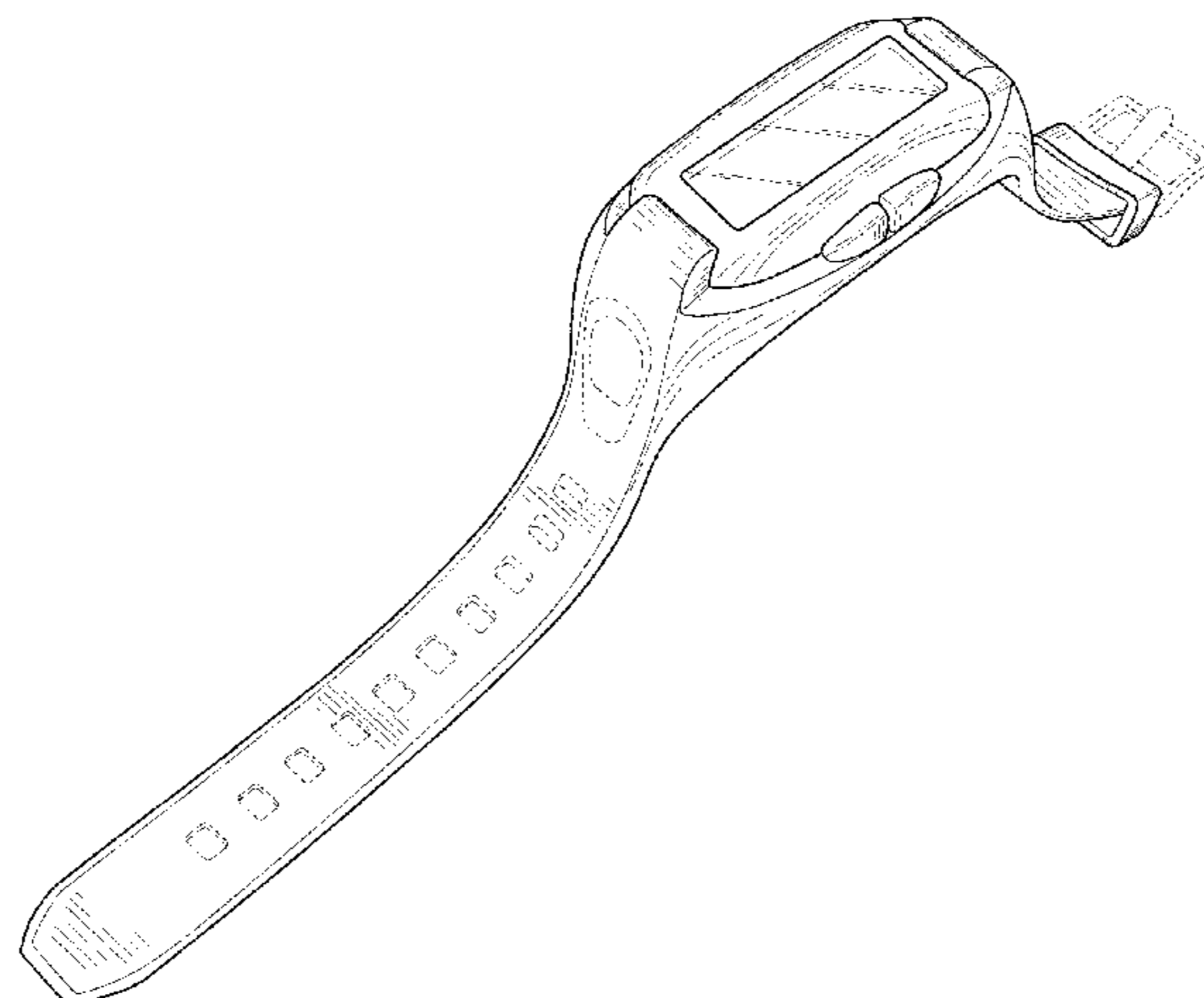
FIG. 5 is a left side view thereof;

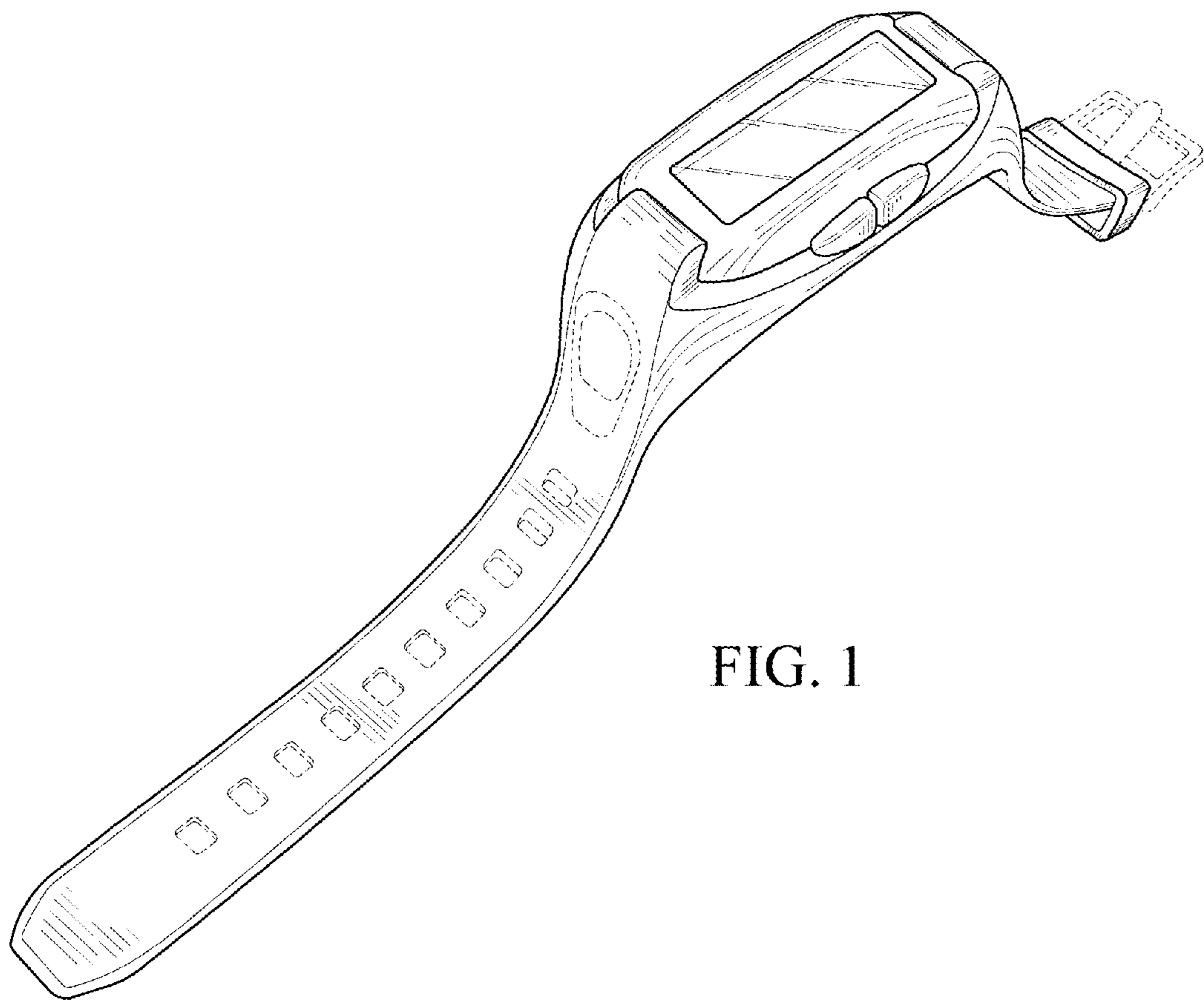

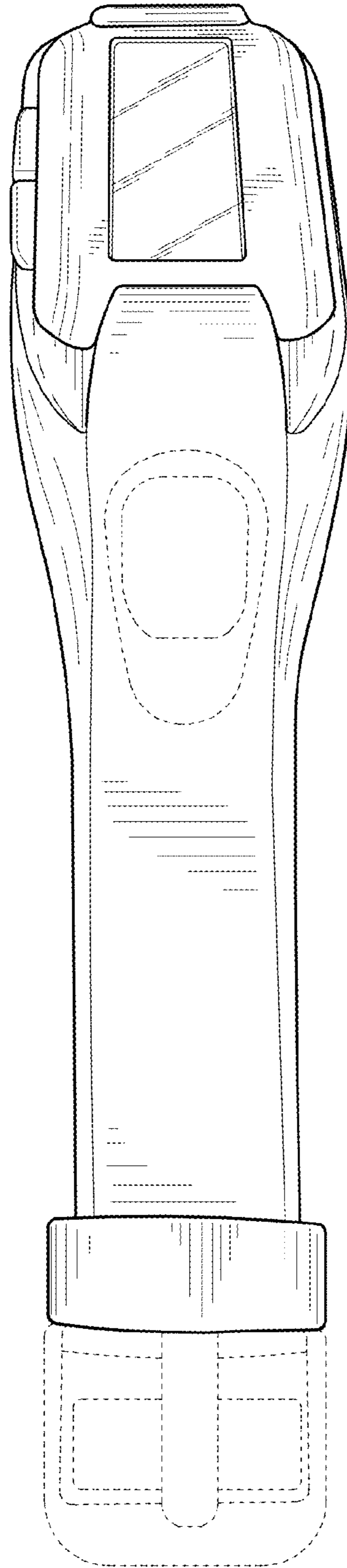

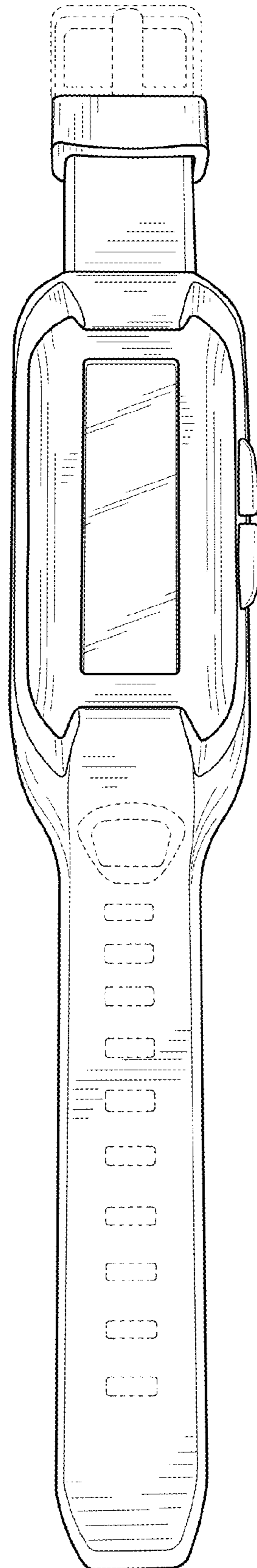

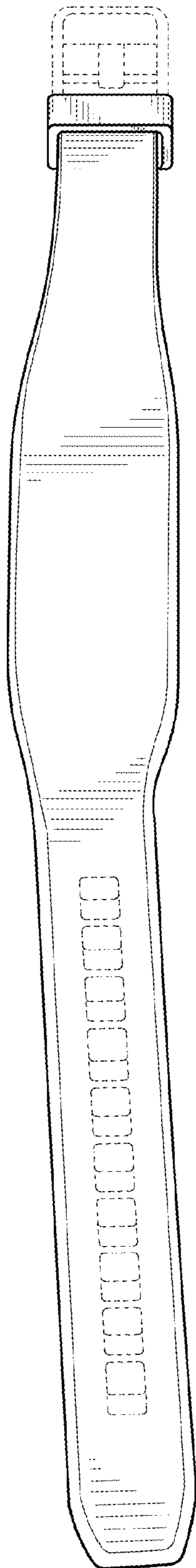

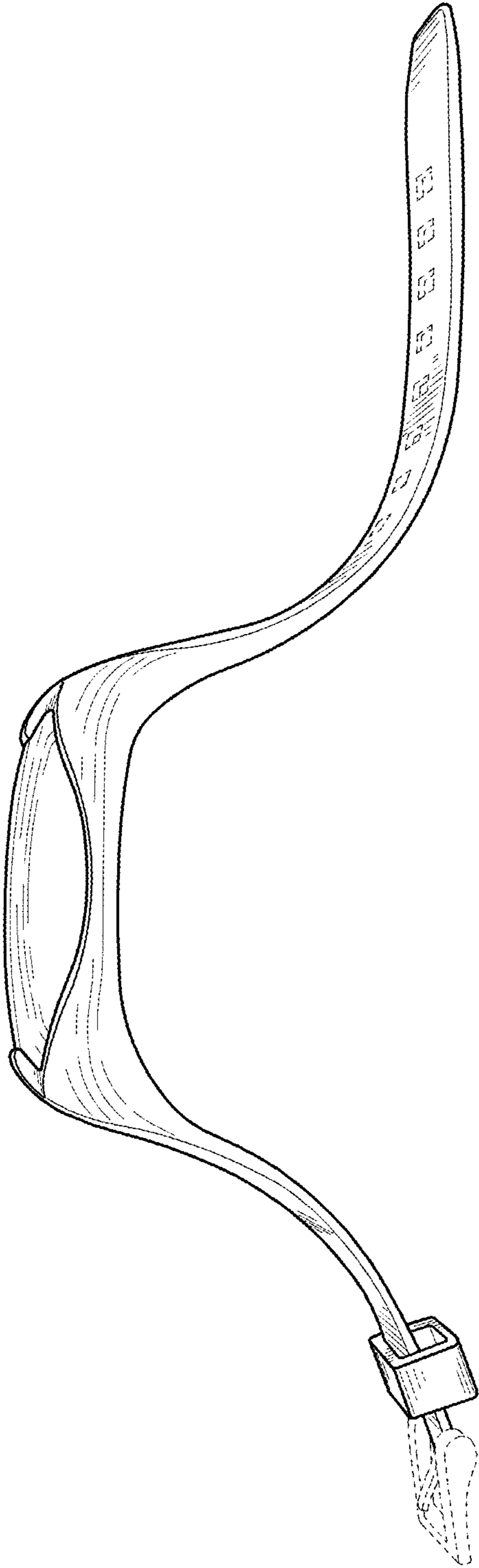

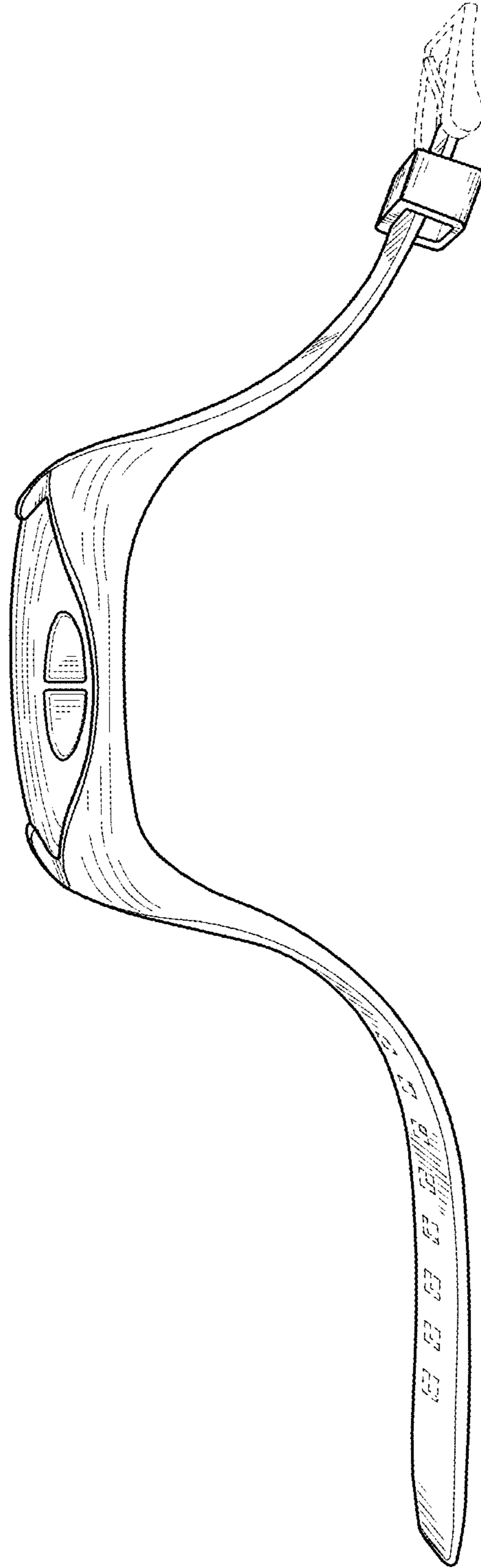

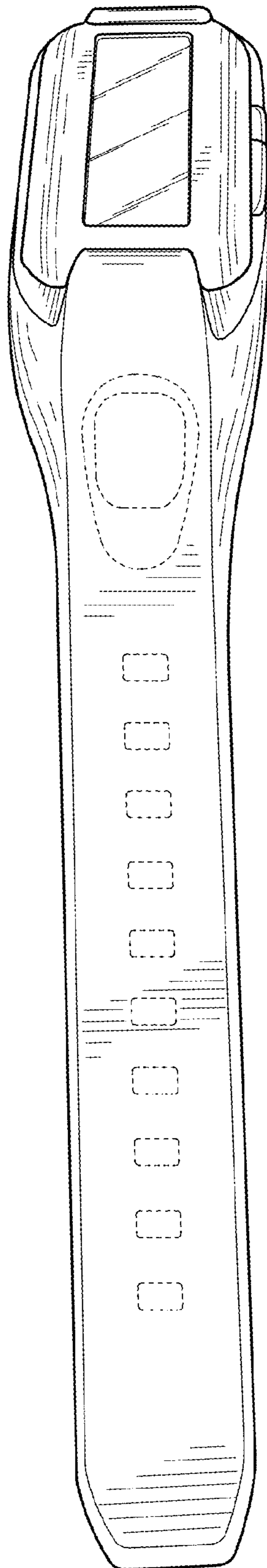
