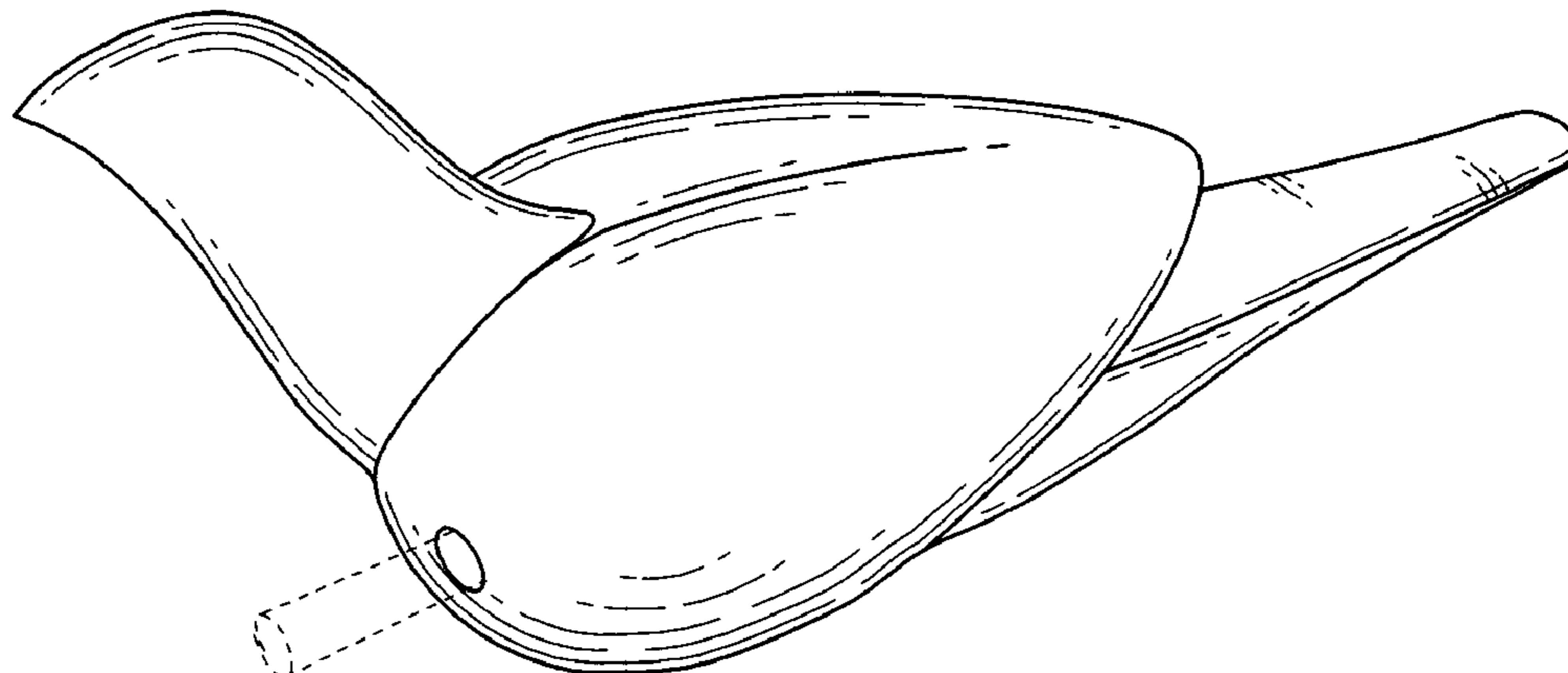
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the bird figurine of the present invention showing our new design;

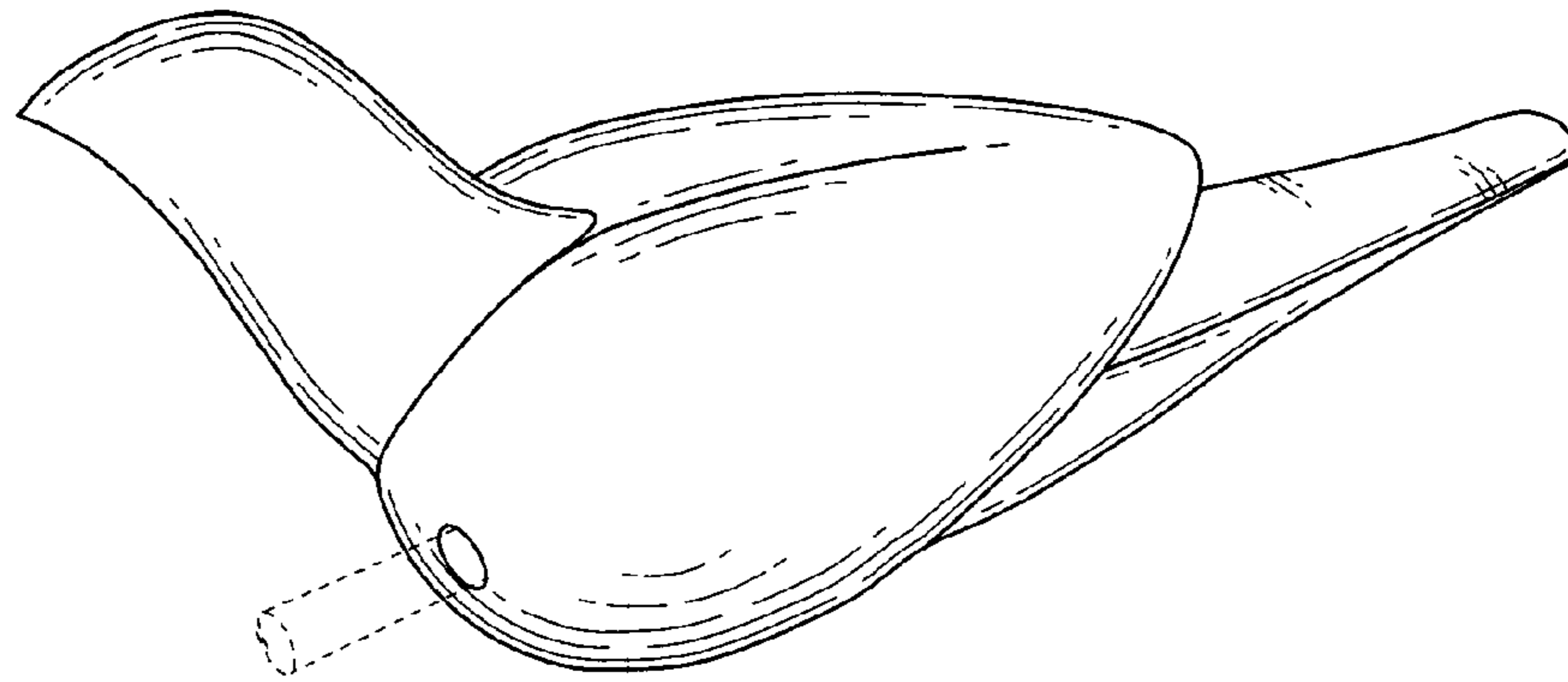

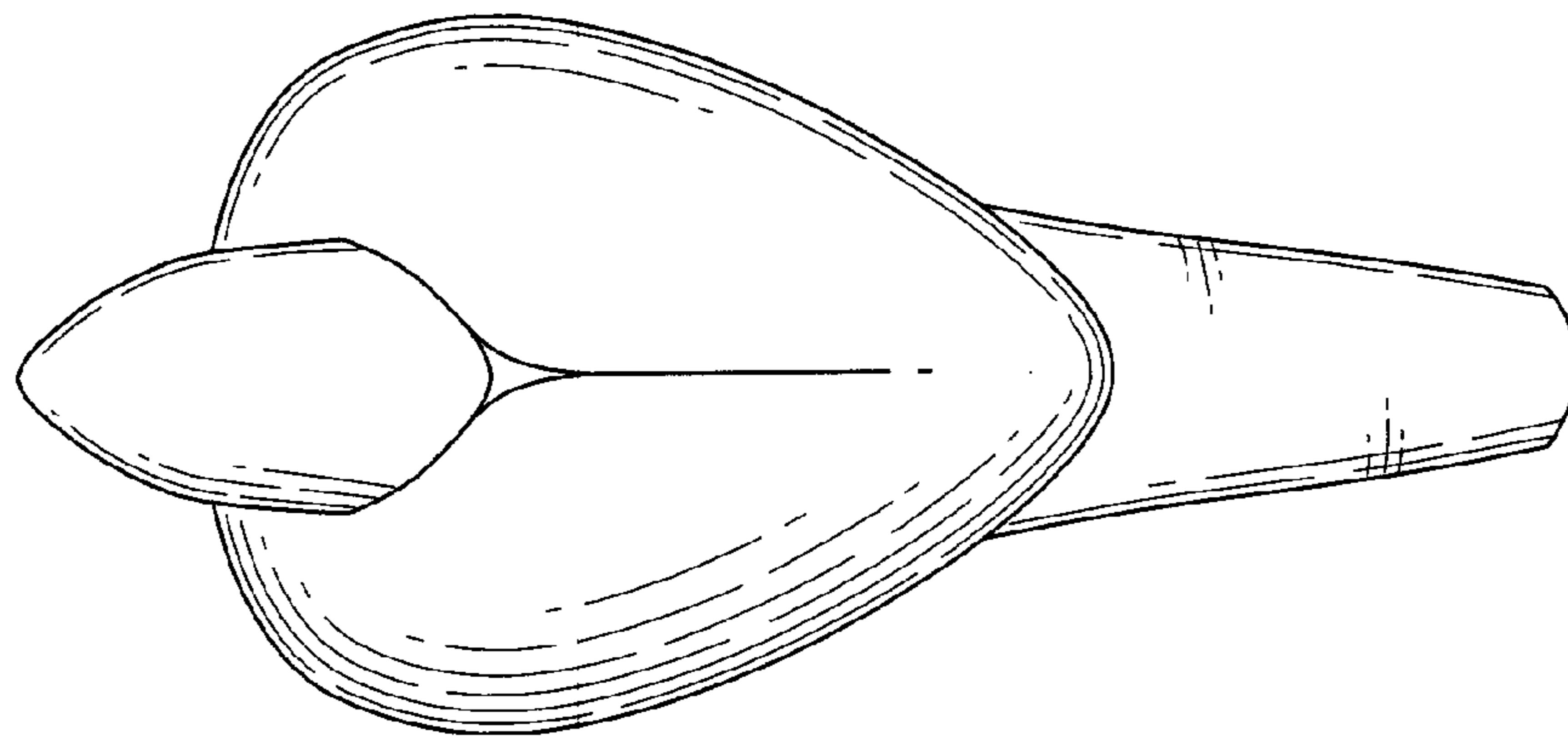

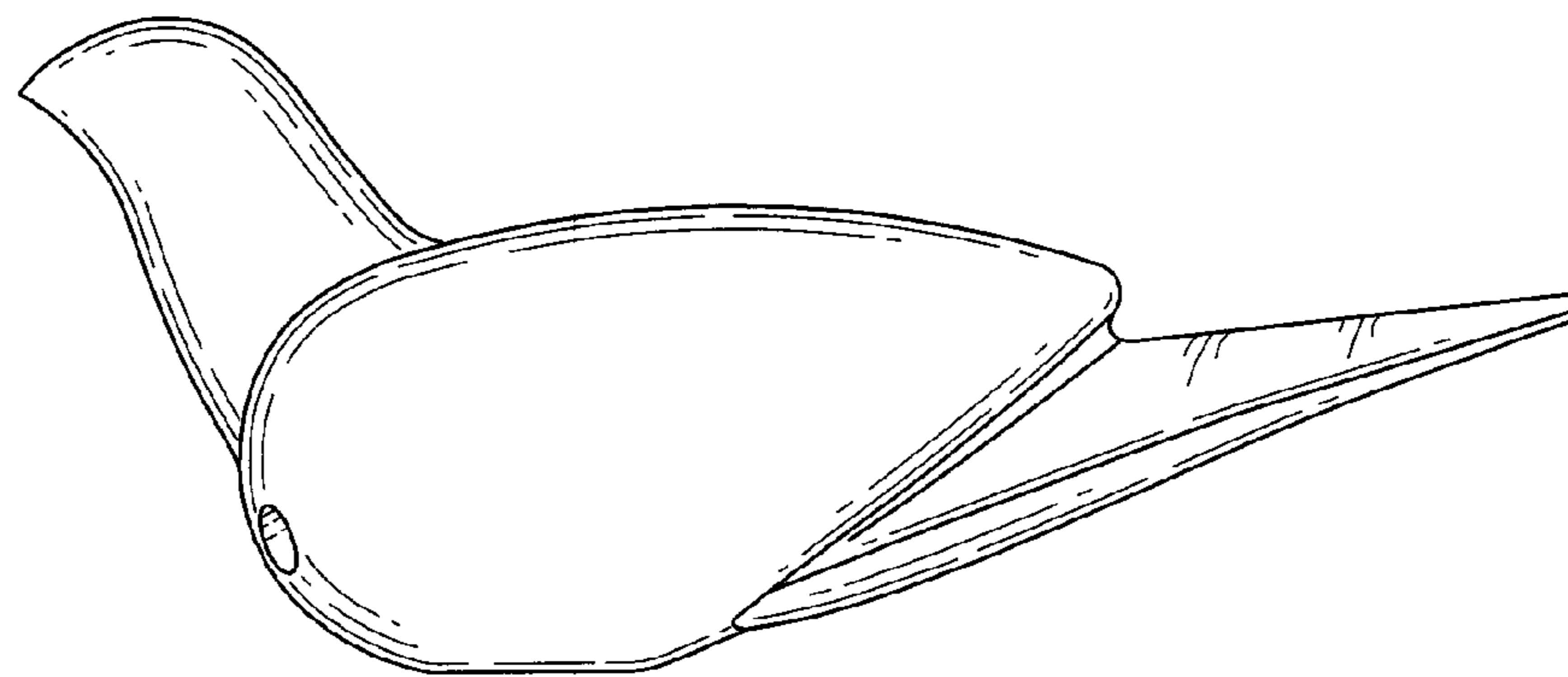

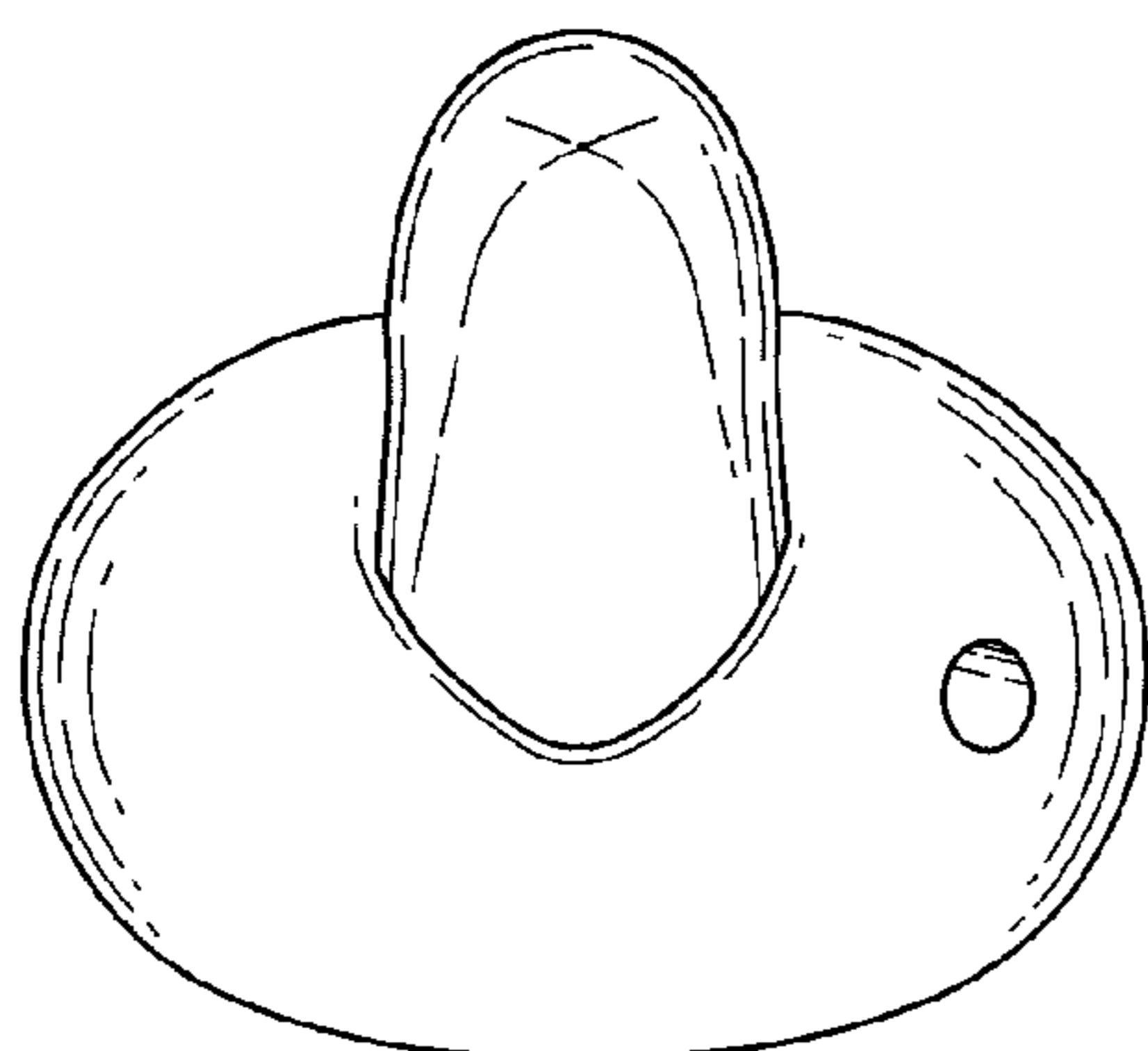

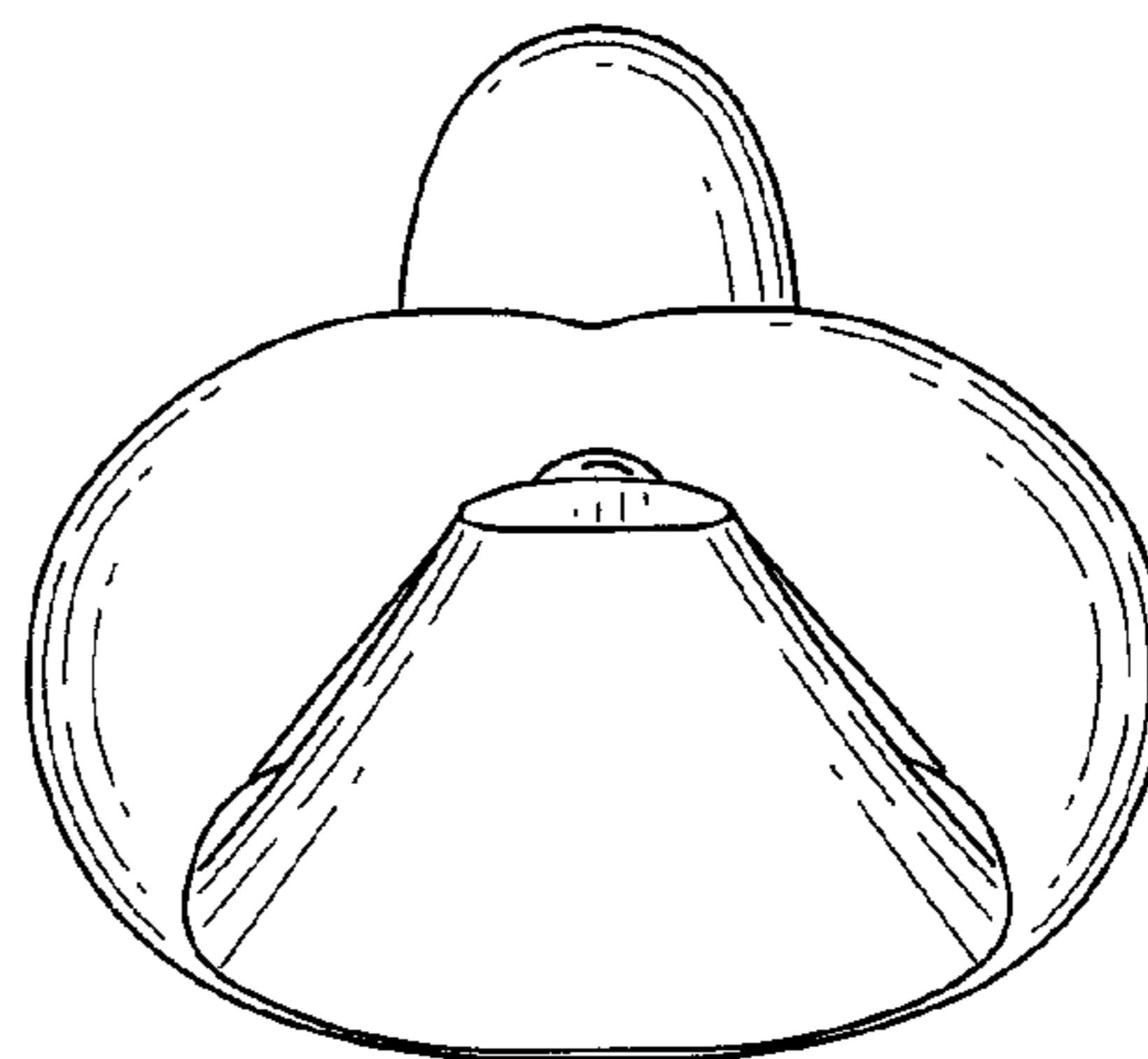

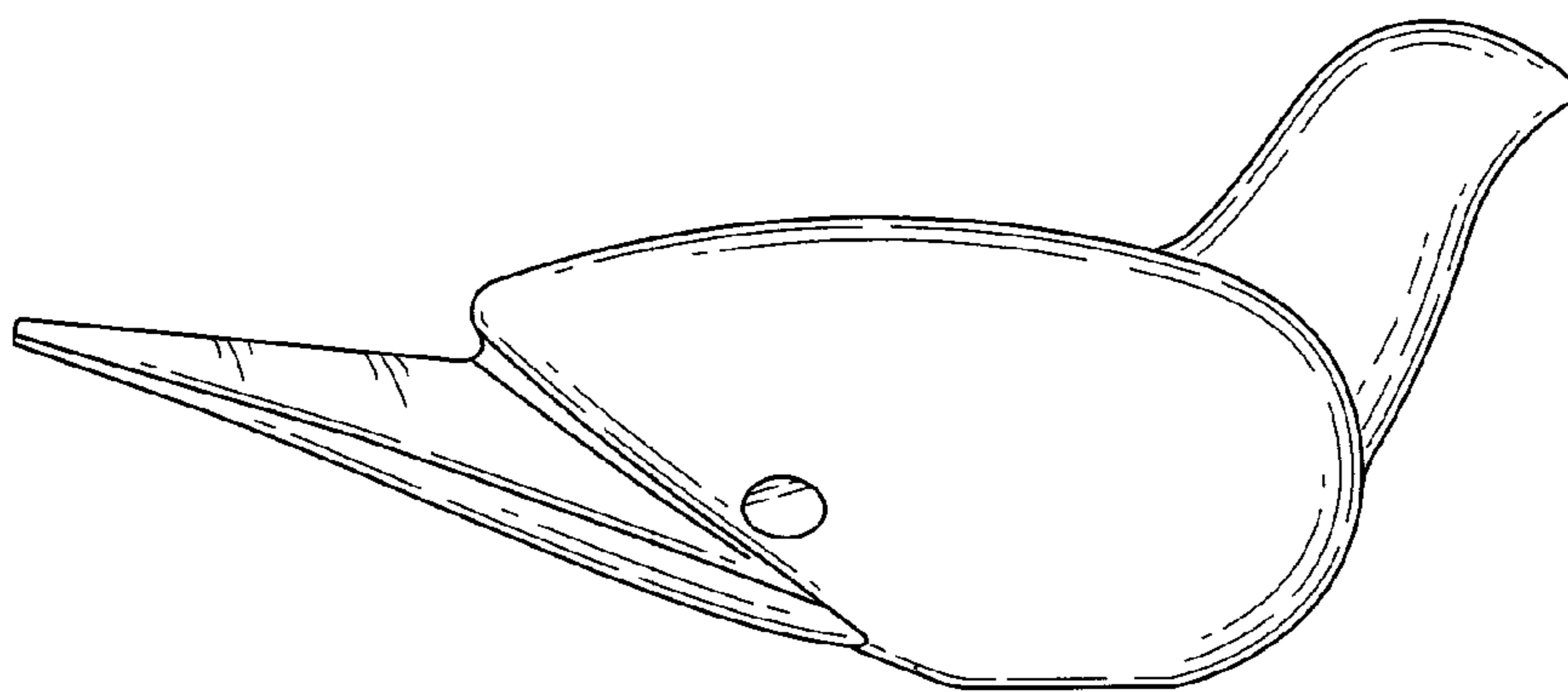

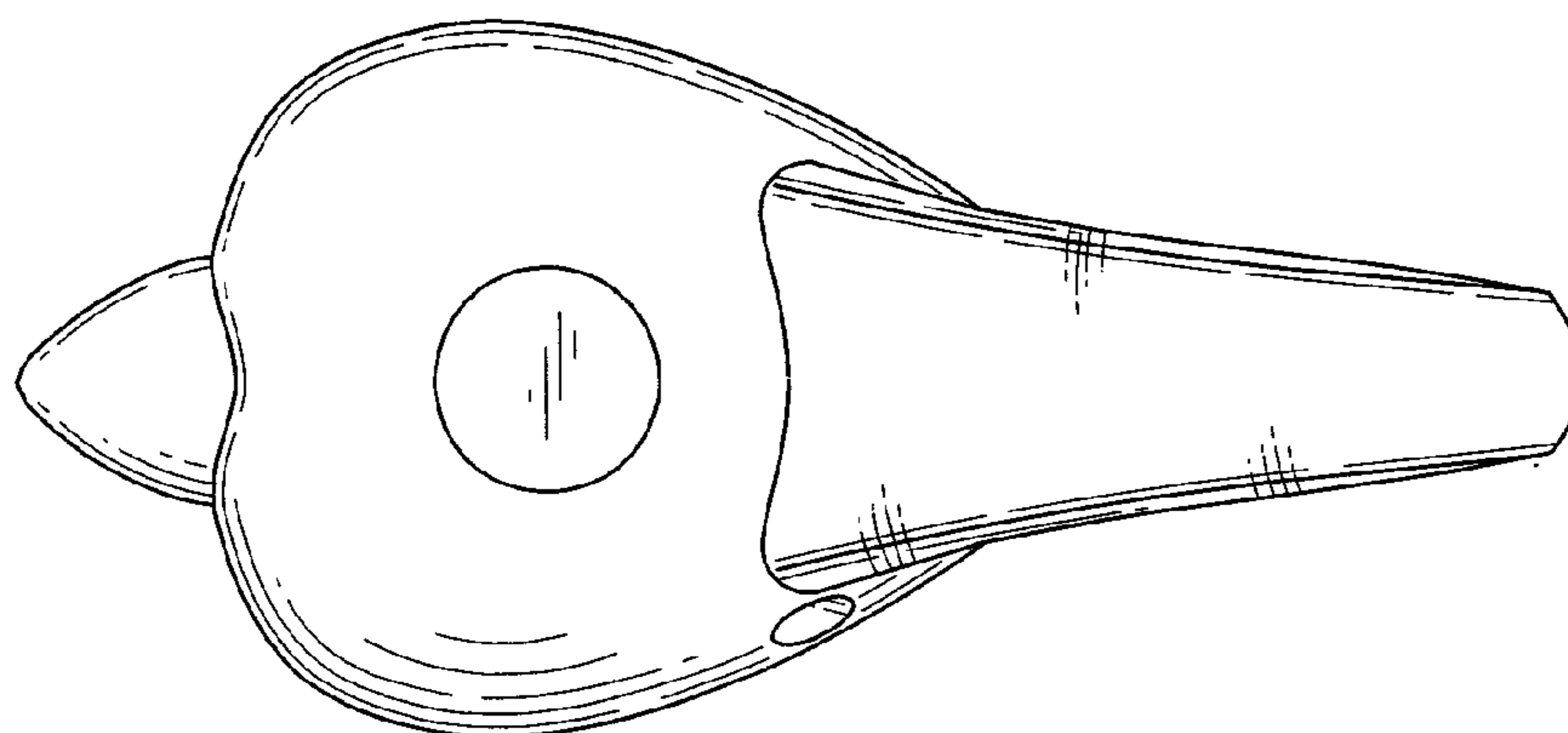

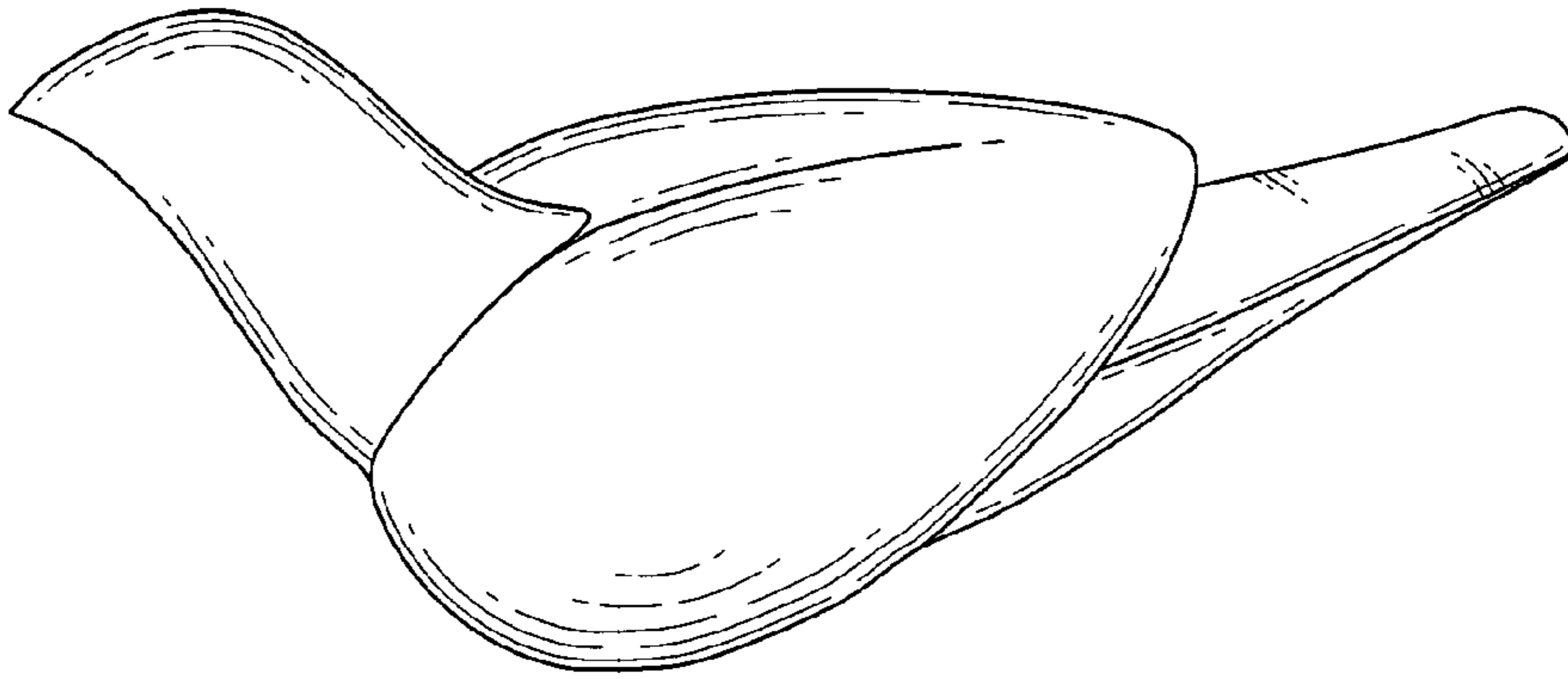

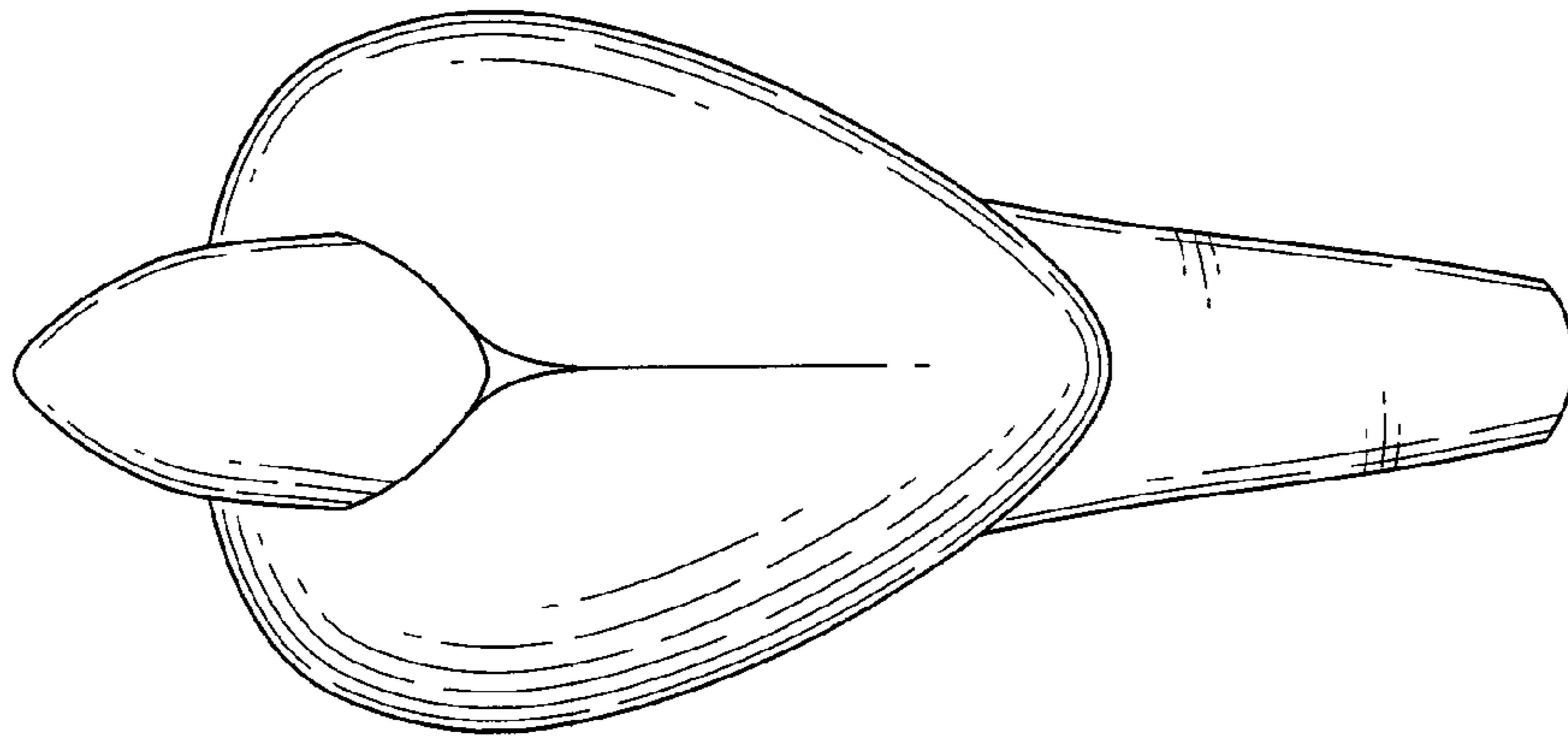

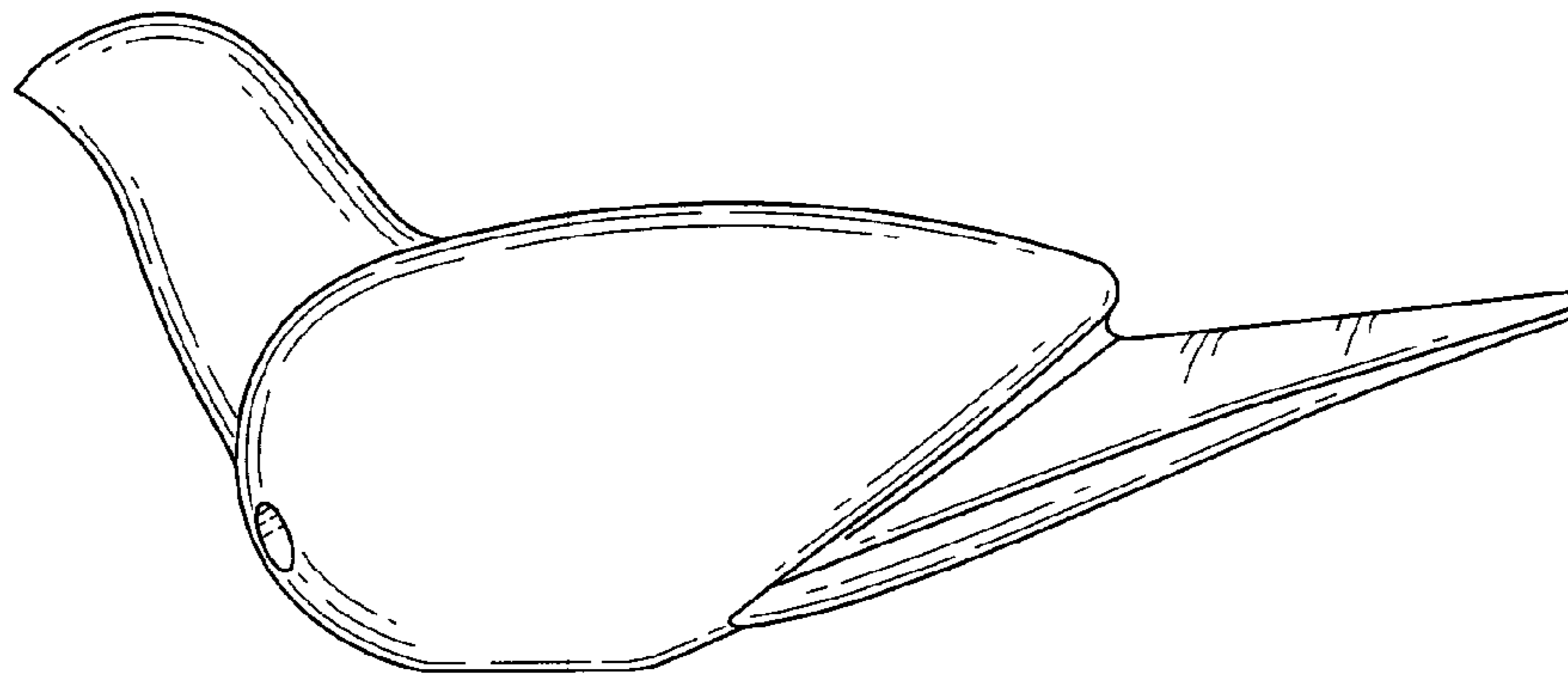

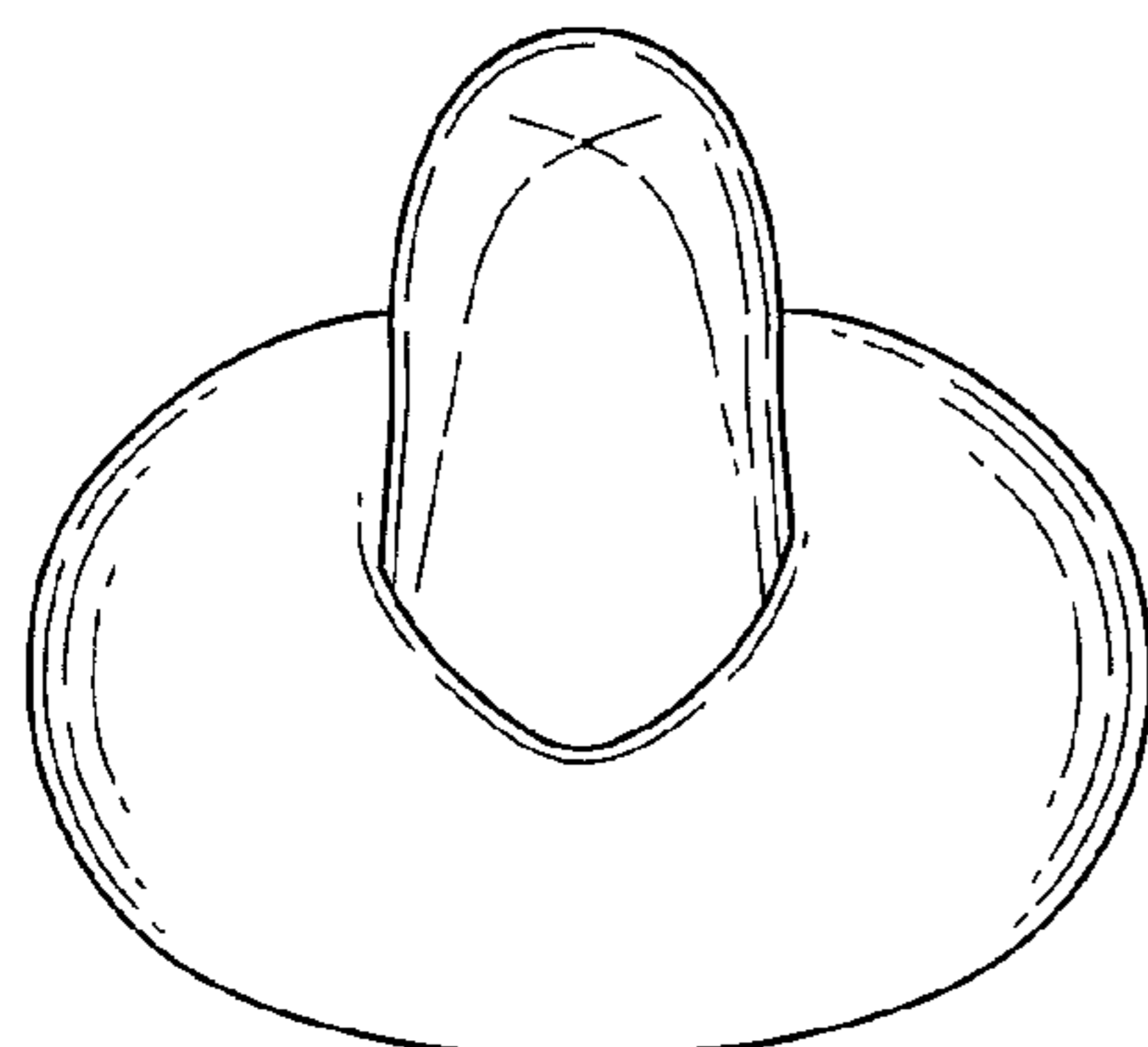

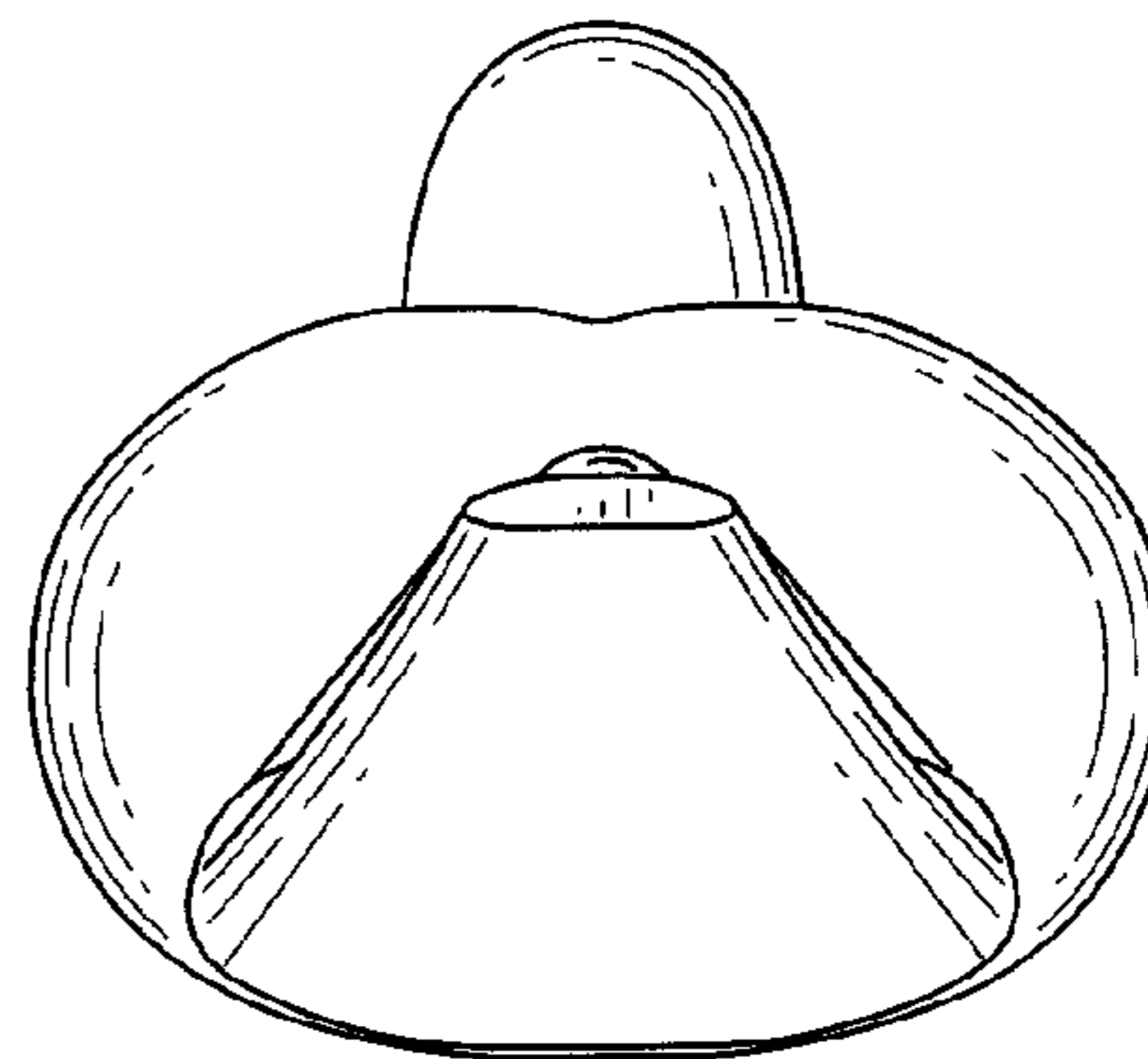

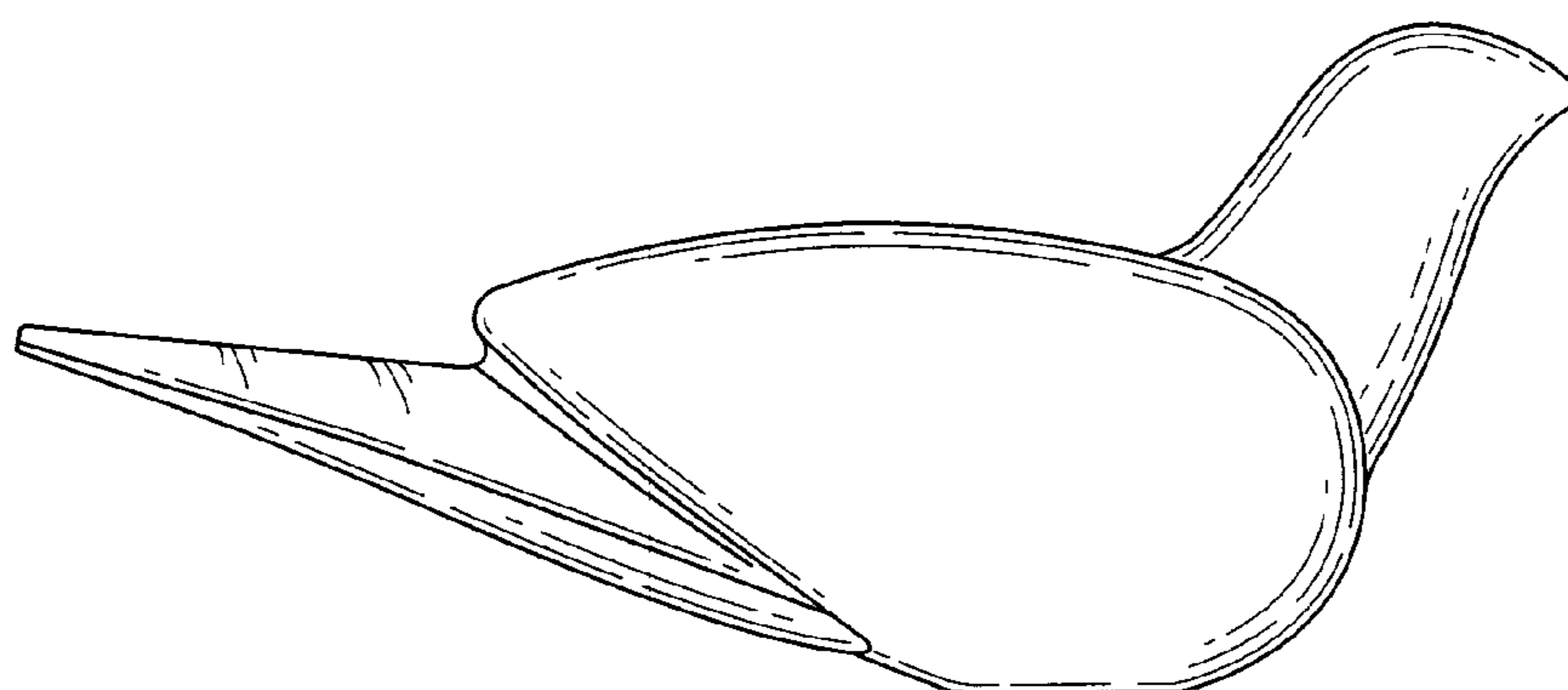

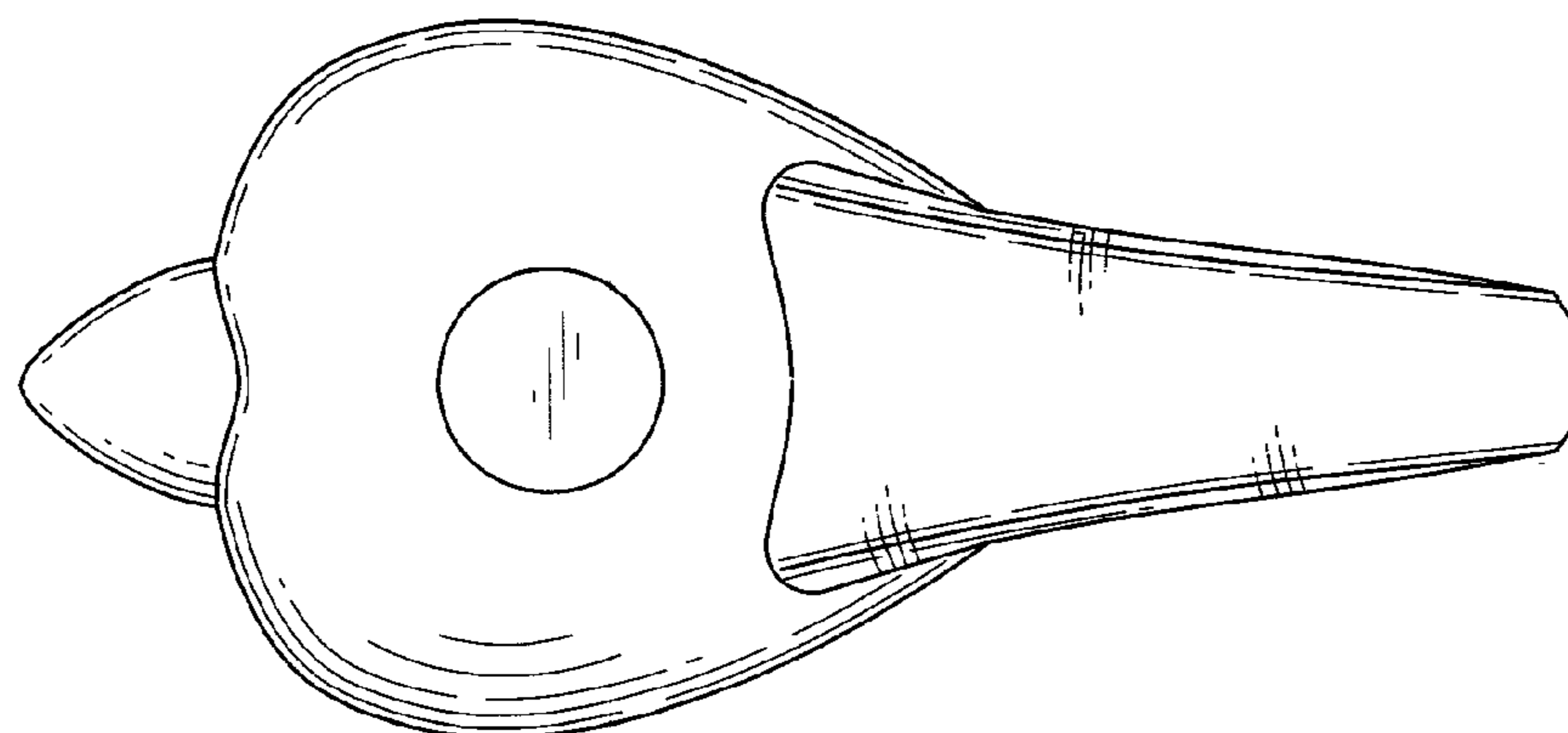
