**DESCRIPTION**

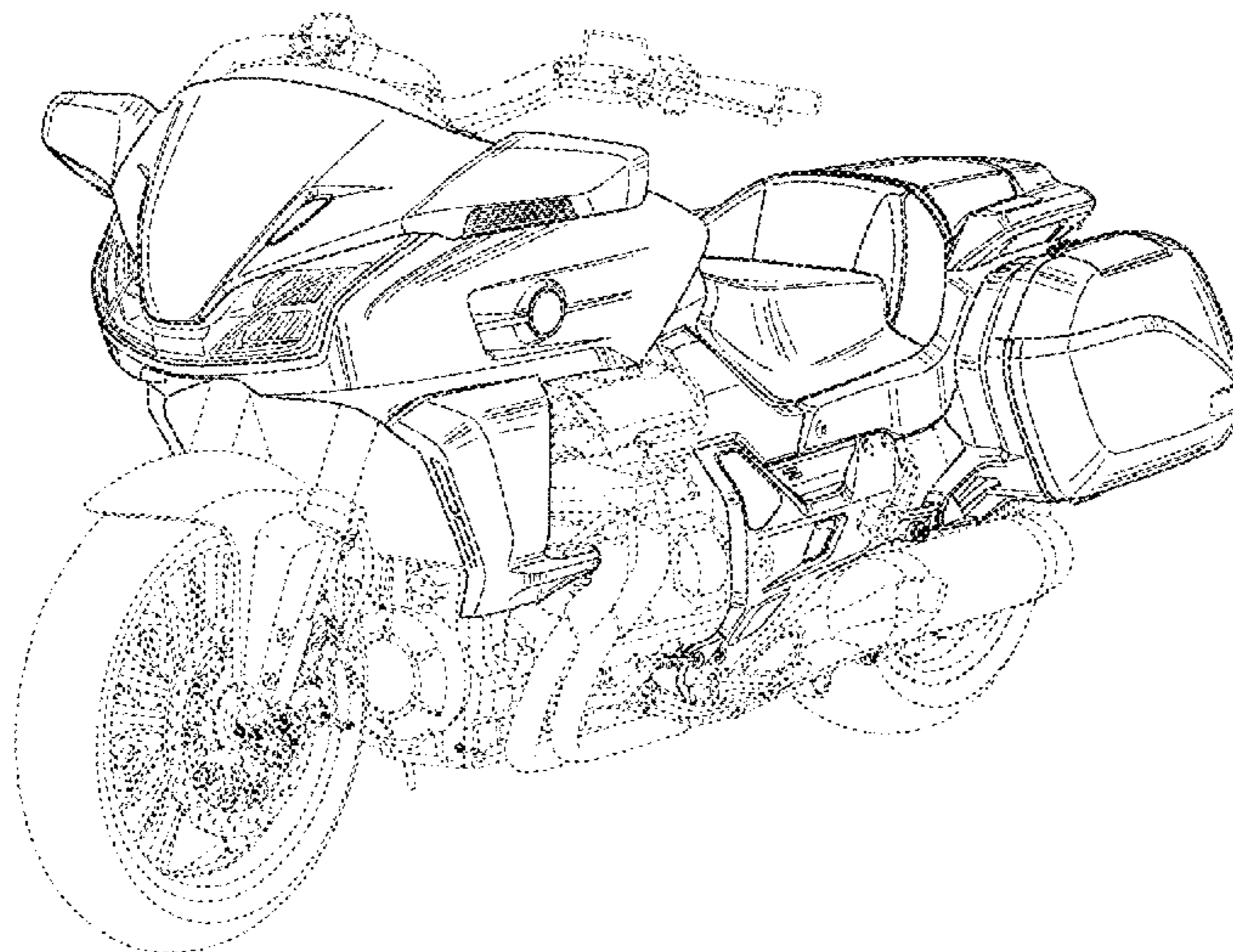

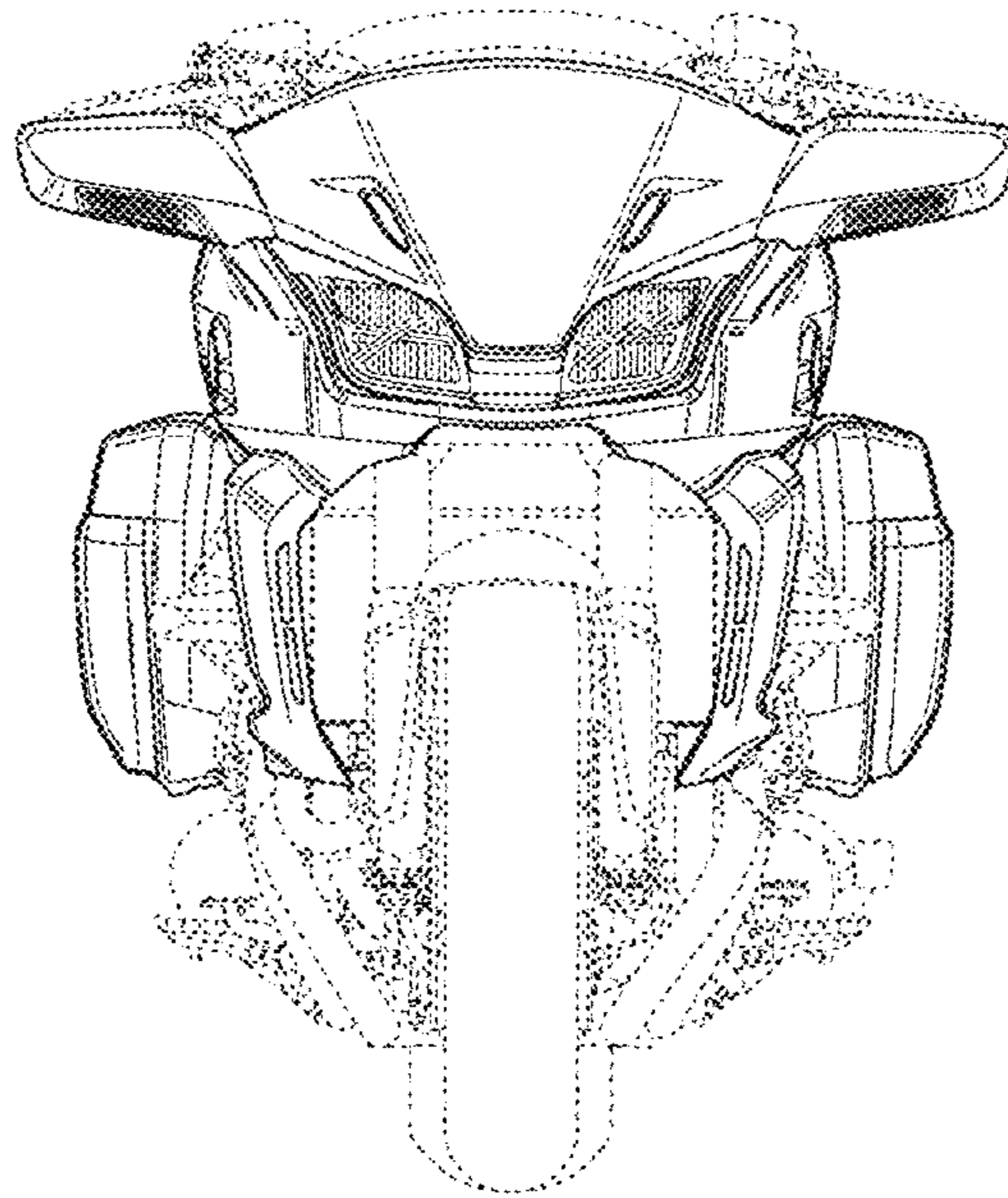

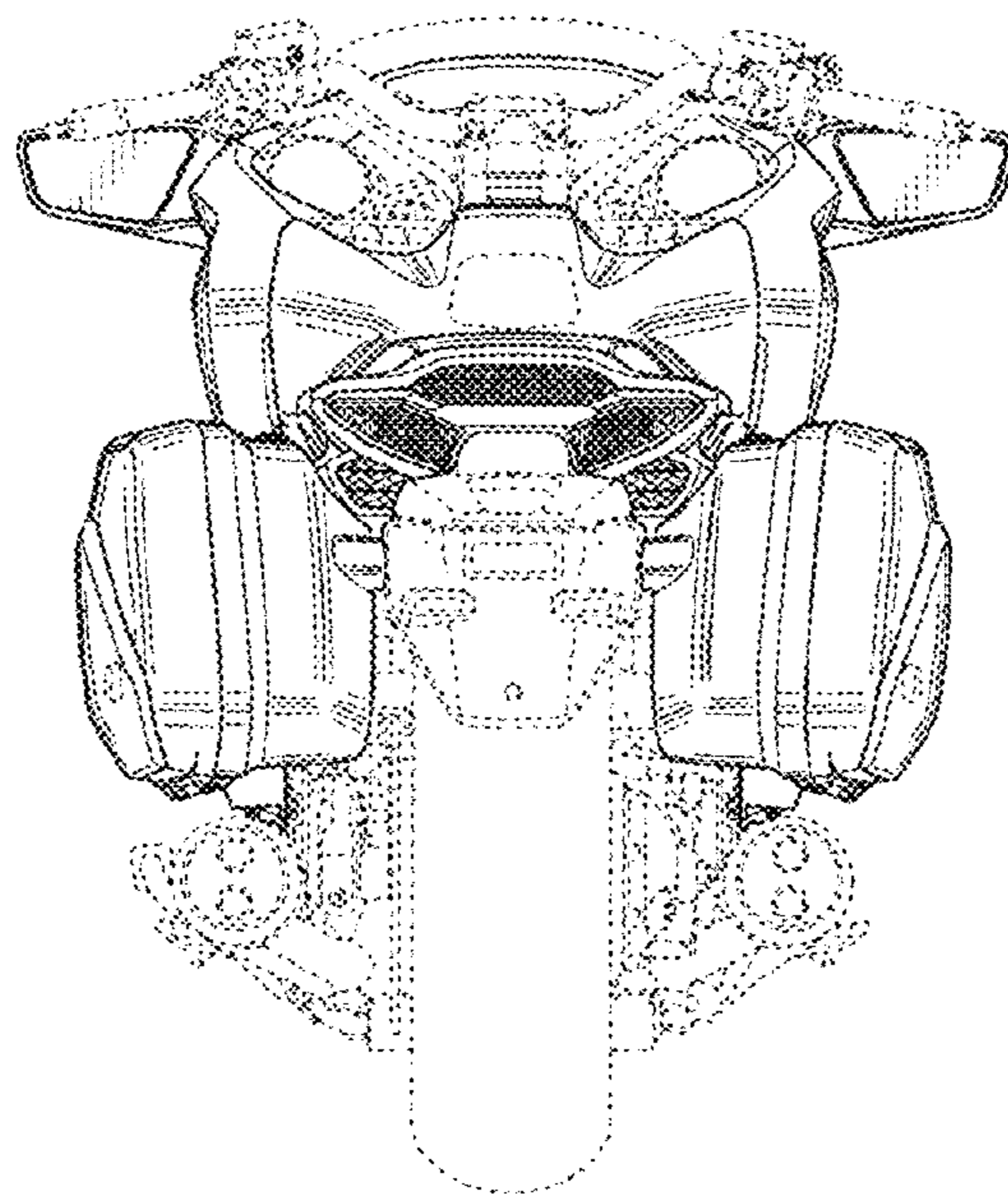

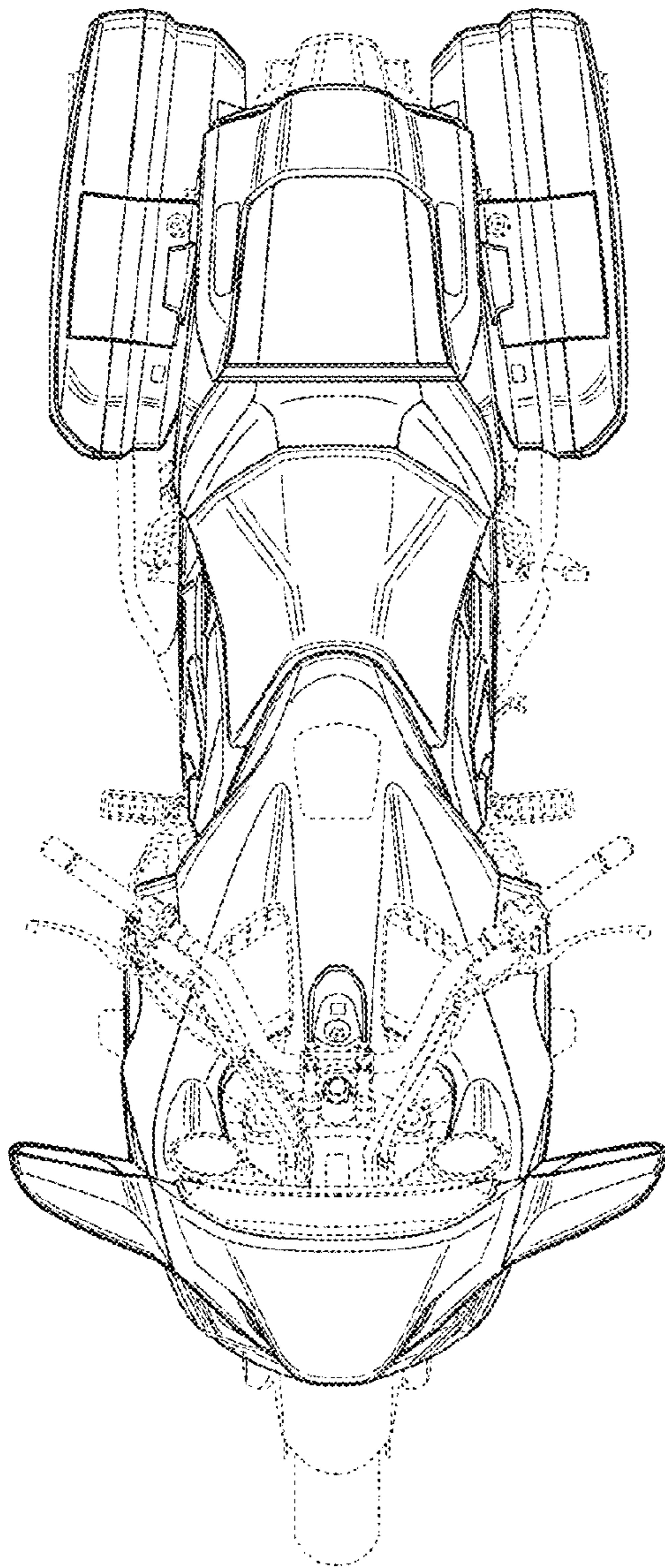

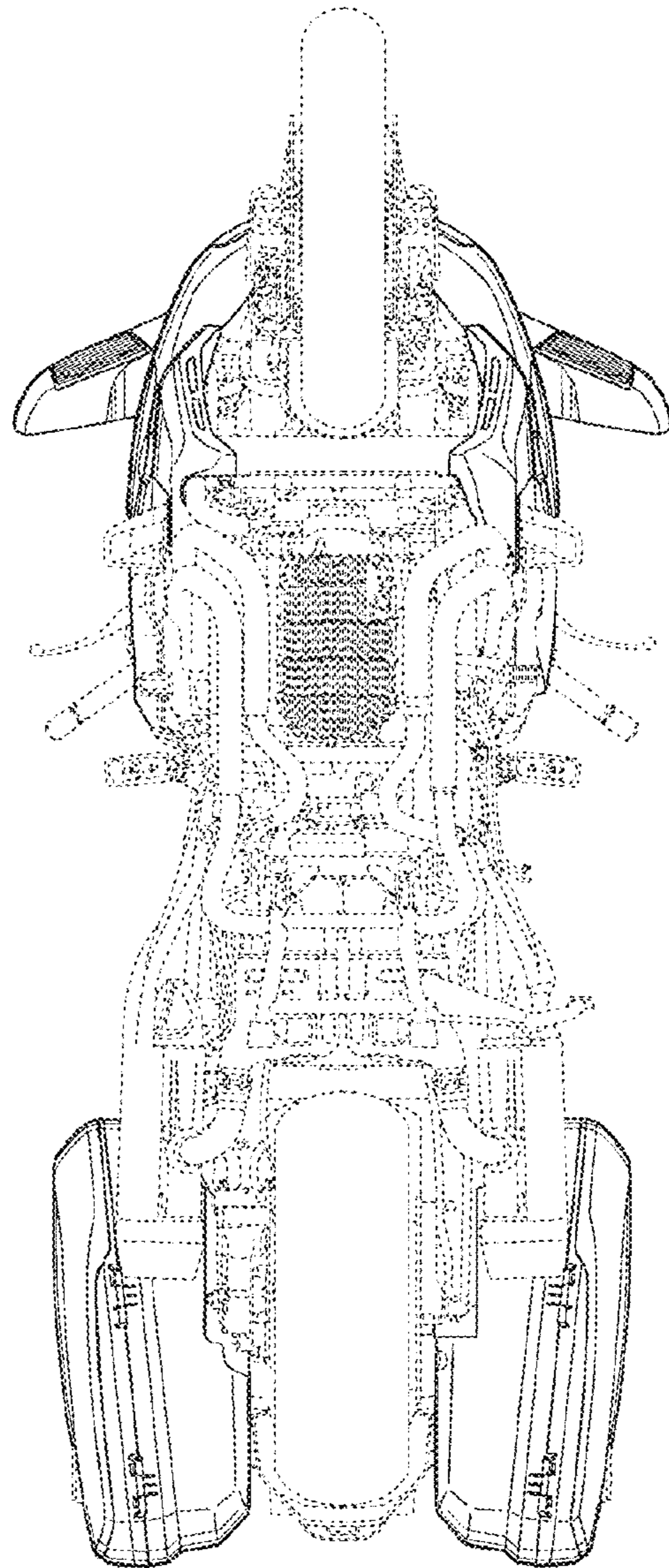

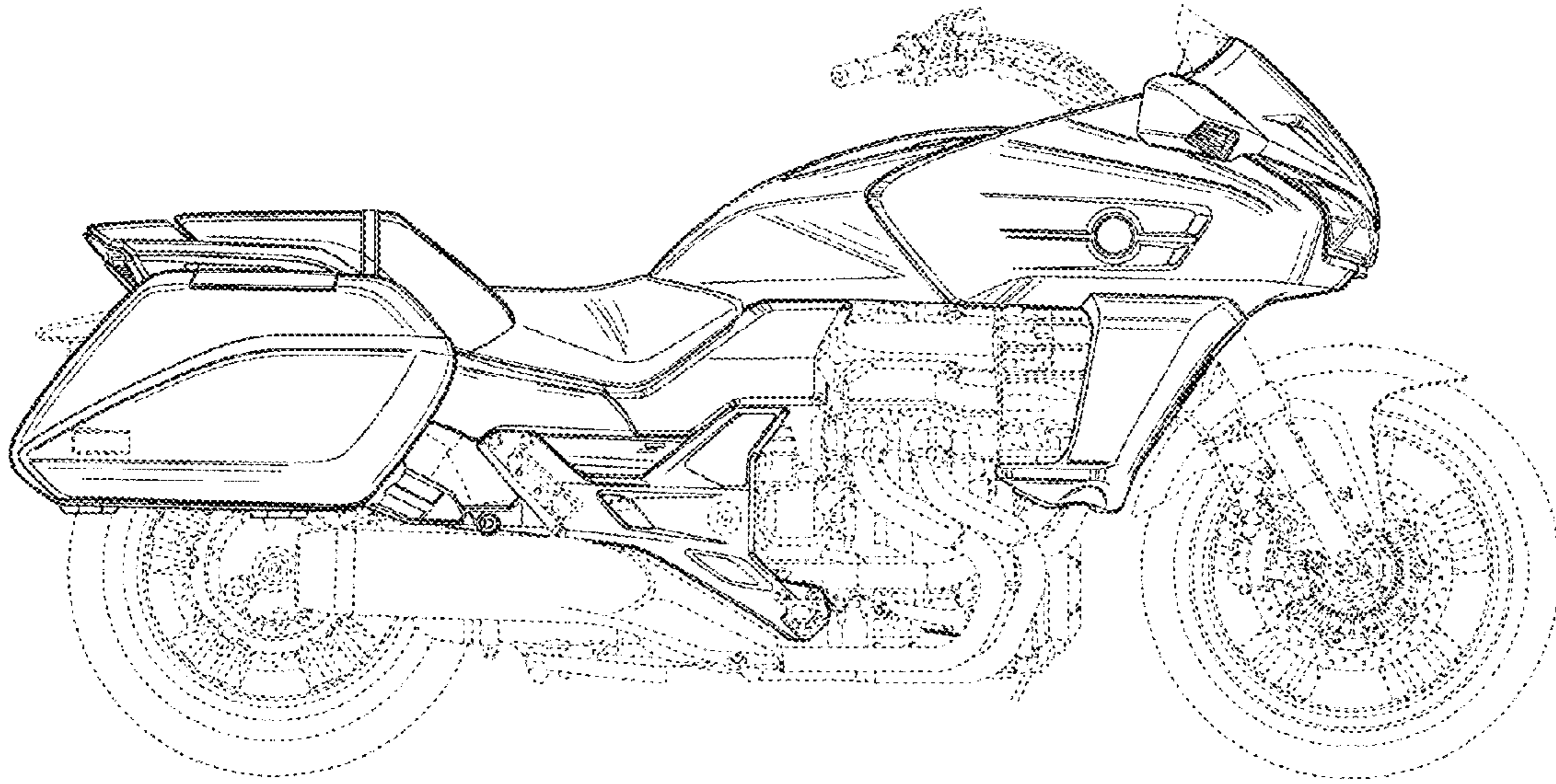

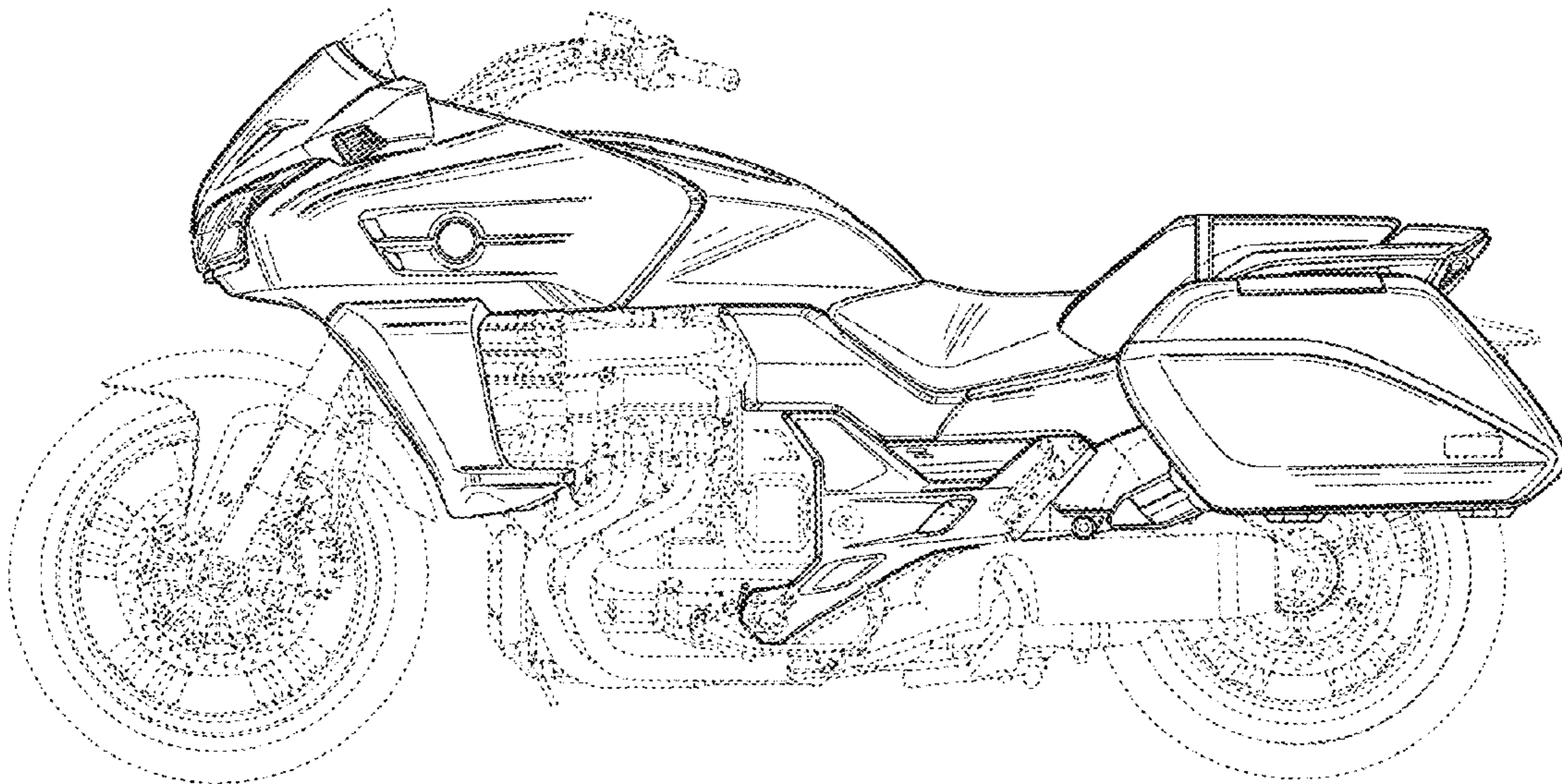

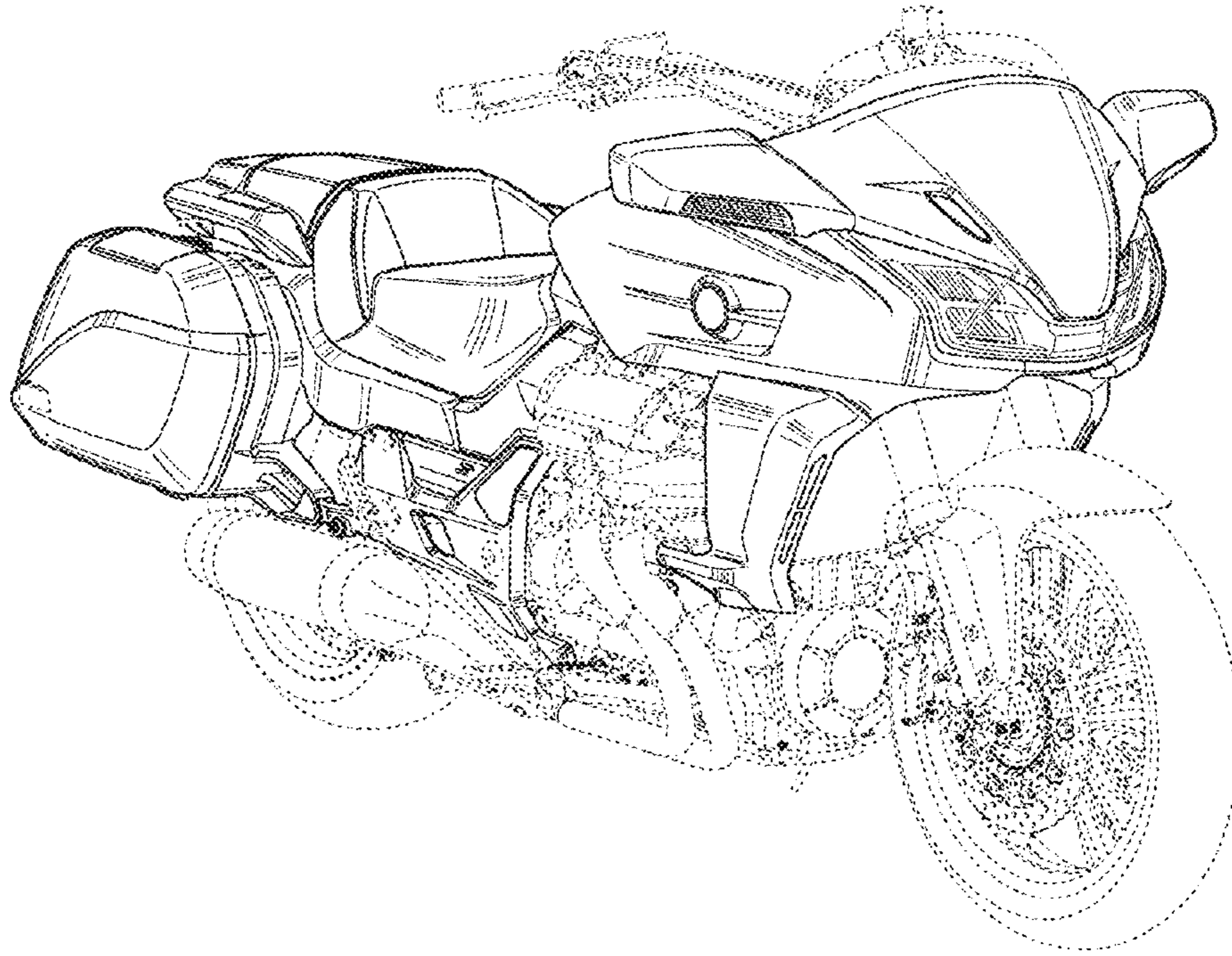

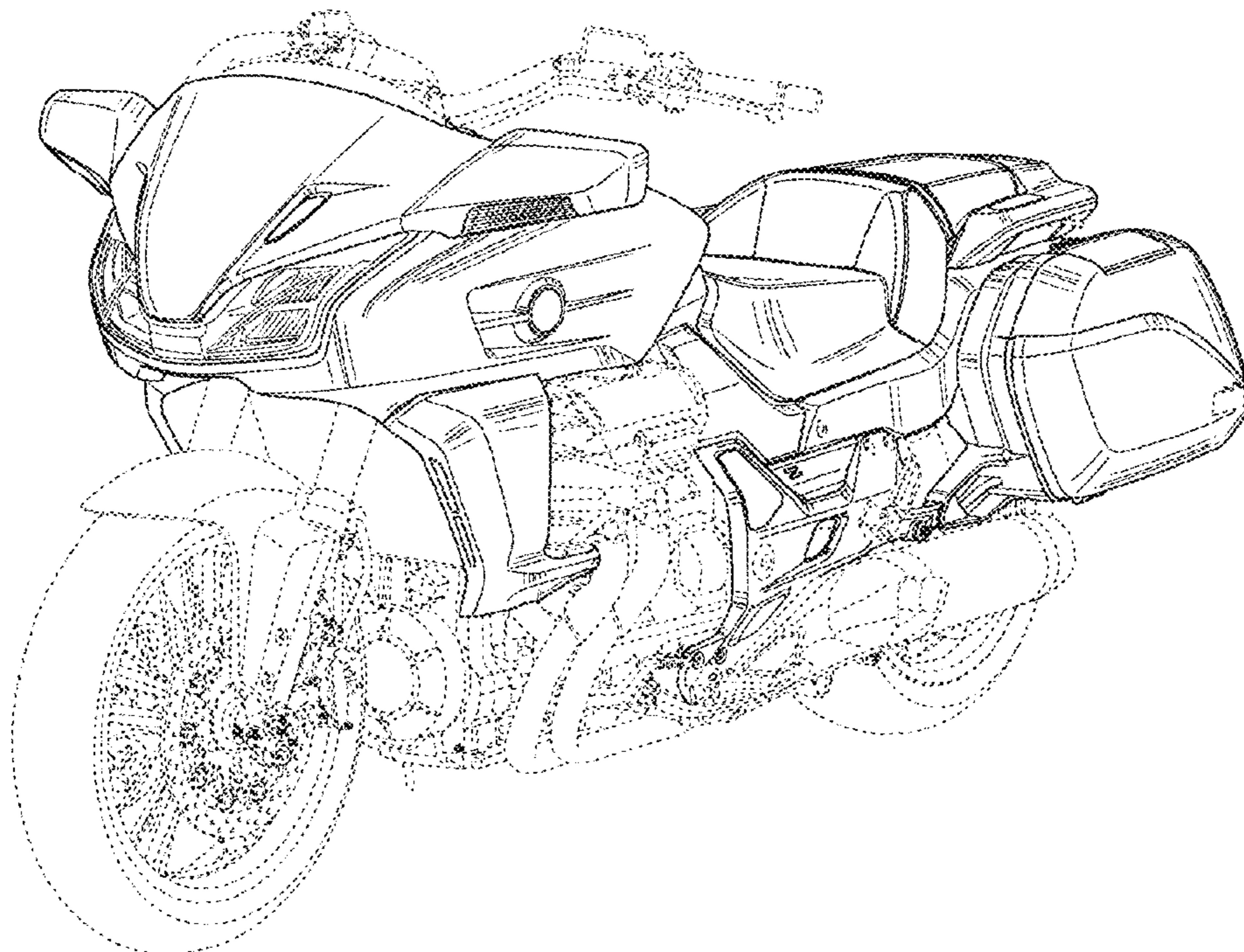

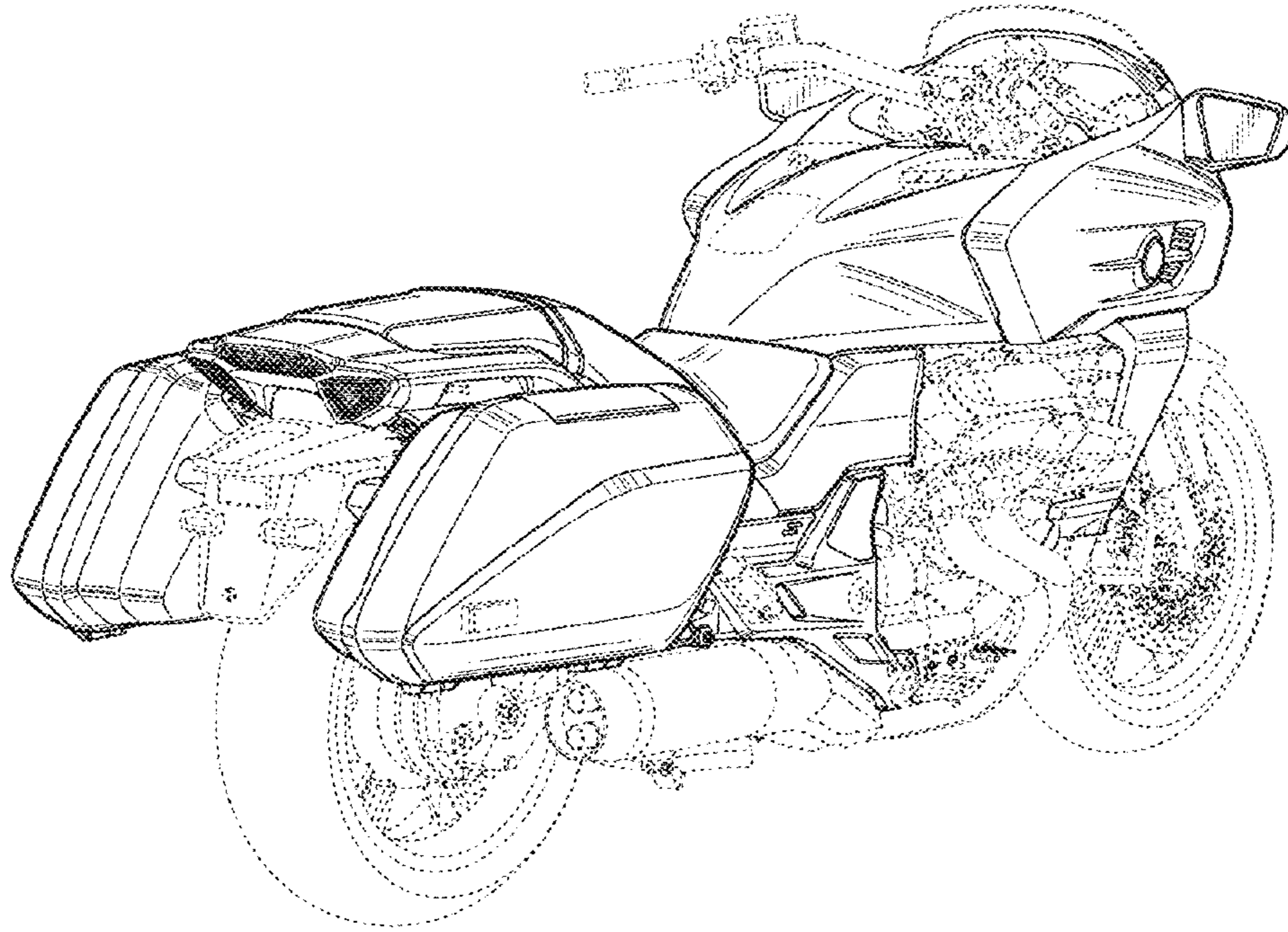
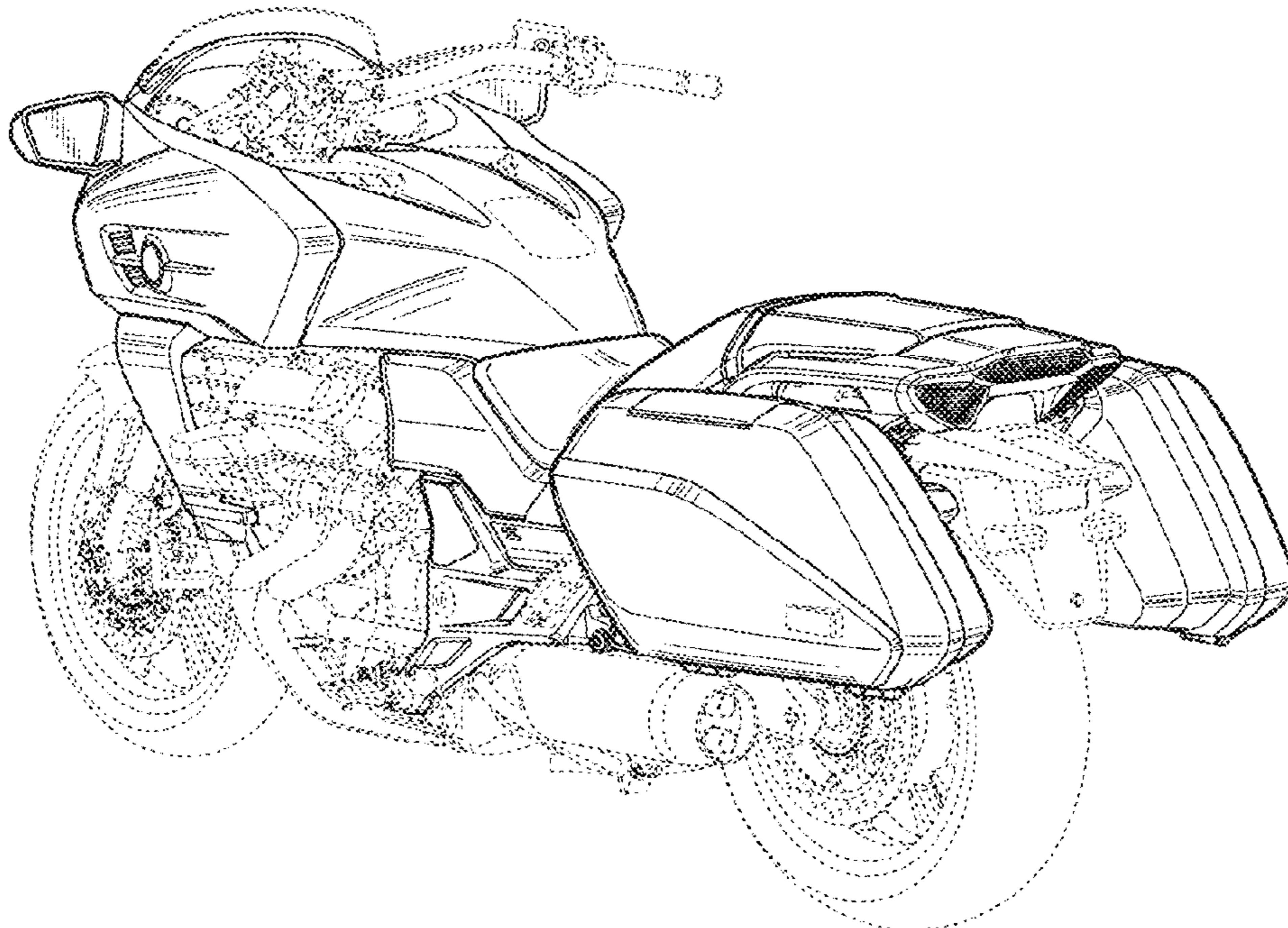
