**DESCRIPTION**

FIG. 1 is a front perspective view of a portable terminal showing my new design;

FIG. 10 is a right side view thereof;

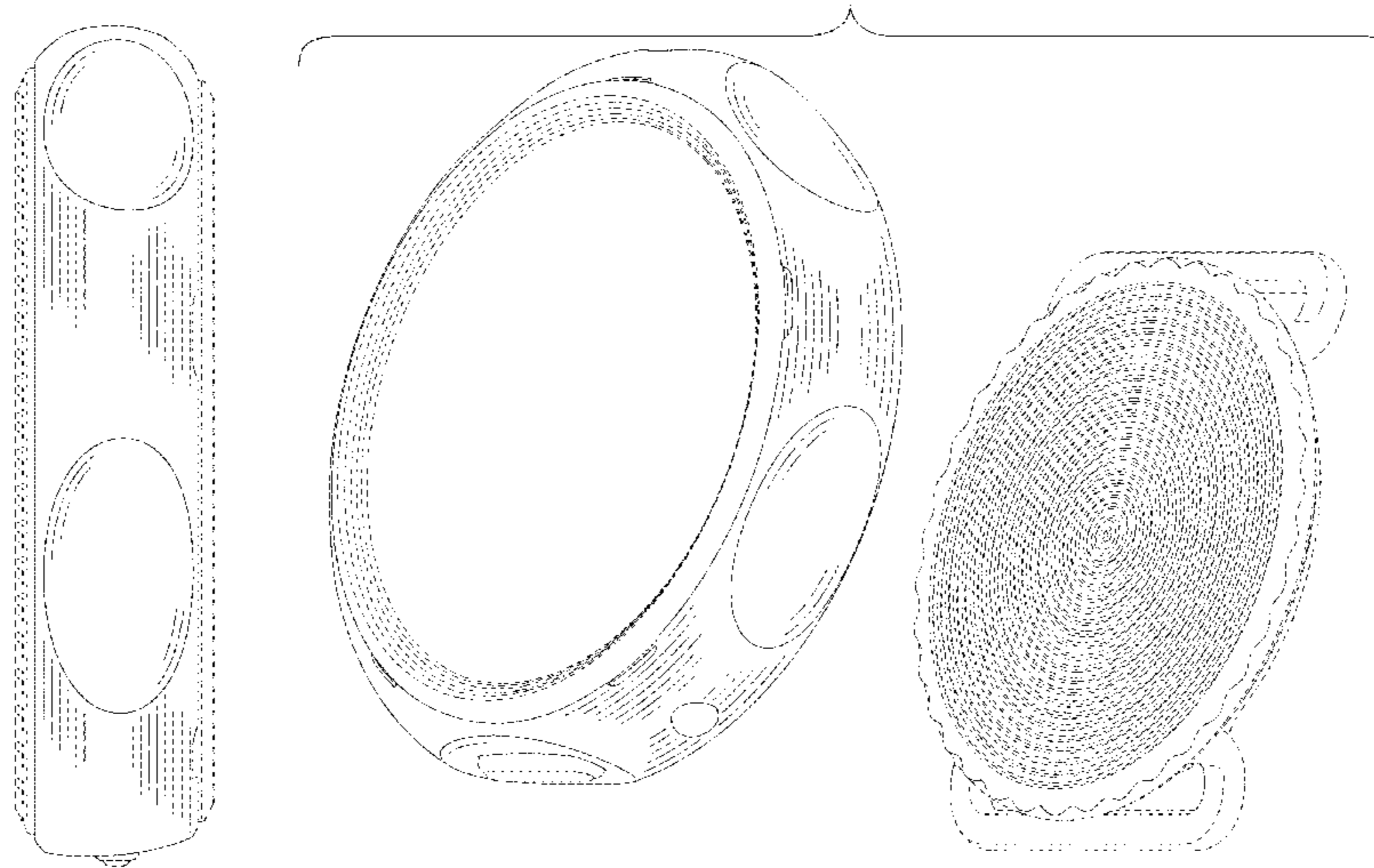
FIG. 11 is a bottom view thereof;

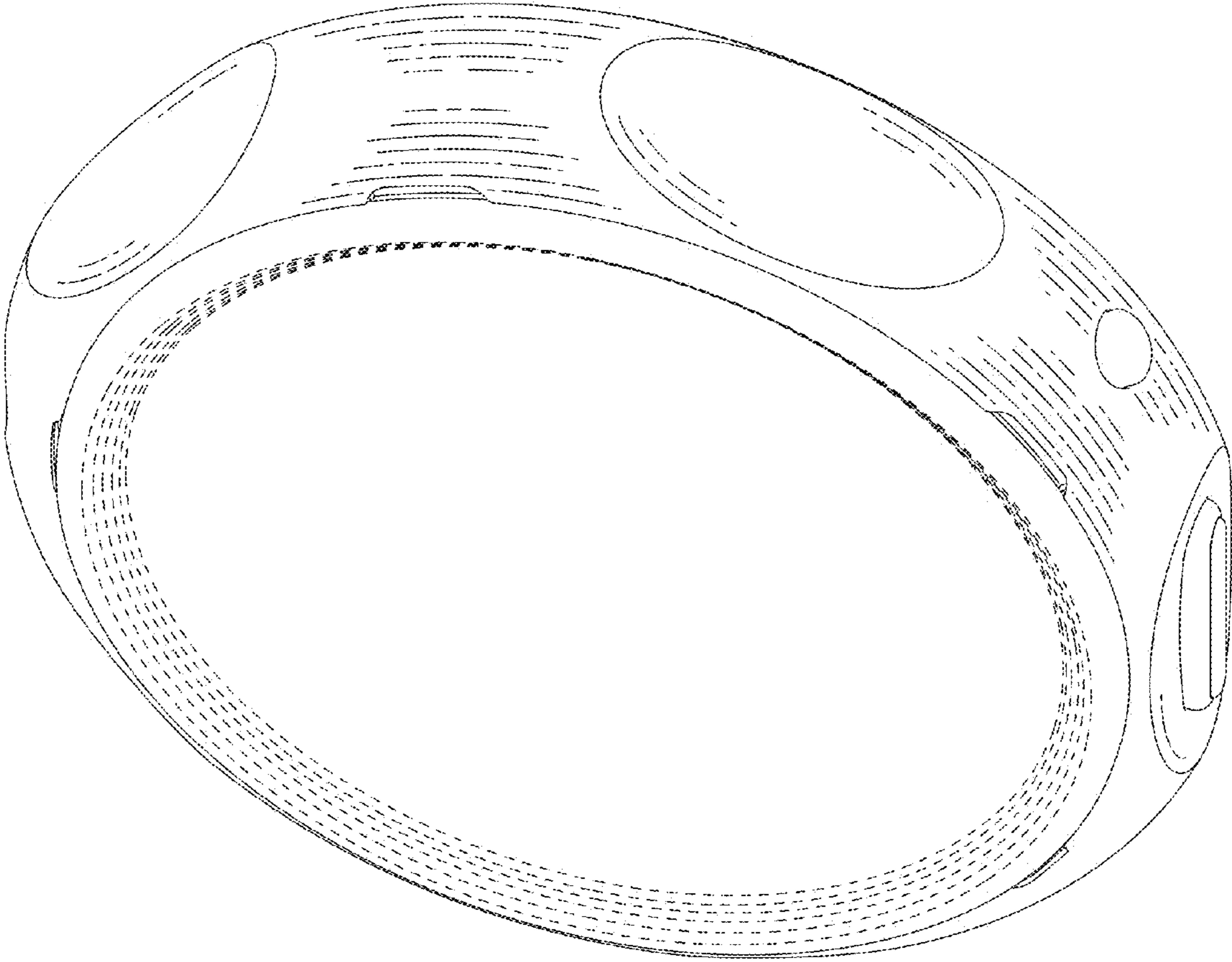

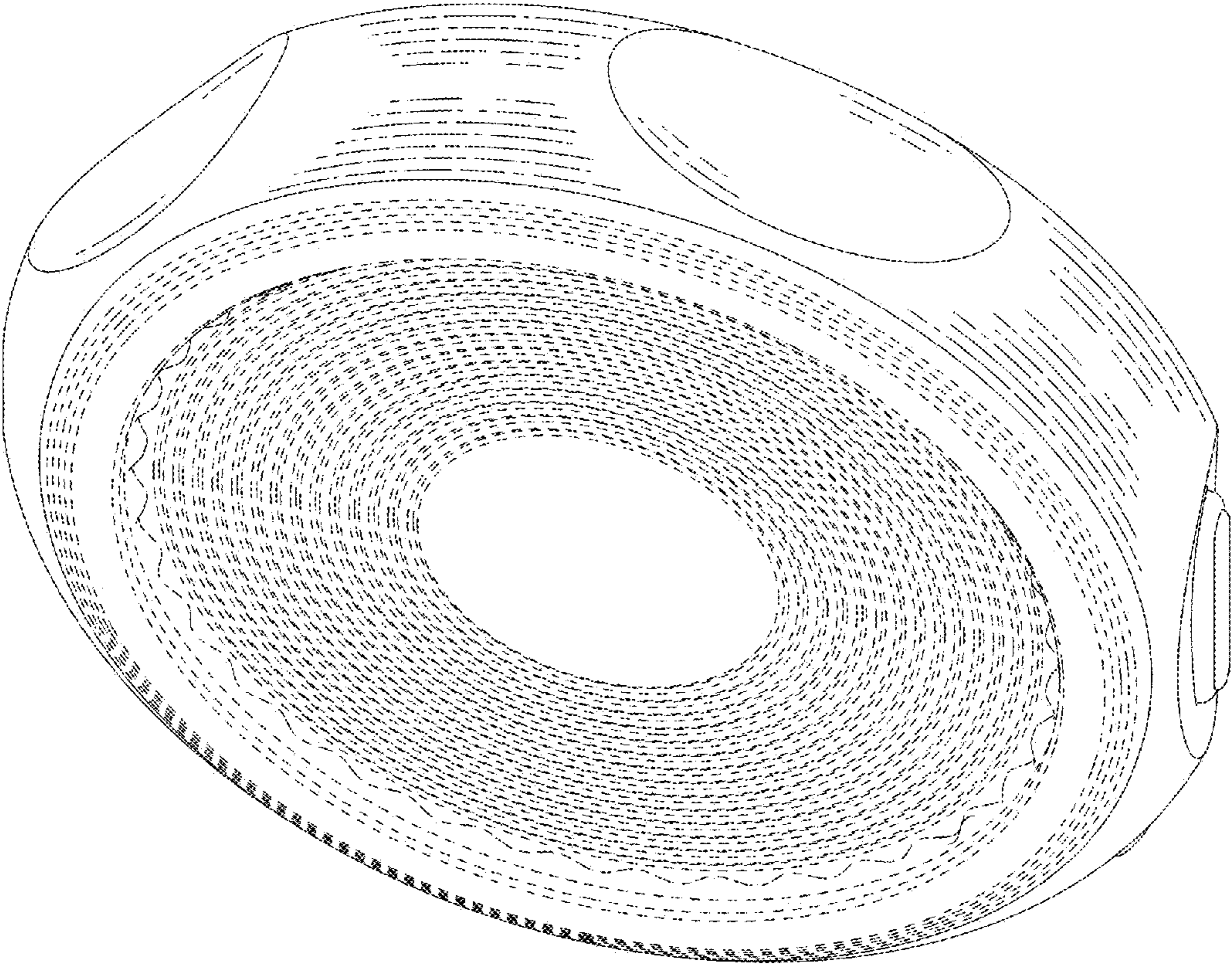

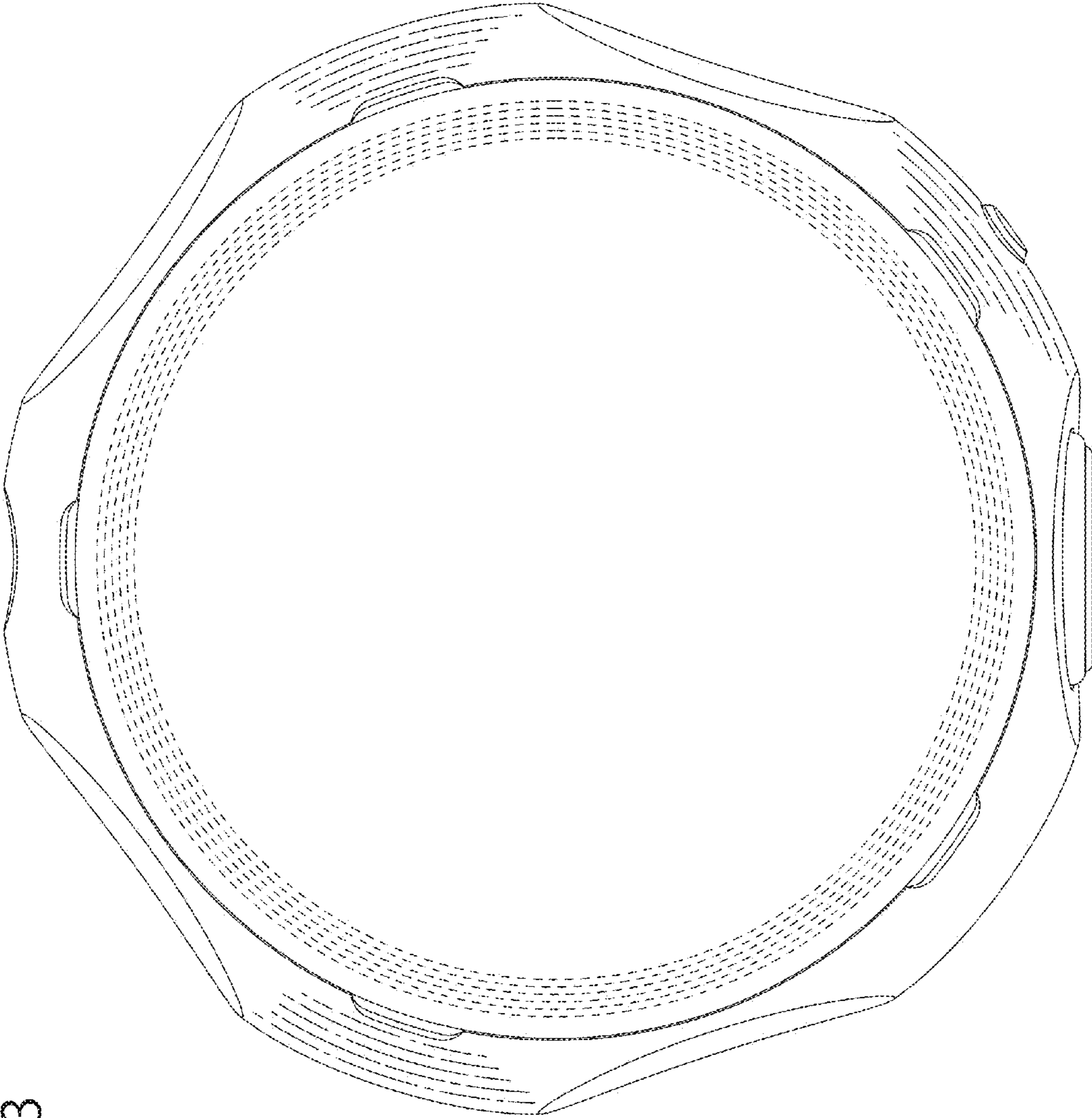

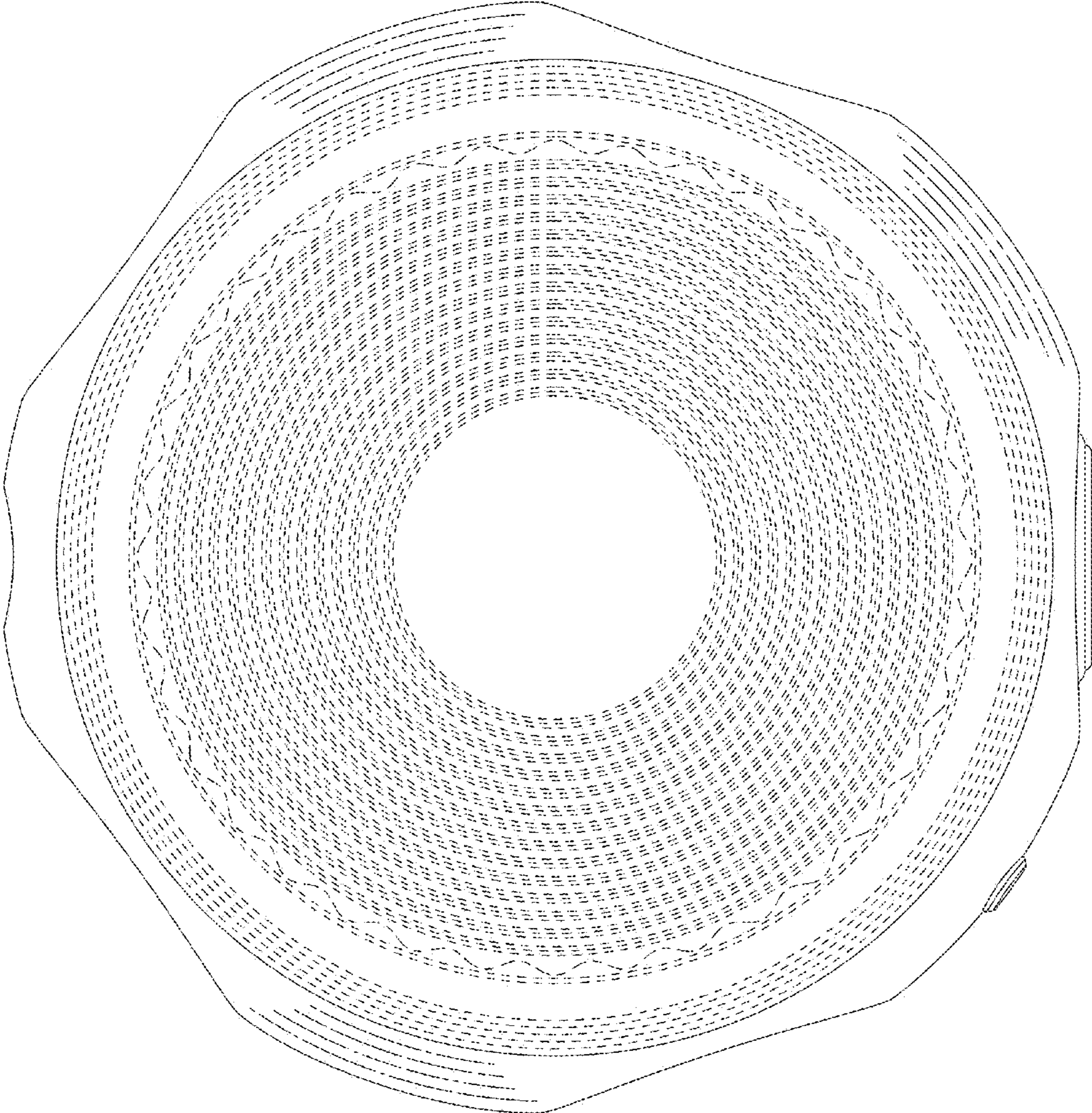

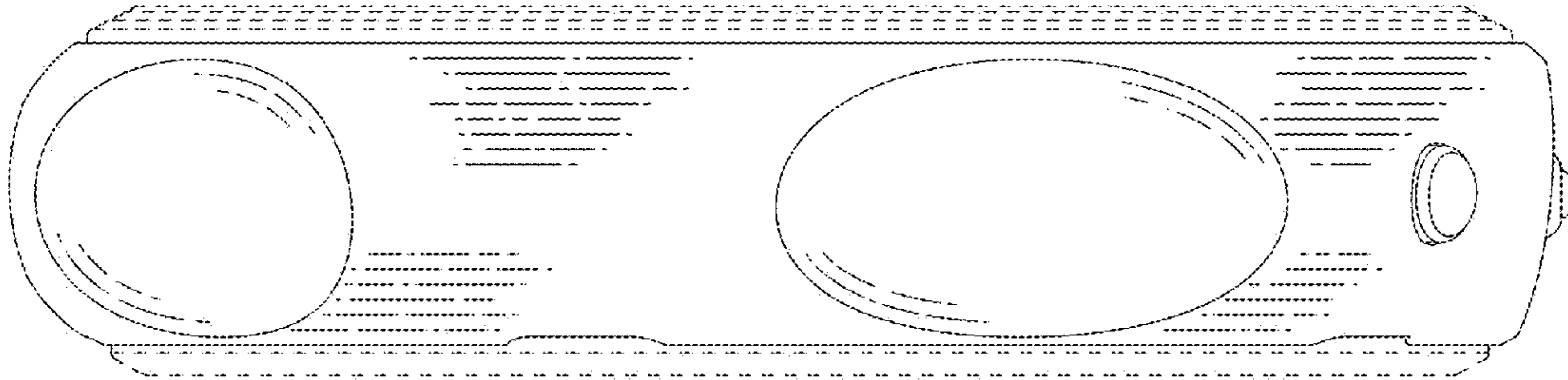

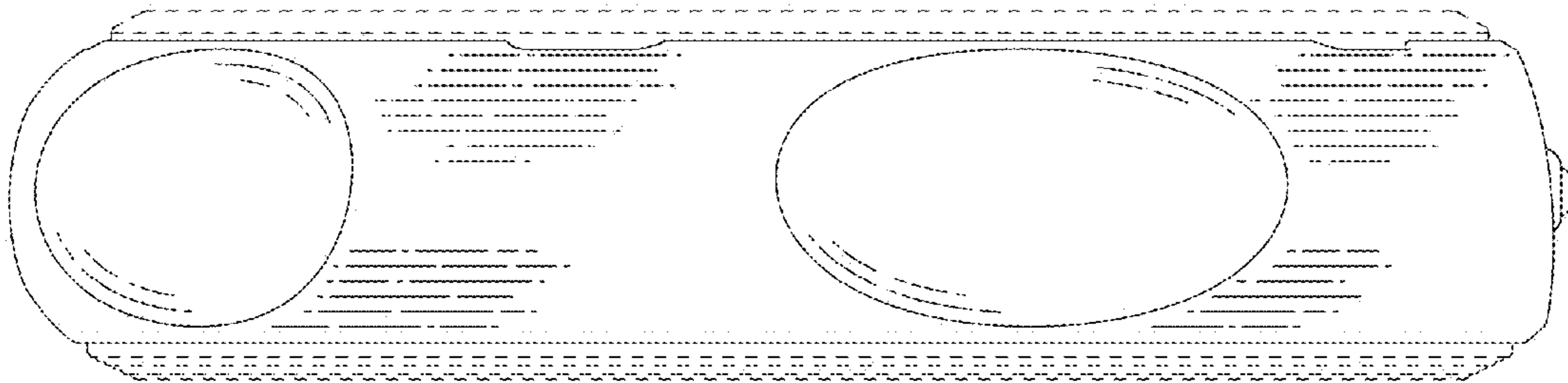

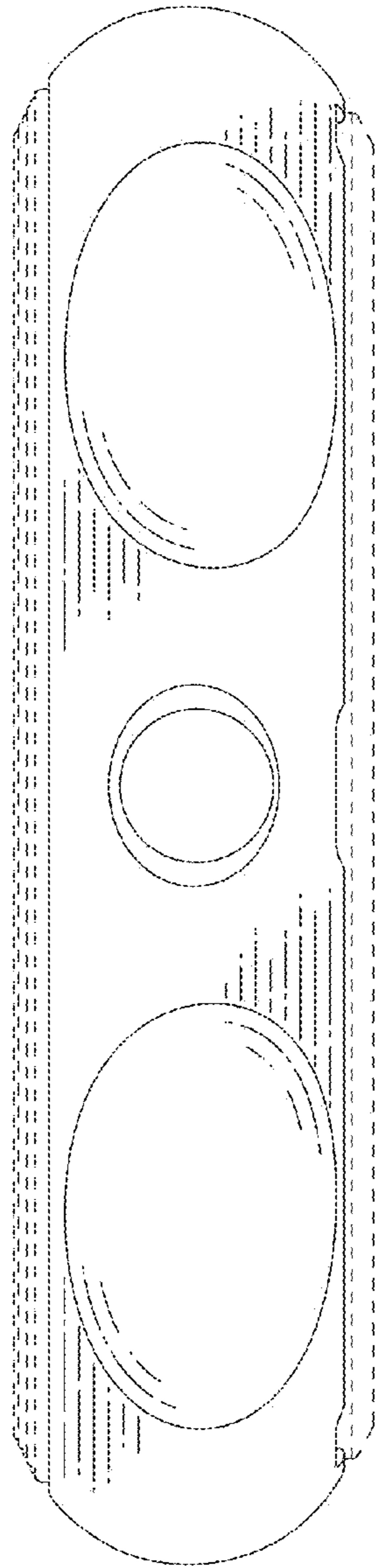
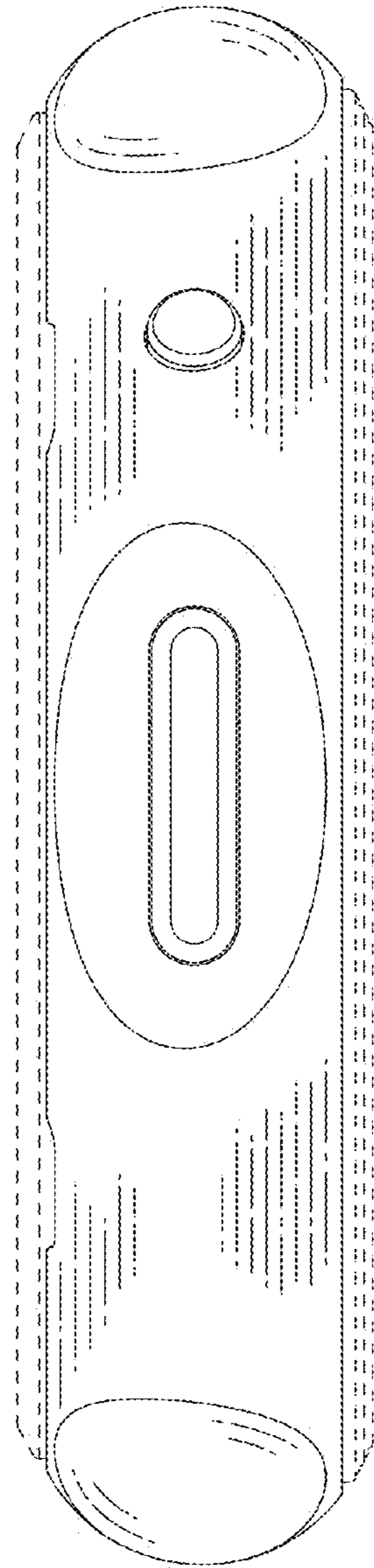

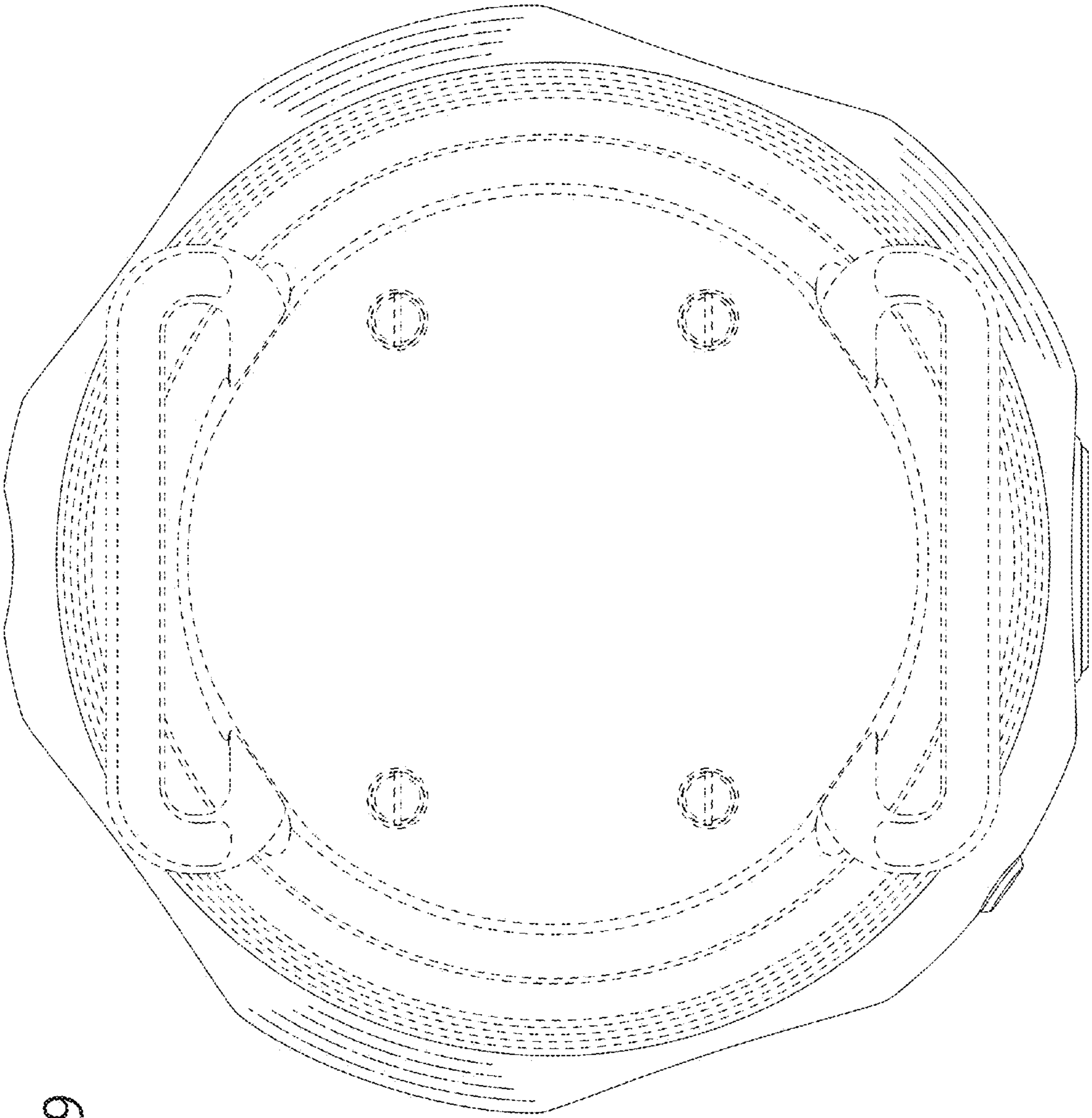

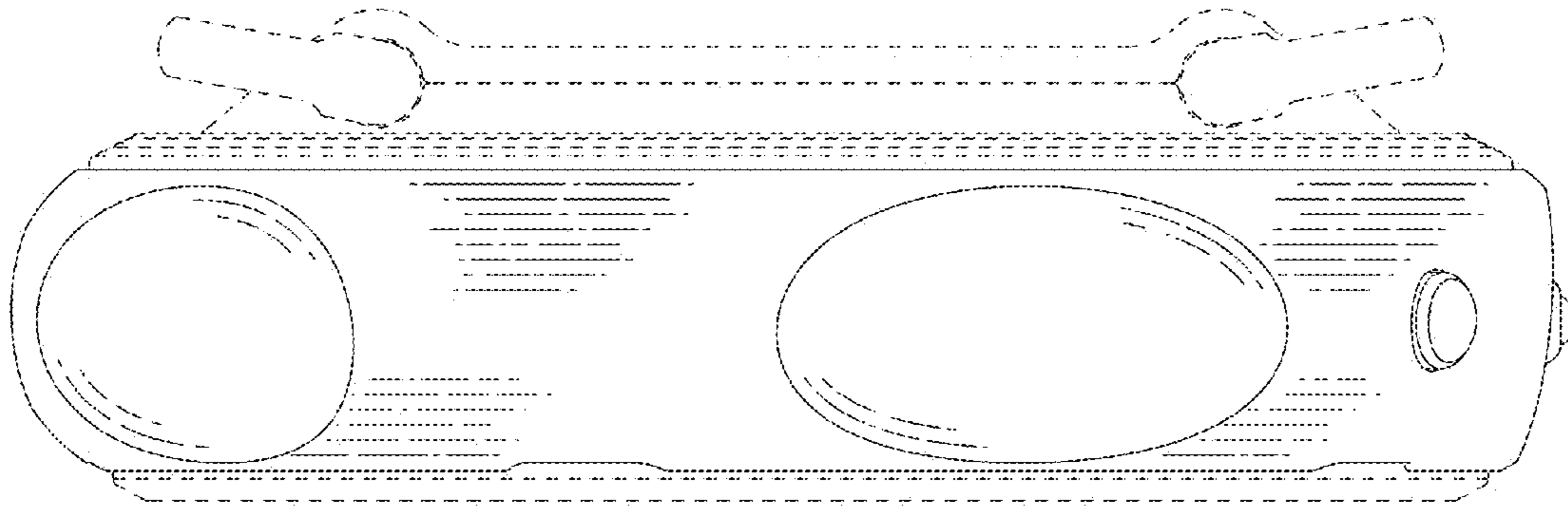
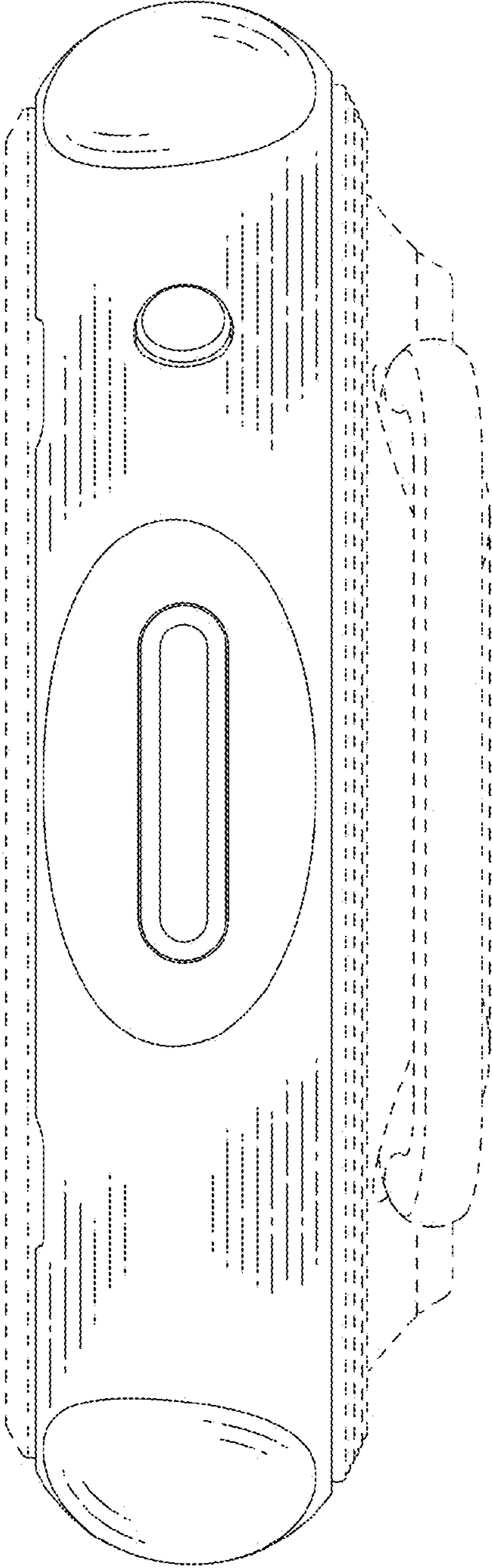

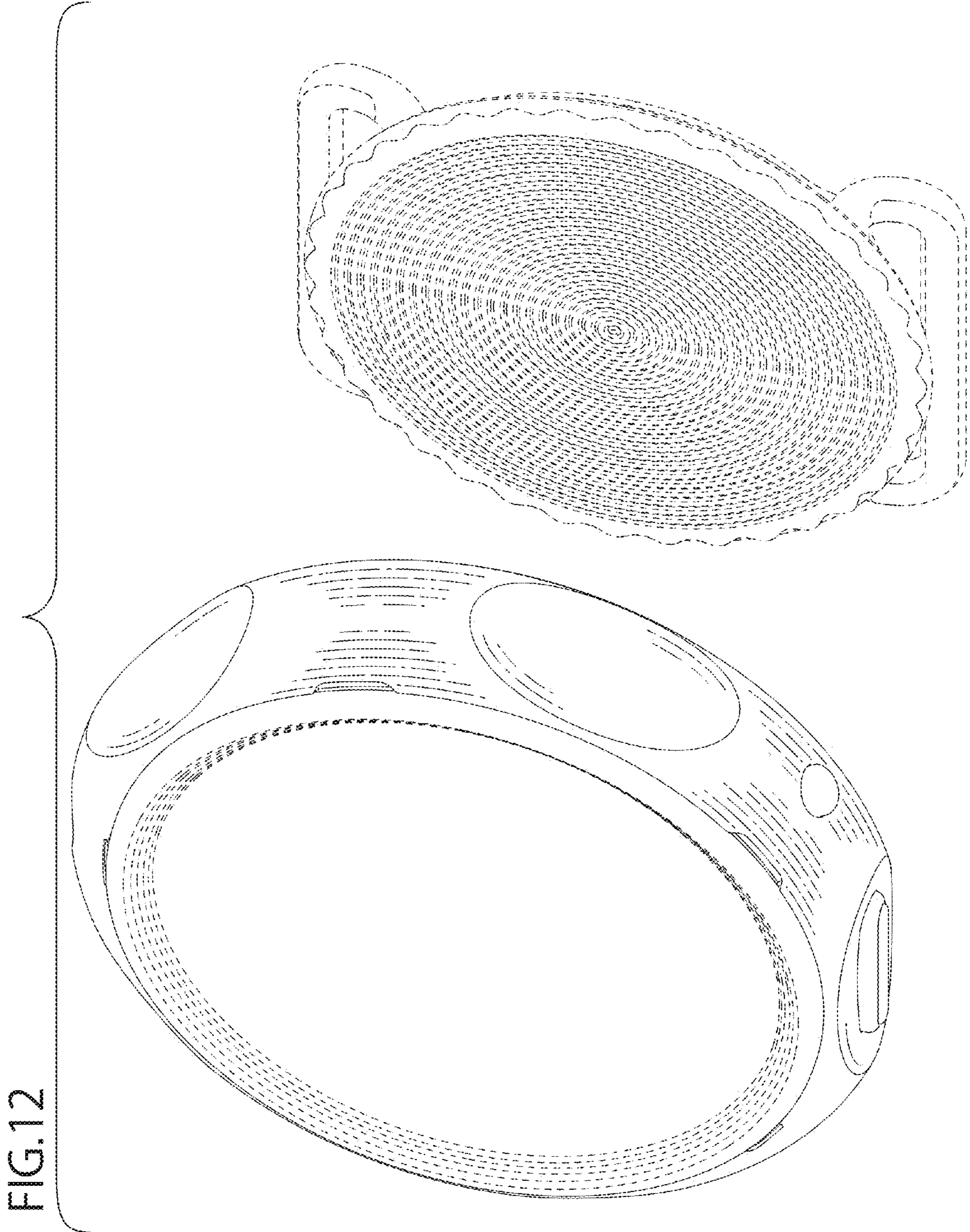

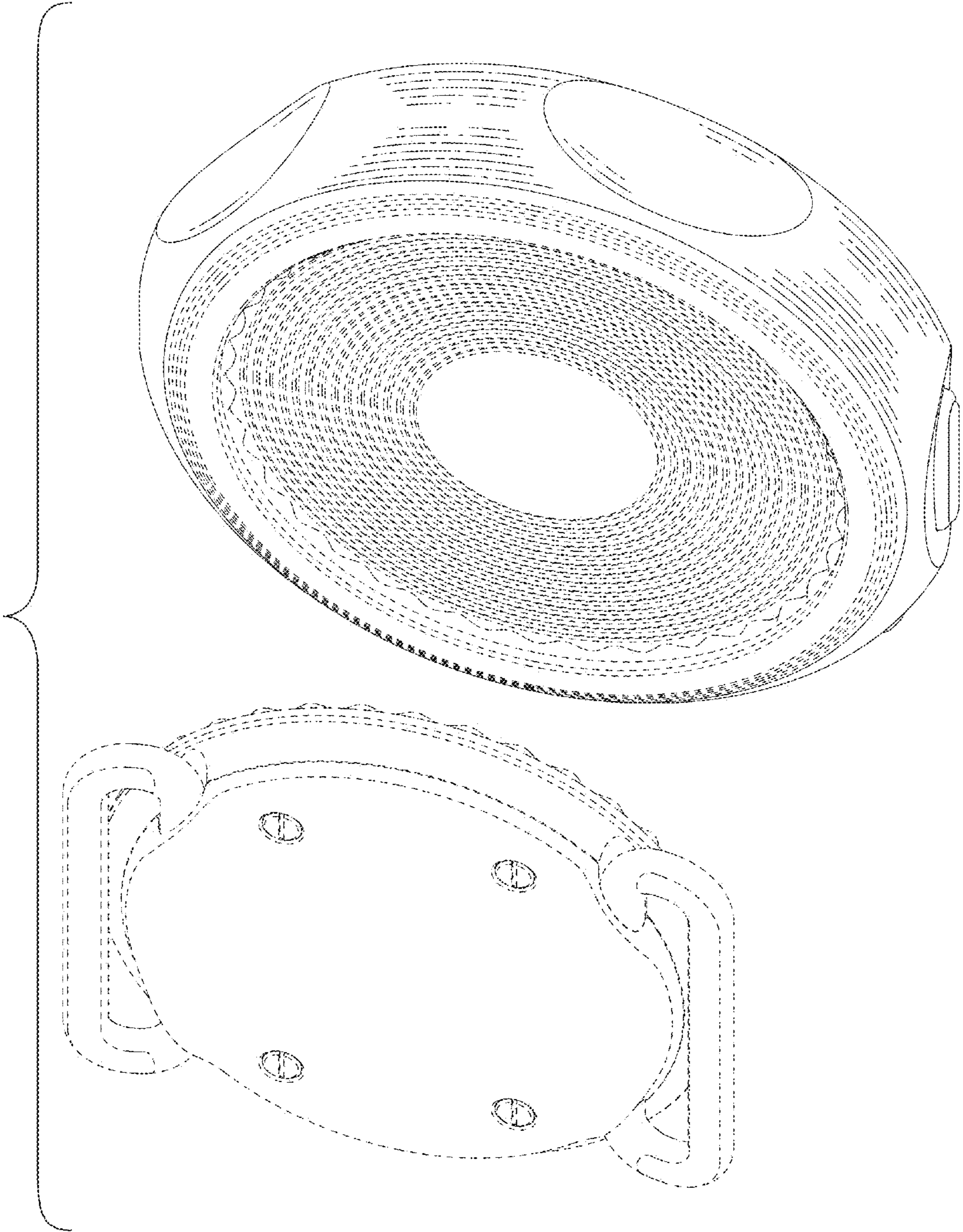
