**DESCRIPTION**

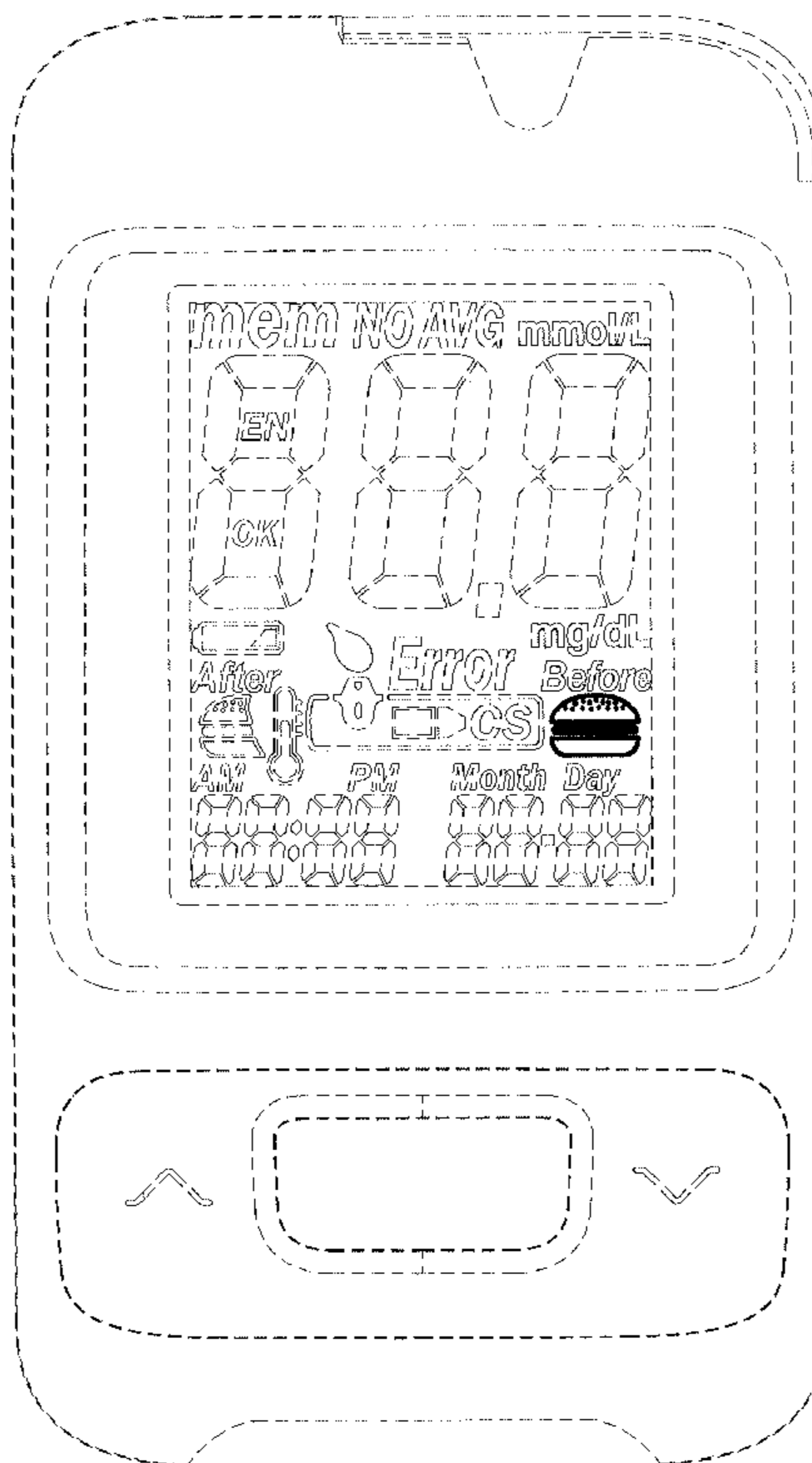

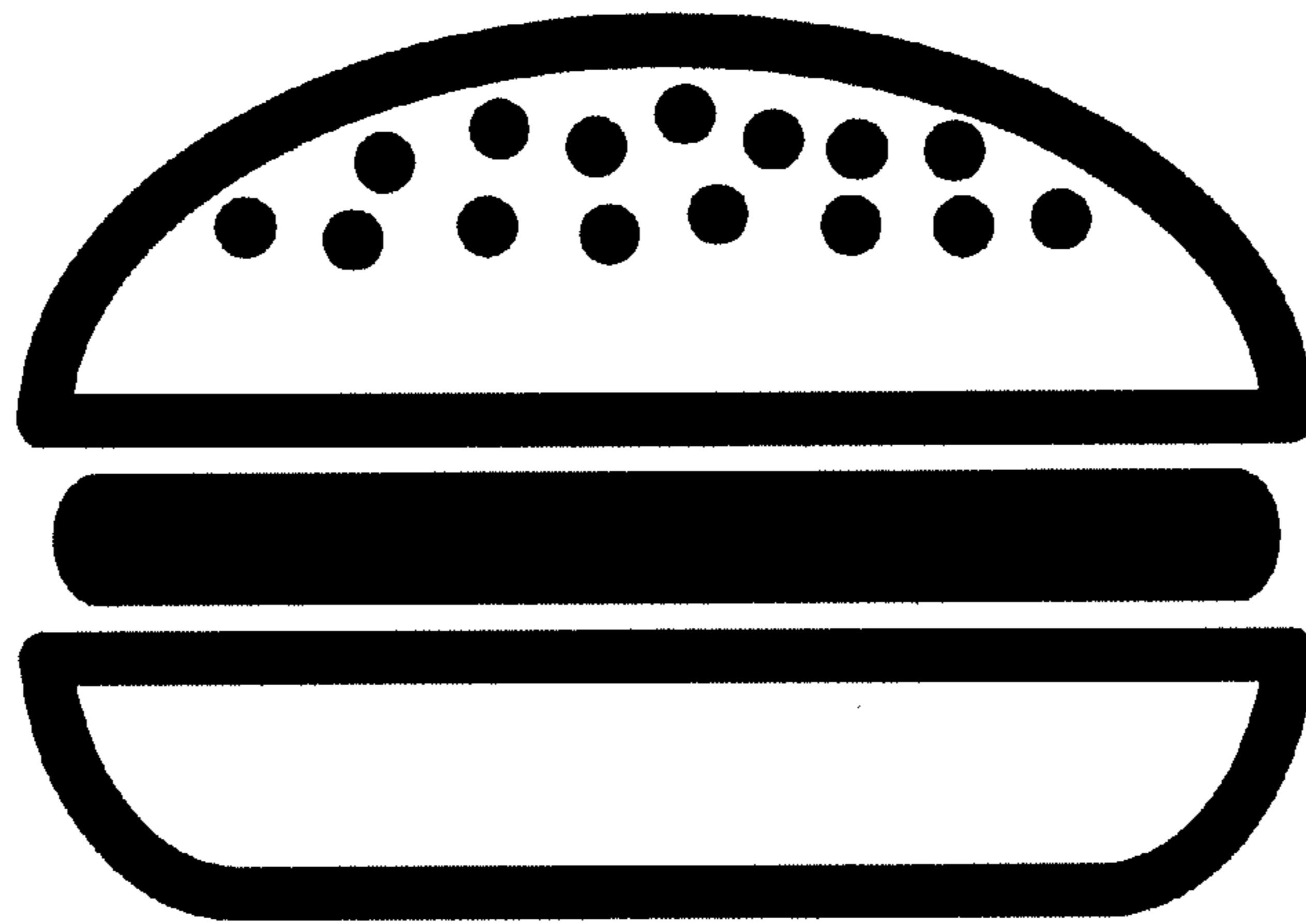

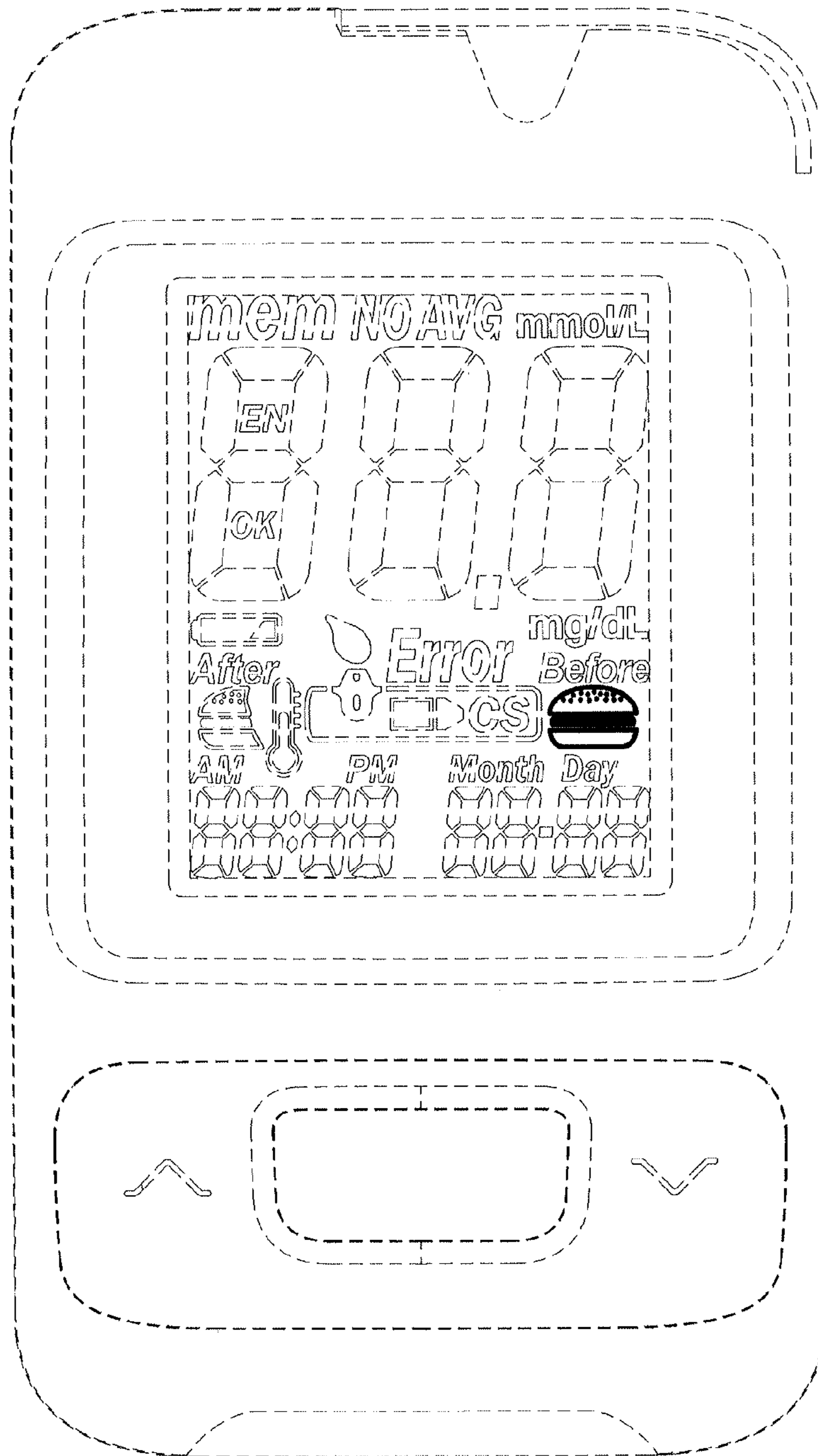
