The ornamental design for a fascia tissue fitness device, as shown and described.

**DESCRIPTION**

FIG. 1 is an illustration of a perspective view of a fascia tissue fitness device;

FIG. 2 is an illustration of a left-end view of an ornamental design of the fascia tissue fitness device;

FIG. 3 is an illustration of a right-end view of an ornamental design of the fascia tissue fitness device;

FIG. 5 is an illustration of a right-side view of an ornamental design of the fascia tissue fitness device;

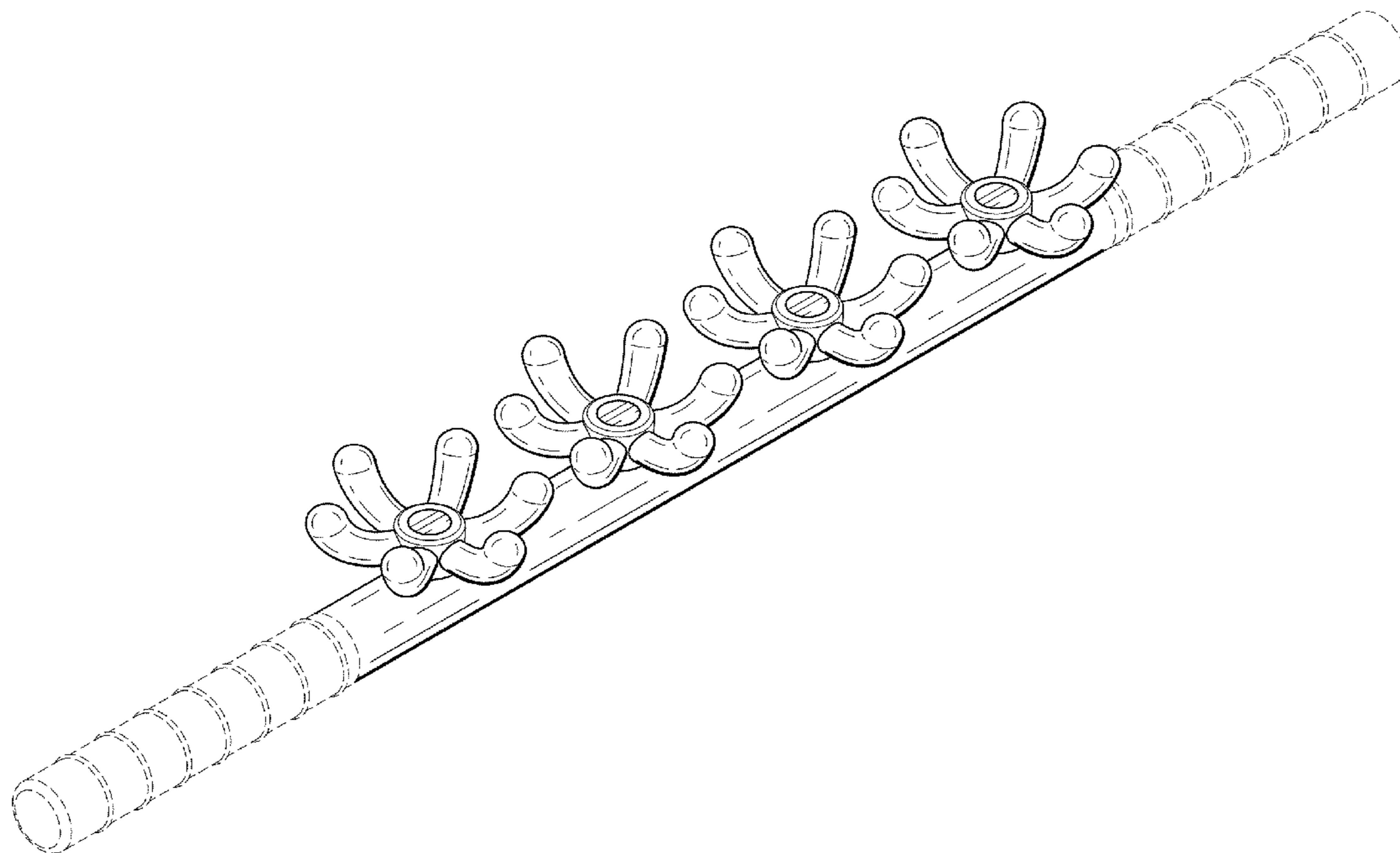
FIG. 6 is an illustration of a top view of an ornamental design of the fascia tissue fitness device; and

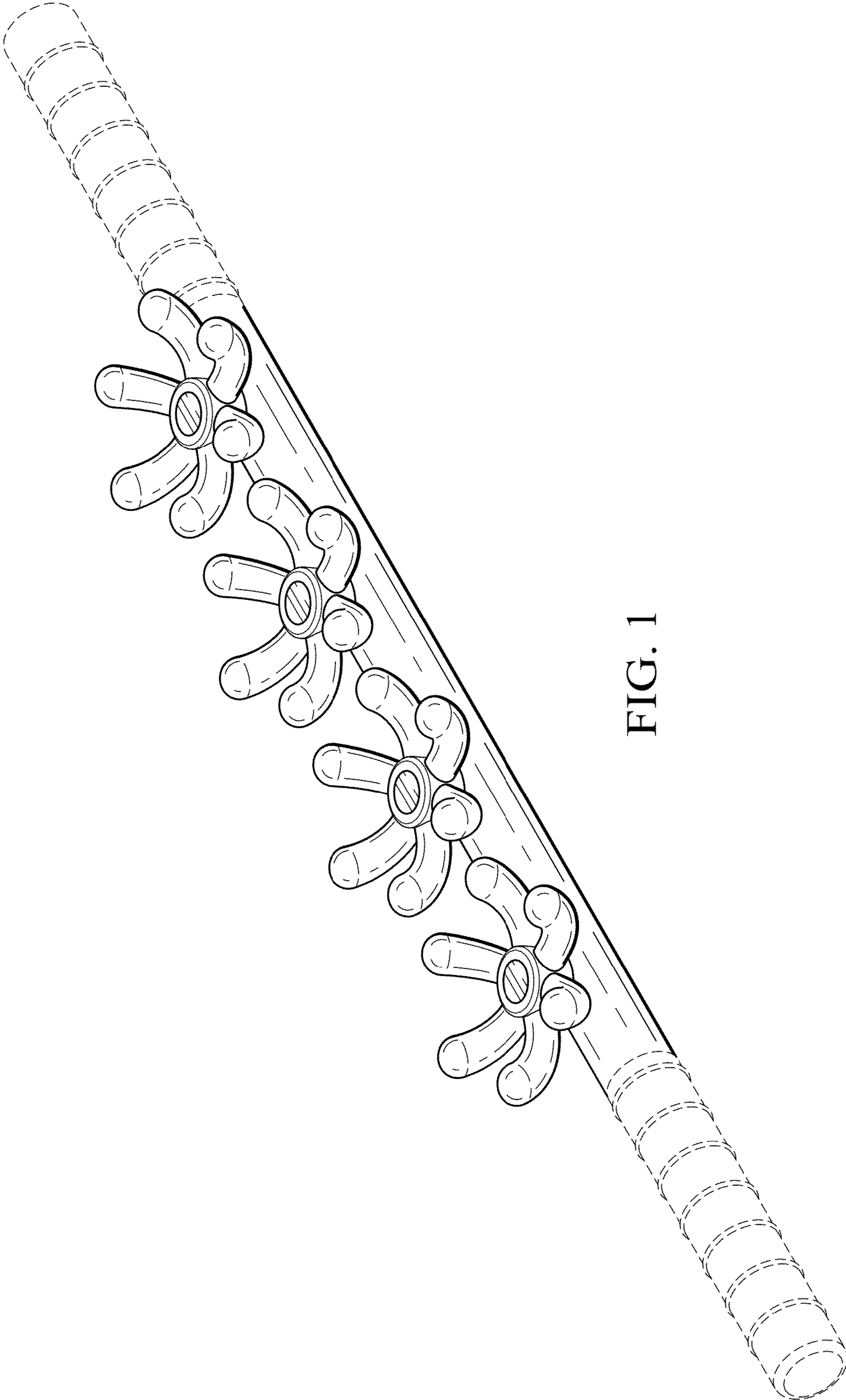

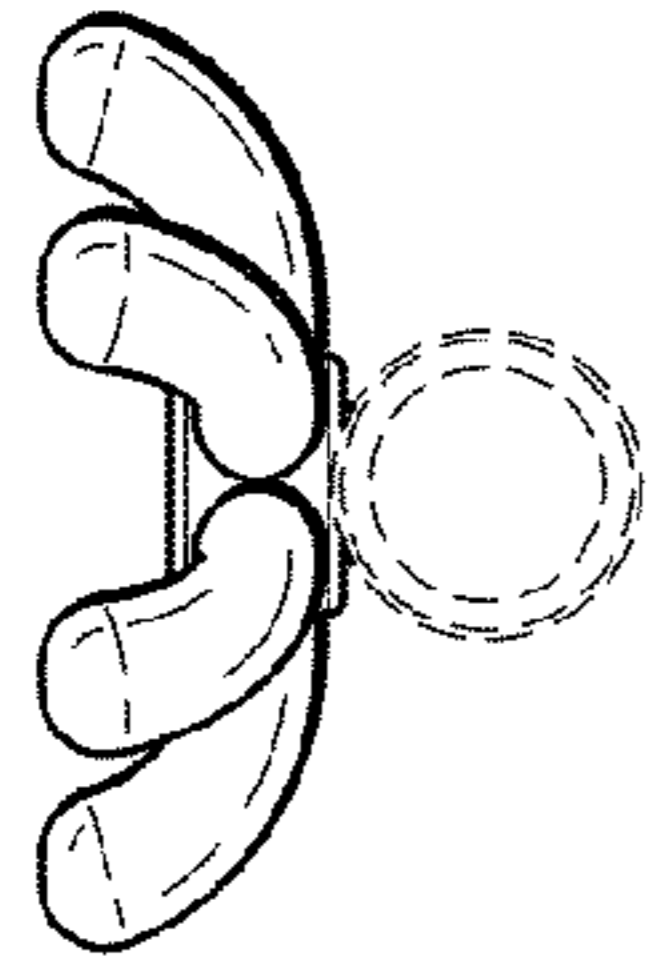

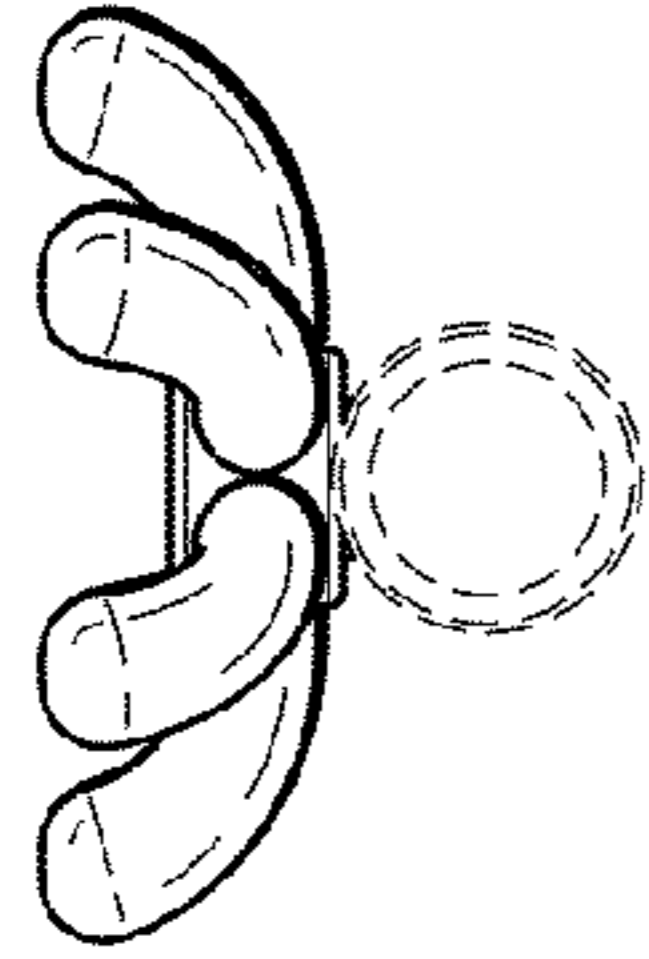

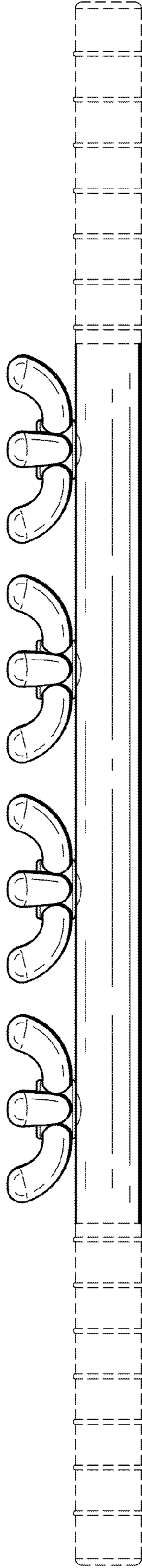

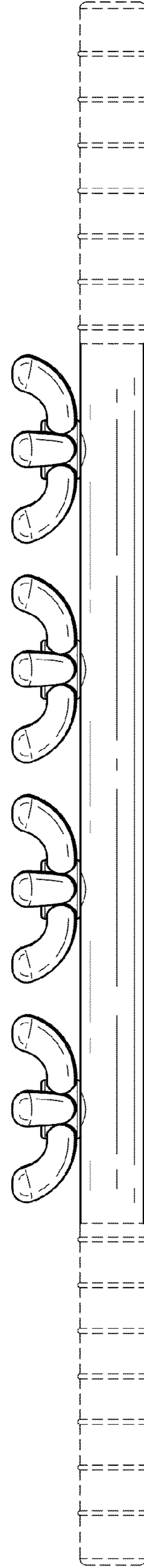

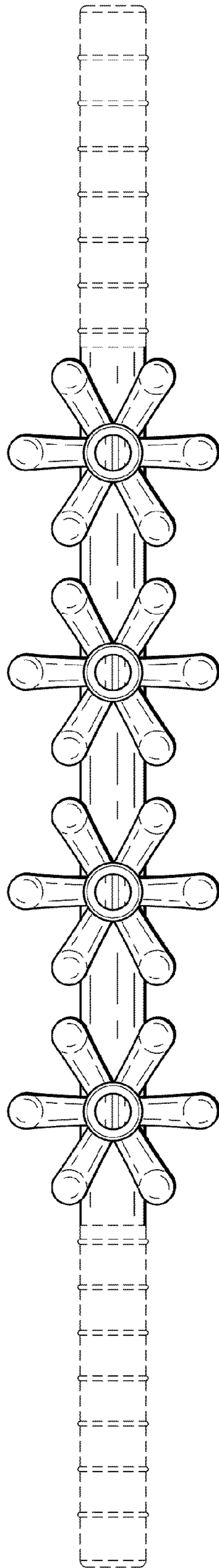

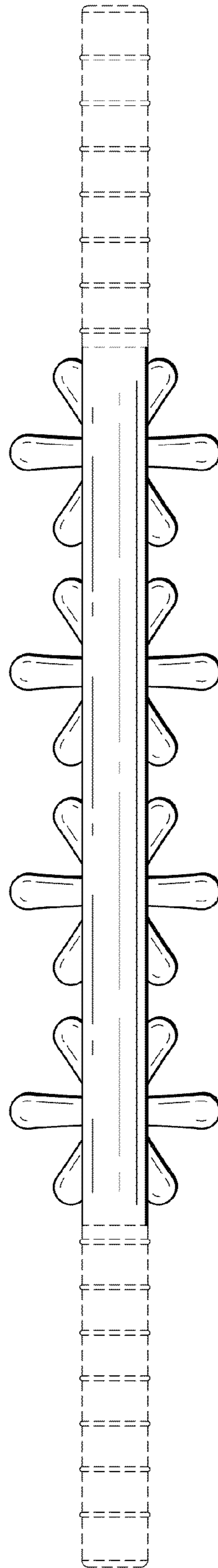

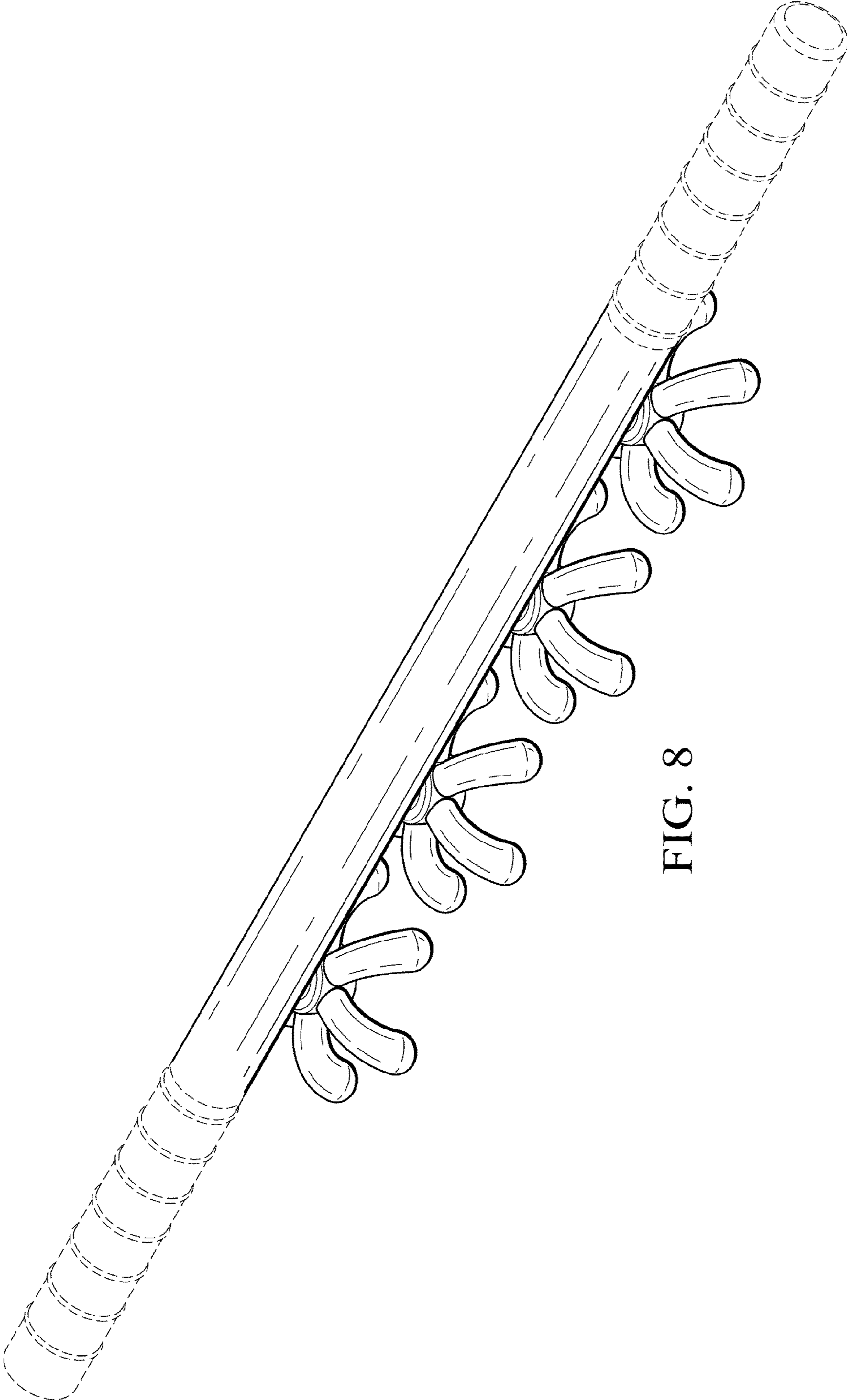
