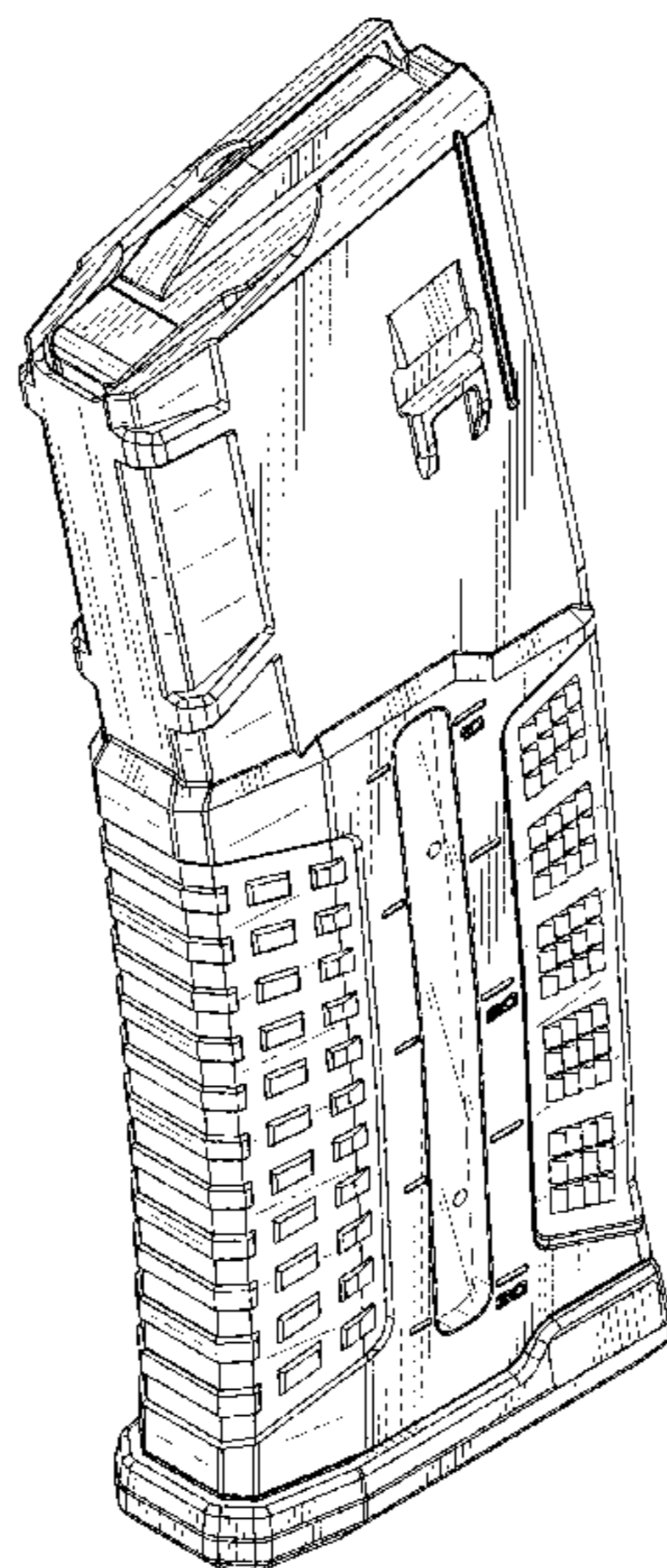
(57) **CLAIM**
The ornamental design for a magazine for a firearm, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, top perspective view of a magazine for a firearm in accordance with my new design;
FIG. 2 is a front view of the magazine for a firearm of FIG. 1;
FIG. 3 is a right side view of the magazine for a firearm of FIG. 1;
FIG. 4 is a rear view of the magazine for a firearm of FIG. 1;
FIG. 5 is a left side view of the magazine for a firearm of FIG. 1;
FIG. 6 is a top view of the magazine for a firearm of FIG. 1;
FIG. 7 is a bottom view of the magazine for a firearm of FIG. 1; and,
FIG. 8 is a rear, left, bottom perspective view of the magazine for a firearm of FIG. 1.

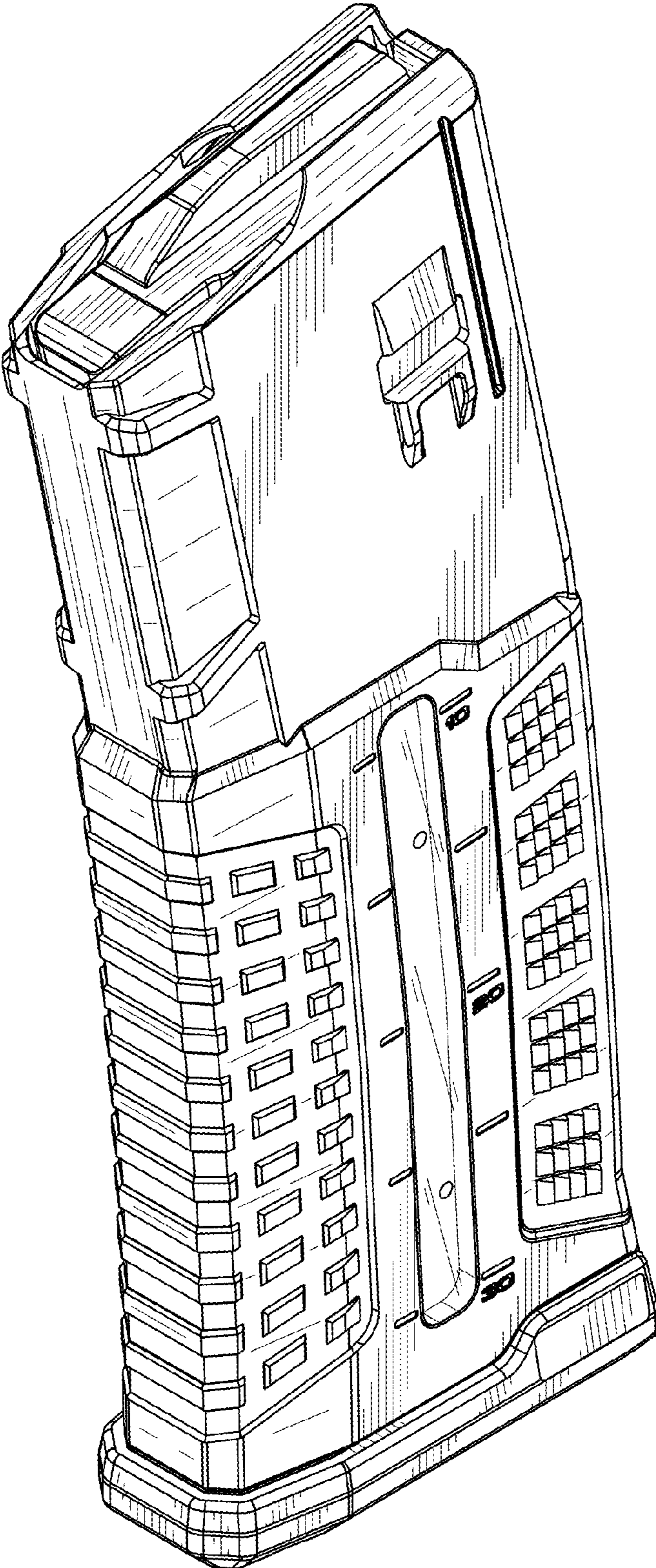

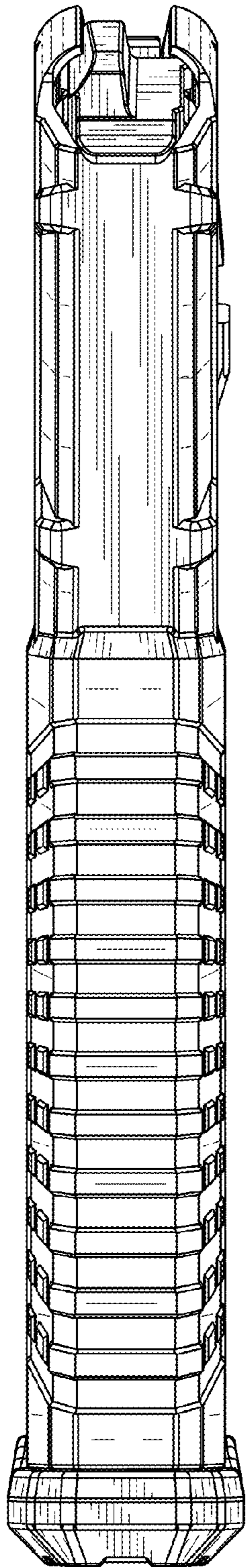

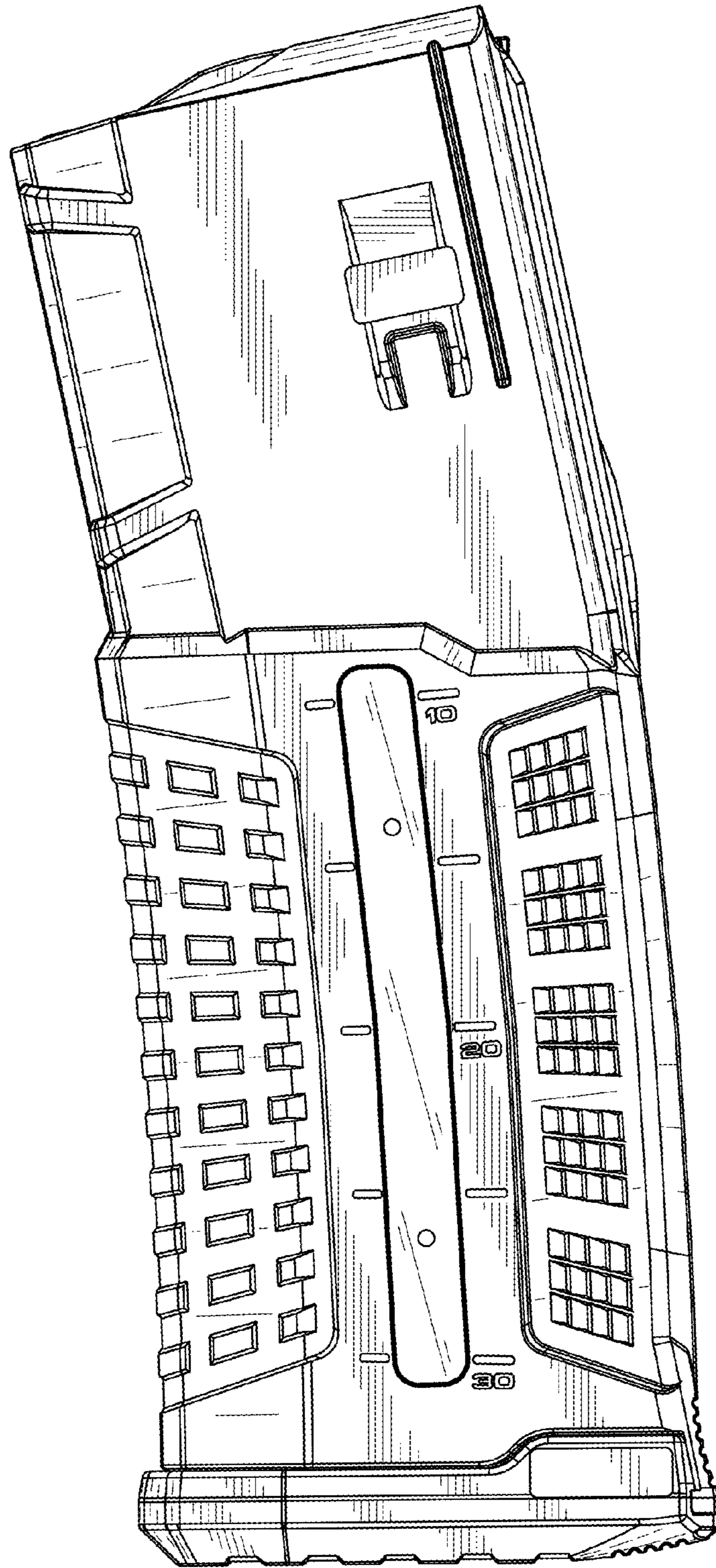

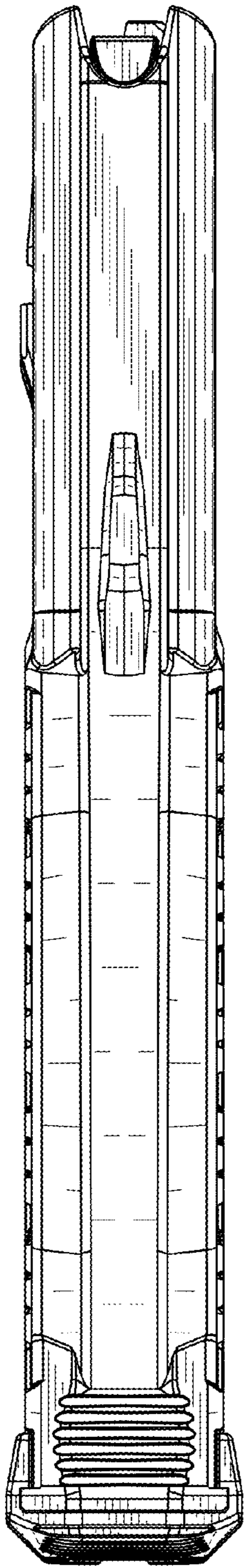

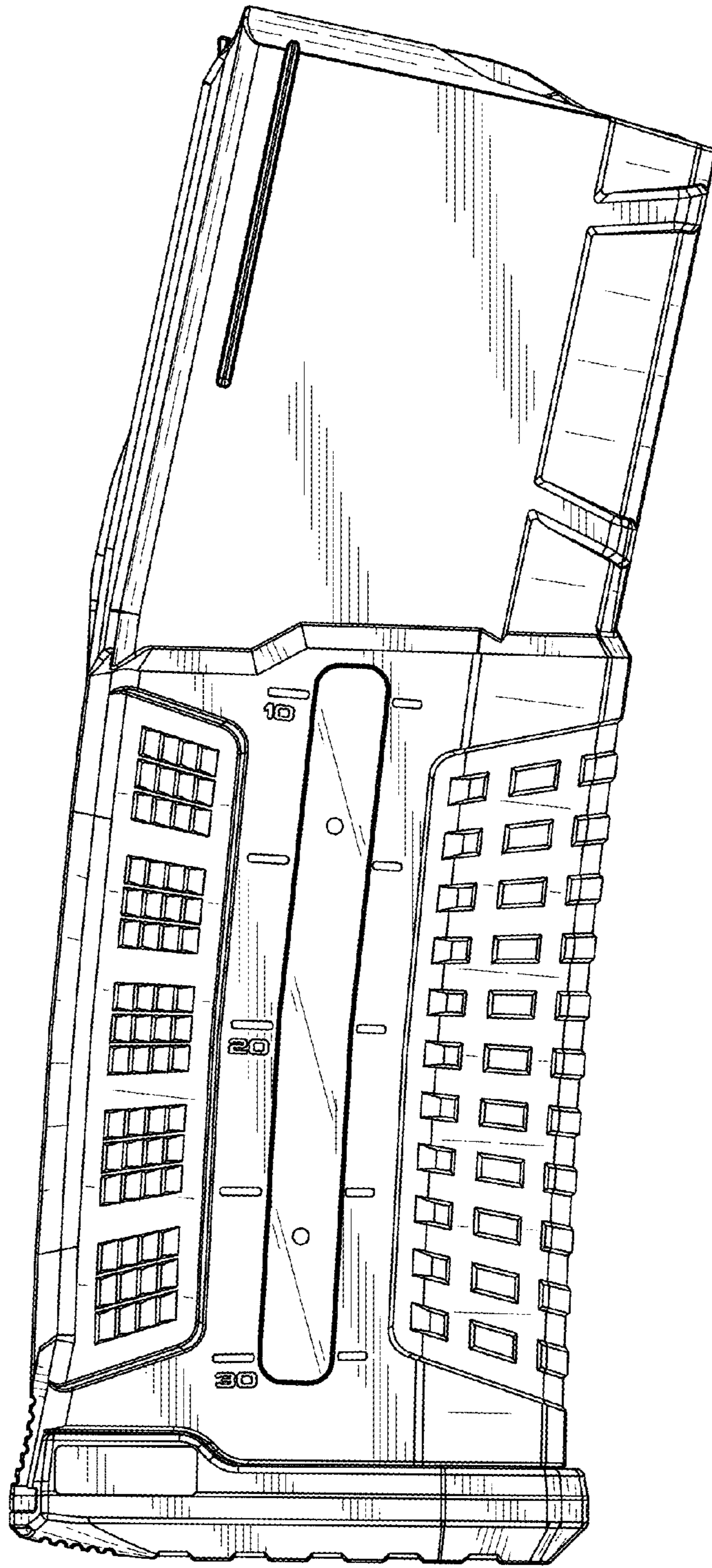

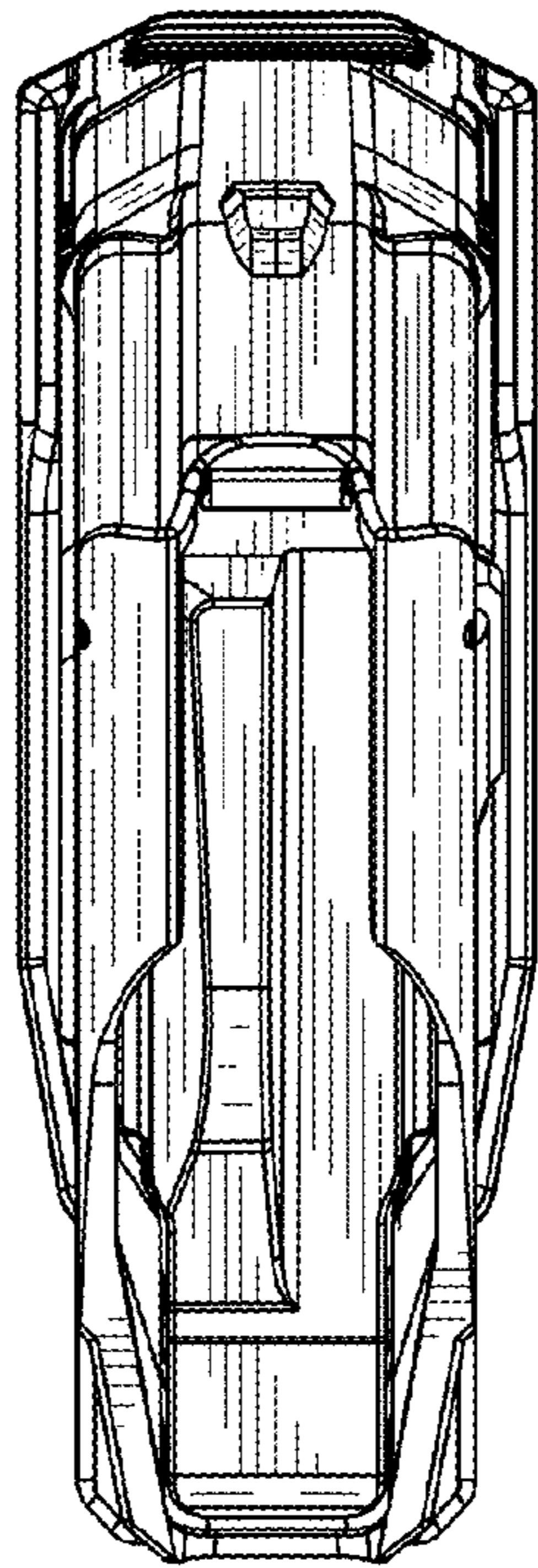

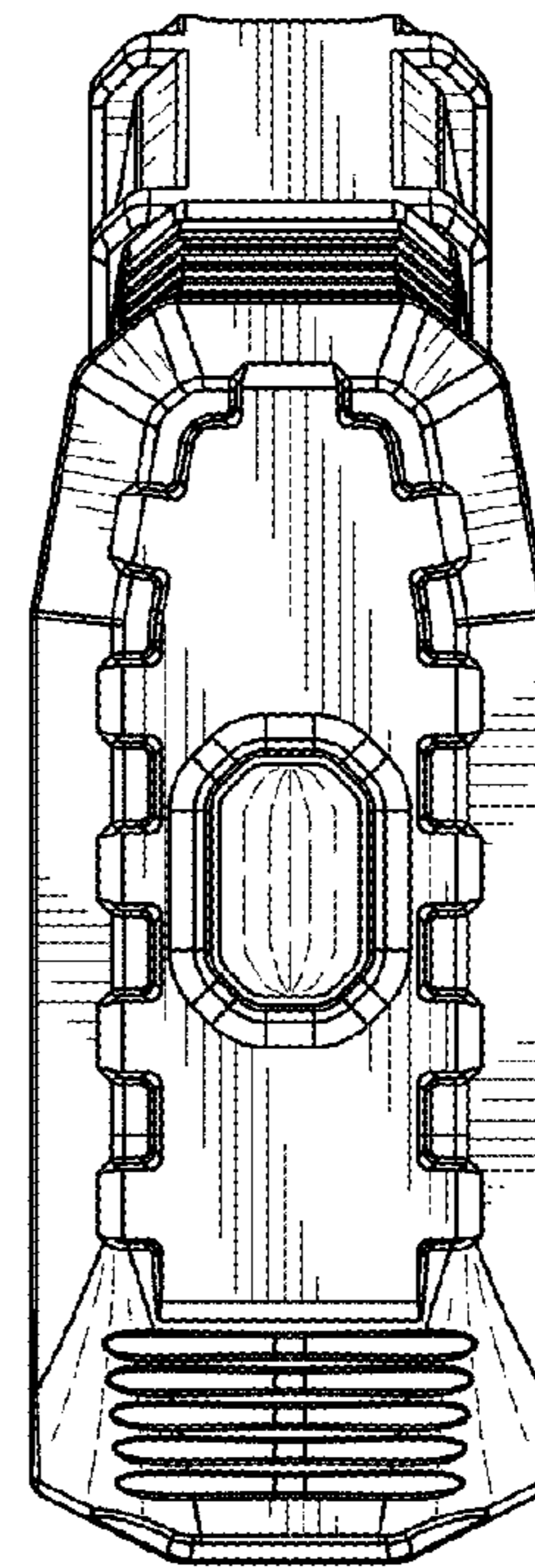

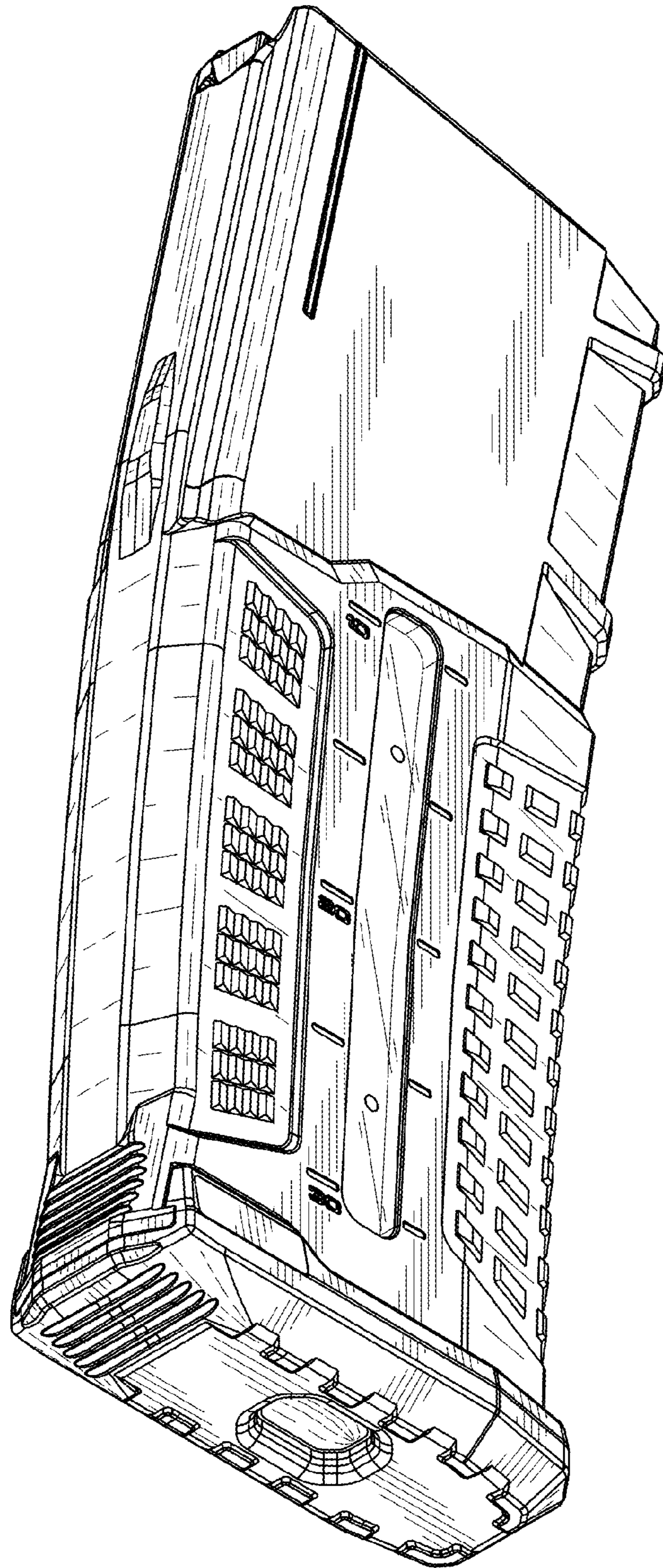
